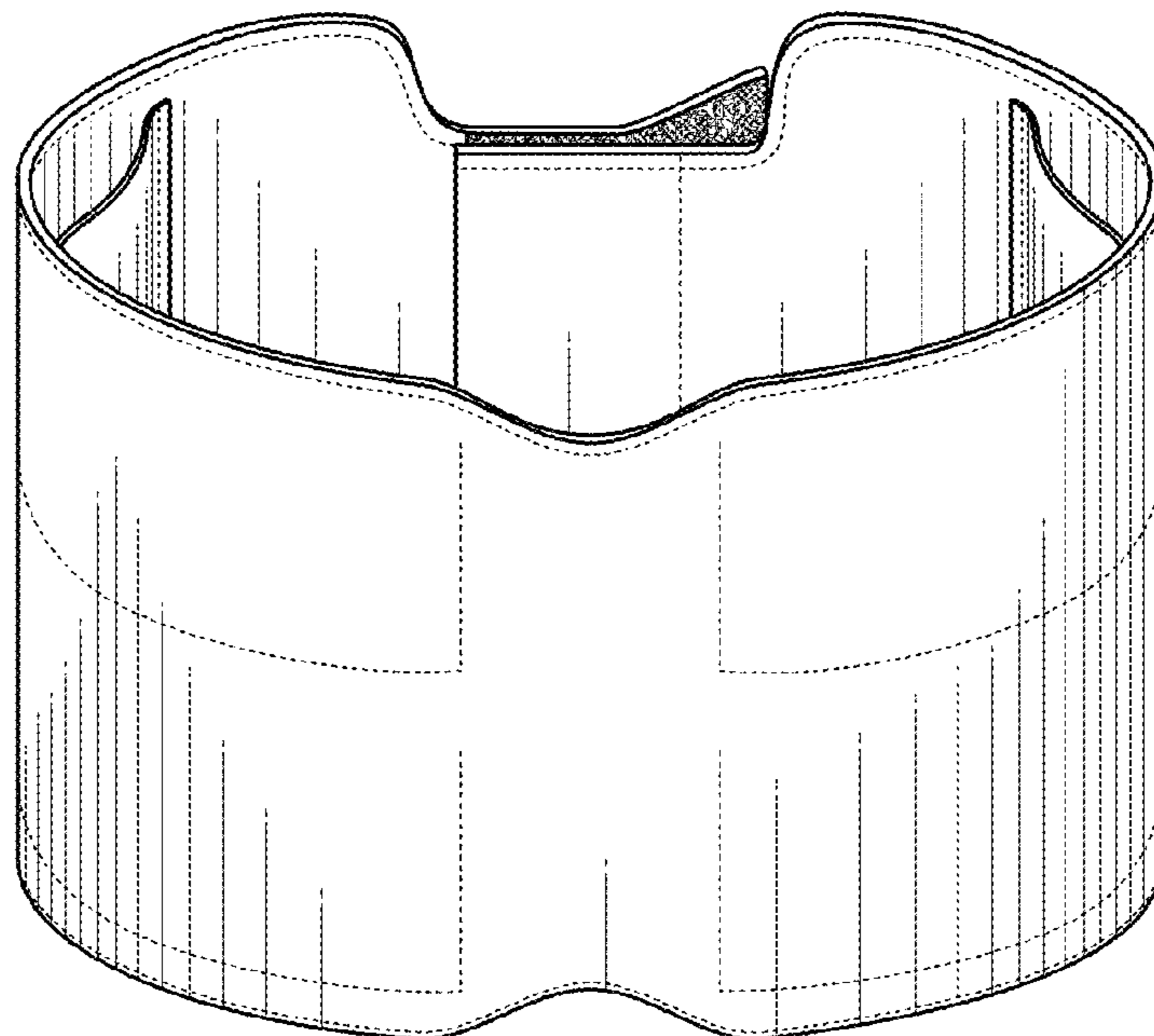
(57) **CLAIM**

The ornamental design for a torso support for hot/cold heat transfer media packs, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of a torso support for hot/cold heat transfer media packs in use;

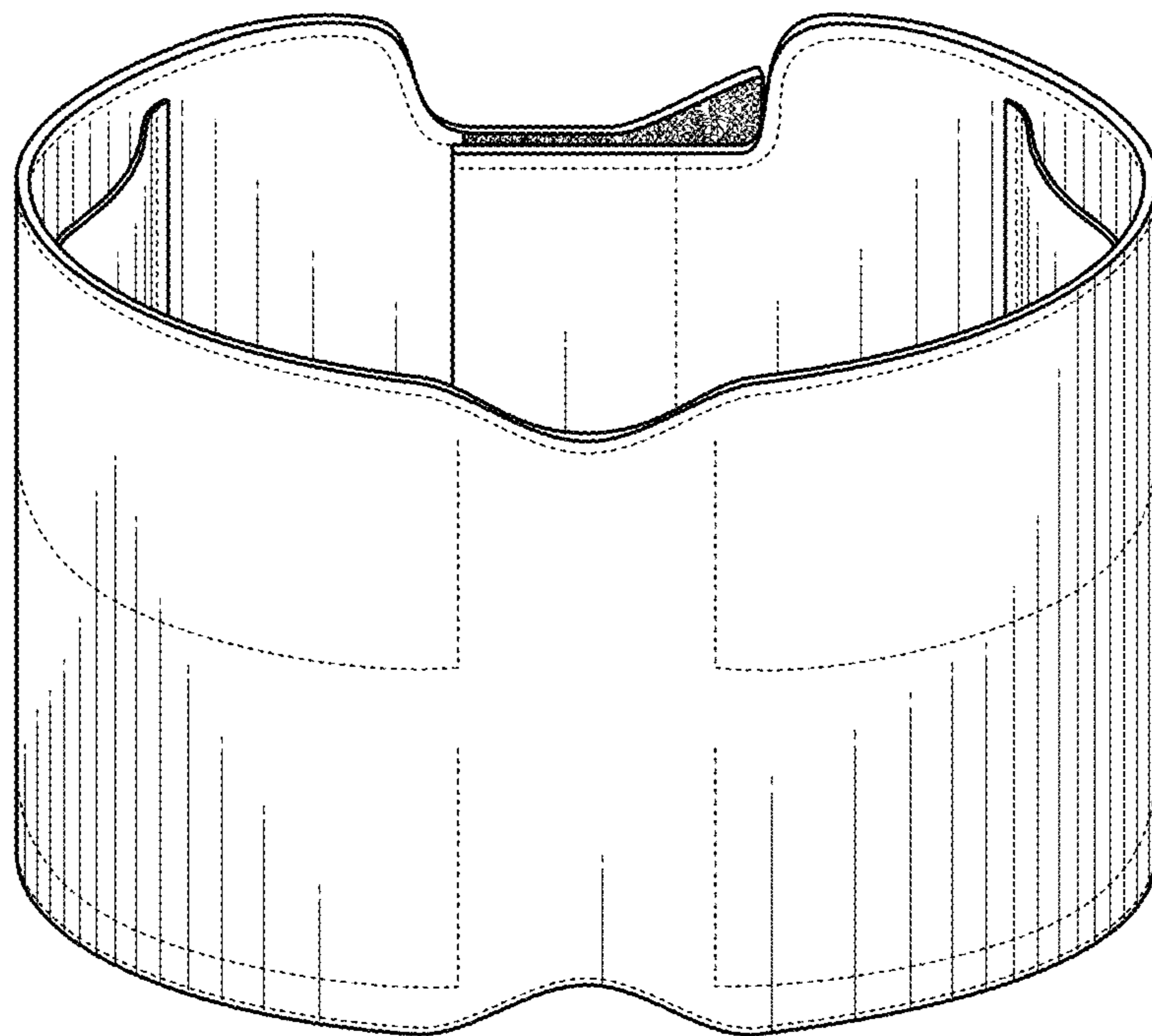

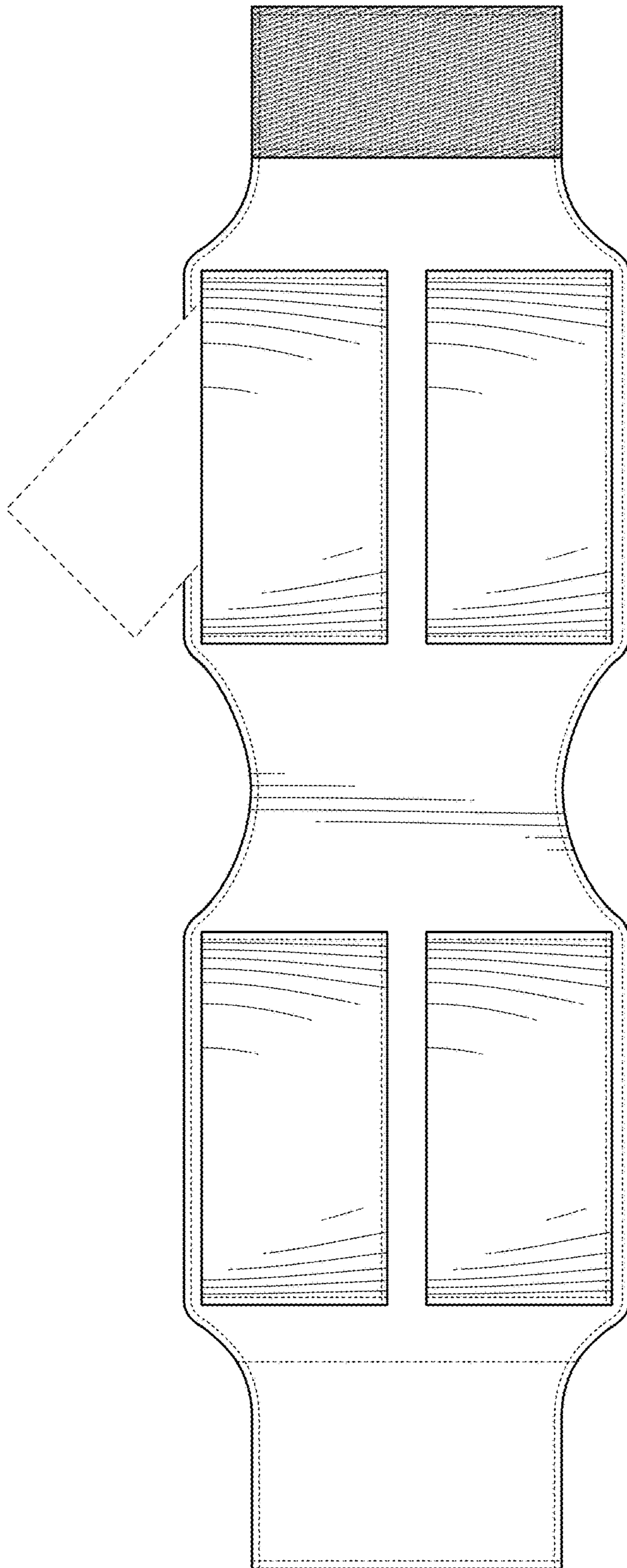

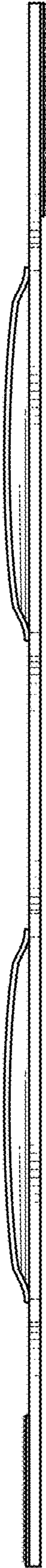

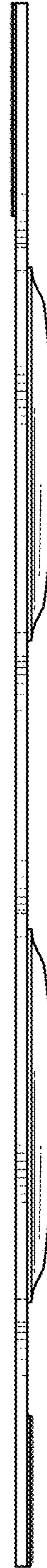

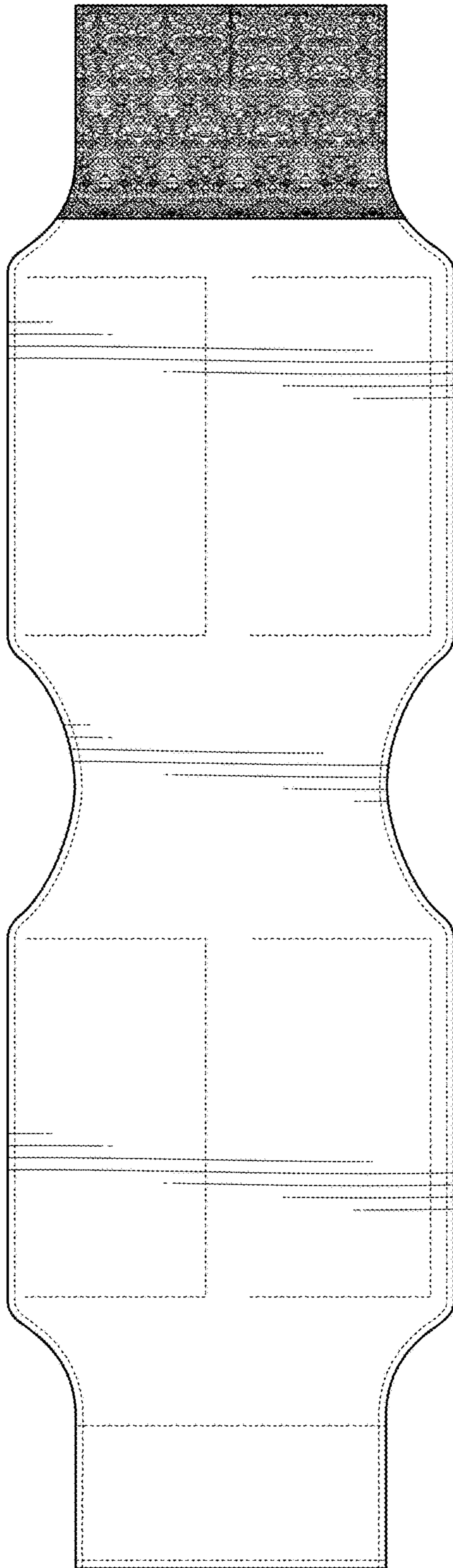
