(57) **CLAIM**

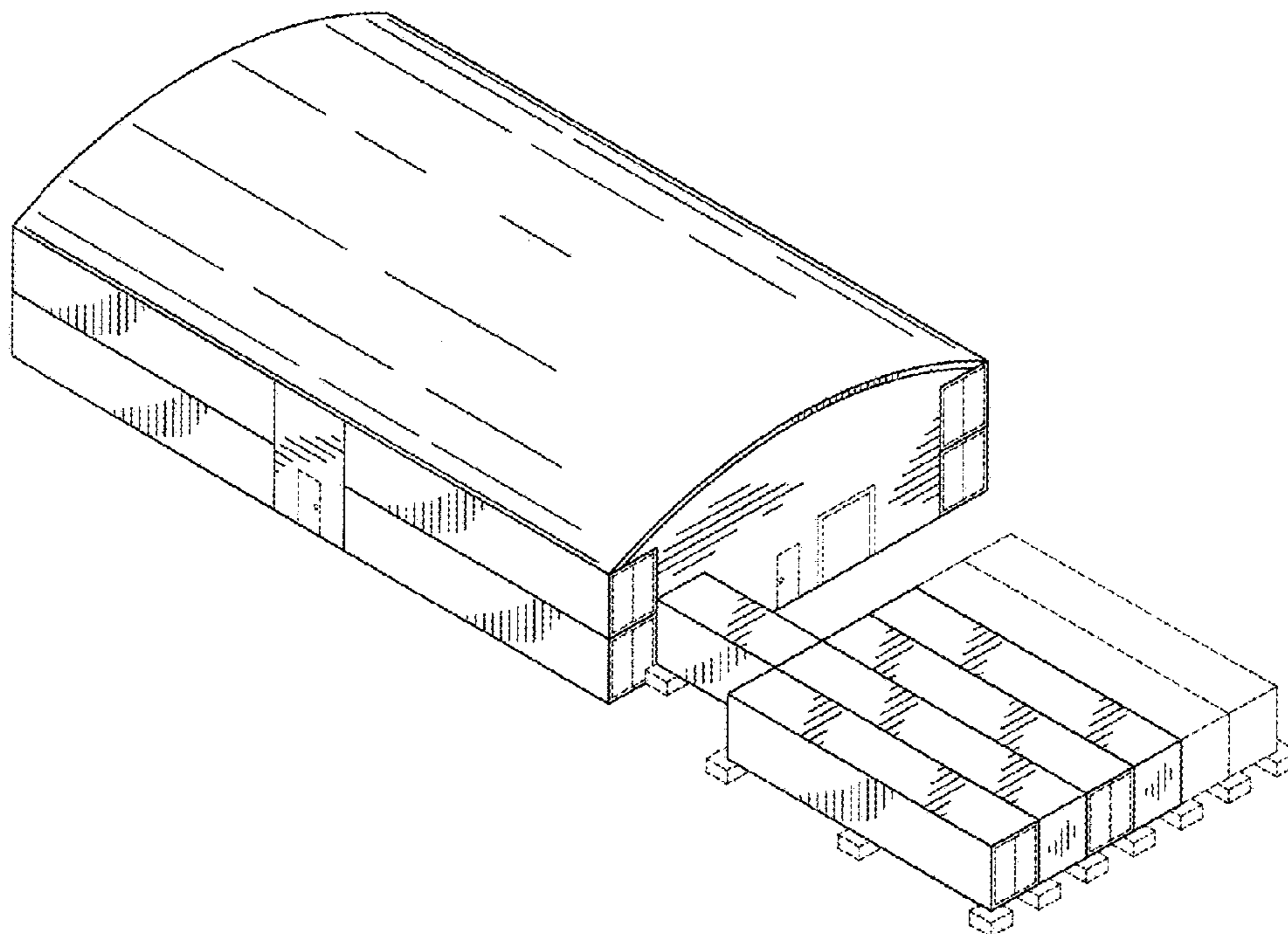
The ornamental design for a corrosion control facility, as shown and described.

DESCRIPTION

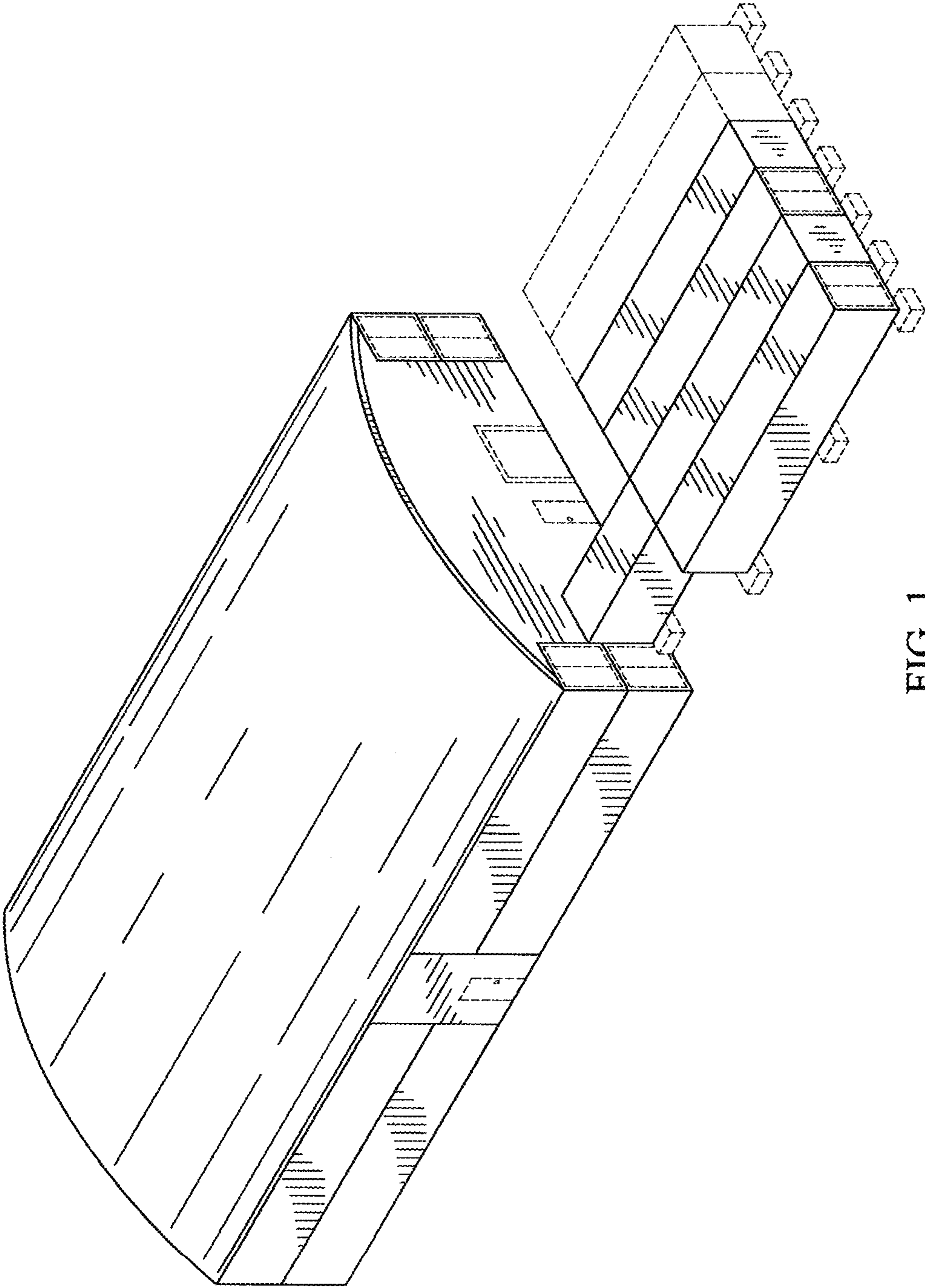

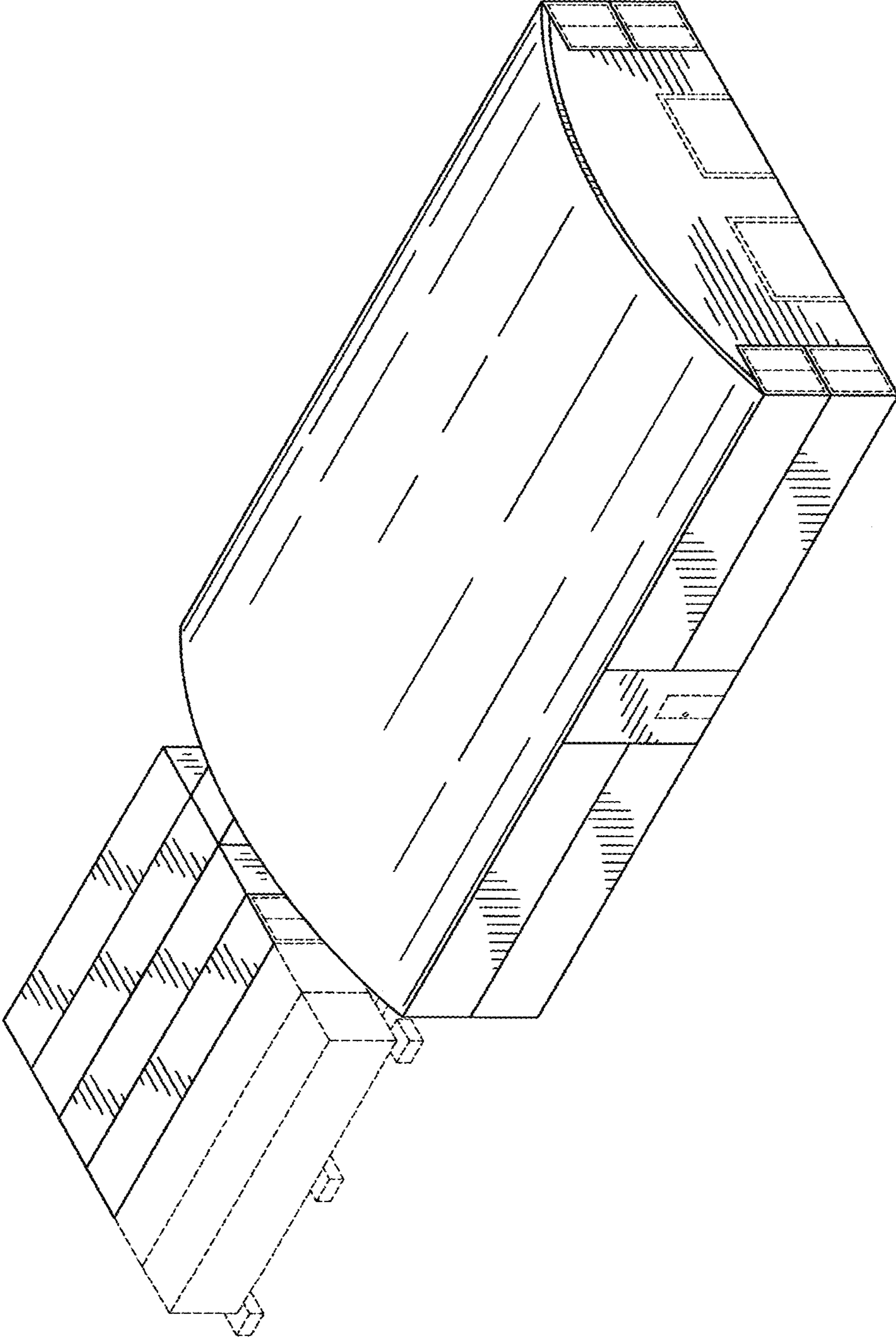

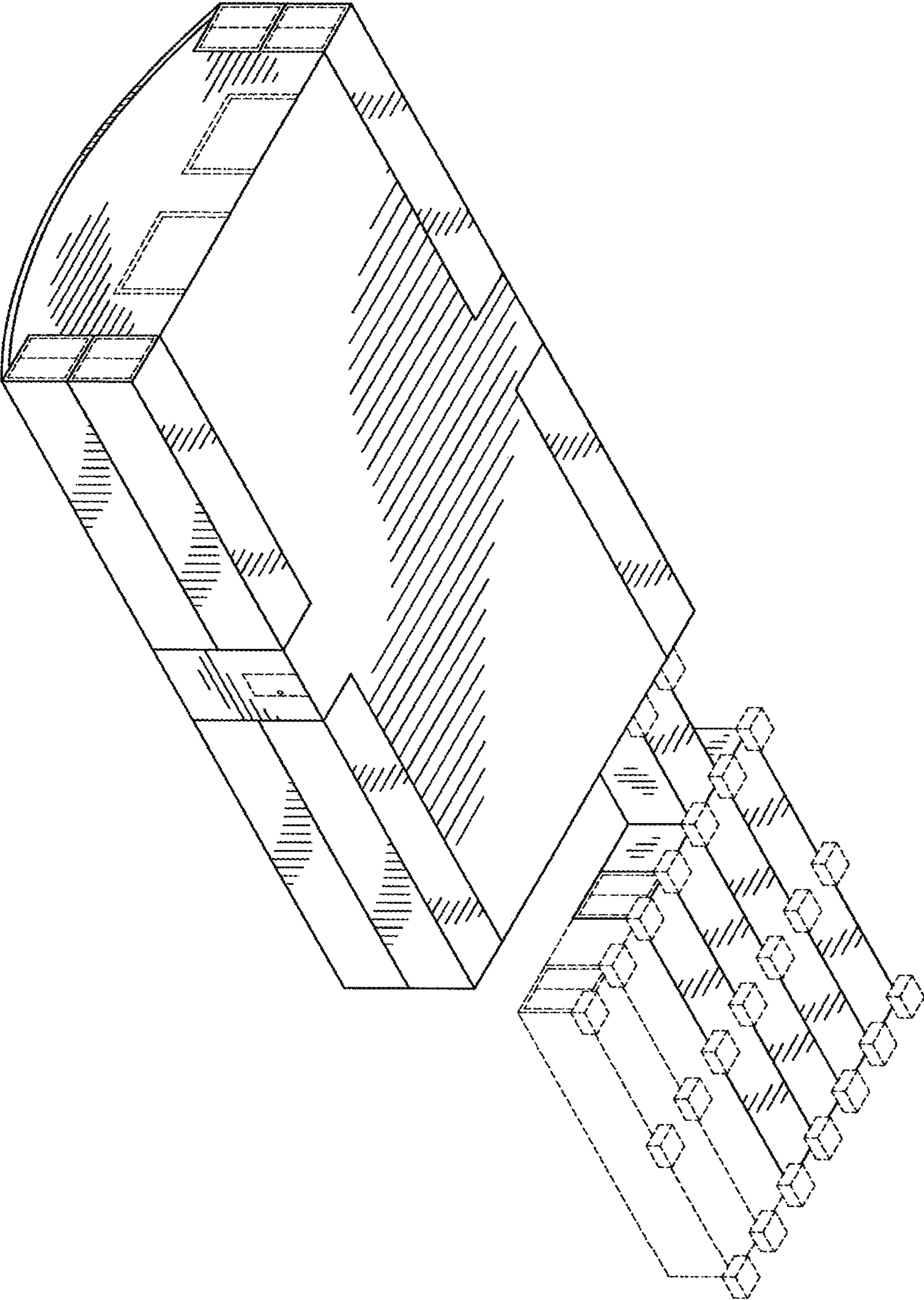

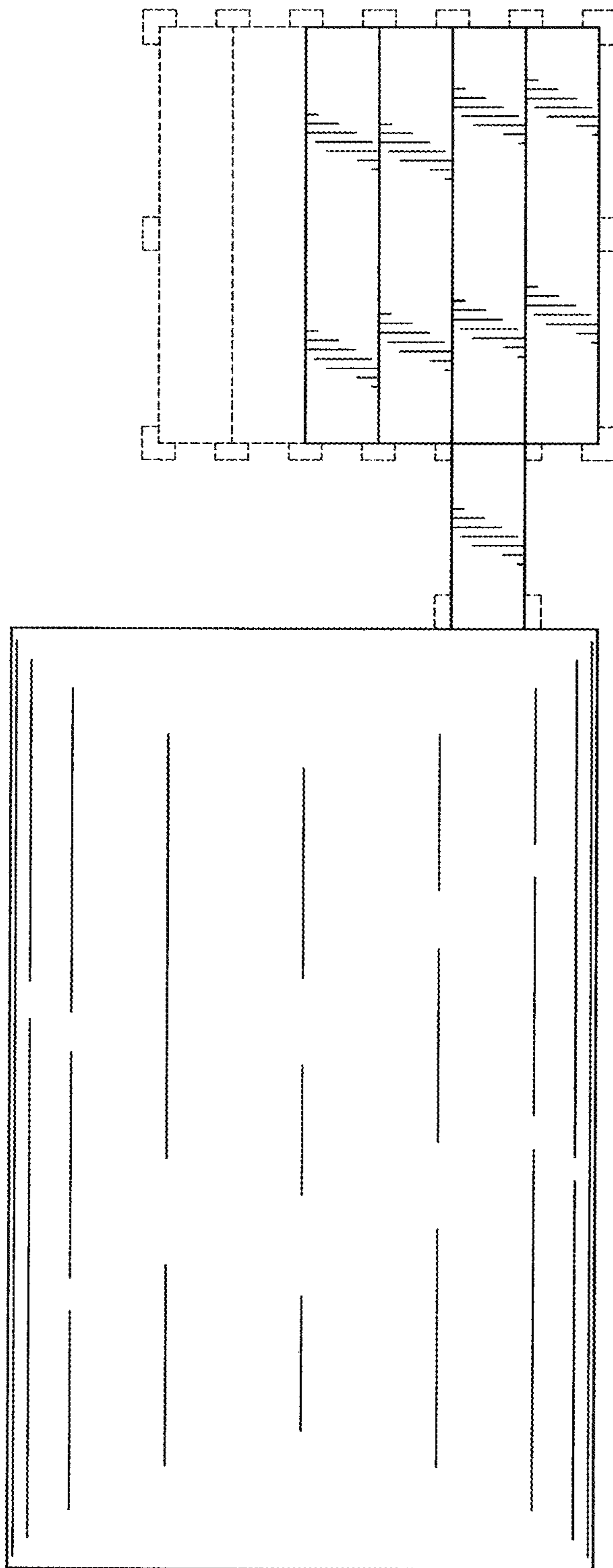

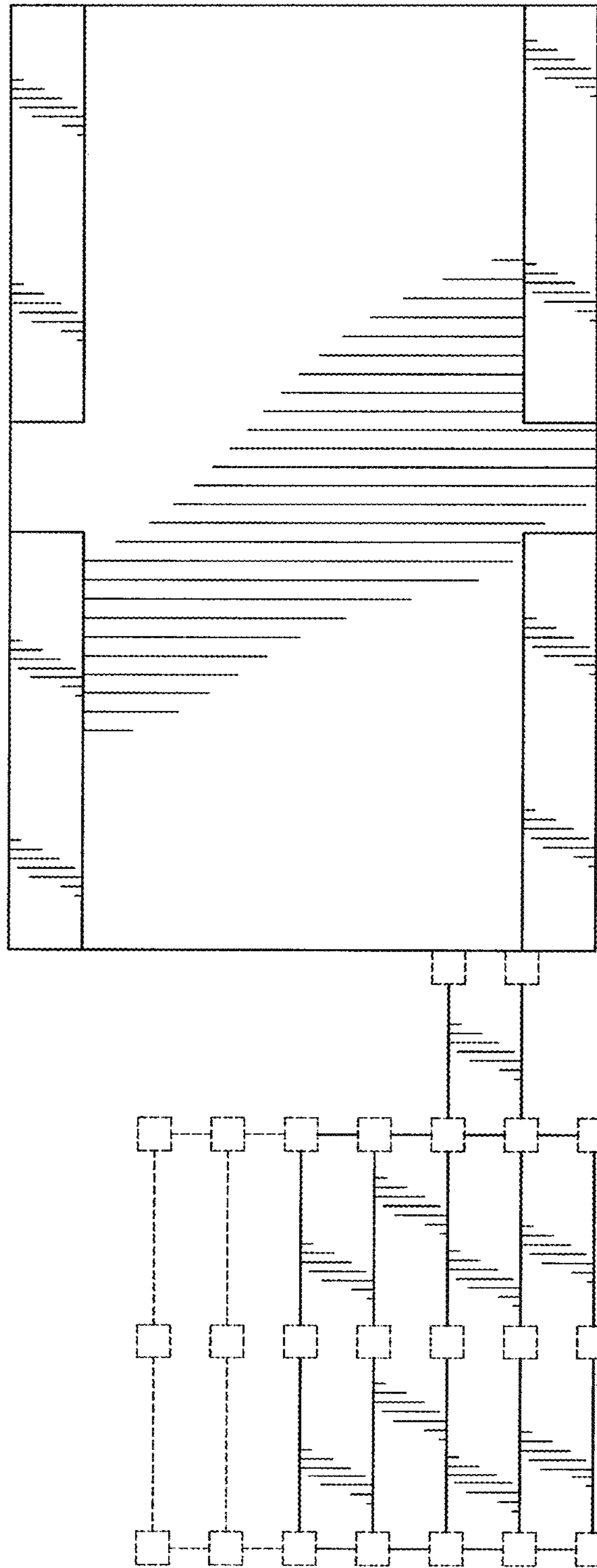

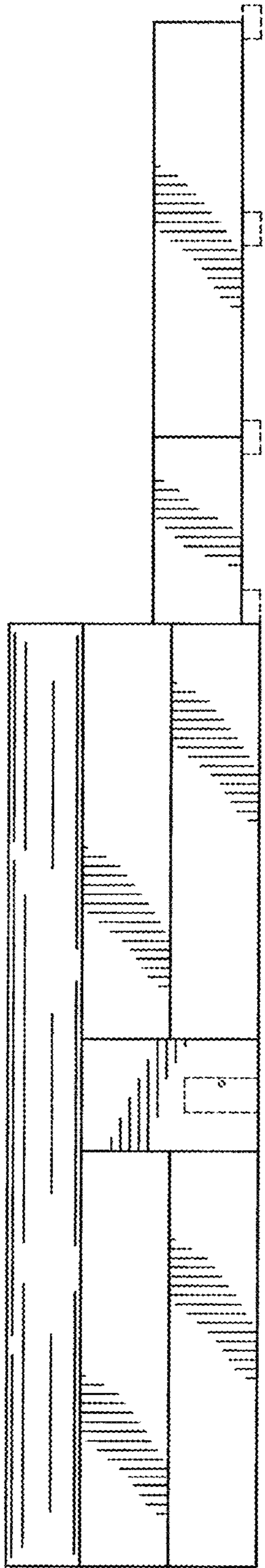

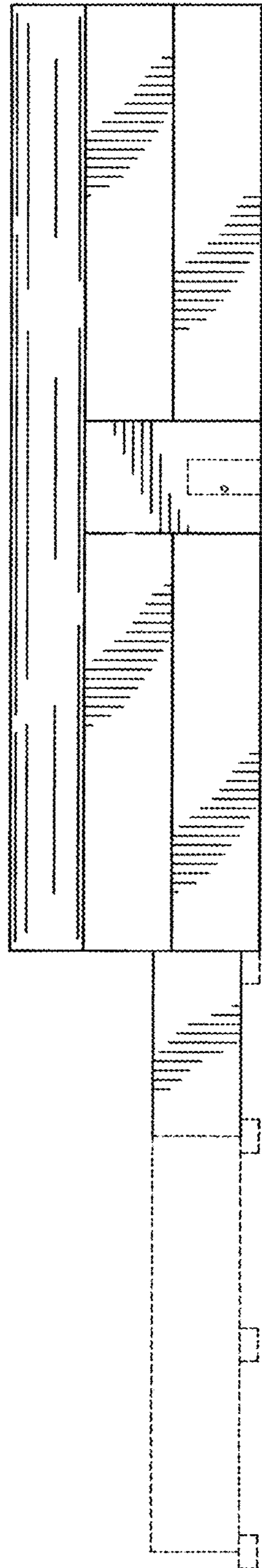

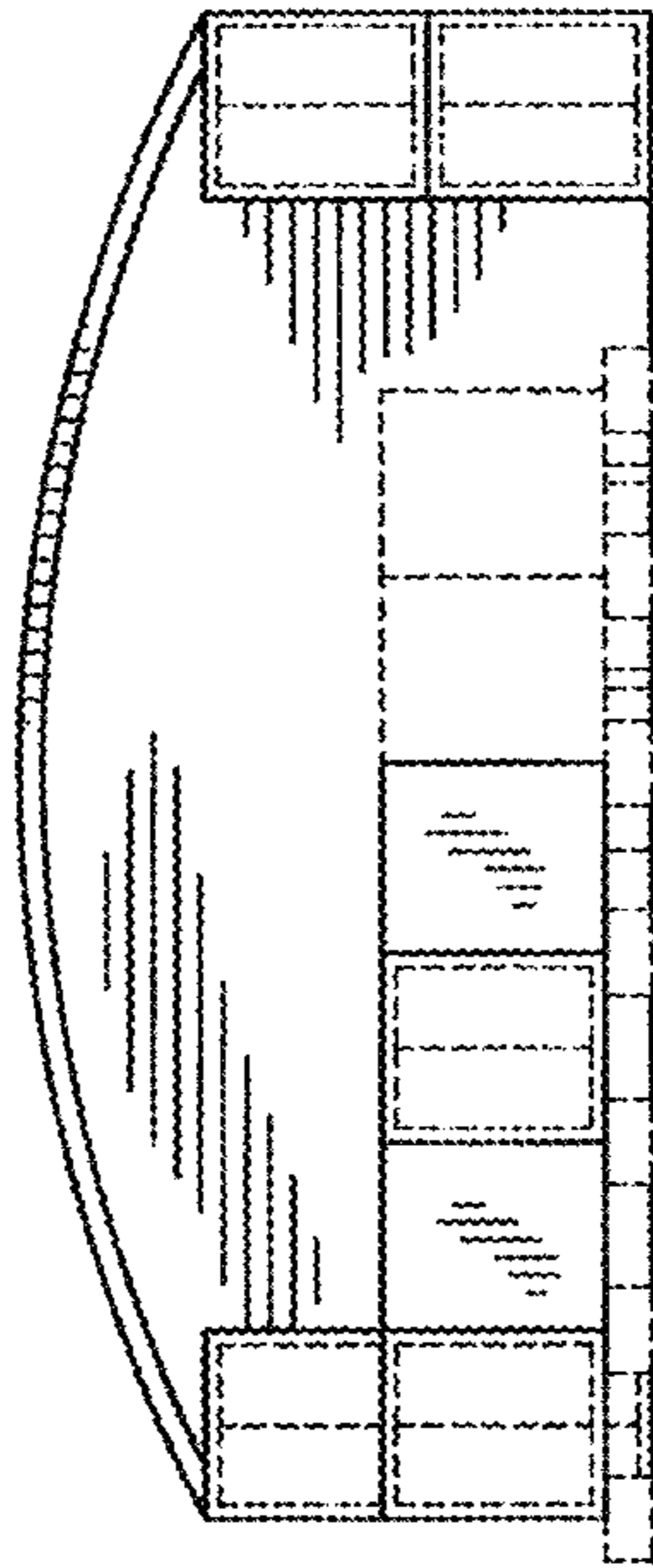

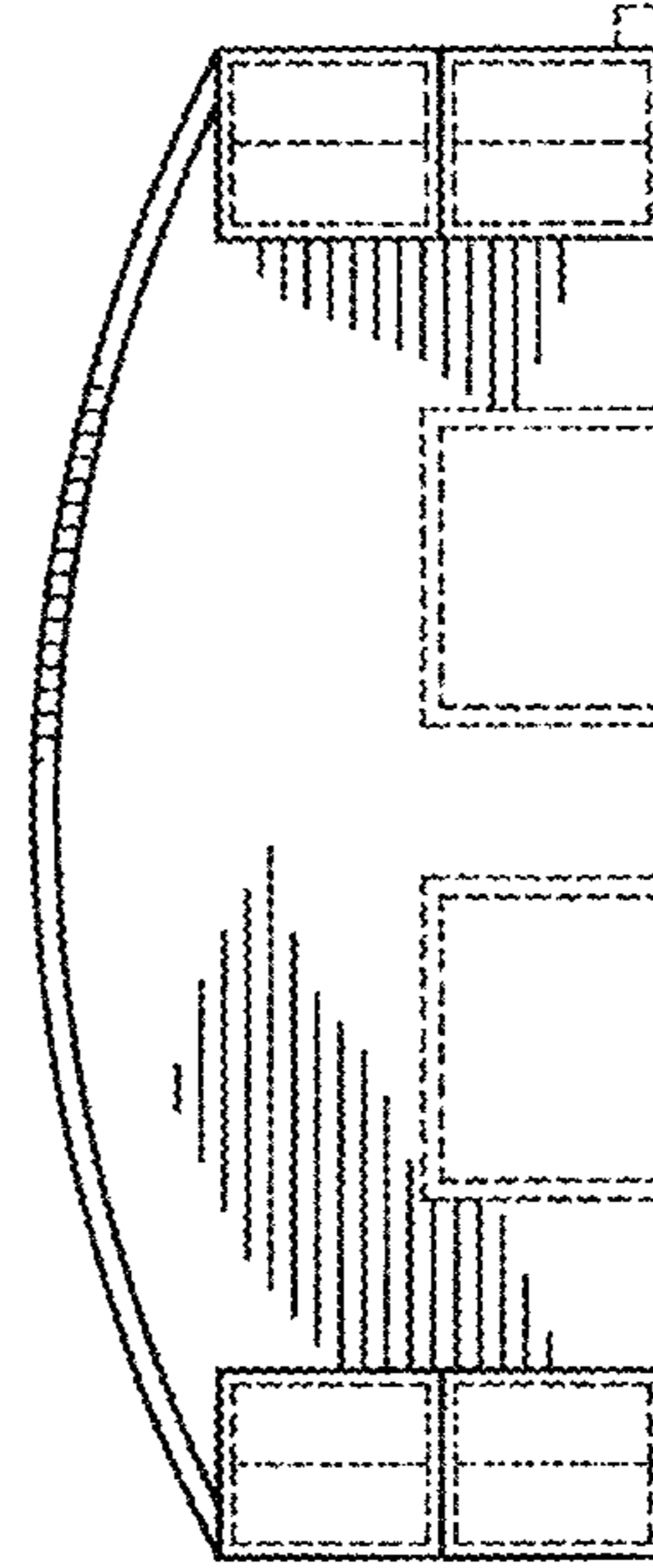
