FIG. 3 is a bottom view of FIG. 1;

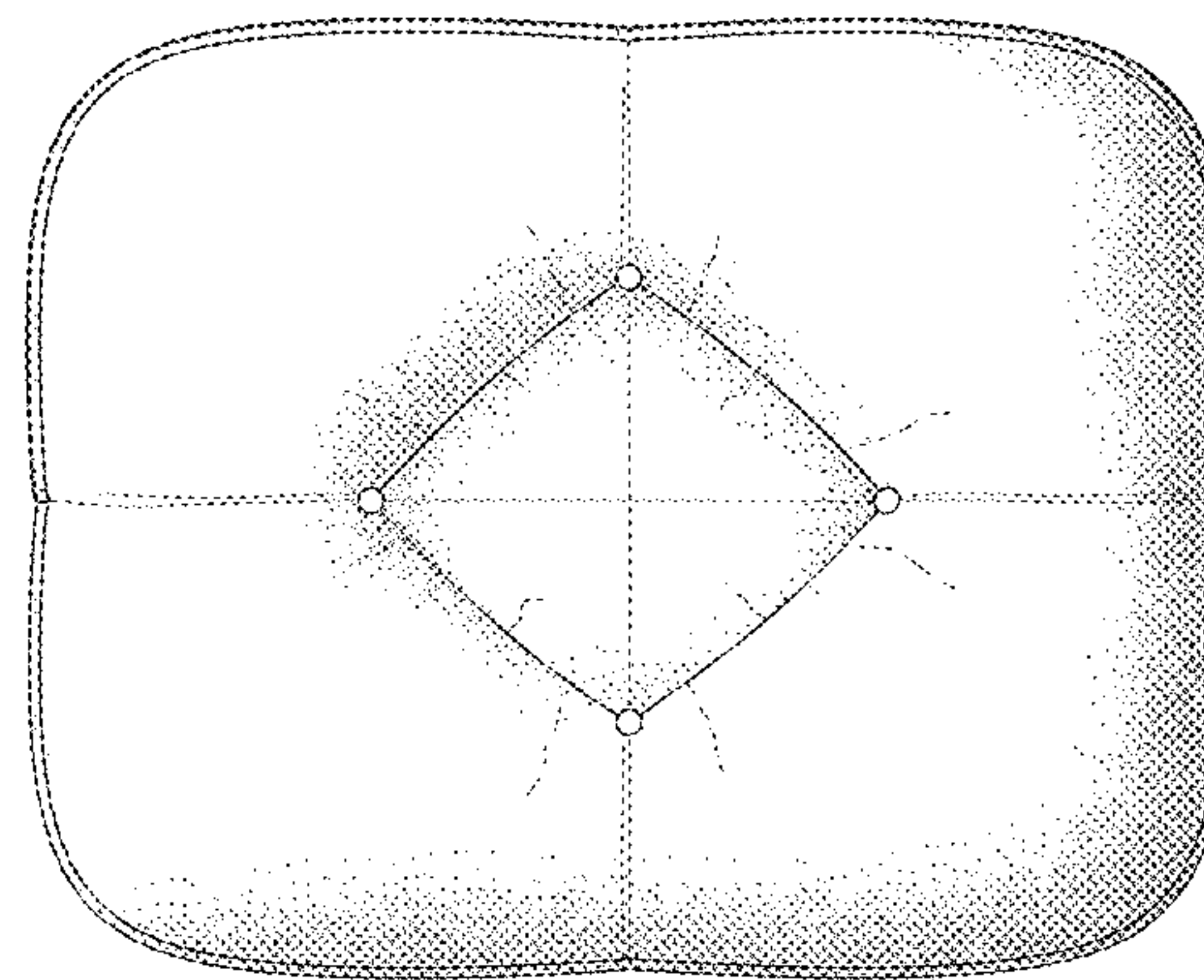
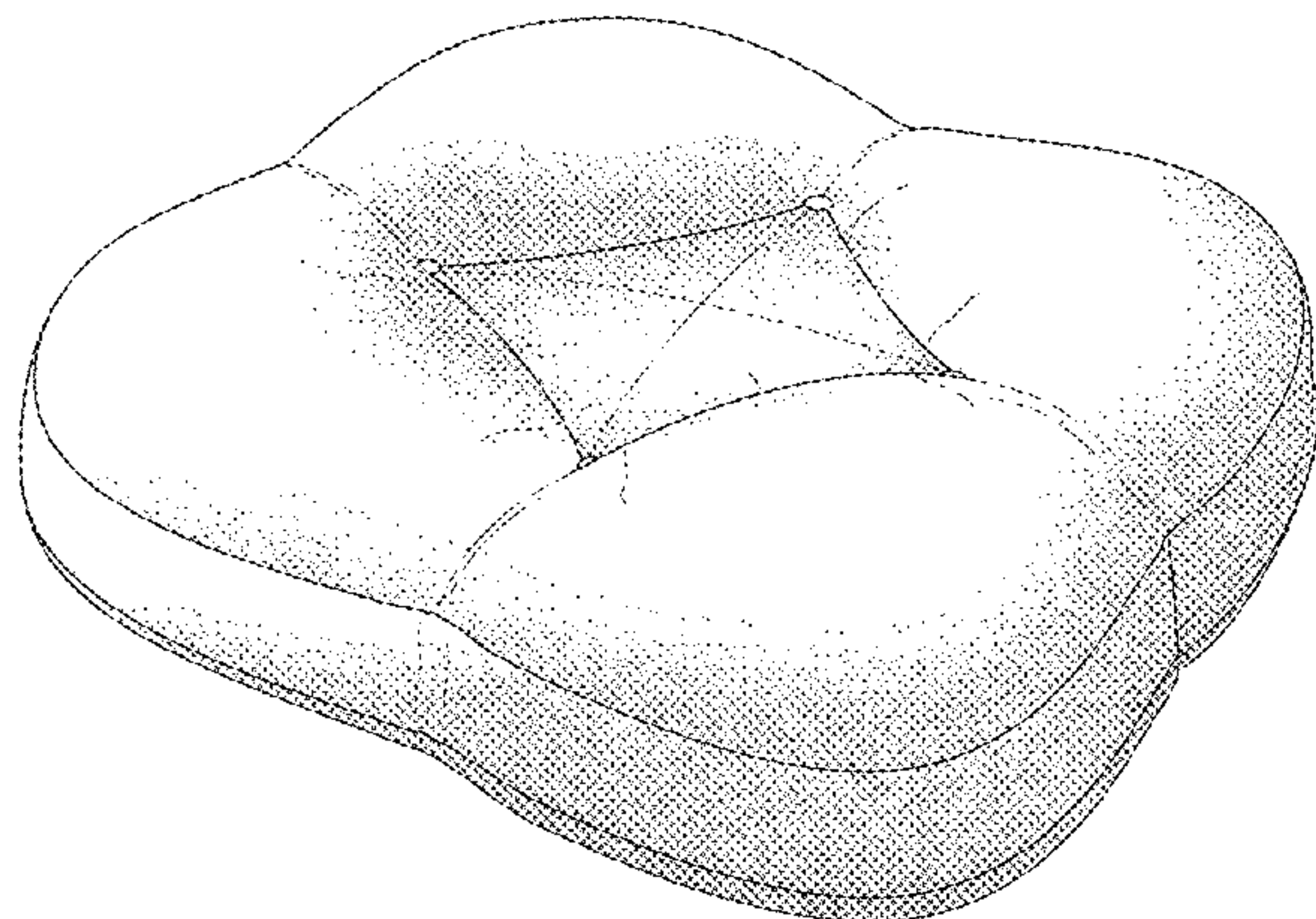
FIG. 4 is a front view of FIG. 1;

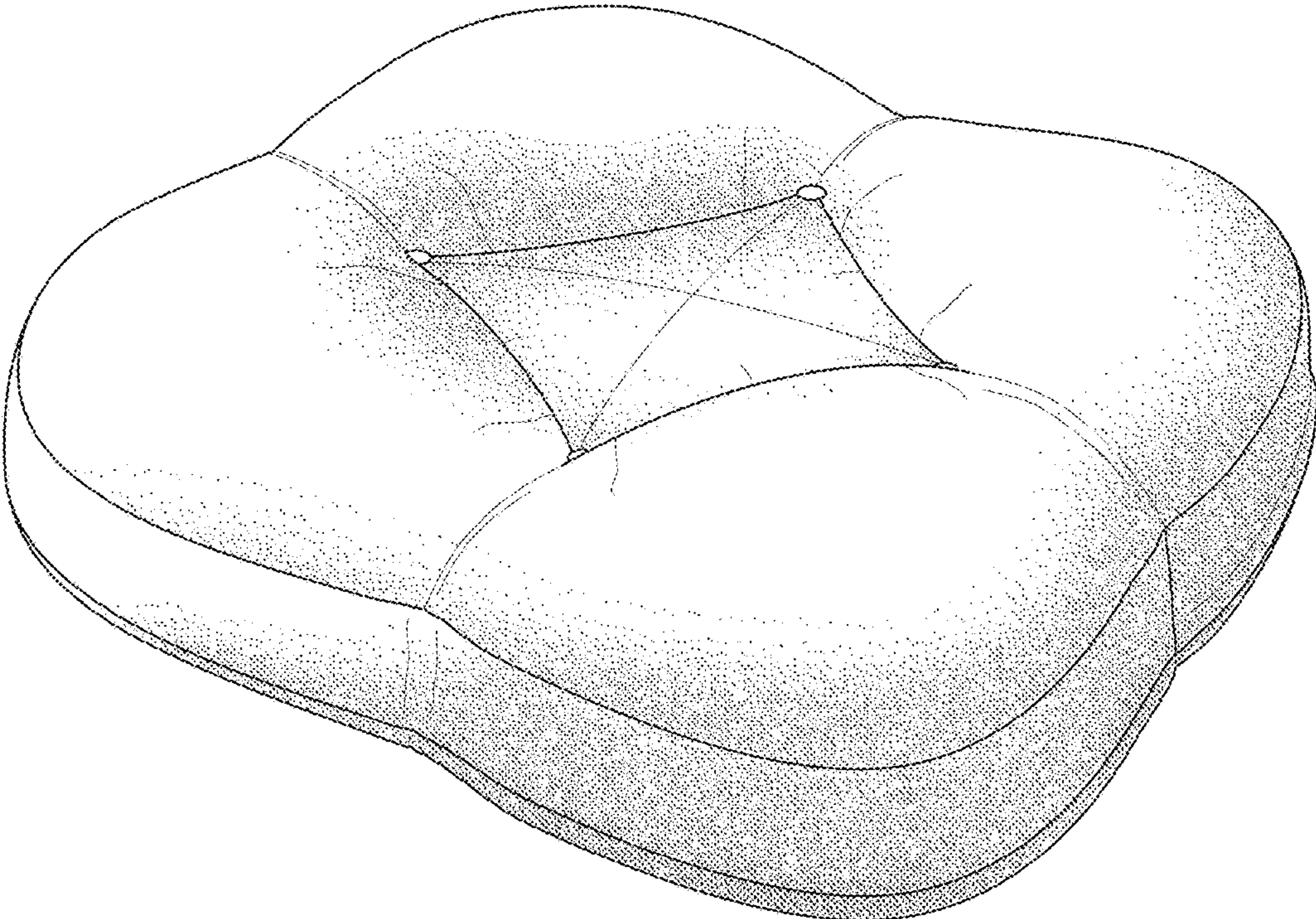

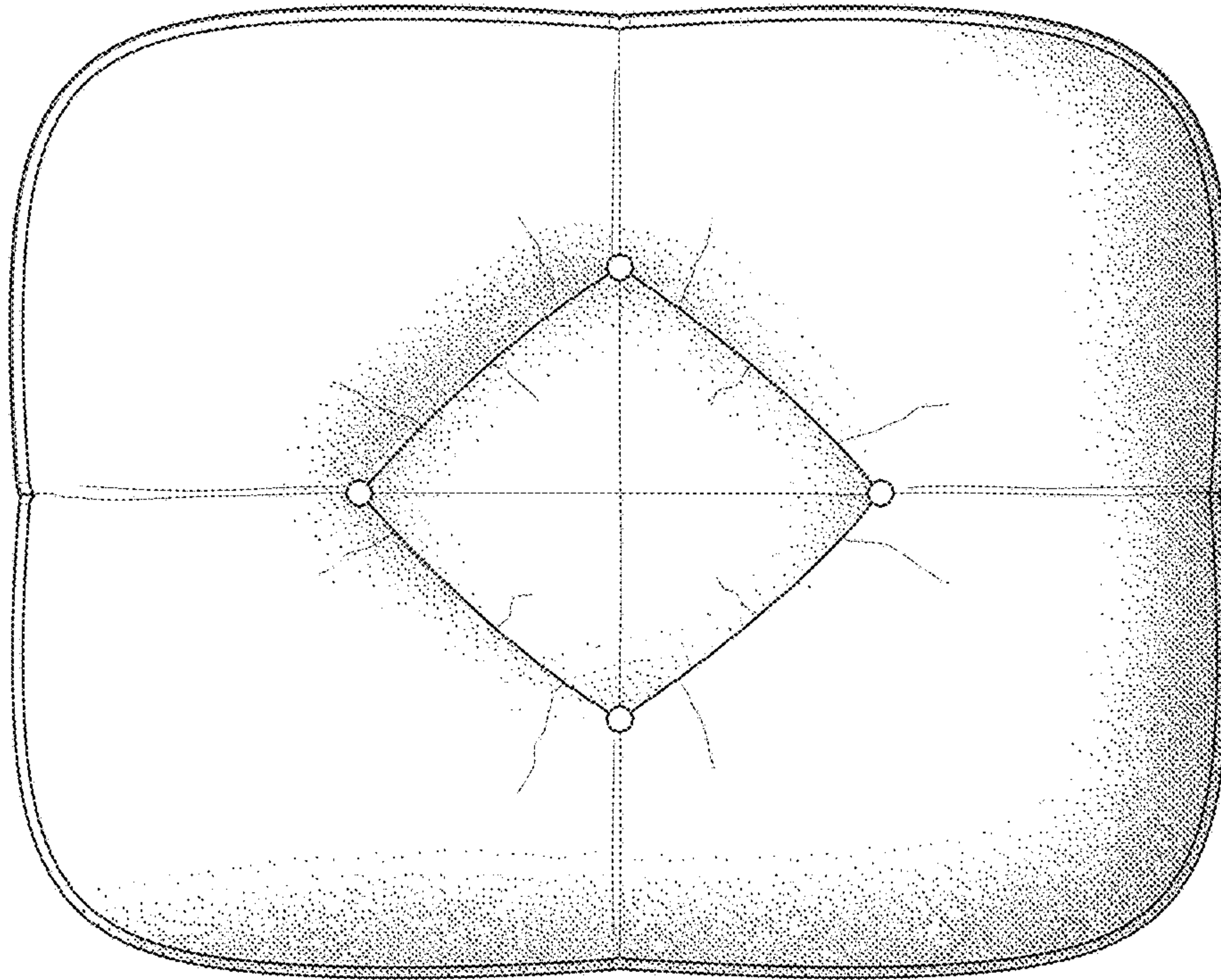

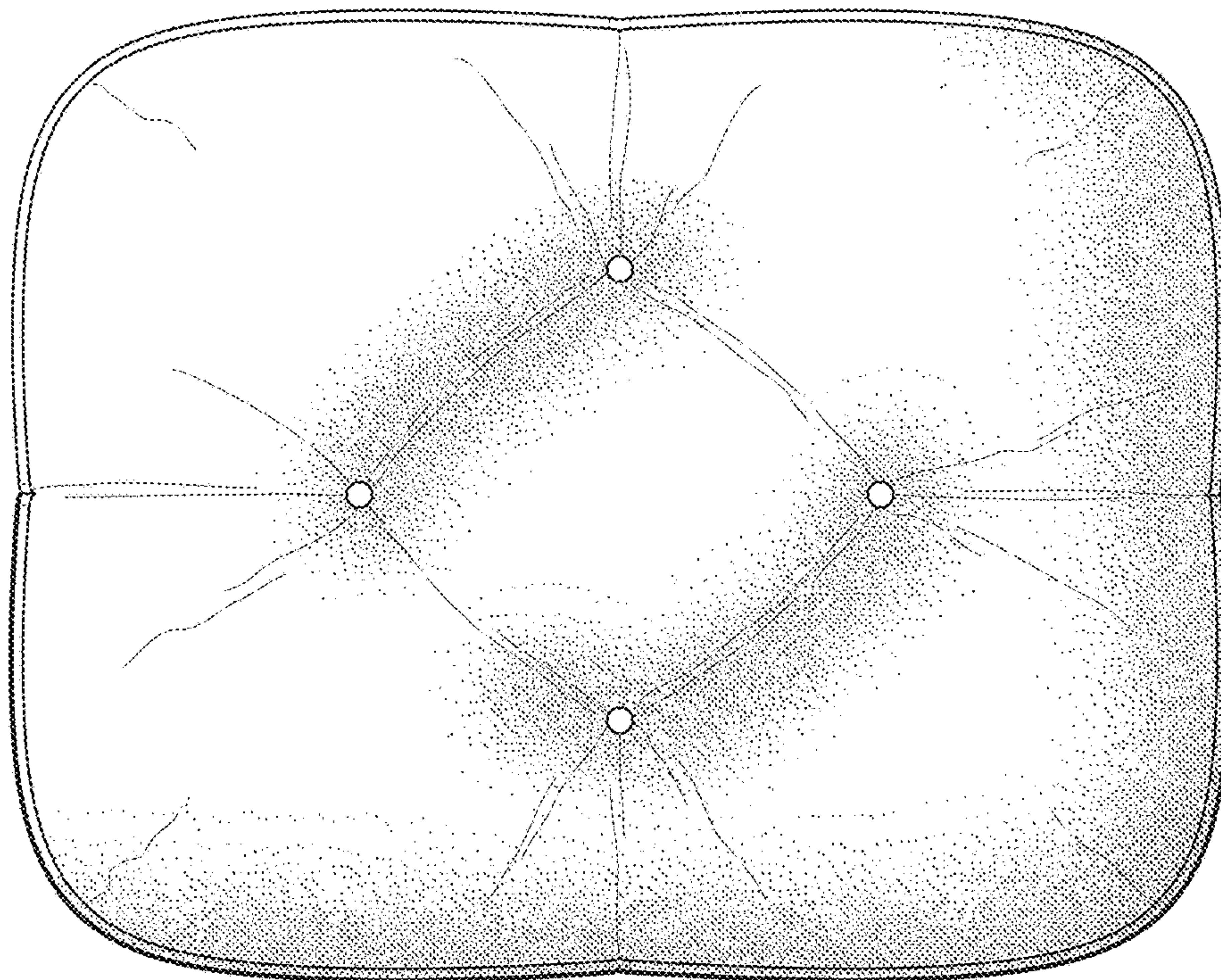

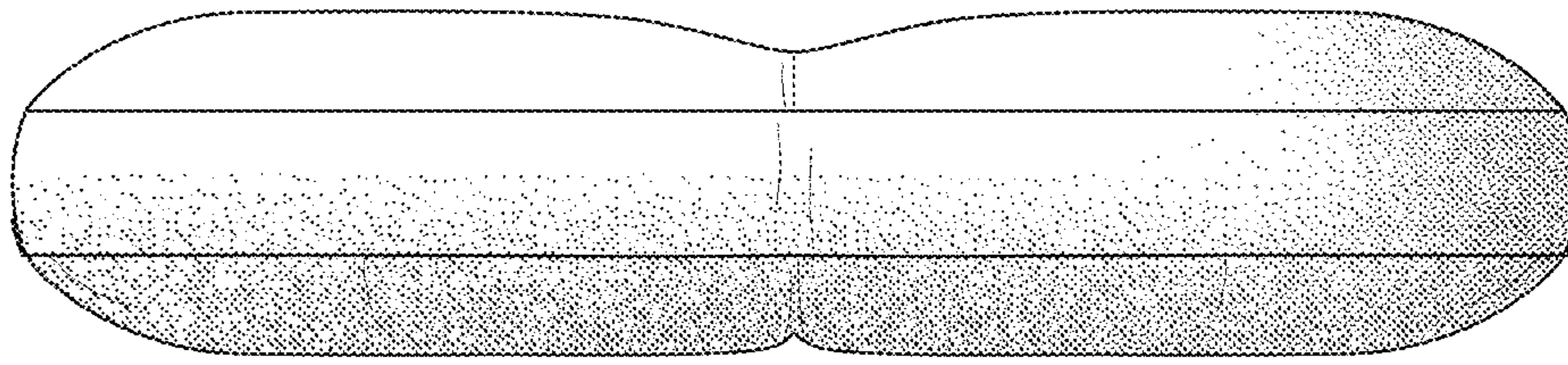

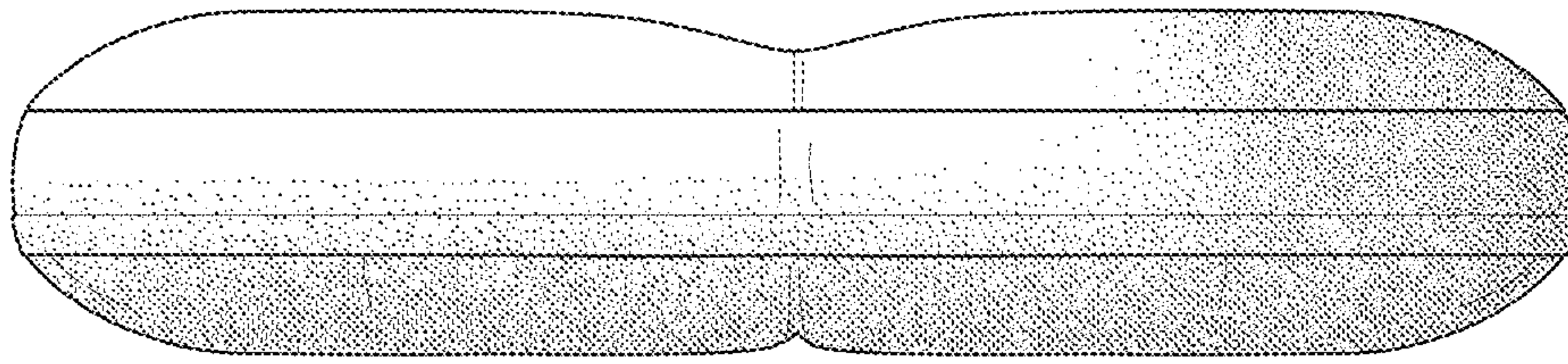

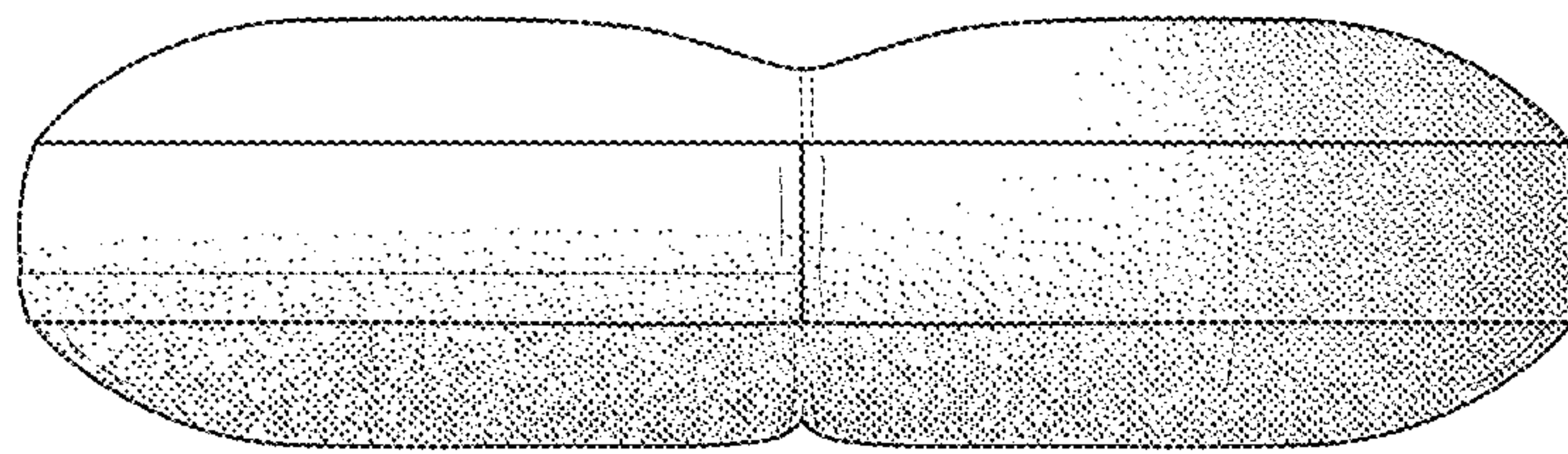

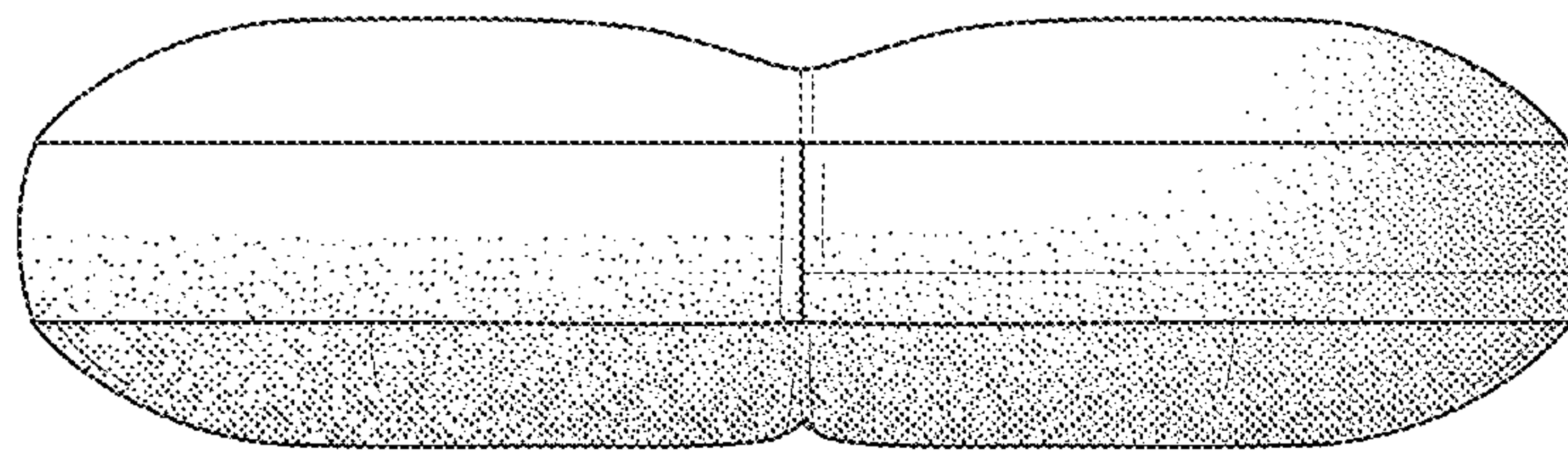
