FIG. 5 is a bottom plan view of the golf shoe upper portion of this invention;

FIG. 7 is a rear elevation view of the golf shoe upper portion of this invention.

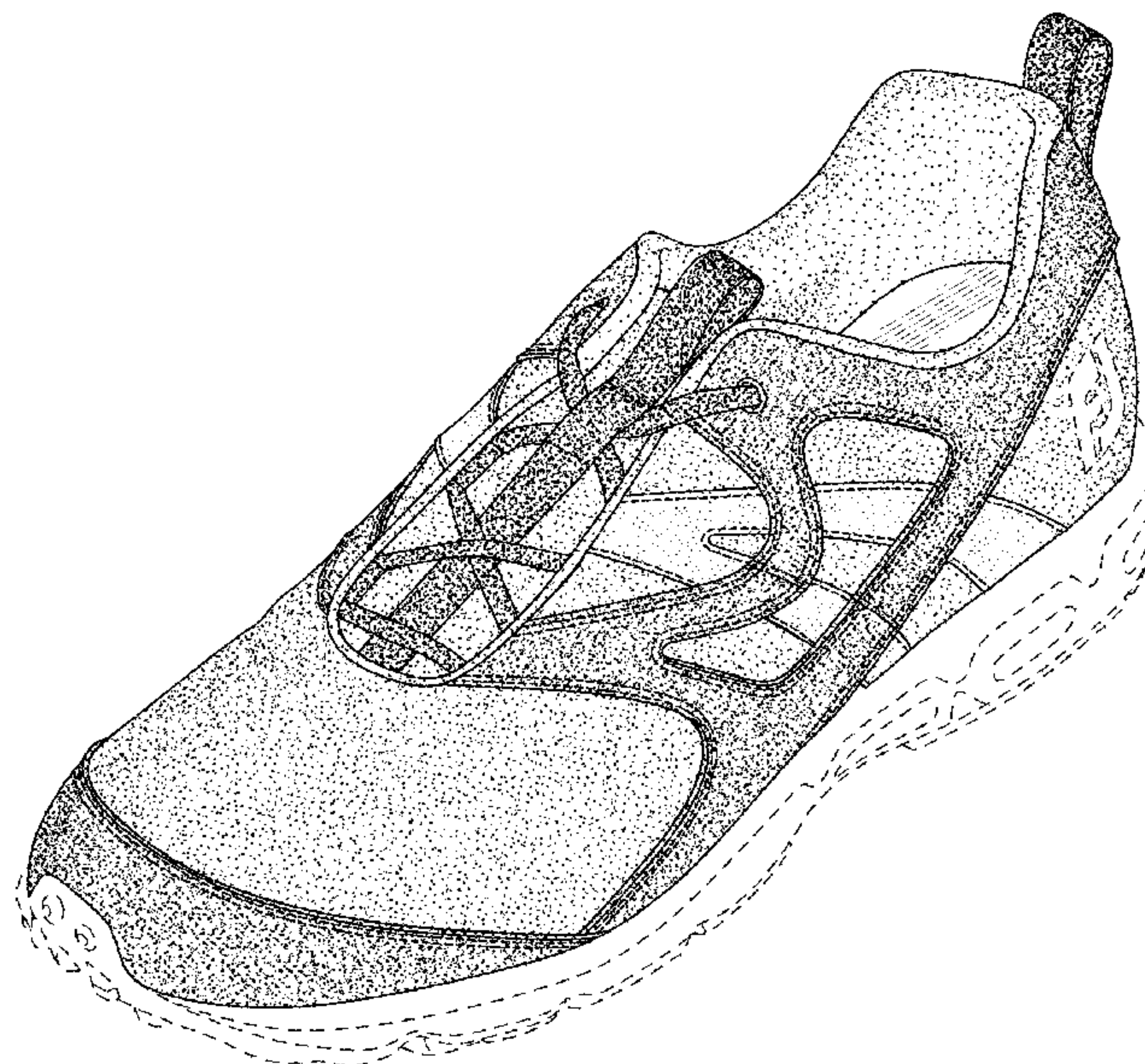
In FIGS. 1-7, the broken lines showing a logo on the top surface of the shoe form no part of the claimed design. The different stippling shown on the top surface of the shoe indicates a contrast in texture between the respective areas of the top surface and is not surface shading. Also, the broken lines showing a shoe outsole including cleats on the bottom surface of the shoe form no part of the claimed design.

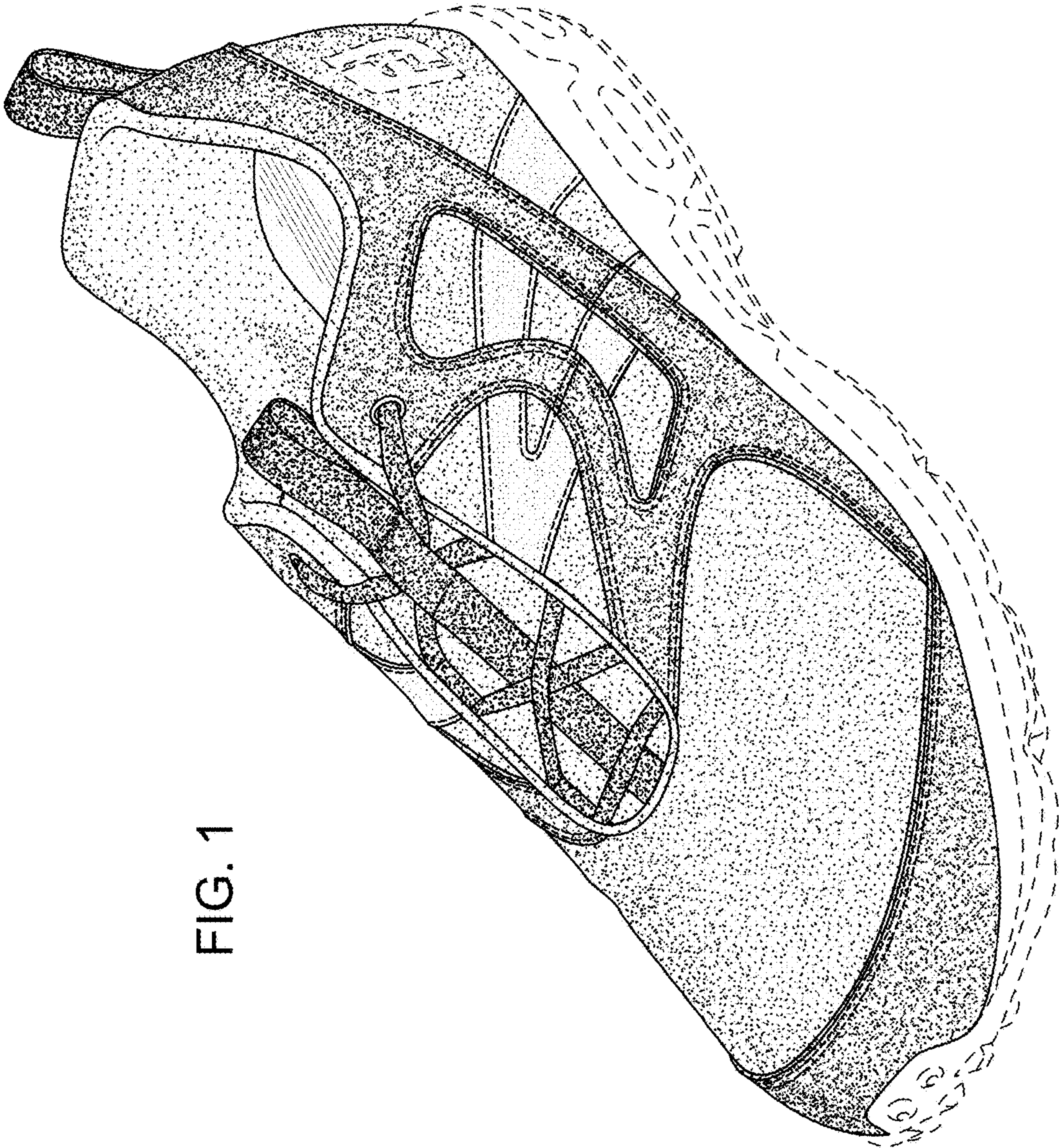

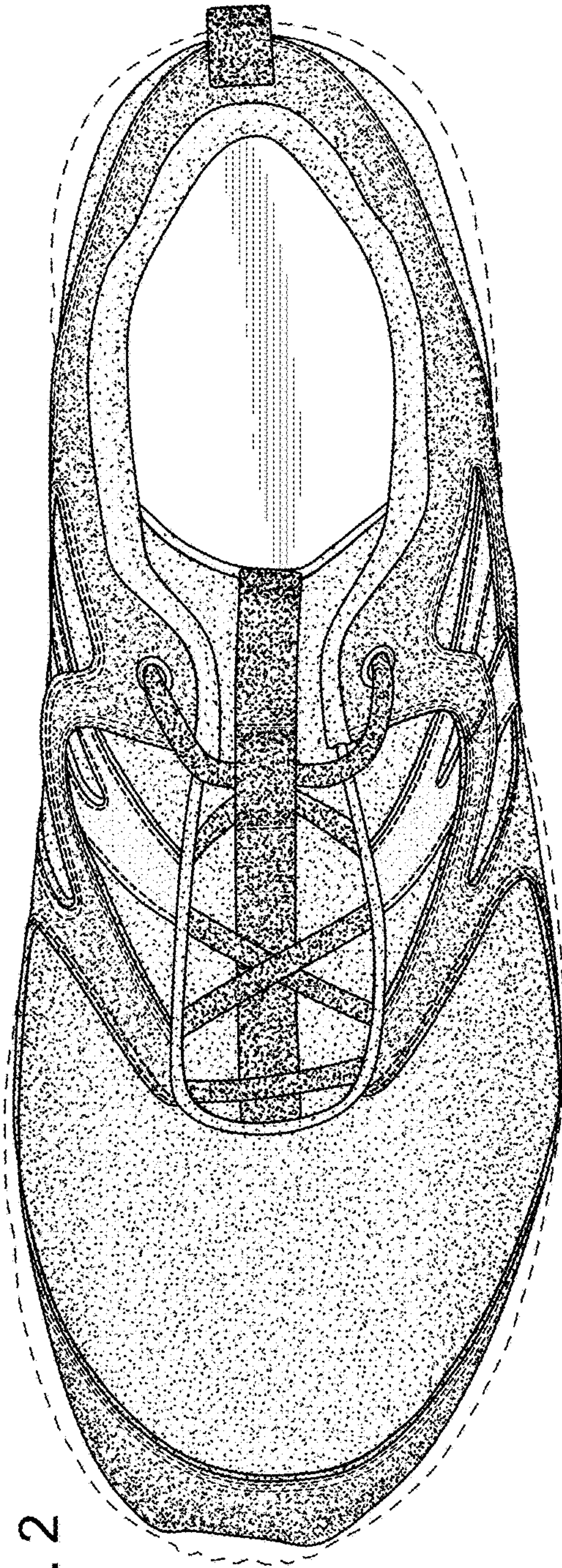

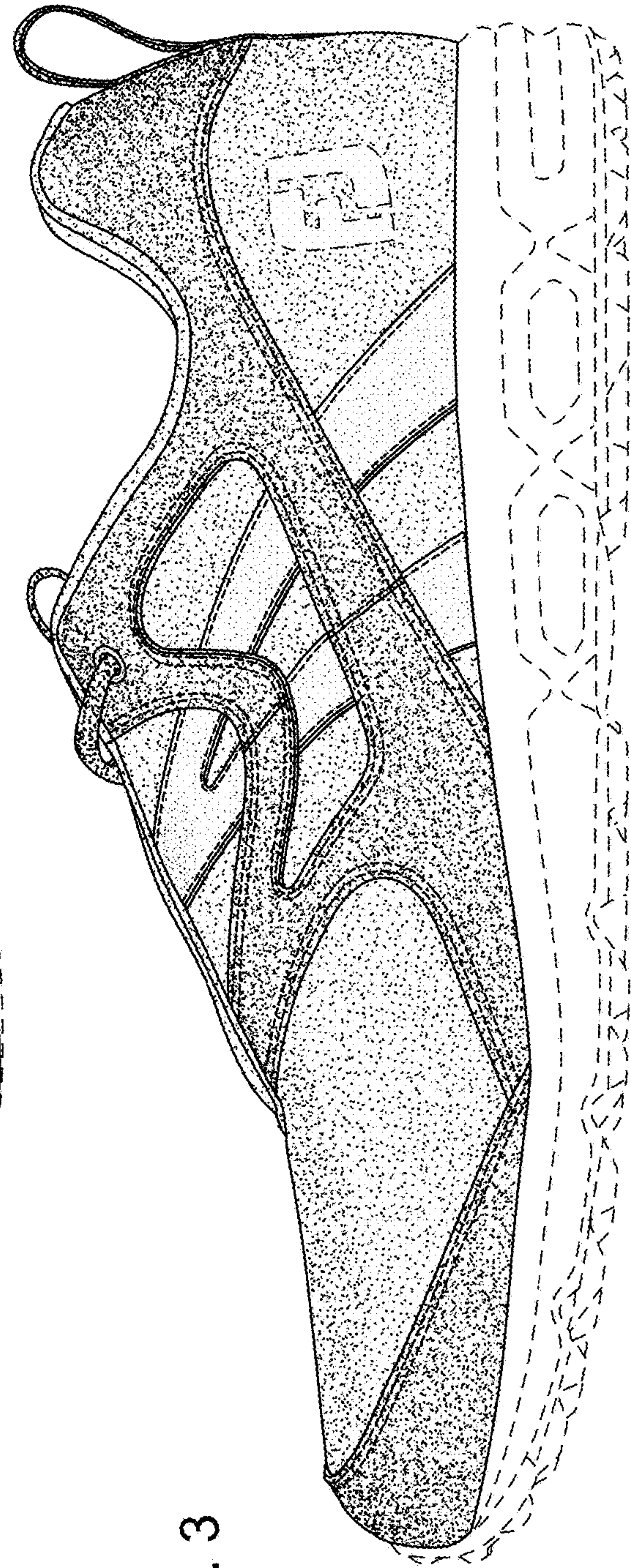

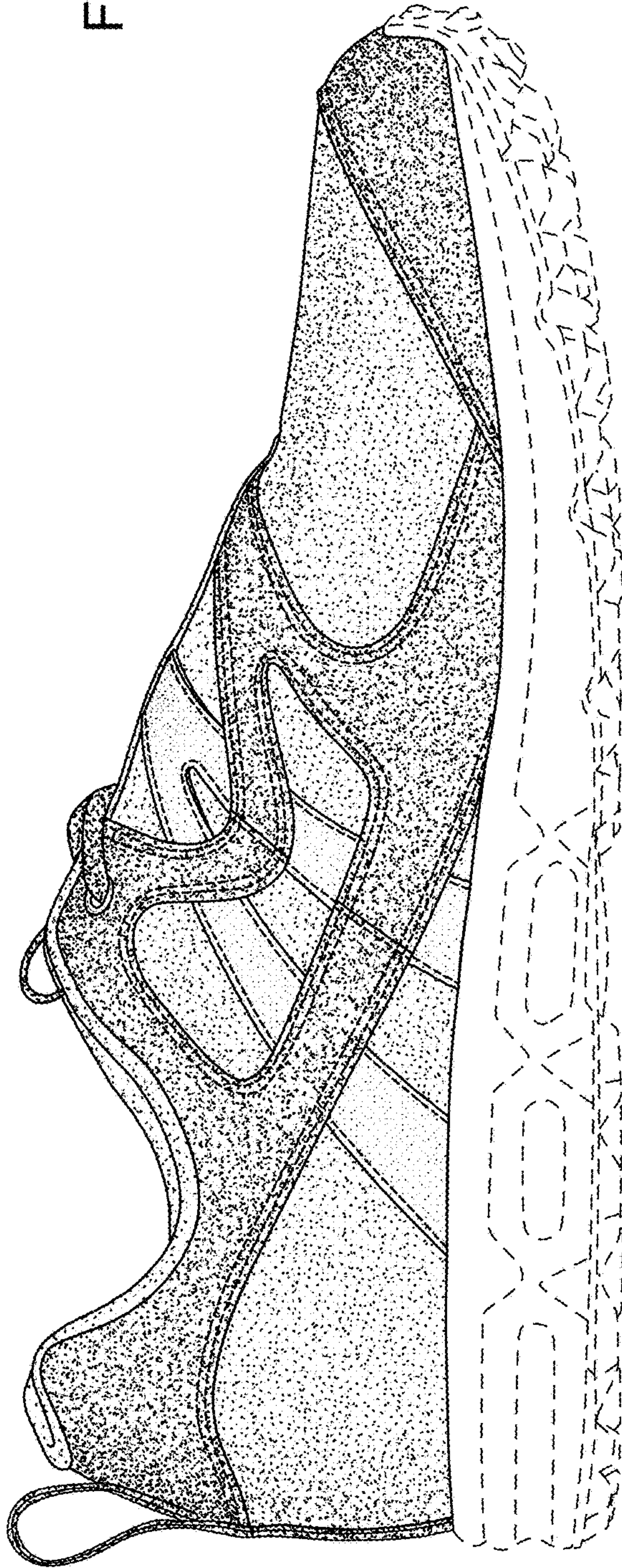
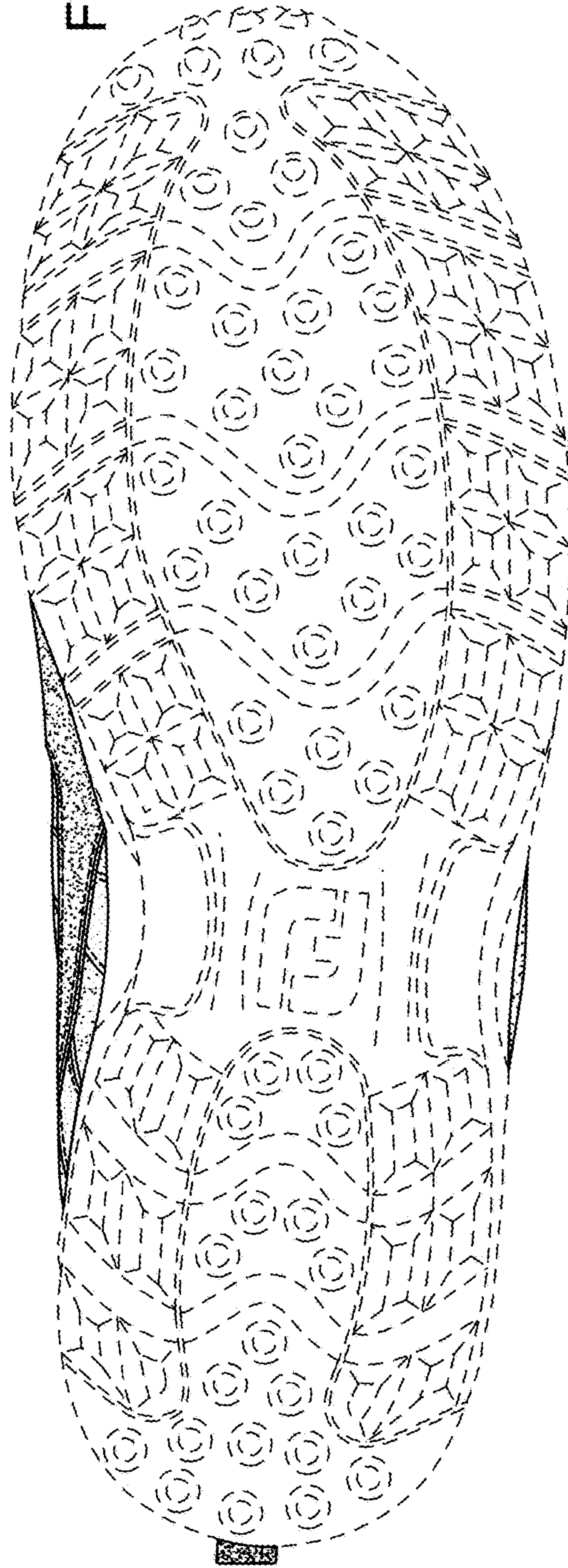

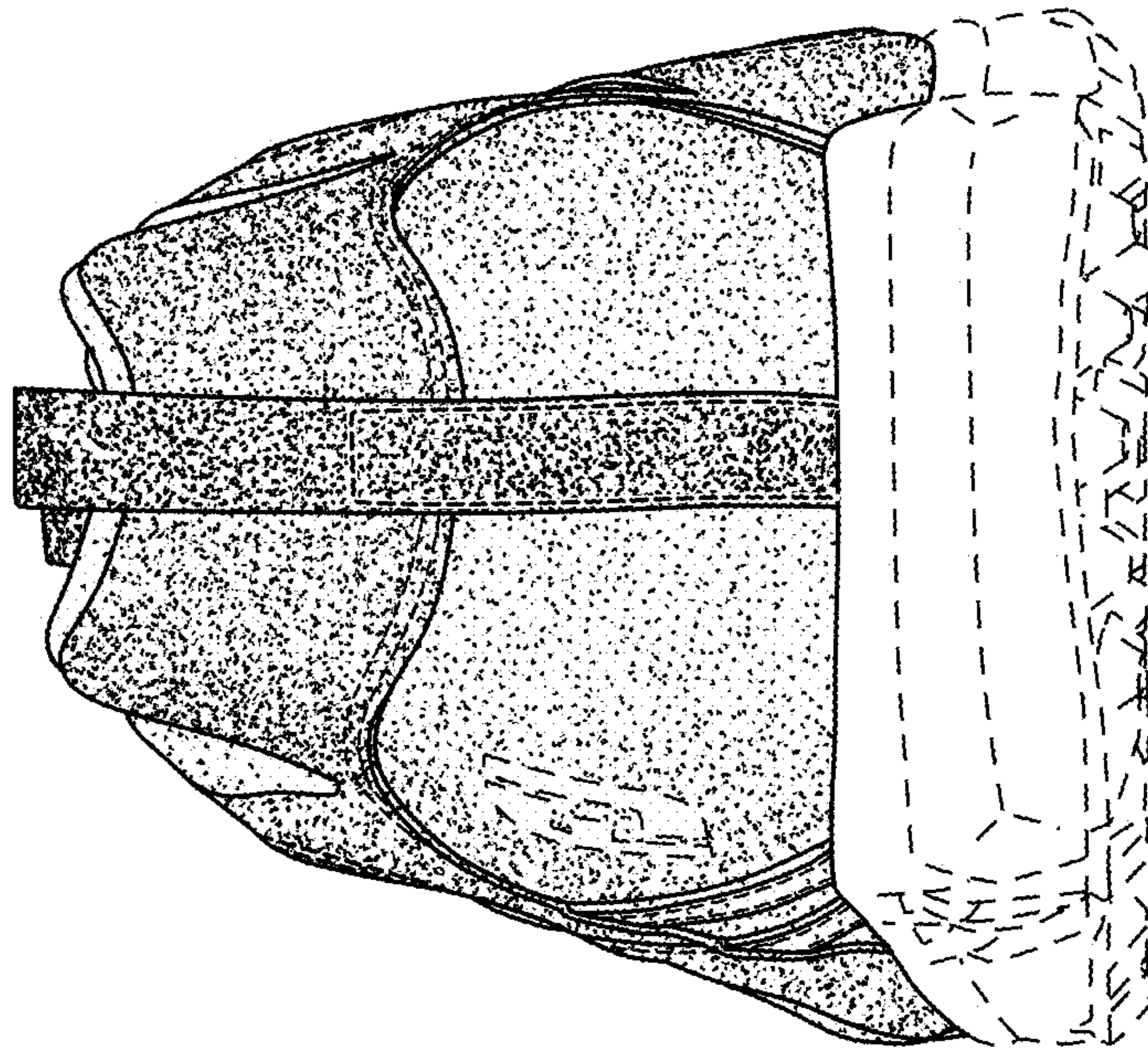

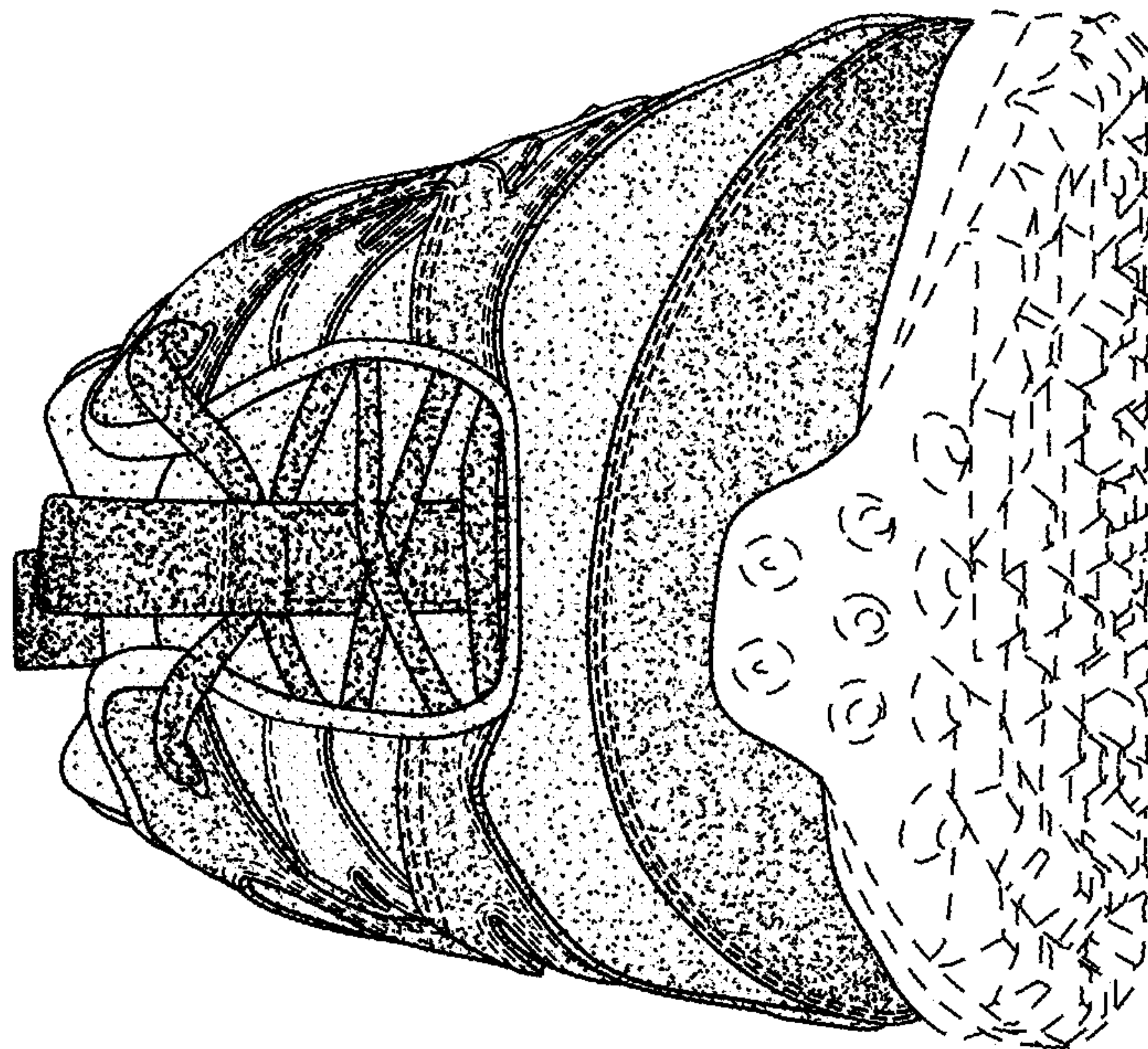
