I claim the ornamental design for a shoe, as shown and described.

DESCRIPTION

FIG. 1 is a front perspective view of a shoe of the claimed design;
FIG. 2 is a front elevational view of the shoe shown in FIG. 1;
FIG. 3 is a rear elevational view of the shoe shown in FIG. 1;
FIG. 4 is a right side elevational view of the shoe shown in FIG. 1;
FIG. 5 is a left side view of the shoe shown in FIG. 1;
FIG. 6 is a top plan view of the shoe shown in FIG. 1; and,
FIG. 7 is a bottom plan view of the shoe shown in FIG. 1.

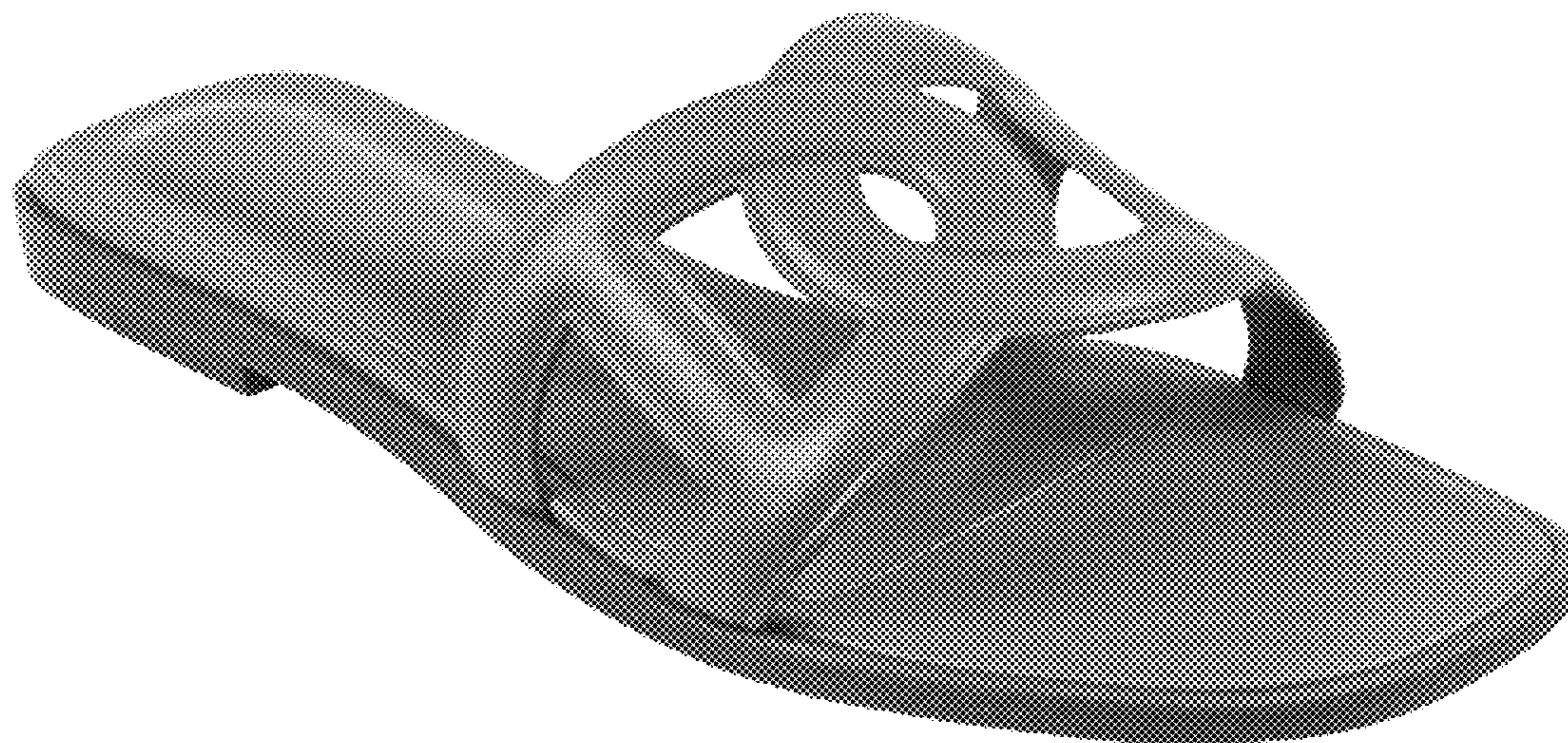

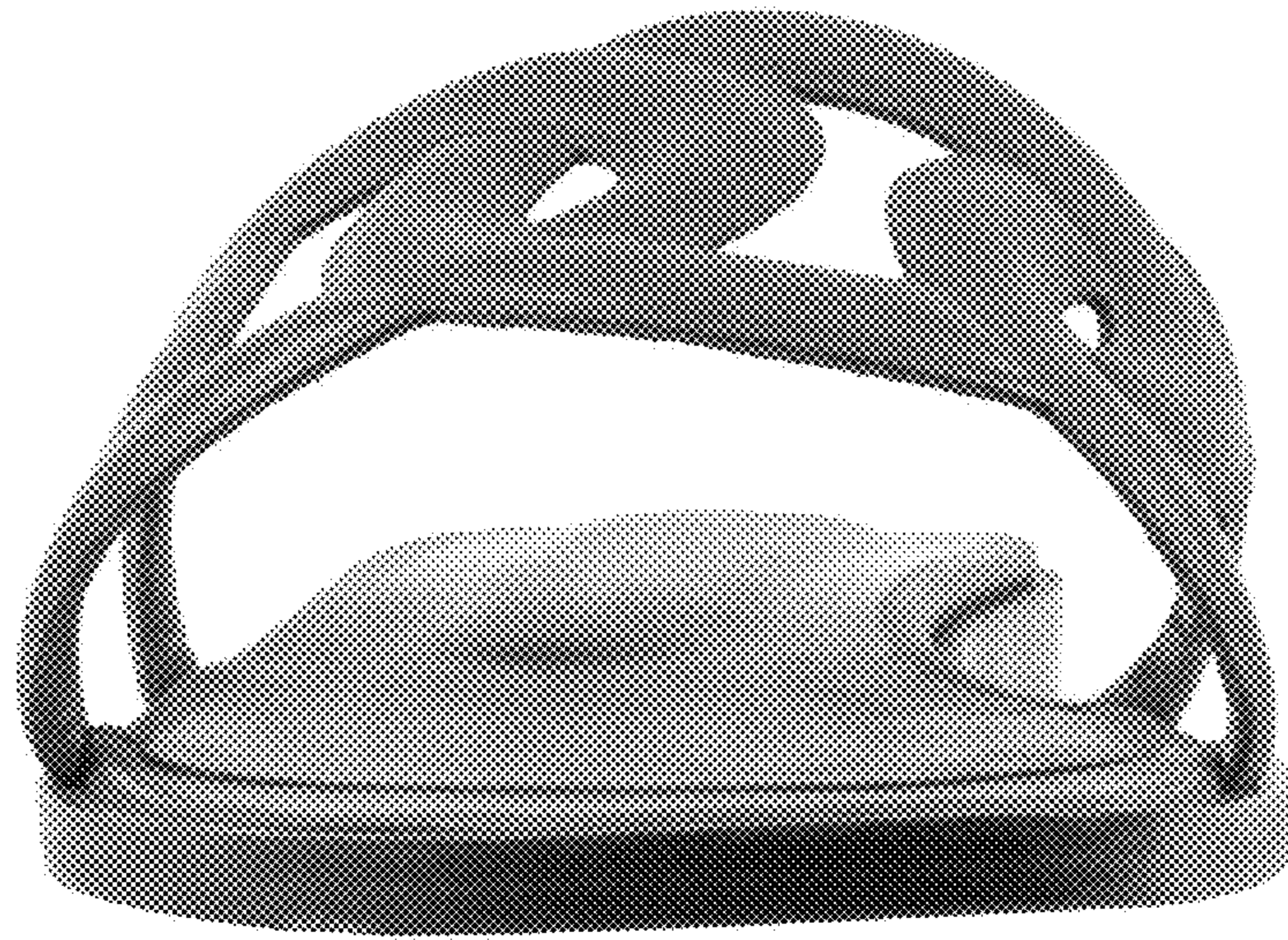

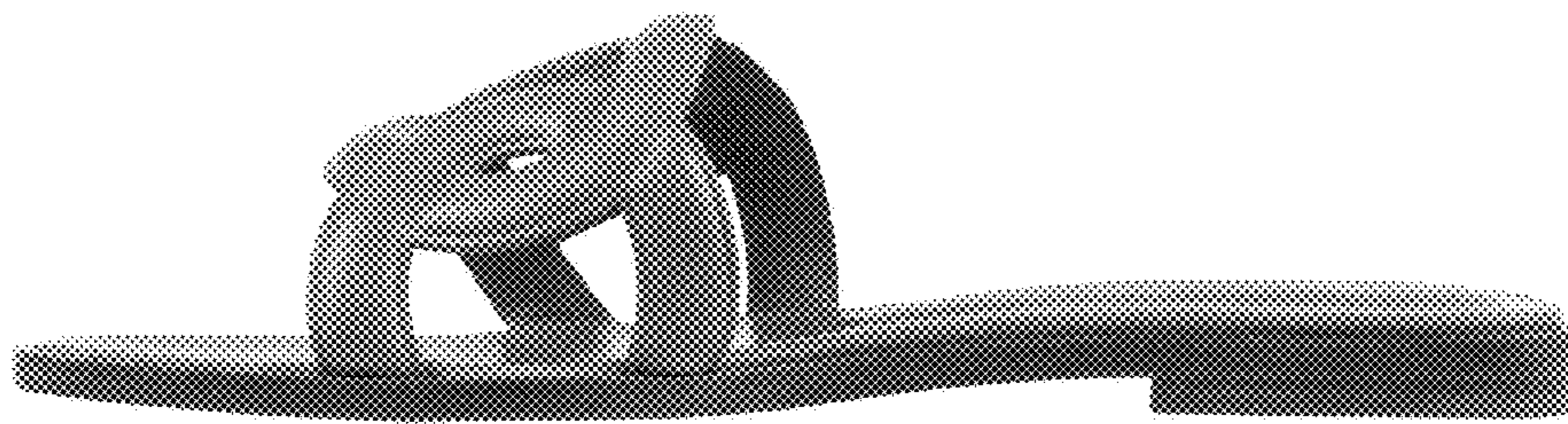

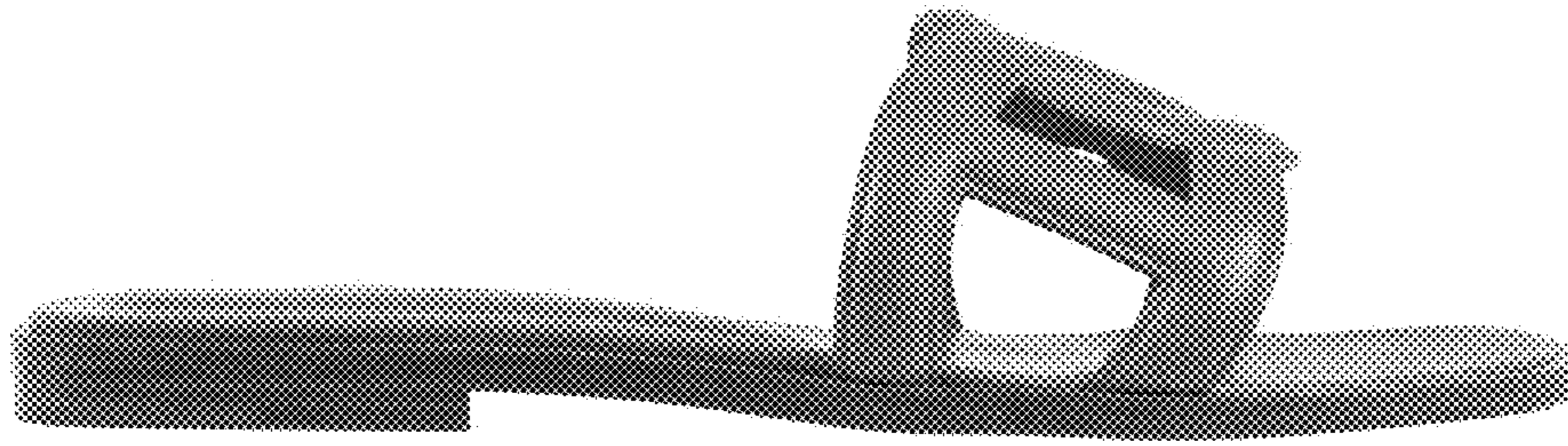

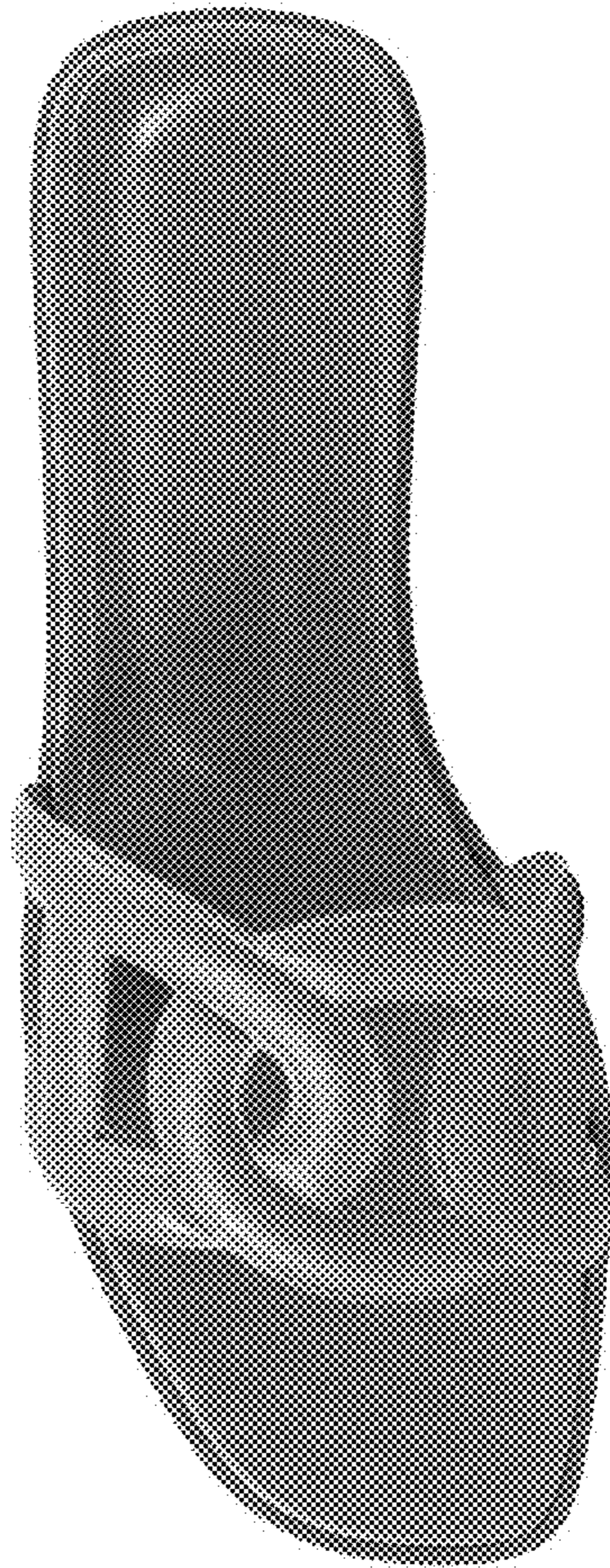

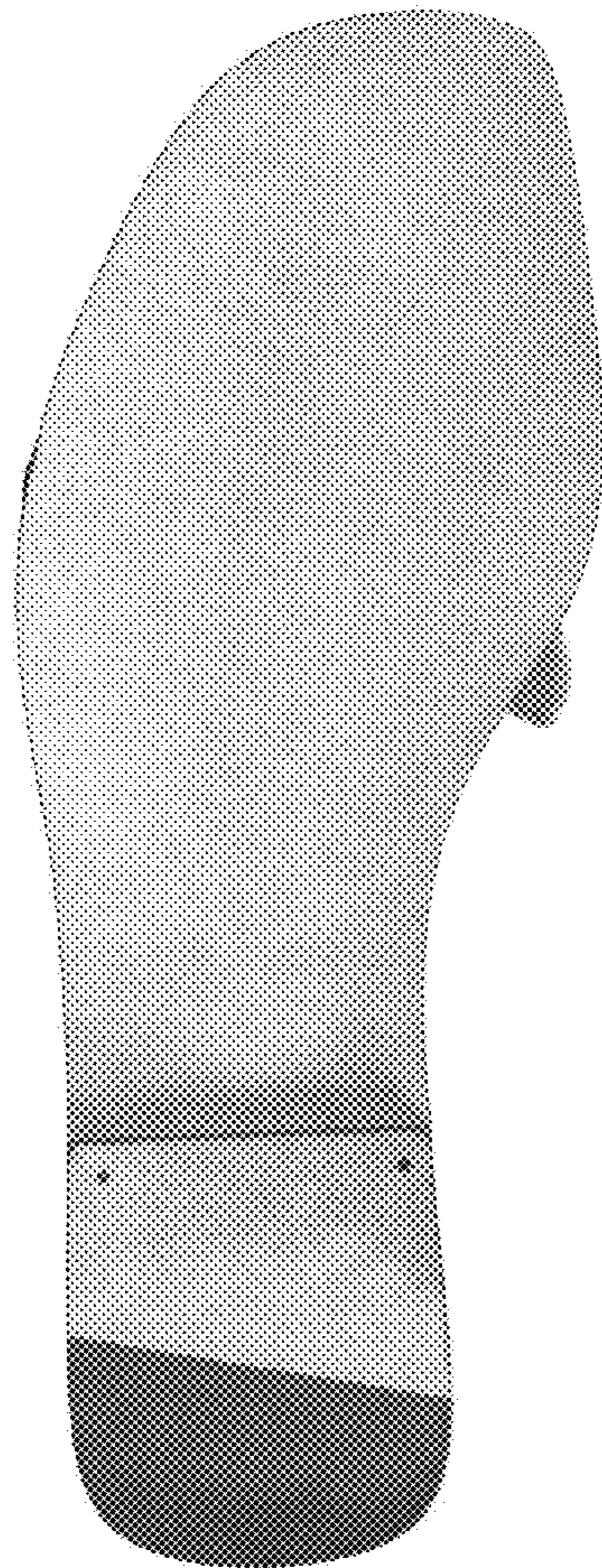
