DESCRIPTION

FIG. 1 is a front perspective view of a footwear showing my new design;

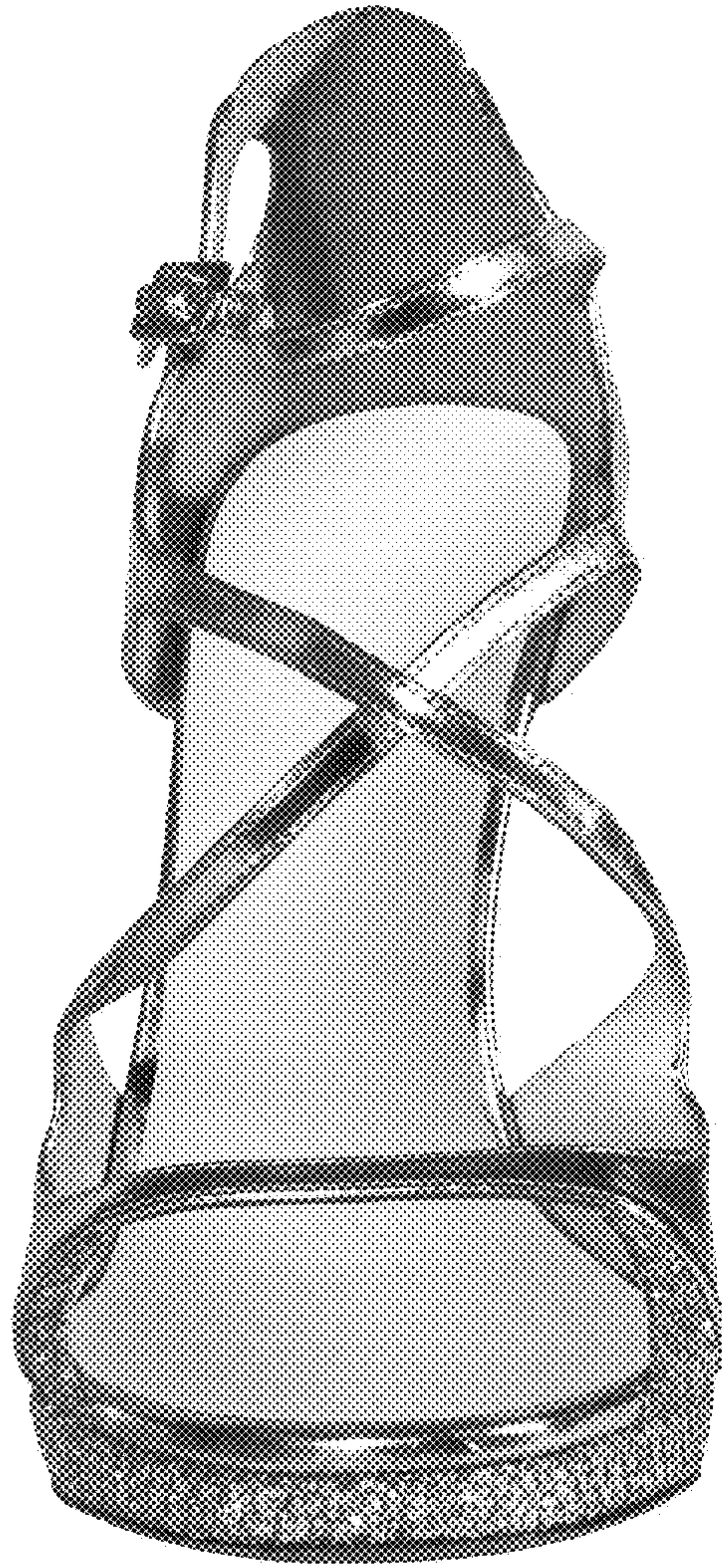

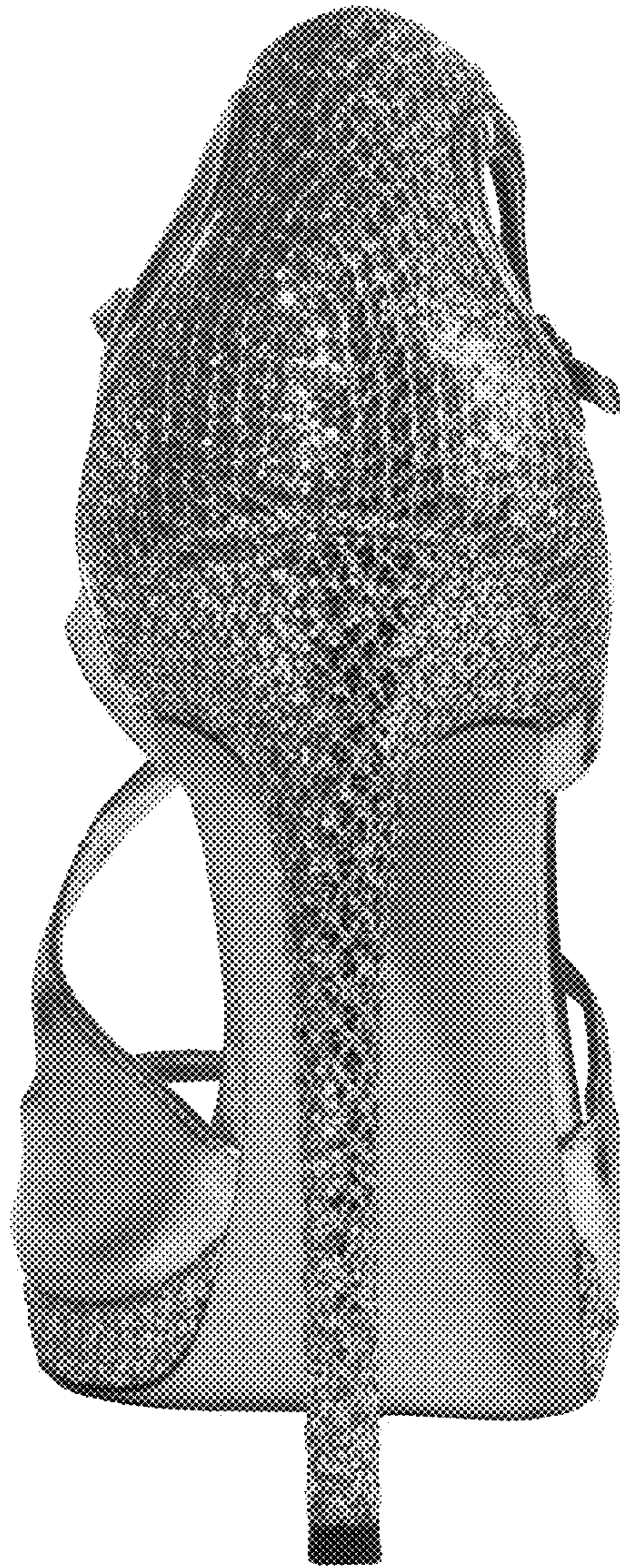

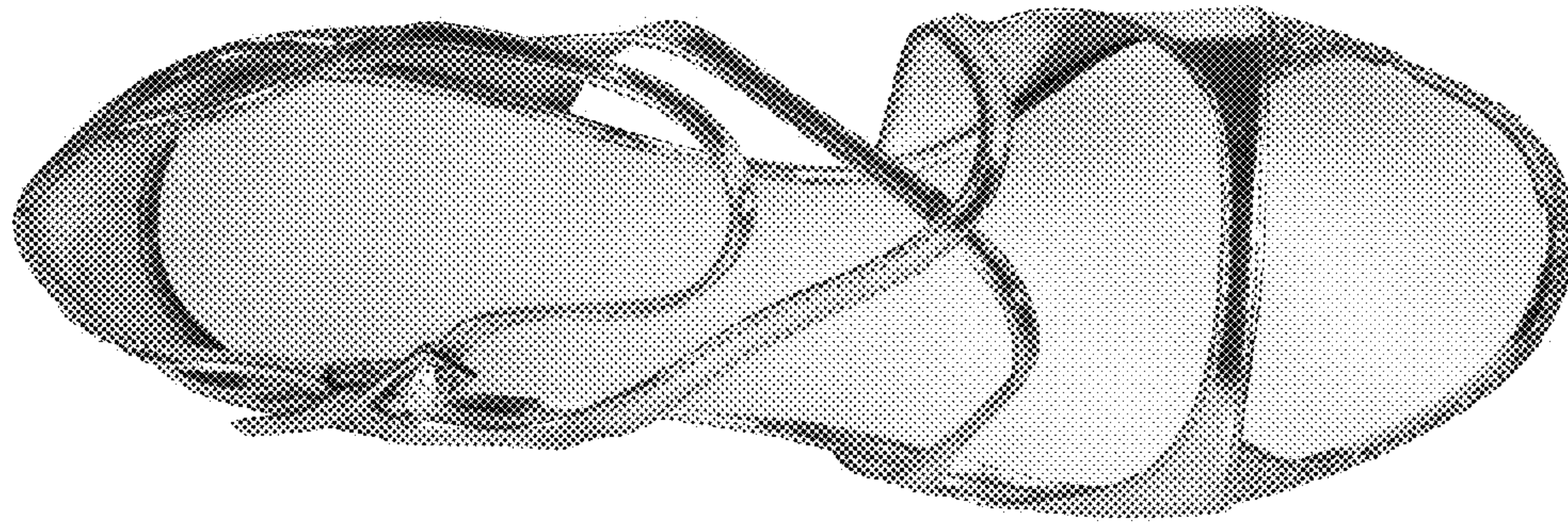
