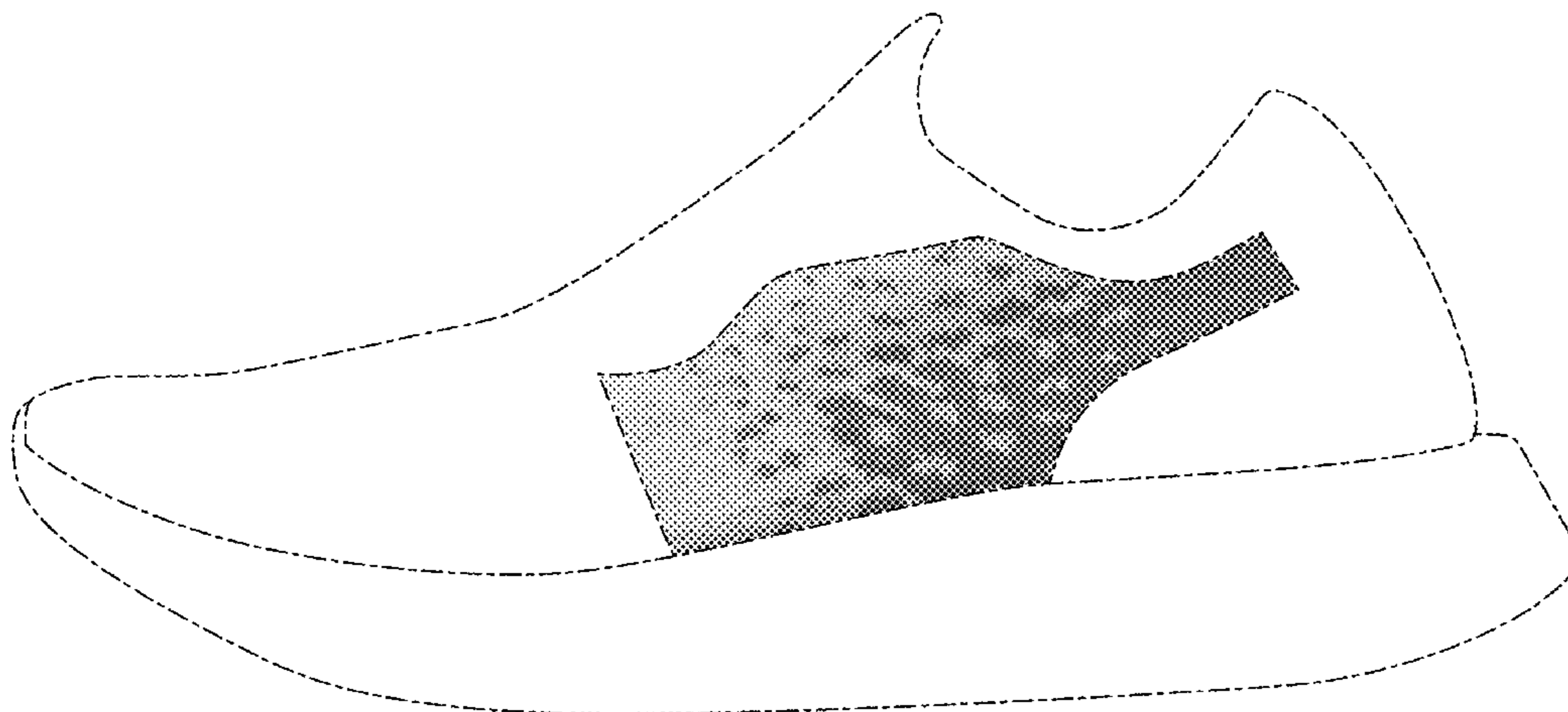
CLAIM

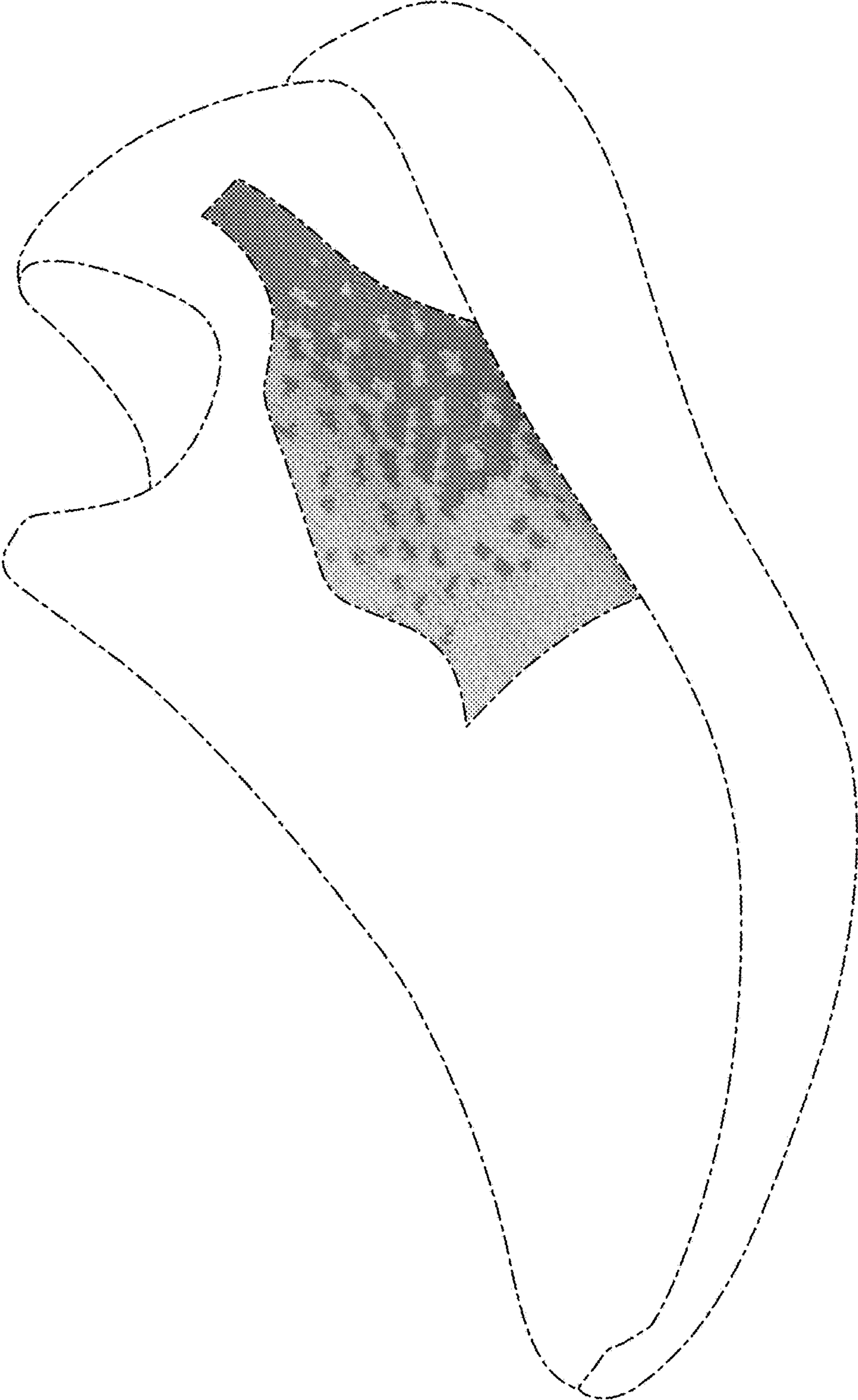

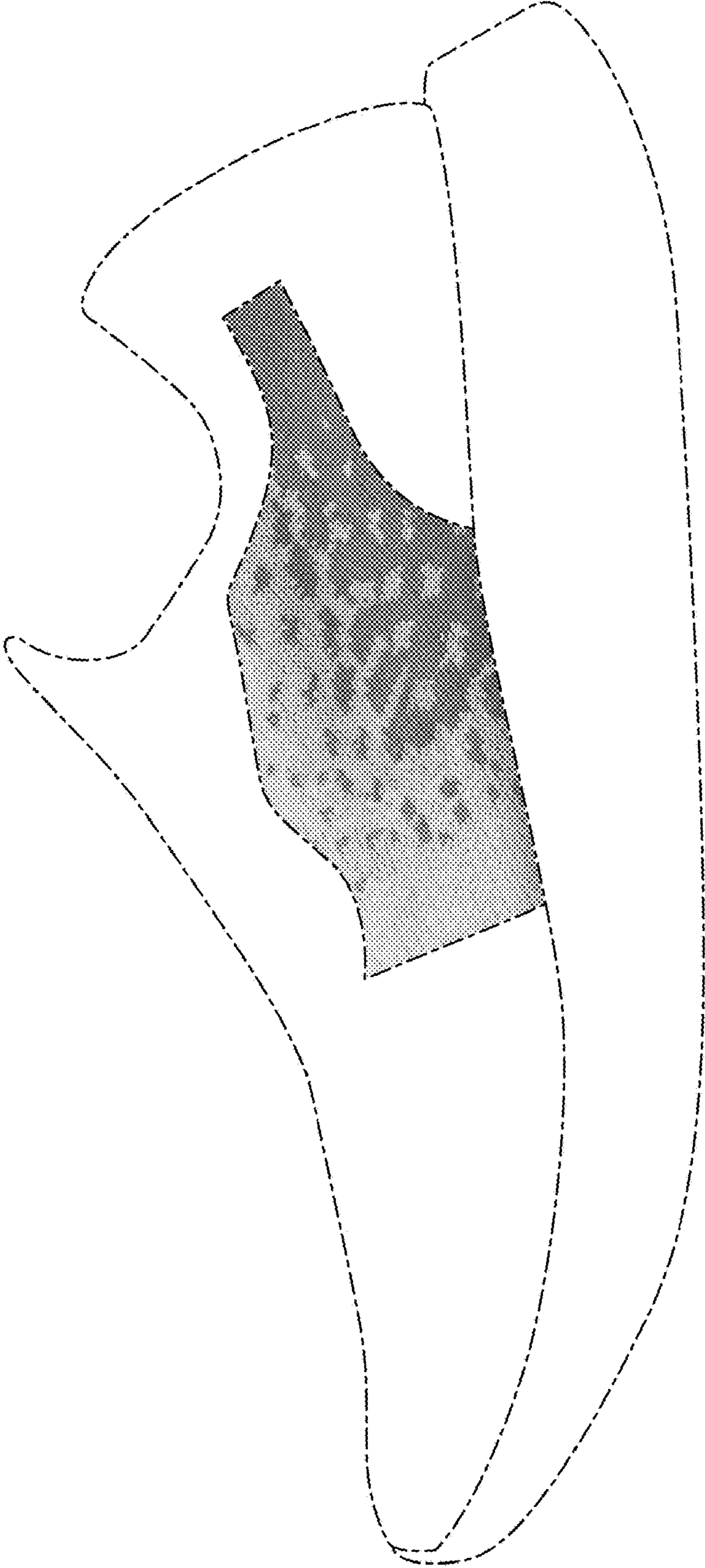

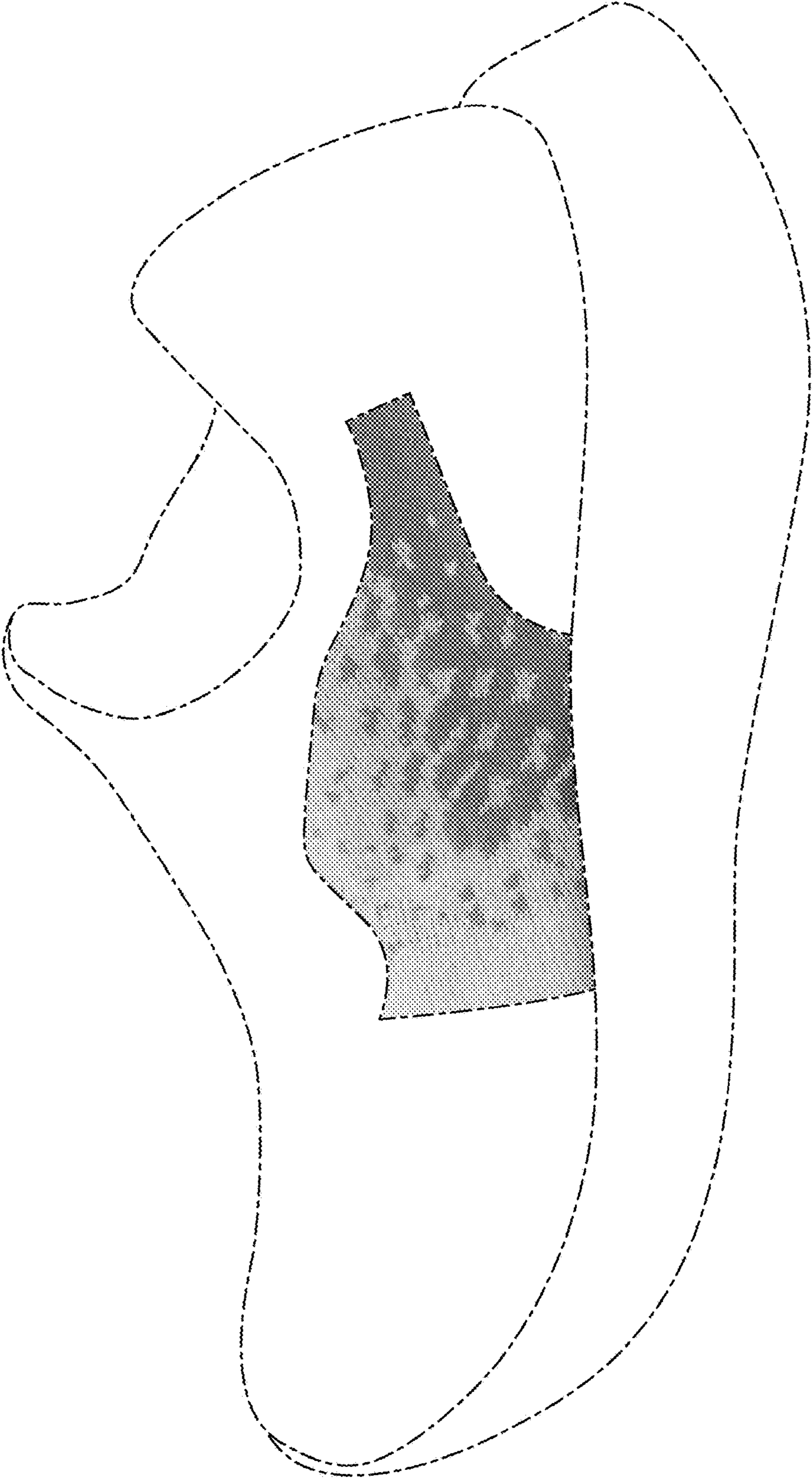
