**DESCRIPTION**

FIG. 1 is a top perspective view of a track nut showing our design;  
 FIG. 2 is a bottom perspective view thereof;  
 FIG. 3 is a front view thereof, the rear, left side, and right side views being identical;  
 FIG. 4 is a top view thereof; and,  
 FIG. 5 is a bottom view thereof.

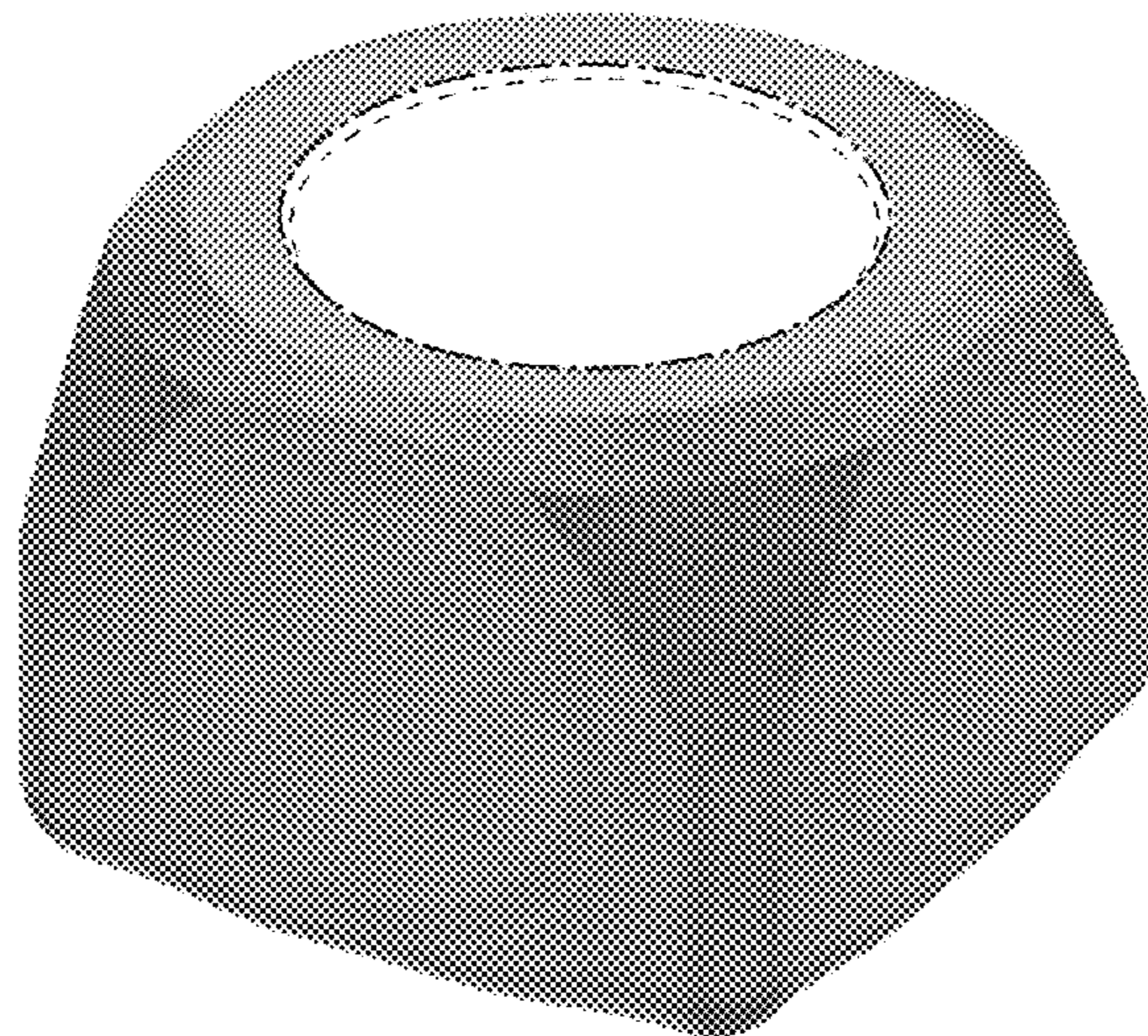

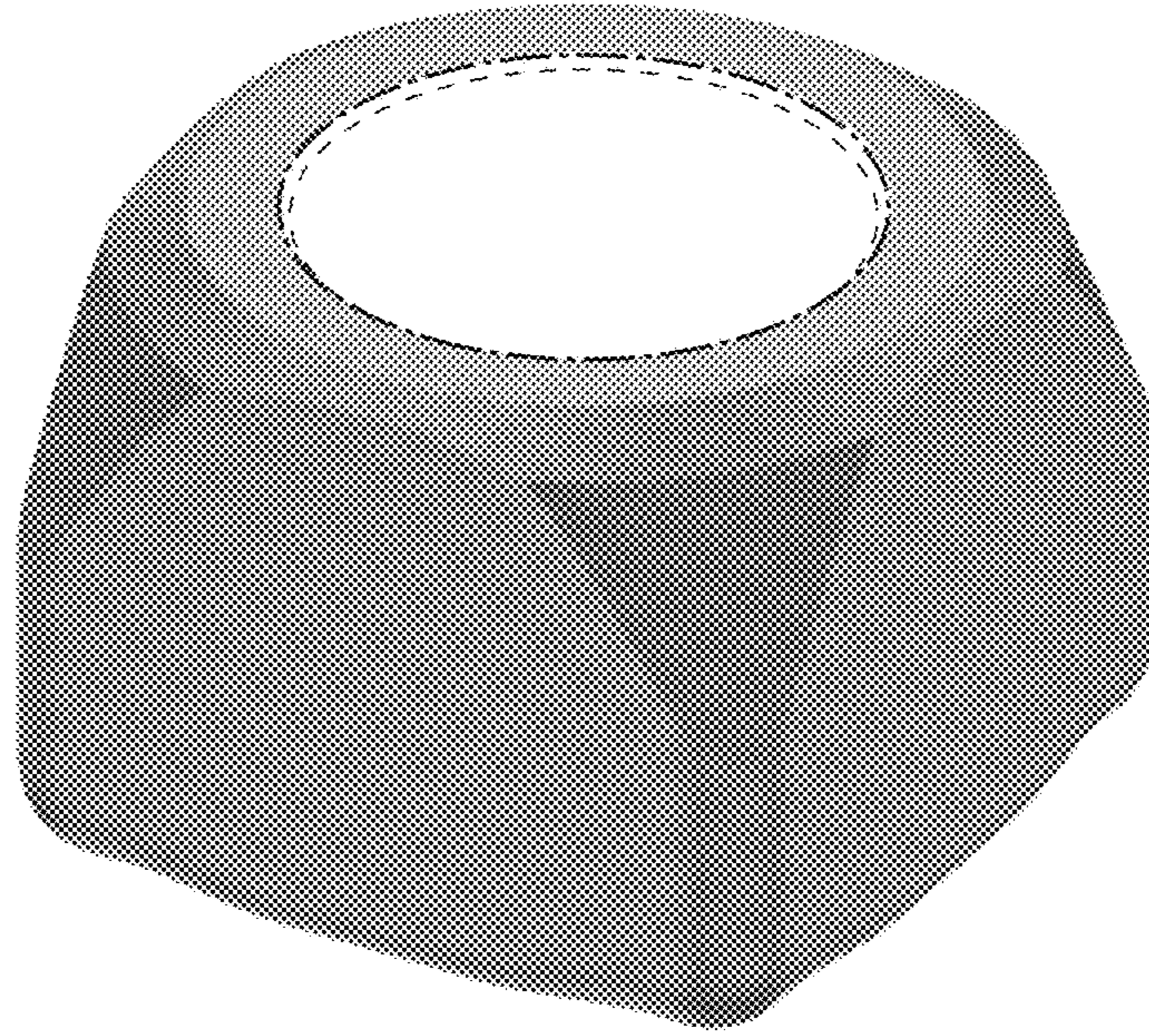

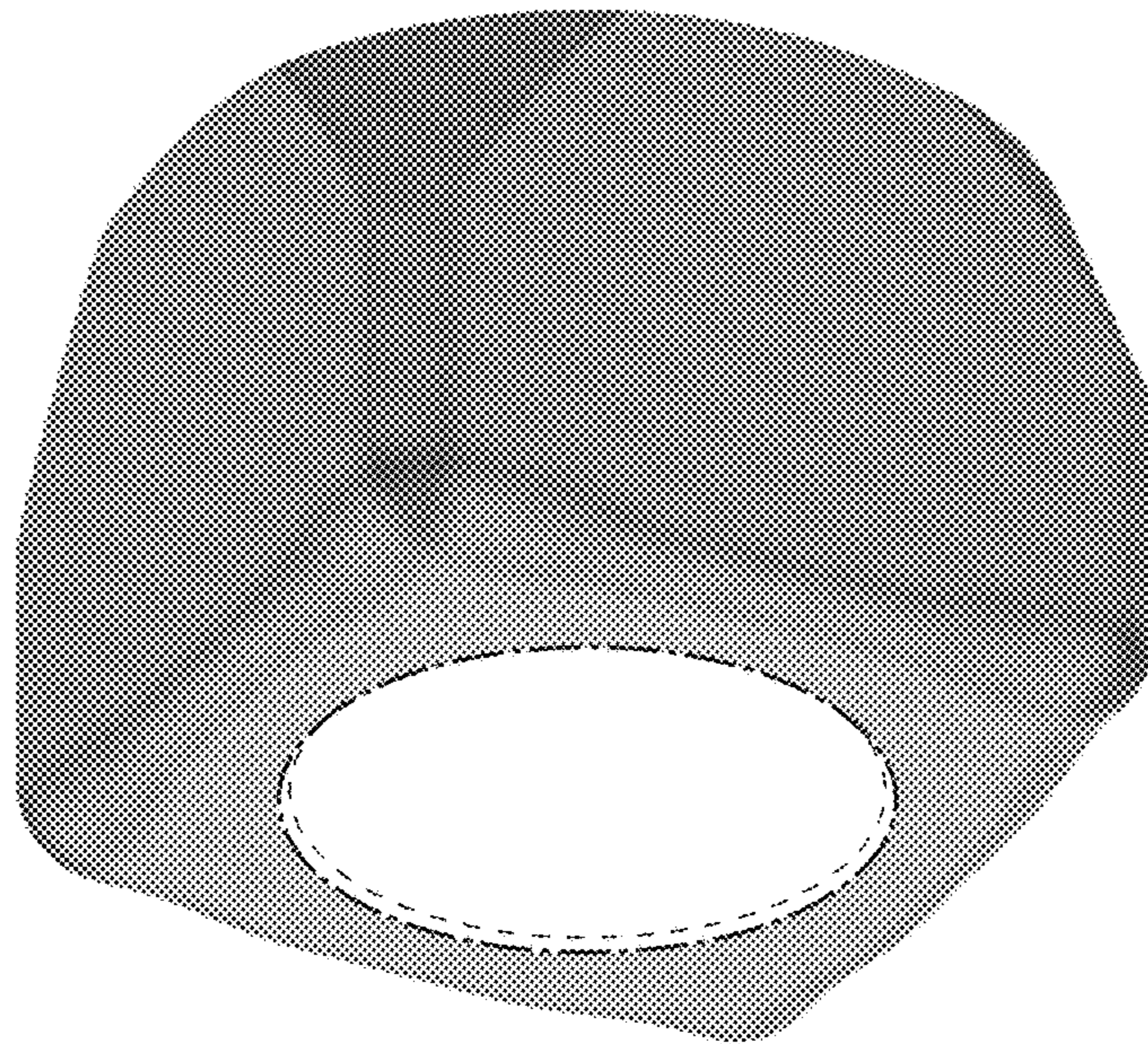

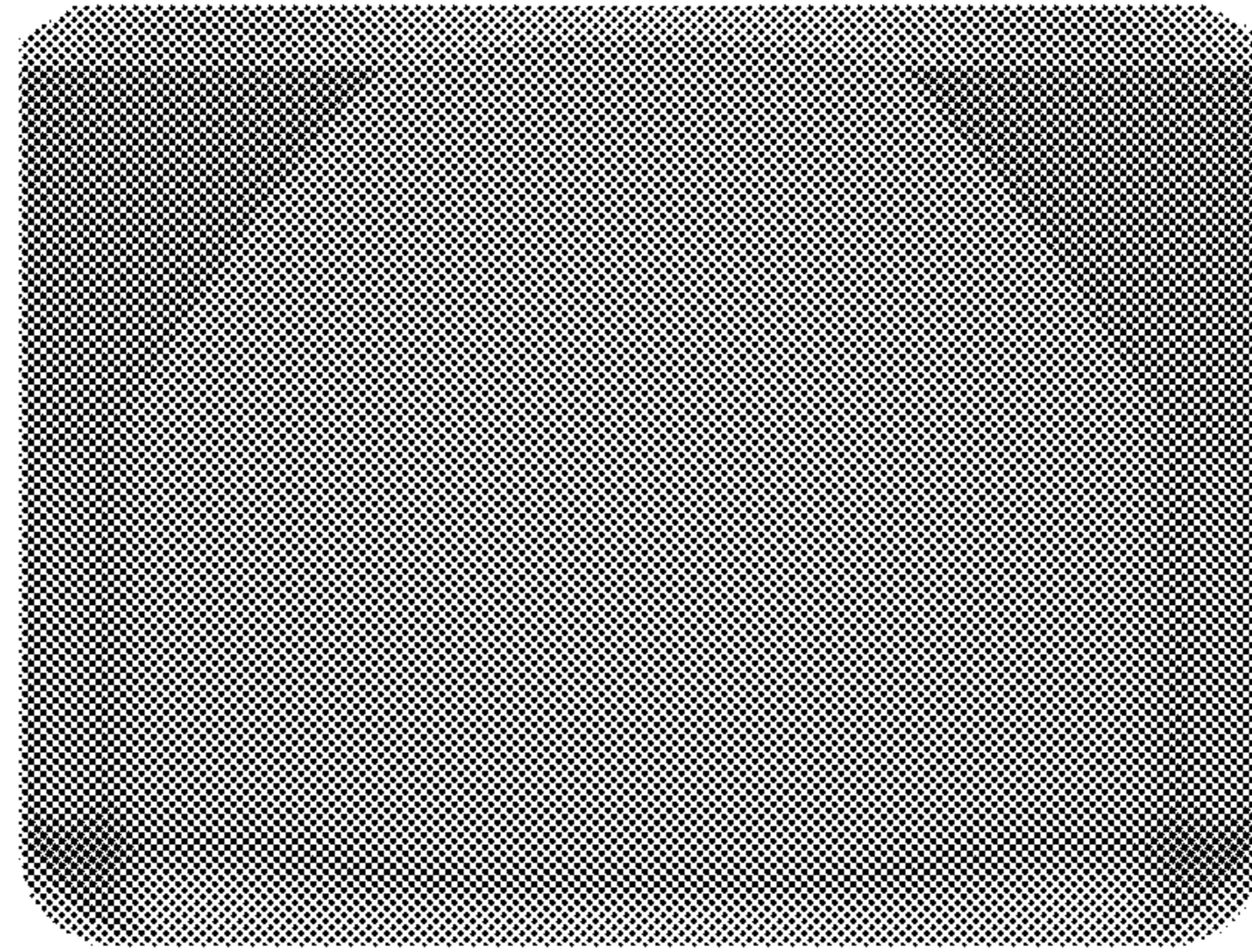




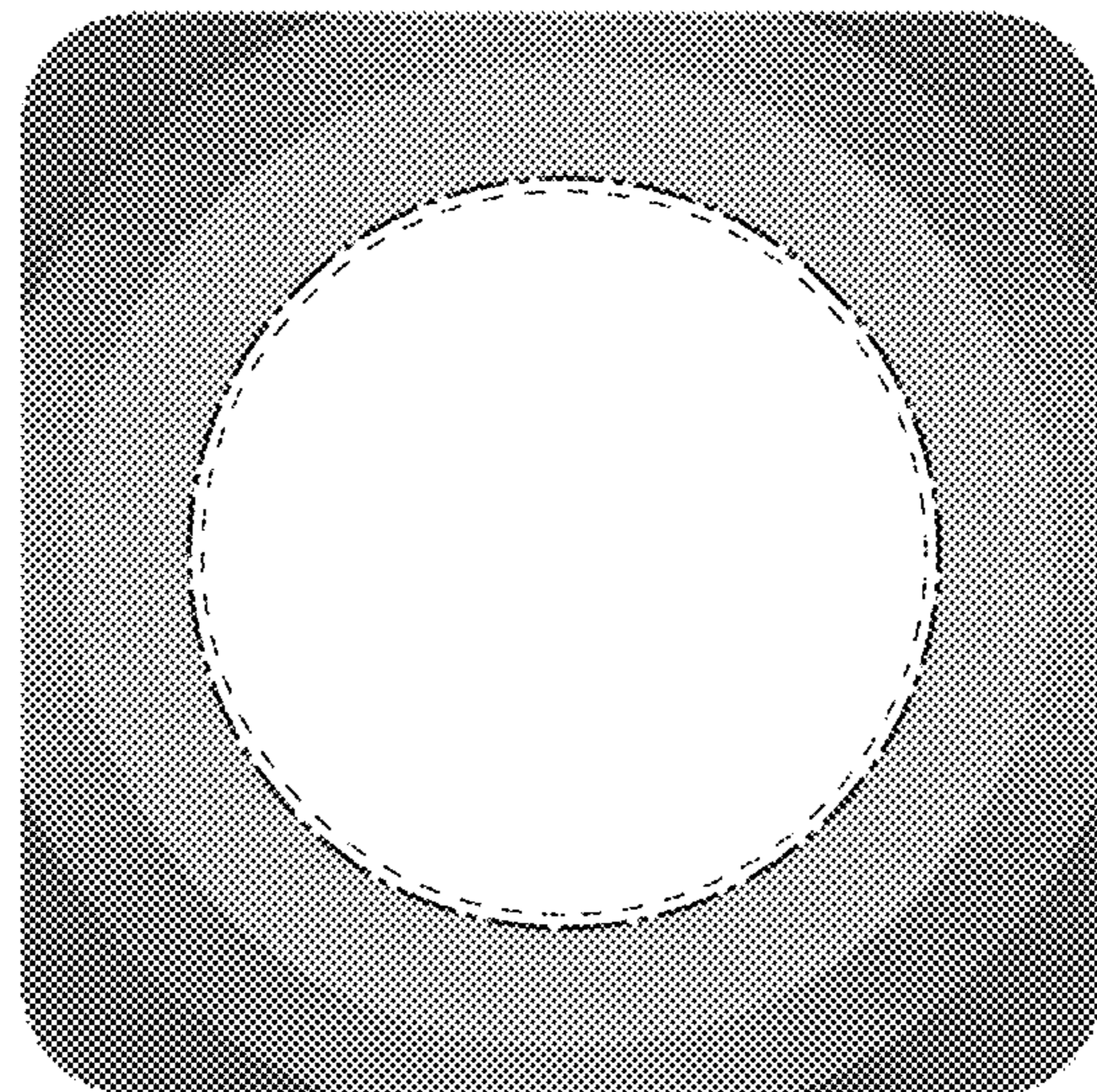

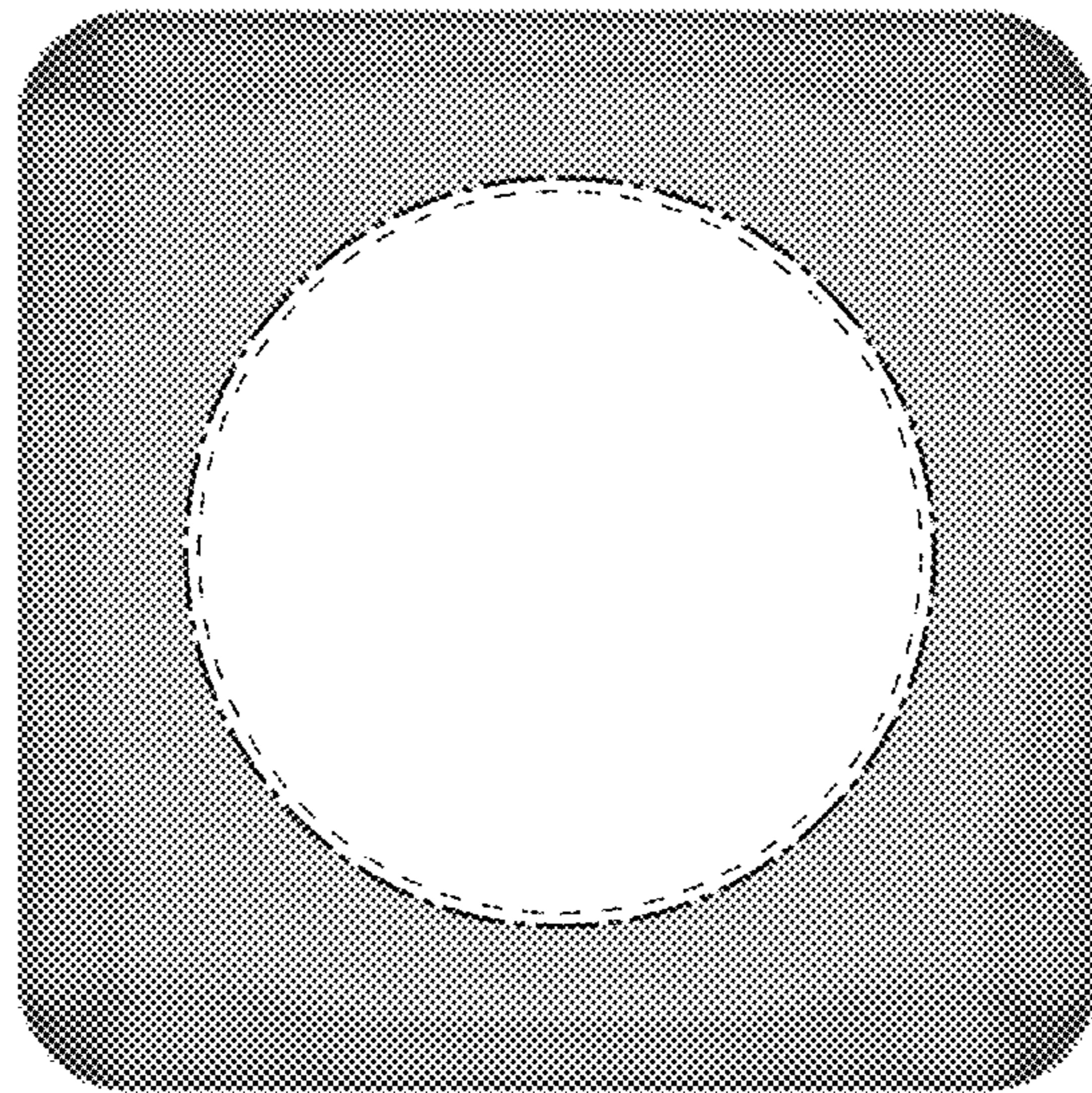
