DESCRIPTION

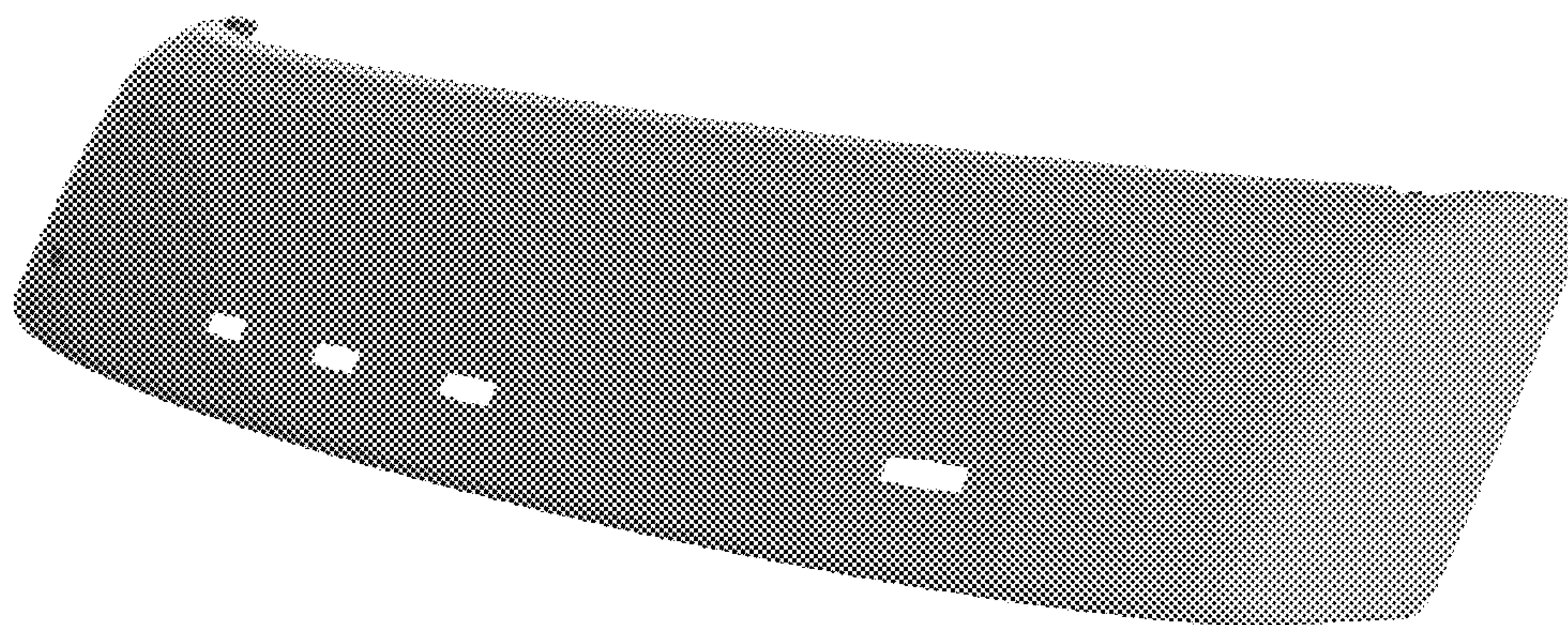
FIG. 1 is a perspective view of a sun visor for vehicle showing my new design.

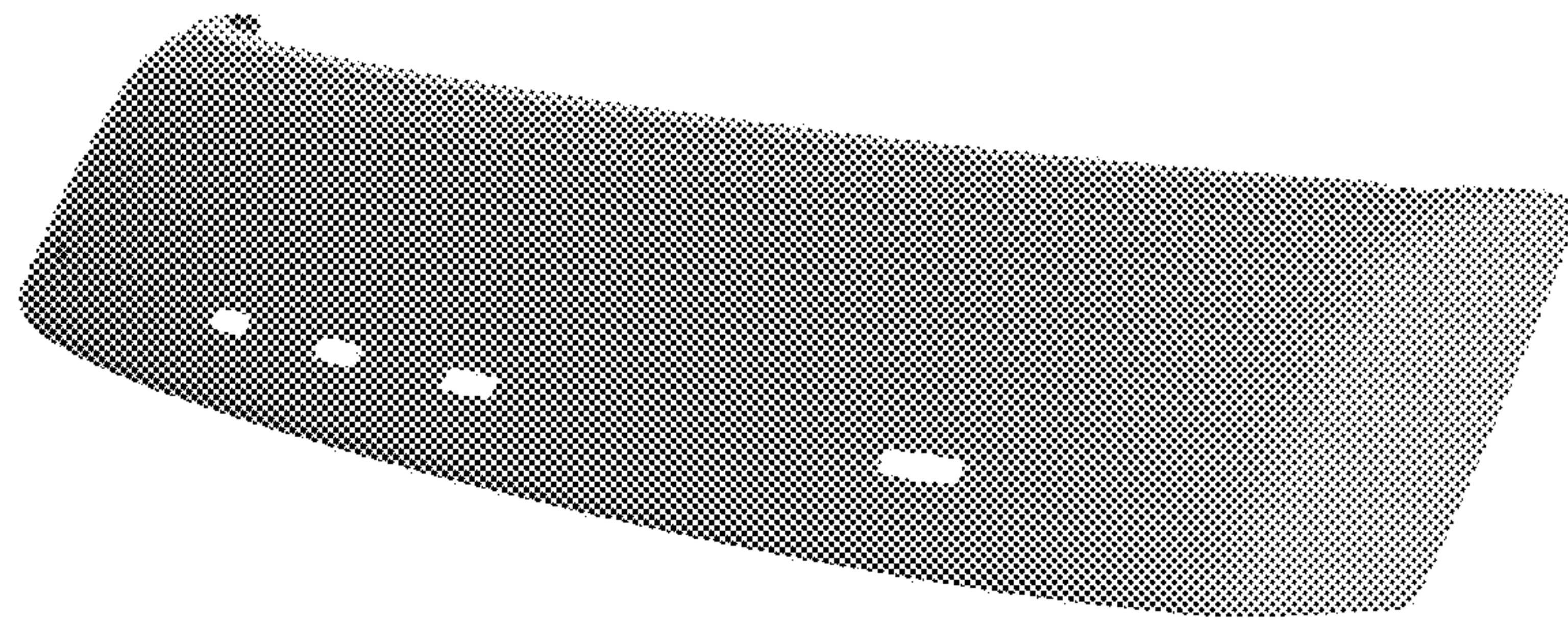

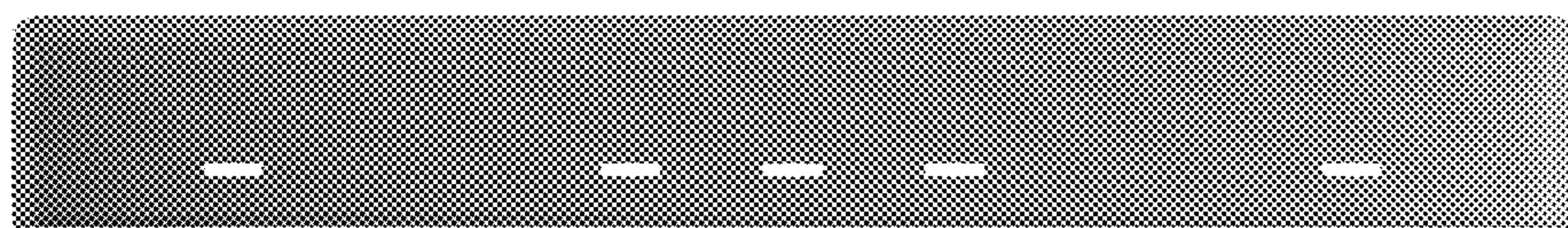

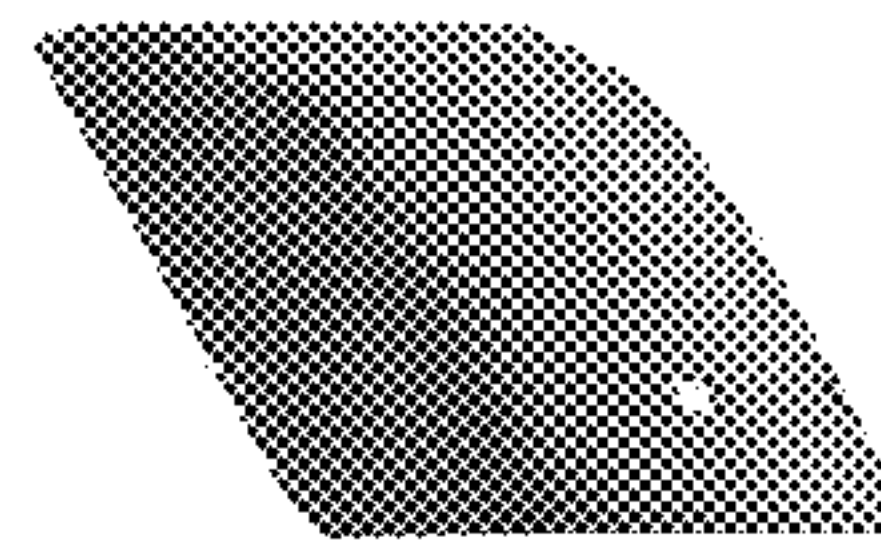

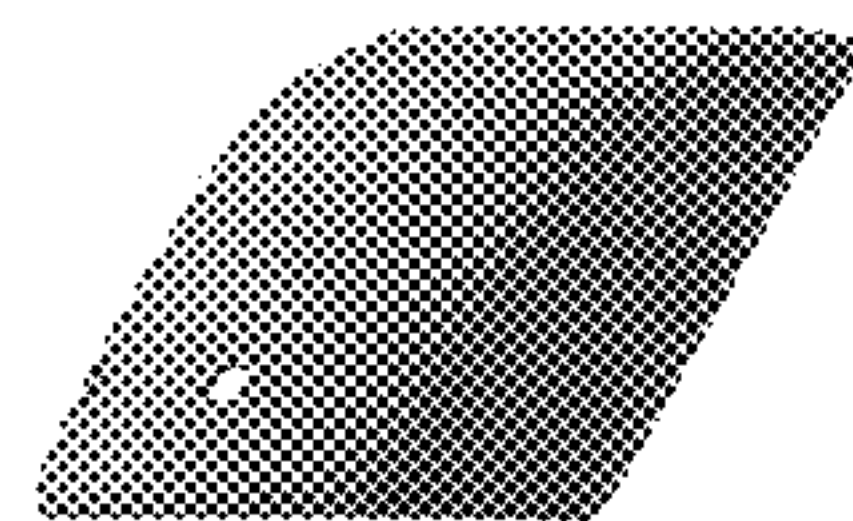

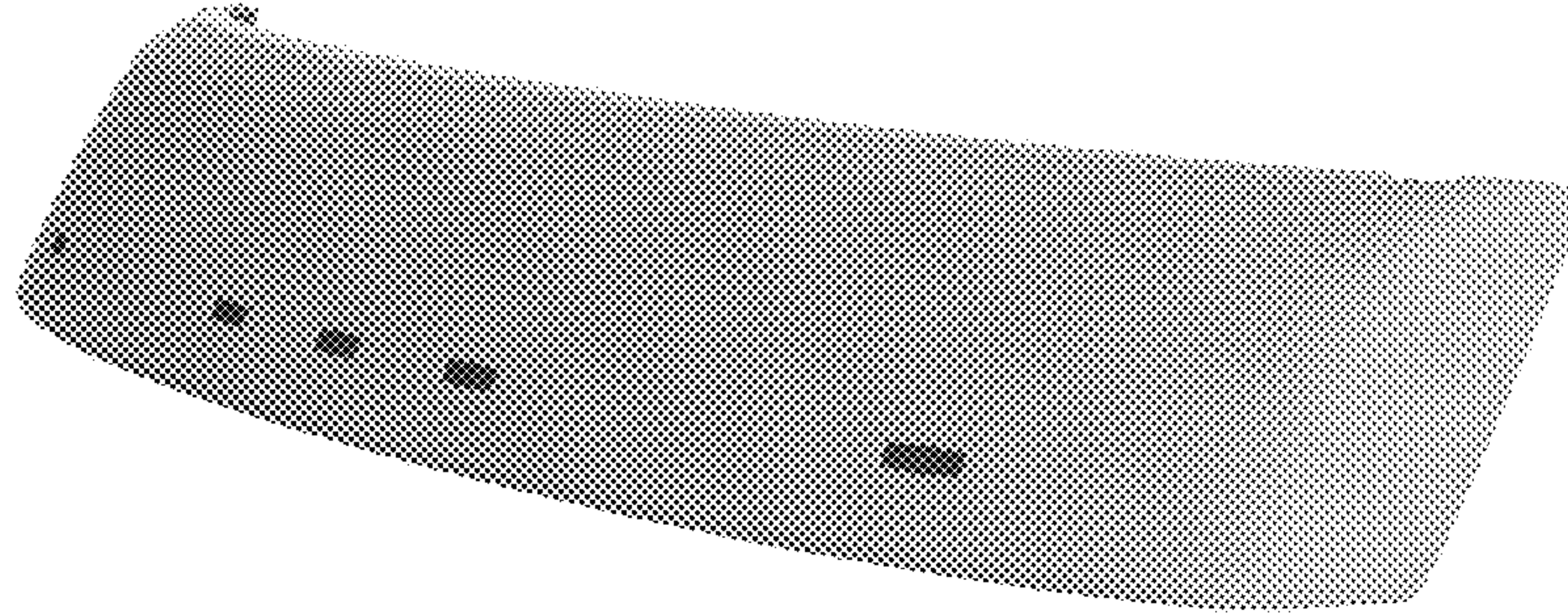

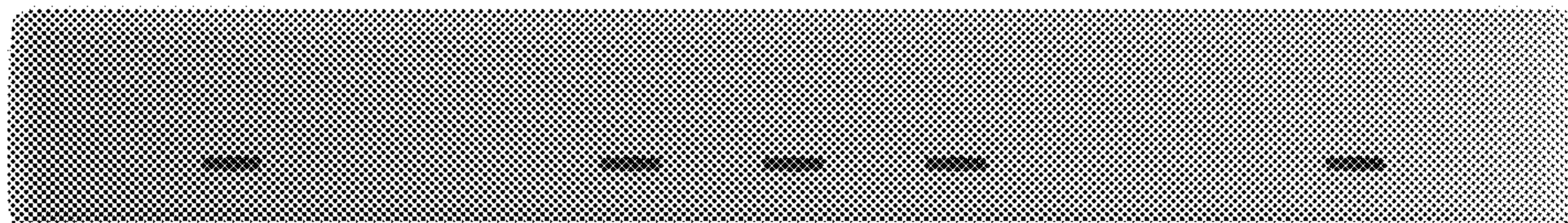

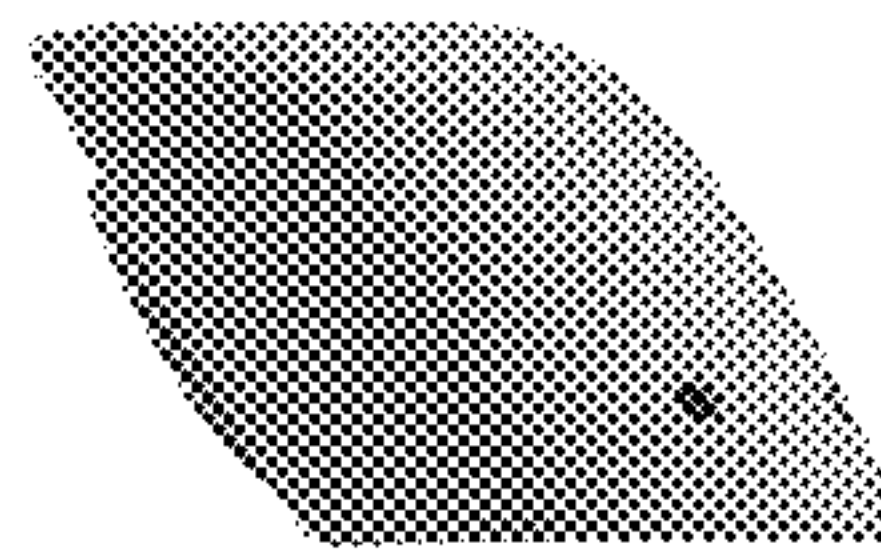

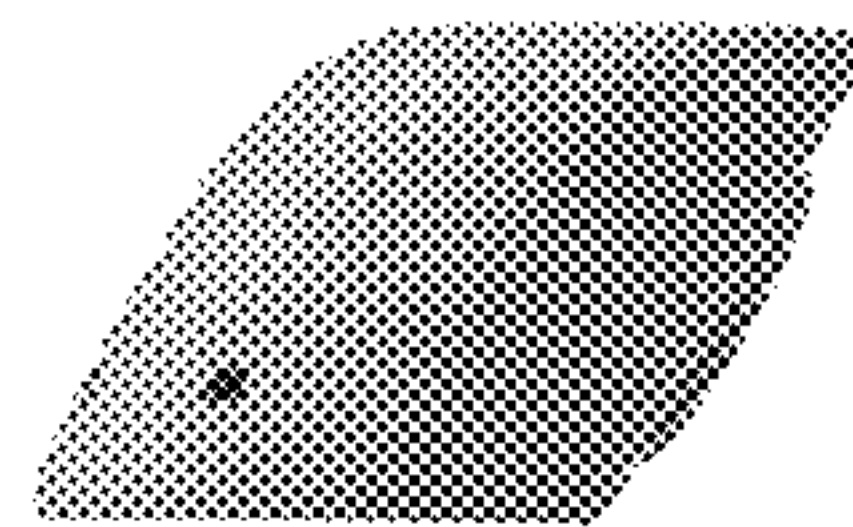
