(57) **CLAIM**

The ornamental design for a display screen or portion thereof with an animated graphical user interface, as shown and described.

**DESCRIPTION**

FIG. 1 illustrates a front view of a display screen or portion thereof with an animated graphical user interface (GUI) showing a first image in the sequence showing the new design;

FIG. 8 illustrates an eighth image thereof;

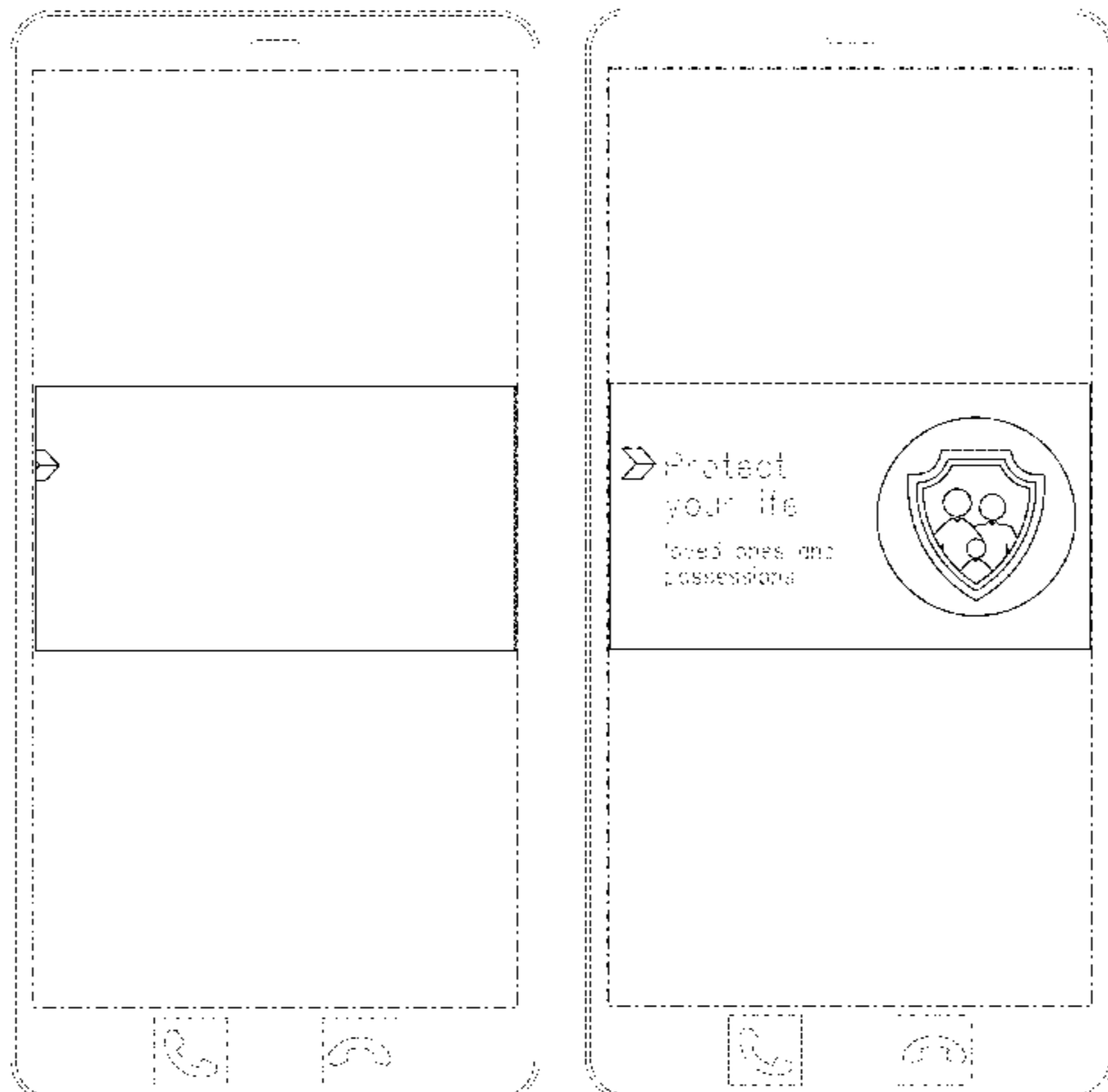
FIG. 9 illustrated a ninth image depicted thereof; and,

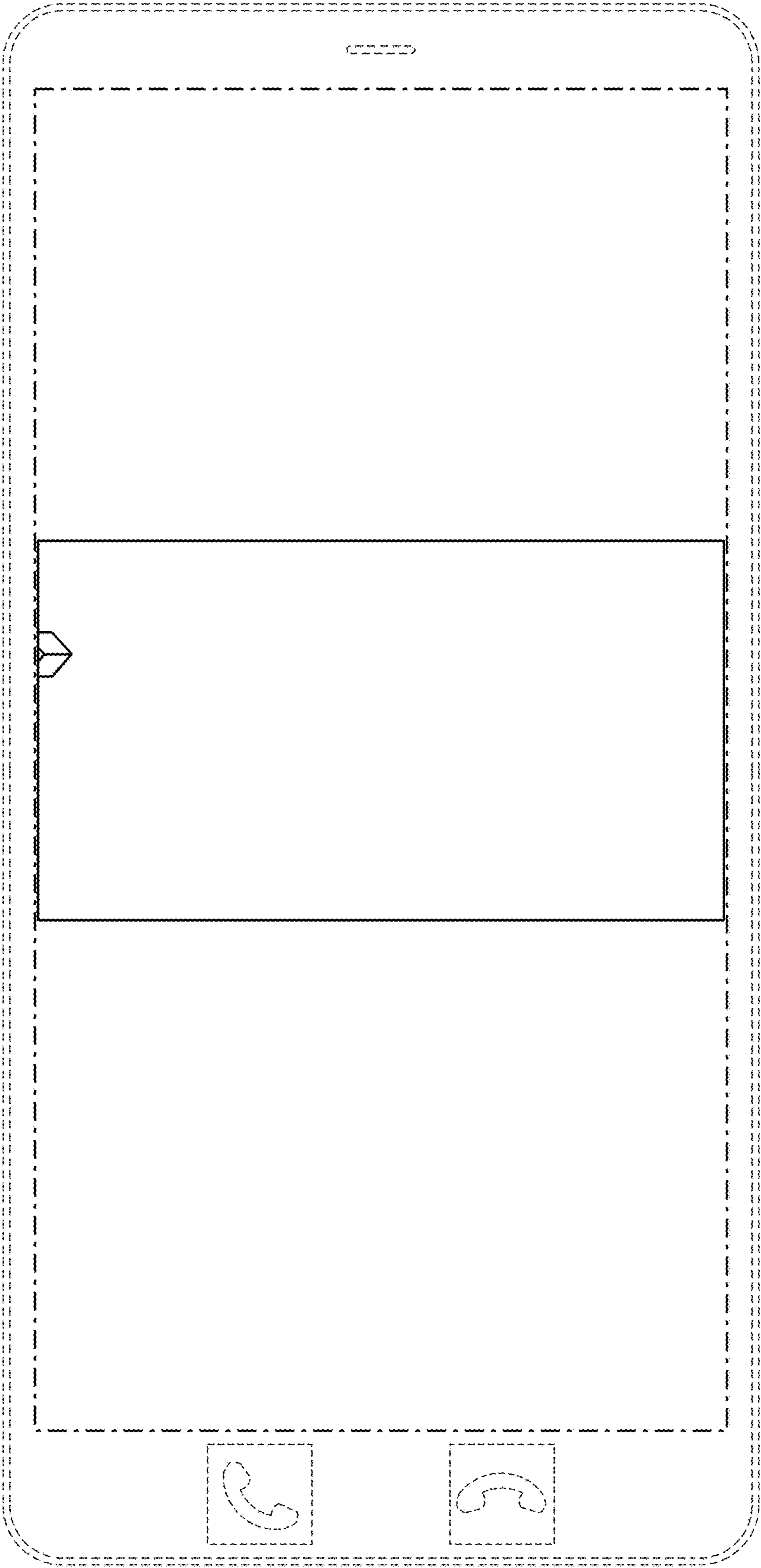

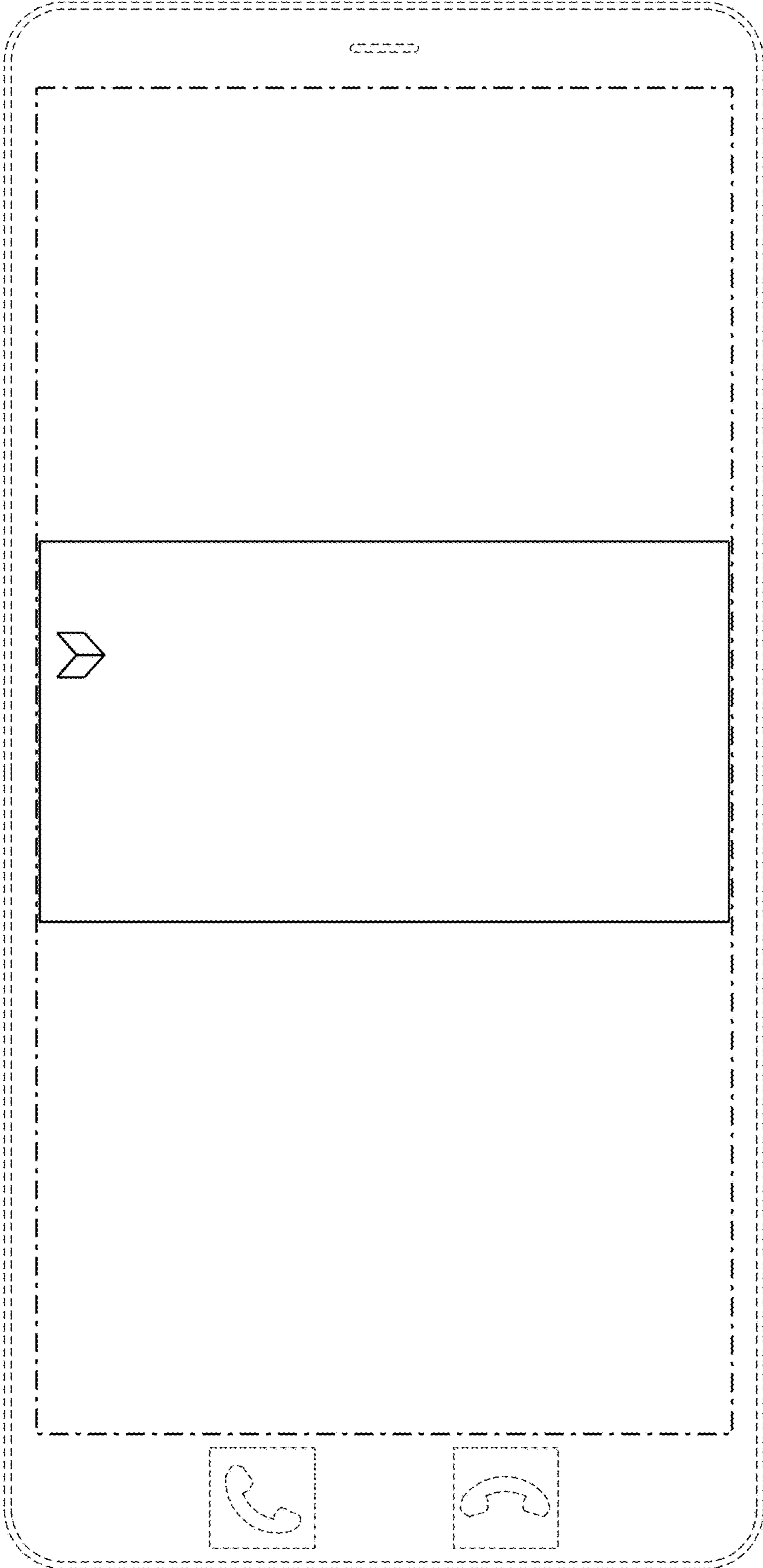

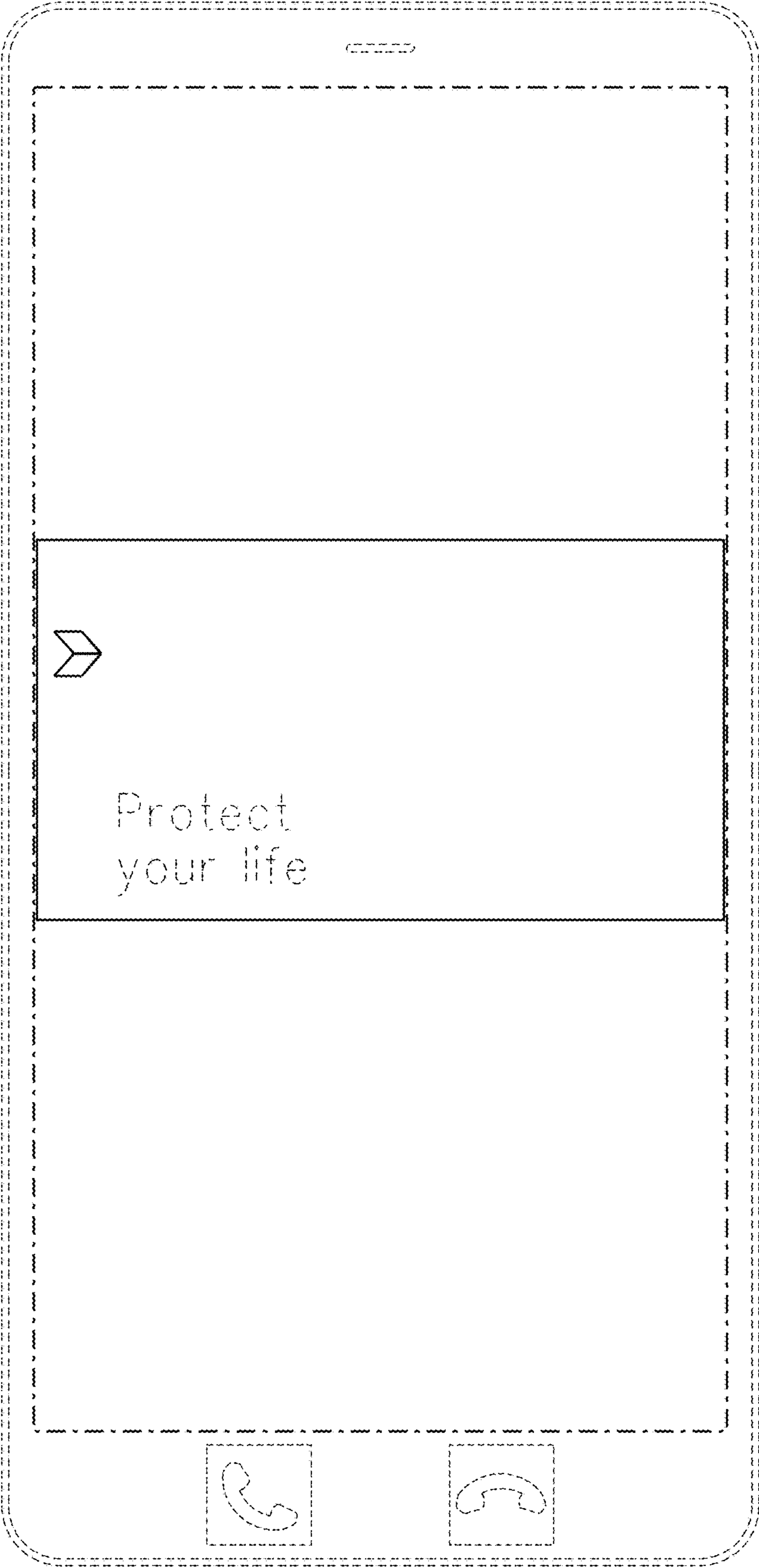

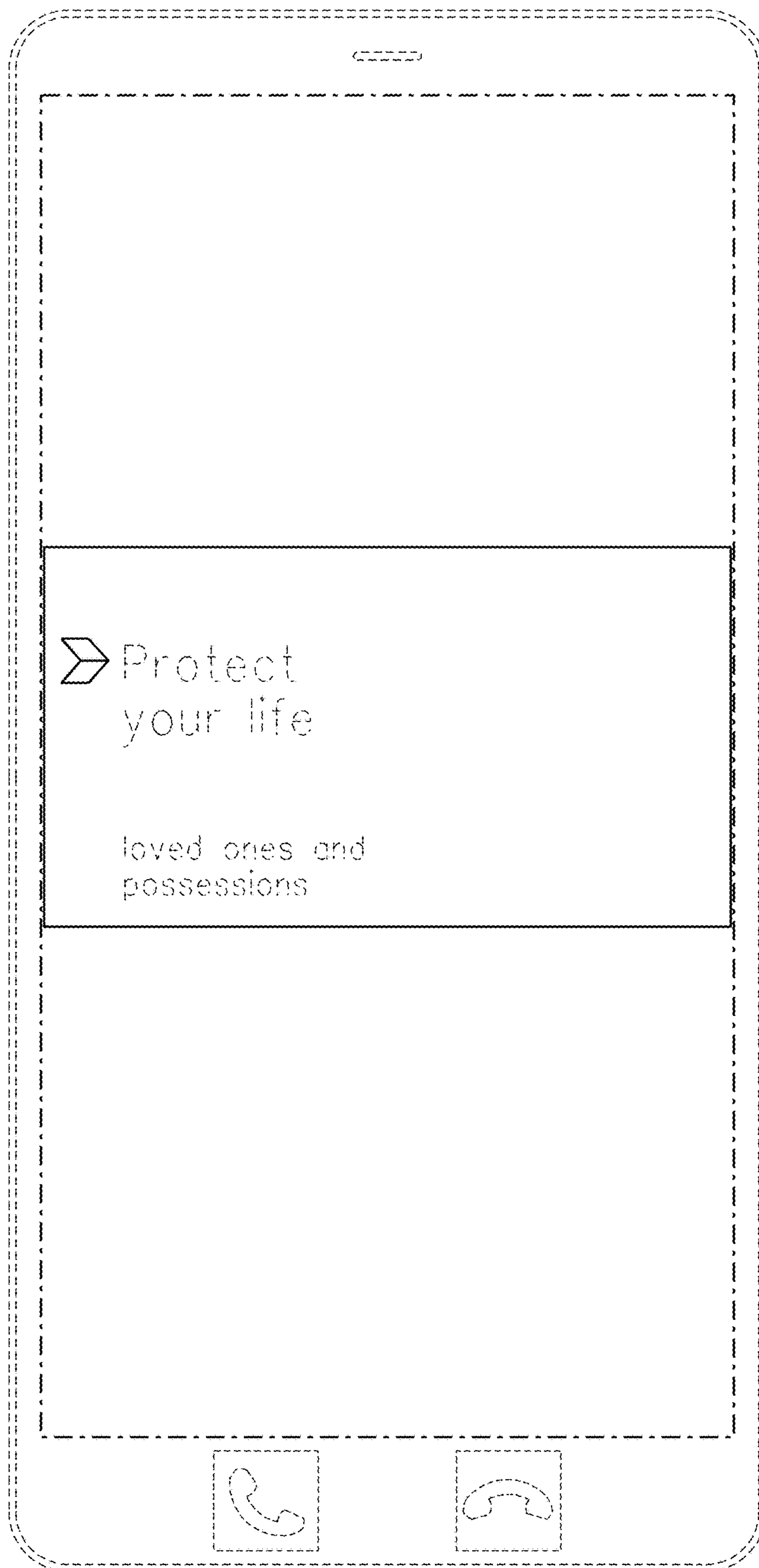

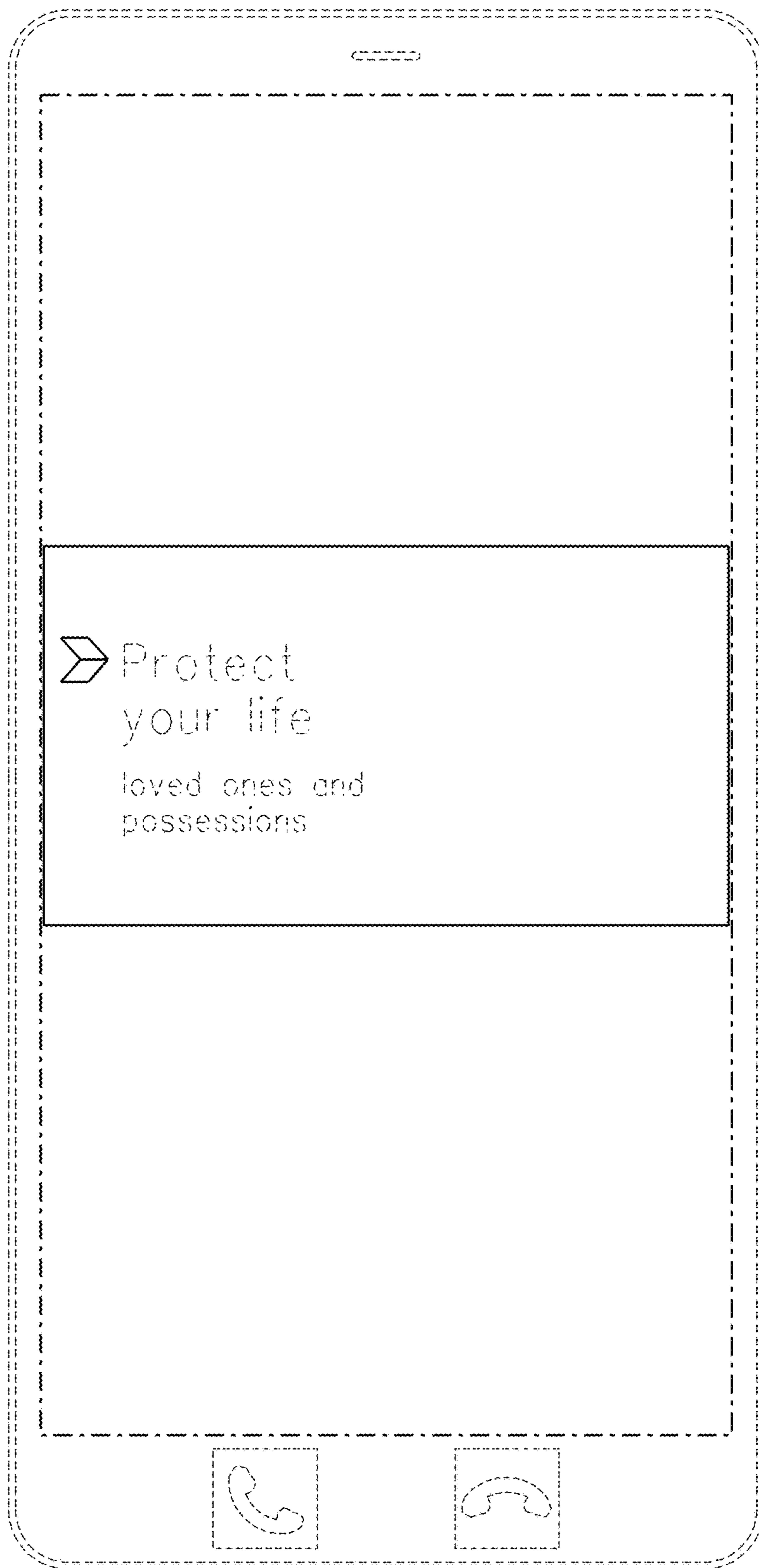

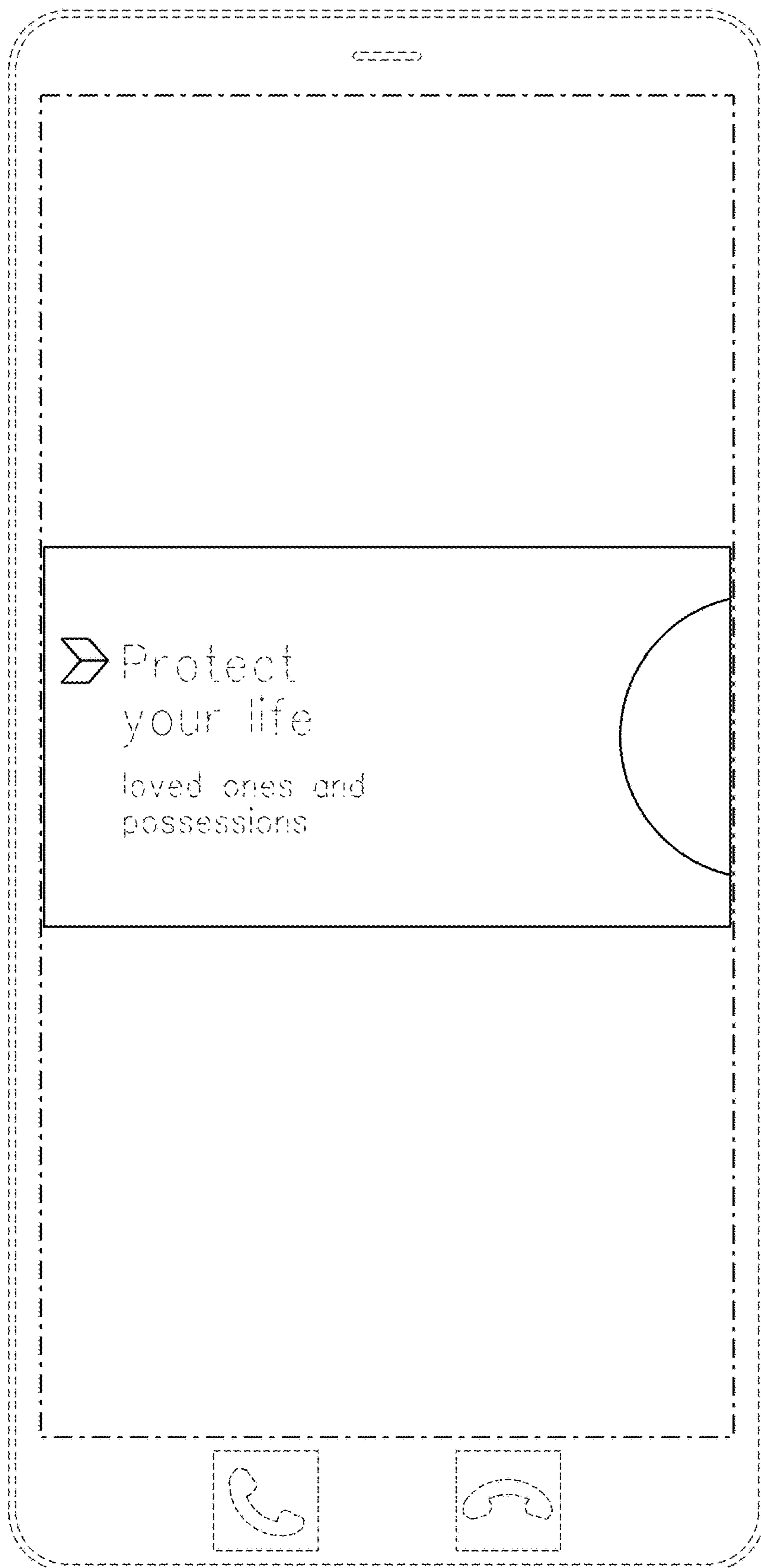

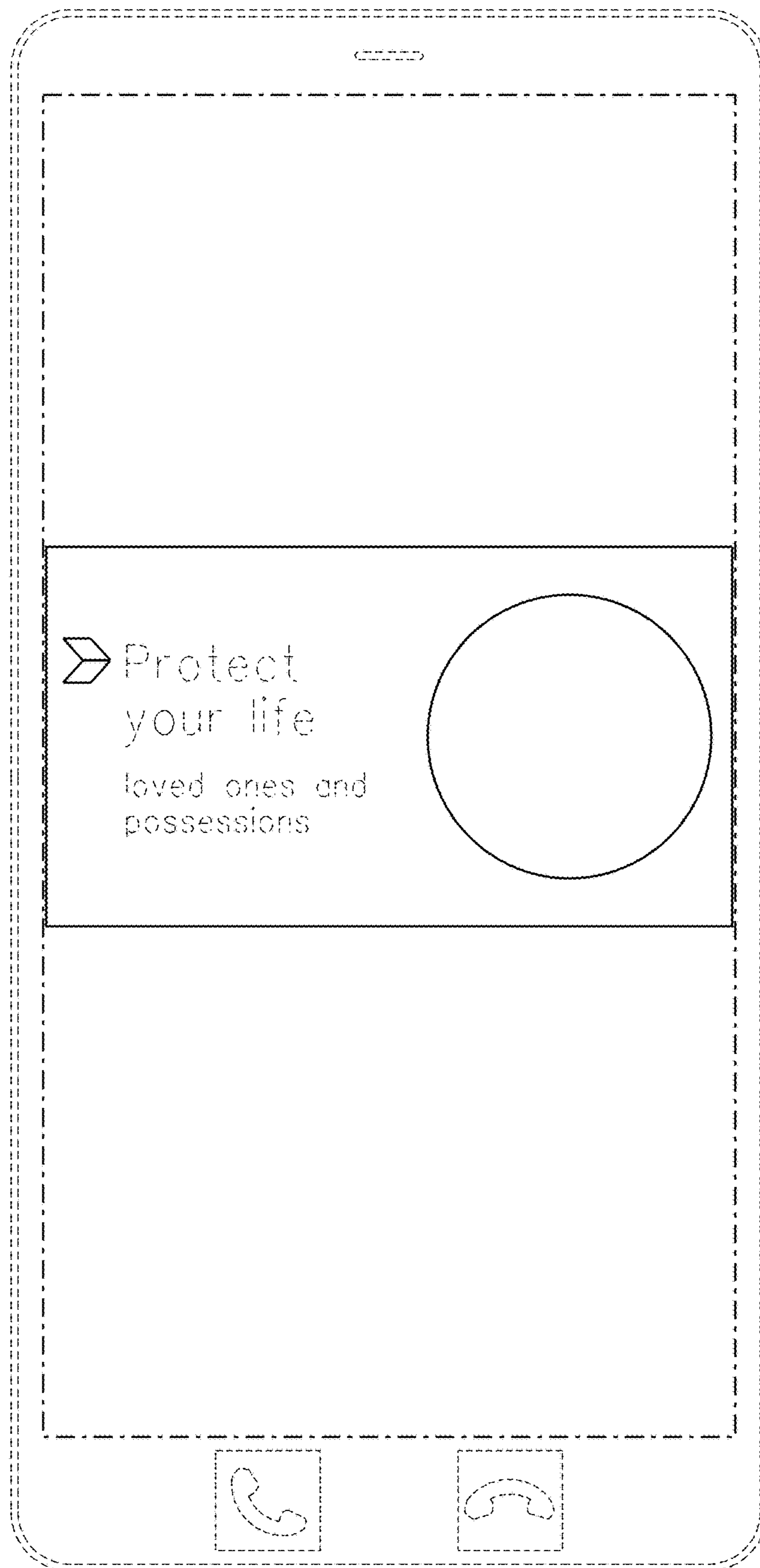

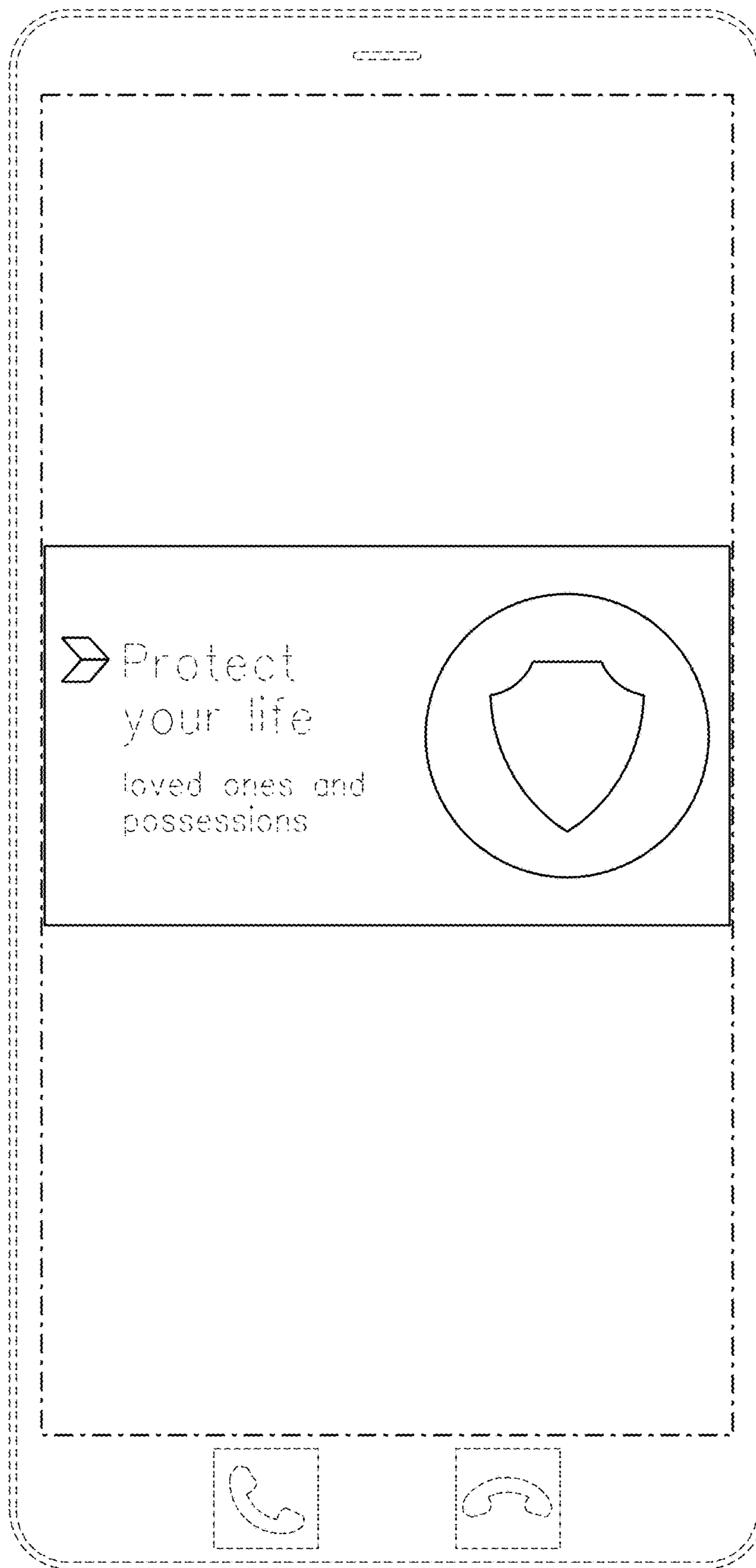

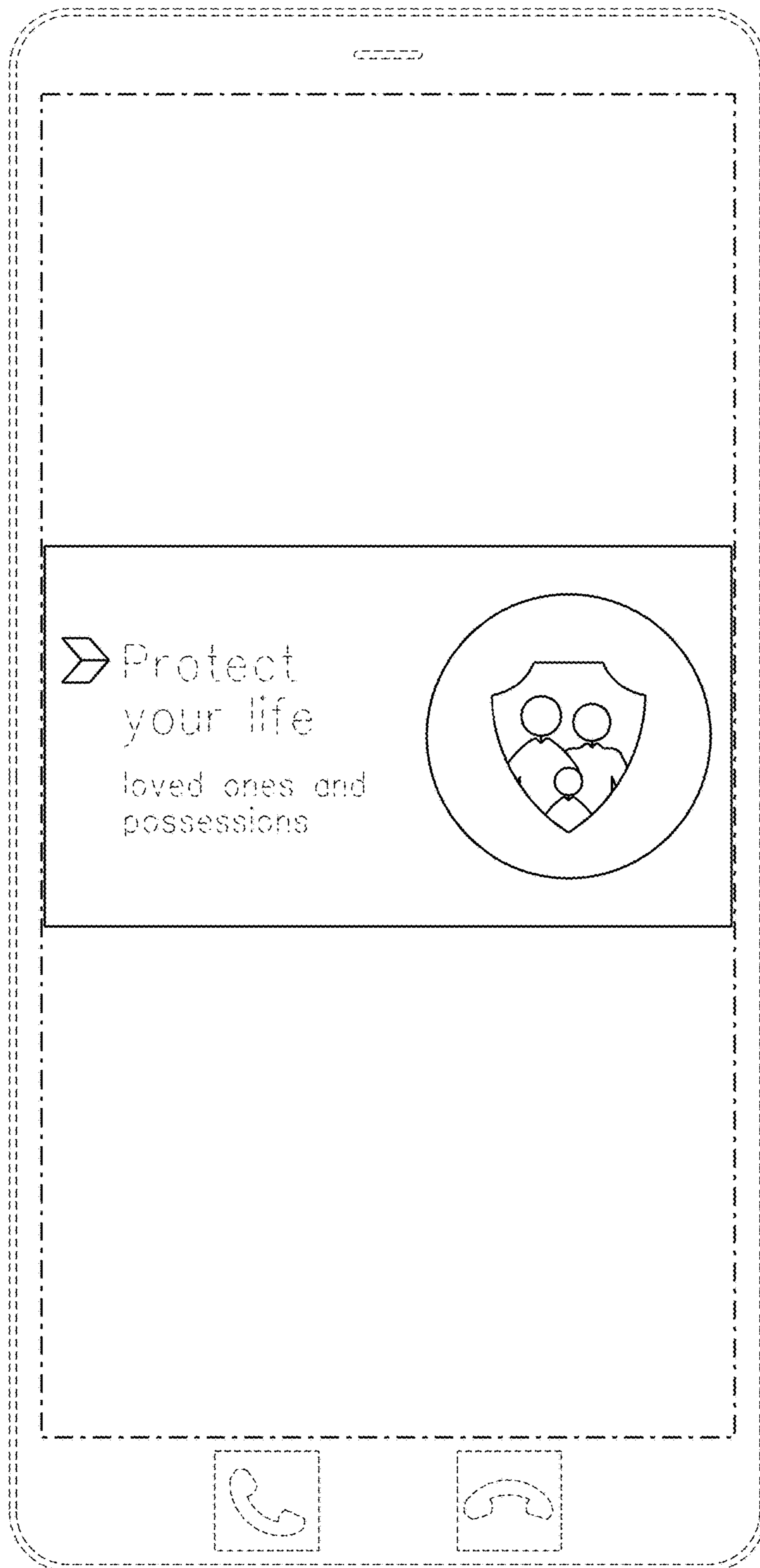

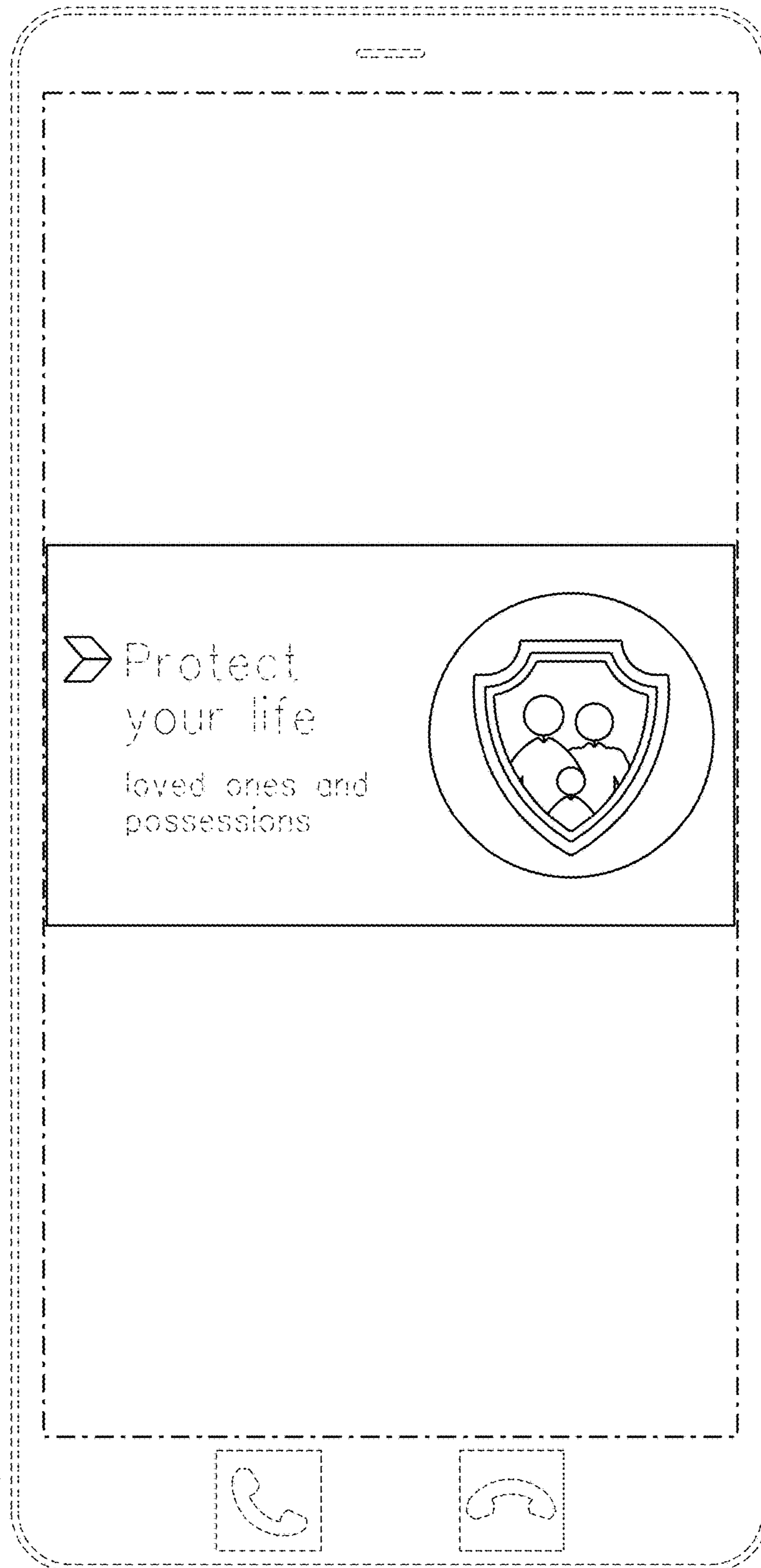
