(57) **CLAIM**

The ornamental design for a display screen or portion thereof with an animated graphical user interface, as shown and described.

DESCRIPTION

FIG. 11 illustrates an eleventh image thereof;

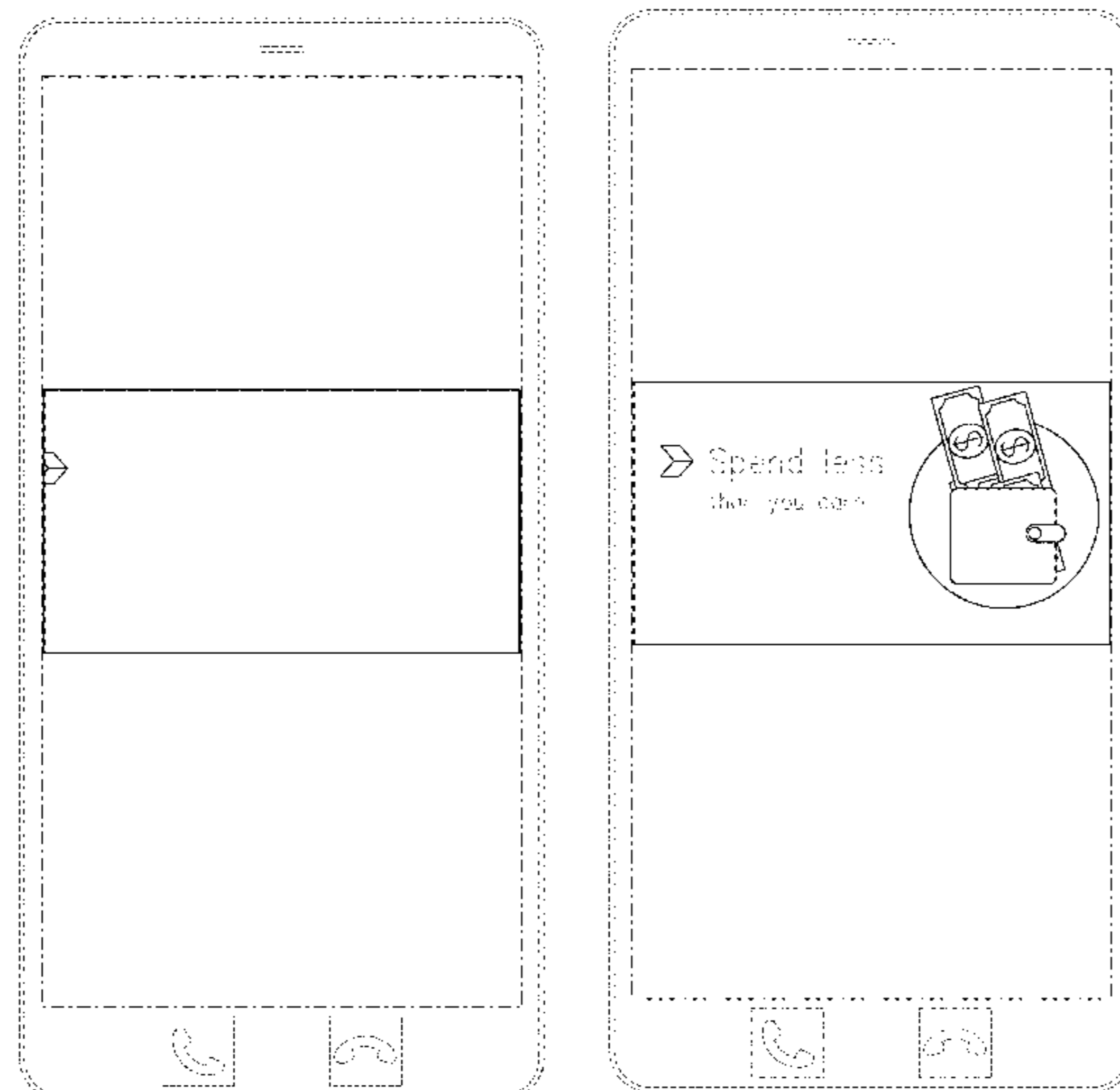
FIG. 12 illustrates a twelfth image thereof; and,

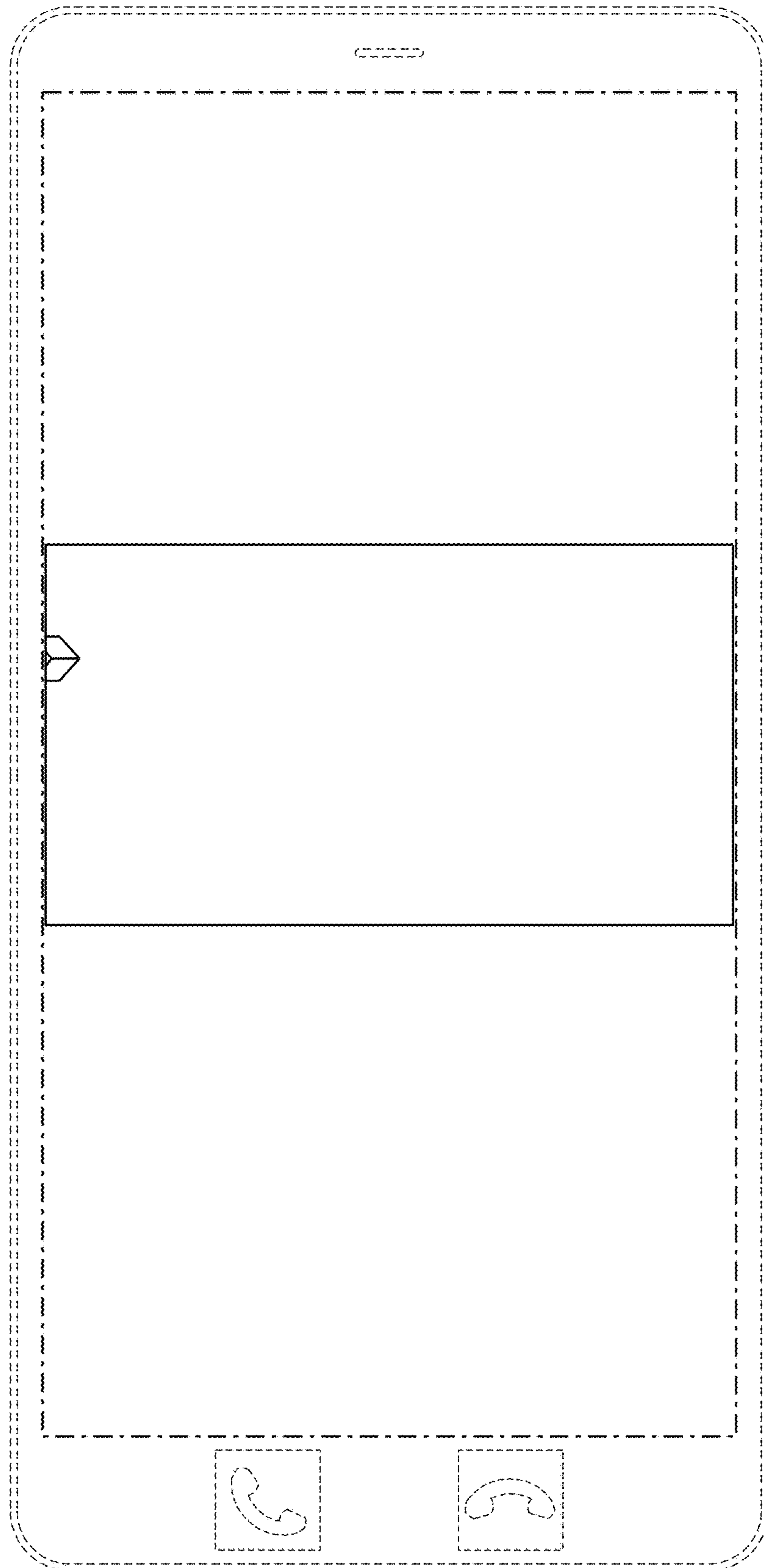

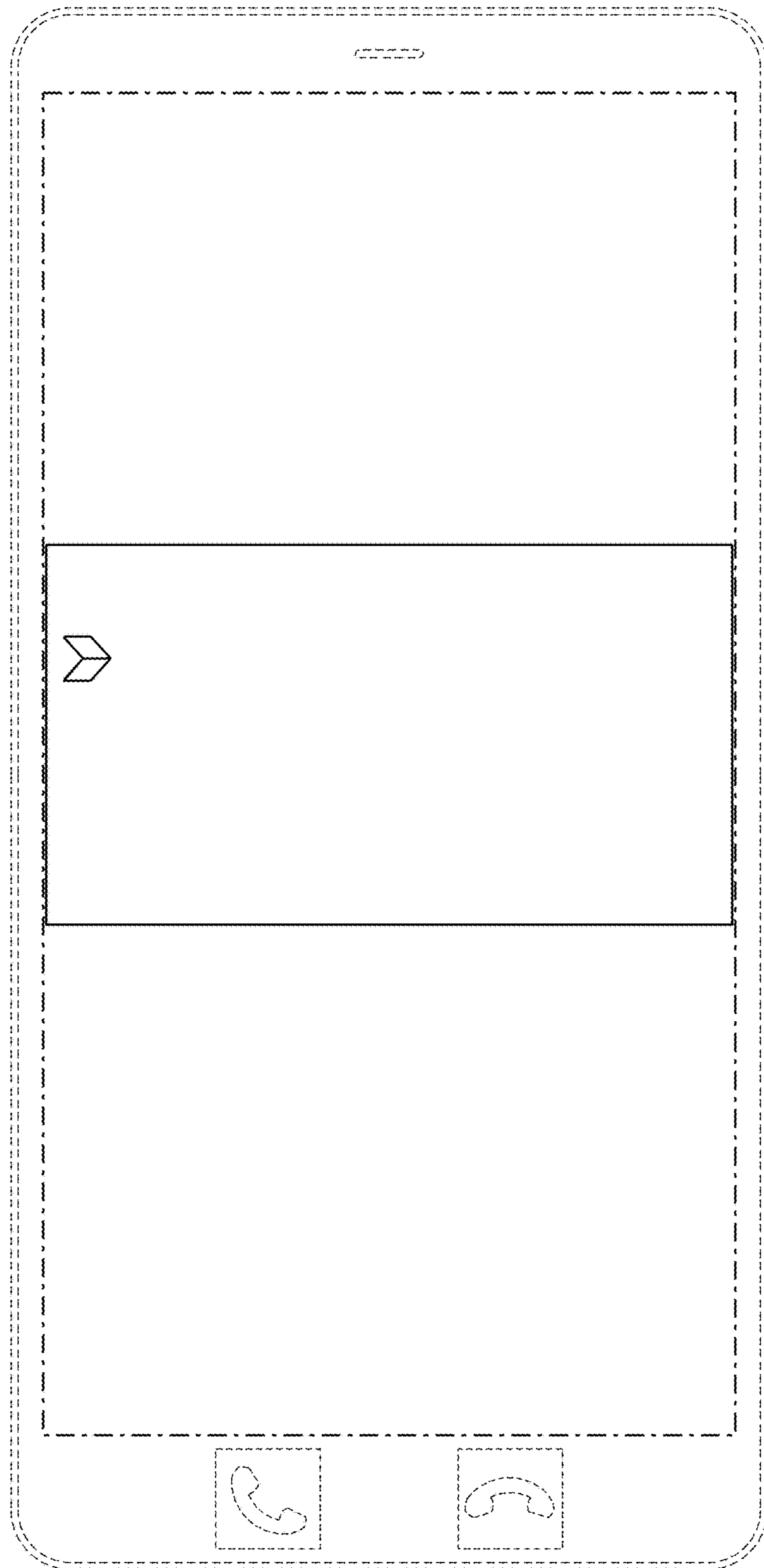

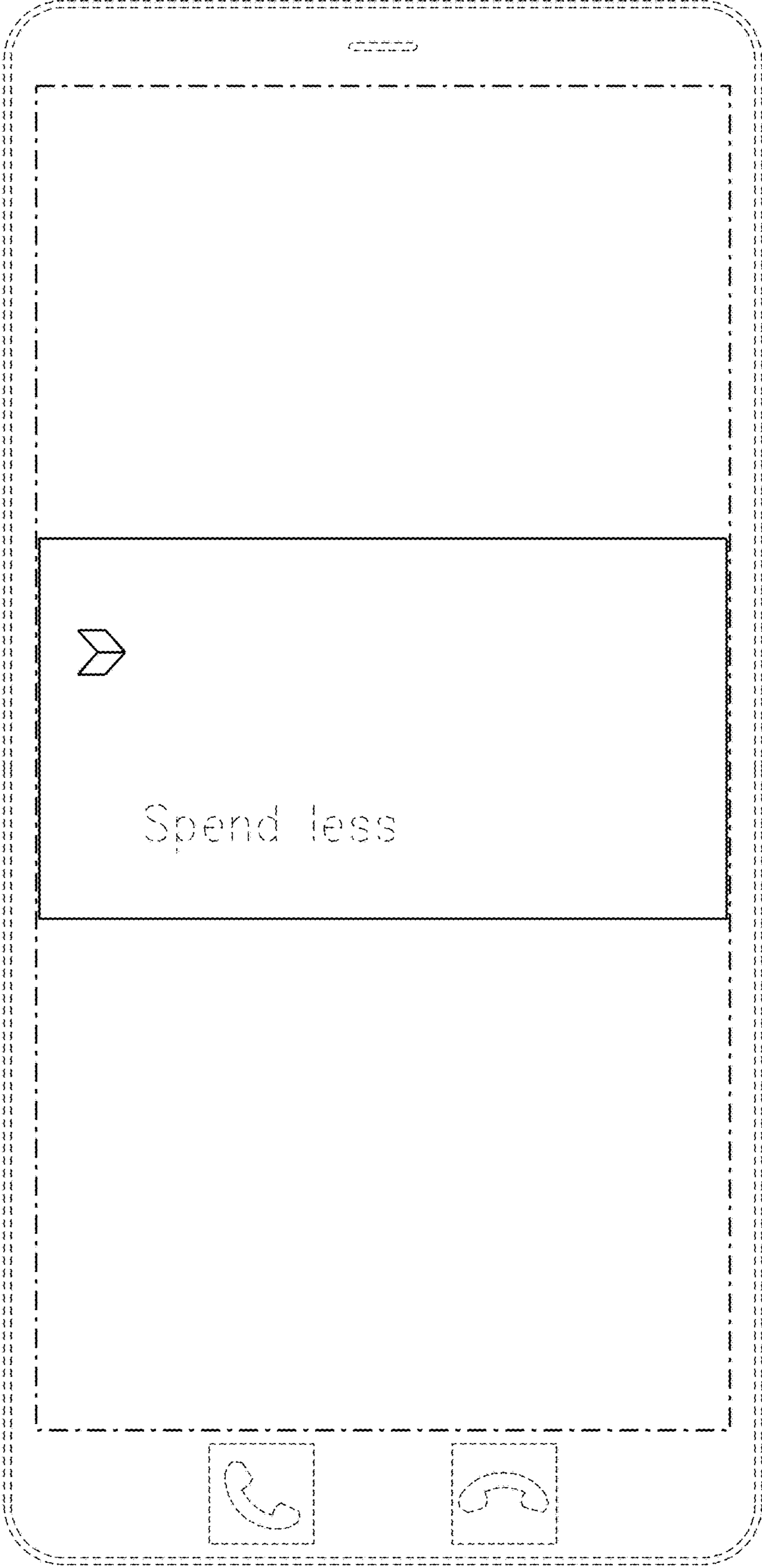

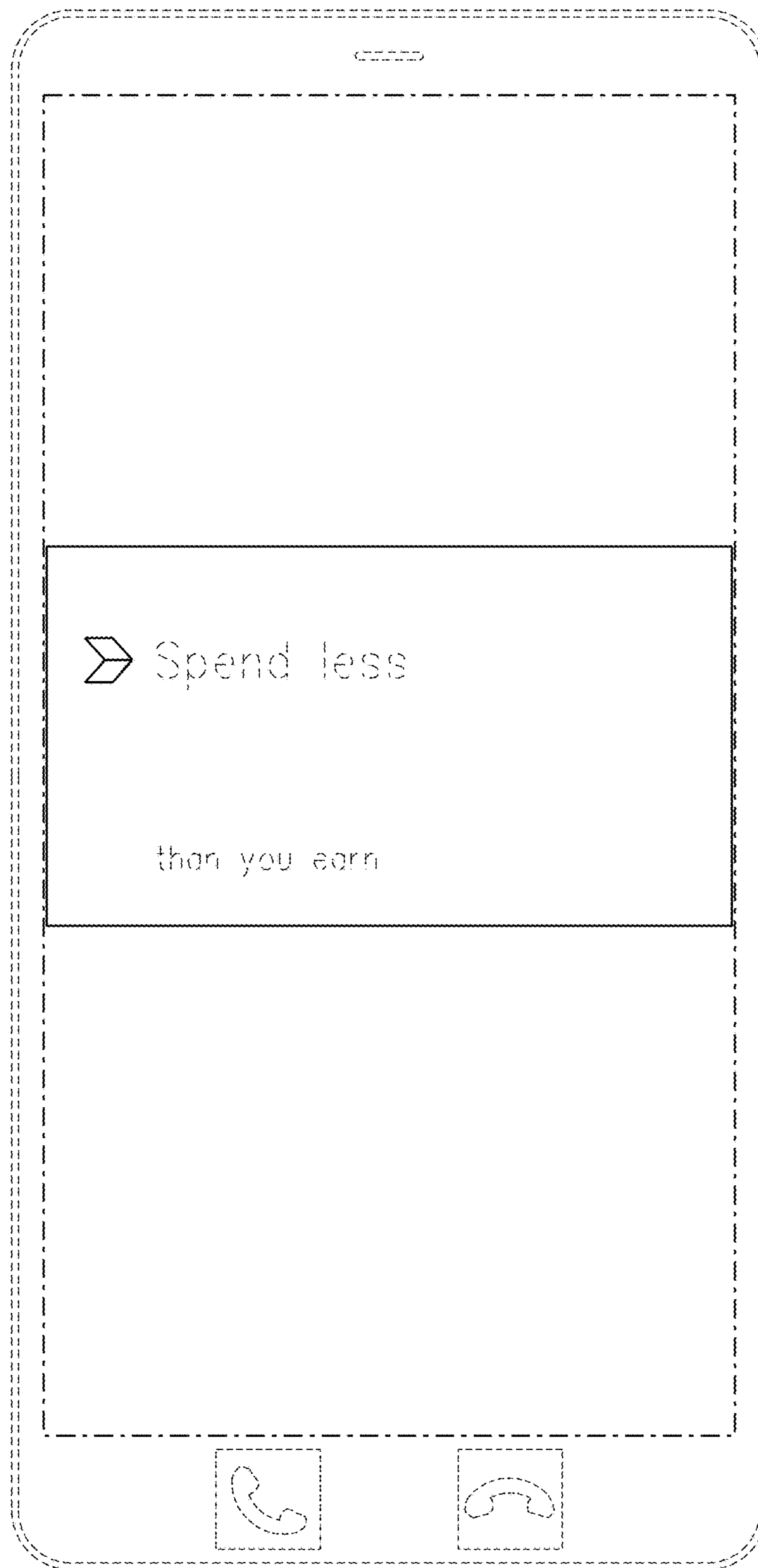

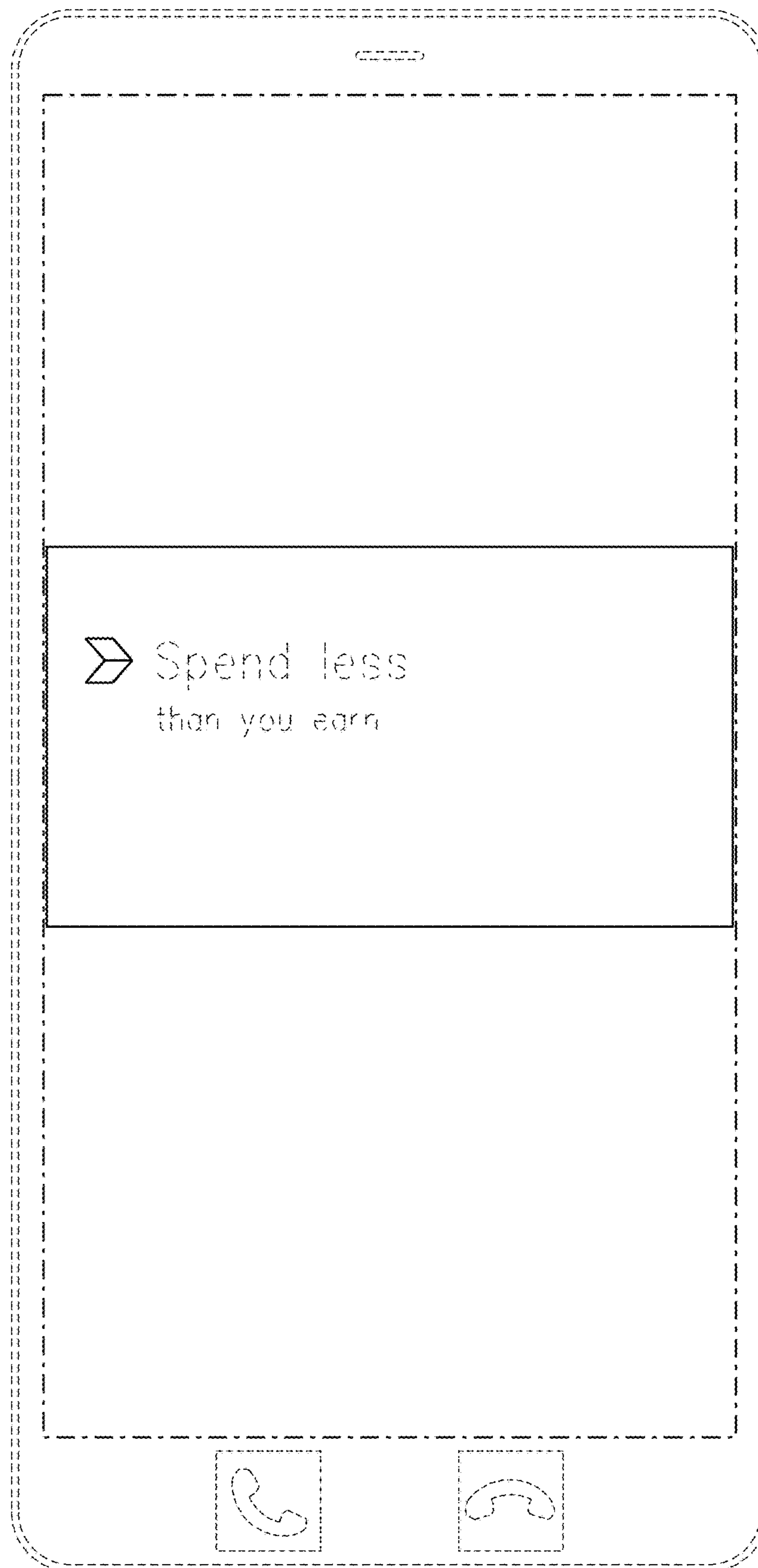

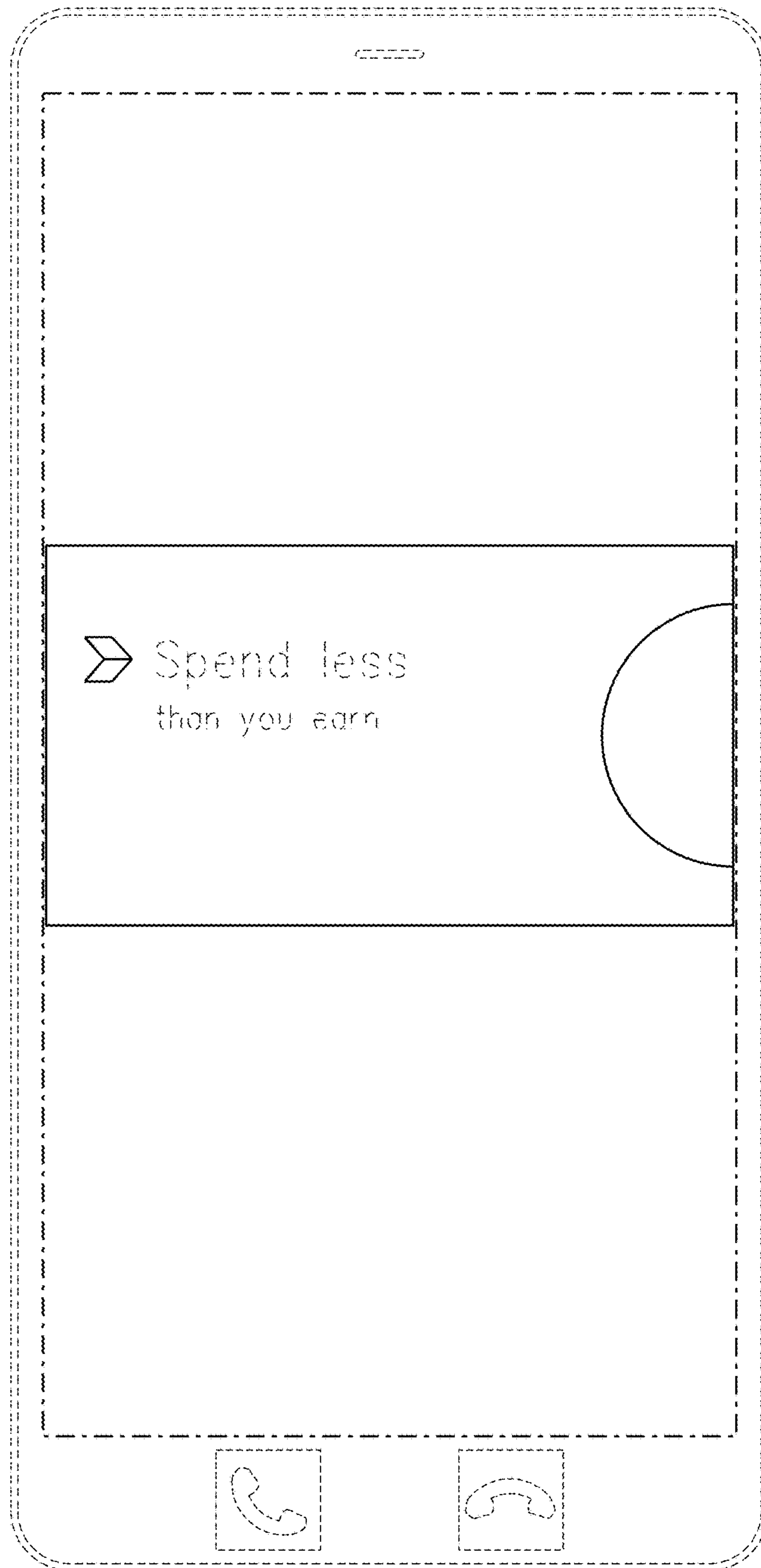

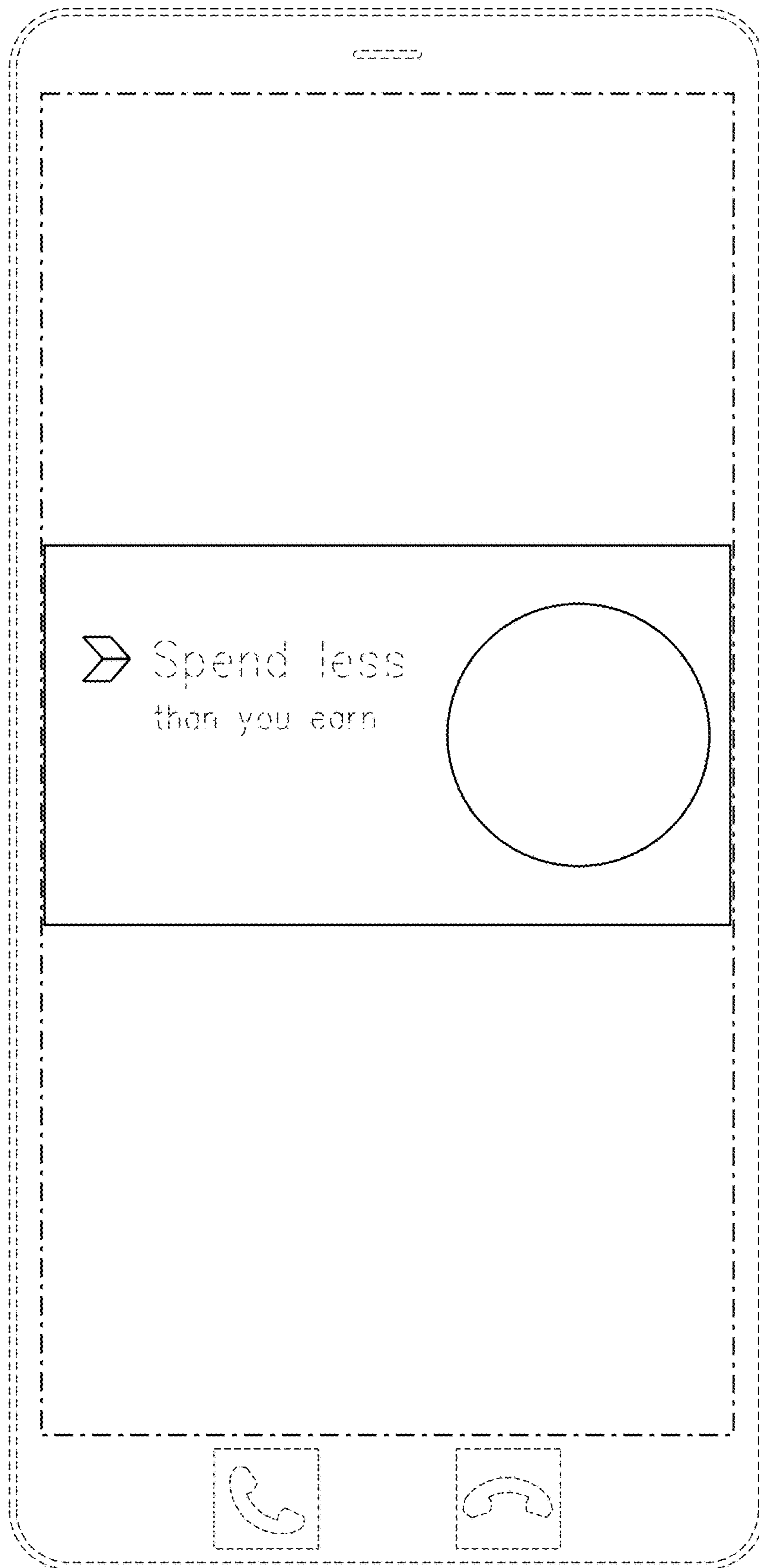

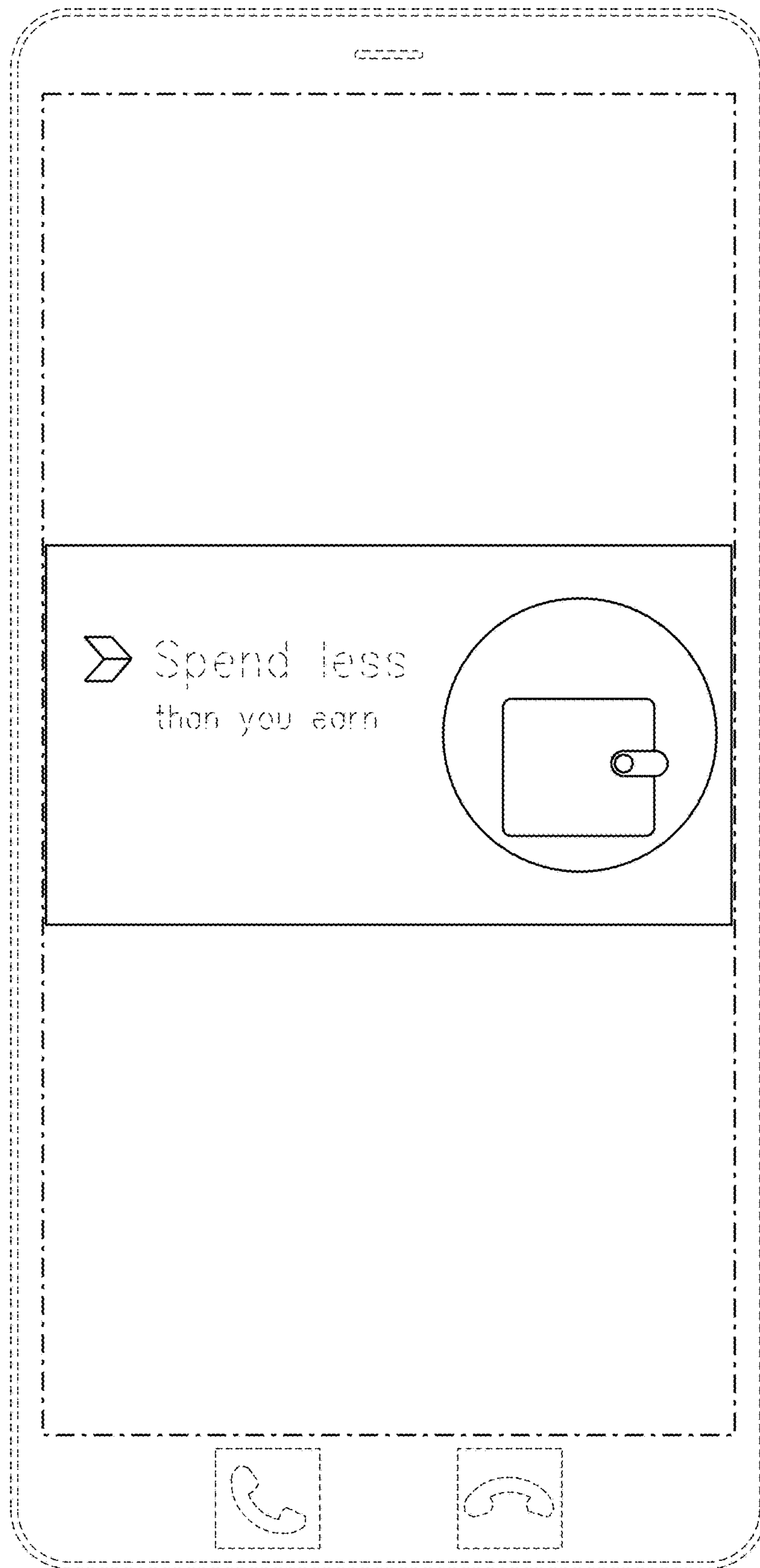

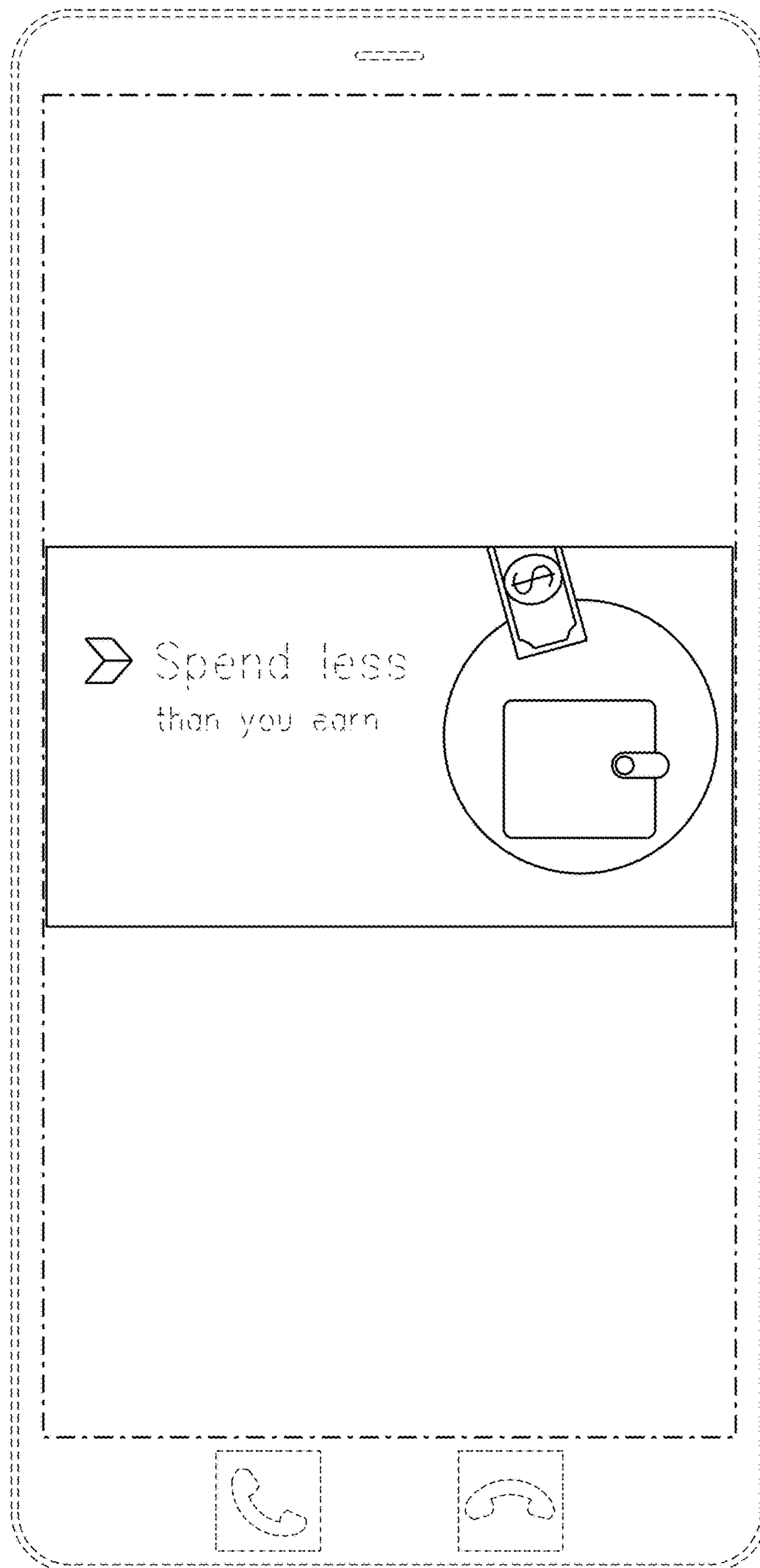

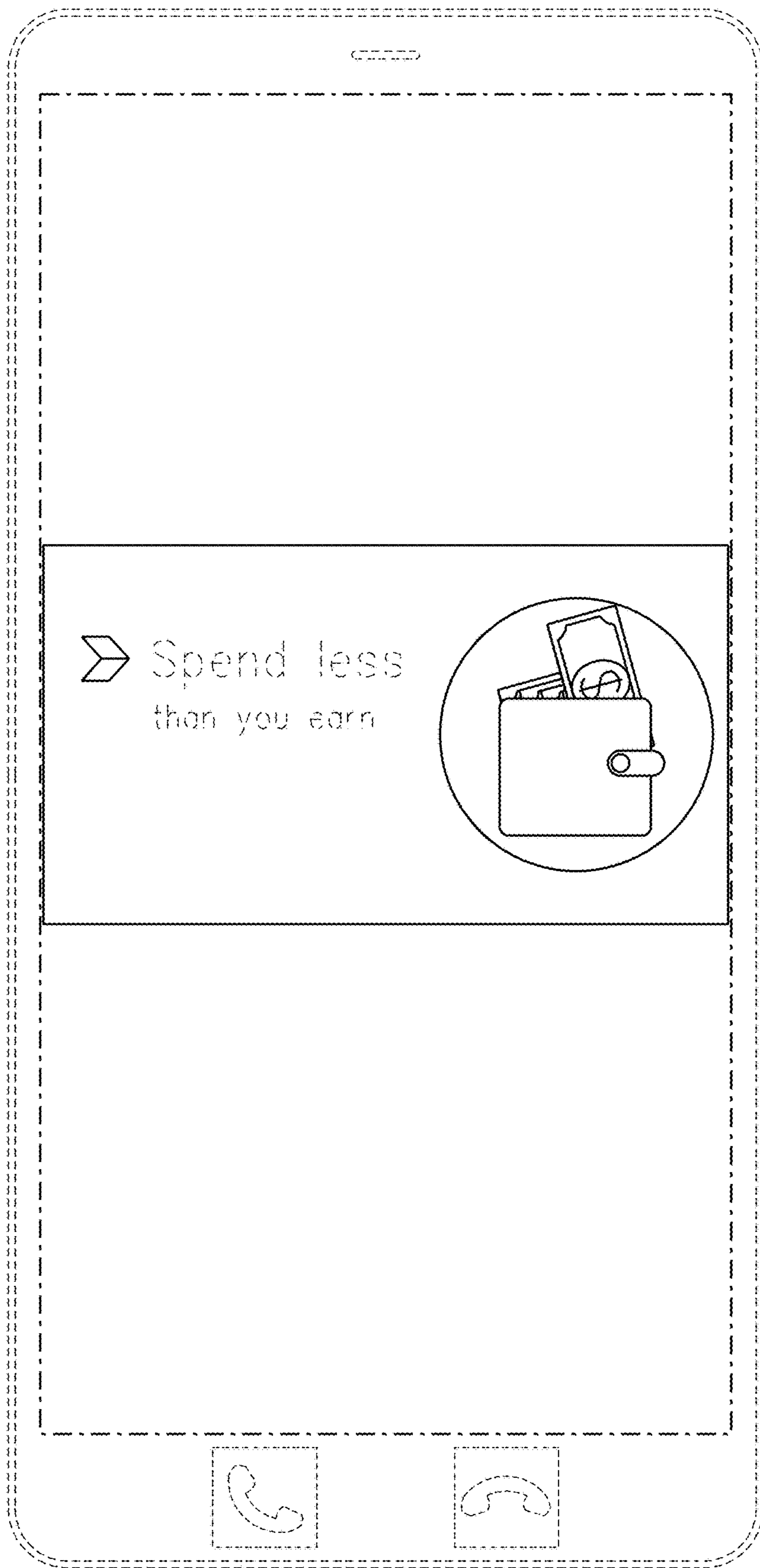

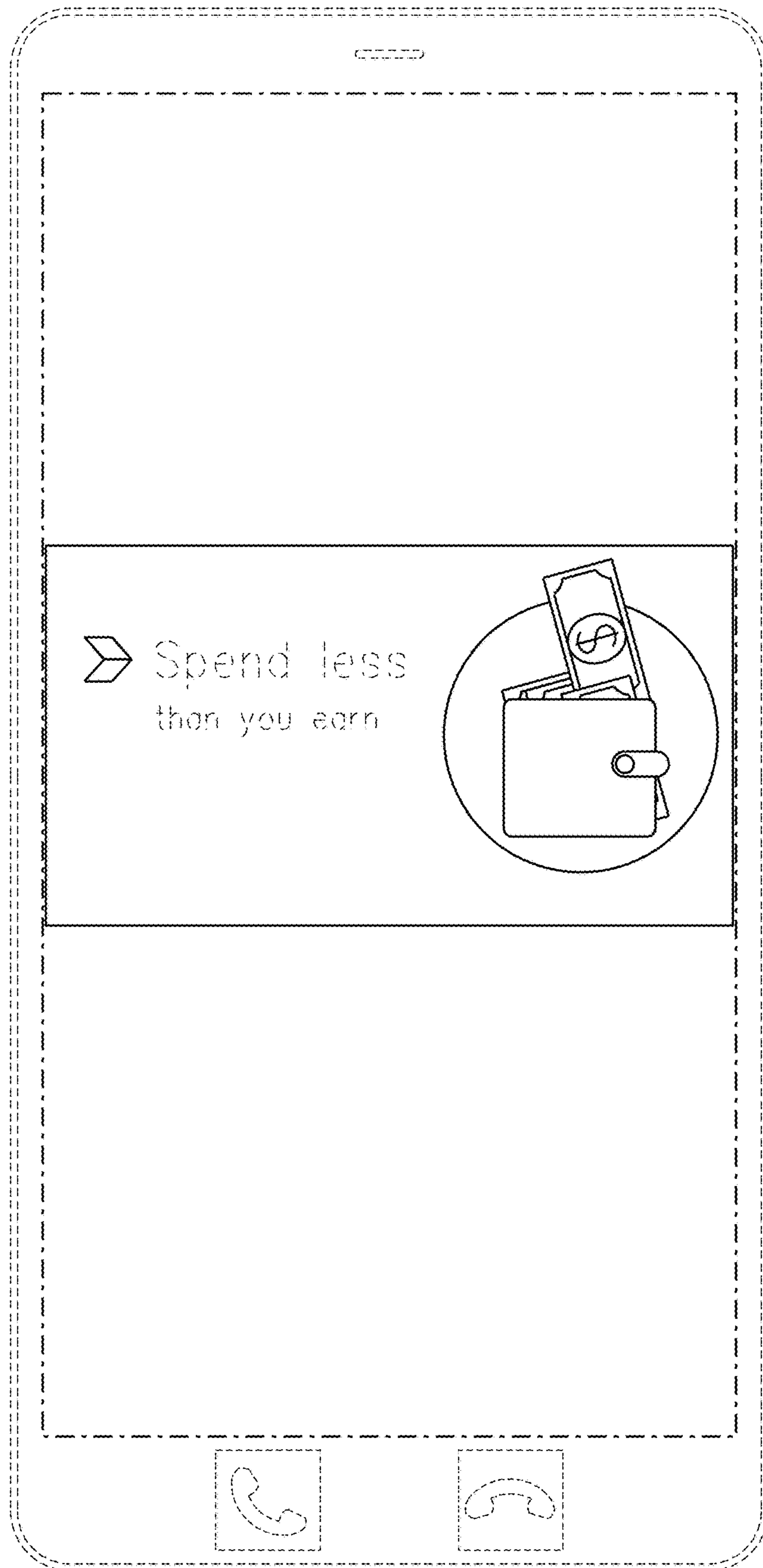

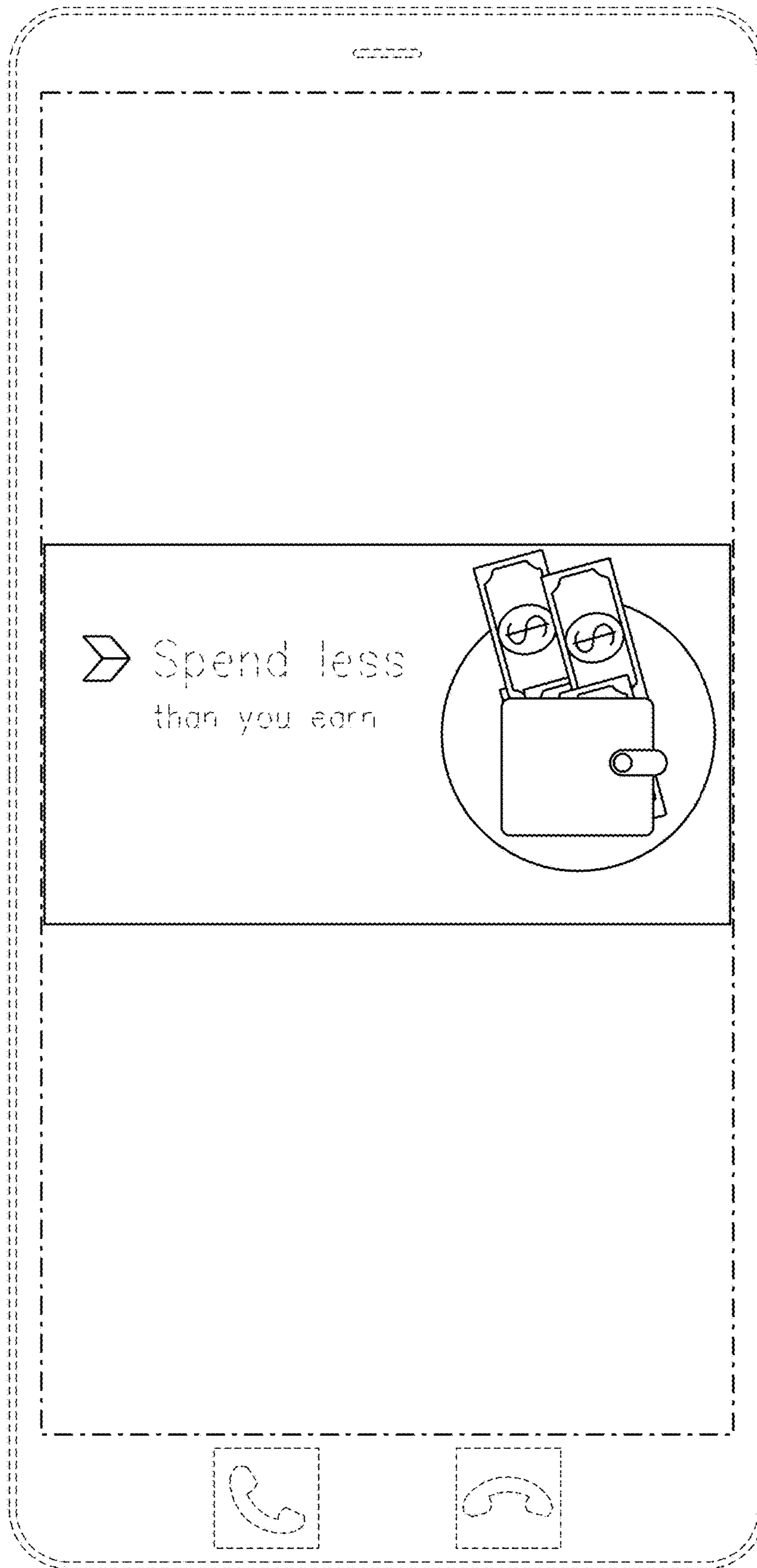

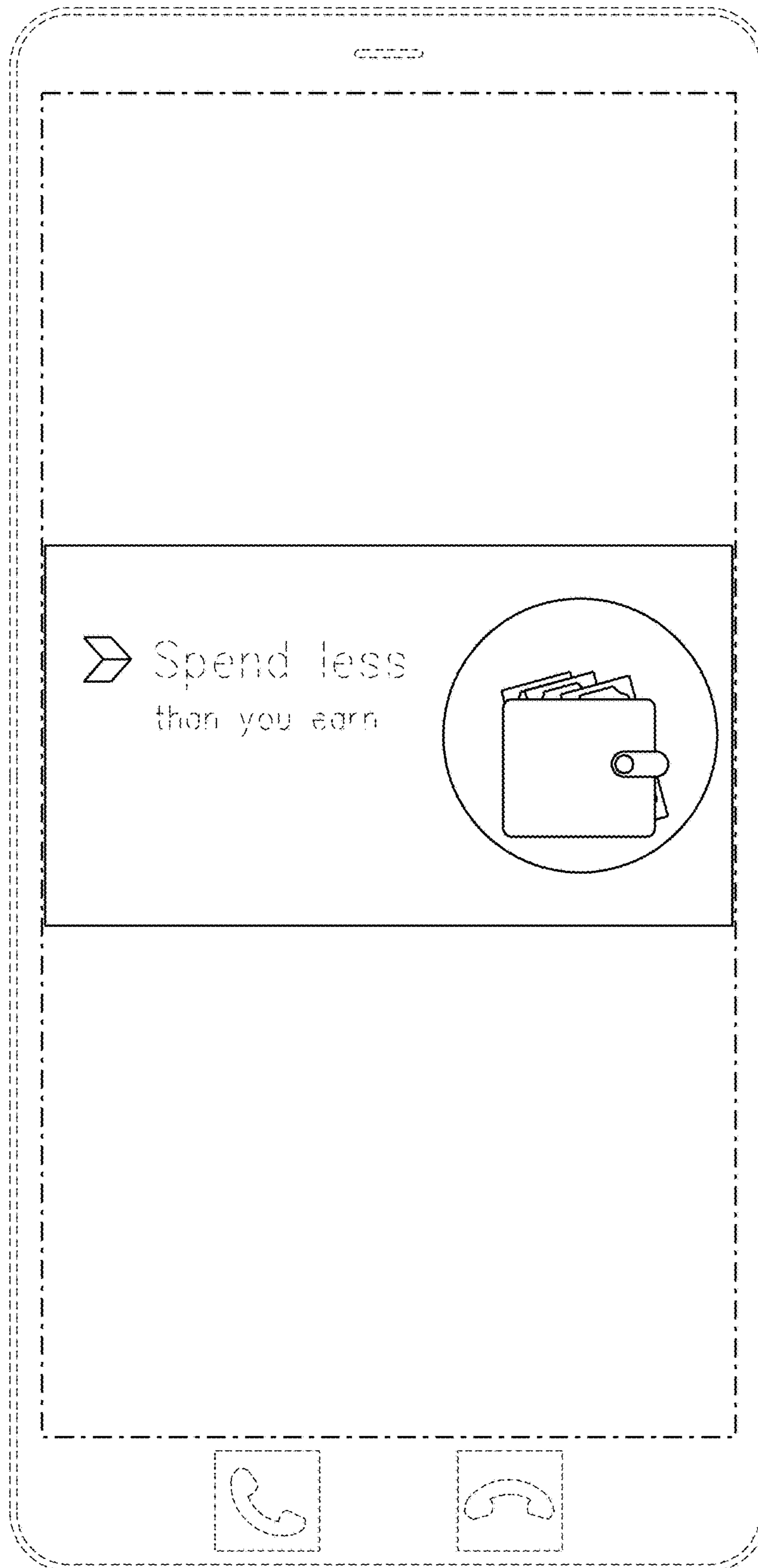
