FIG. 1 is a front view of a first embodiment of a display screen or portion thereof with graphical user interface showing our new design;

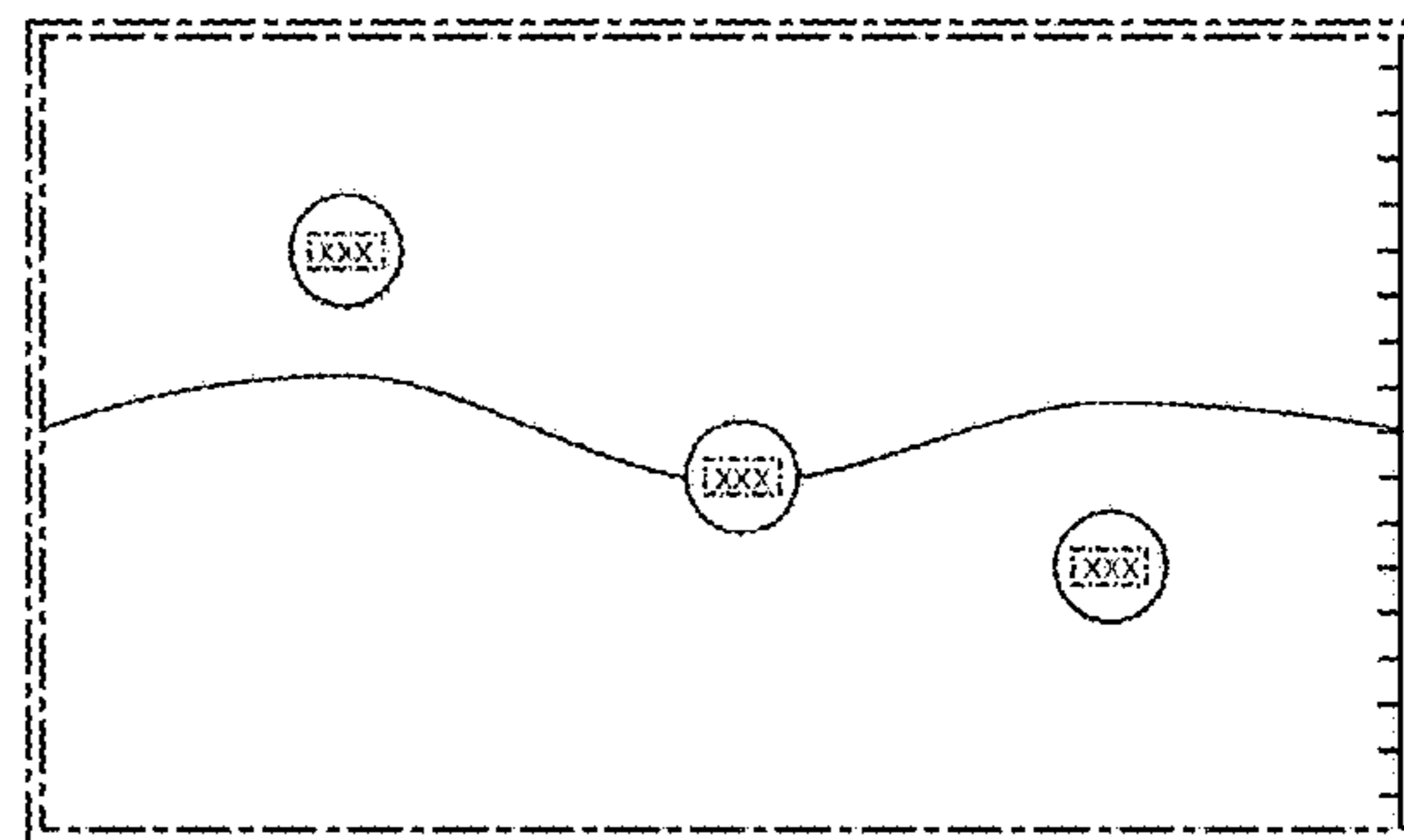
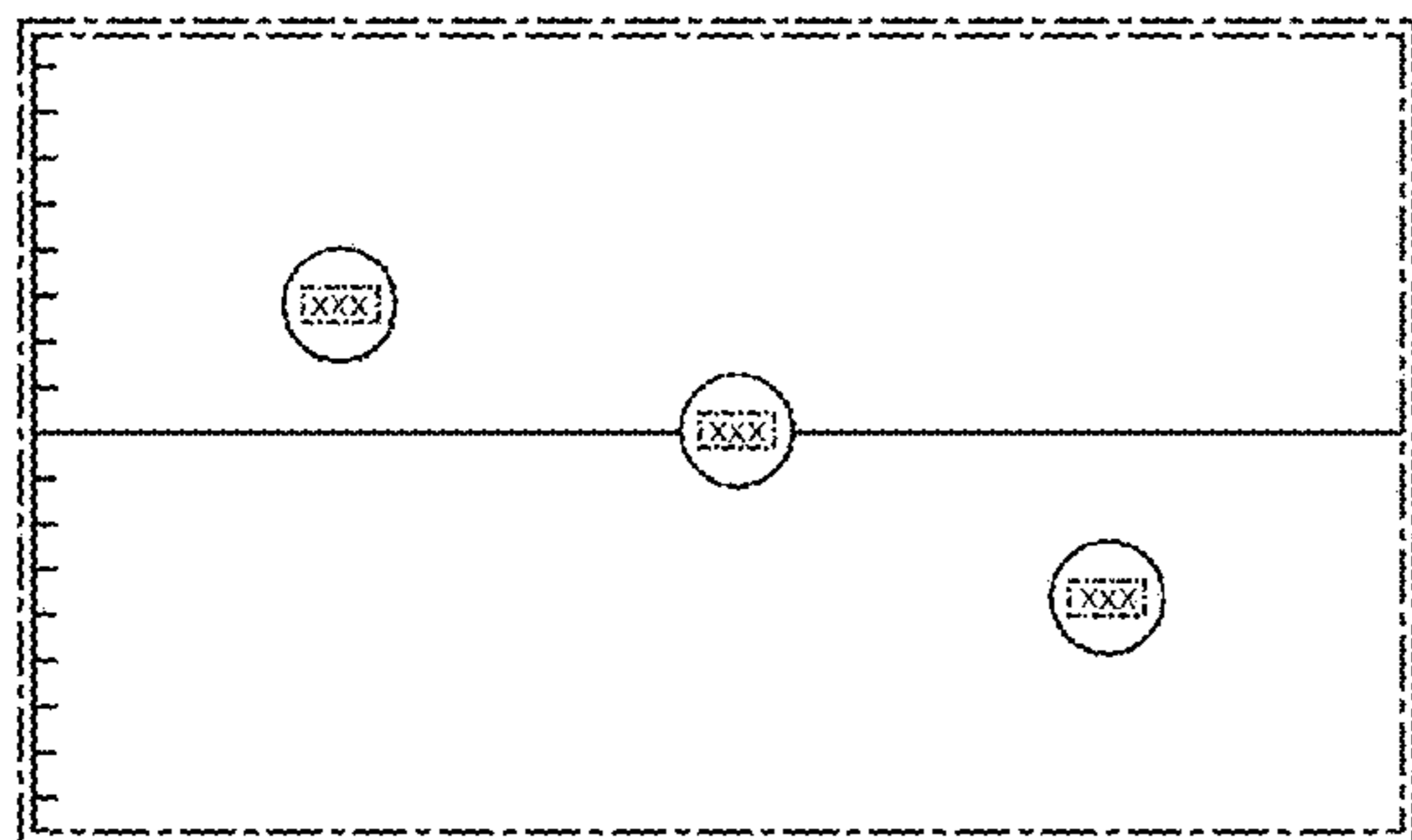
FIG. 2 is a front view of a second embodiment of a display screen or portion thereof with graphical user interface showing our new design;

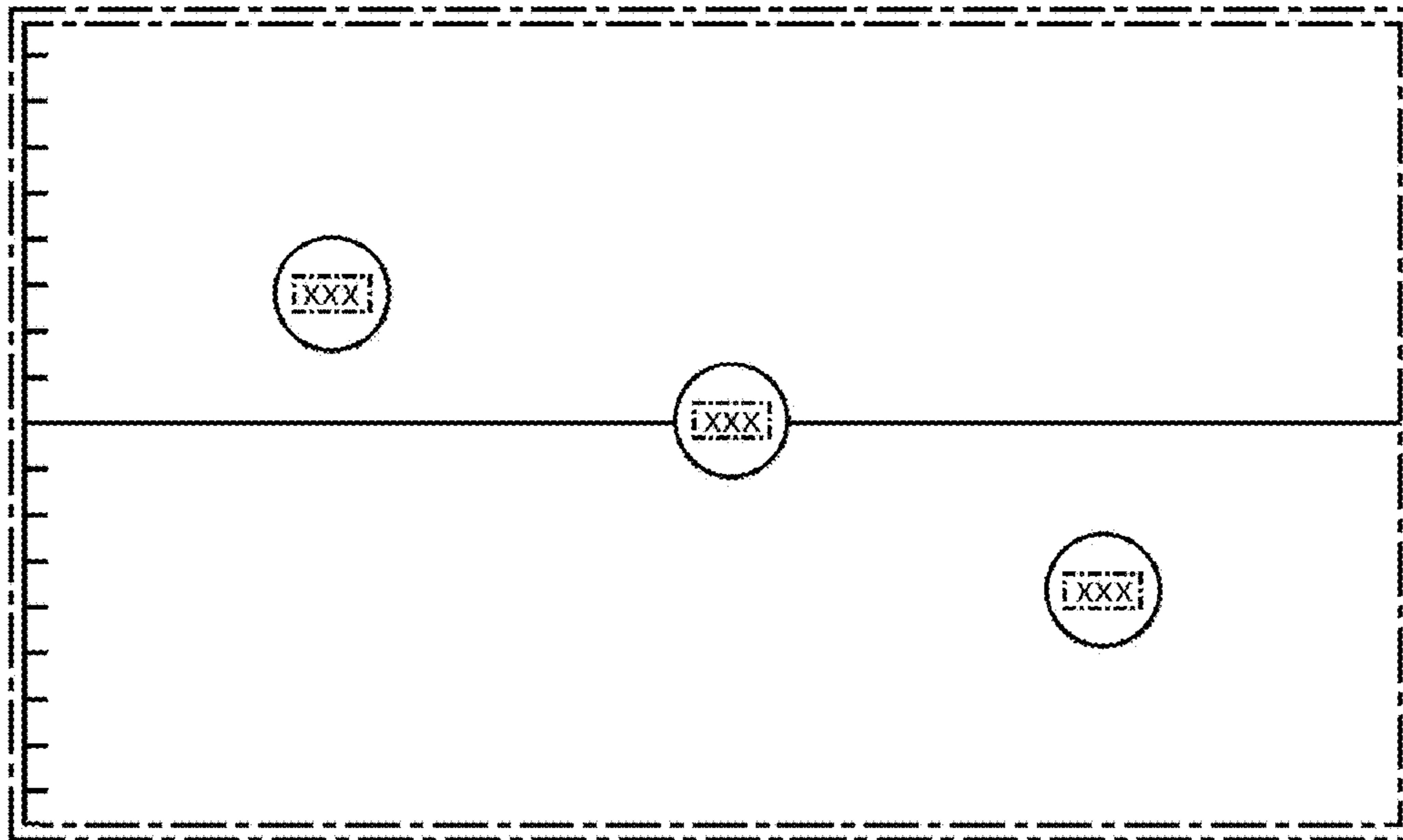

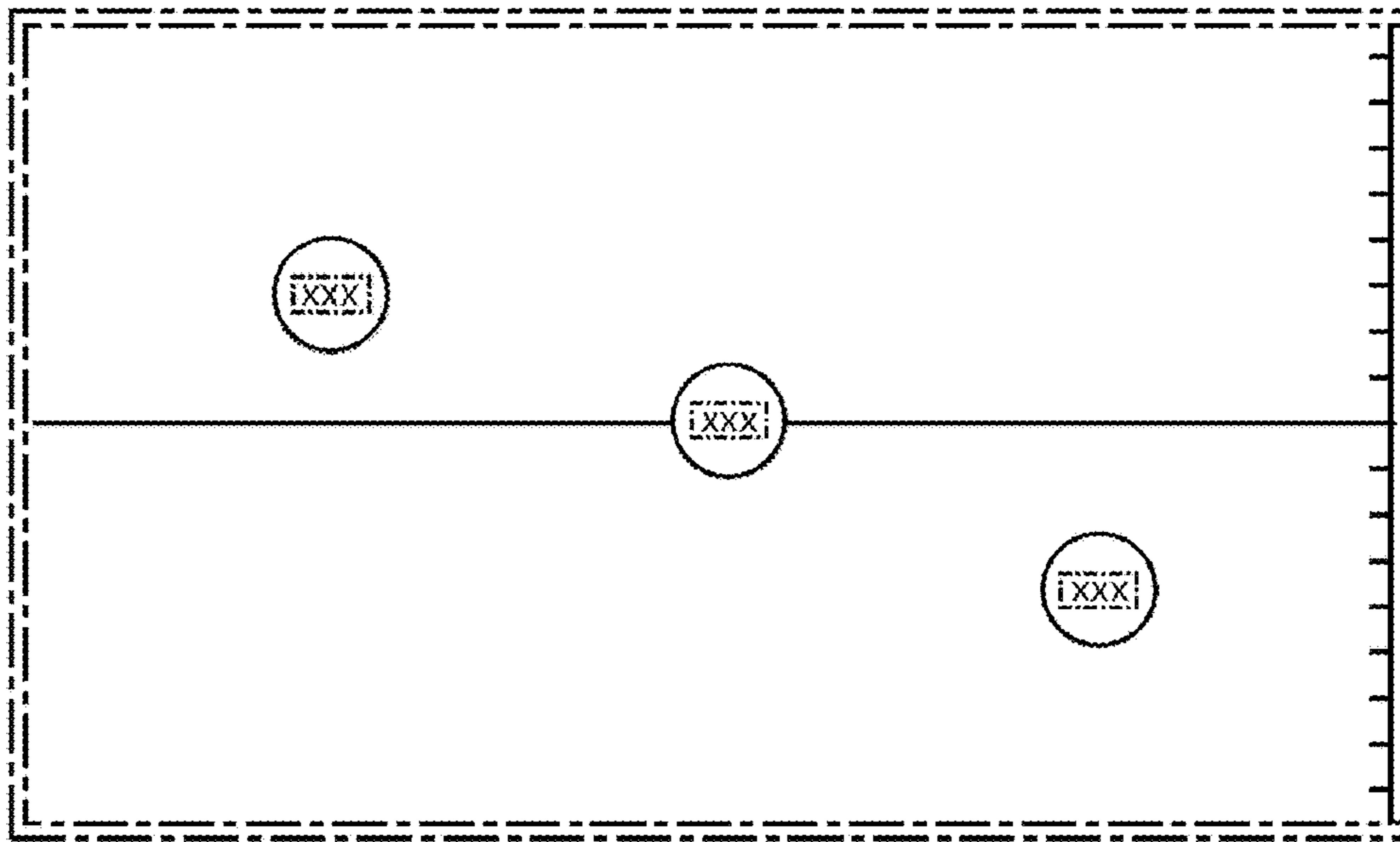

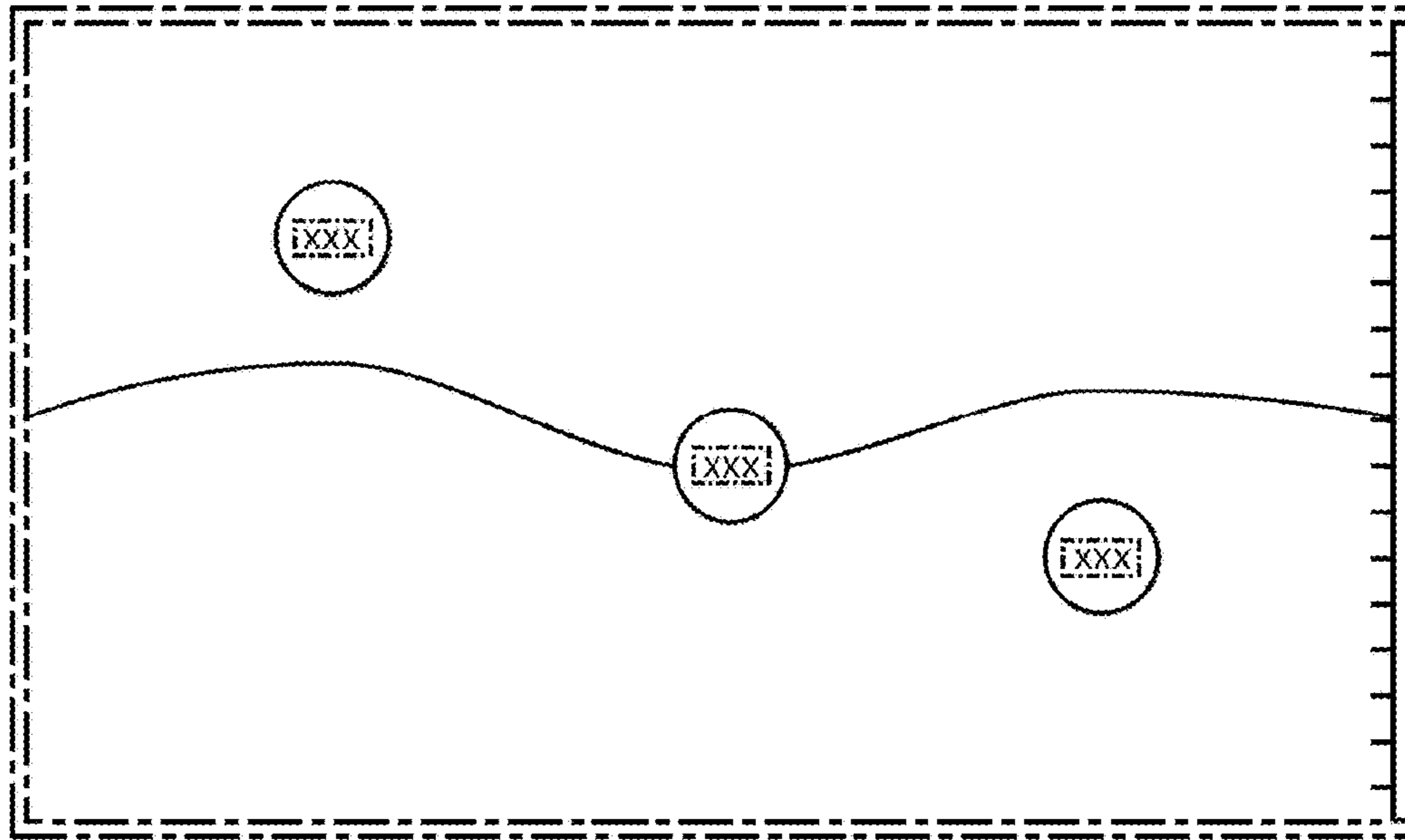

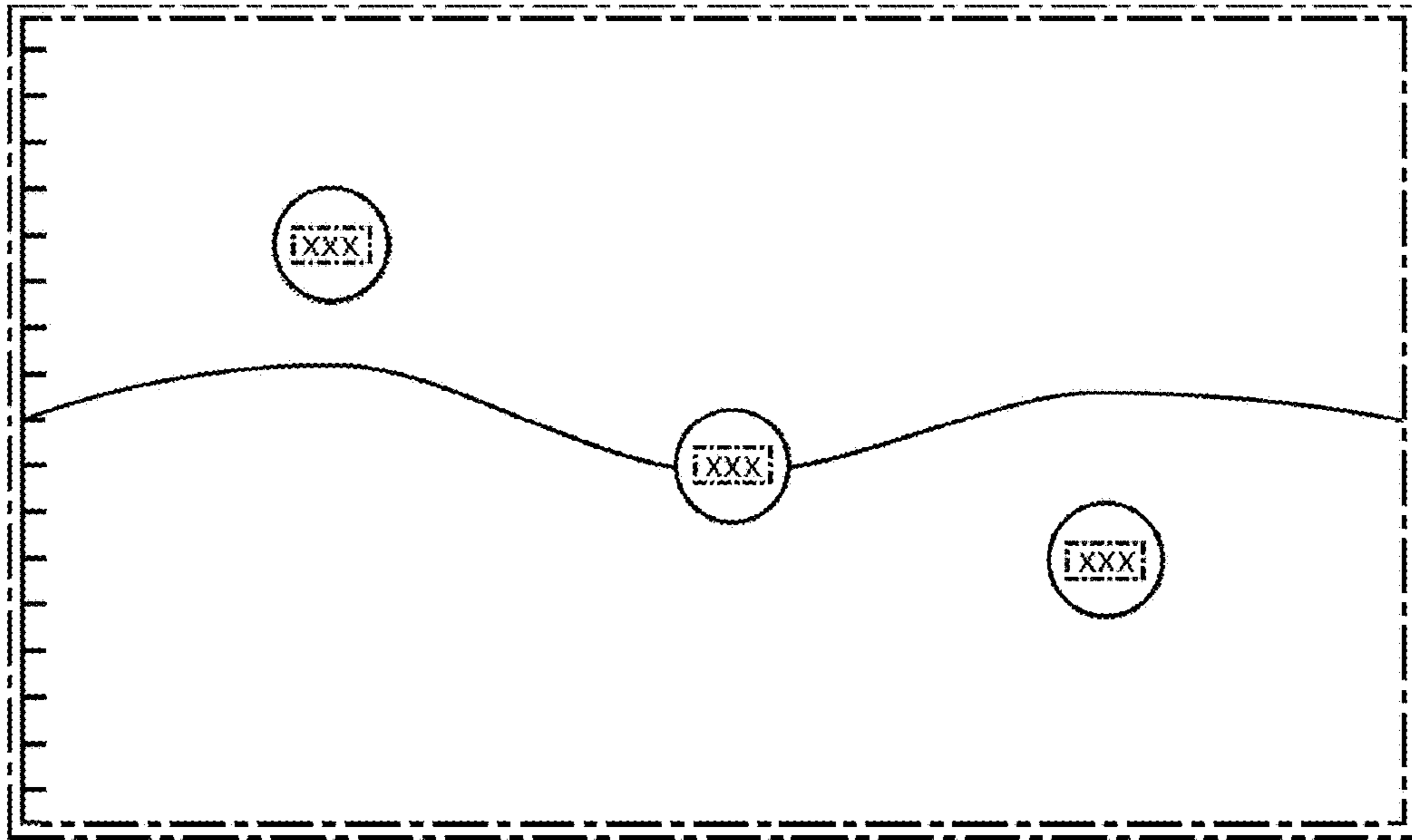
