(57) **CLAIM**

We claim the ornamental design for a display screen or portion thereof with transitional graphical user interface, as shown and described.

DESCRIPTION

FIG. 12 is an enlarged view of the encircled portion in FIG. 6.

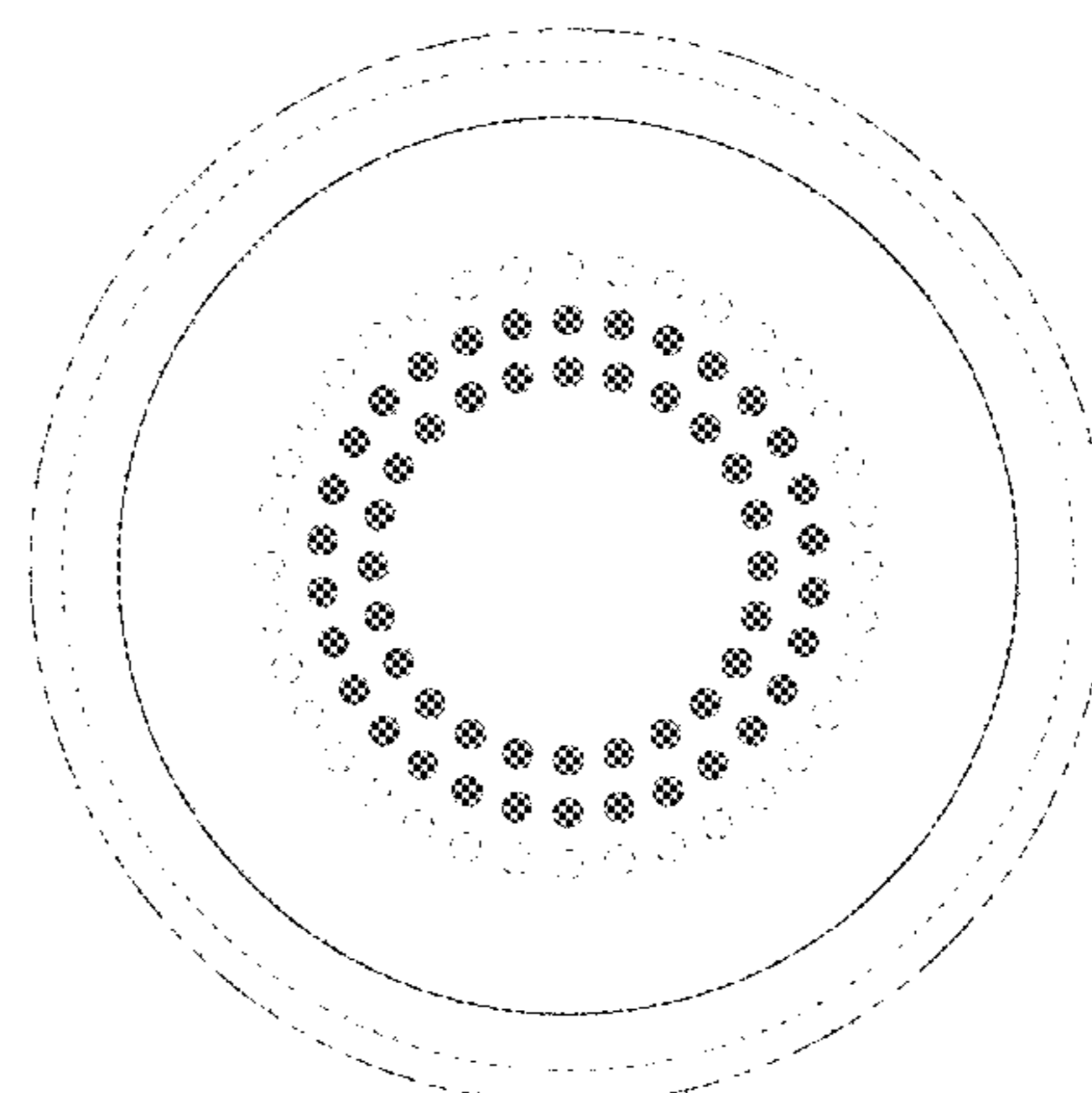
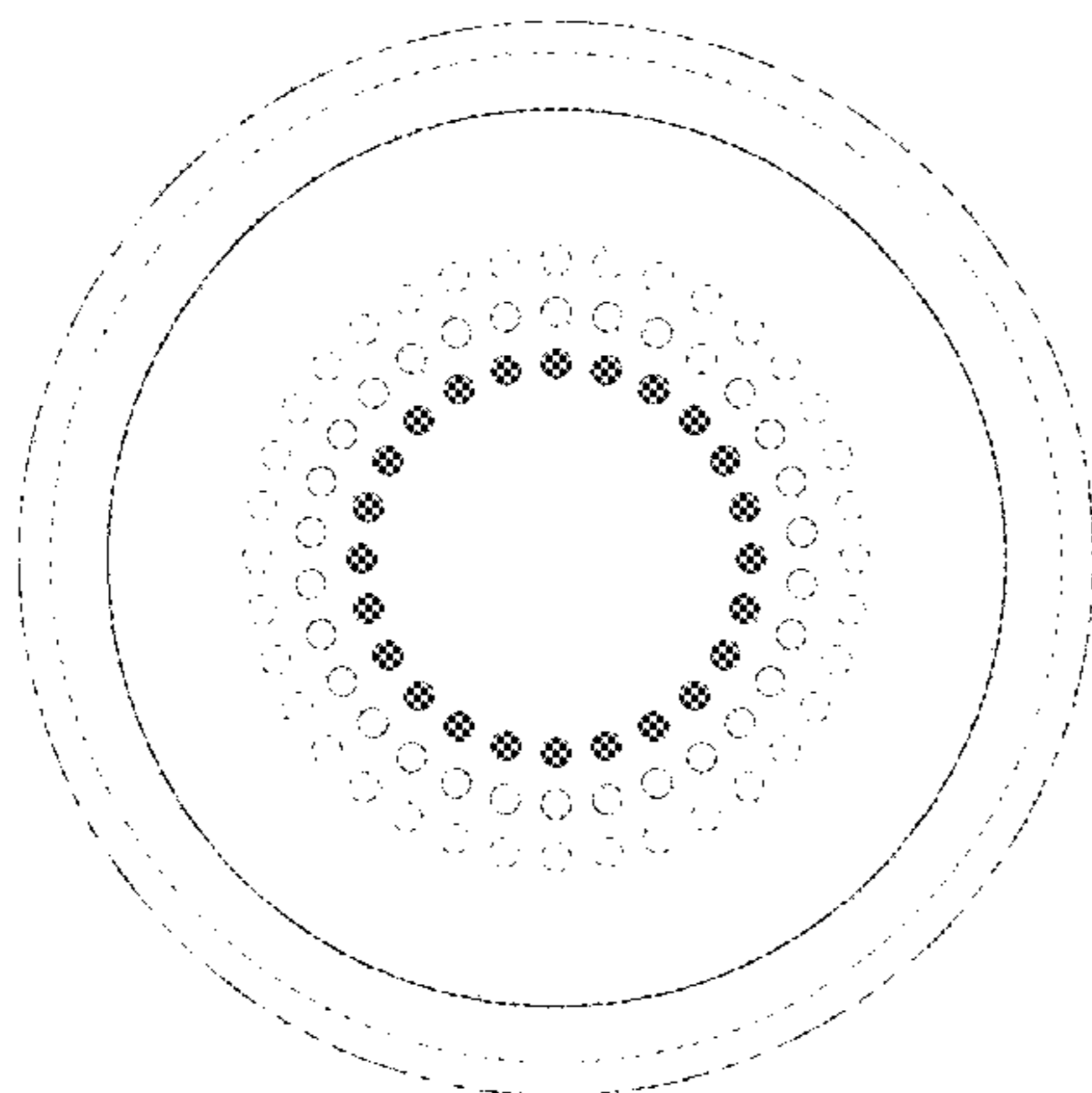
The broken lines in the figures depict environmental subject matter and form no part of the claimed design.

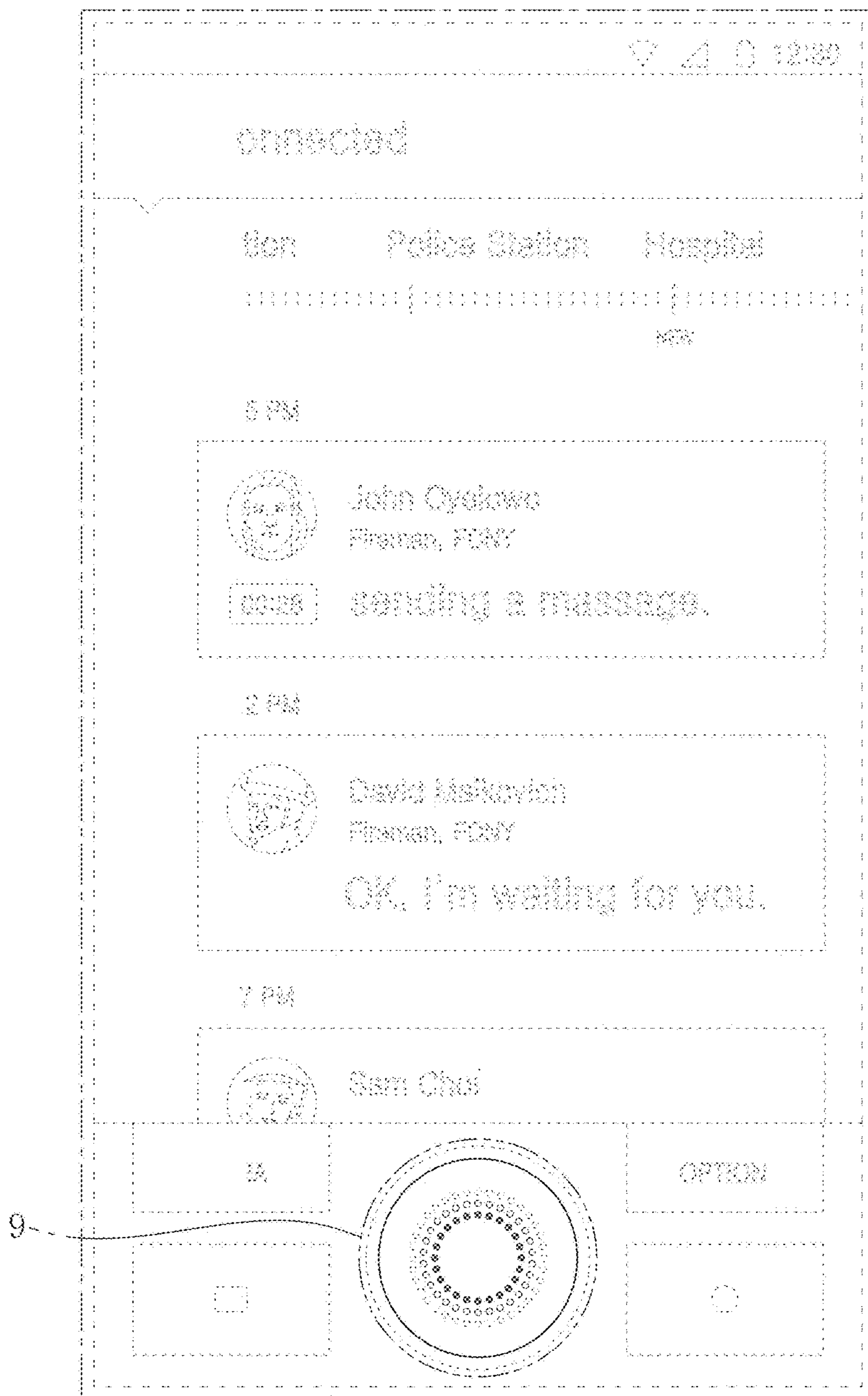

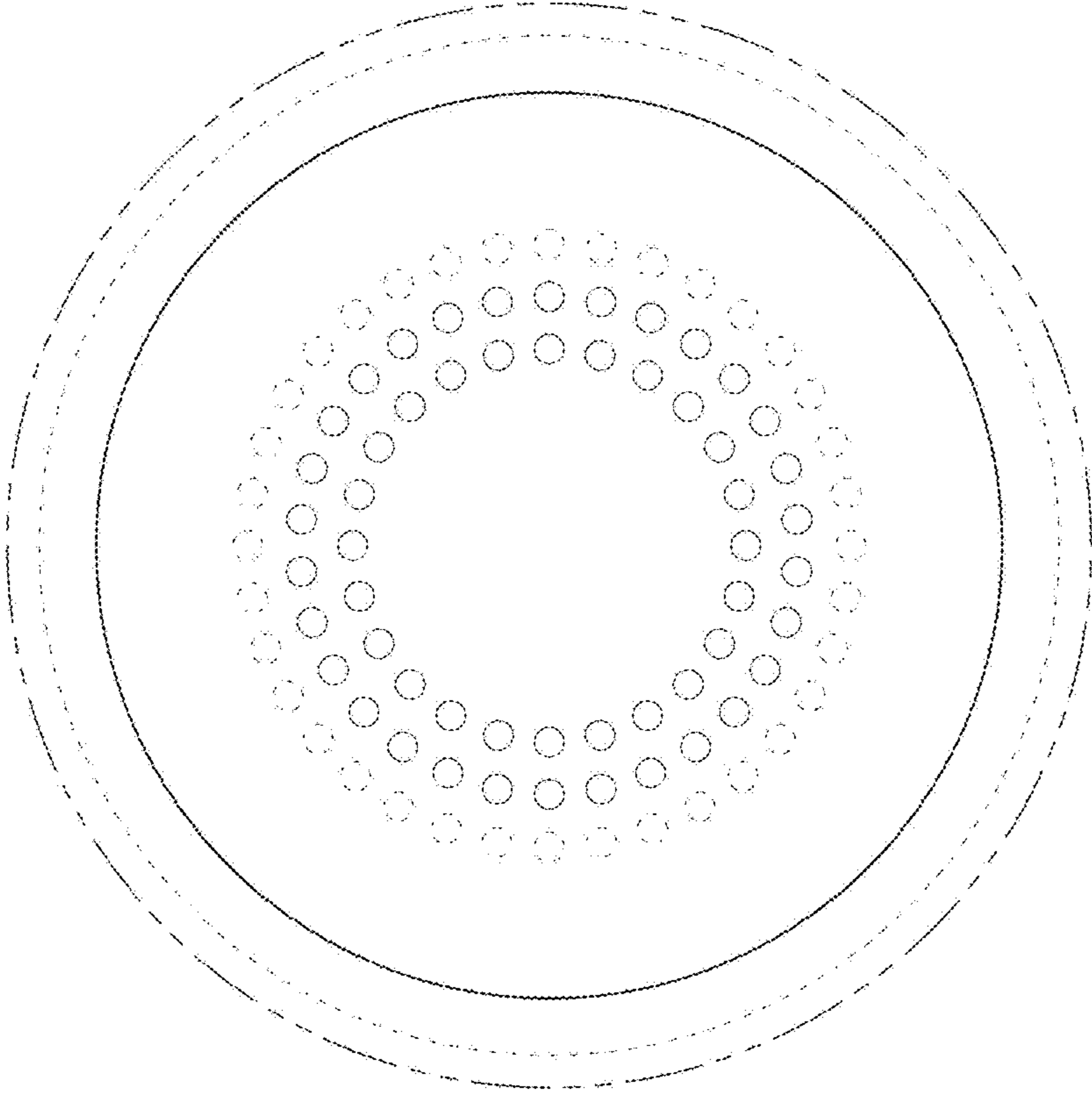

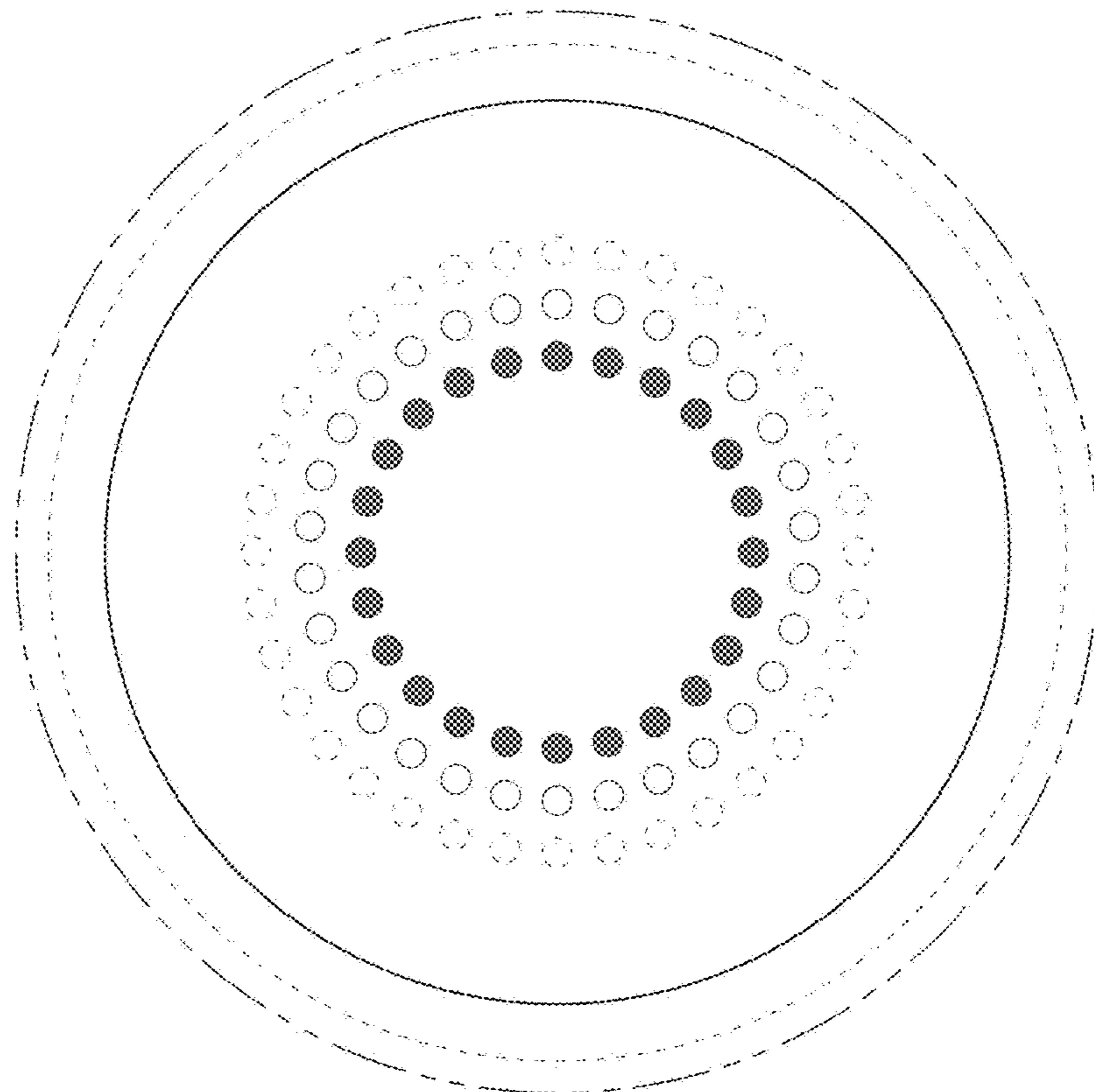

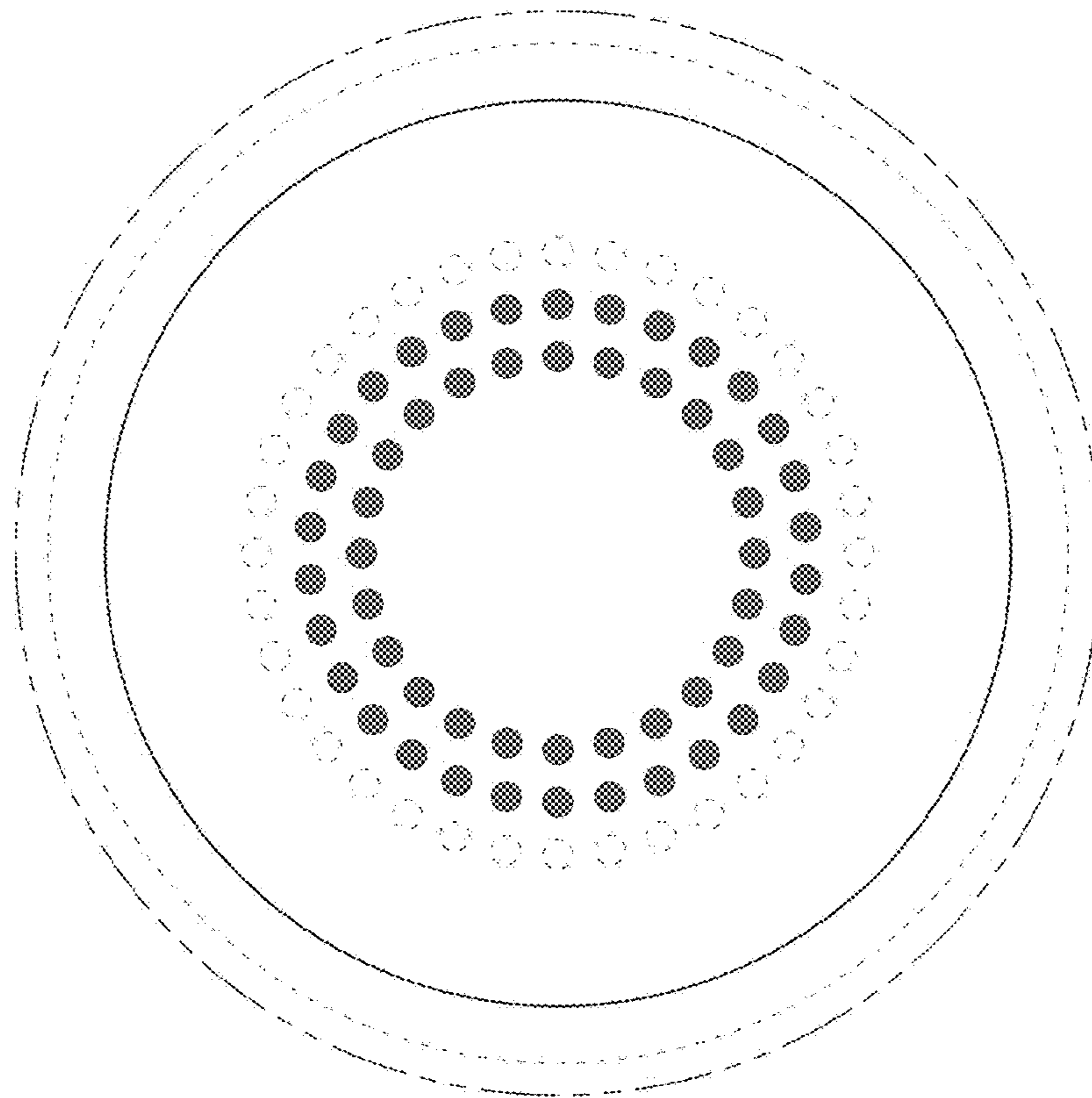

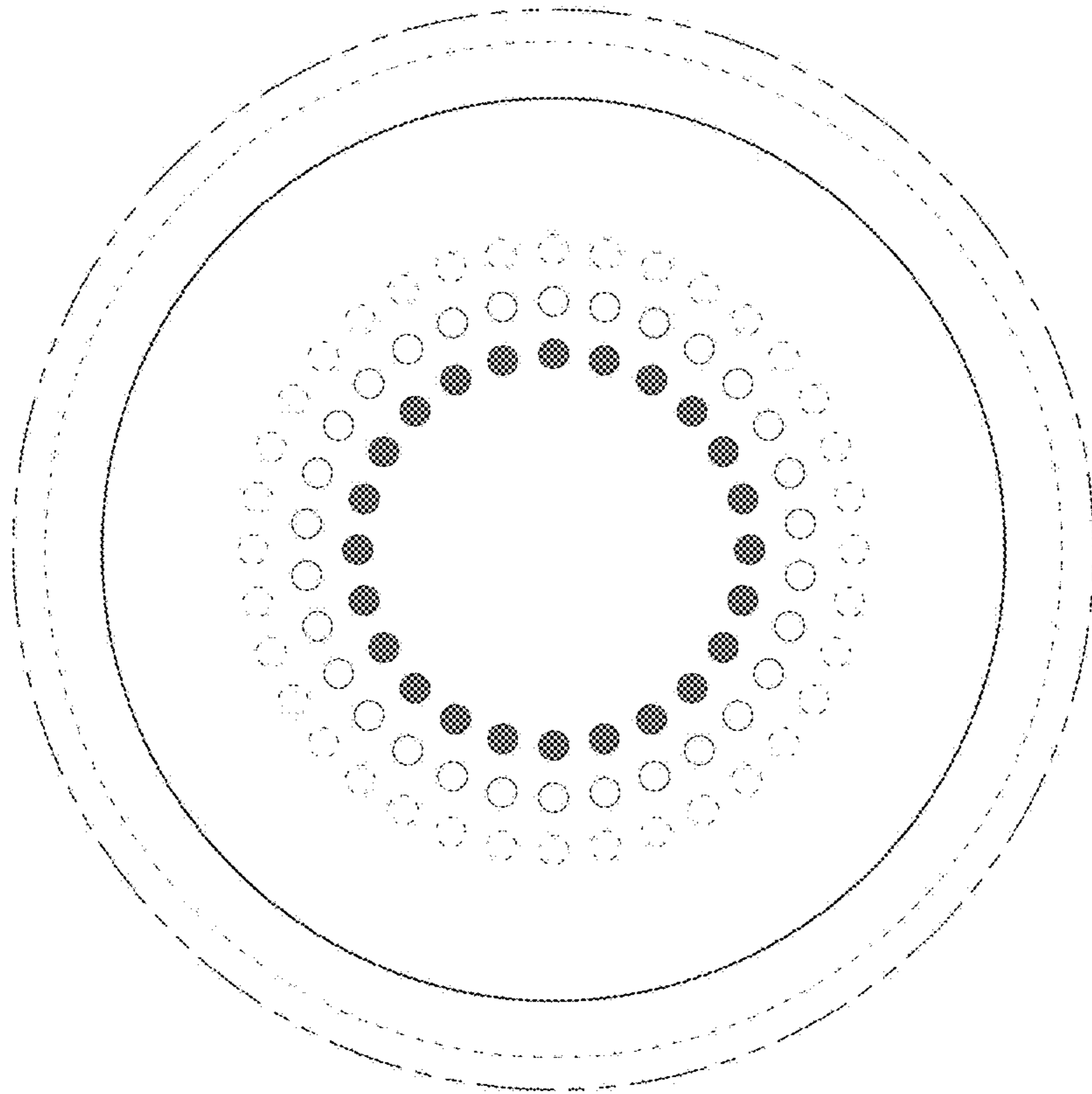
