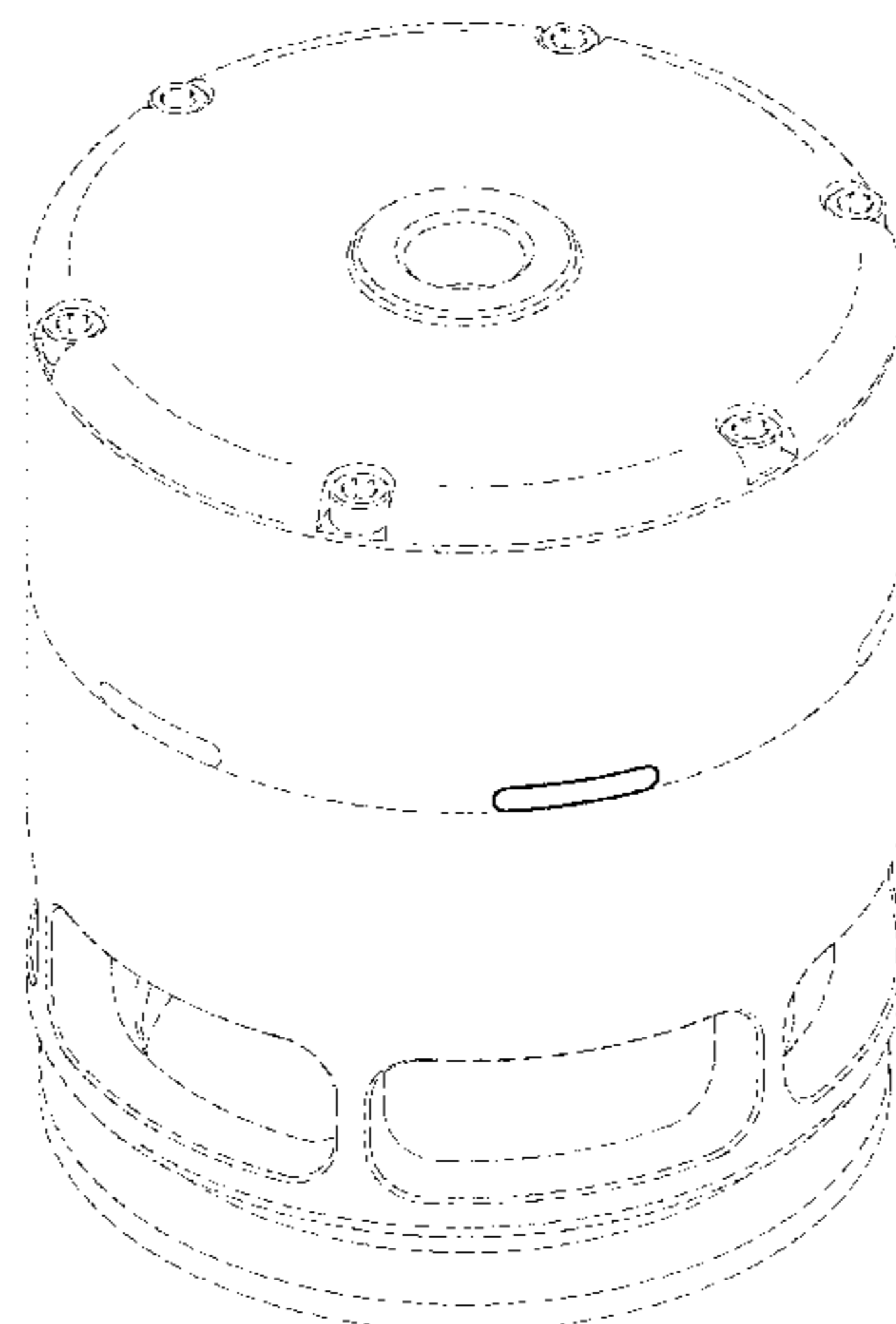
(57) **CLAIM**

DESCRIPTION

FIG. 1 is a perspective view of an upper vent of a multi-chamber blowoff valve showing our new design;

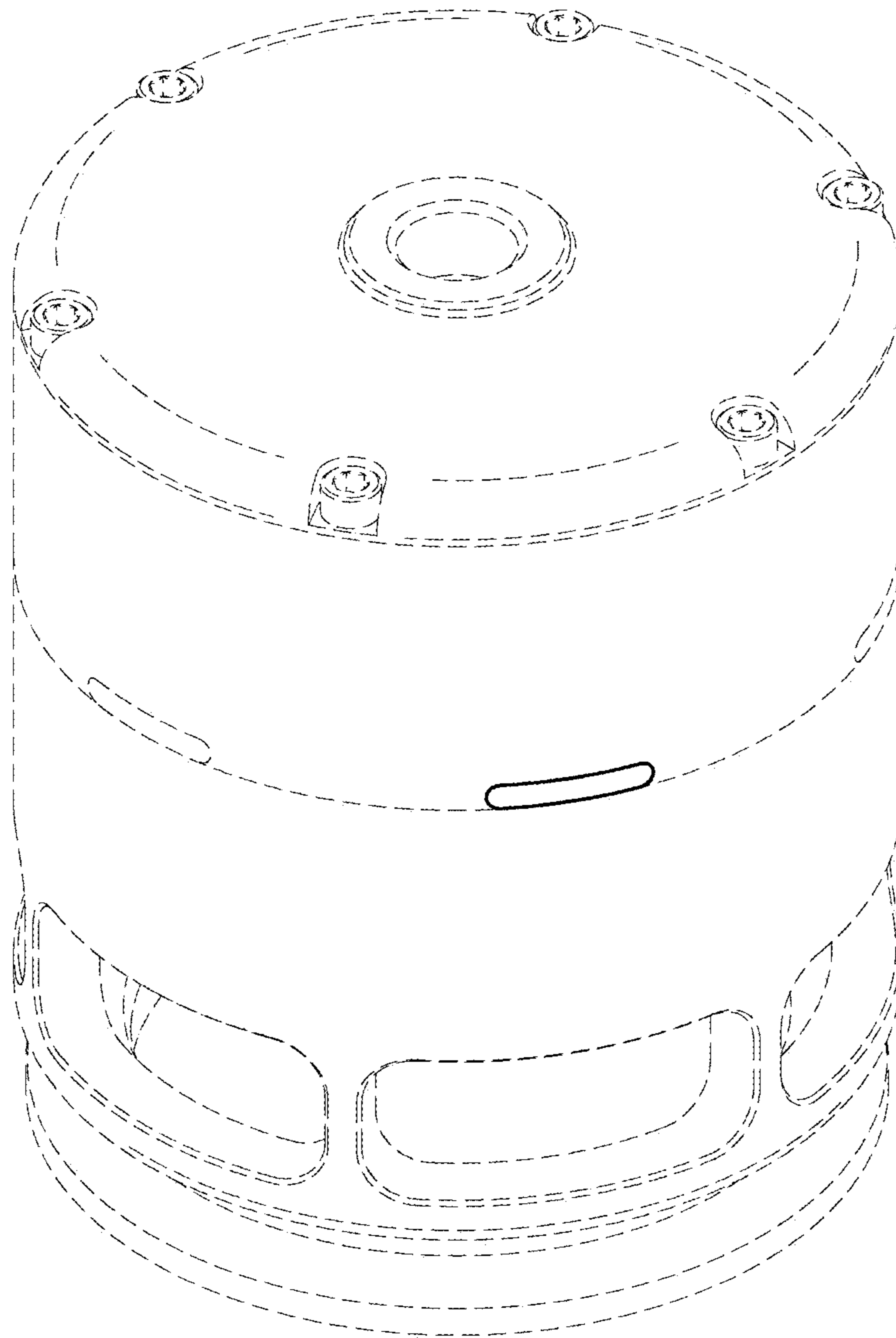

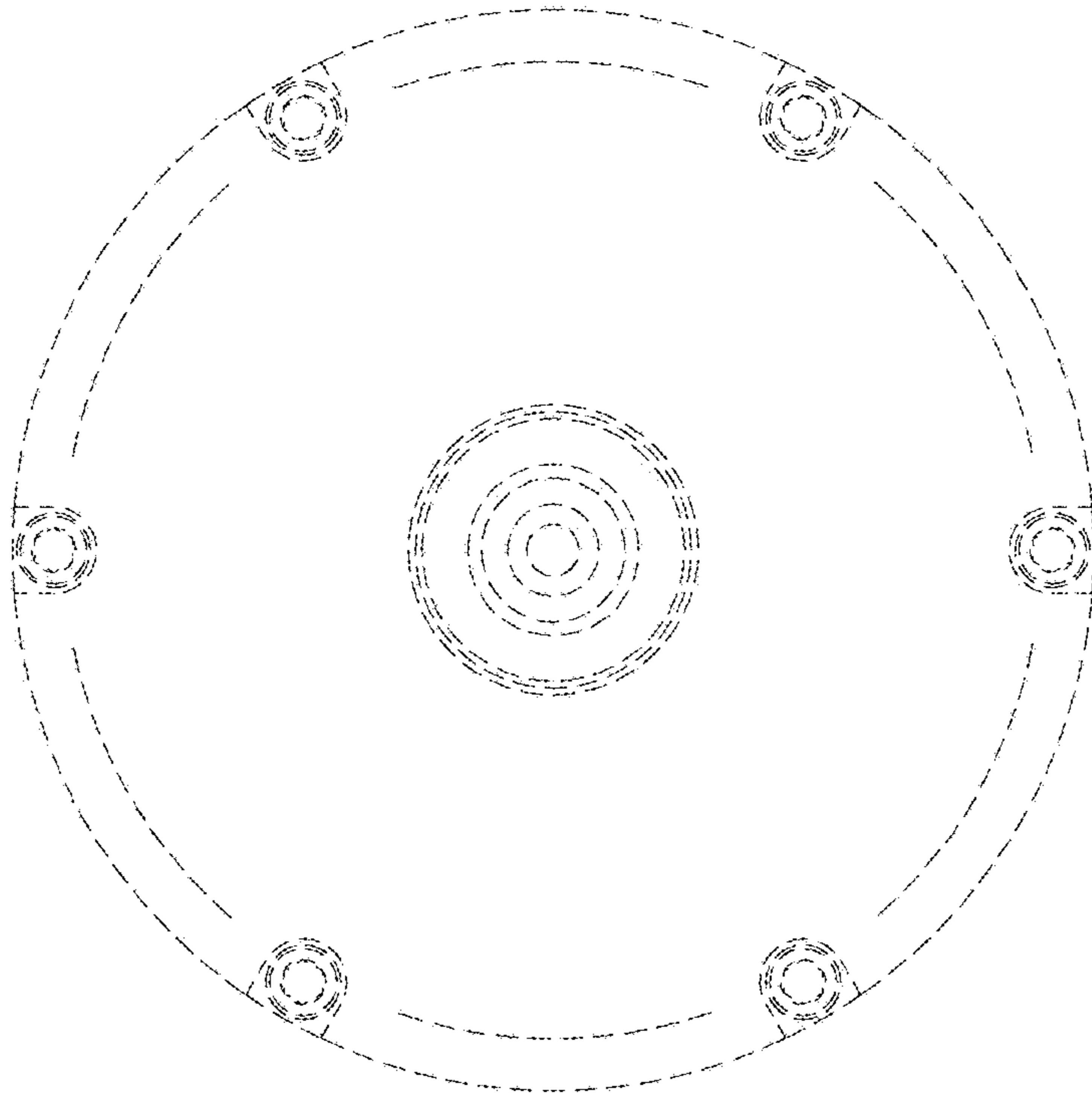

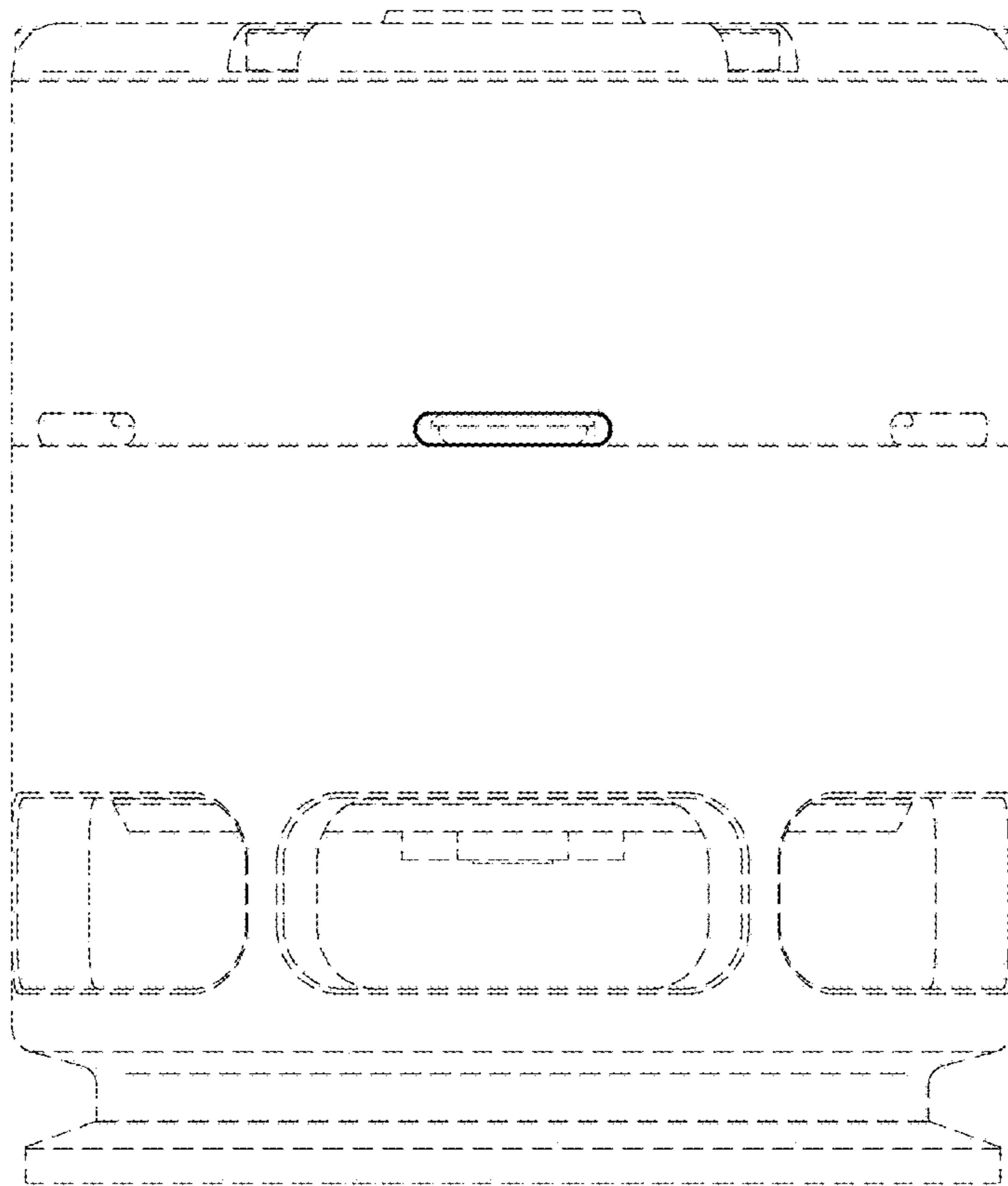

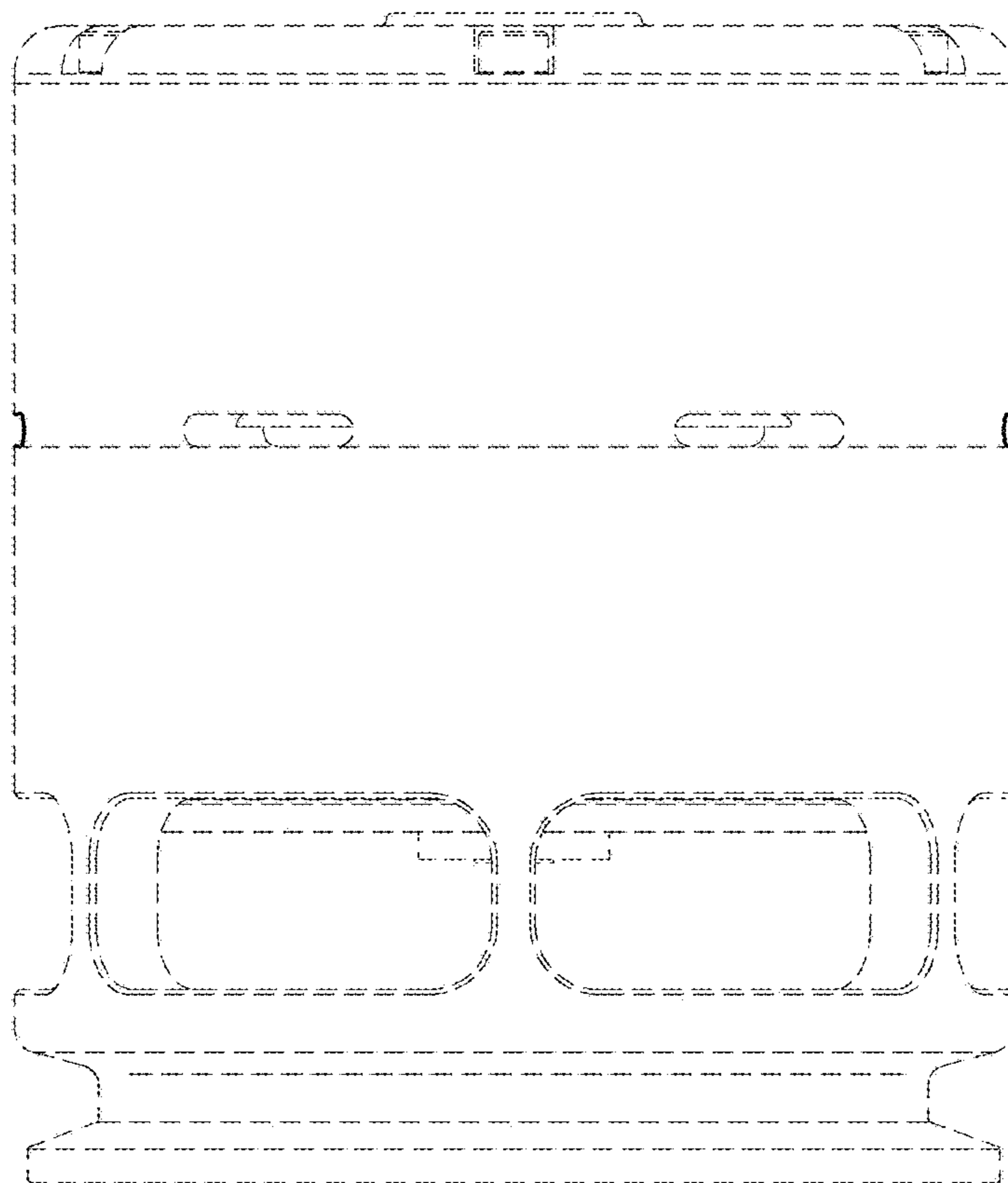

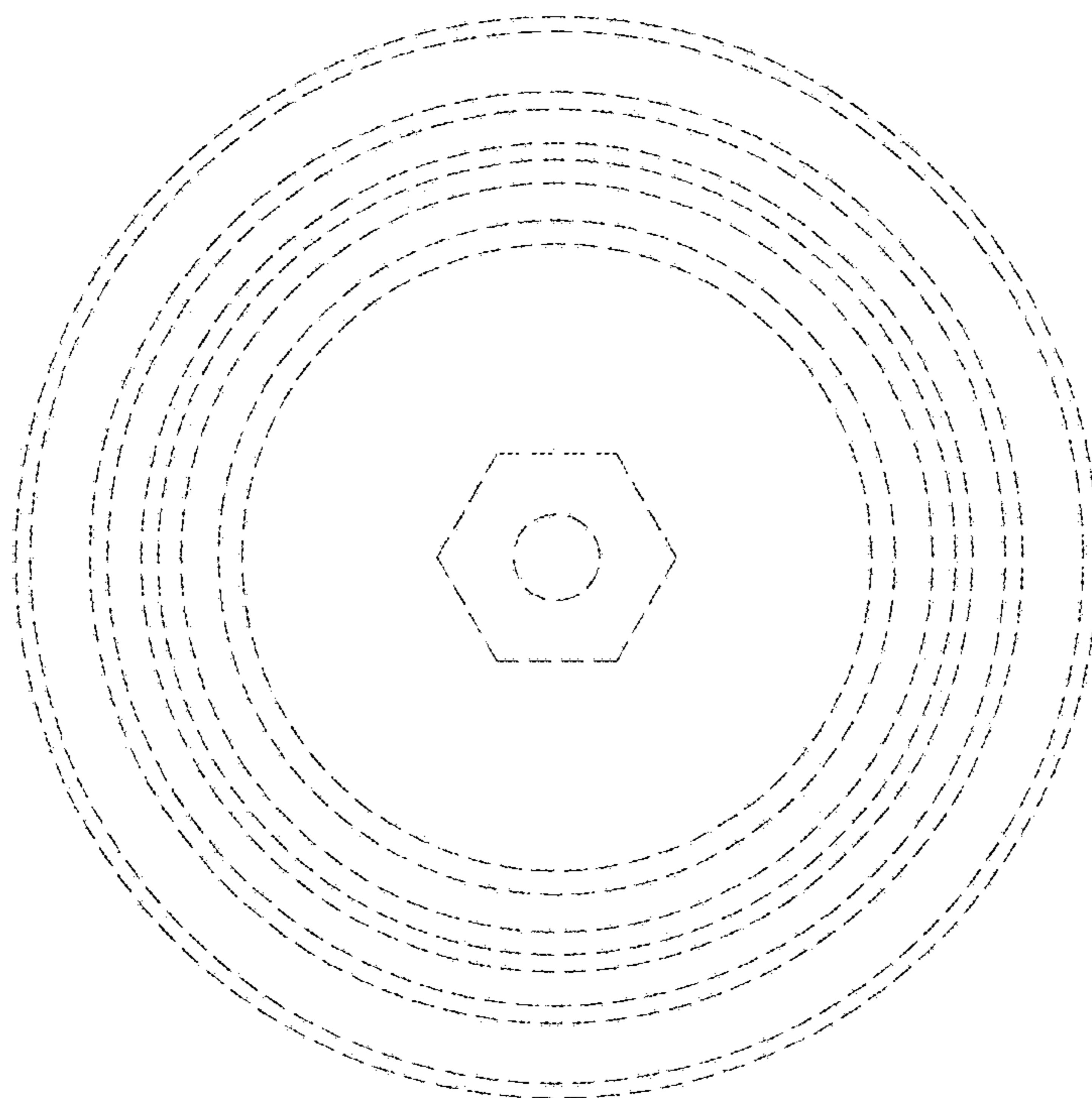
