We claim the ornamental design for a liquid chilling capsule, as shown and described.

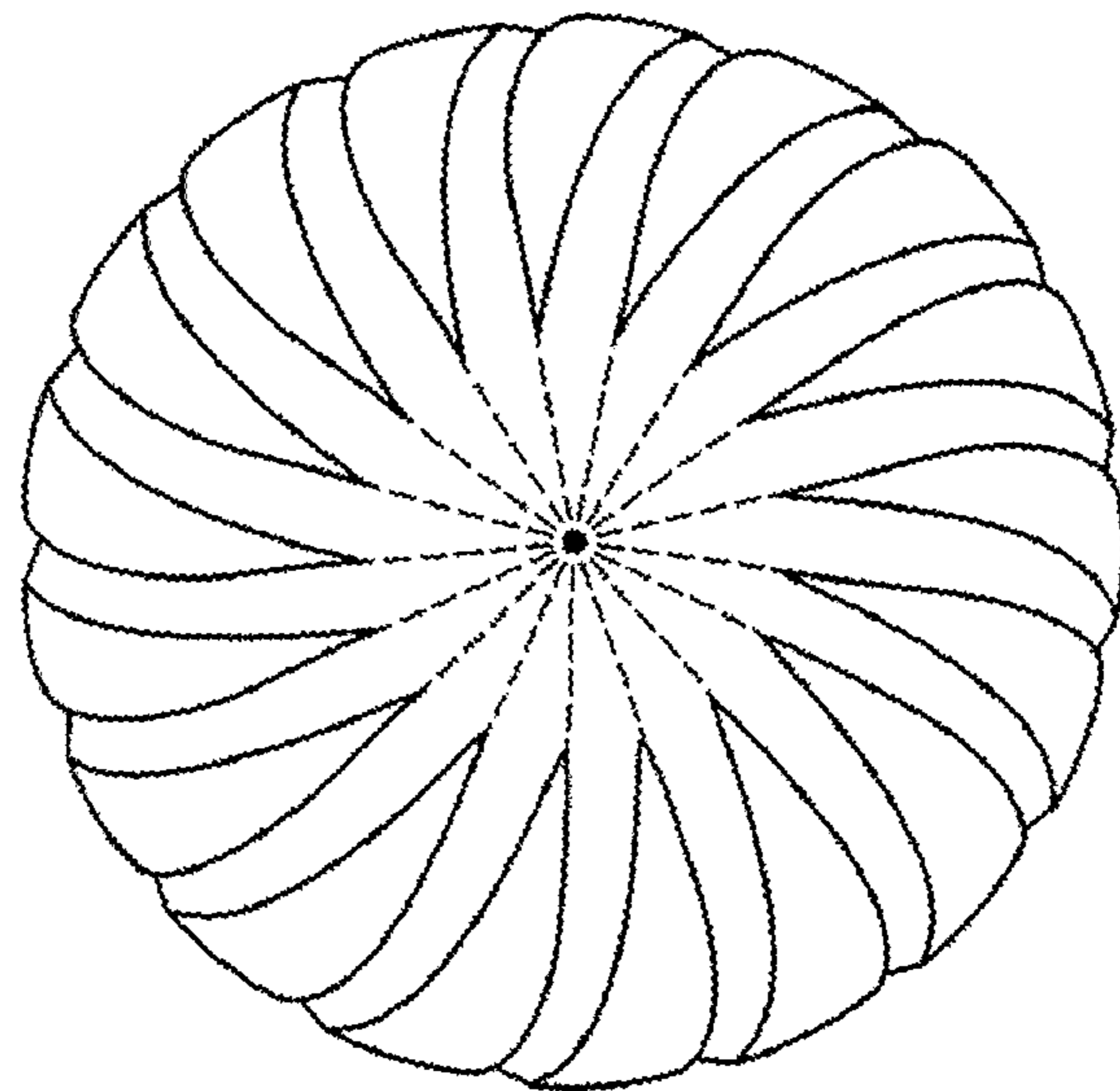
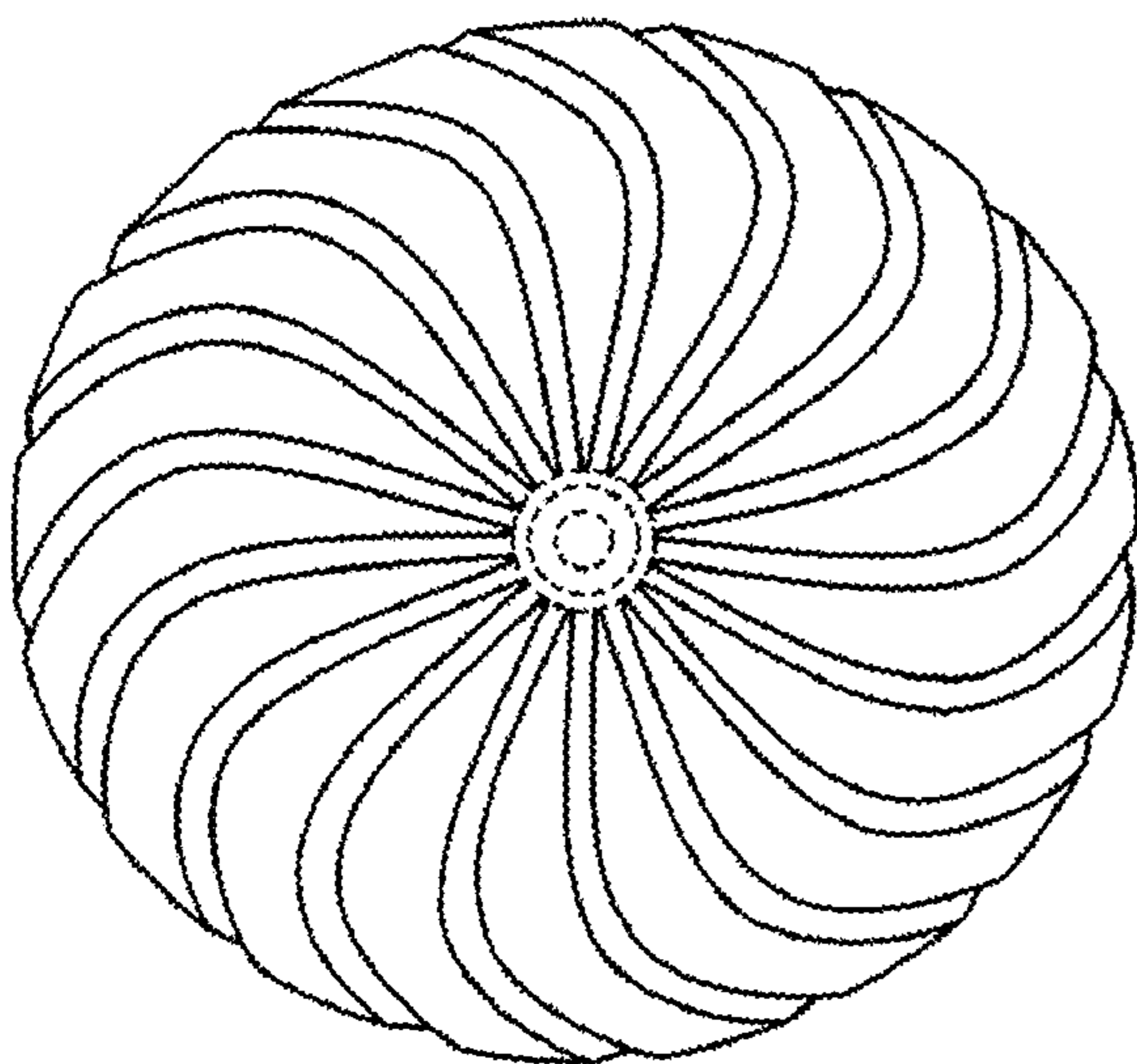

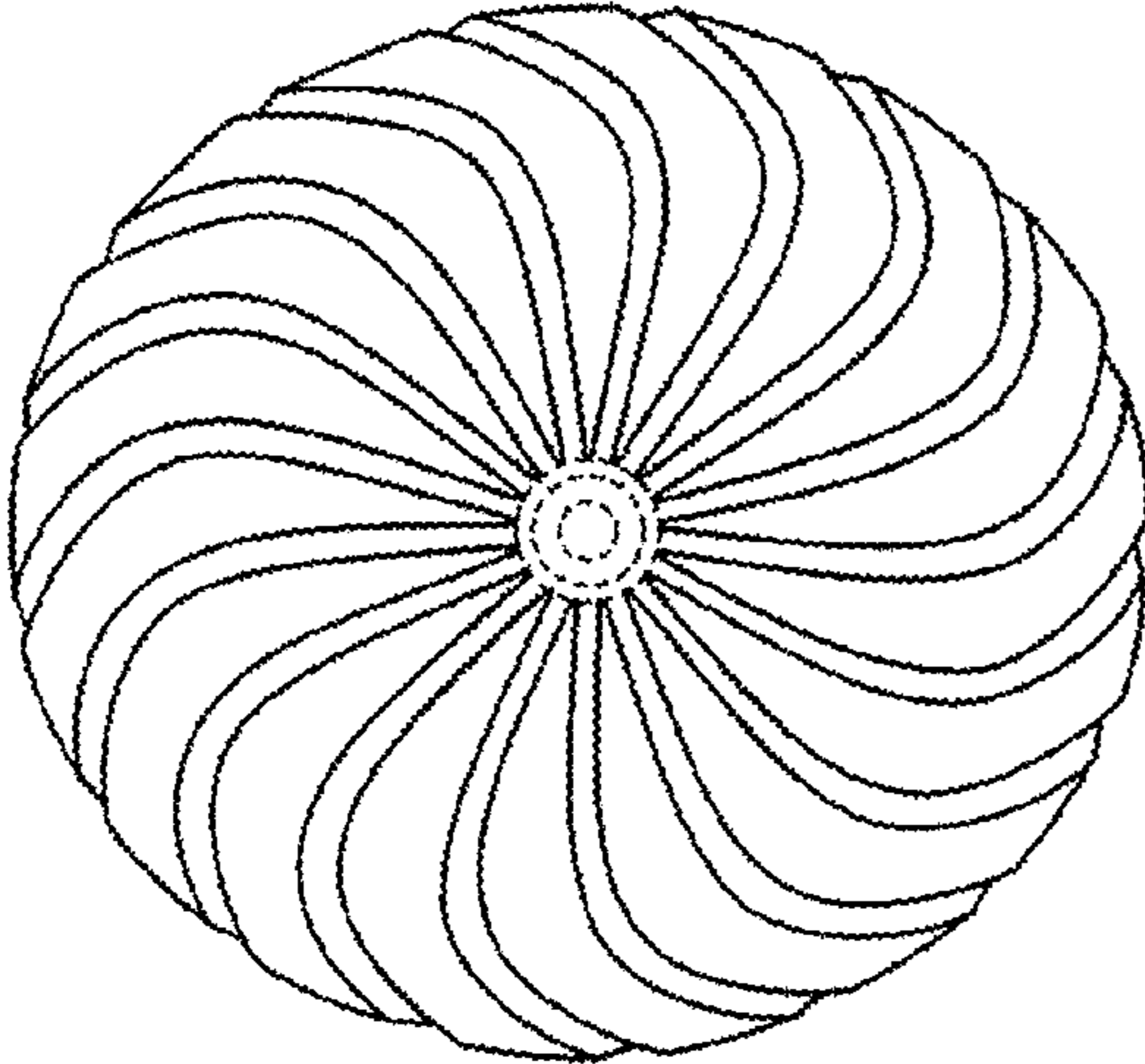

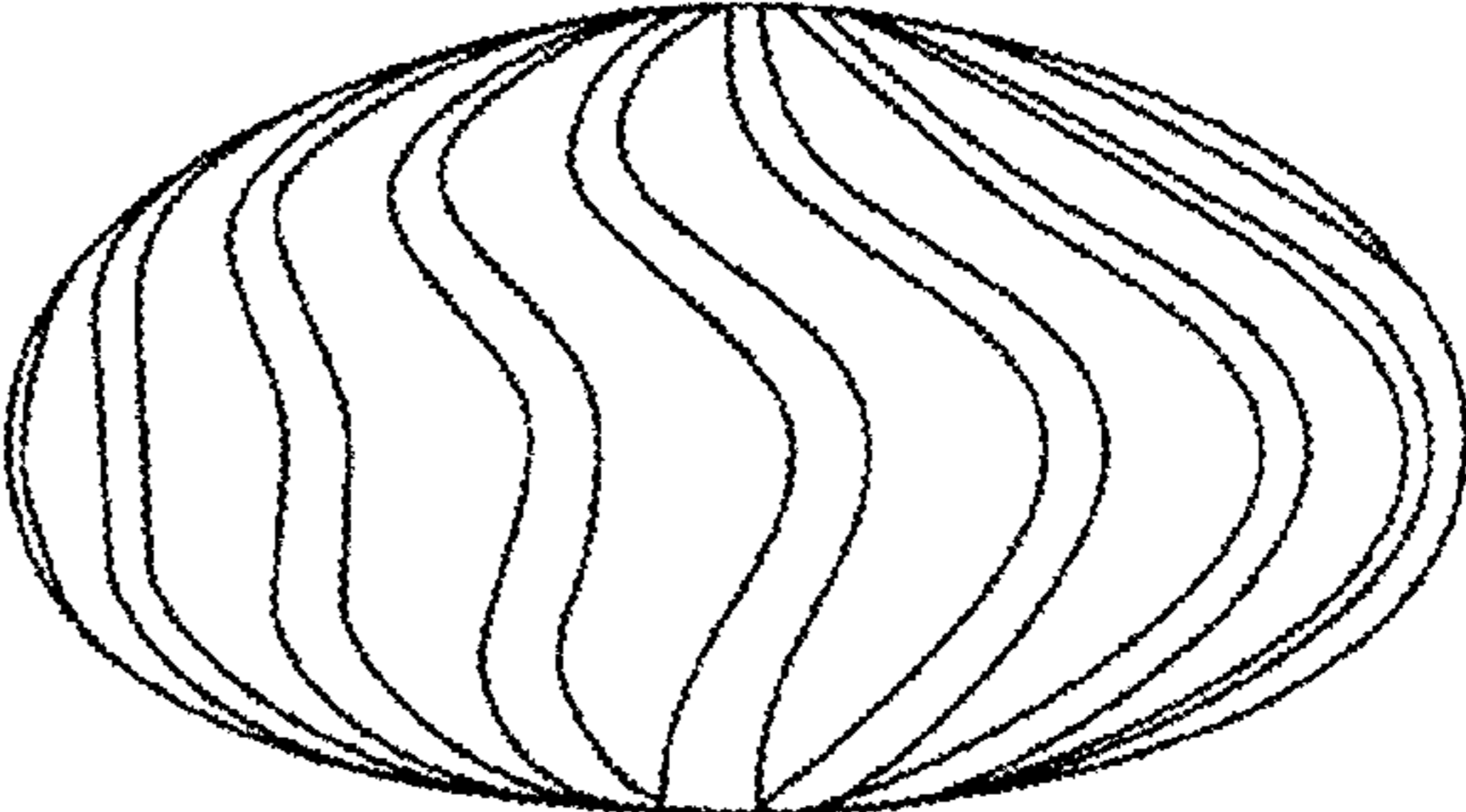

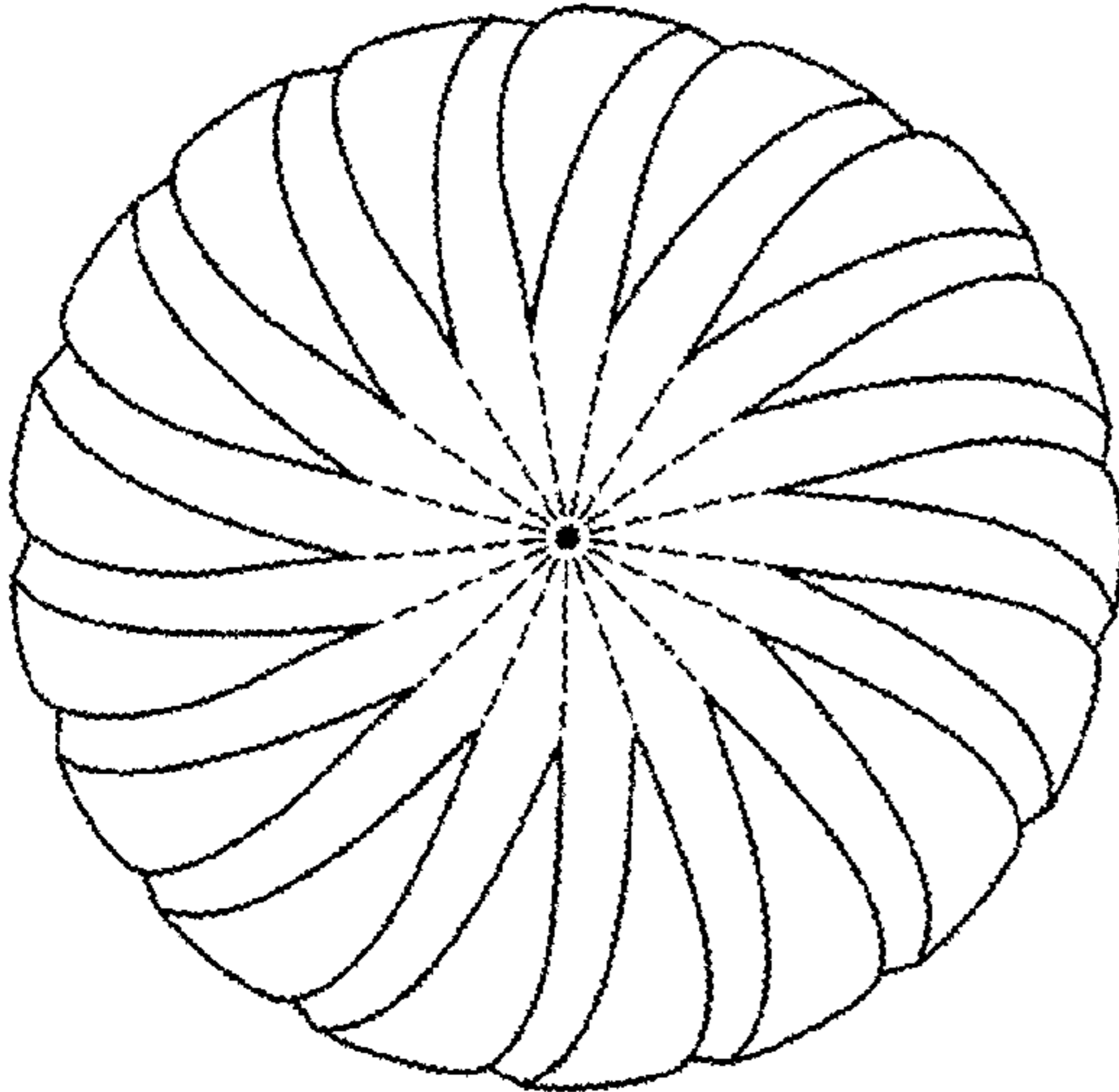
