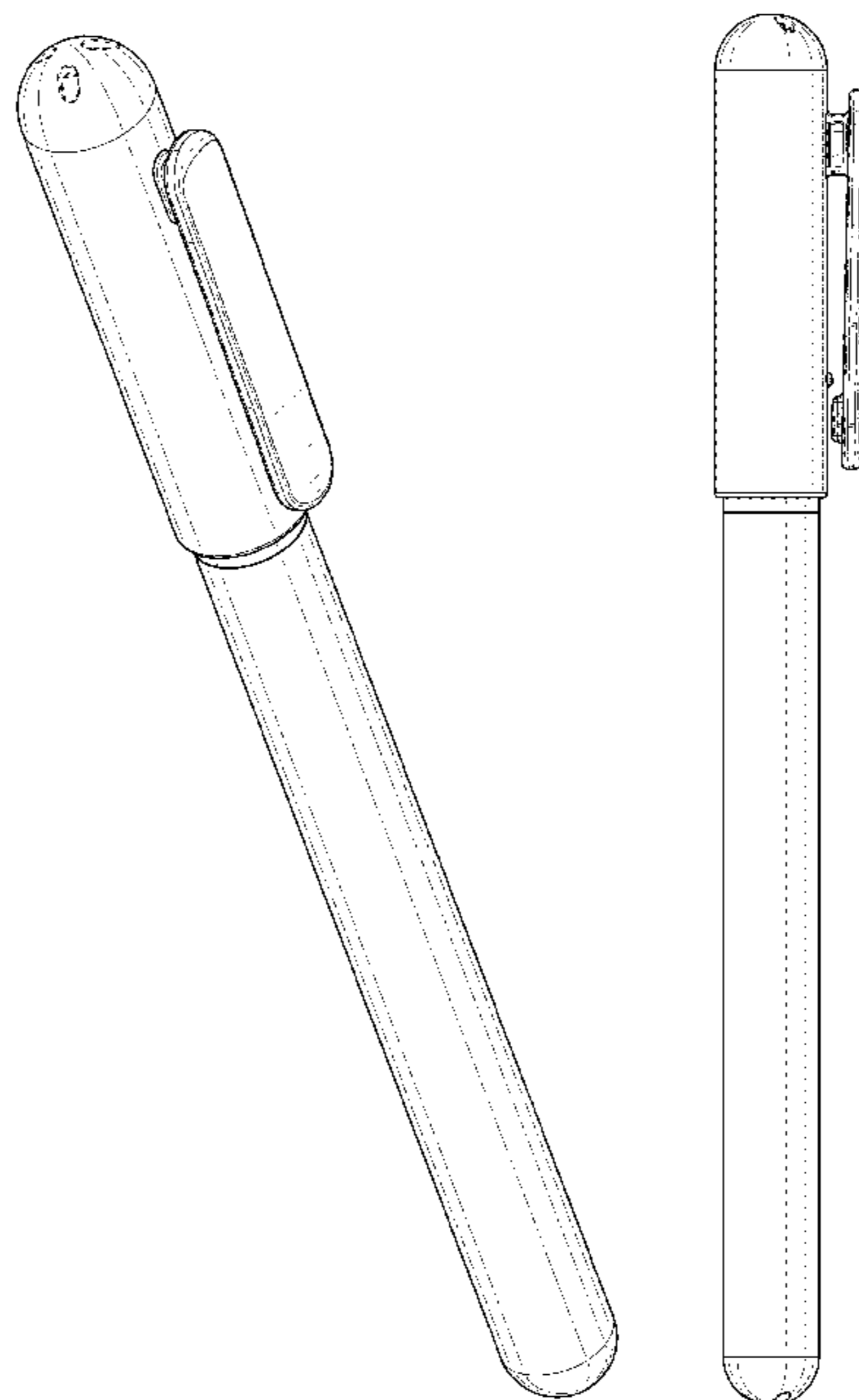
(57) **CLAIM**

DESCRIPTION

FIG. 1 is a perspective view of a writing instrument showing a new design;

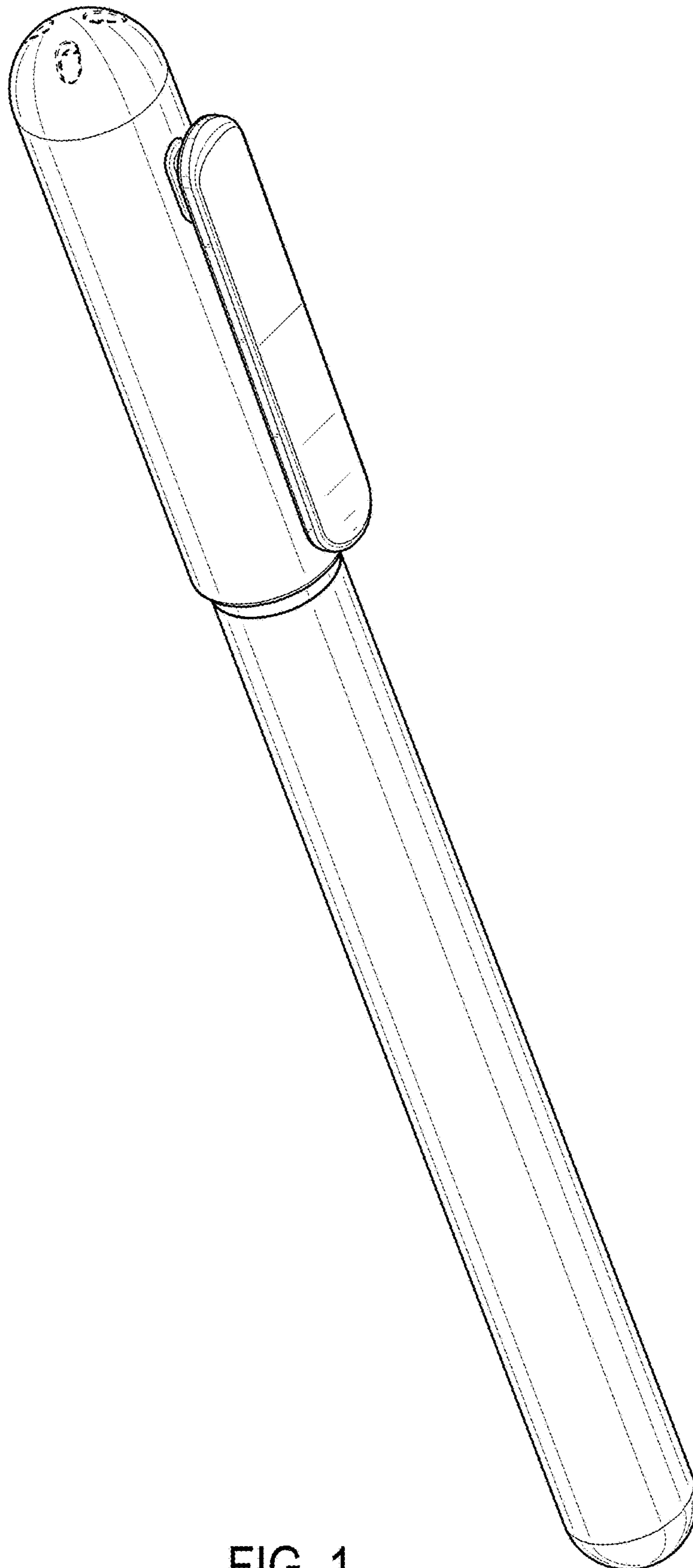

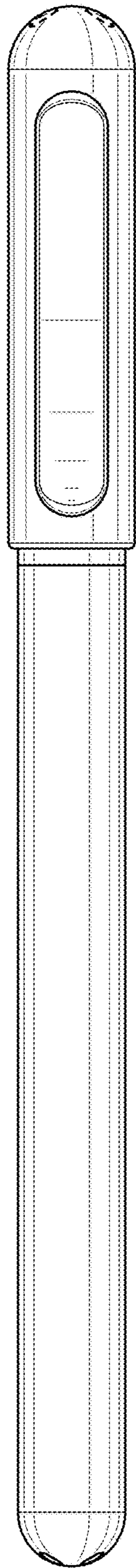

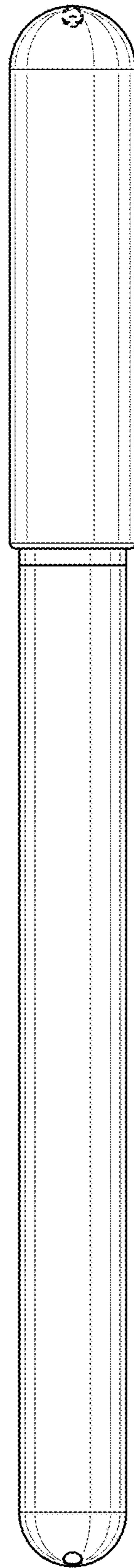

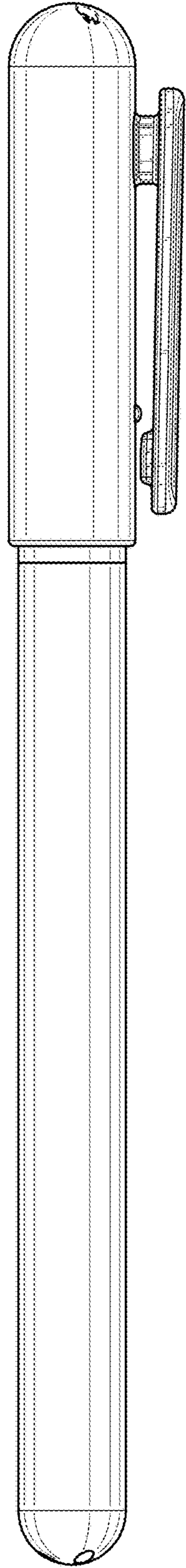

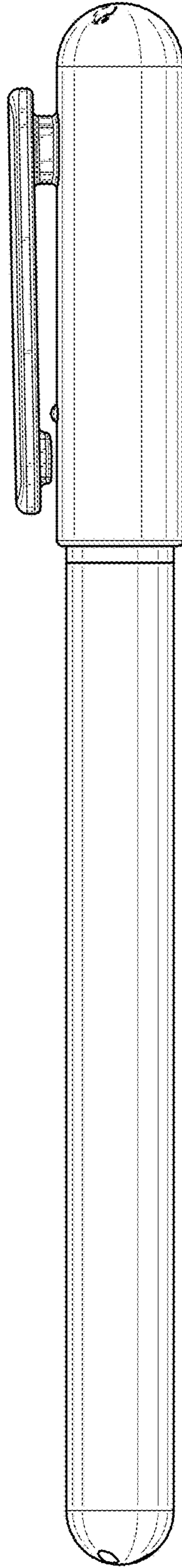

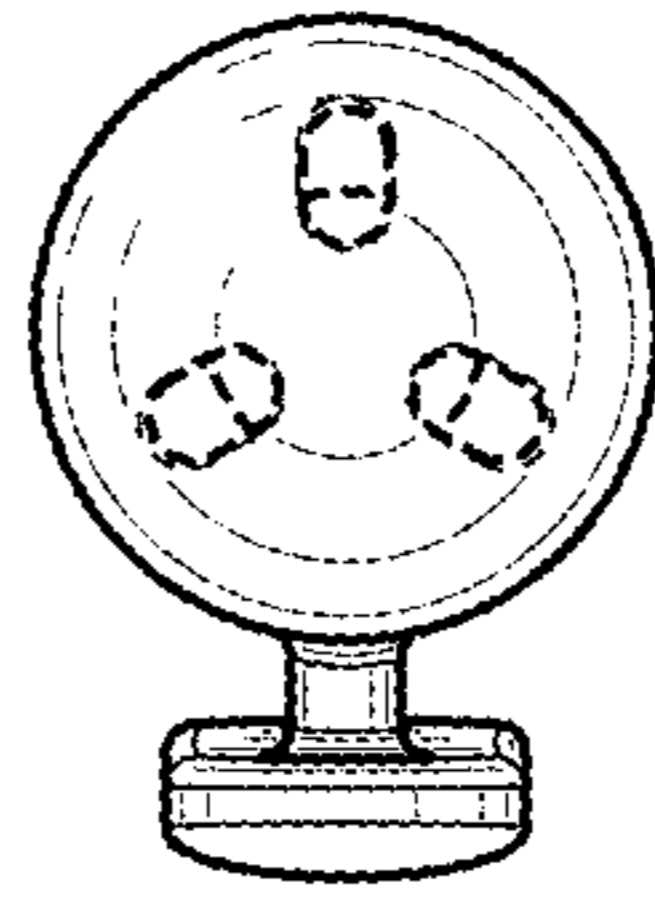

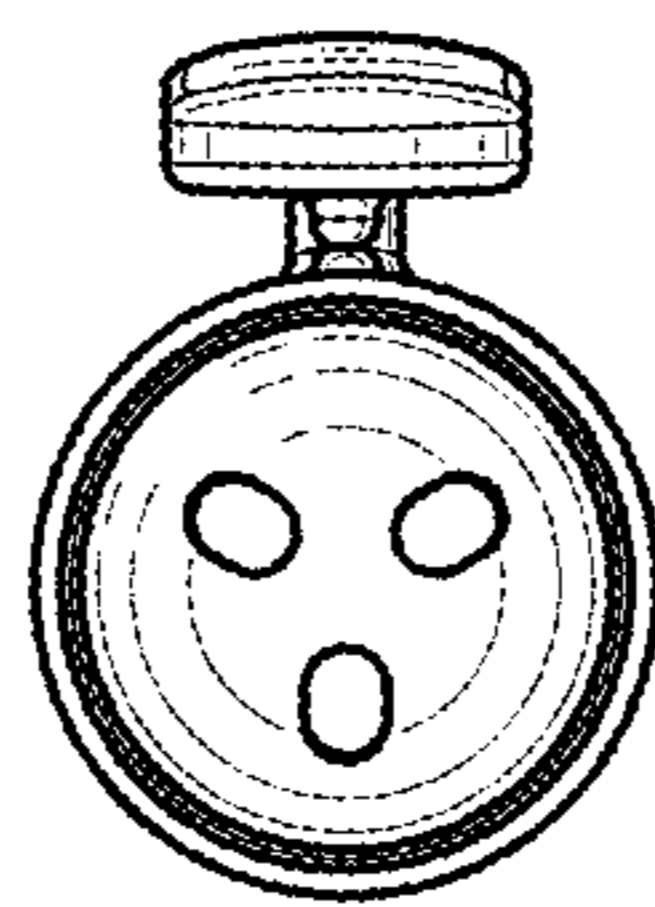
