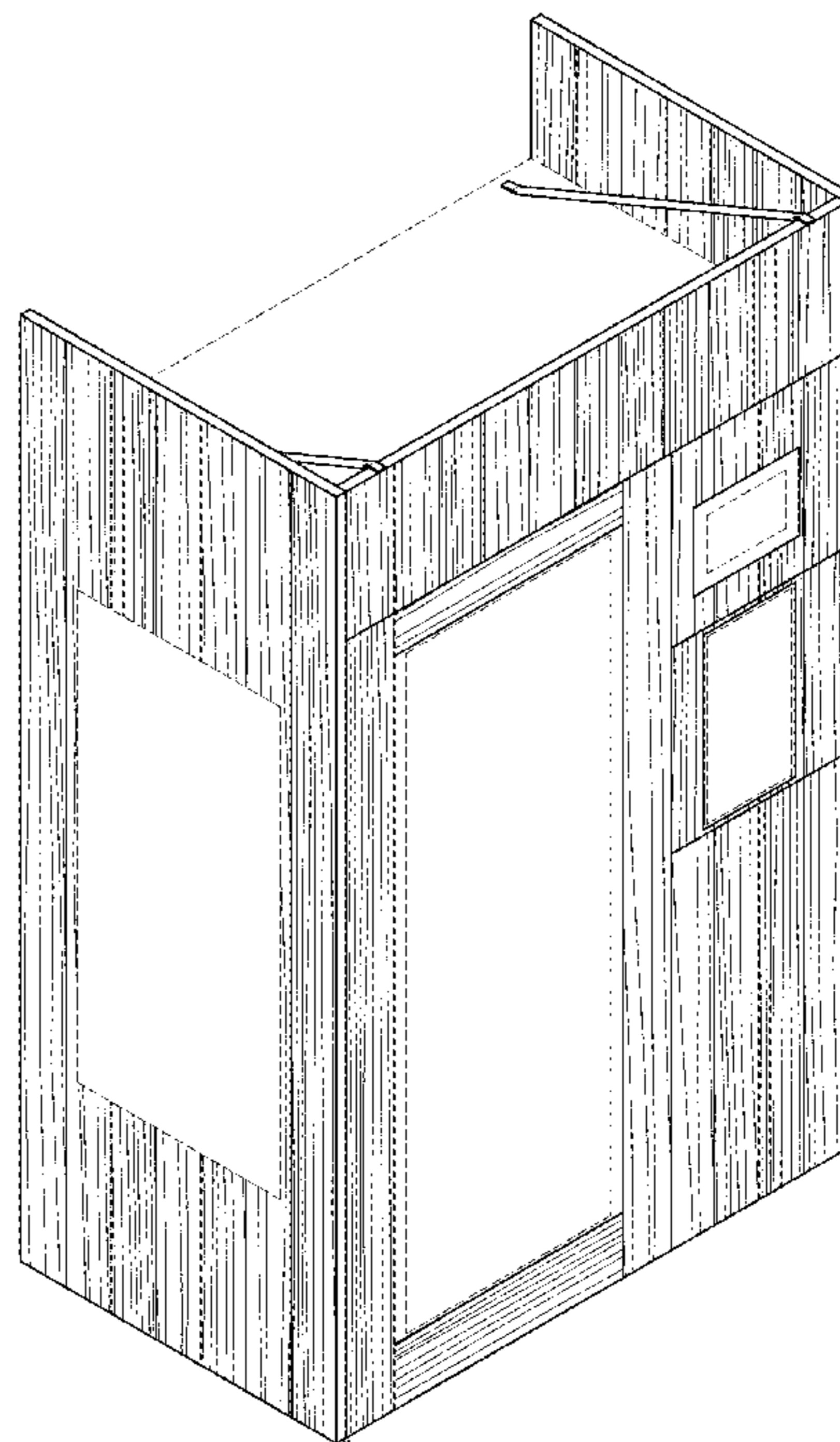
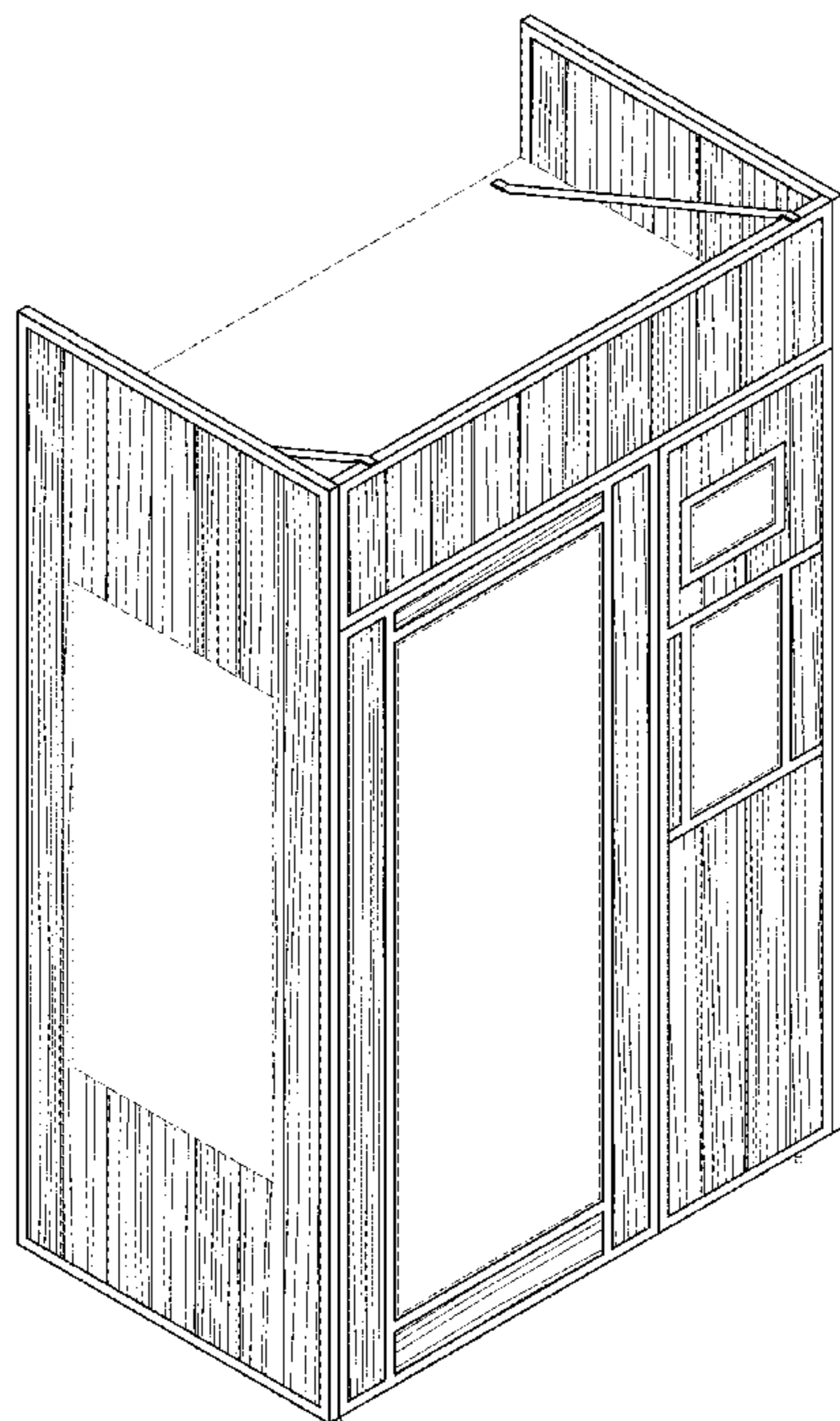
The ornamental design for a vending machine facade, shown and described.

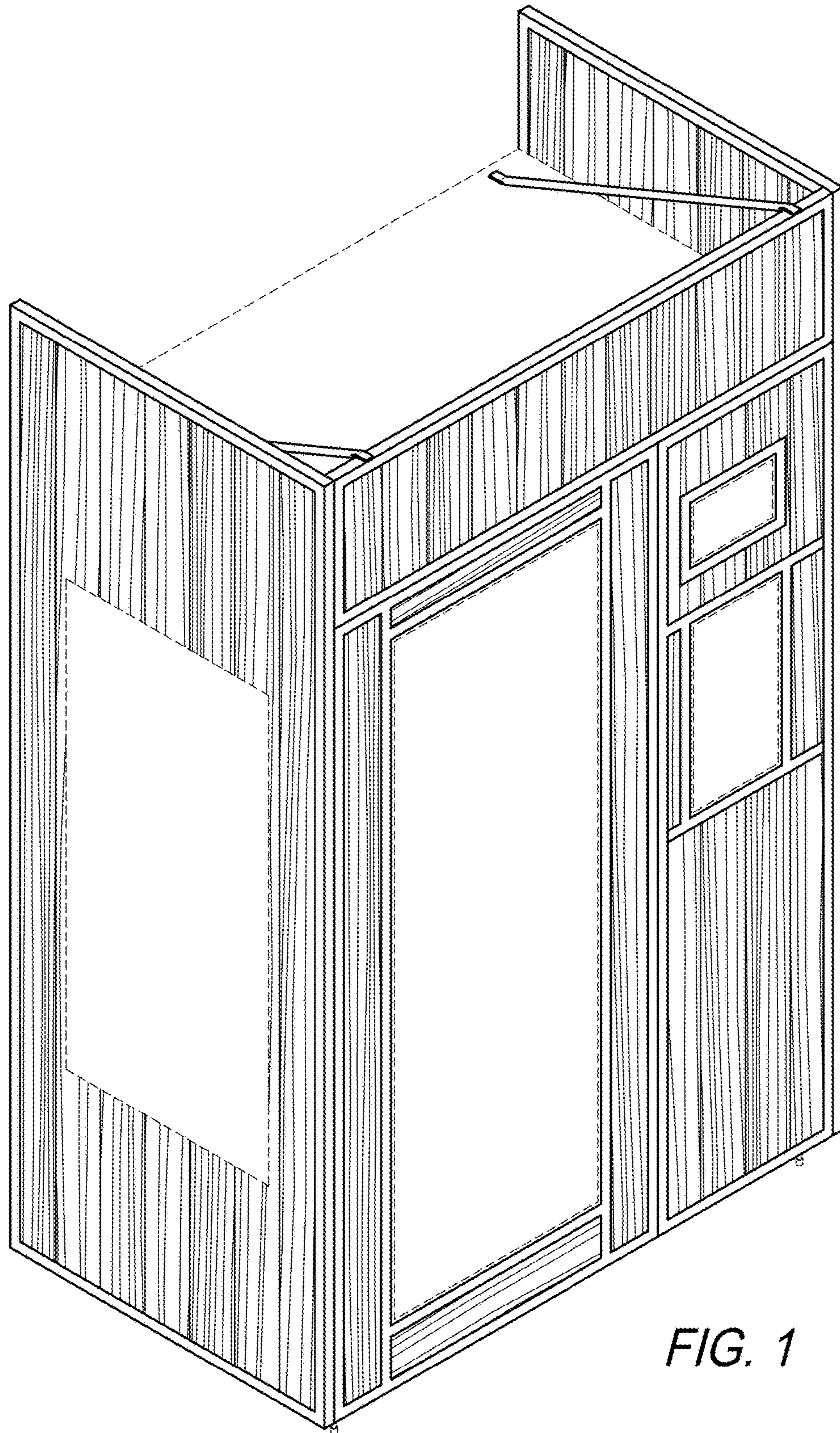

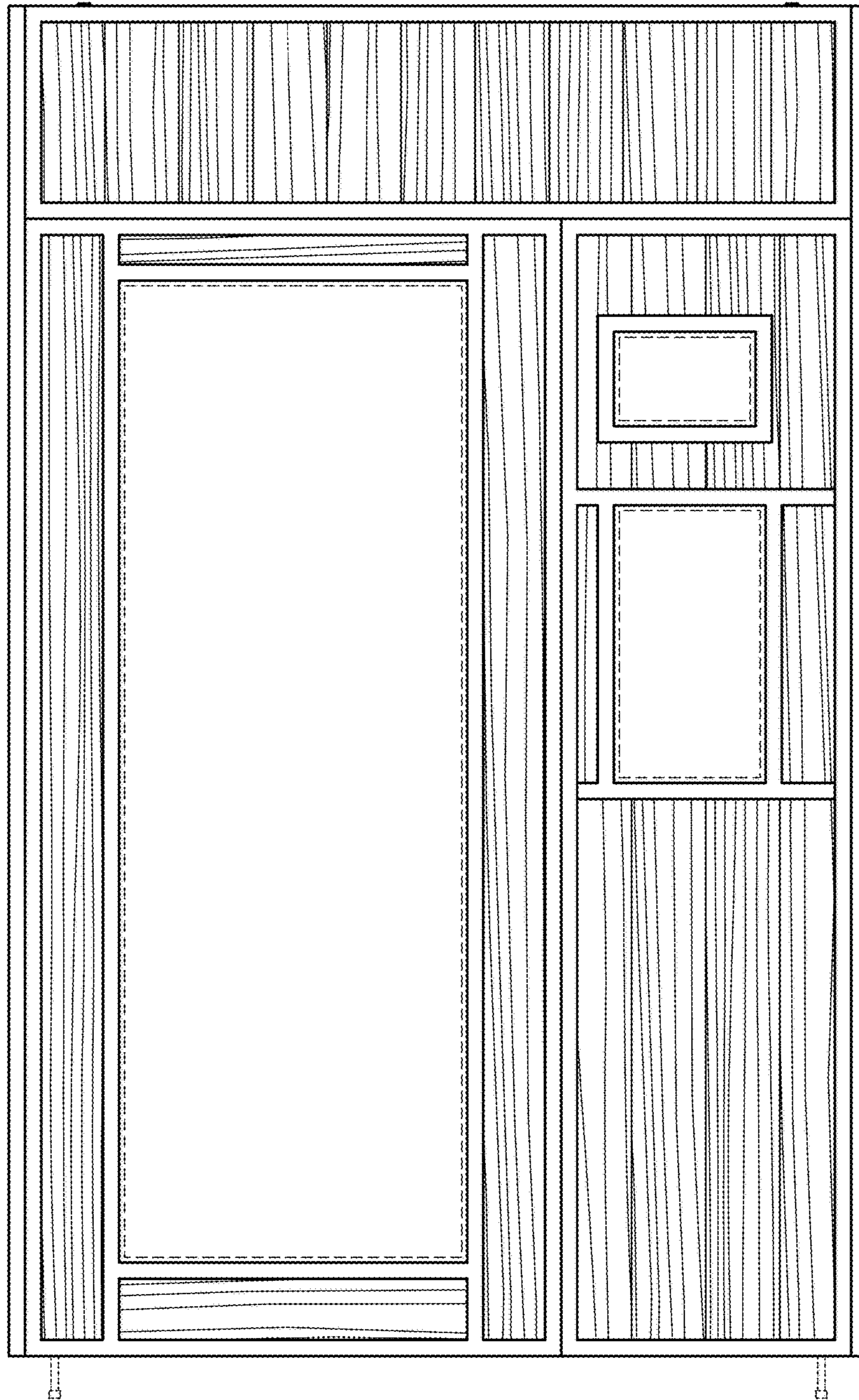

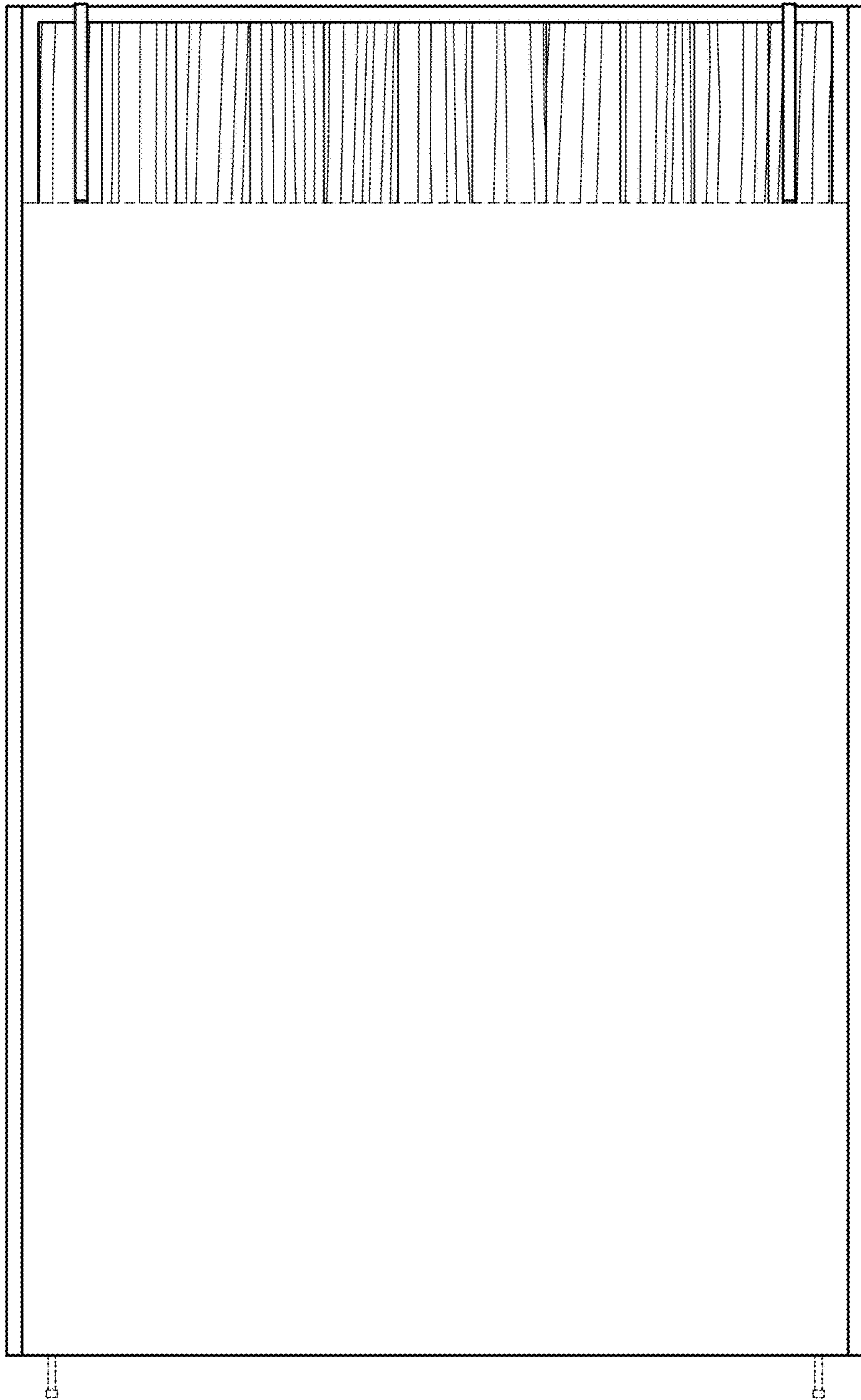

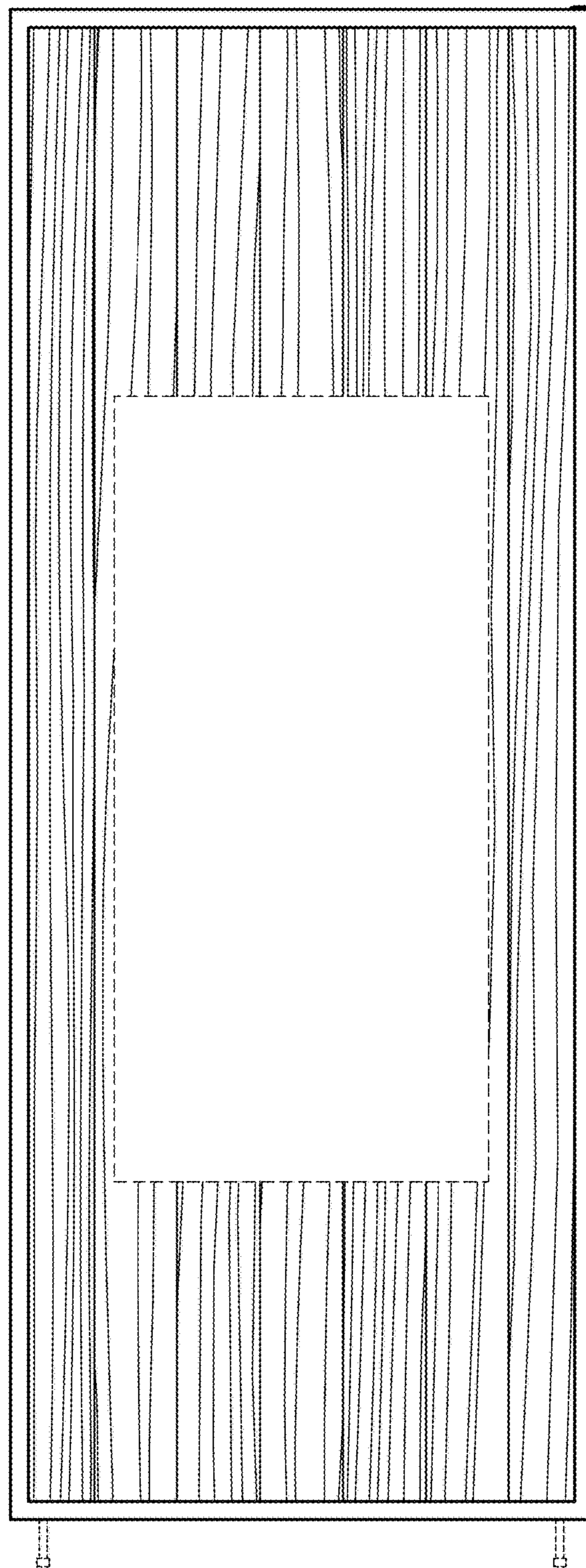

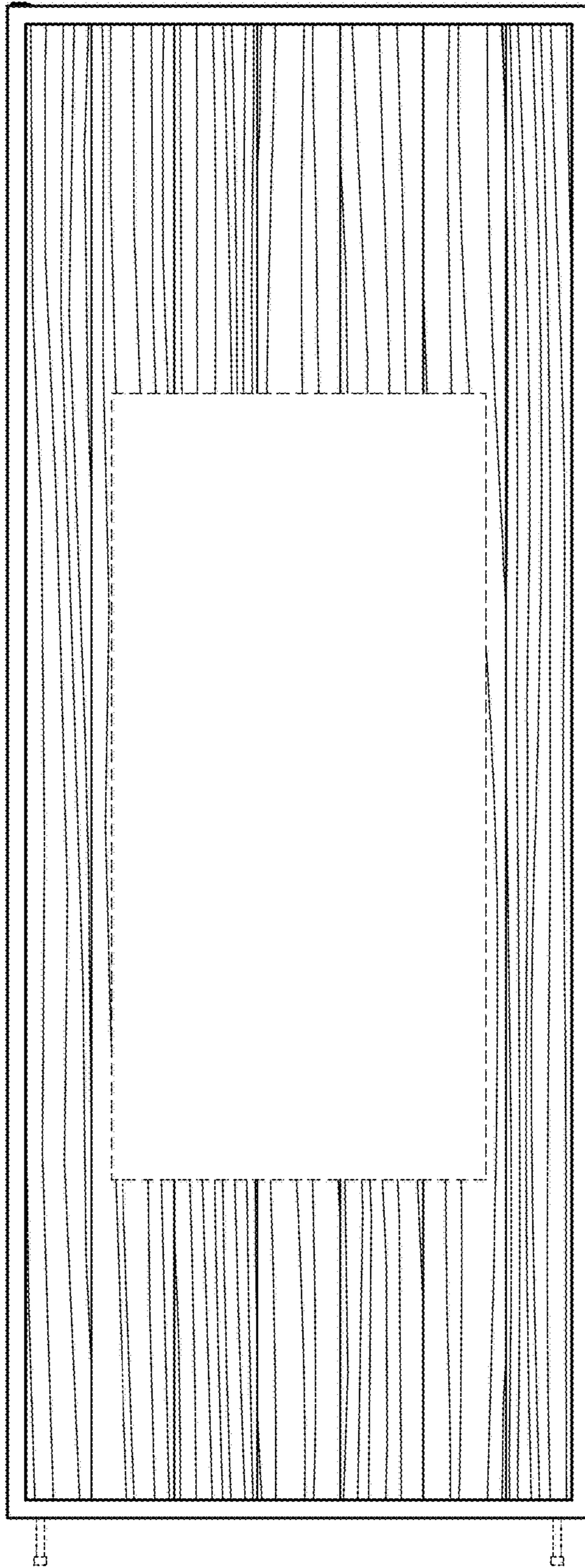

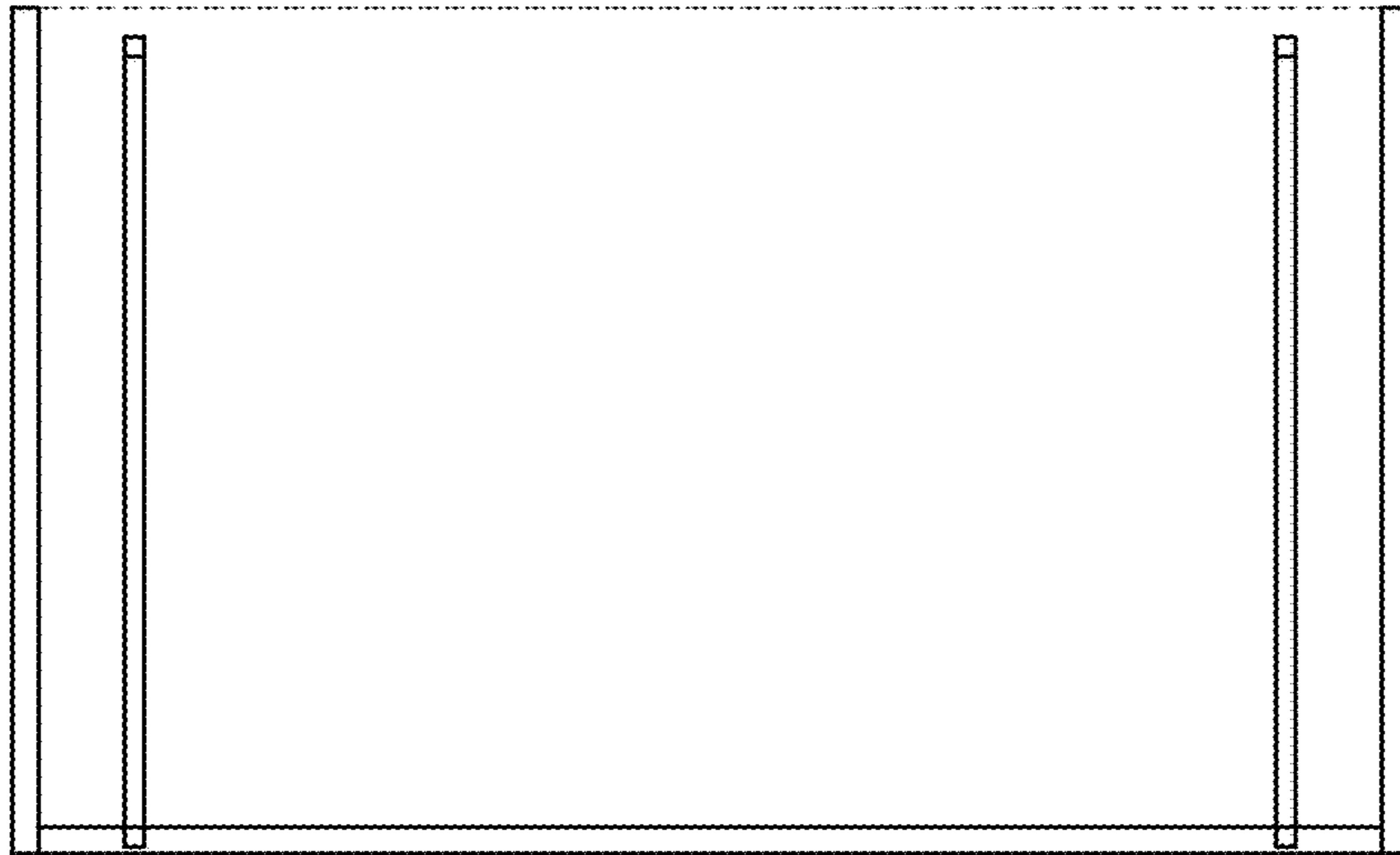

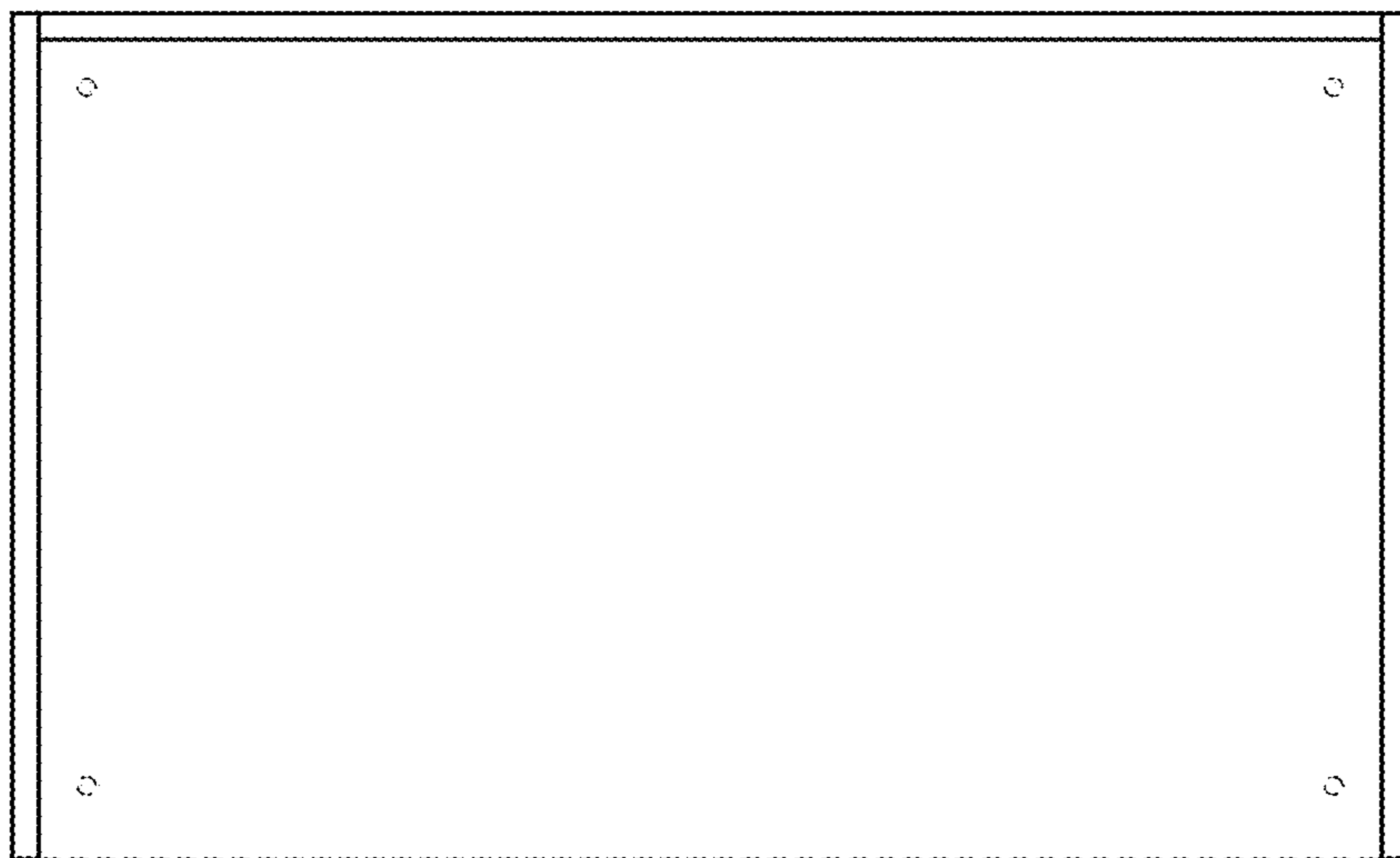

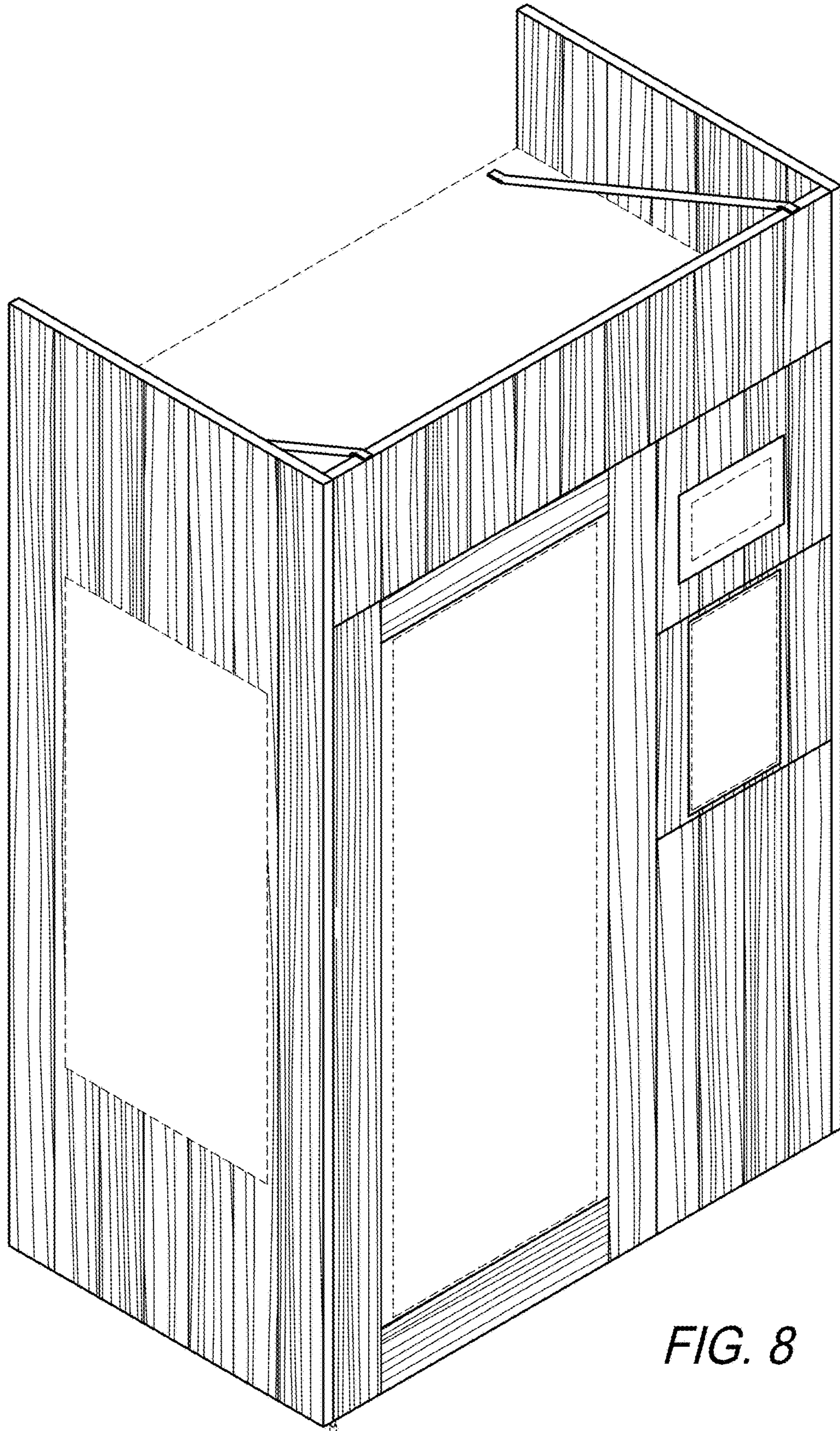

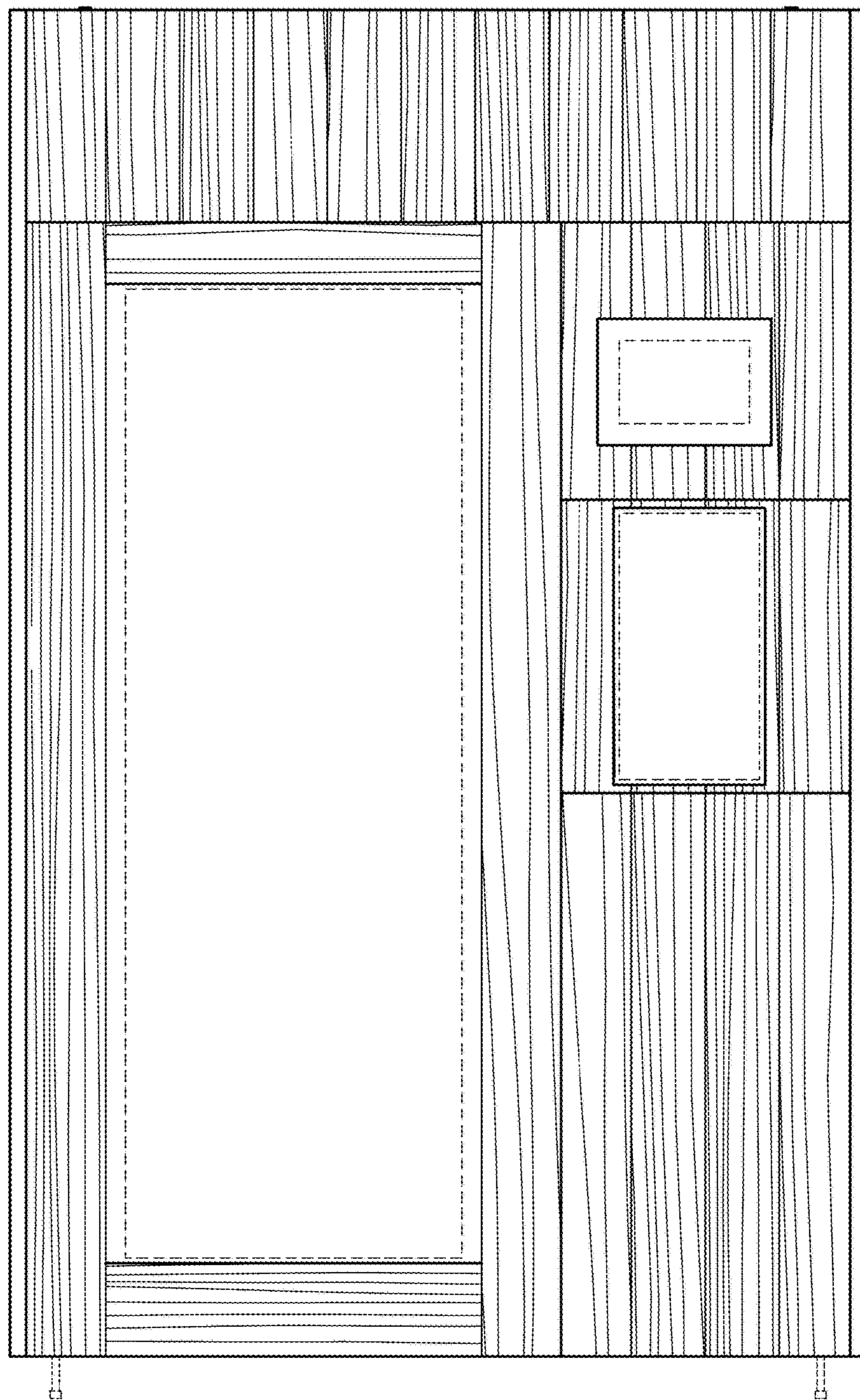

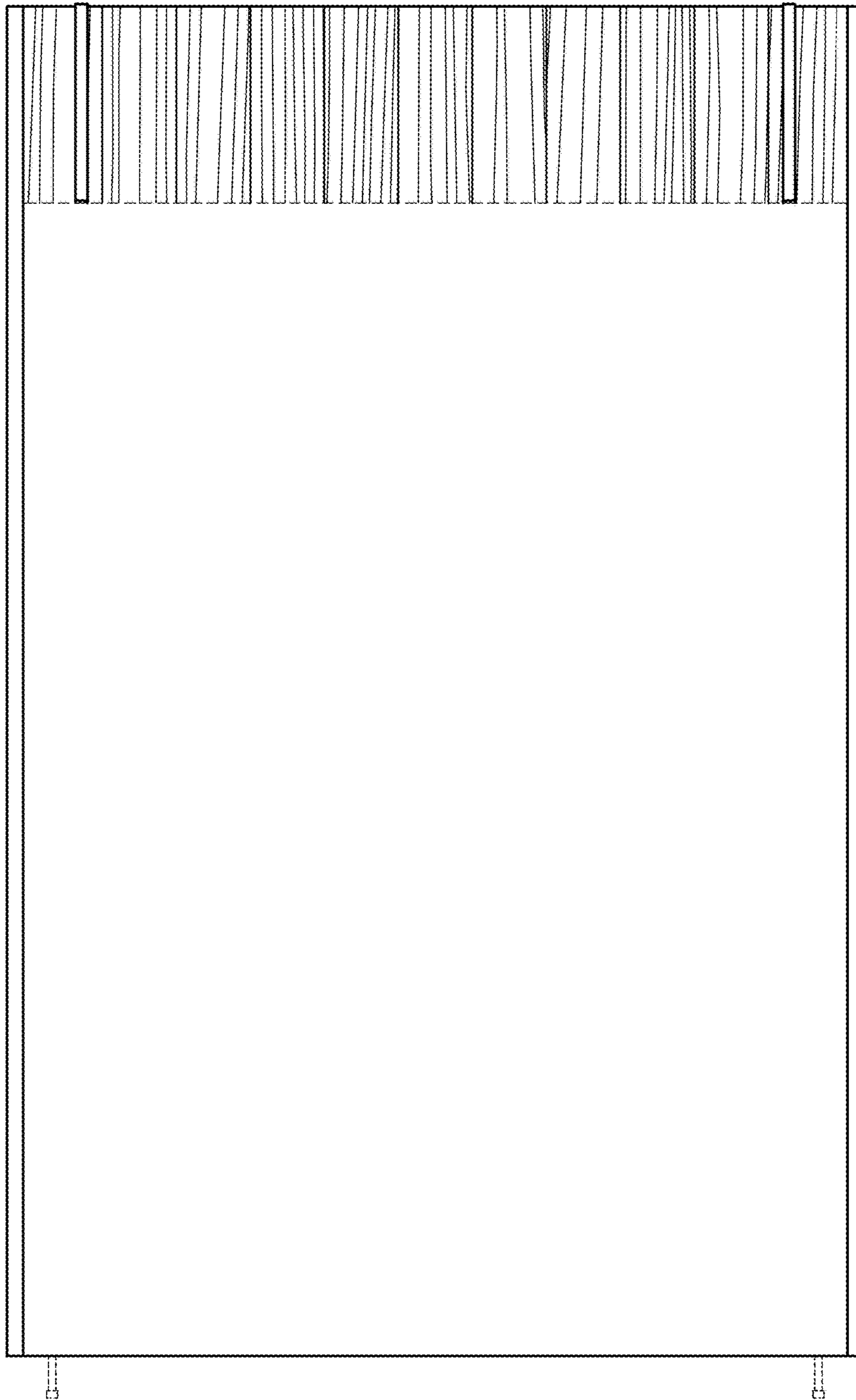

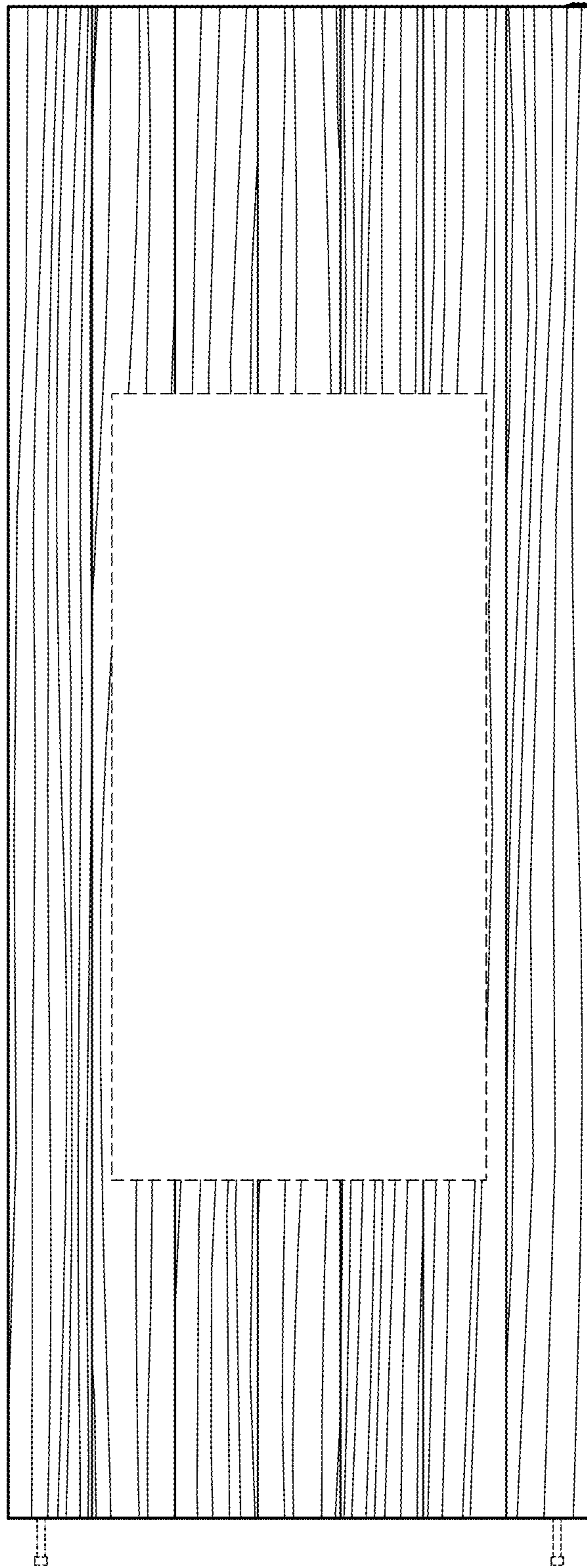

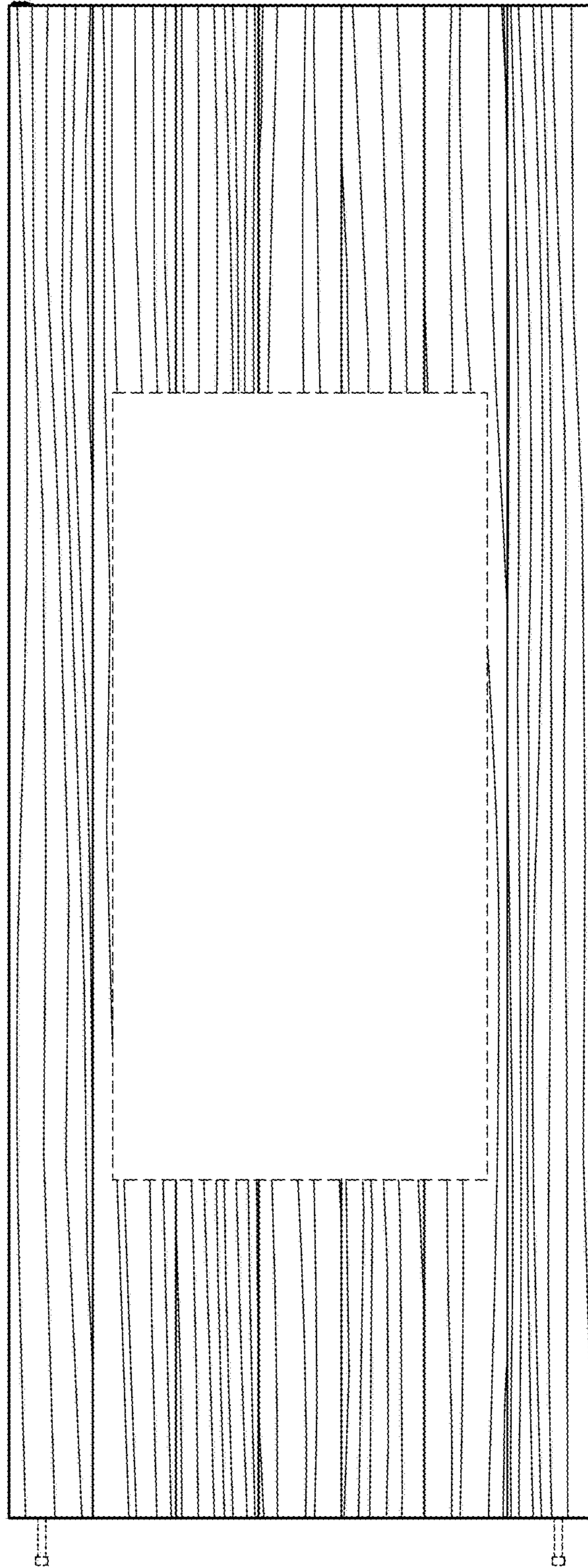

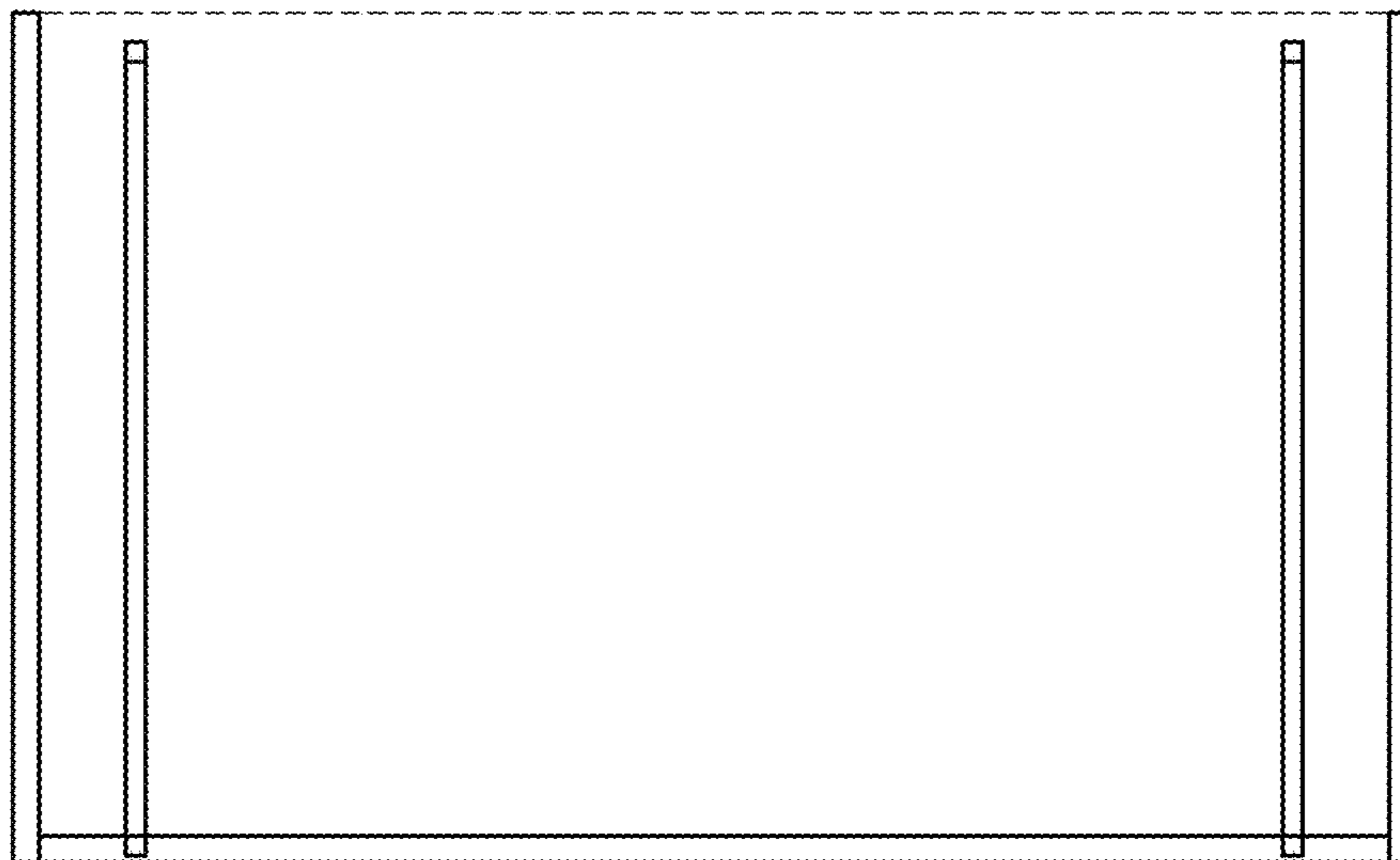

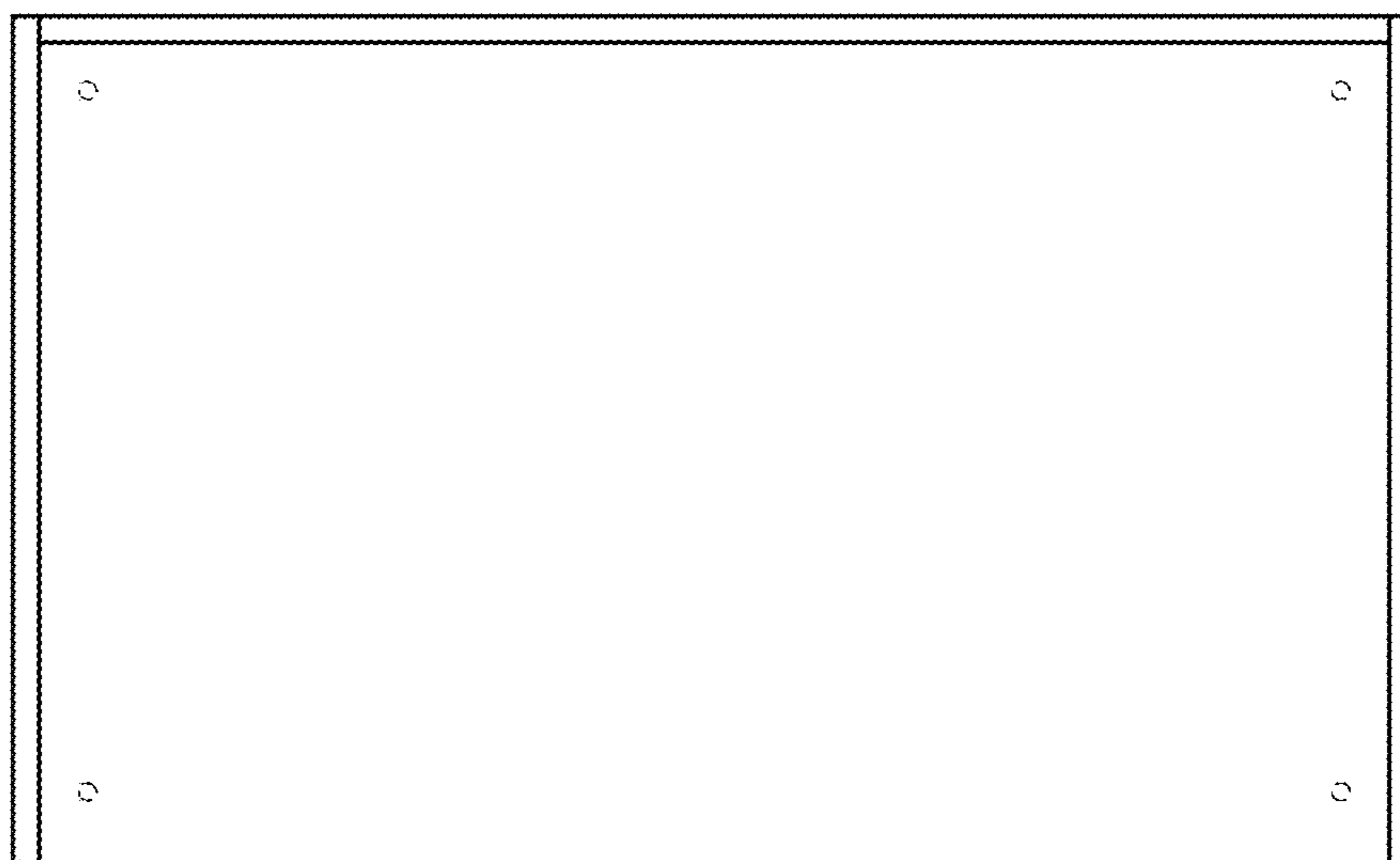
