DESCRIPTION

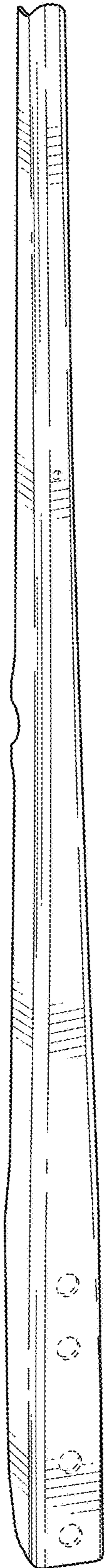

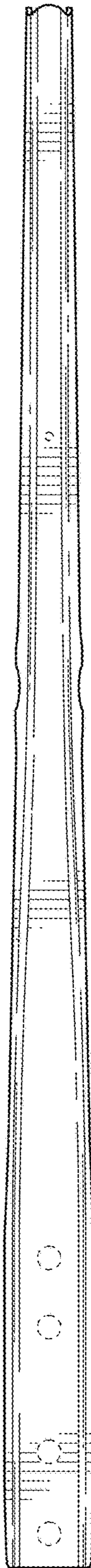

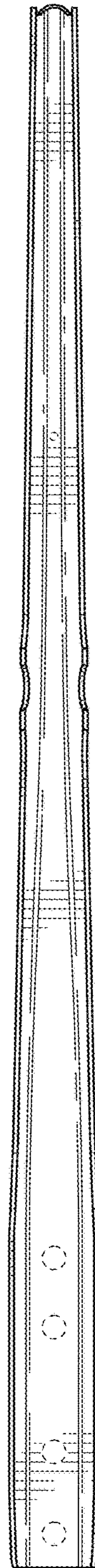

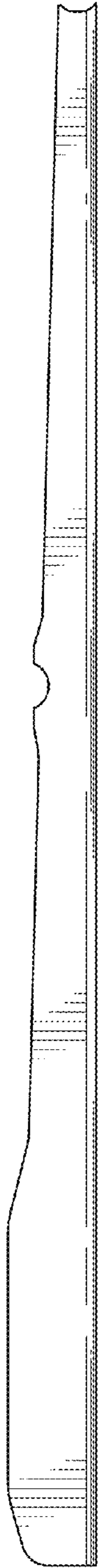

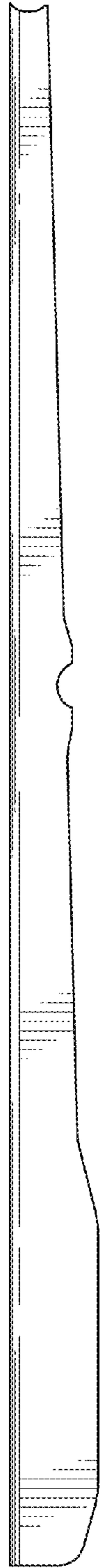

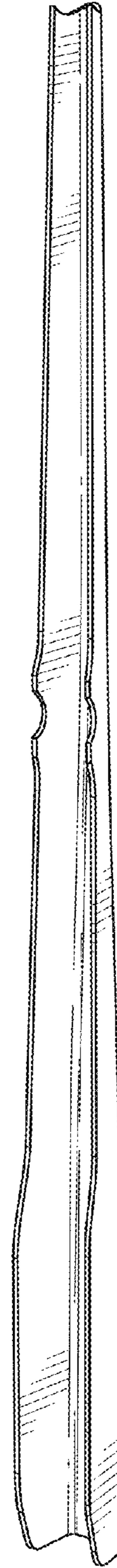

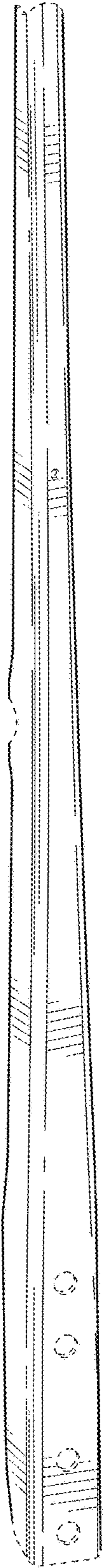

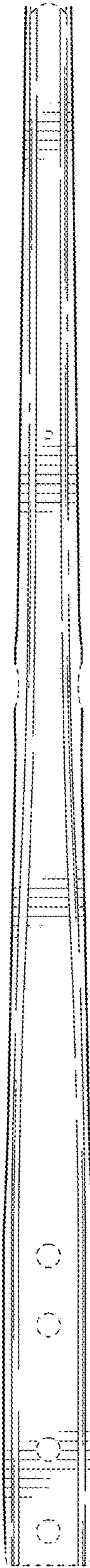

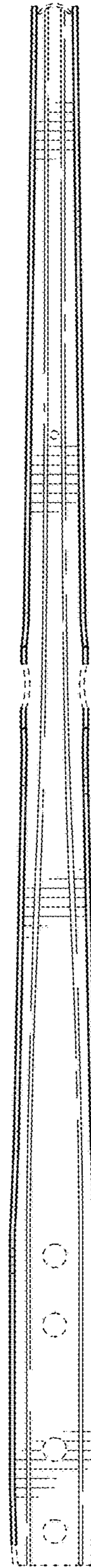

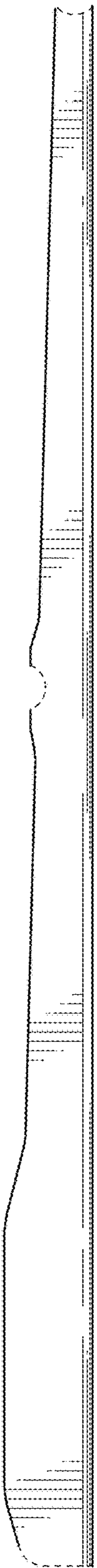

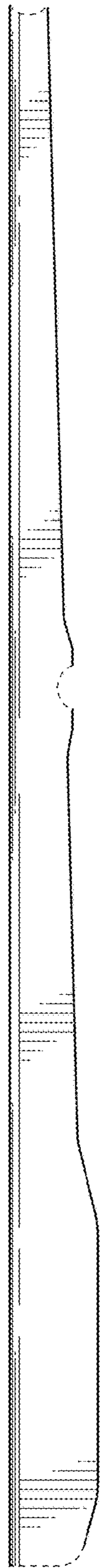

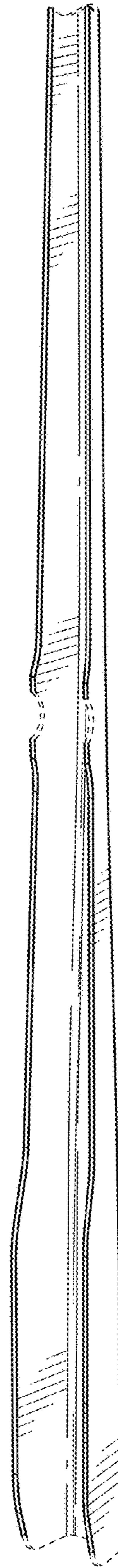
