DESCRIPTION

FIG. 1 is a front view of the automobile lamp of the present invention for one side of a vehicle;

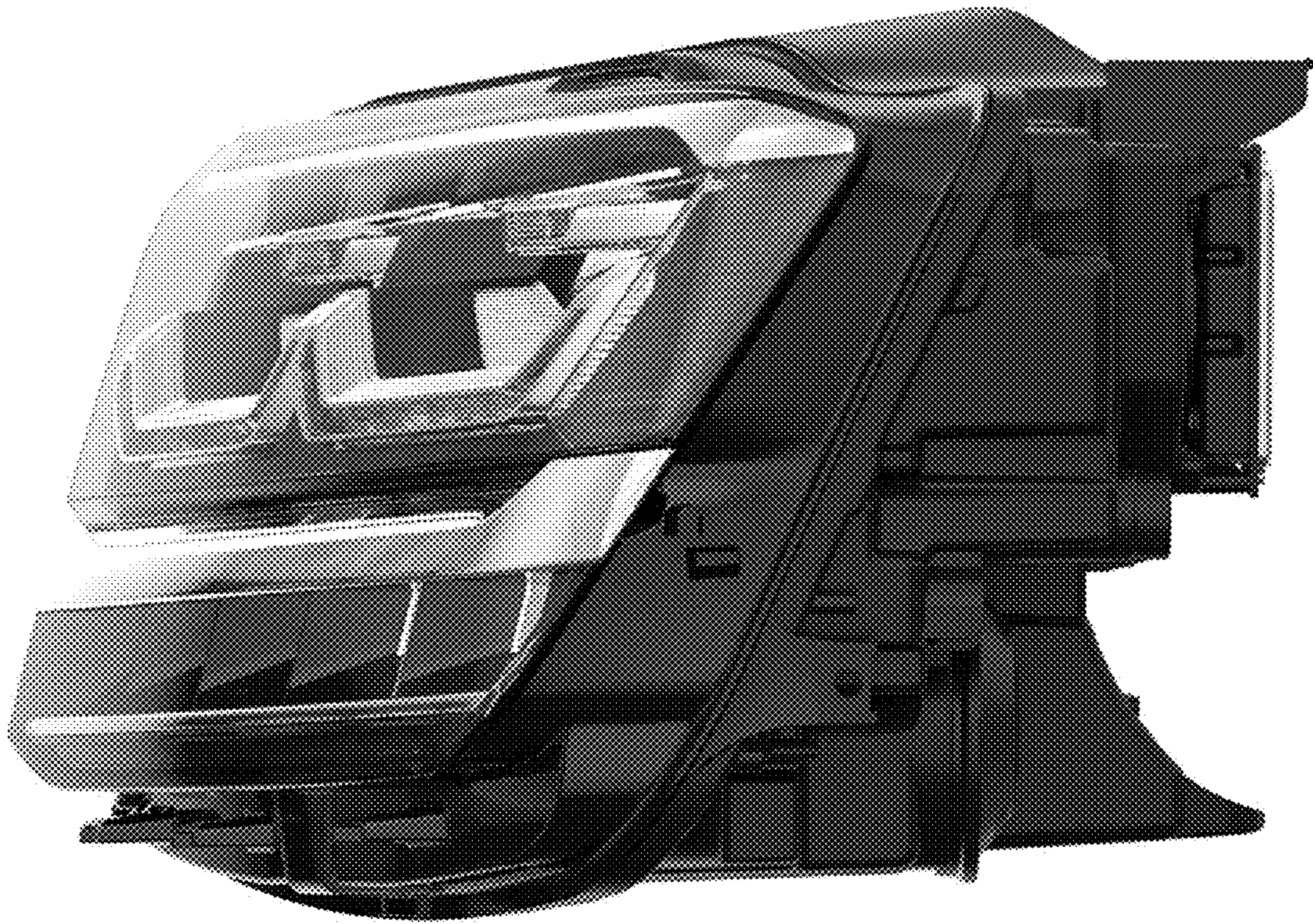

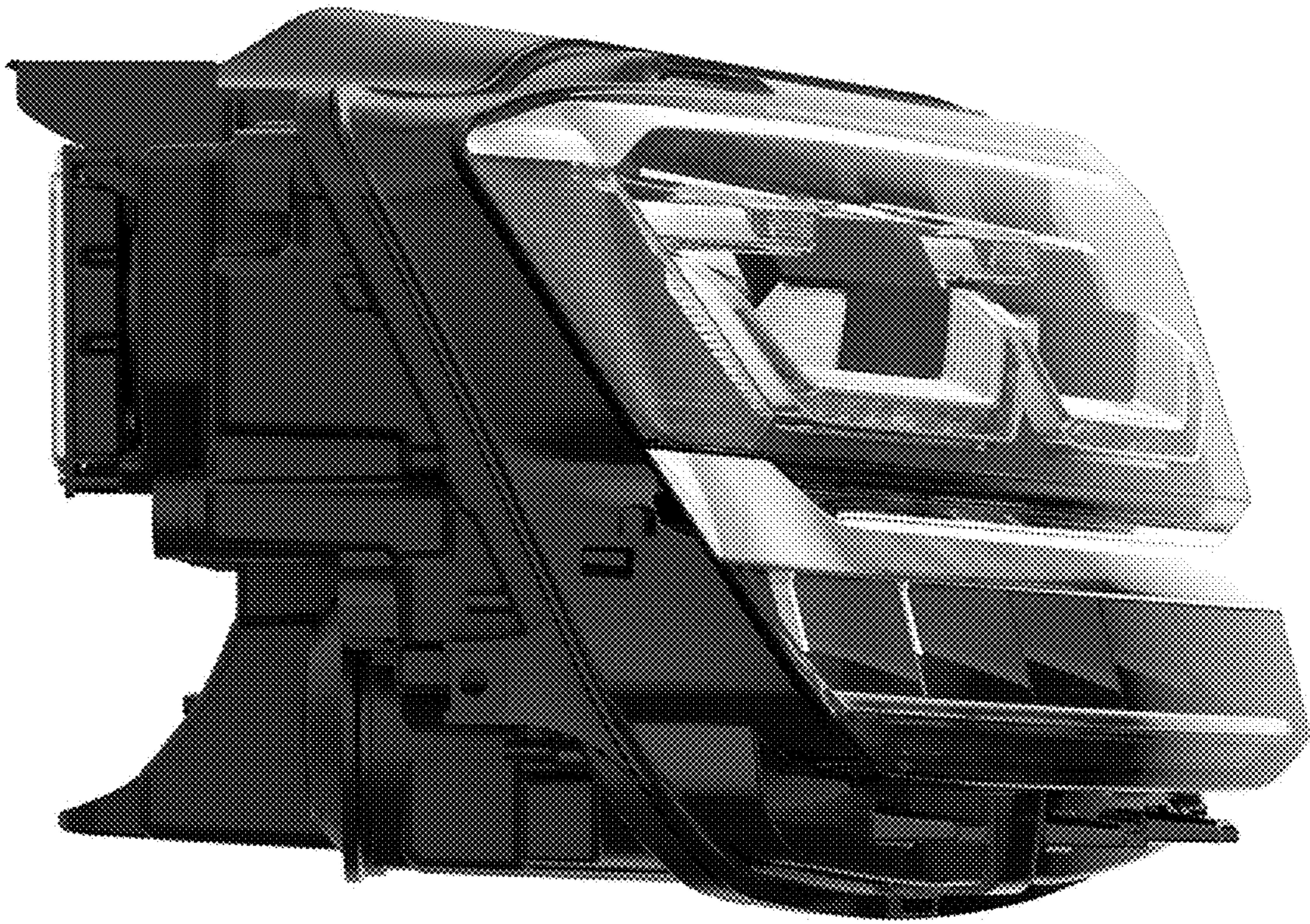
