**DESCRIPTION**

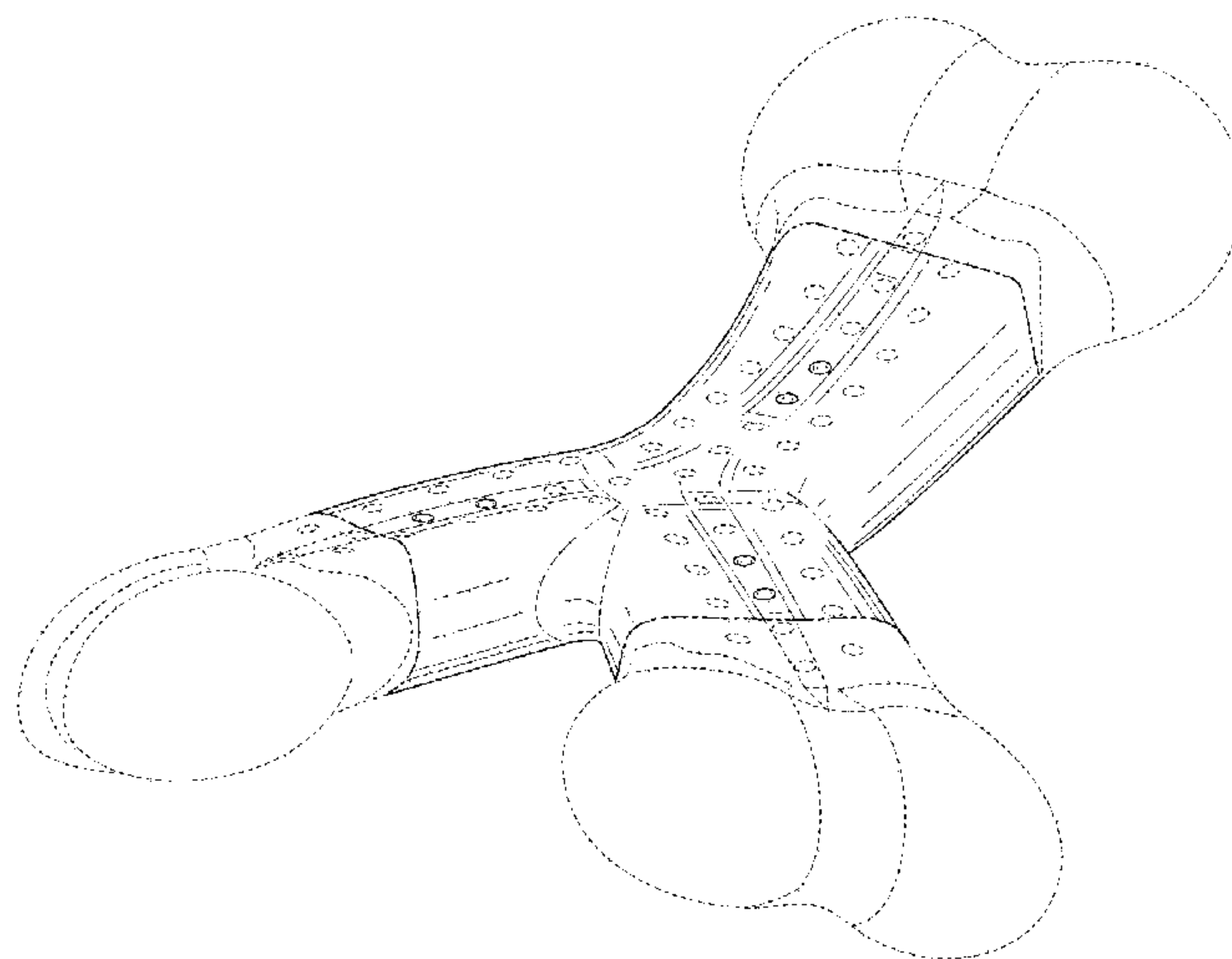
FIG. 1 is a perspective view of the dog chew toy of the present disclosure.

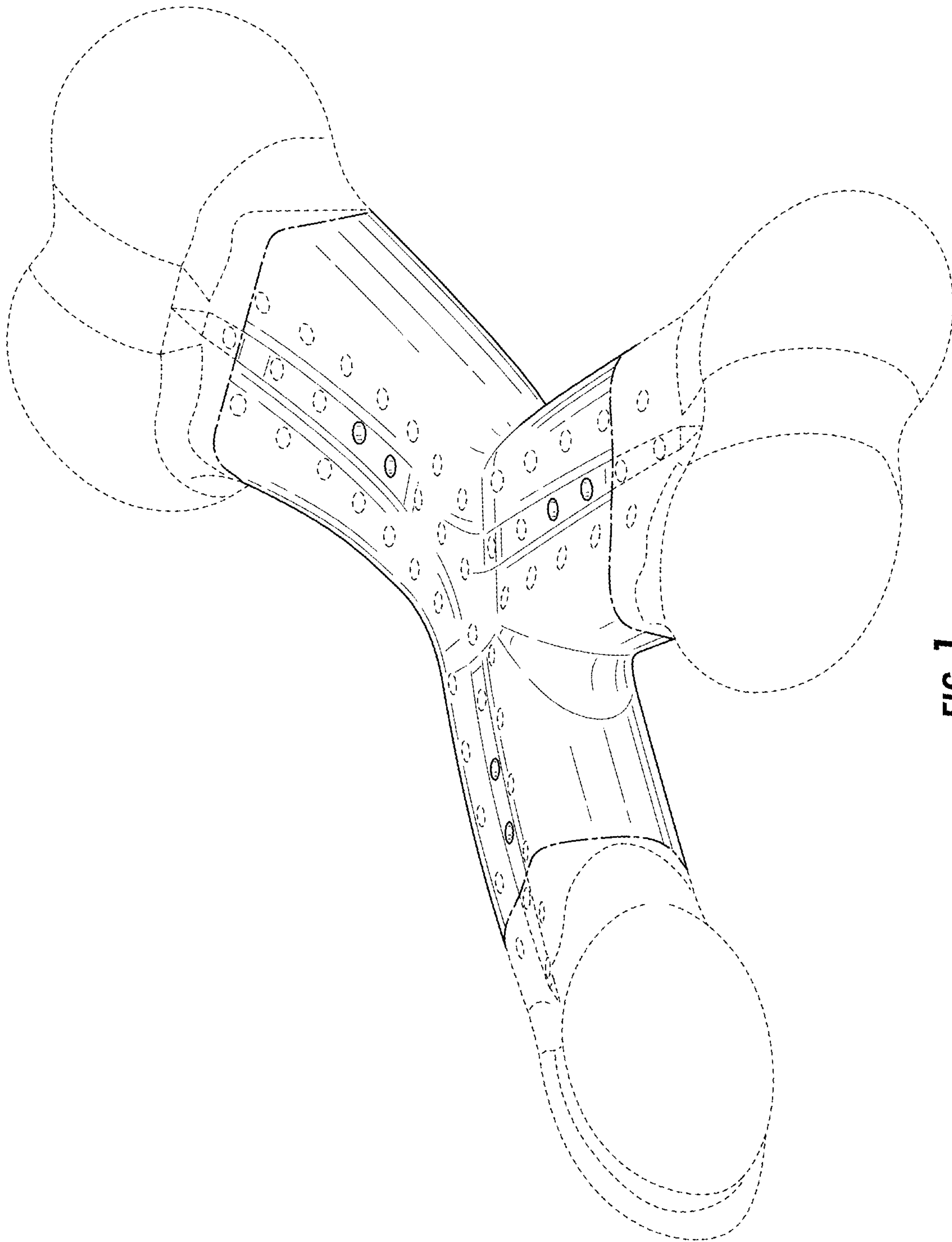

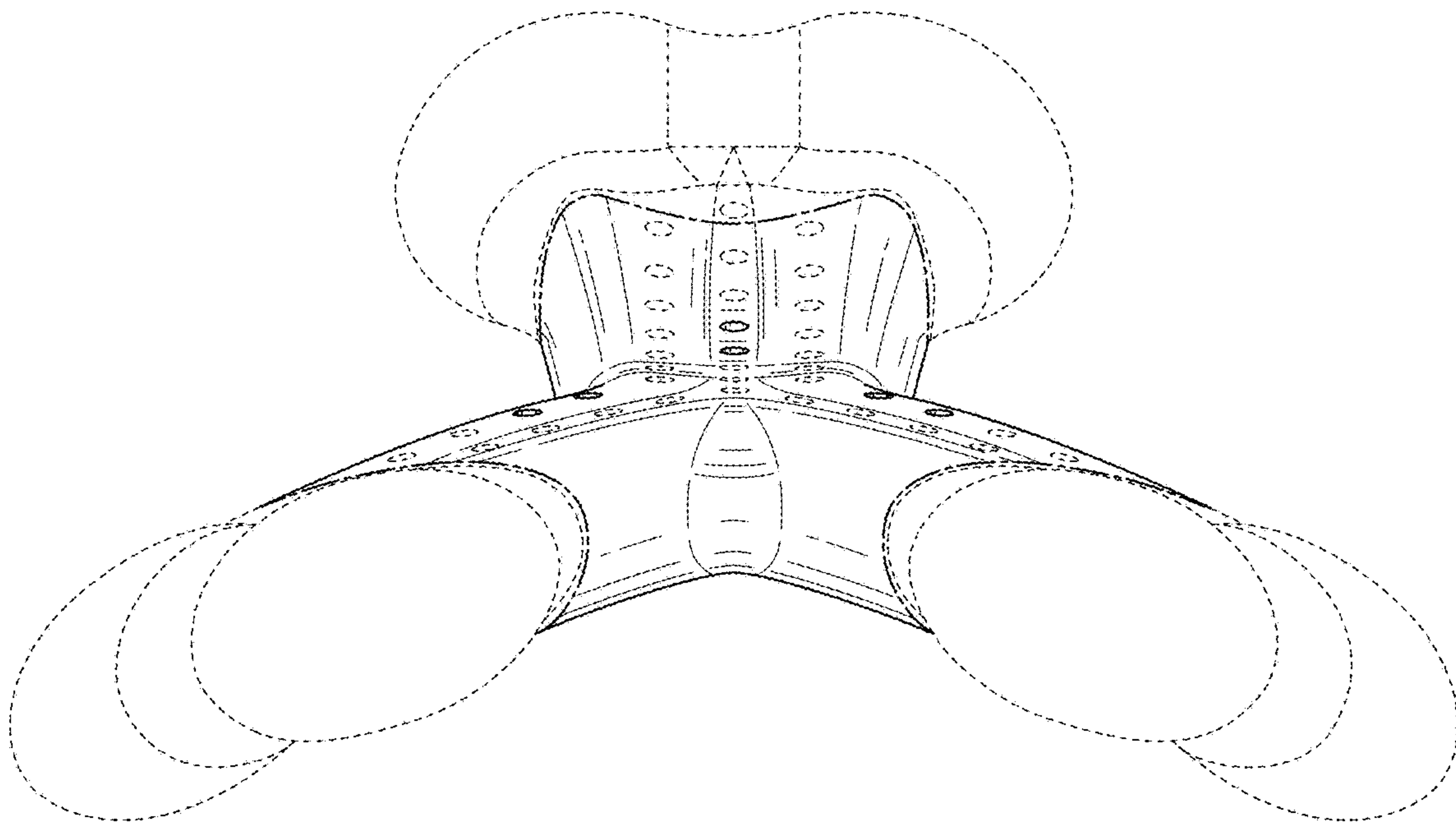
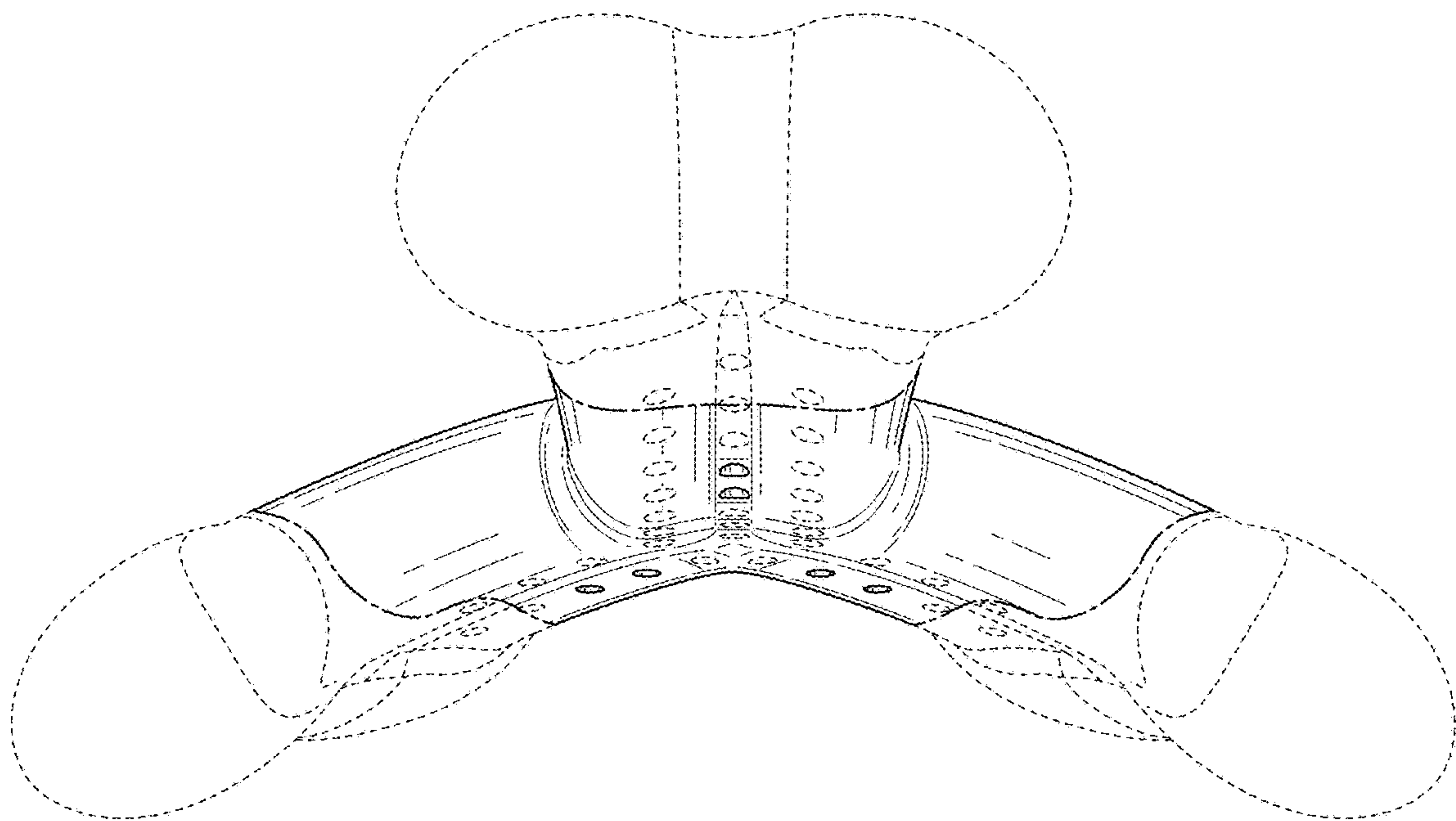

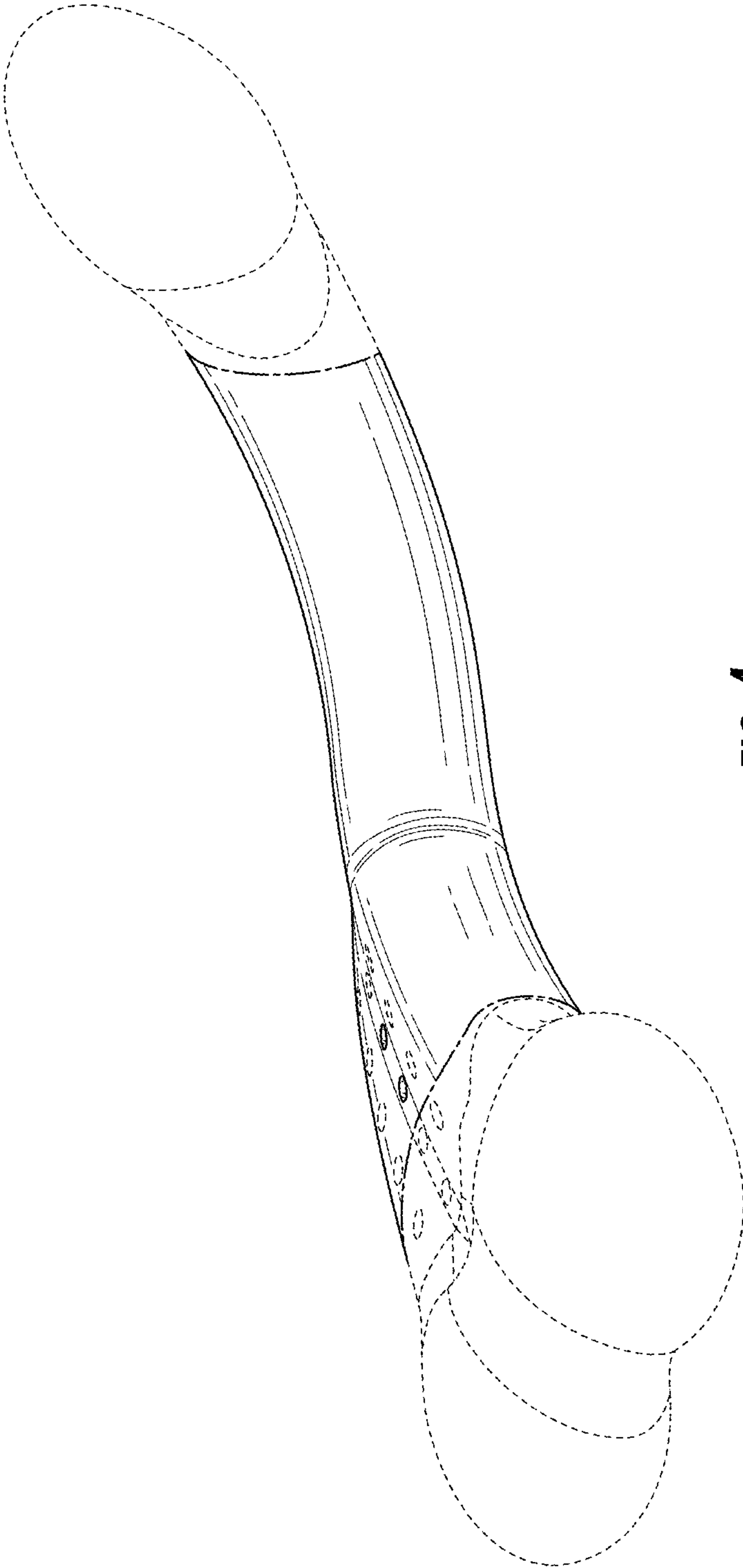

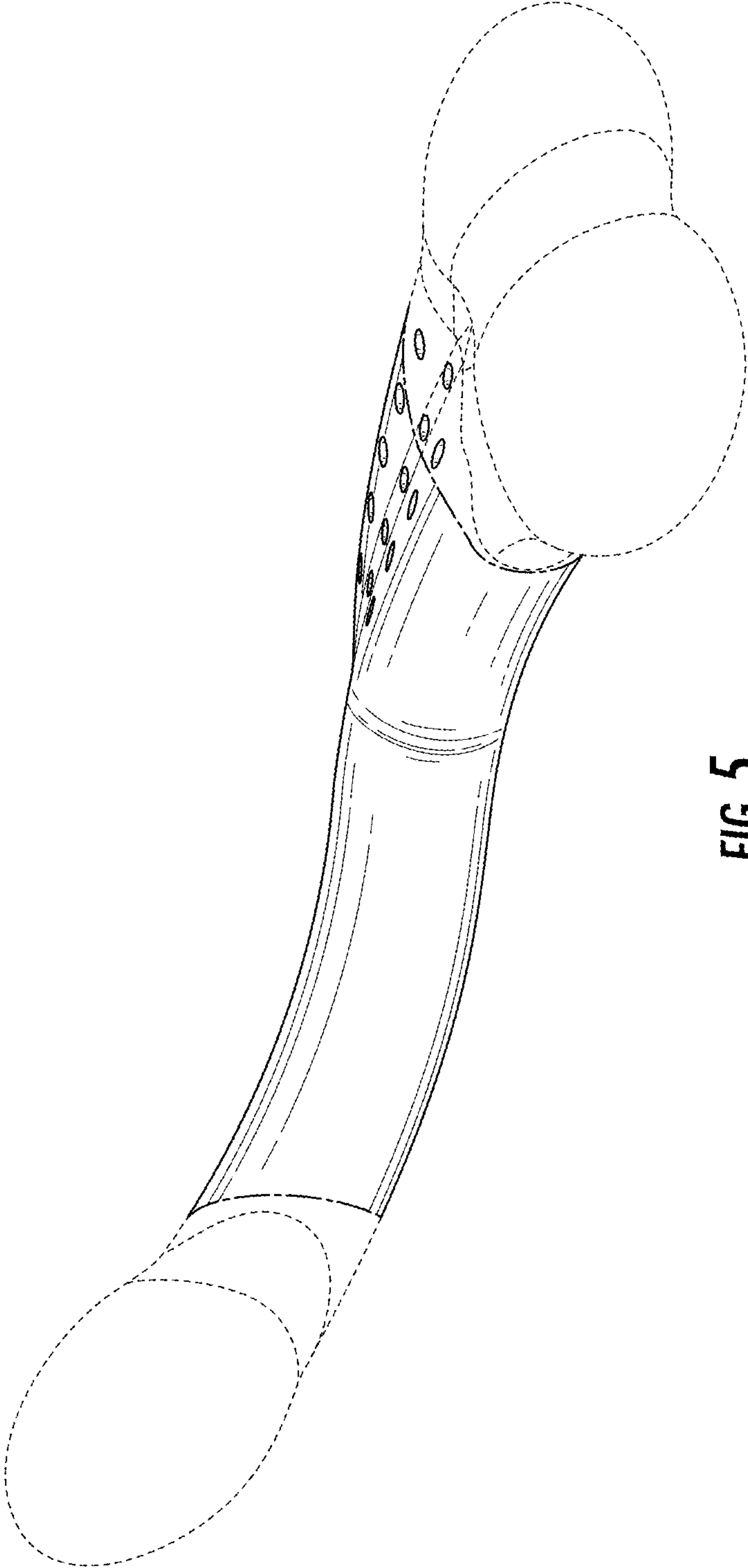

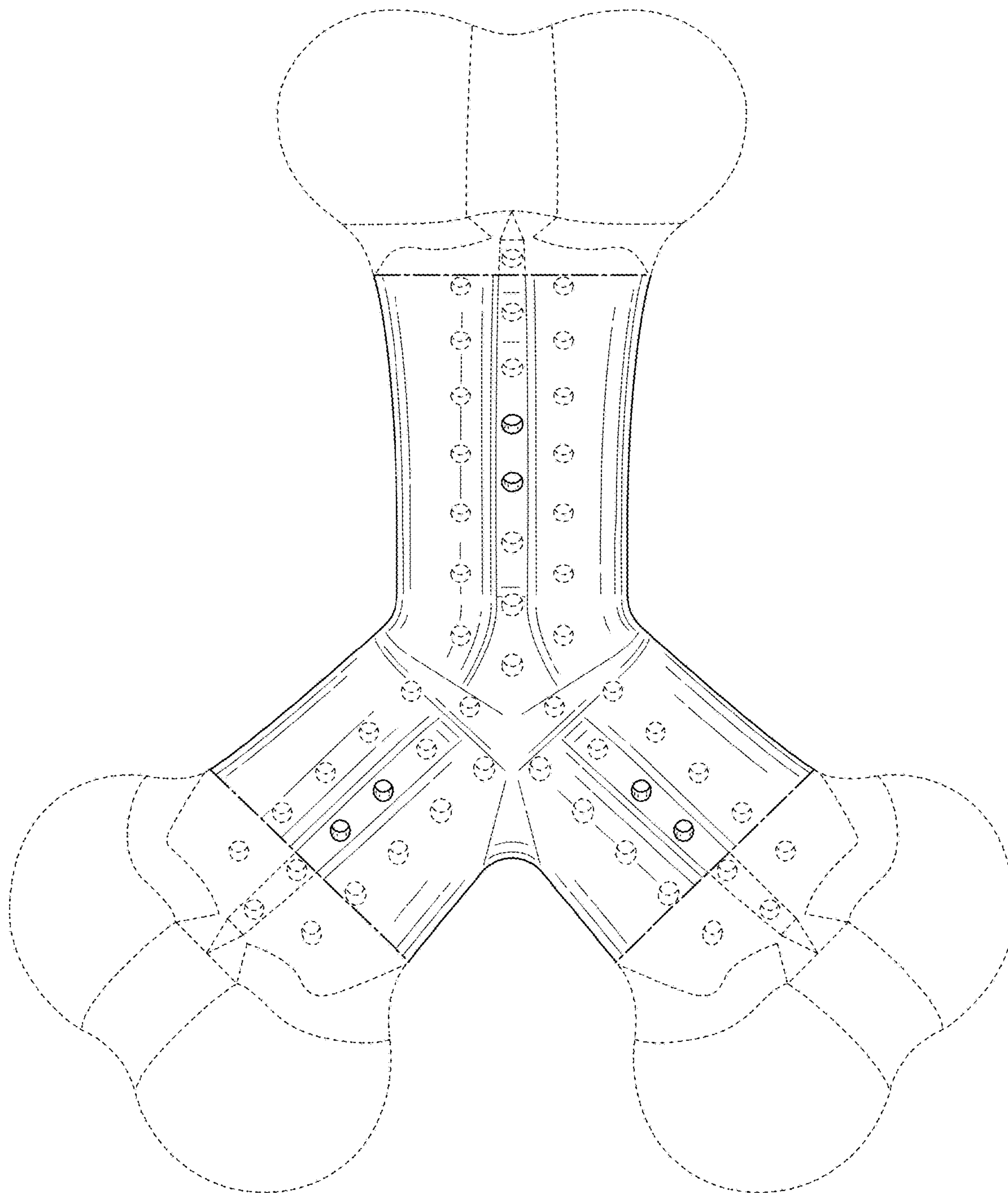
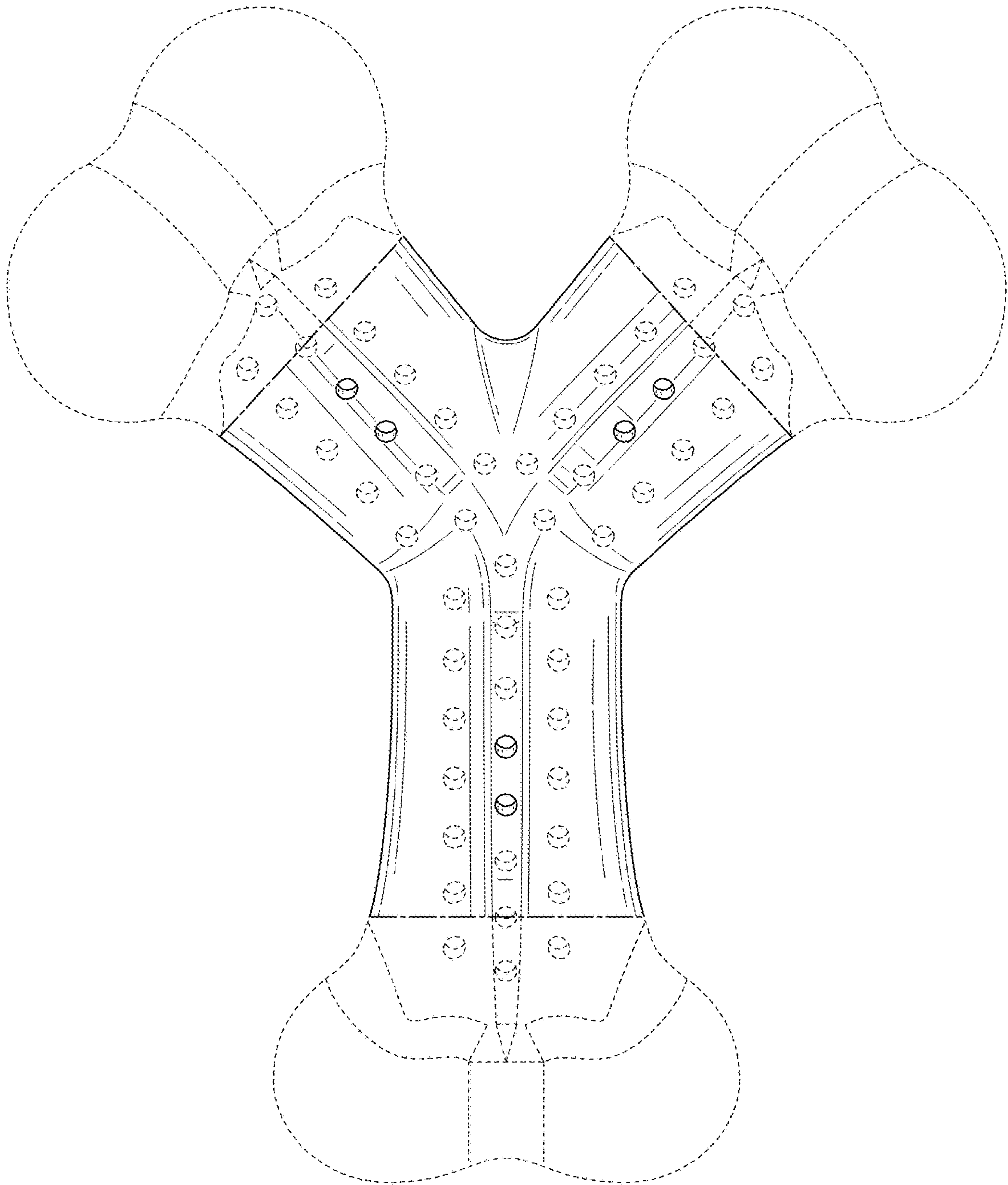
