FIG. 7 shows a front view of a jersey incorporating our new design, with a number patch attached to the front of the jersey;

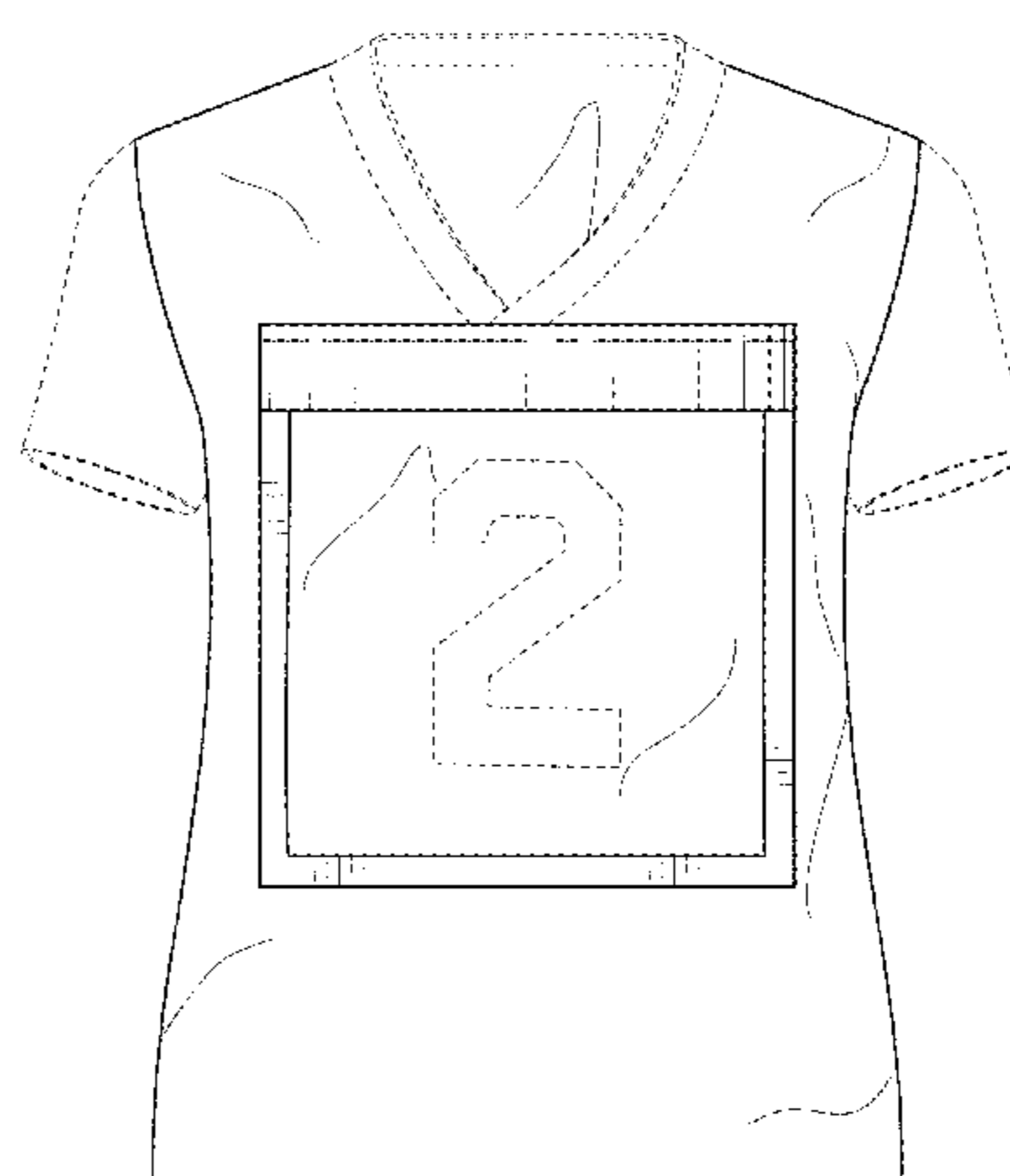
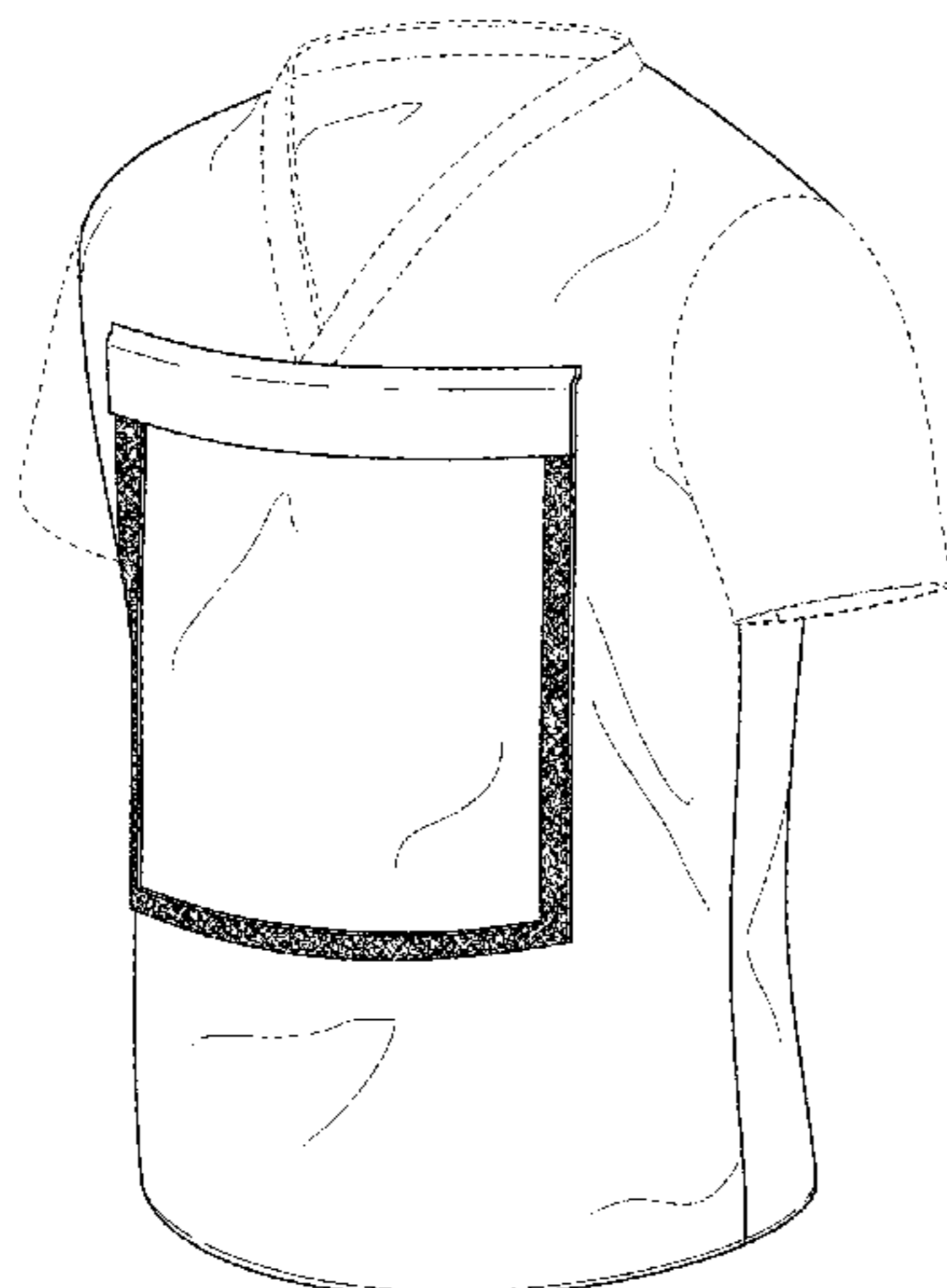
FIG. 8 shows a front view of a number patch for attaching to the front of a jersey incorporating our new design;

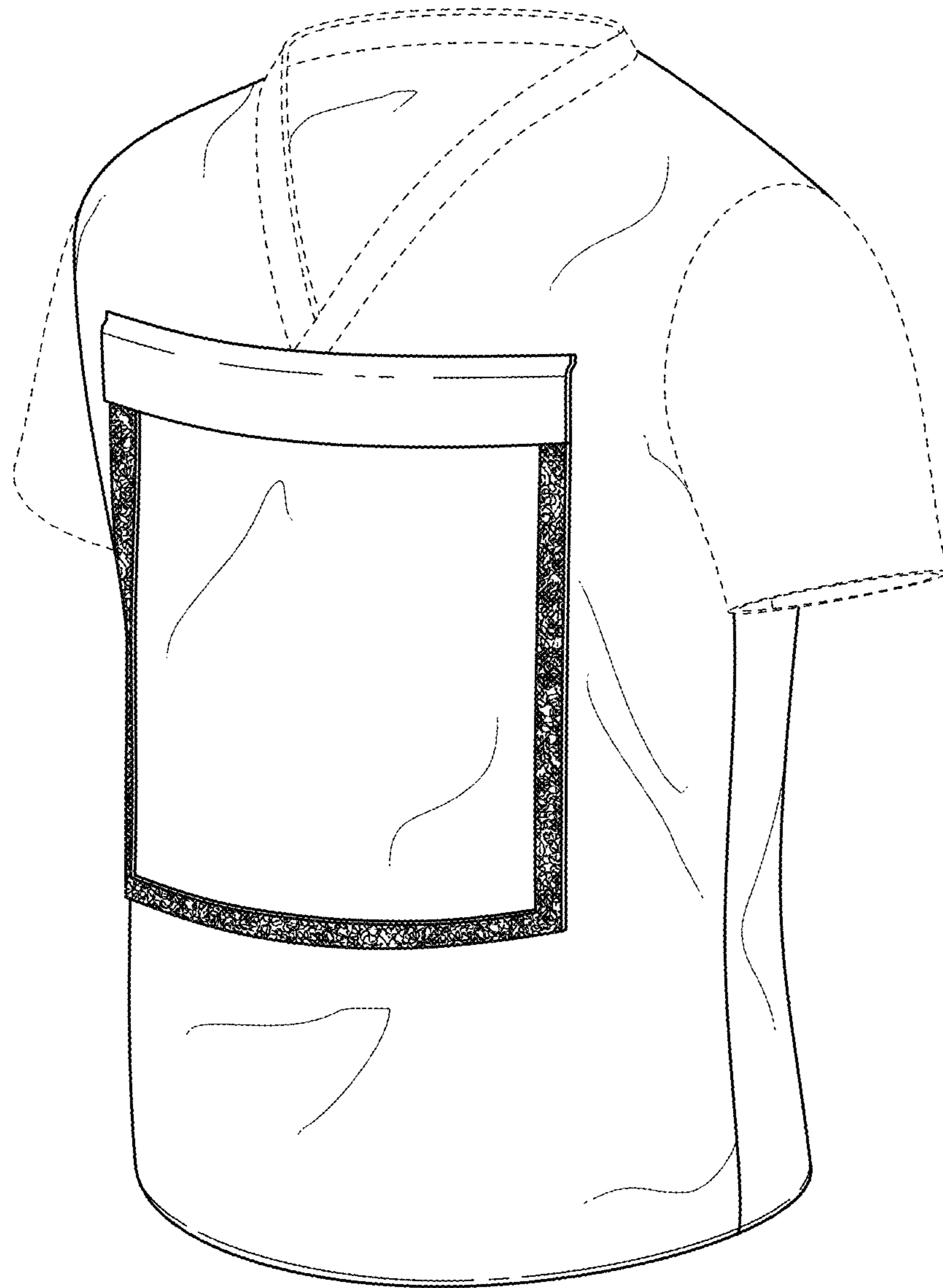

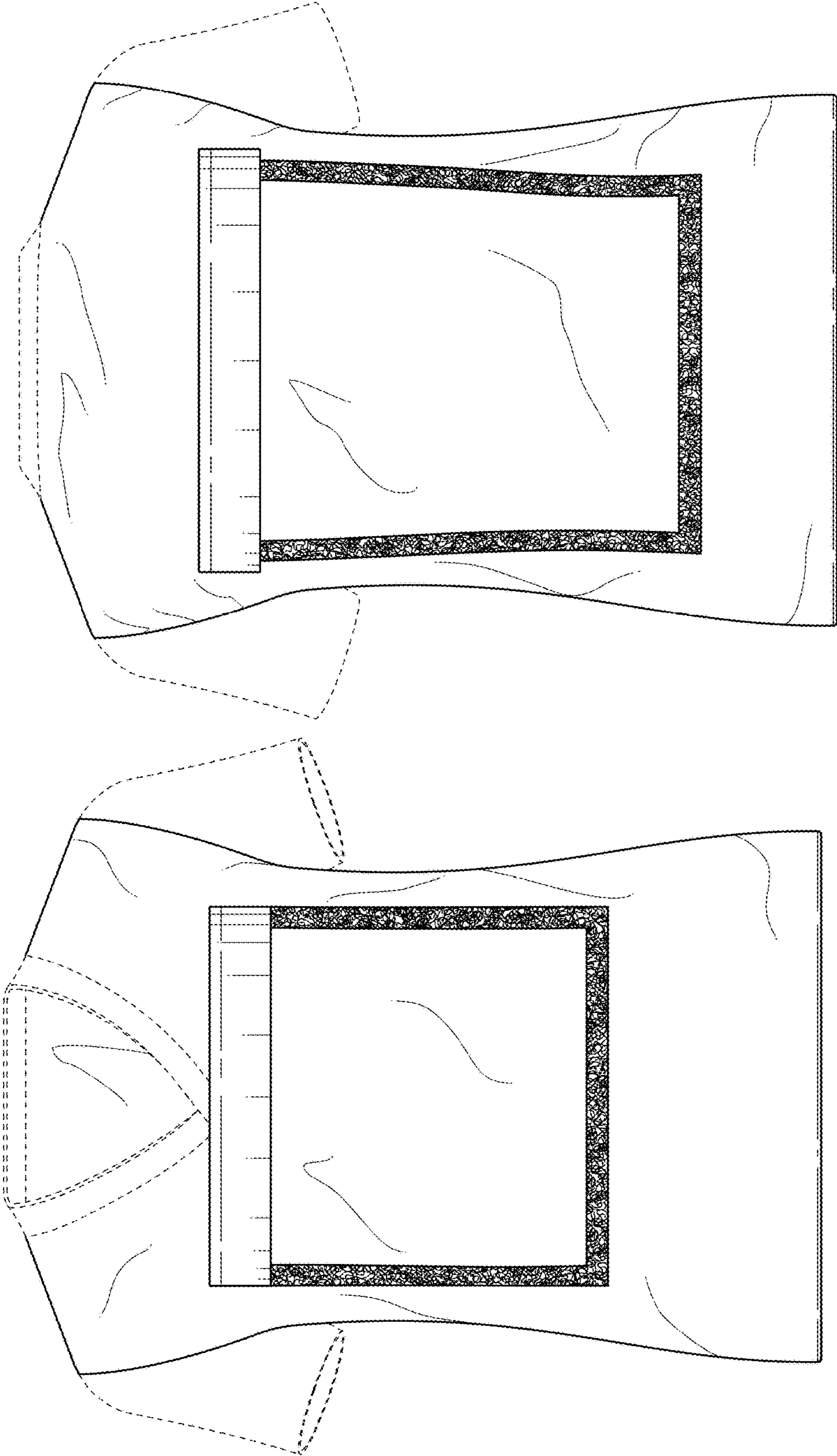

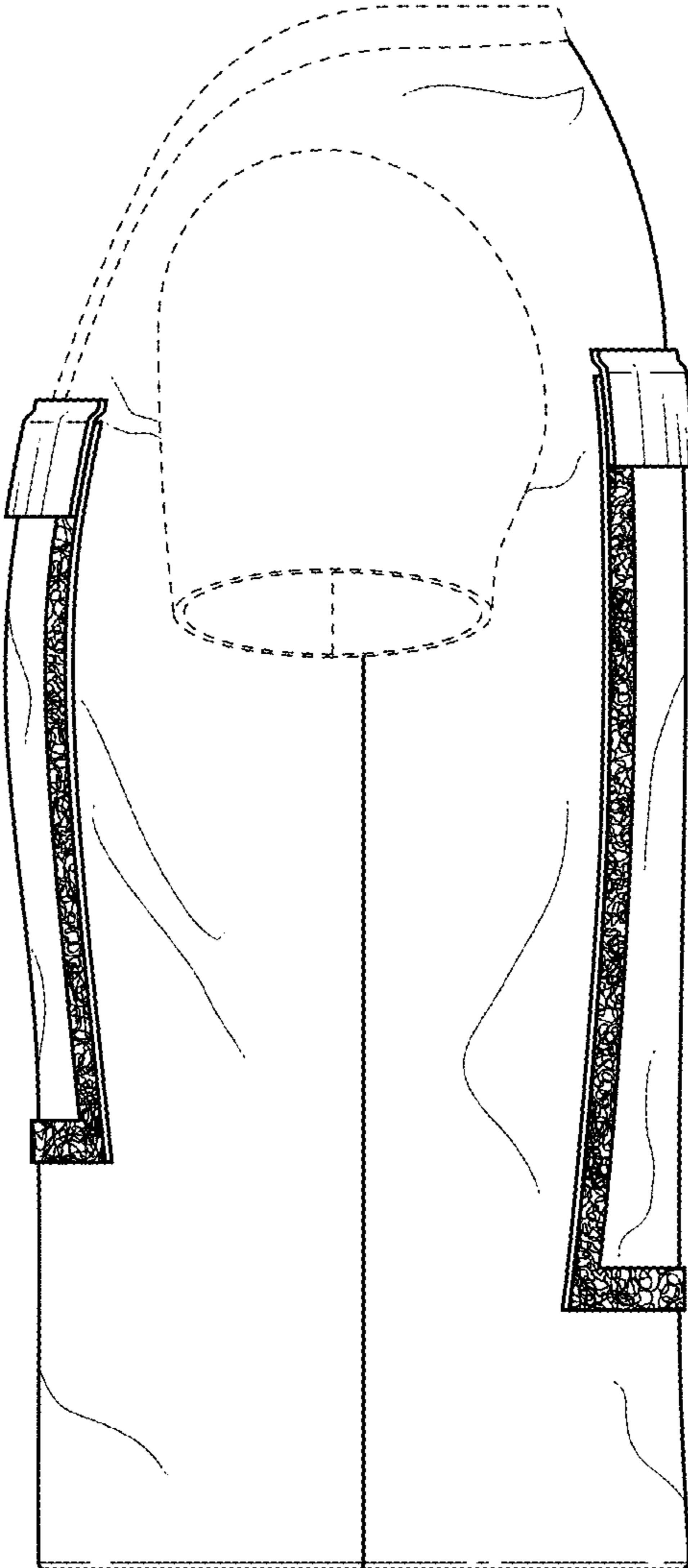

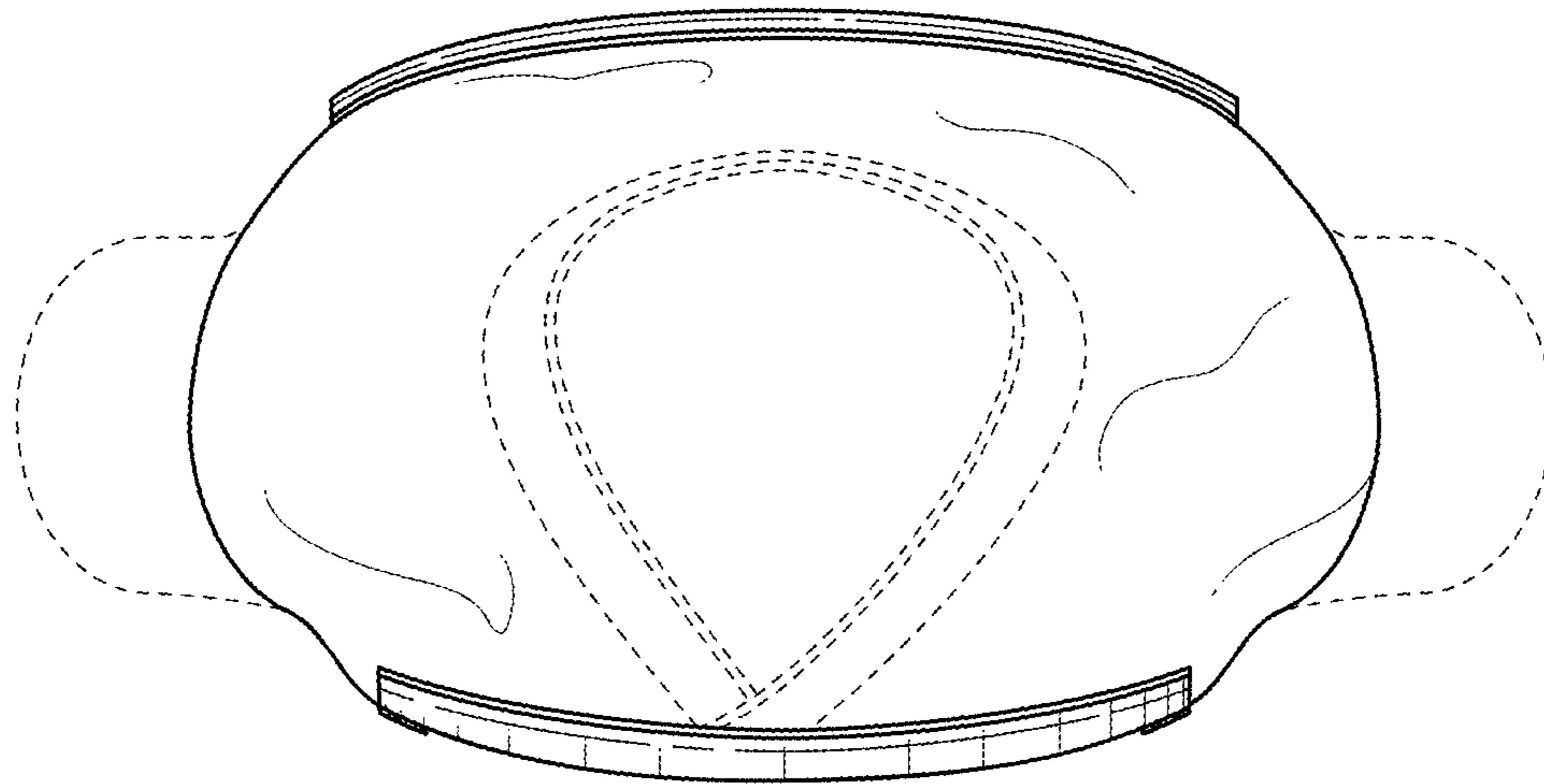

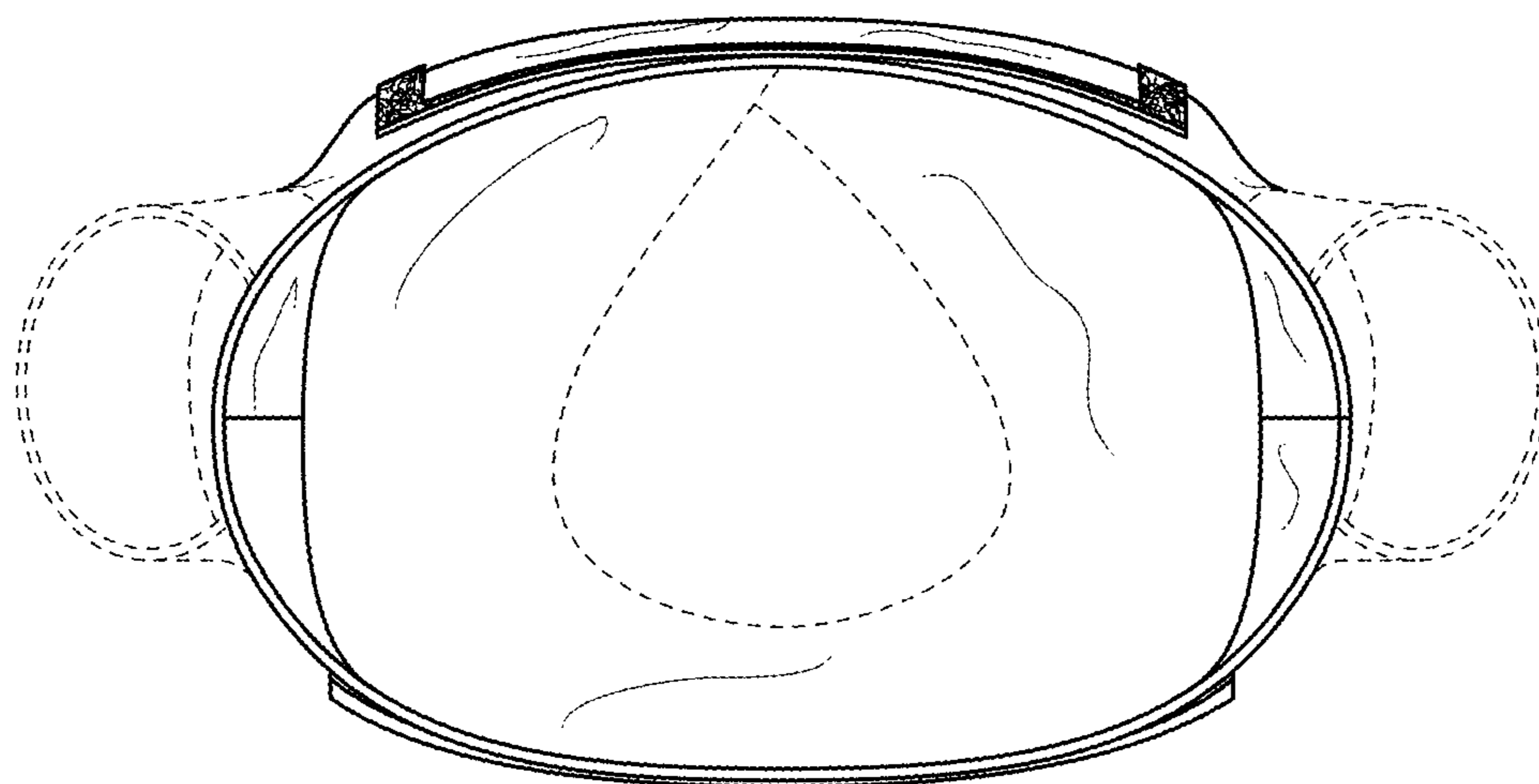

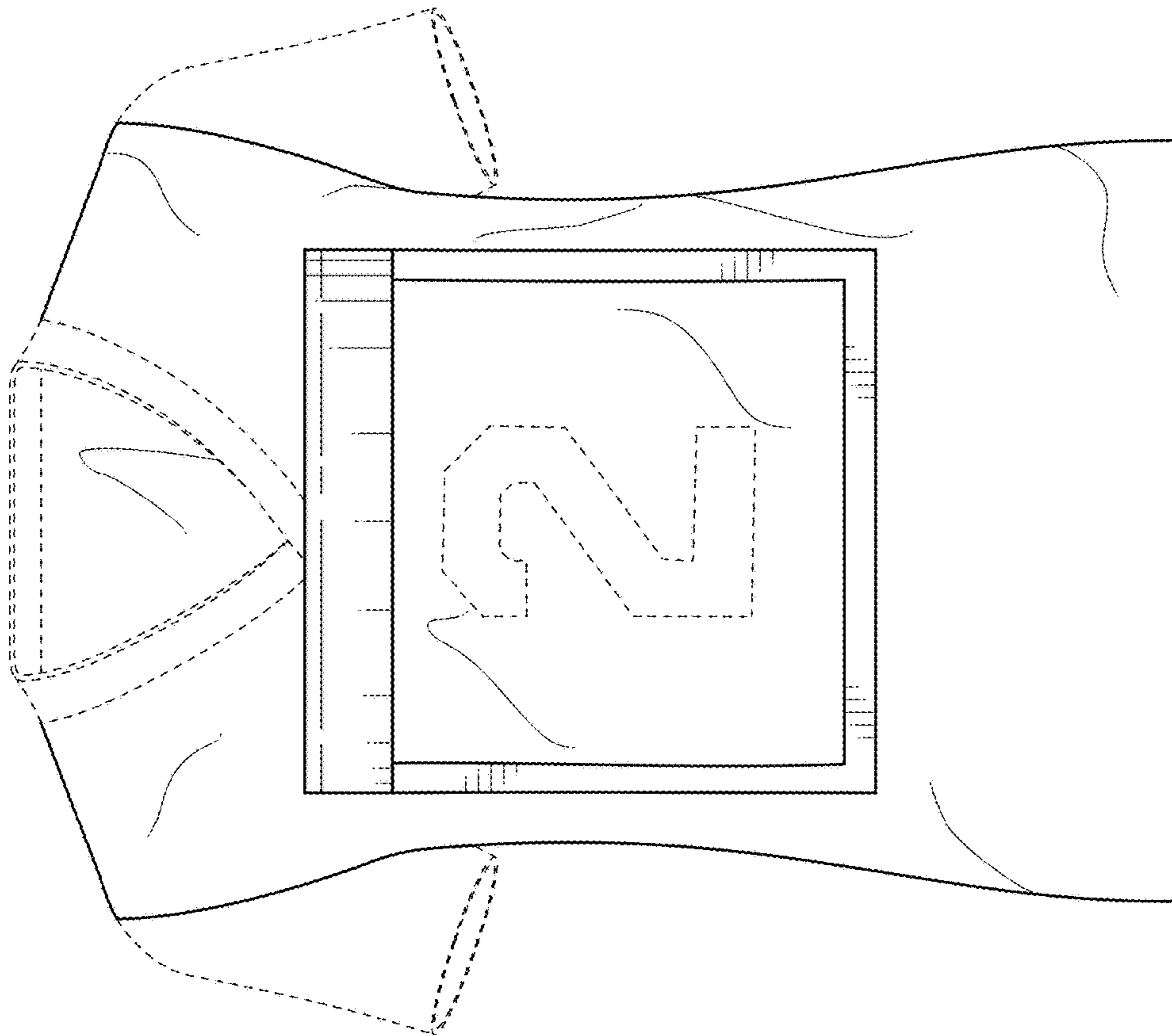

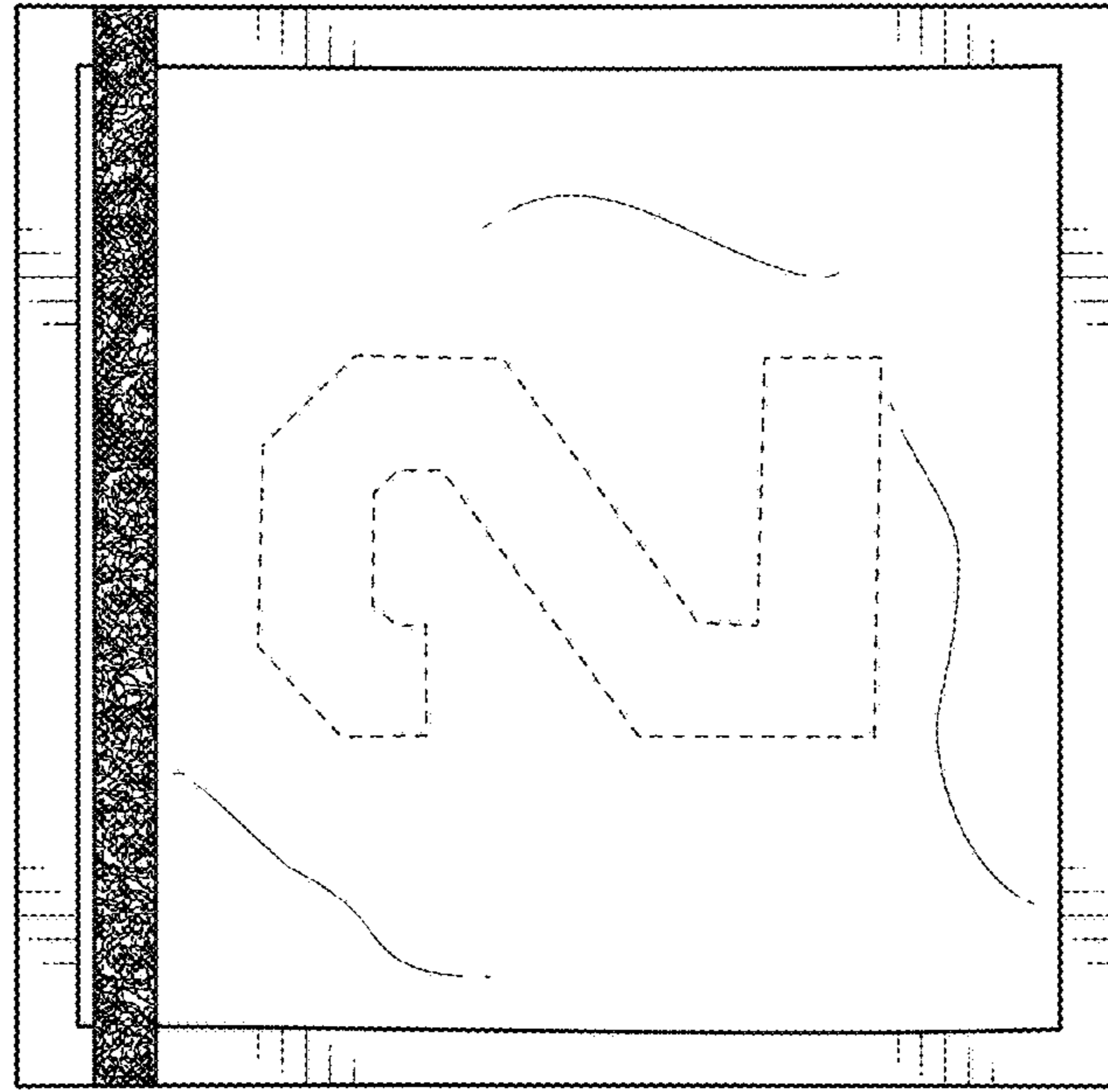

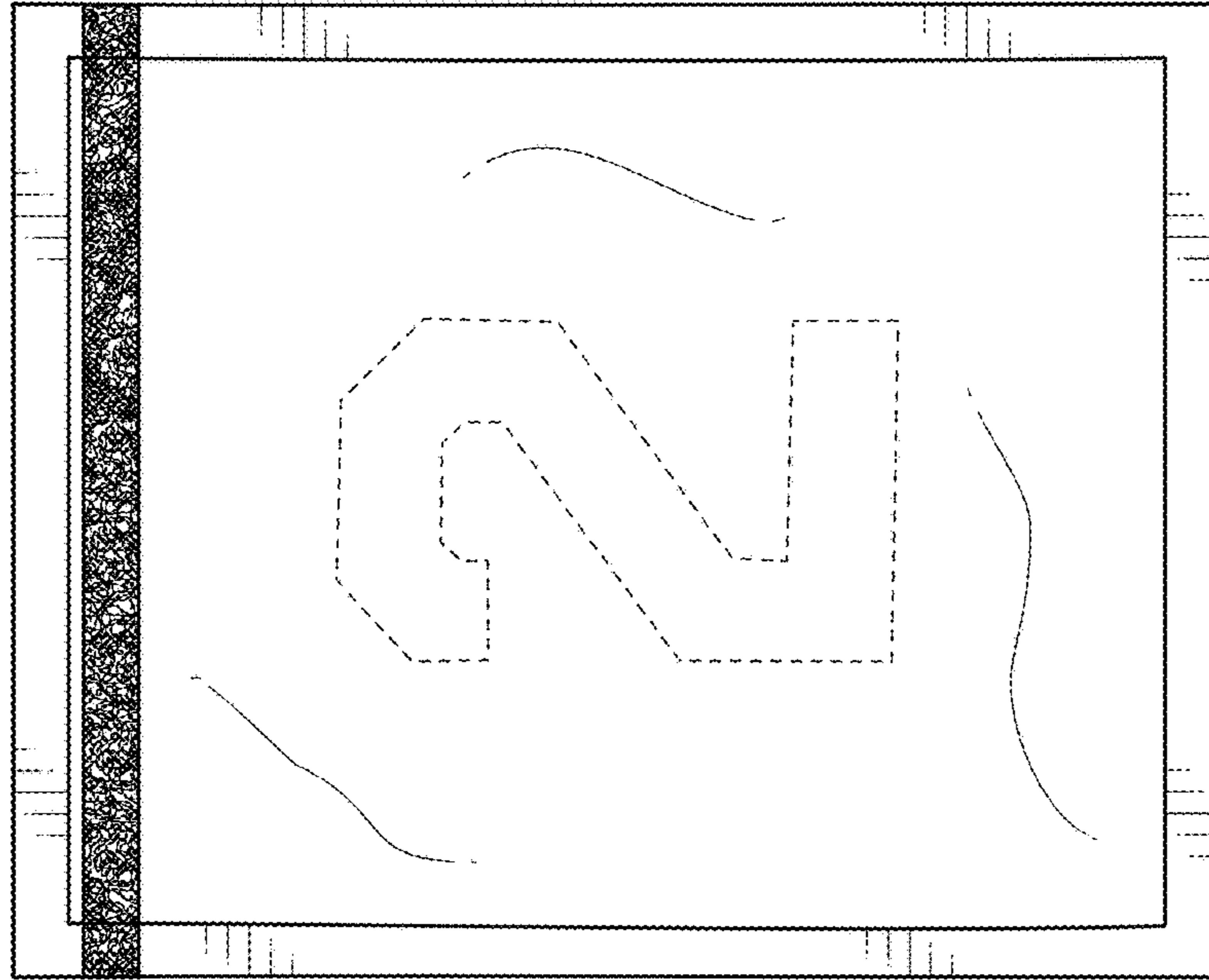

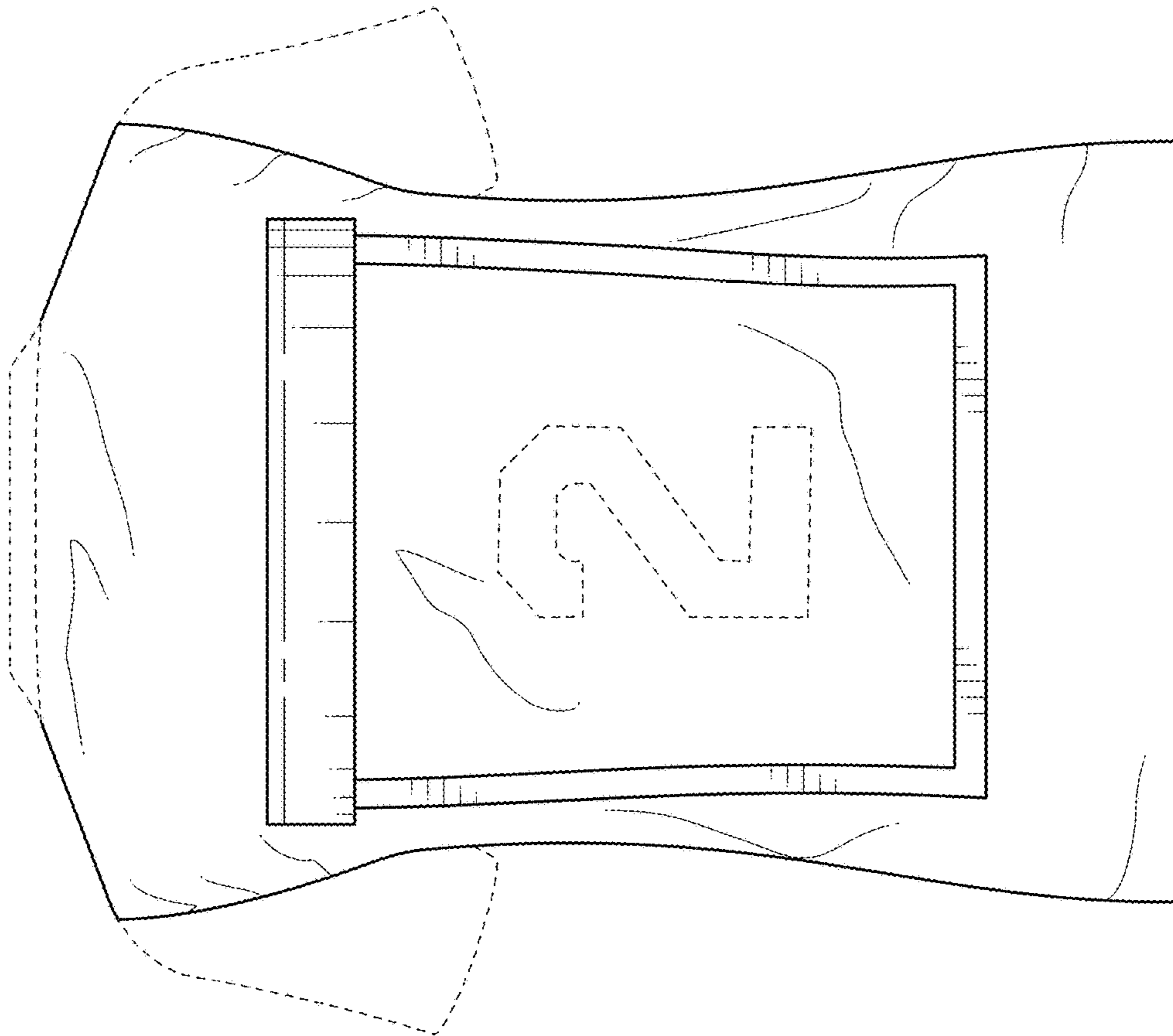
