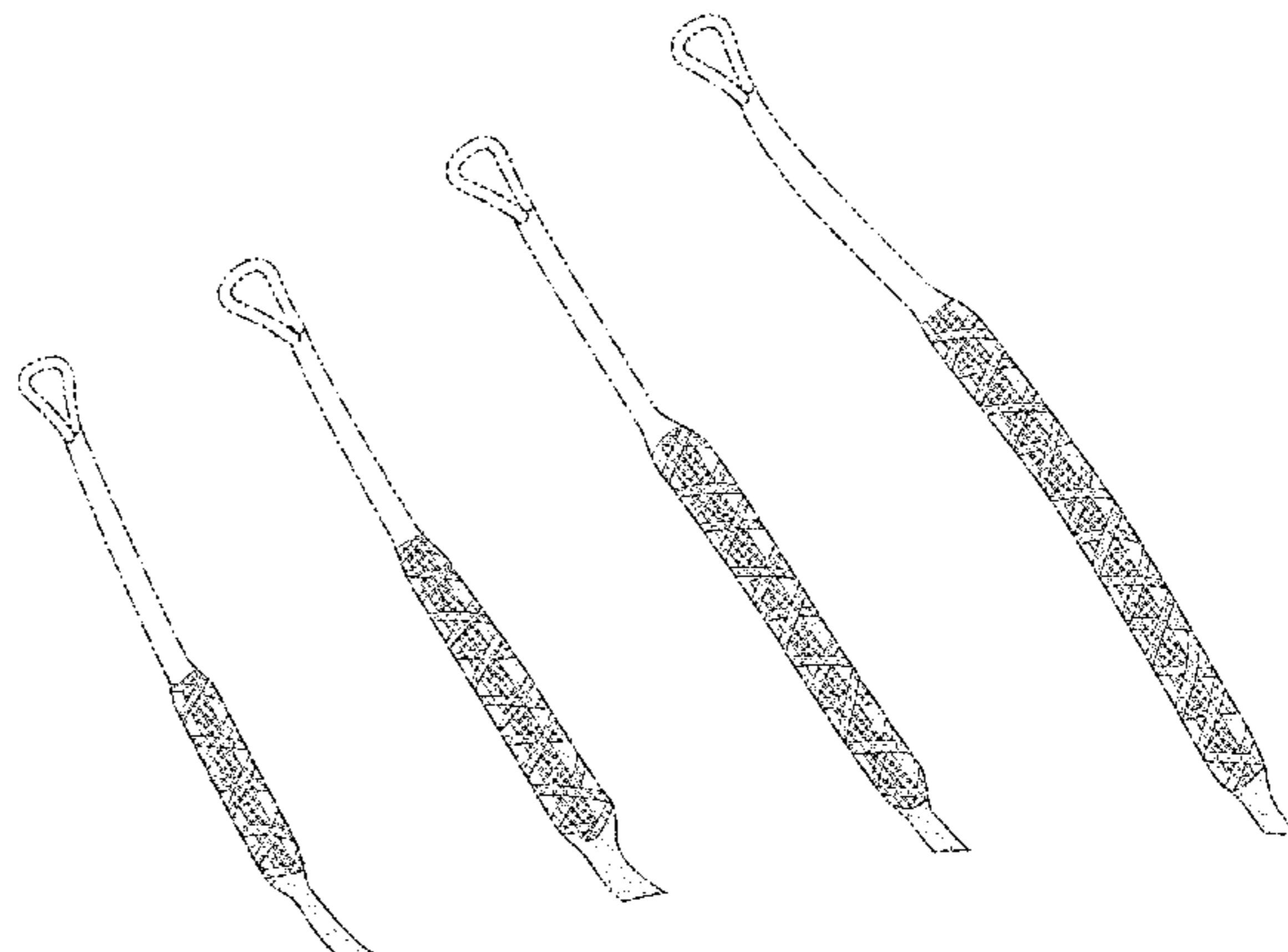
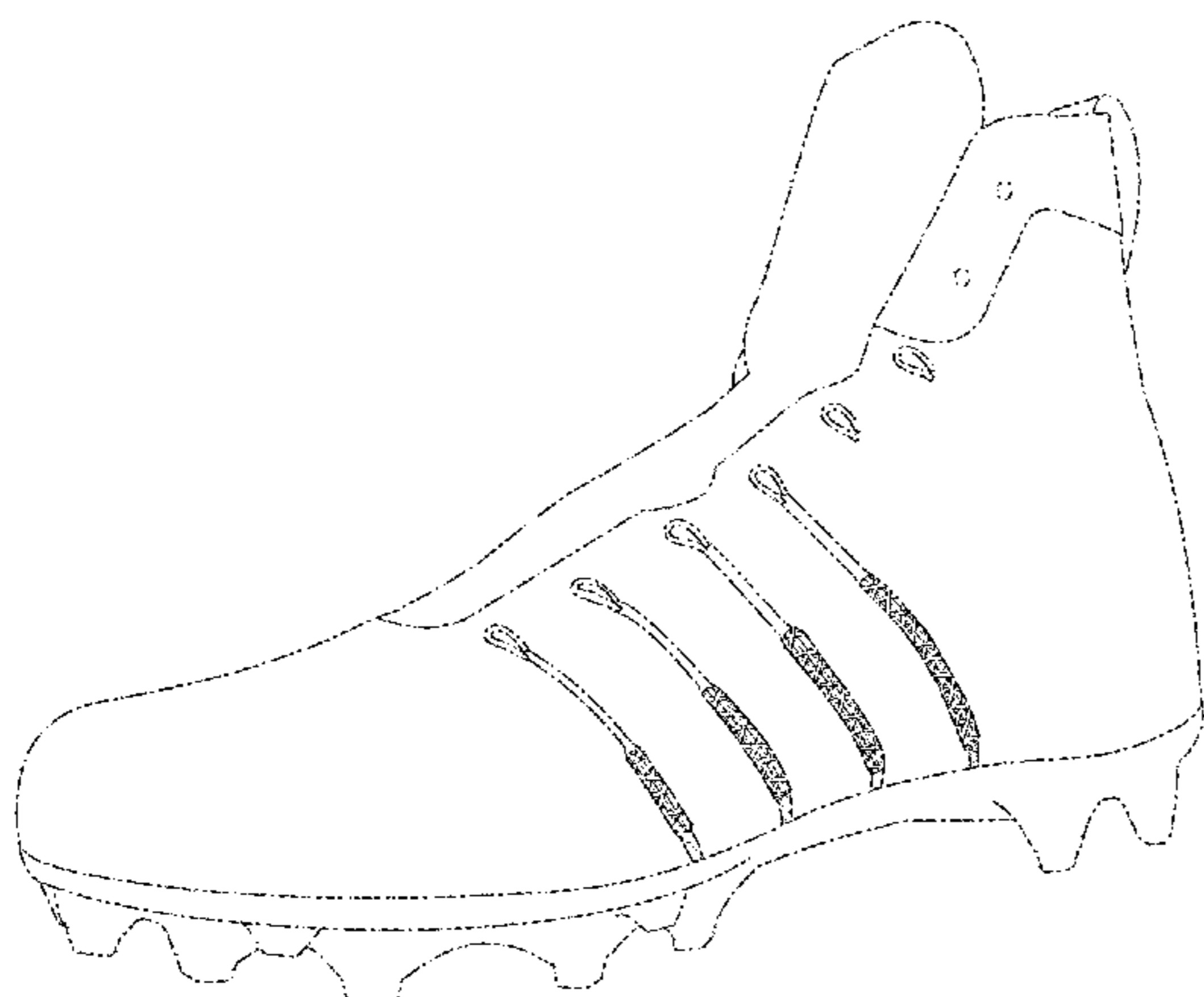
(57) **CLAIM**

The ornamental design for a shoe upper, as shown and described.

DESCRIPTION

FIG. 1 is a front perspective view of a shoe upper showing my new design;
FIG. 2 is a side view thereof;
FIG. 3 is a front view thereof;
FIG. 4 is a rear view thereof;
FIG. 5 is a top view thereof;
FIG. 6 is a rear perspective view thereof;
FIG. 7 is an enlarged view of the claimed region of FIG. 1, shown in isolation for clarity purpose;
FIG. 8 is an enlarged view of the claimed region of FIG. 2, shown in isolation for clarity purpose; and,
FIG. 9 is an enlarged view of the claimed region of FIG. 6, shown in isolation for clarity purpose.
The broken lines immediately adjacent to the shaded area define the bounds of the claimed design and form no part thereof. The broken lines showing the remainder of the shoe represent unclaimed subject matter and form no part of the claimed design. The contrast in shading represents a contrast in appearance only and does not represent any particular color, material, texture or finish.

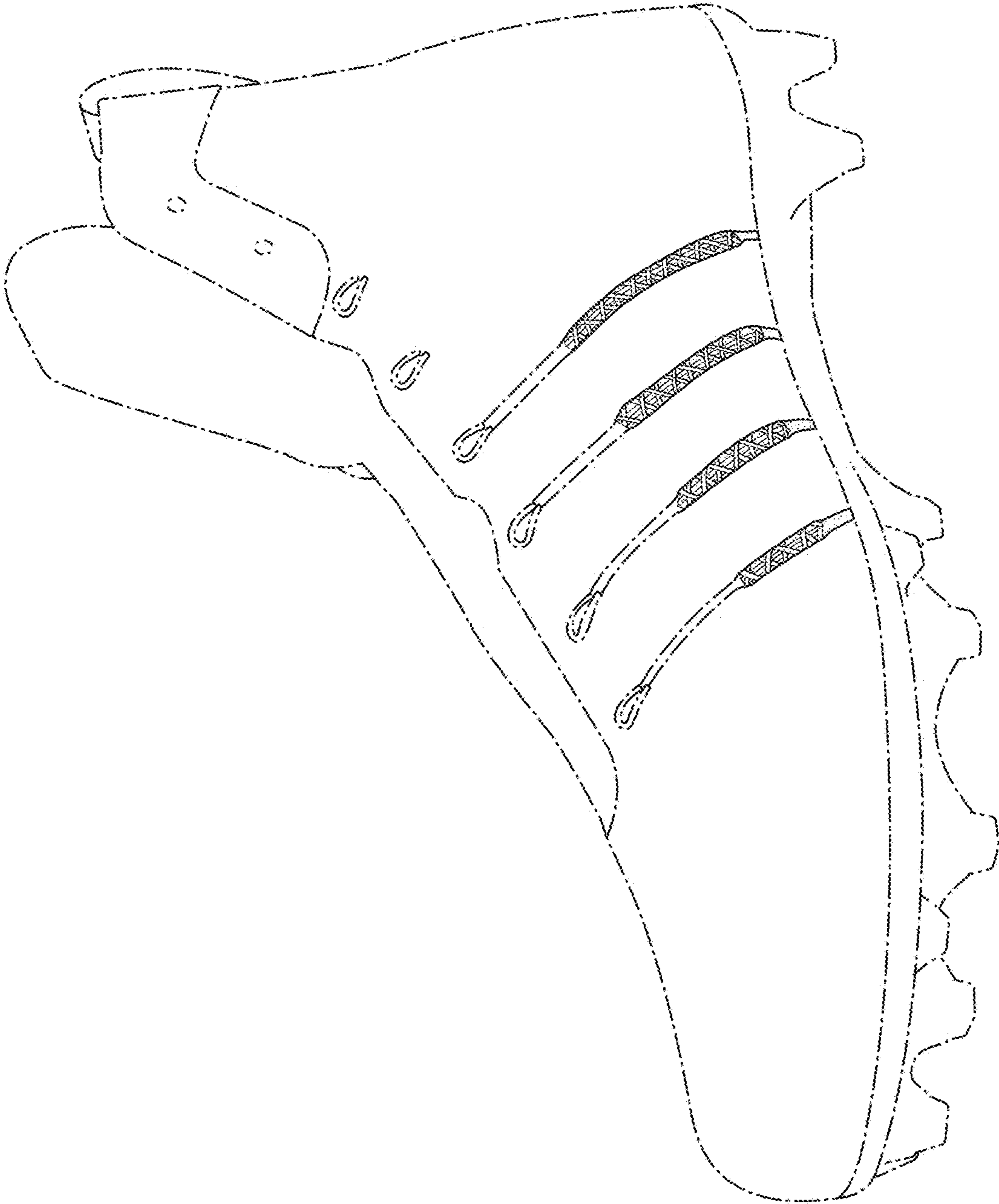

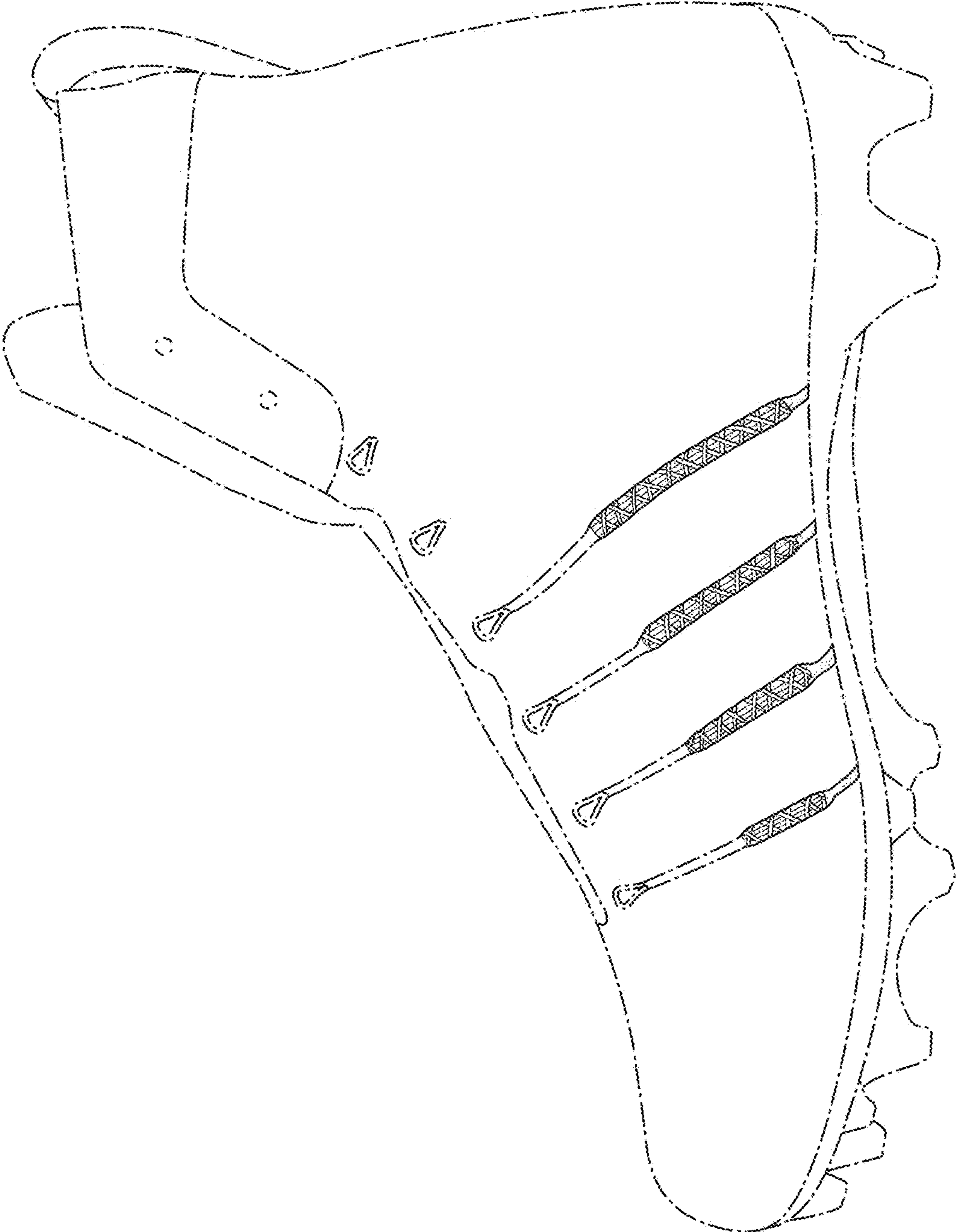

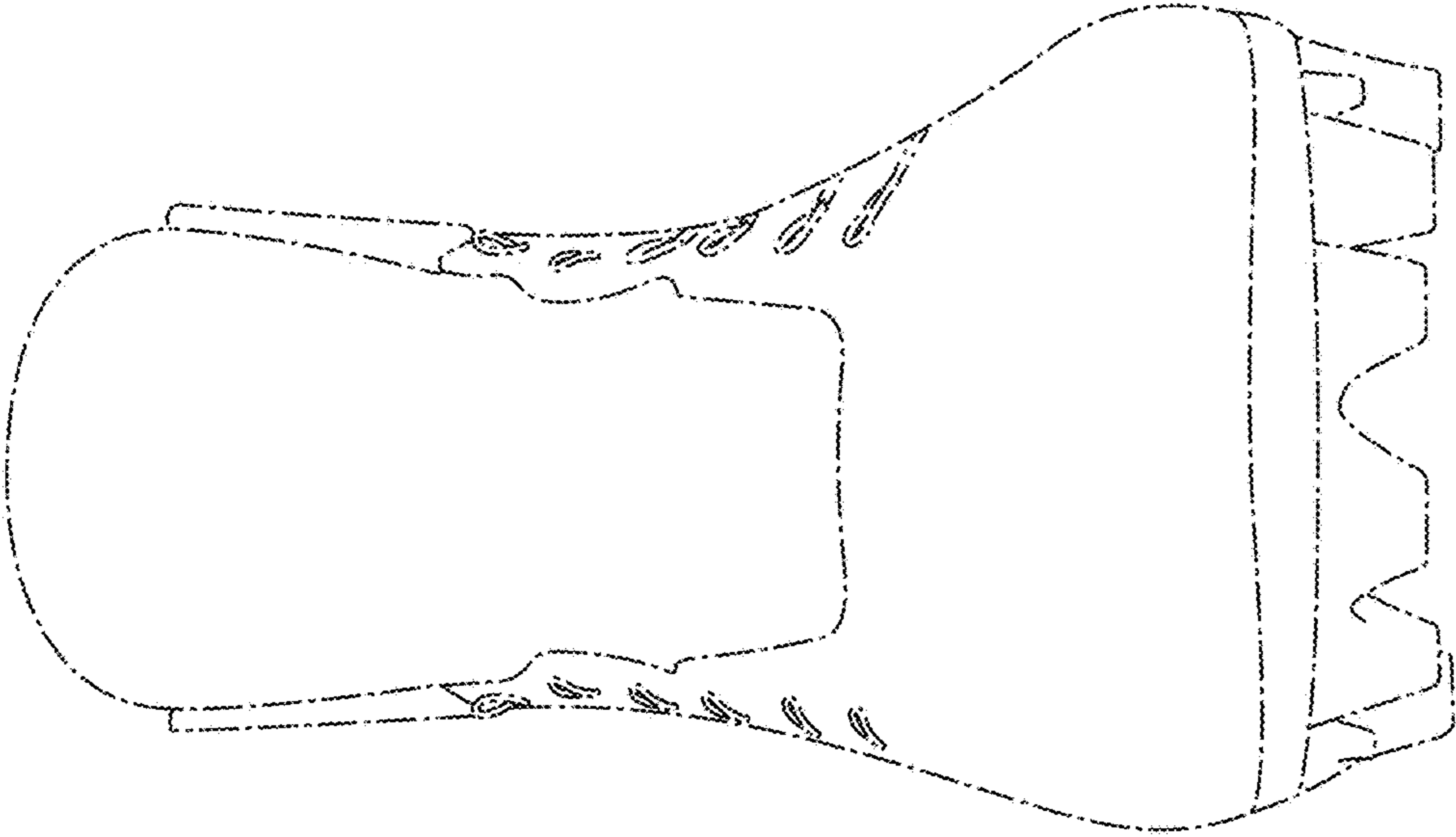

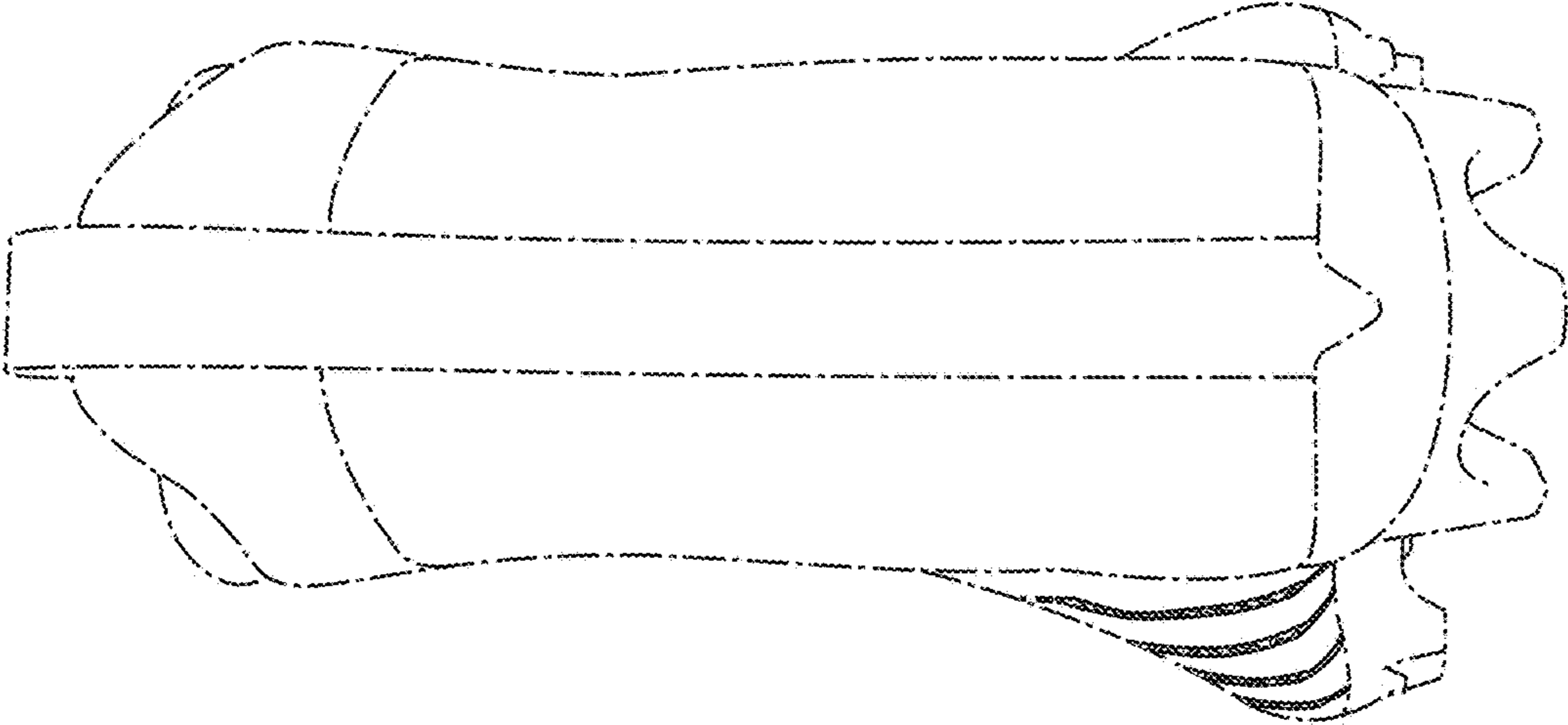

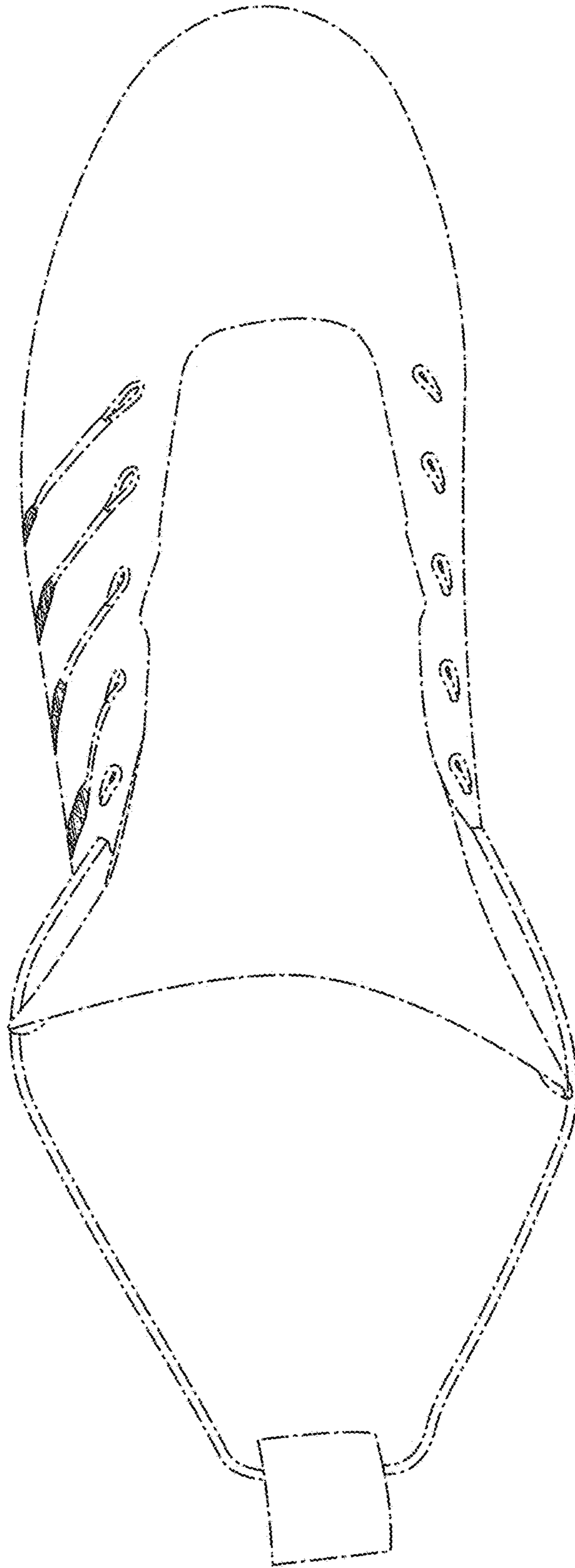

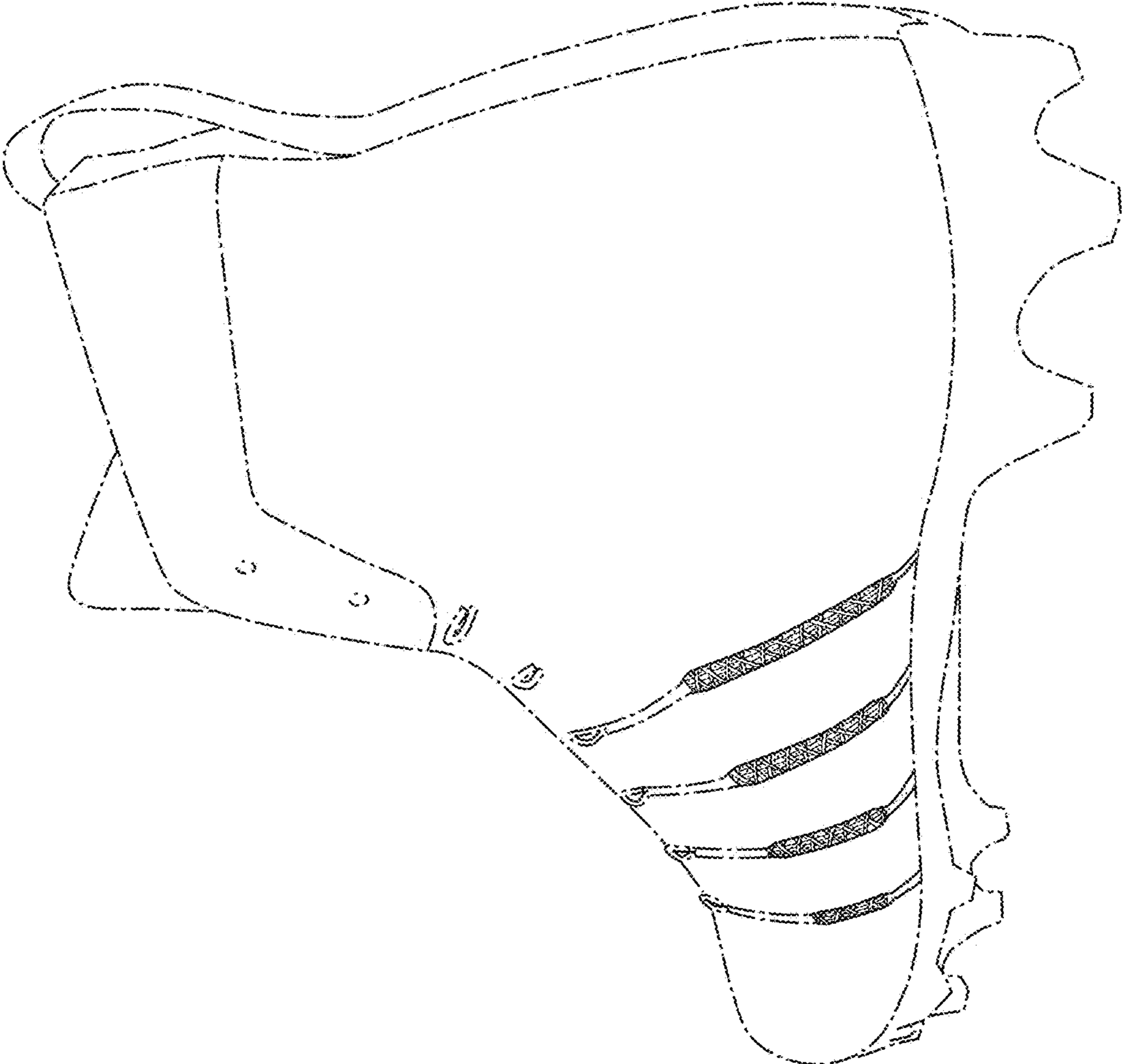

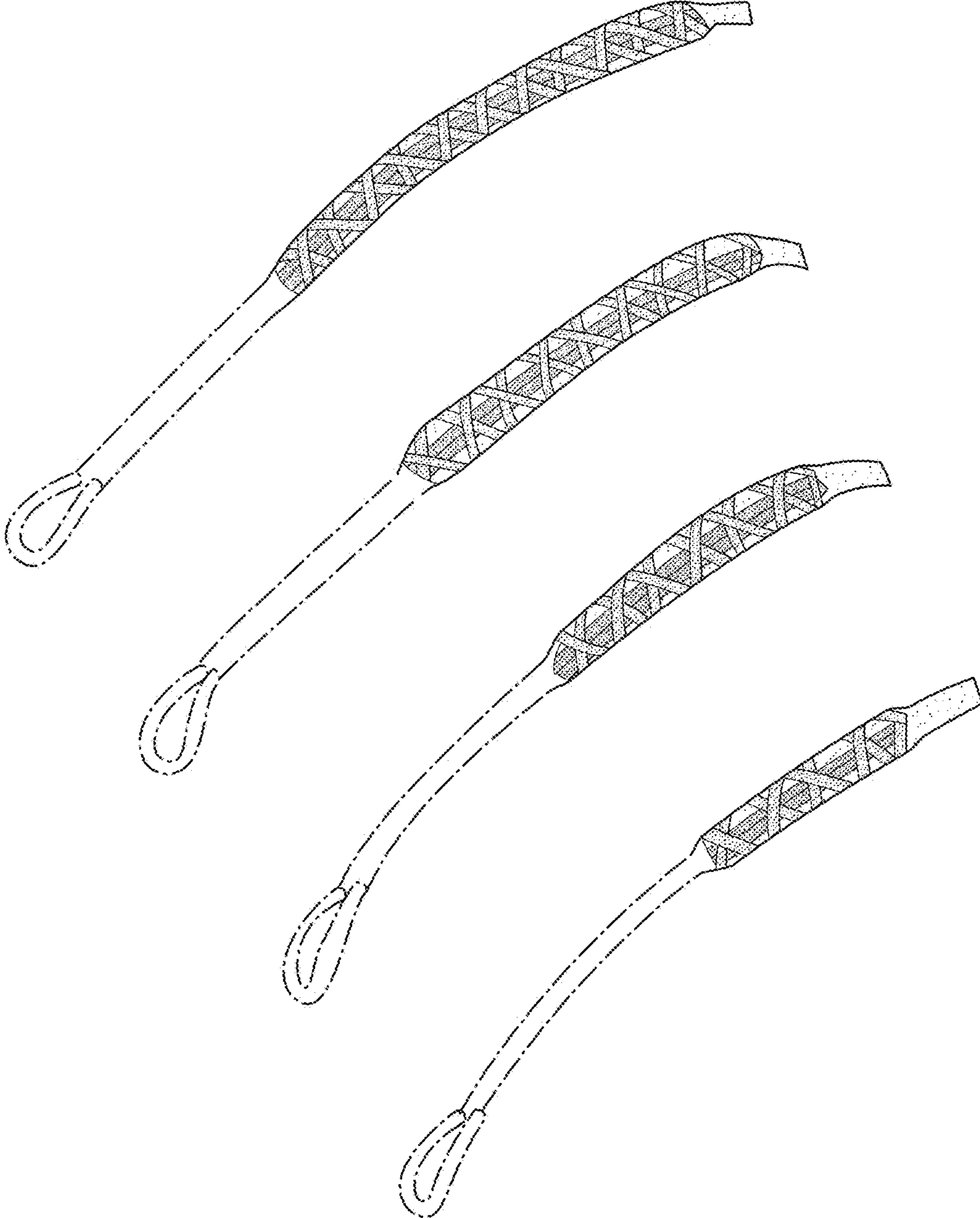

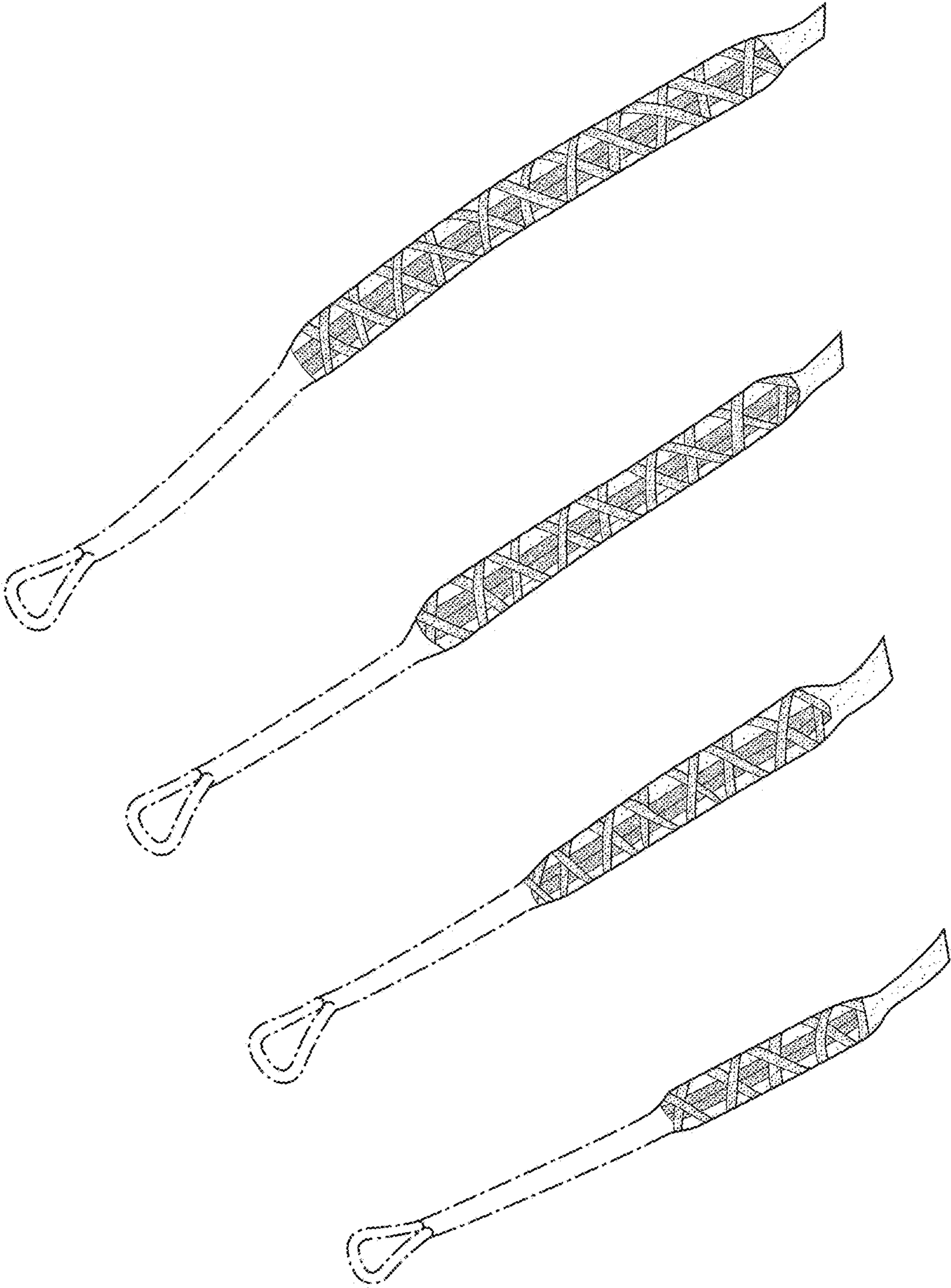

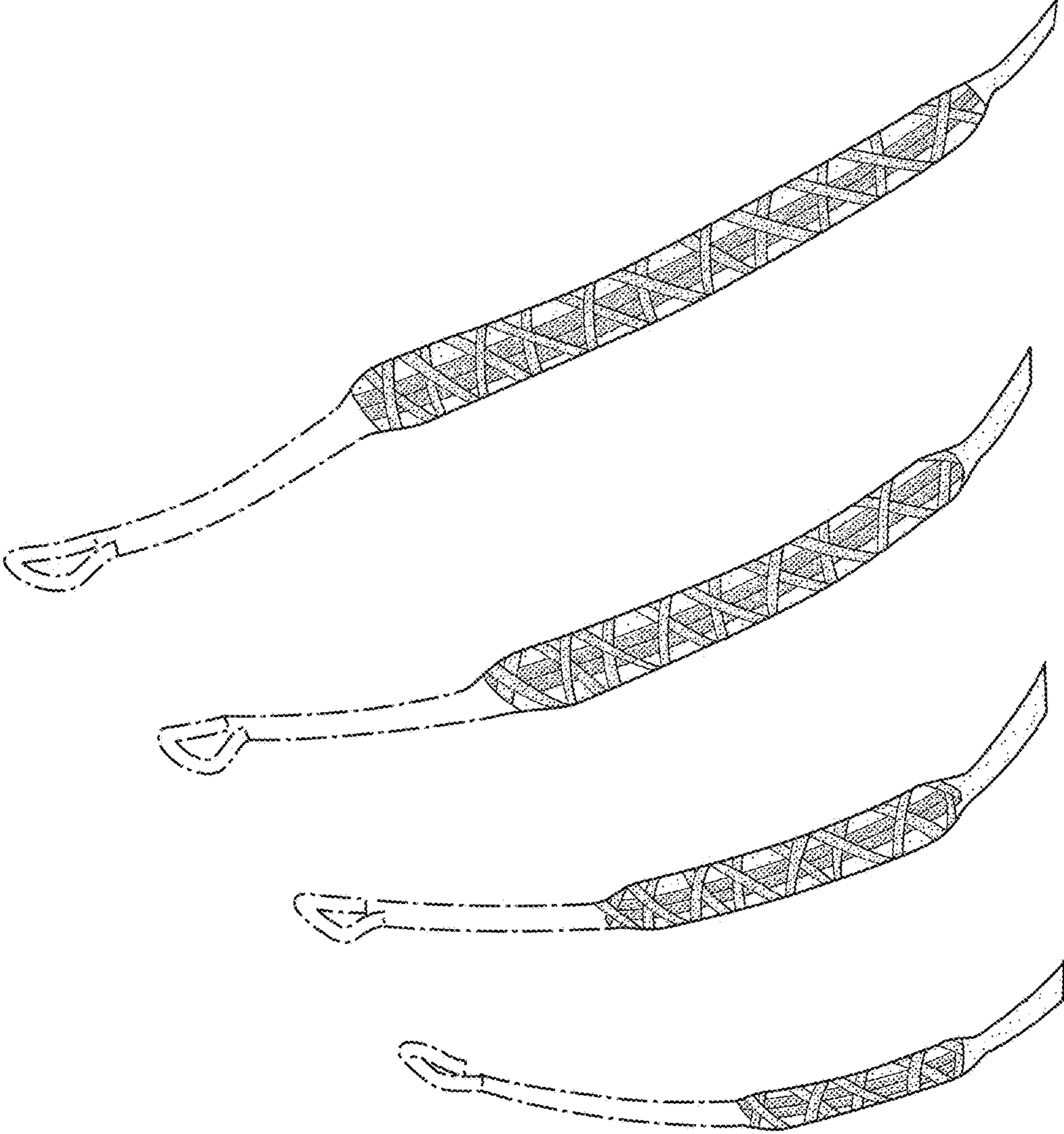
