(57) **CLAIM**

The ornamental design of a hybrid duffel bag with flip cover concealed zipper, as shown and described.

DESCRIPTION

FIG. 1 is a front, right, top perspective view of a hybrid duffel bag with flip cover concealed zipper, illustrating the novel design.

FIG. 2 is a right side view thereof.

FIG. 3 is a left side view thereof.

FIG. 4 is a front view thereof.

FIG. 5 is a back view thereof.

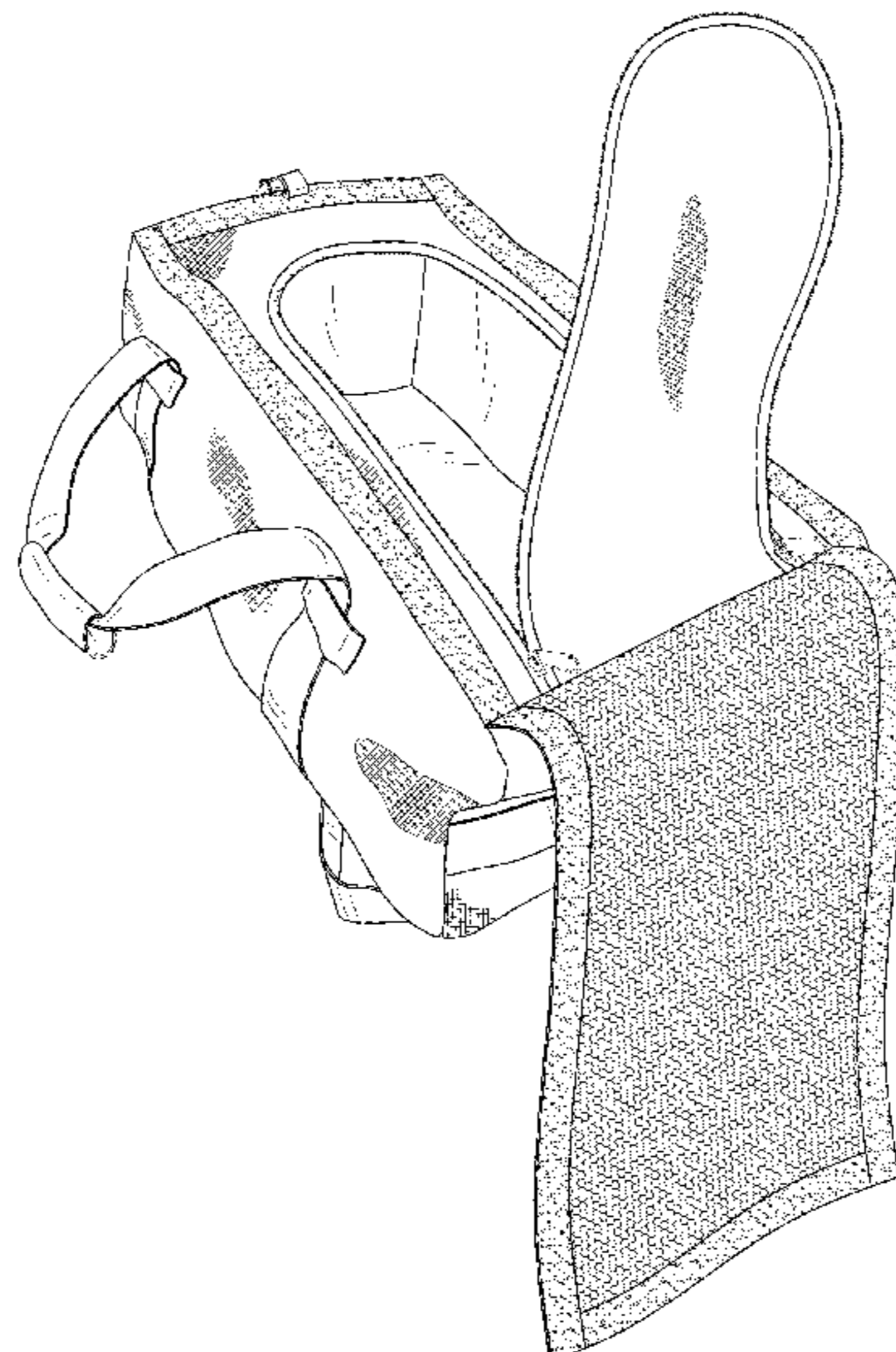
FIG. 6 is a top view thereof.

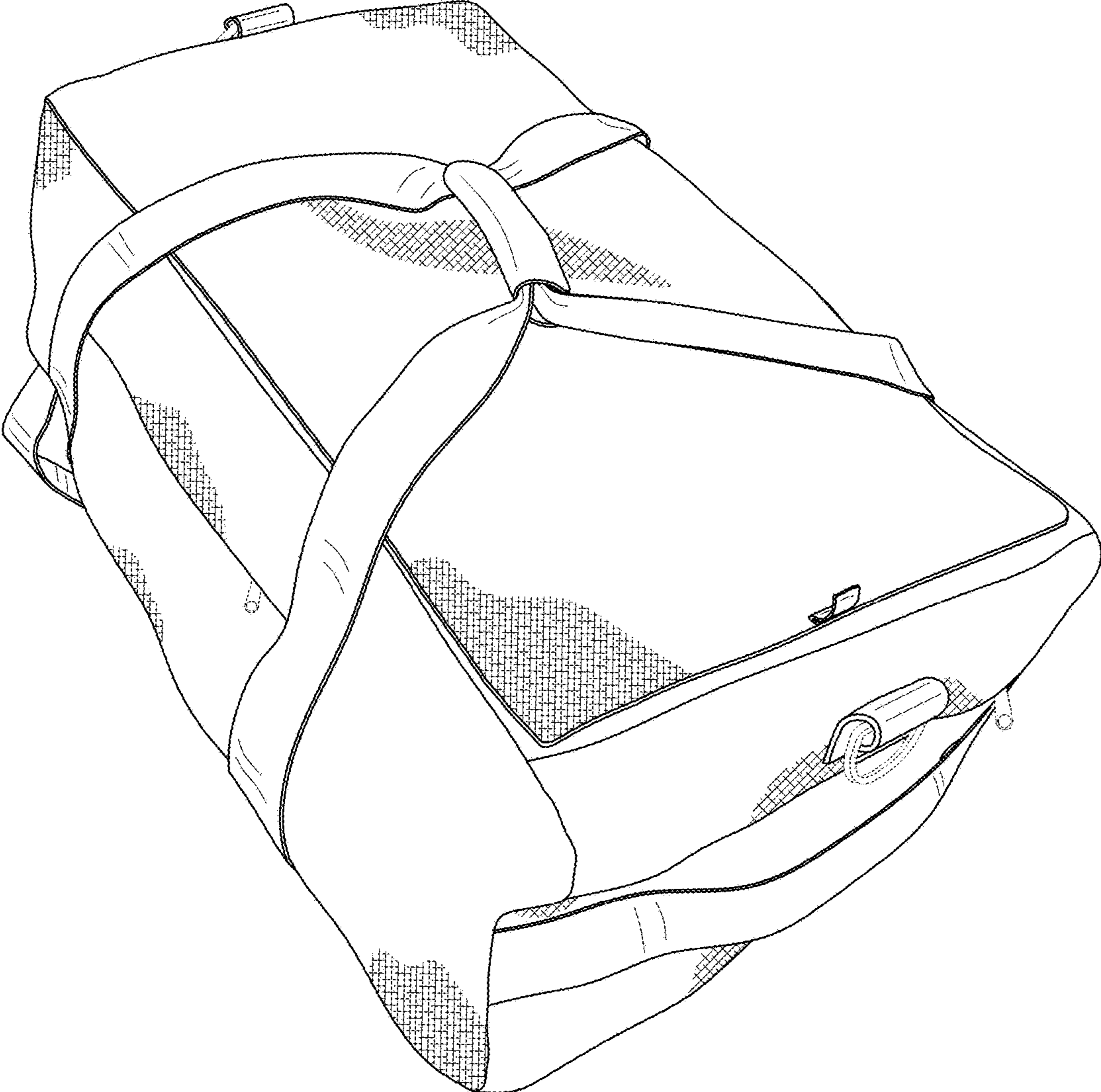

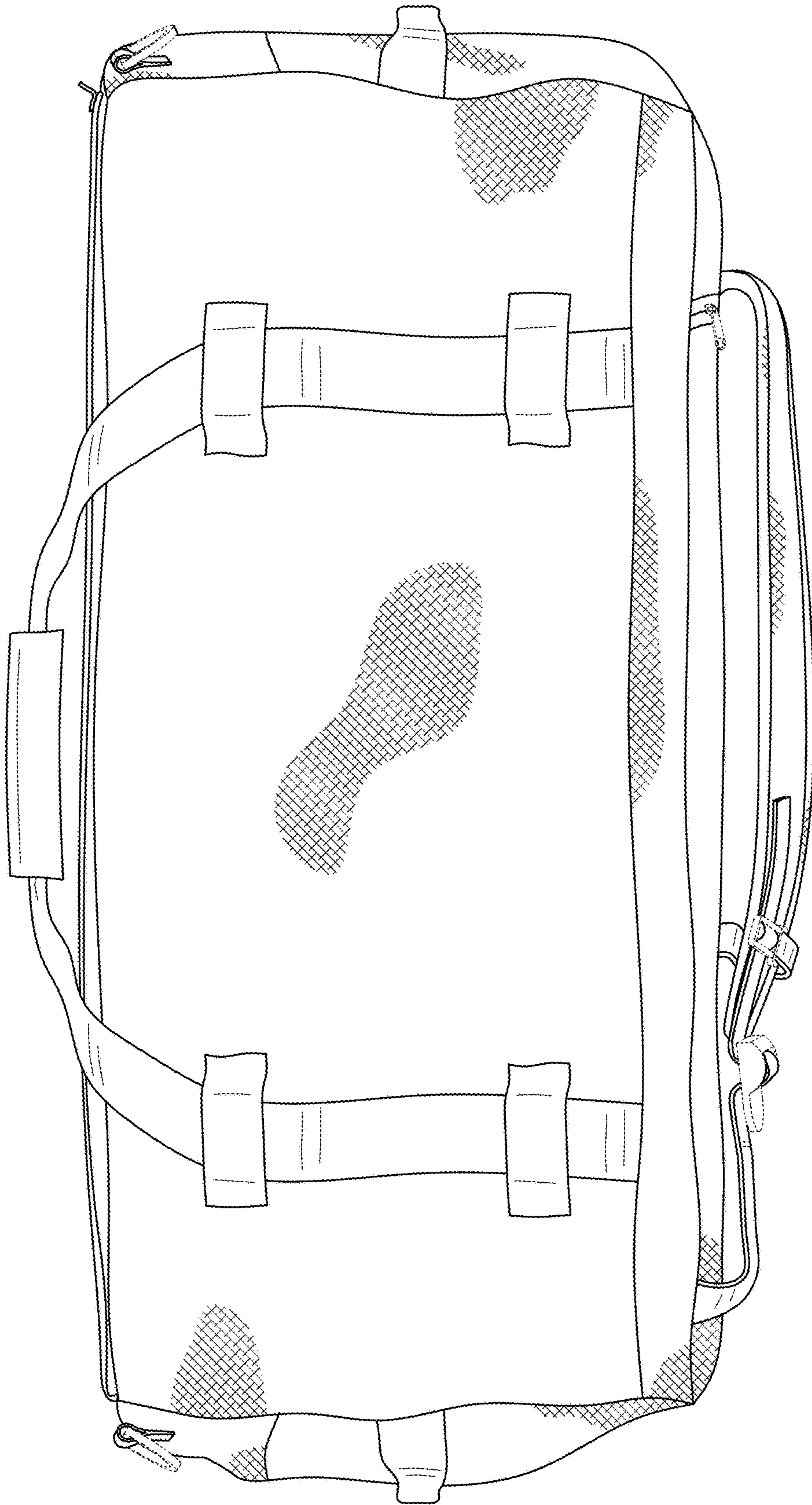

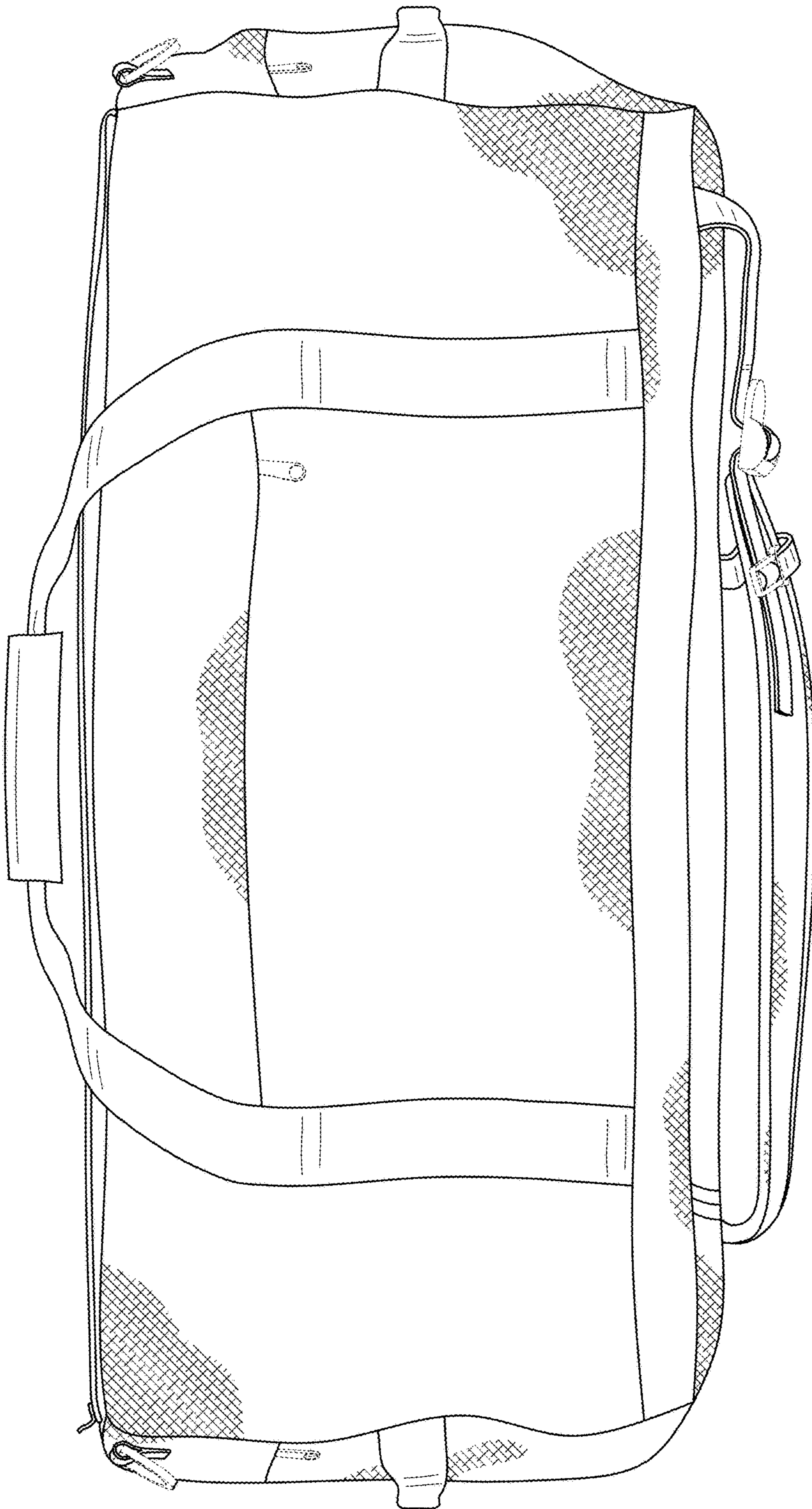

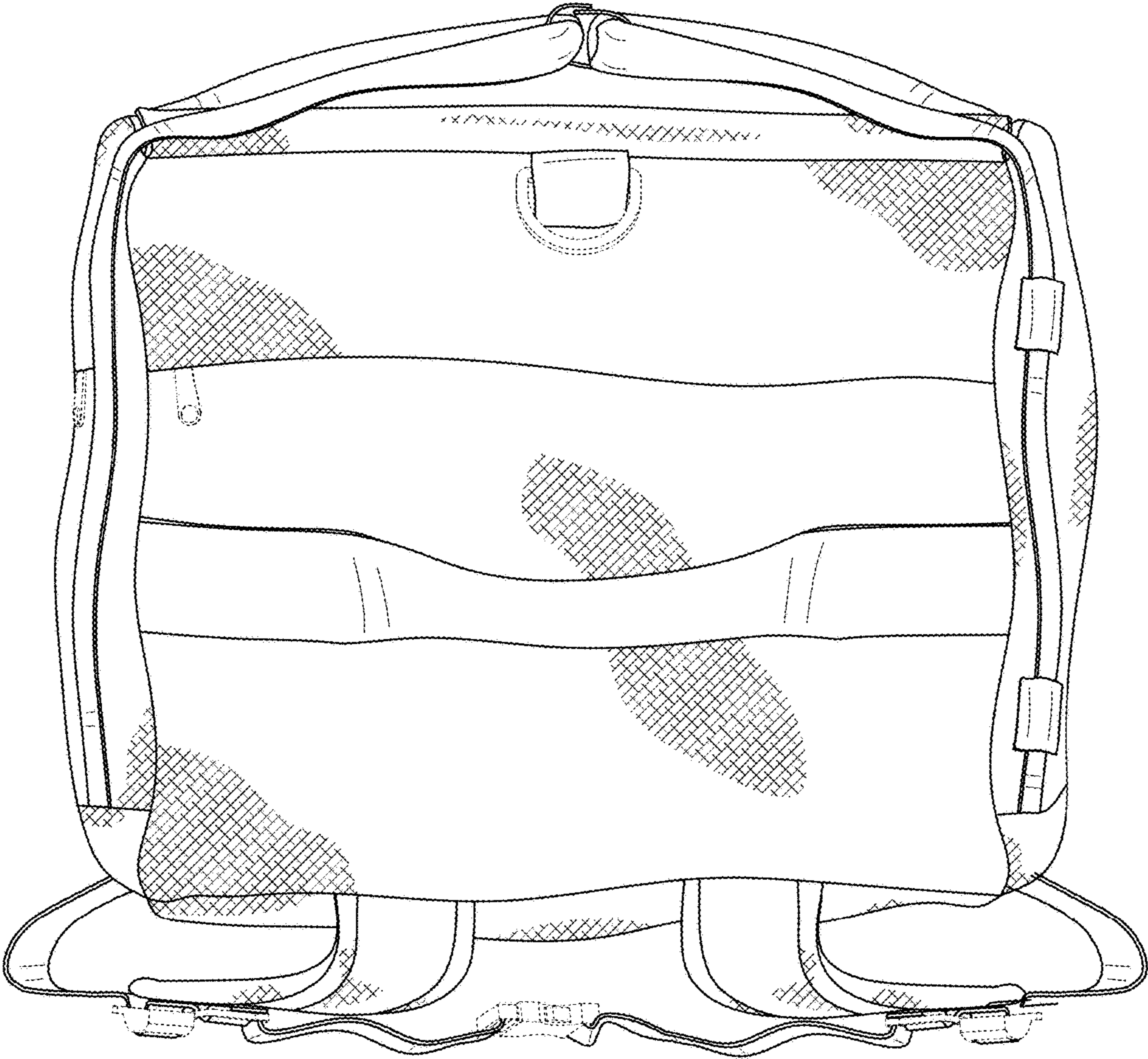

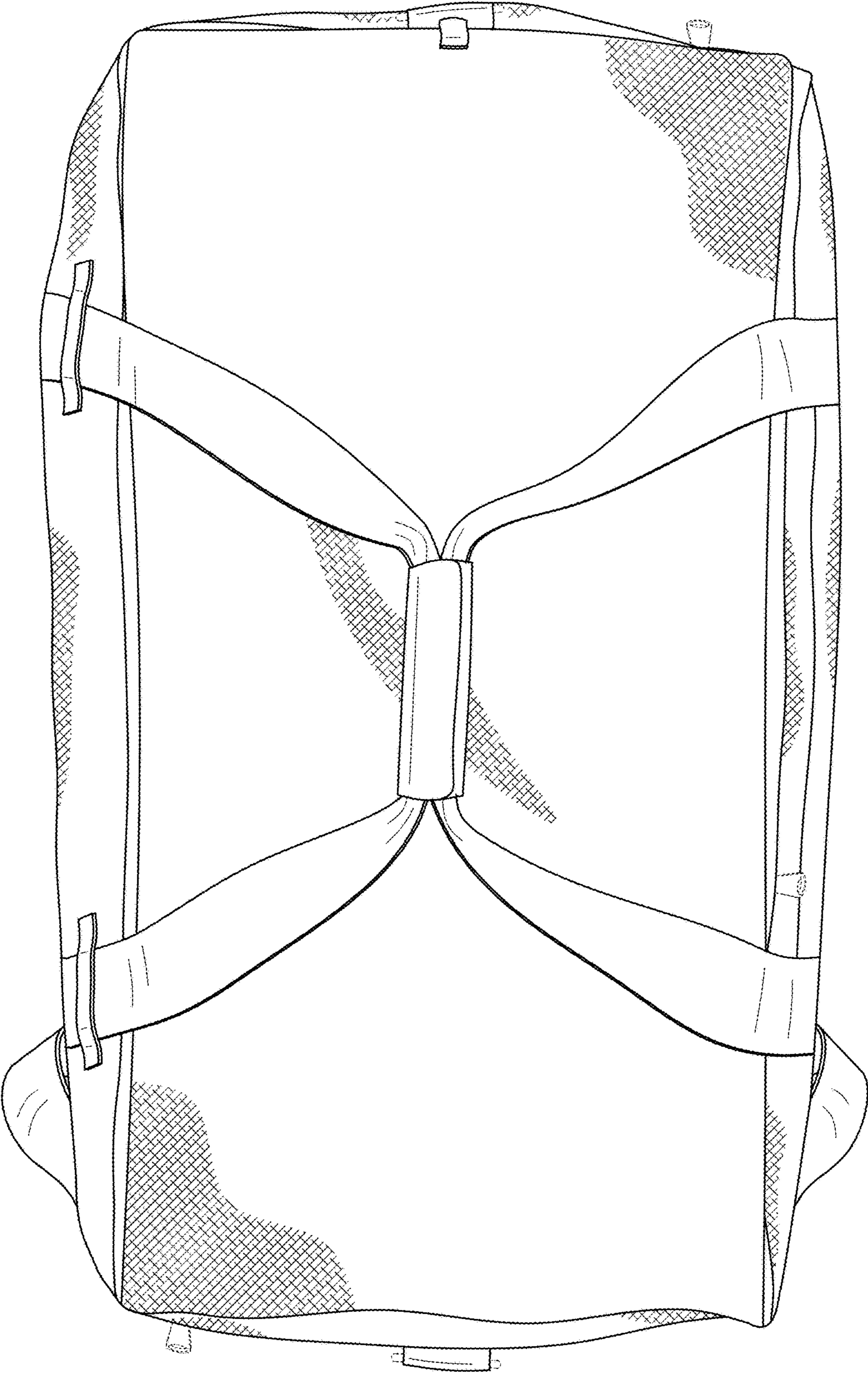

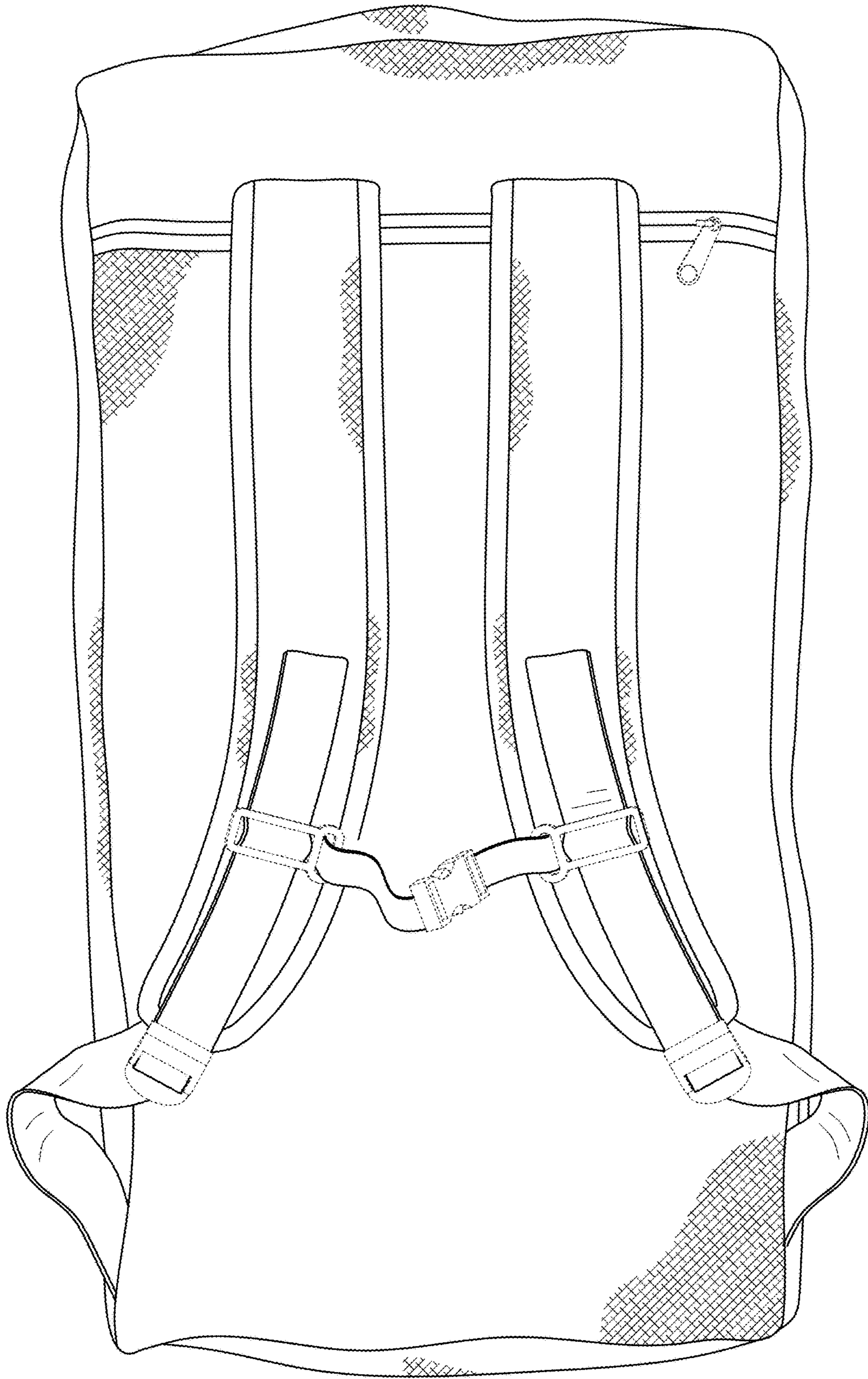

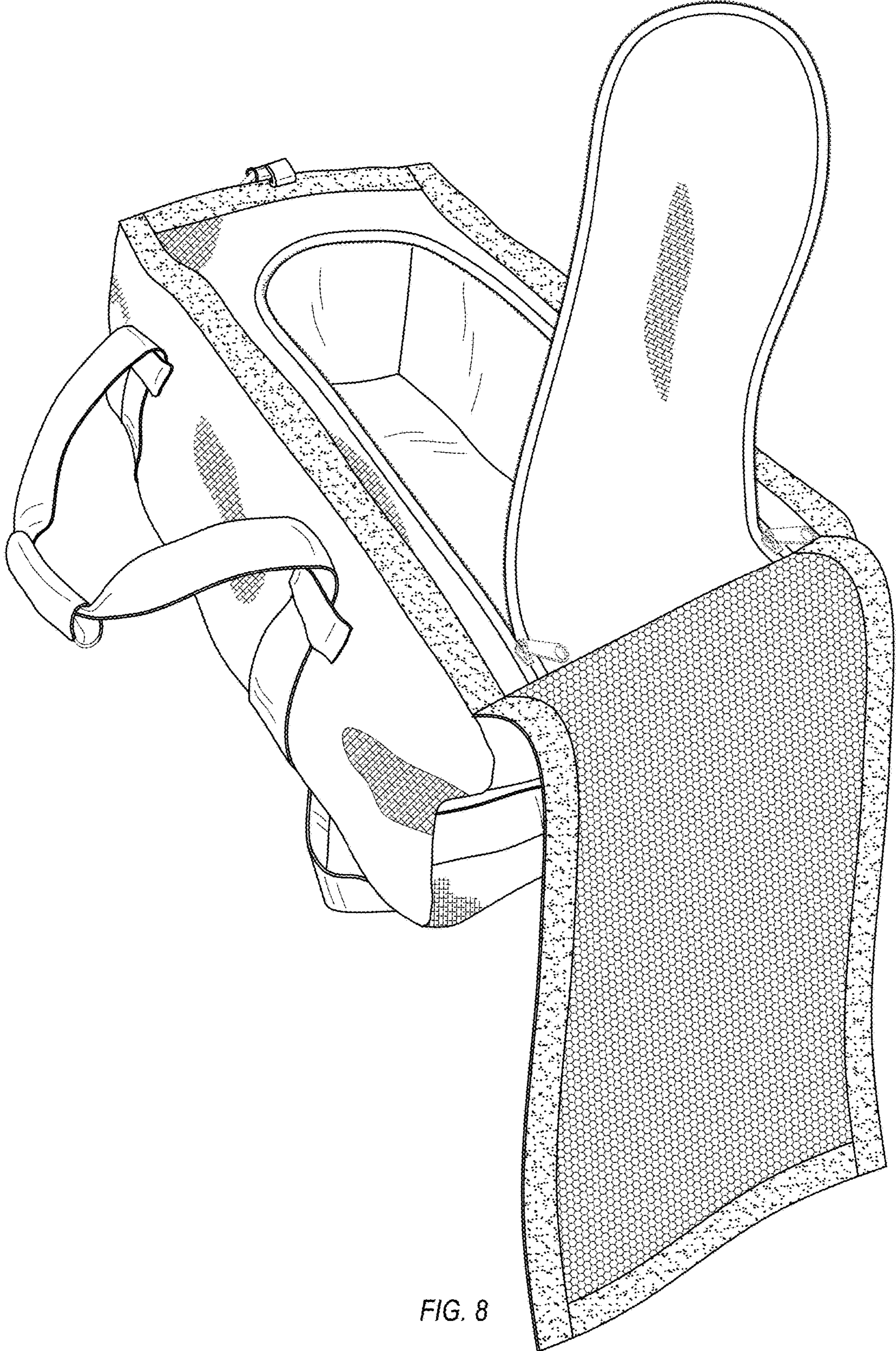
