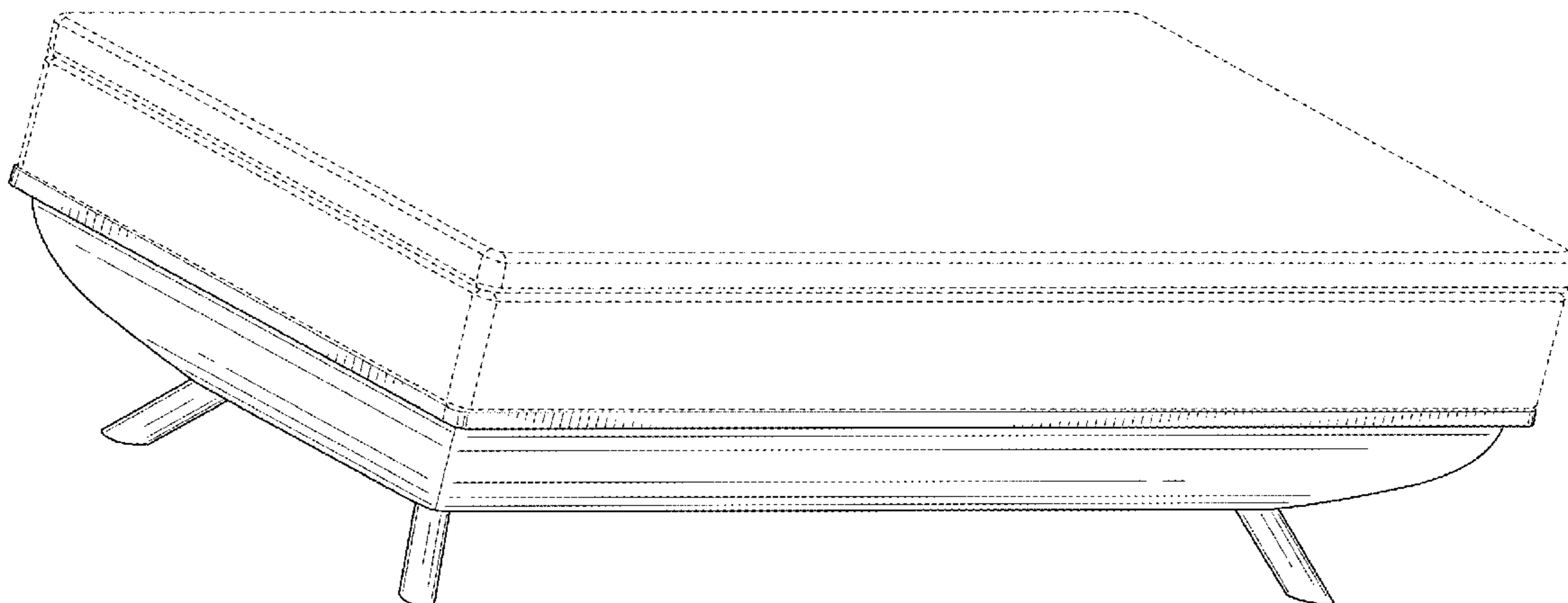
(57) **CLAIM**

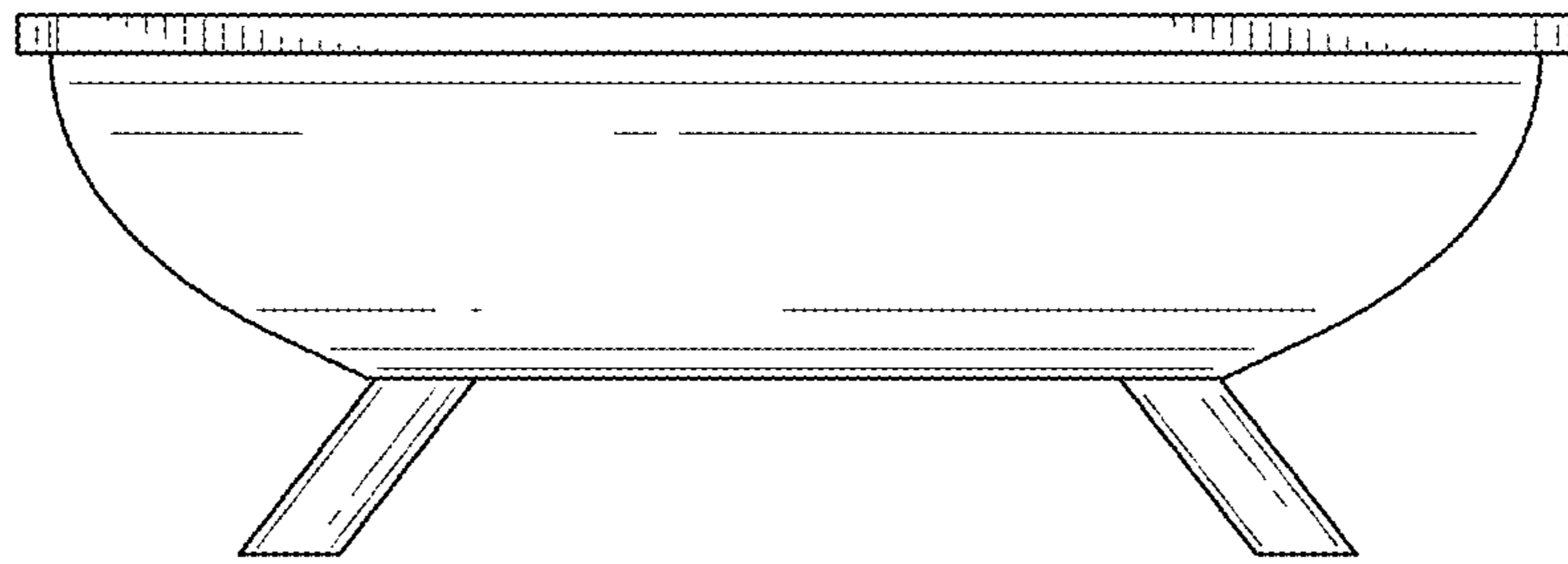
I claim, the ornamental design for a bed frame, as shown and described.

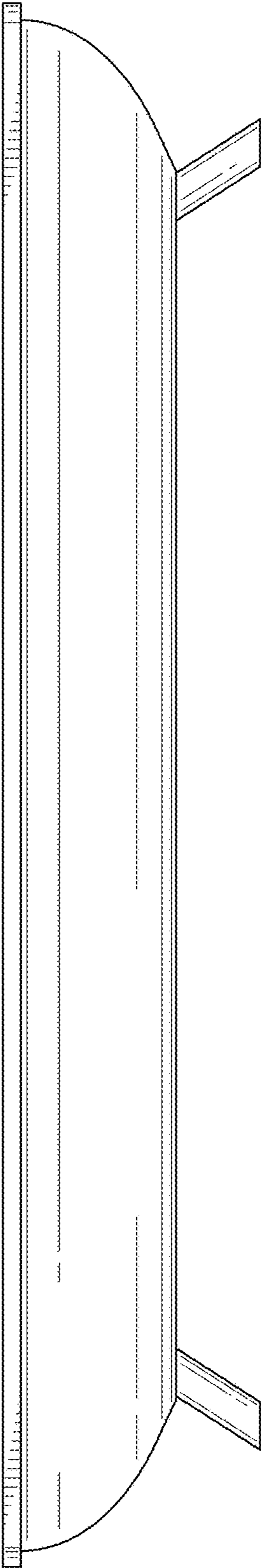

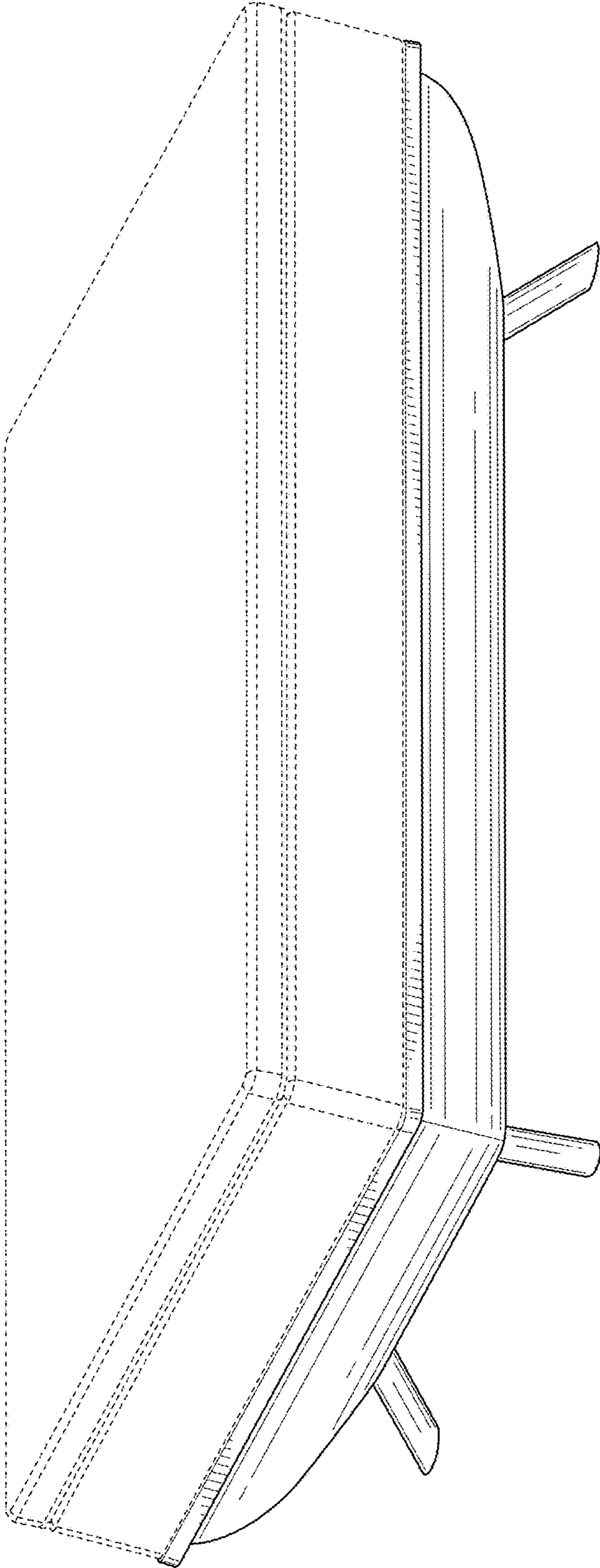

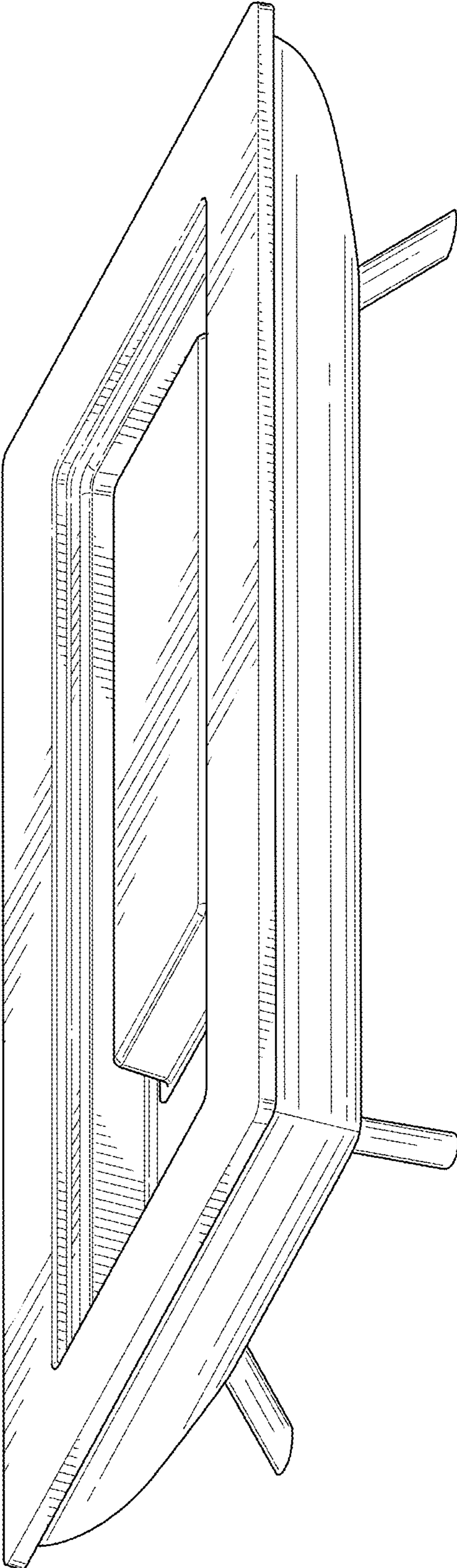

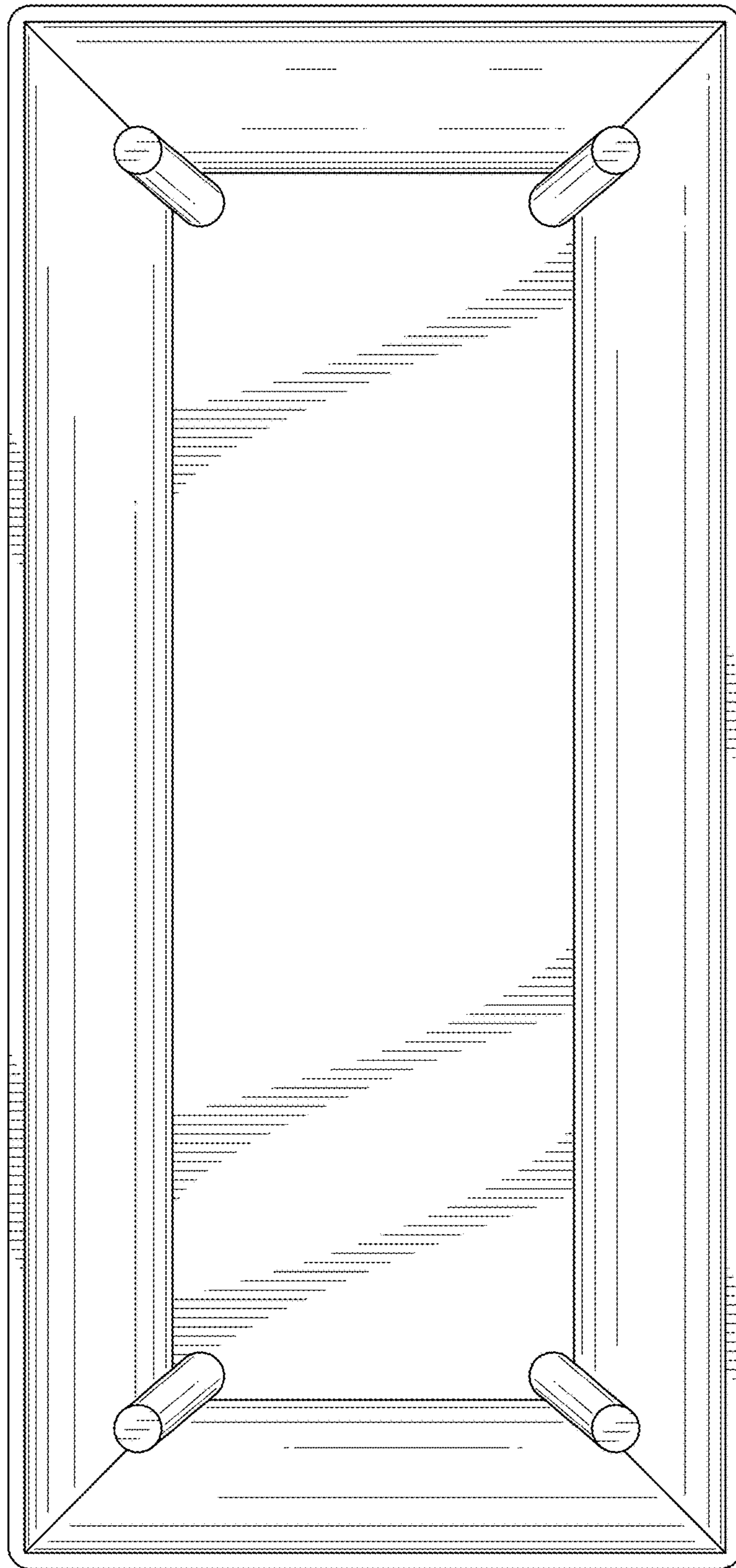
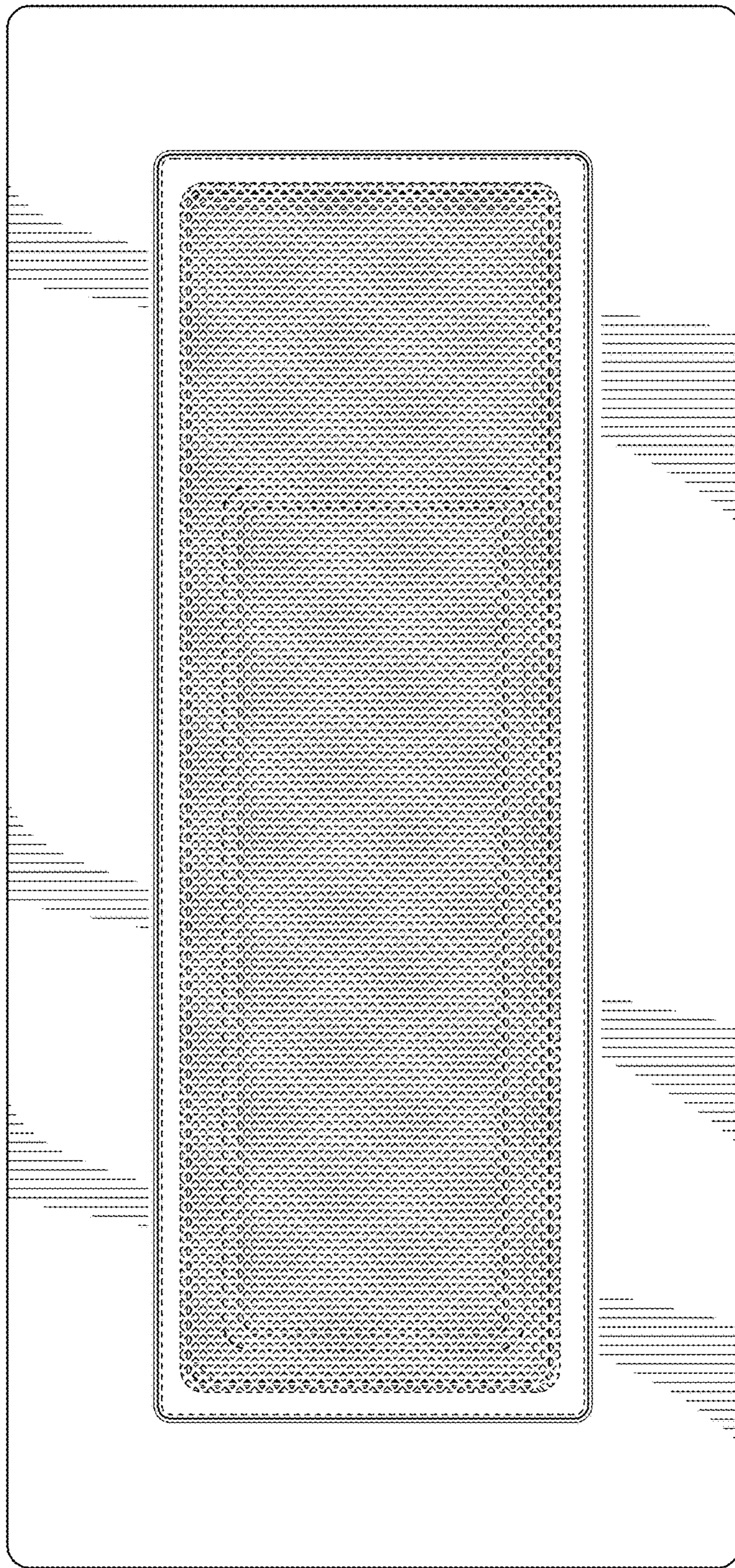
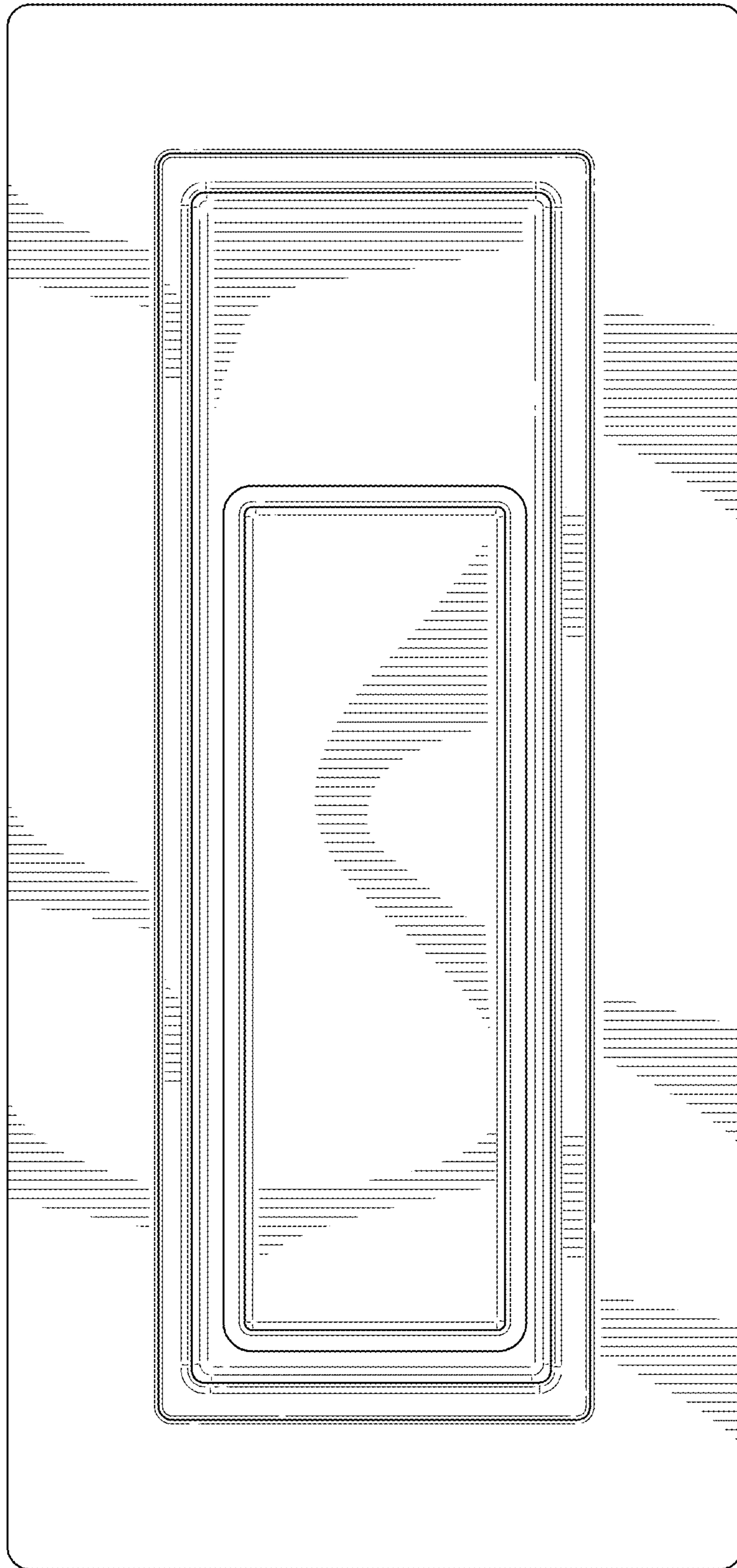
