**DESCRIPTION**

FIG. 1 is a top view of an interlockable bottle cap, showing my design;

FIG. 2 is a front view thereof, the rear view being a mirror image thereof;

FIG. 3 is a right side view thereof, the left side being a mirror image thereof;

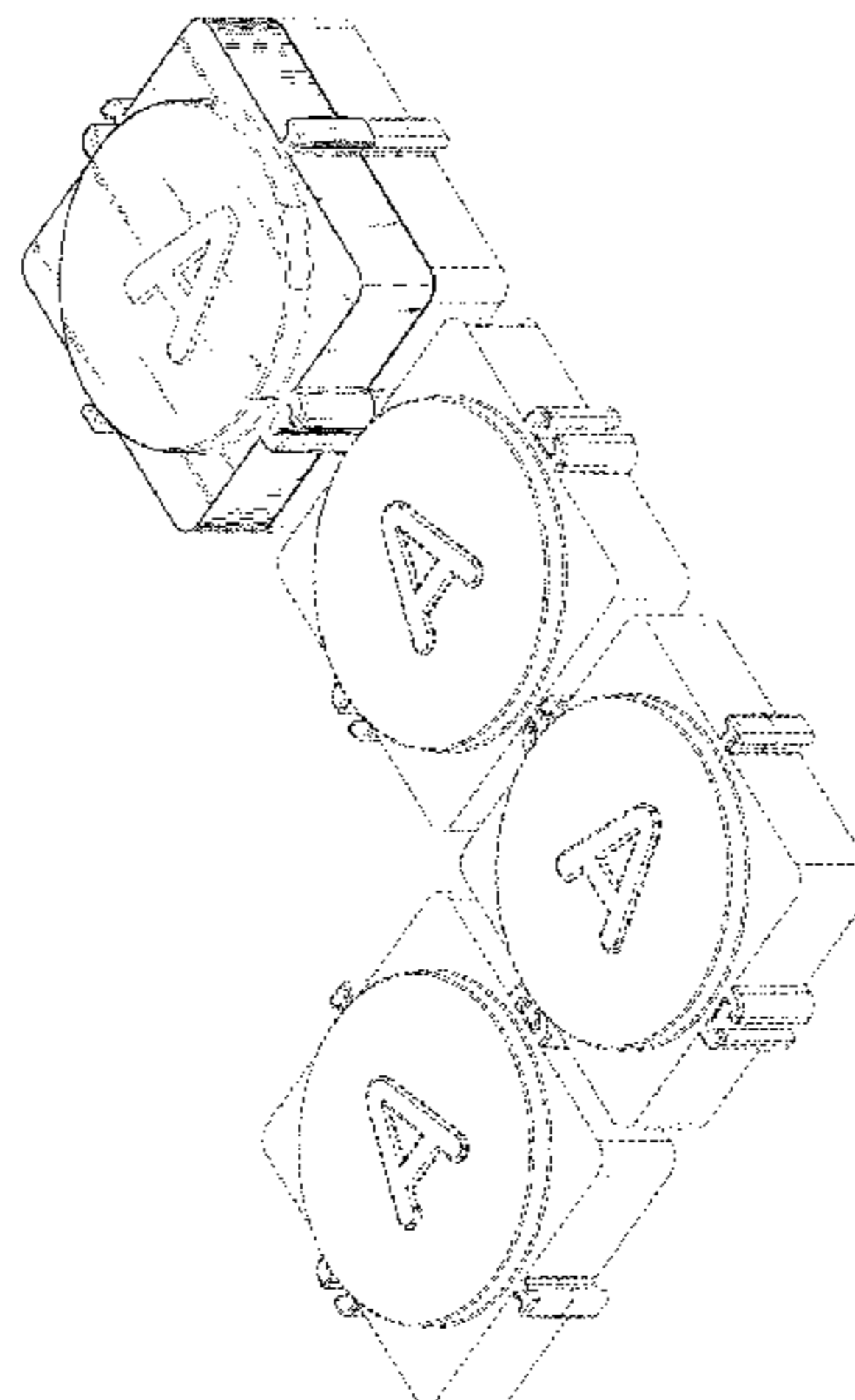
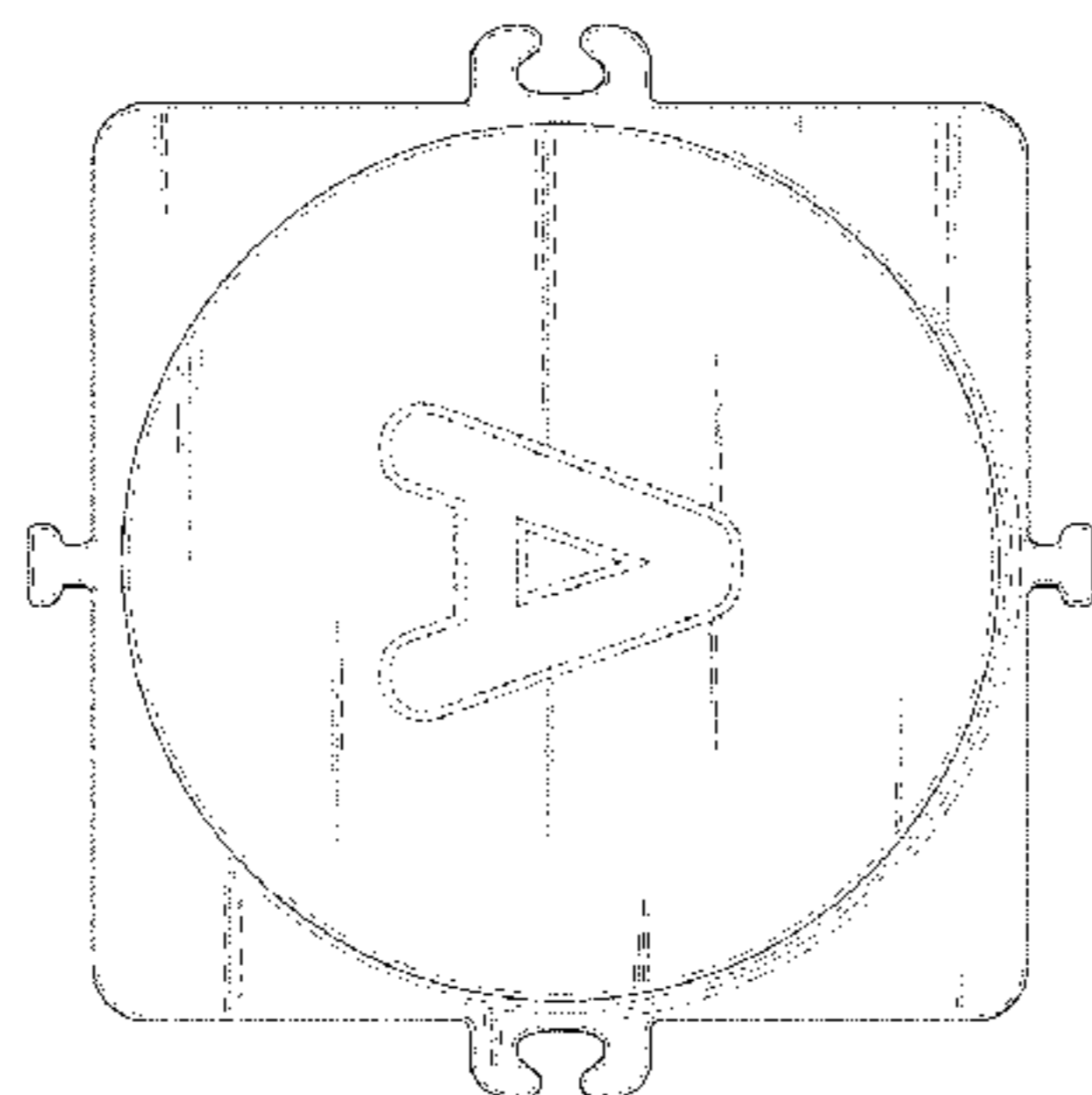
FIG. 4 is a bottom view thereof;

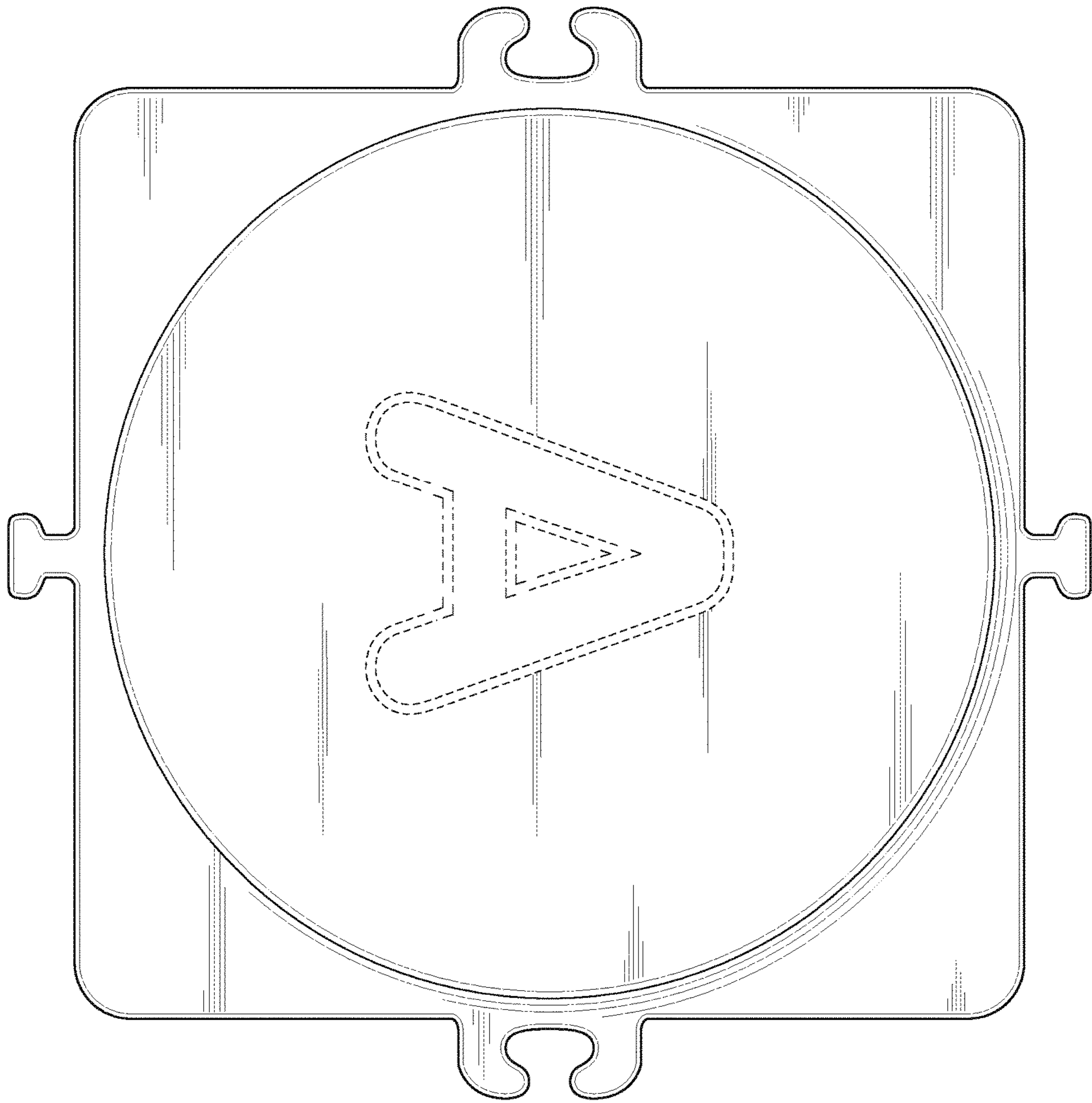
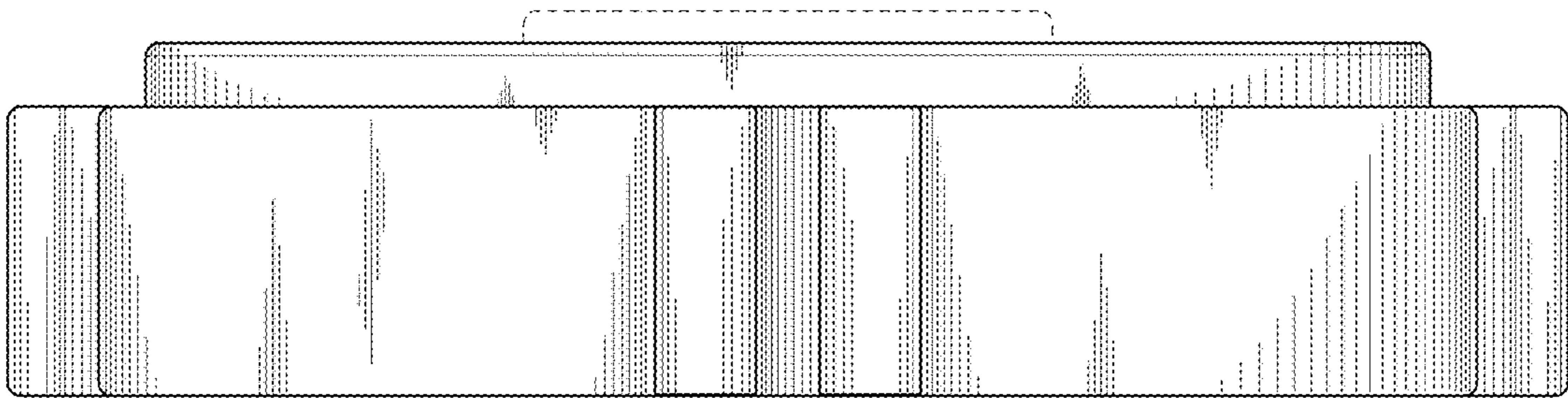
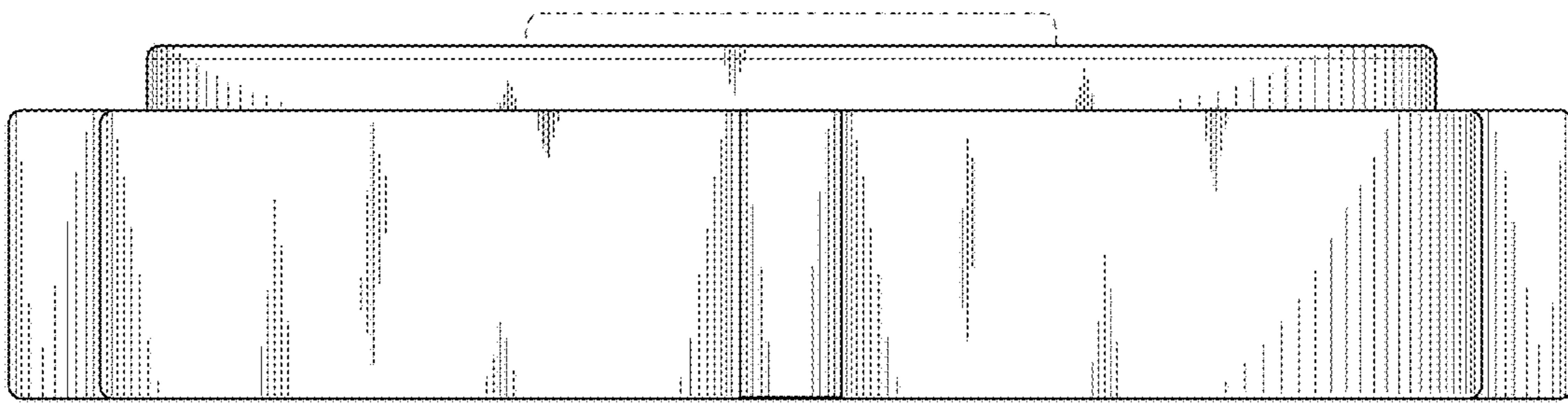

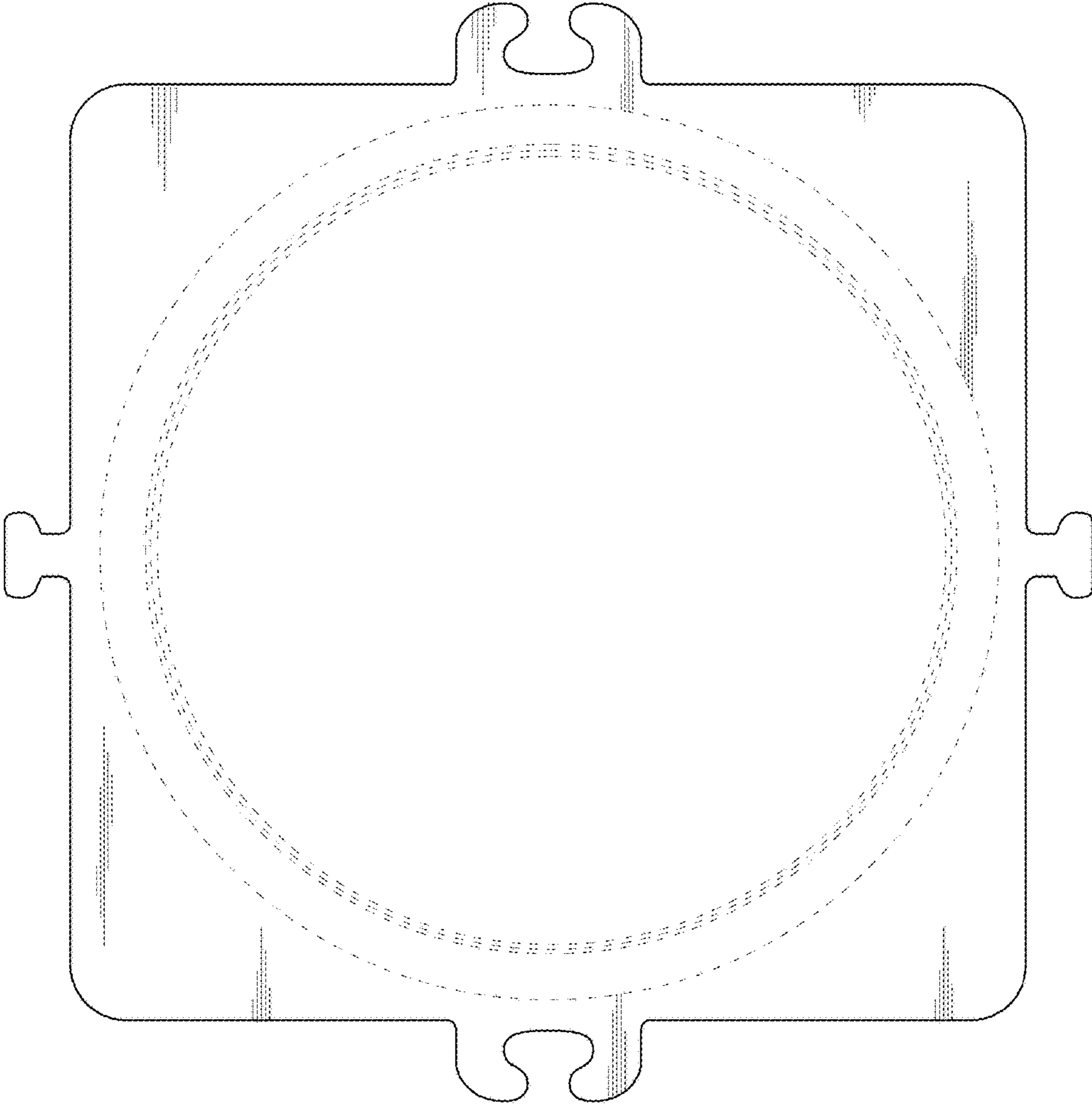

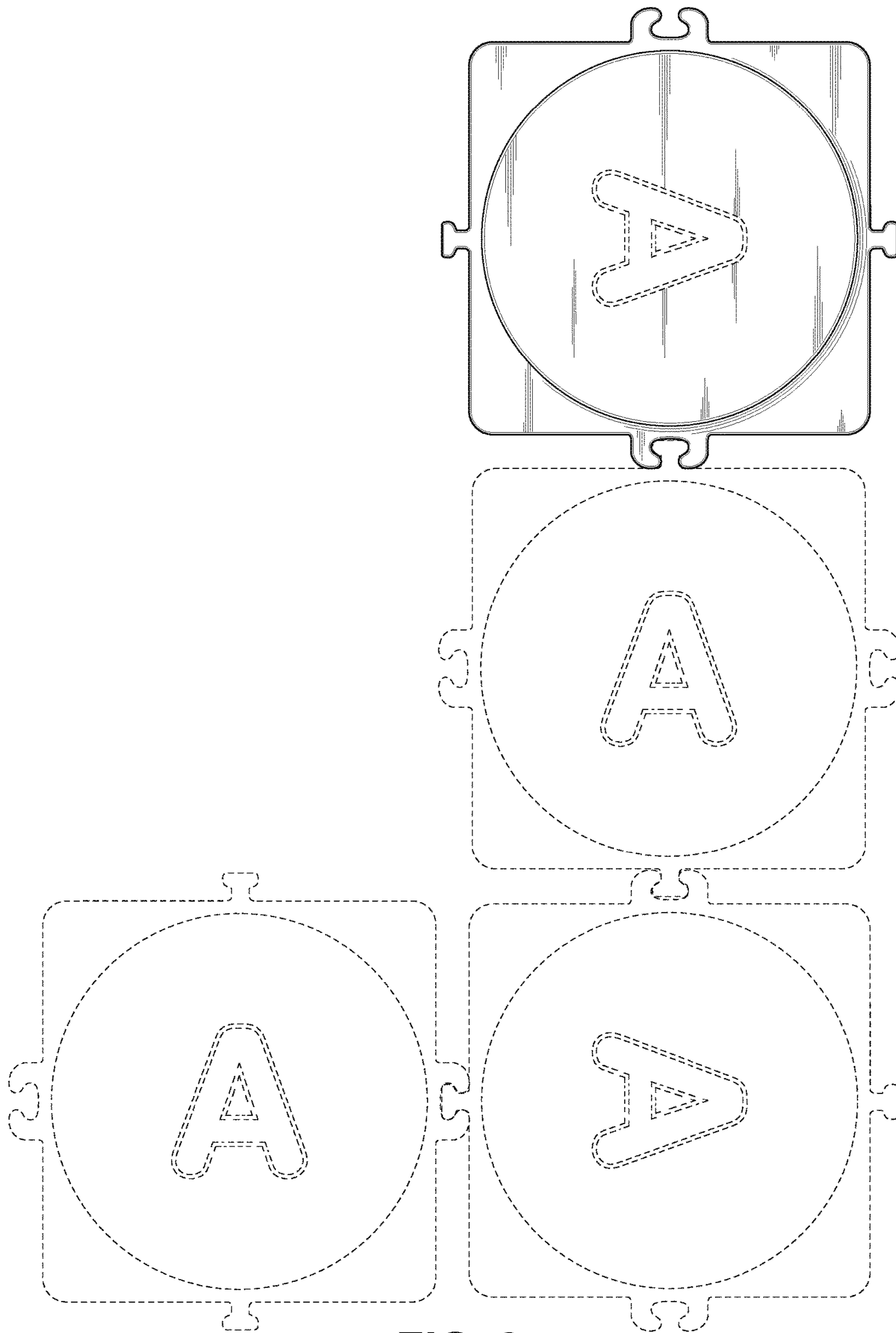
