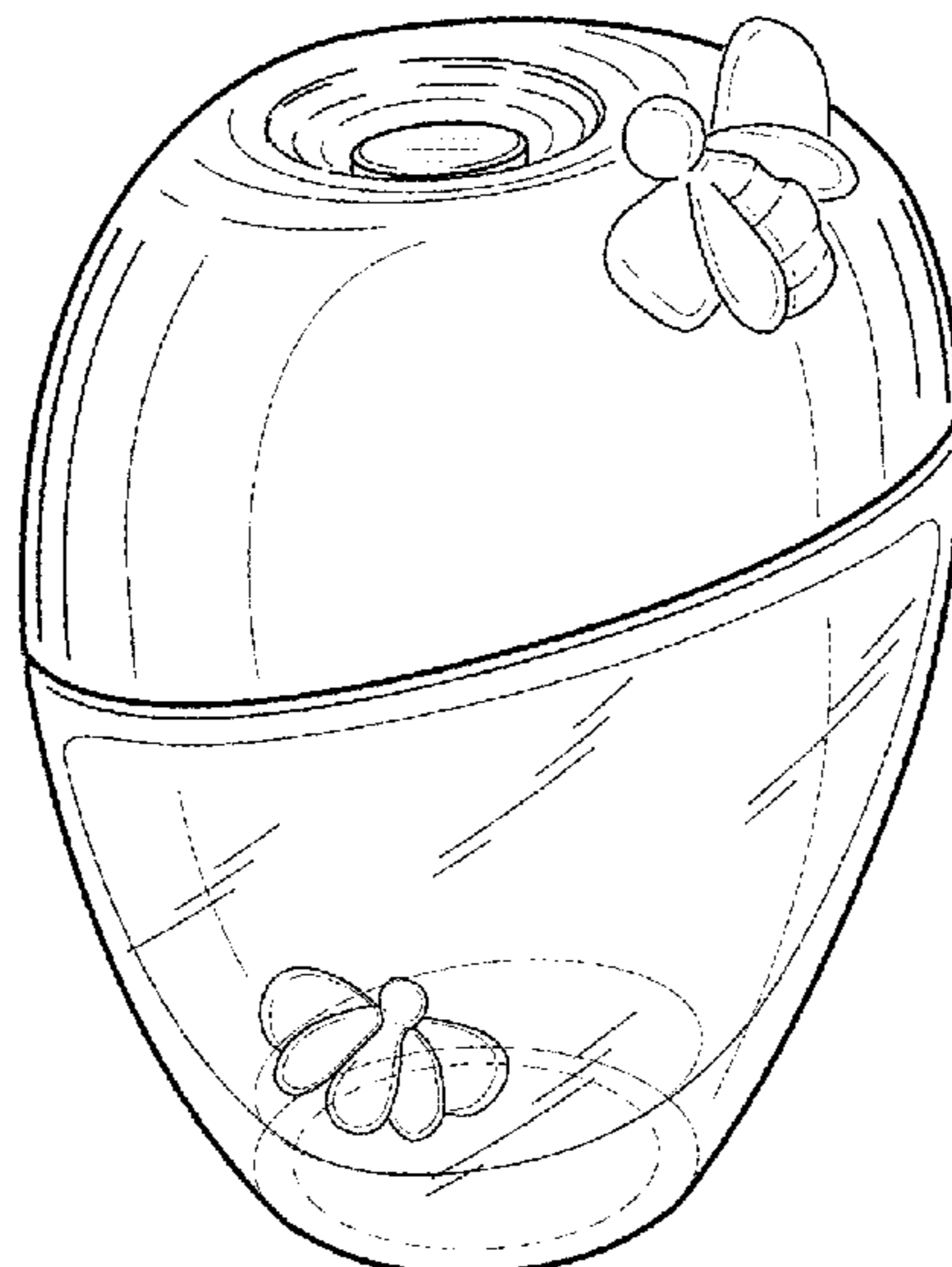
(57) **CLAIM**

The ornamental design for a fragrance bottle with cap, as shown.

DESCRIPTION

FIG. 1 is a top, front and left side perspective view of our new design for a fragrance bottle with cap;
FIG. 2 is a top, front and right side perspective view of our new design for a fragrance bottle with cap;
FIG. 3 is a front elevation view of the fragrance bottle with cap, shown in FIG. 1;
FIG. 4 is a rear elevation view of the fragrance bottle with cap, shown in FIG. 1;
FIG. 5 is a right side elevation view of the fragrance bottle with cap, shown in FIG. 1;
FIG. 6 is a left side elevation view of the fragrance bottle with cap, shown in FIG. 1;
FIG. 7 is a top plan view of the fragrance bottle with cap, shown in FIG. 1; and,
FIG. 8 is a bottom plan view of the fragrance bottle with cap, shown in FIG. 1.

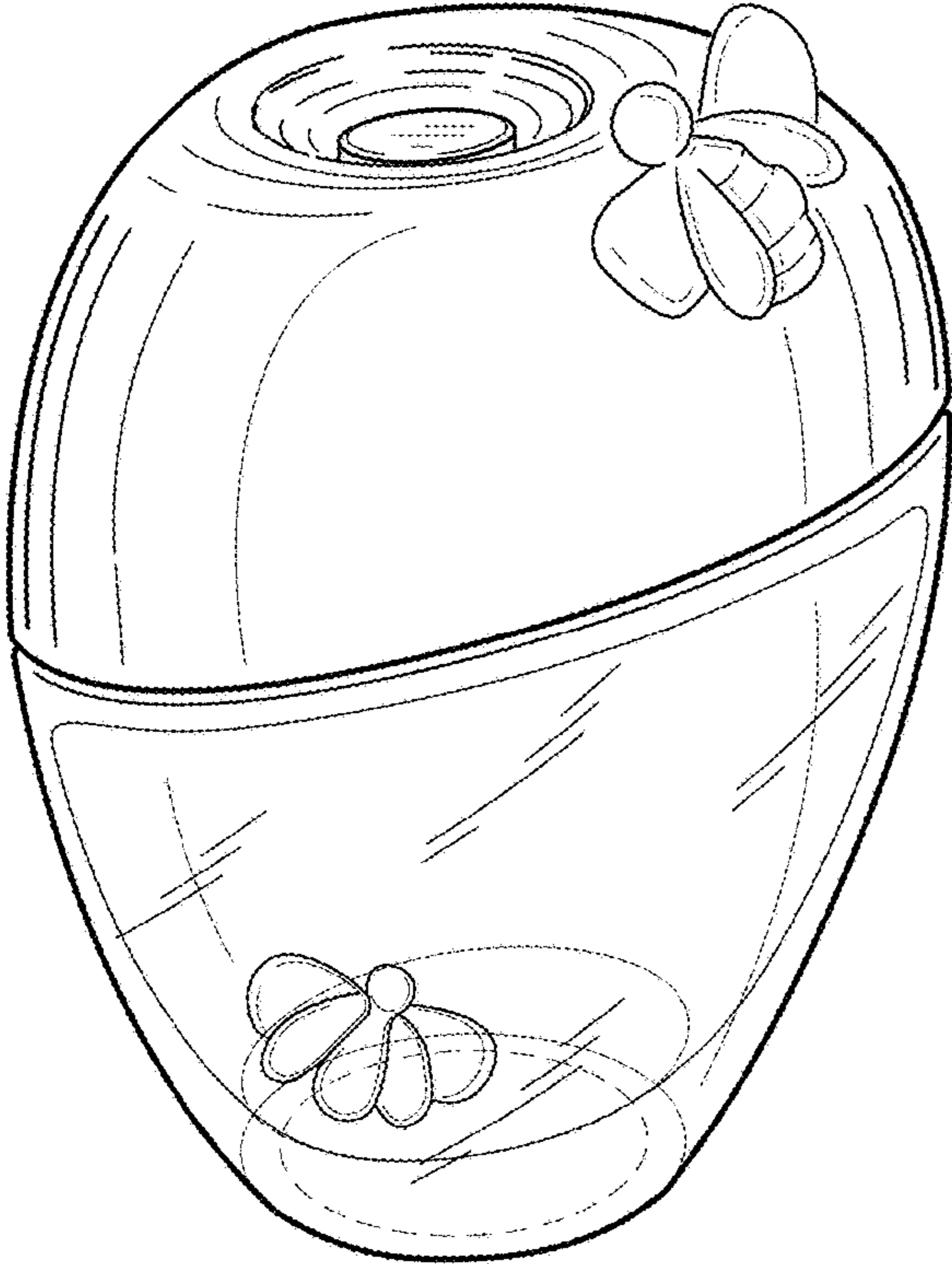

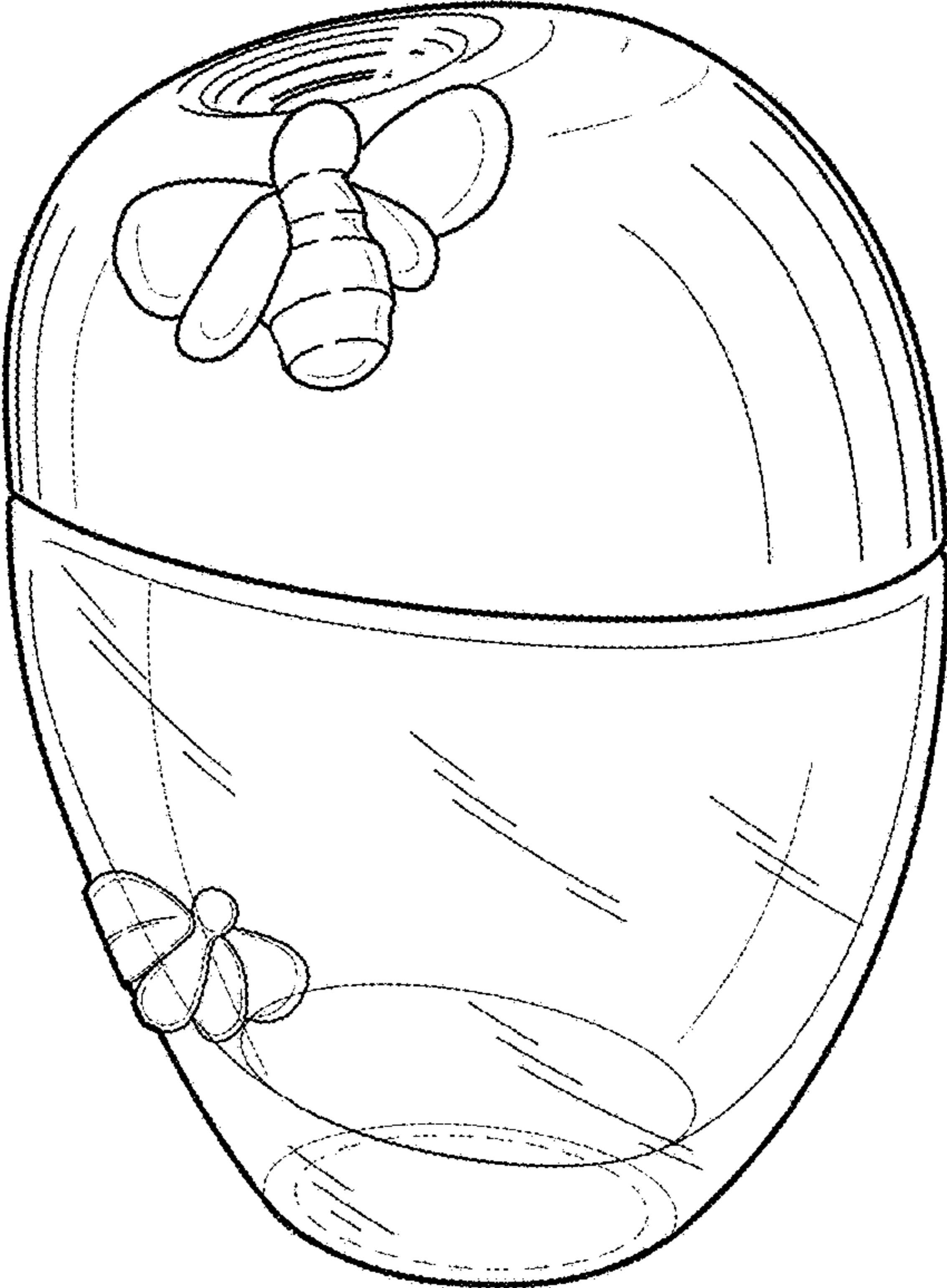

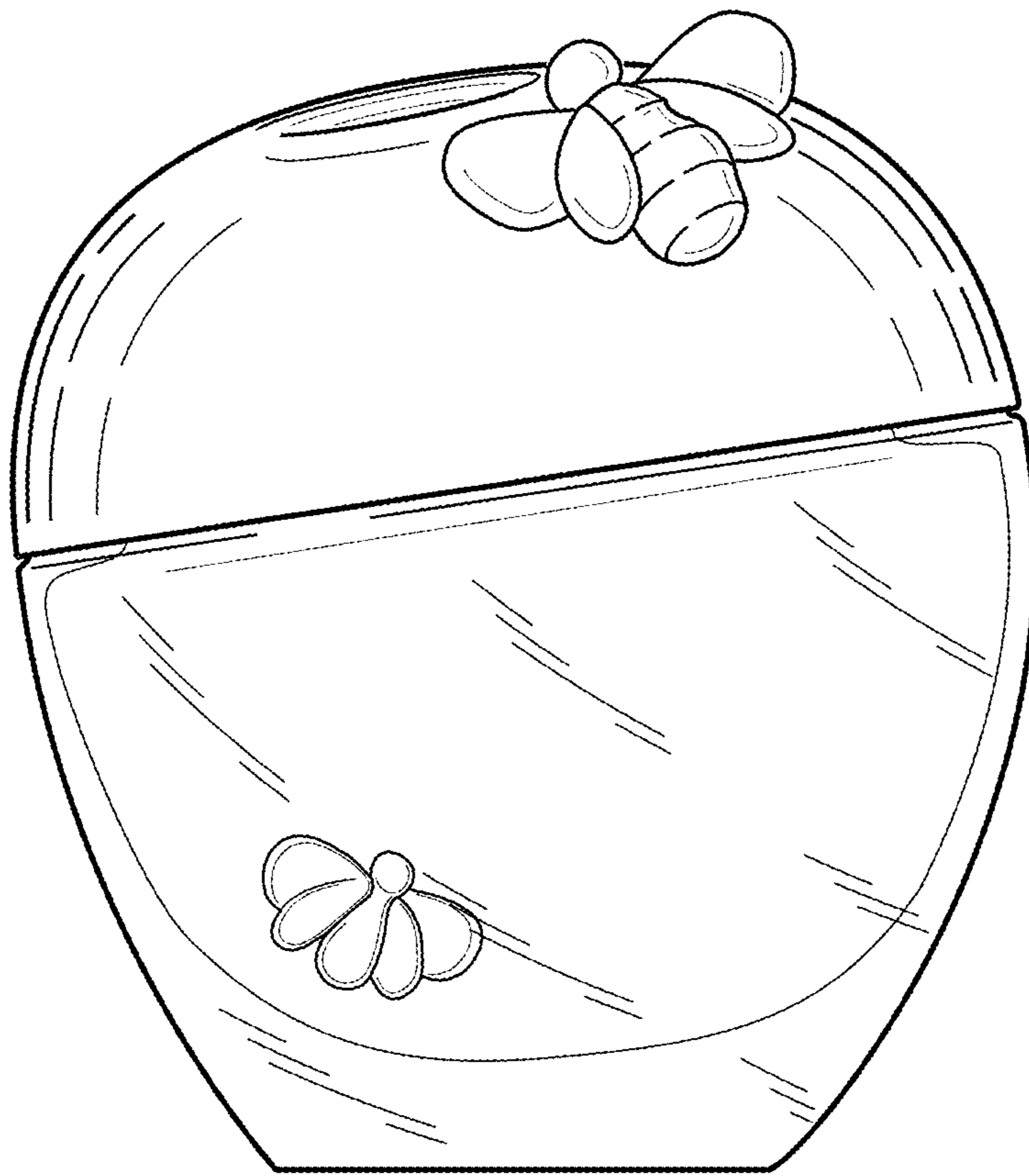

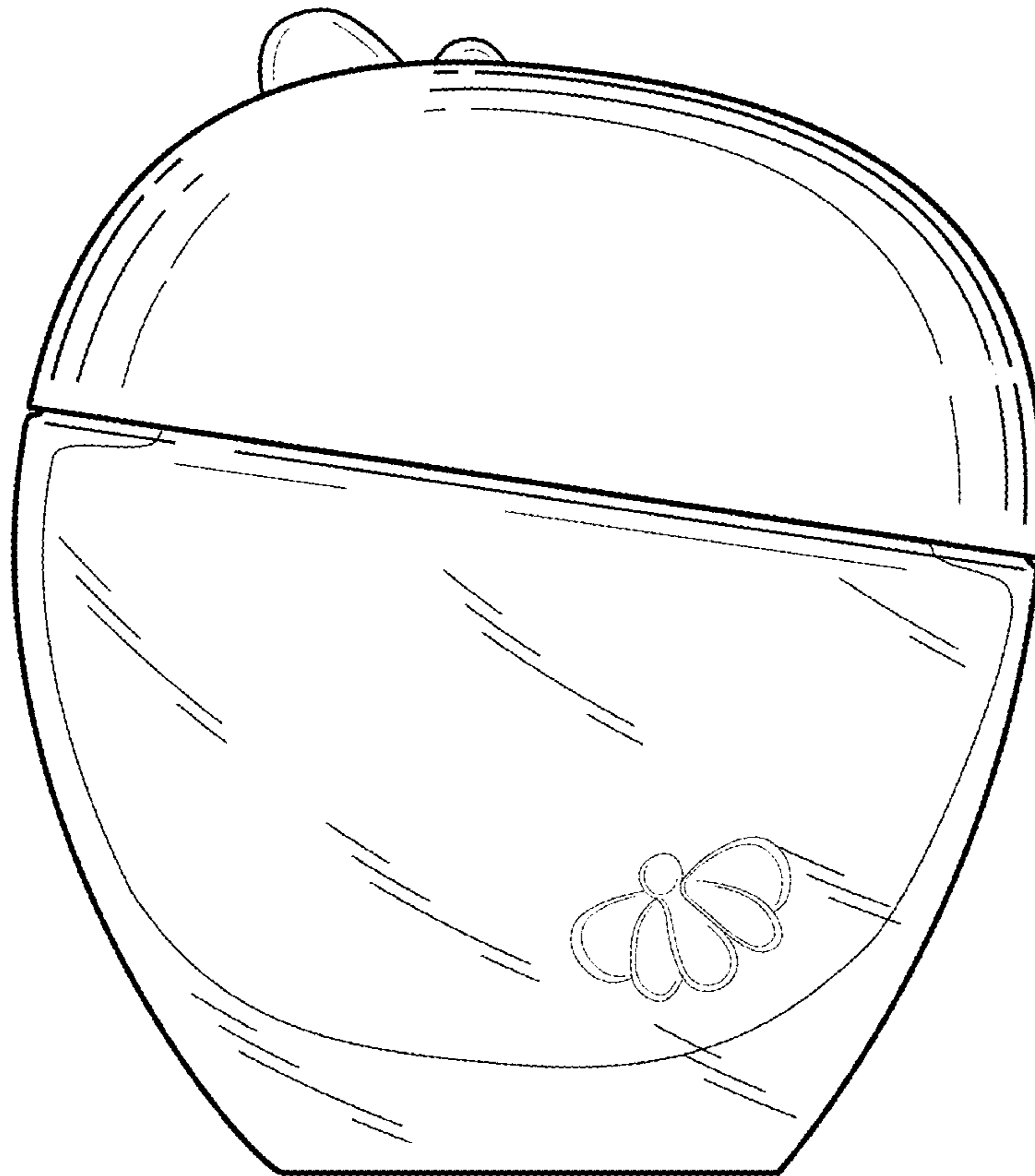

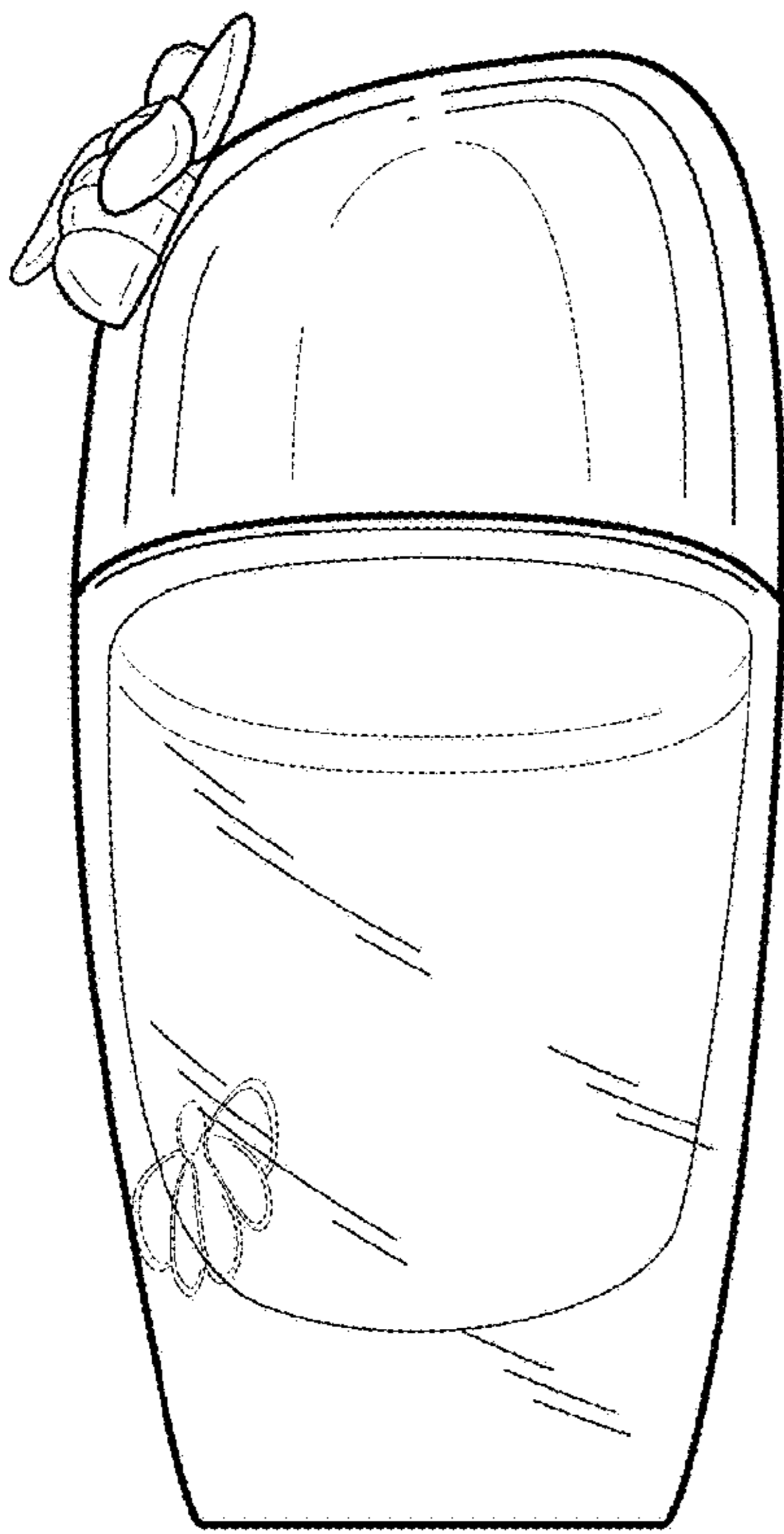

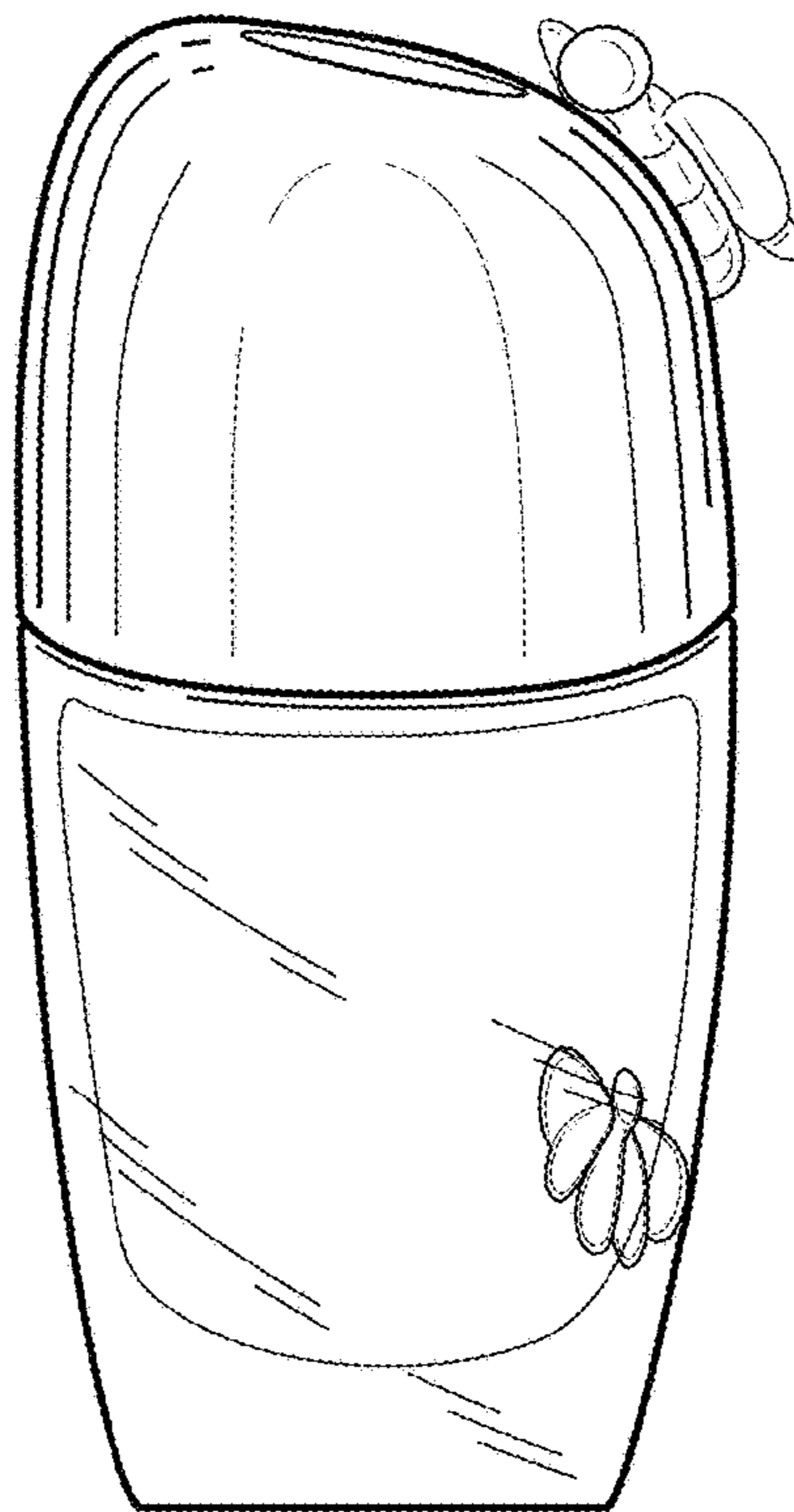

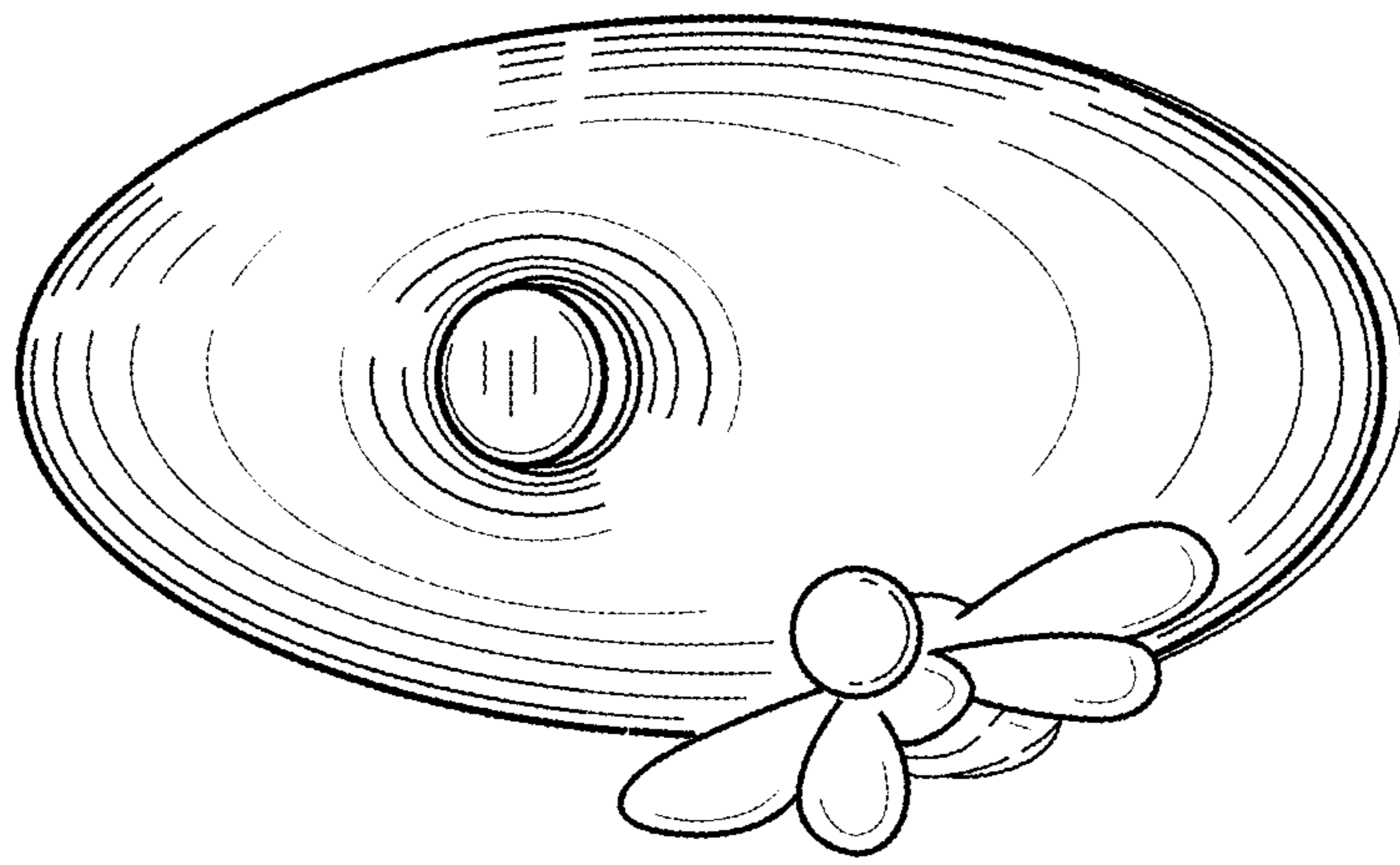
