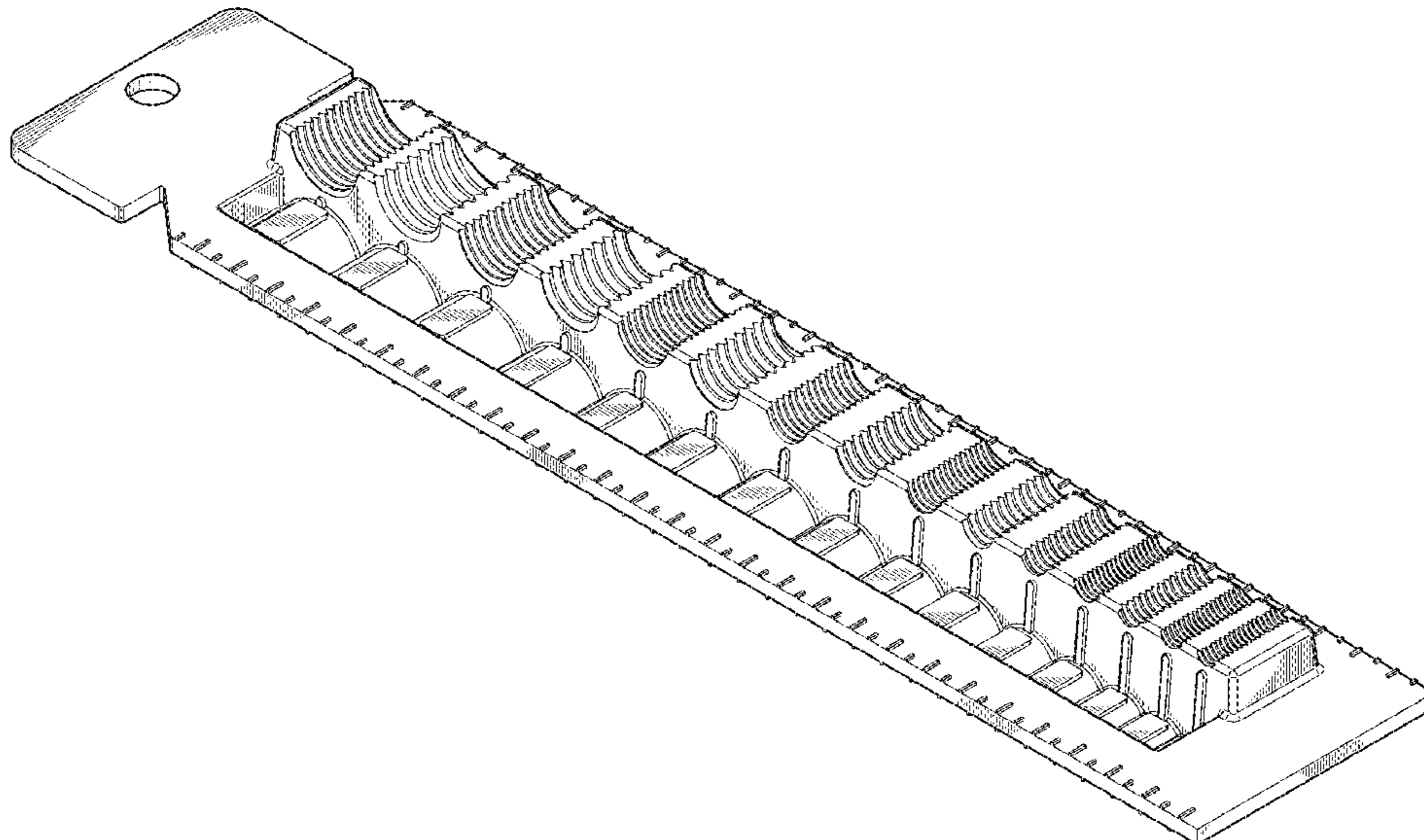
(57) **CLAIM**

The ornamental design for a bolt sorter, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of a bolt sorter looking towards a top side;

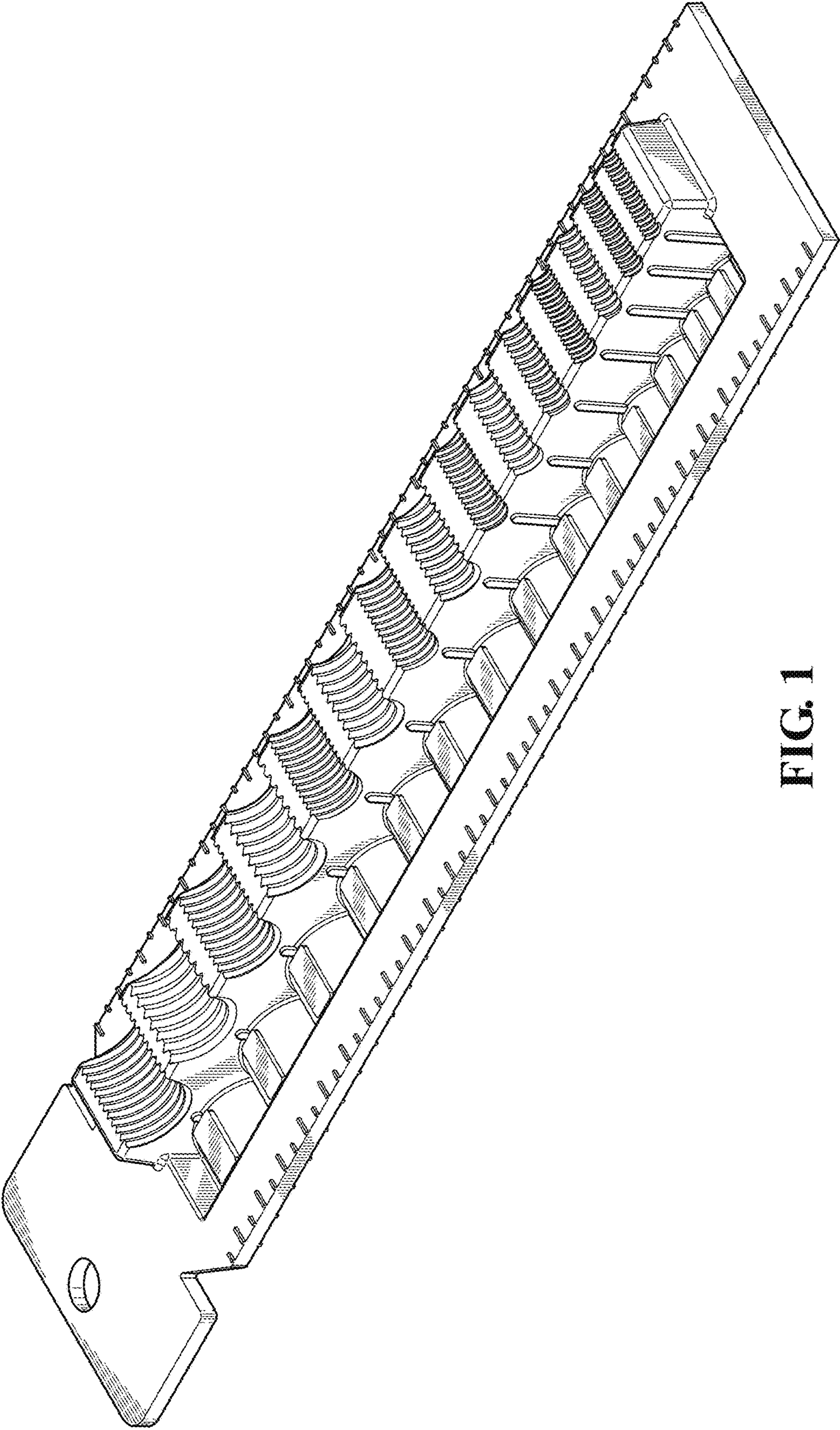

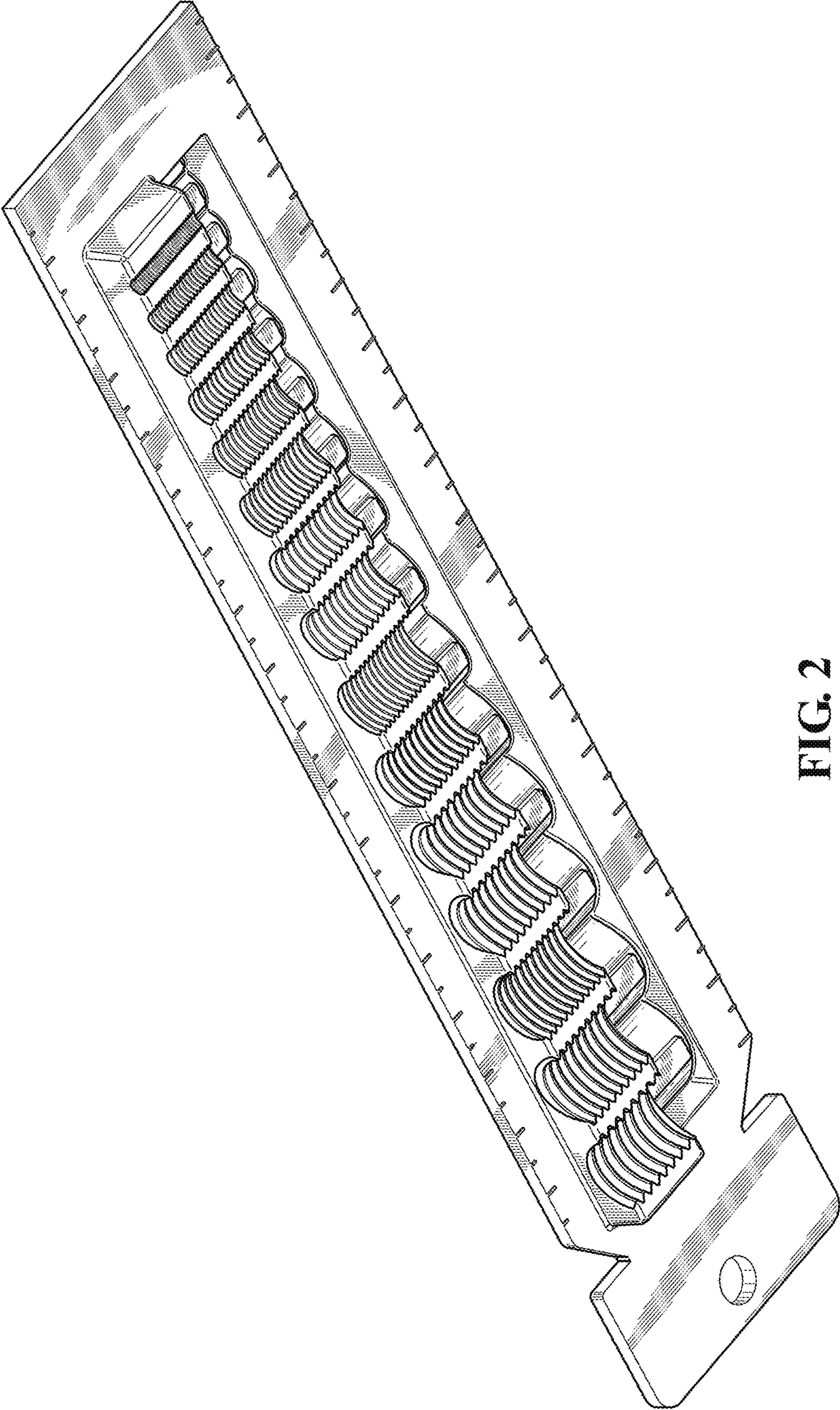

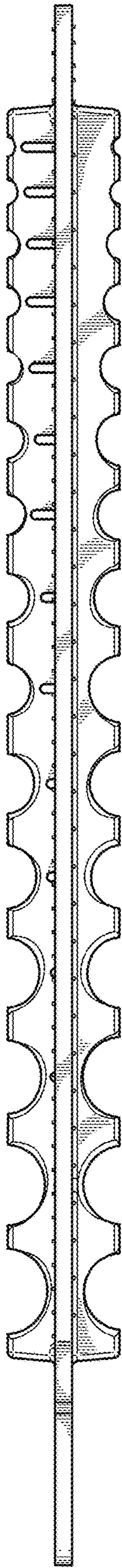

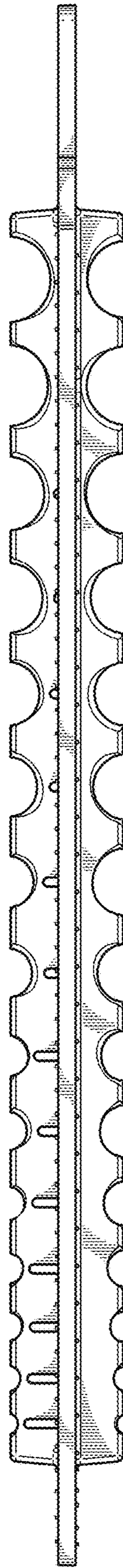

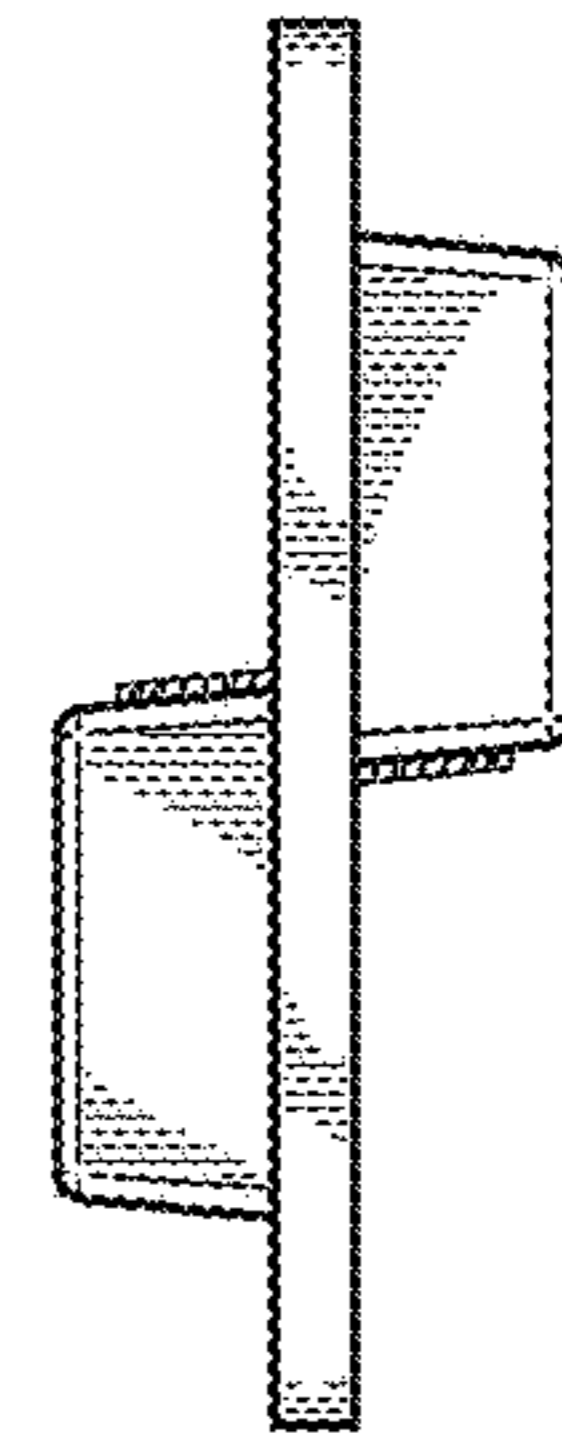

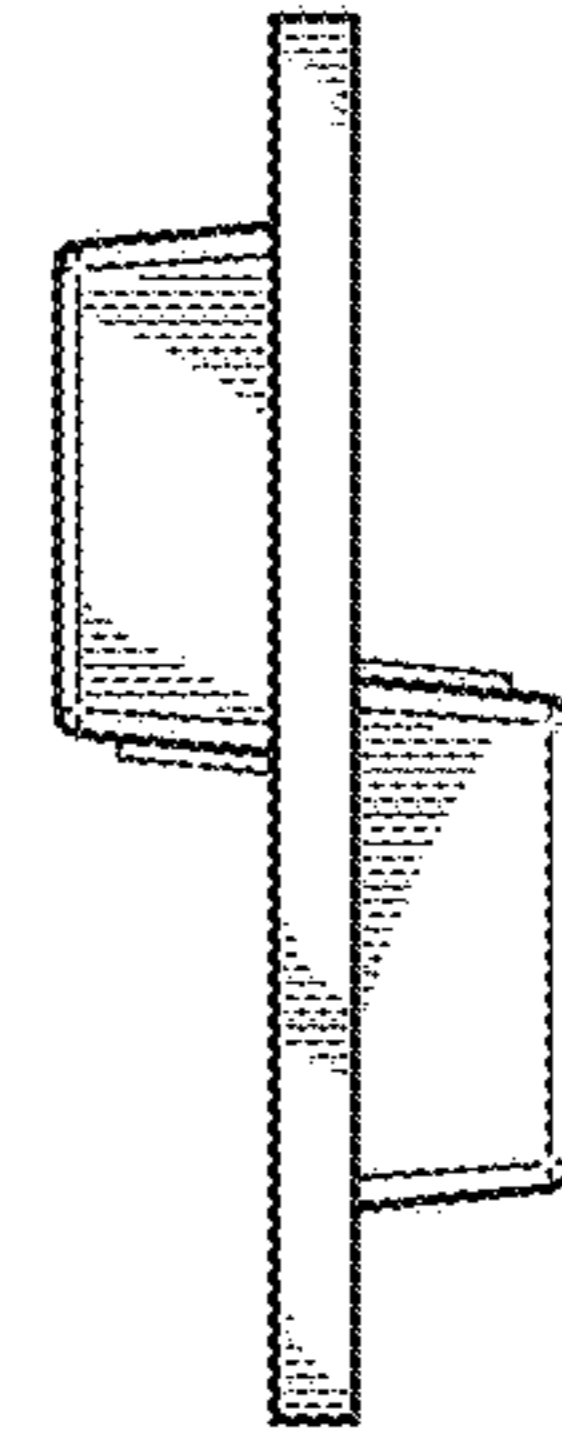

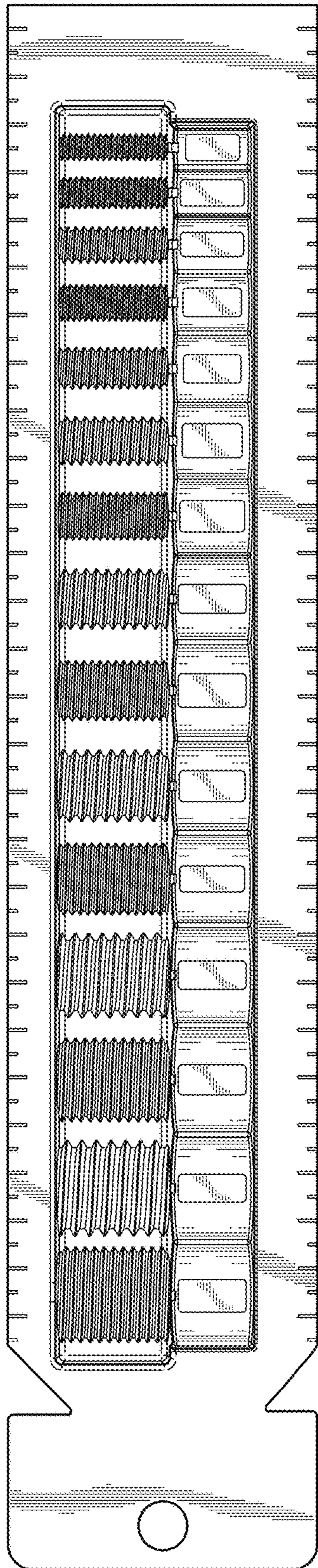

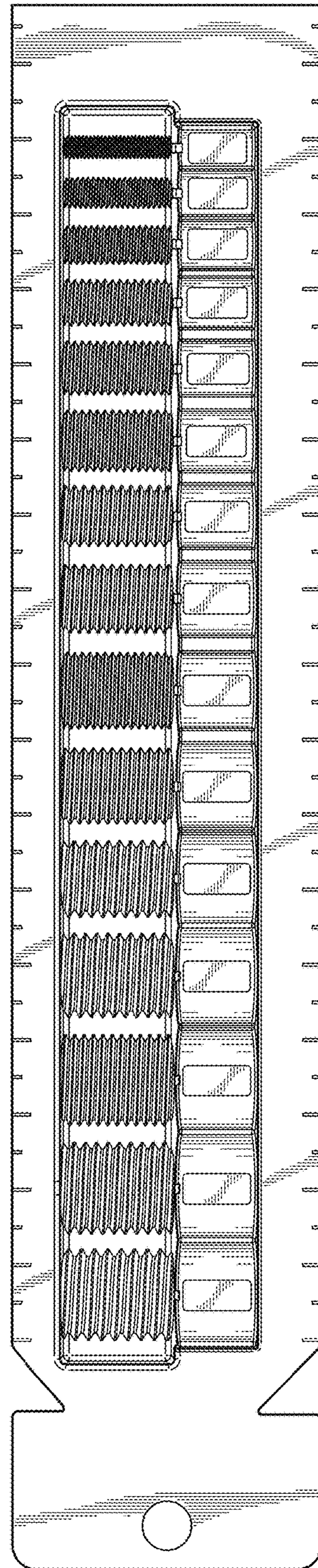

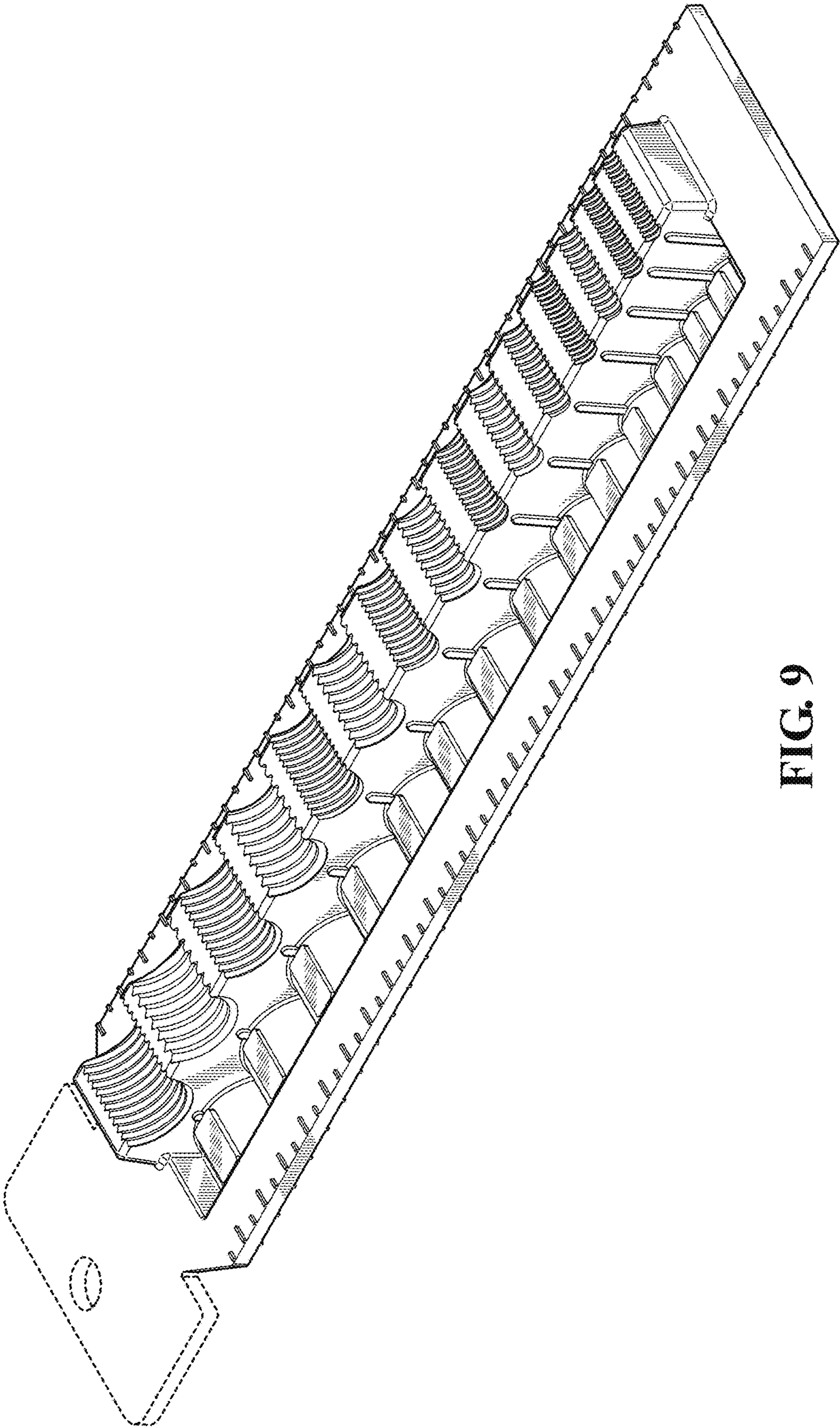

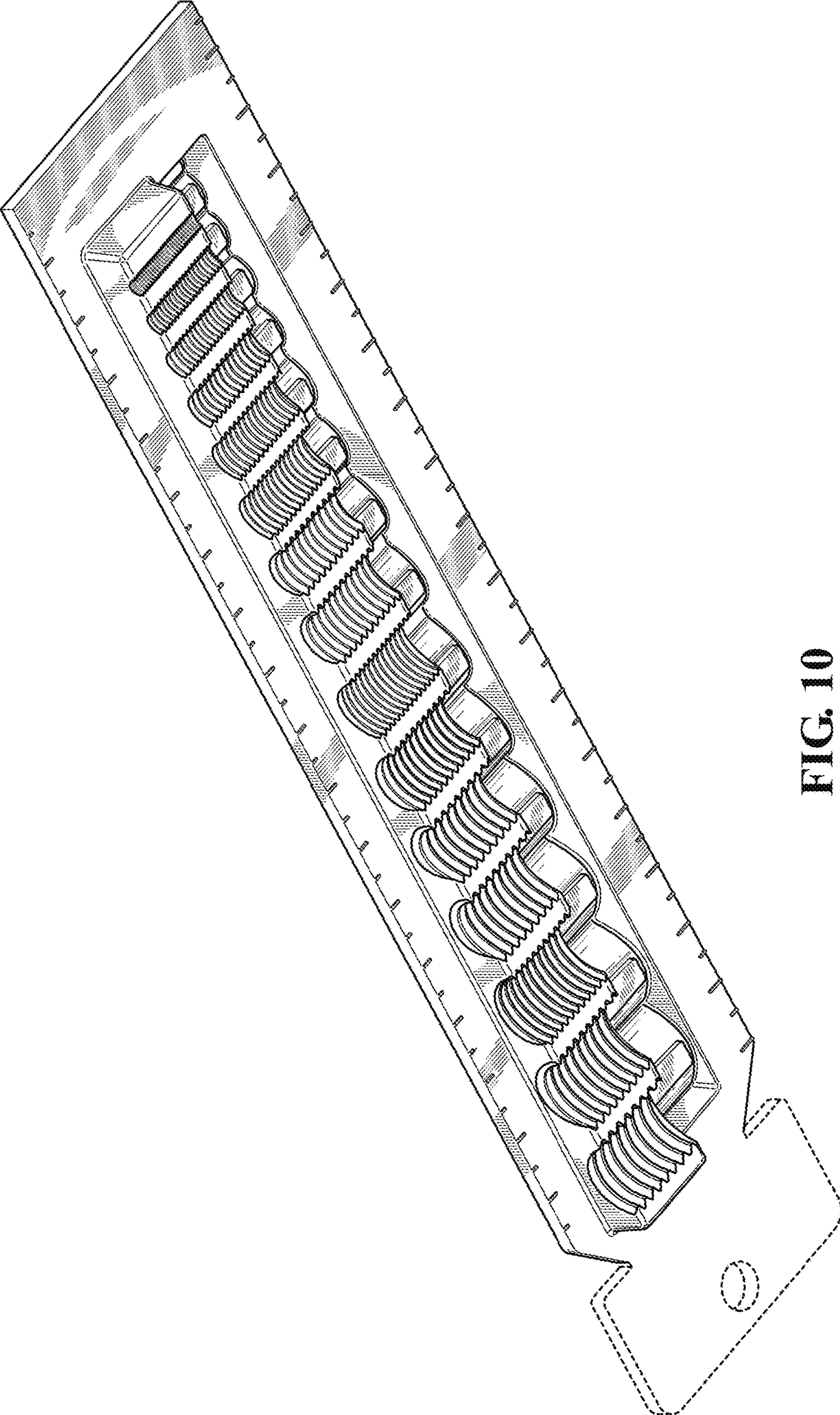

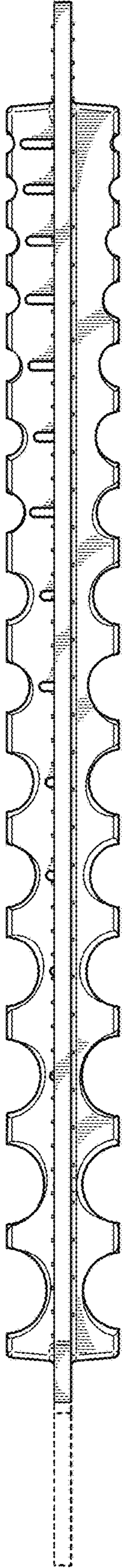

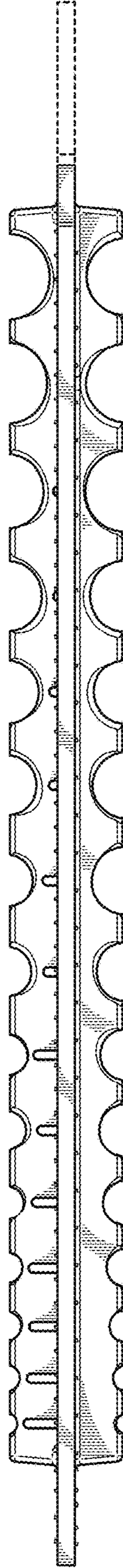

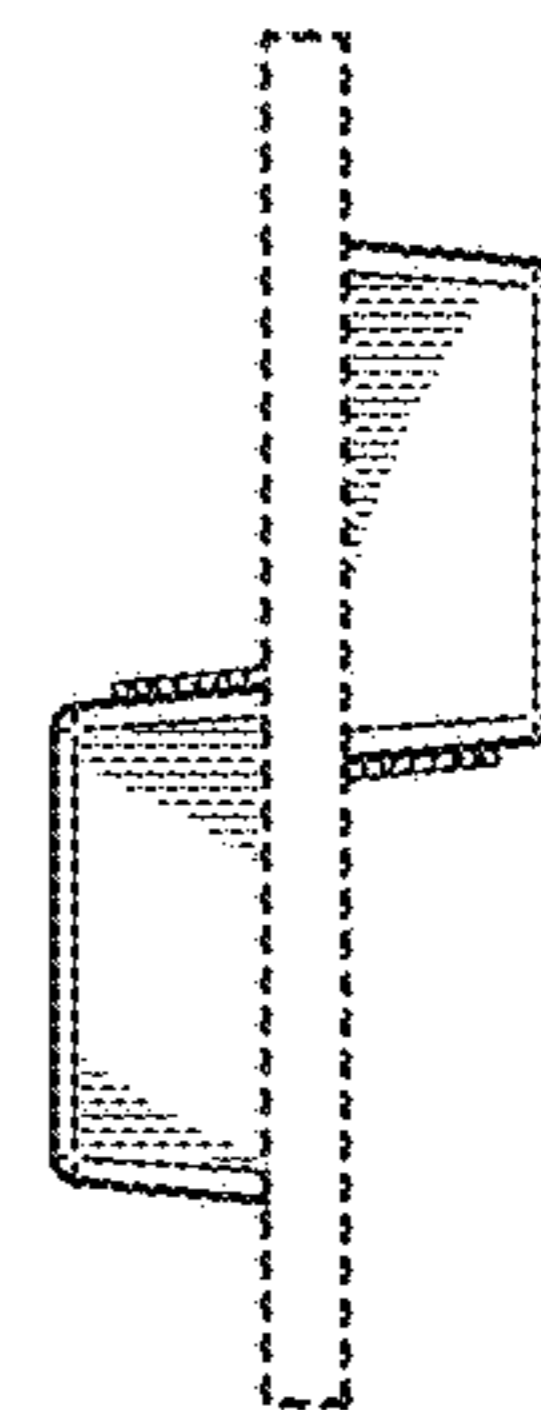

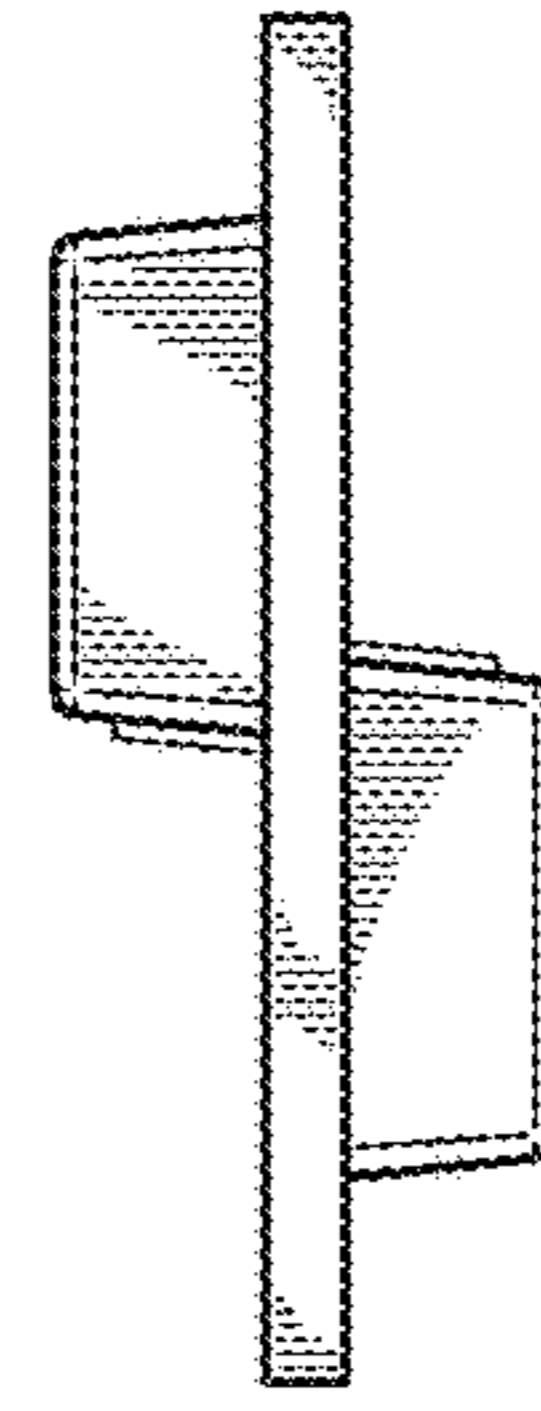

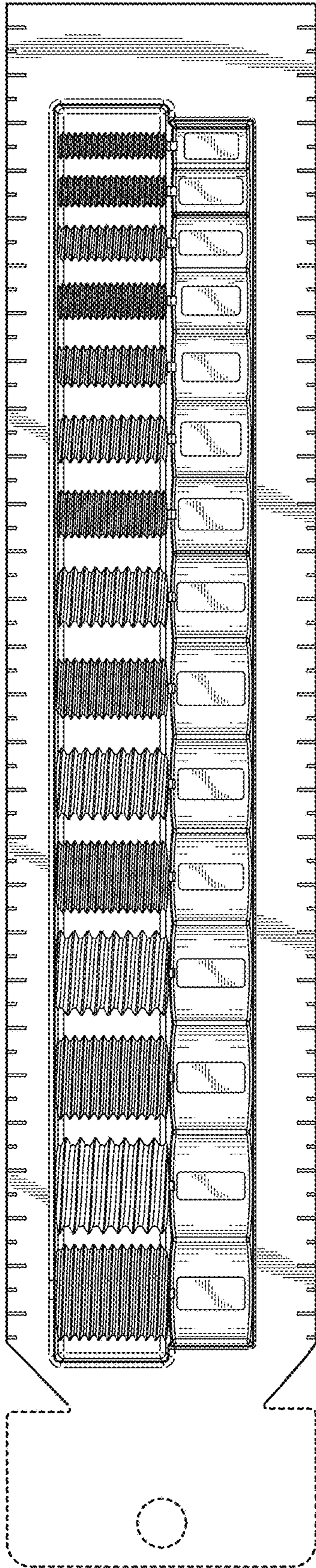

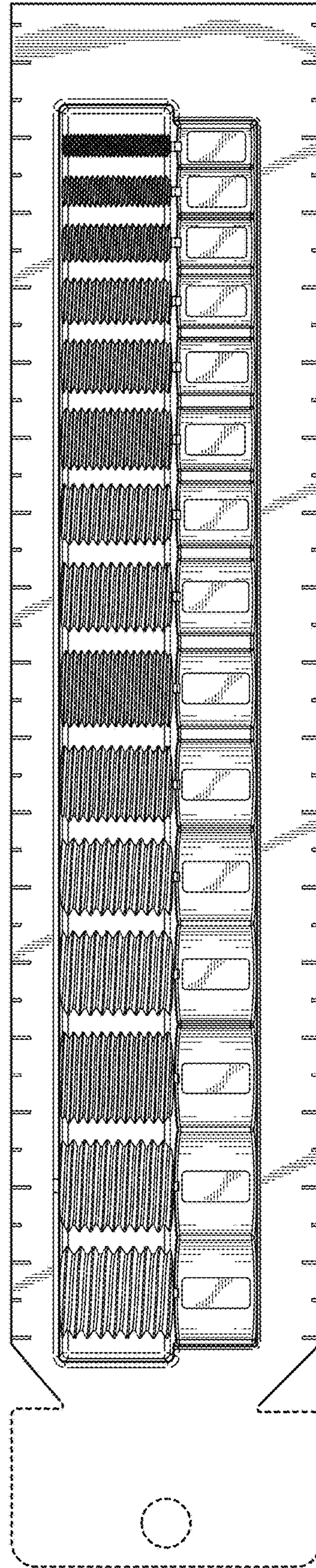
