(57) **CLAIM**

The ornamental design for an instrument panel for a motor vehicle, as shown and described.

DESCRIPTION

FIG. 4 is a right side view thereof;

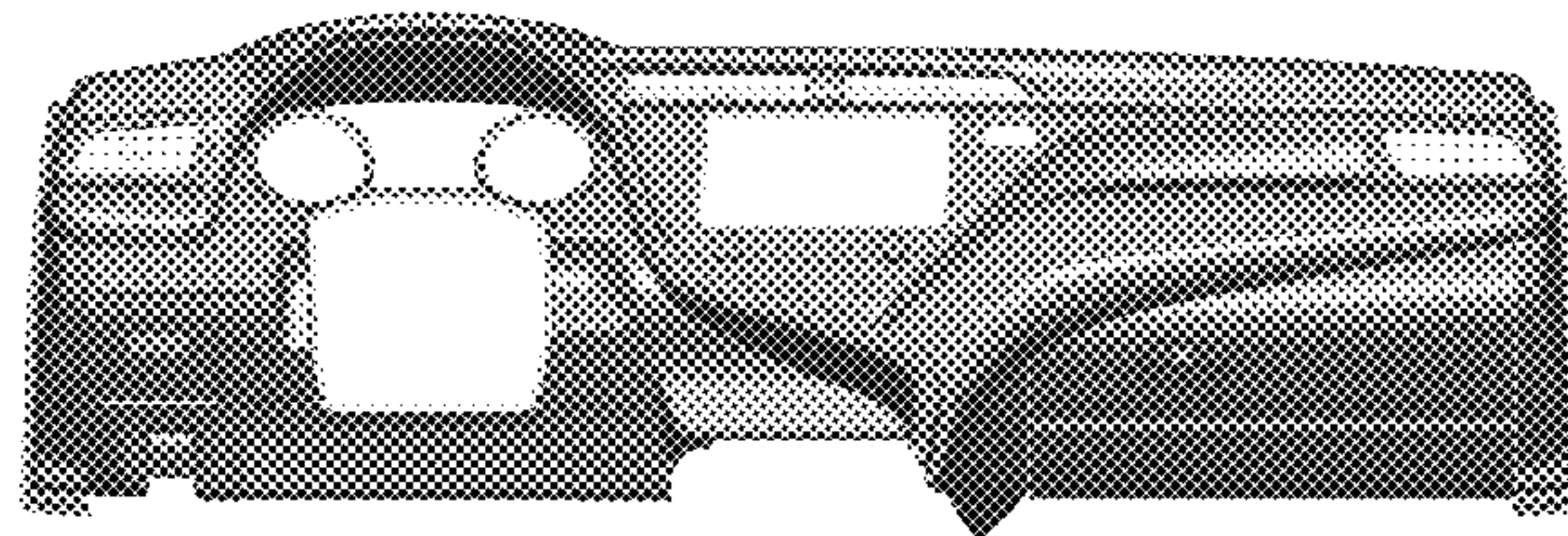
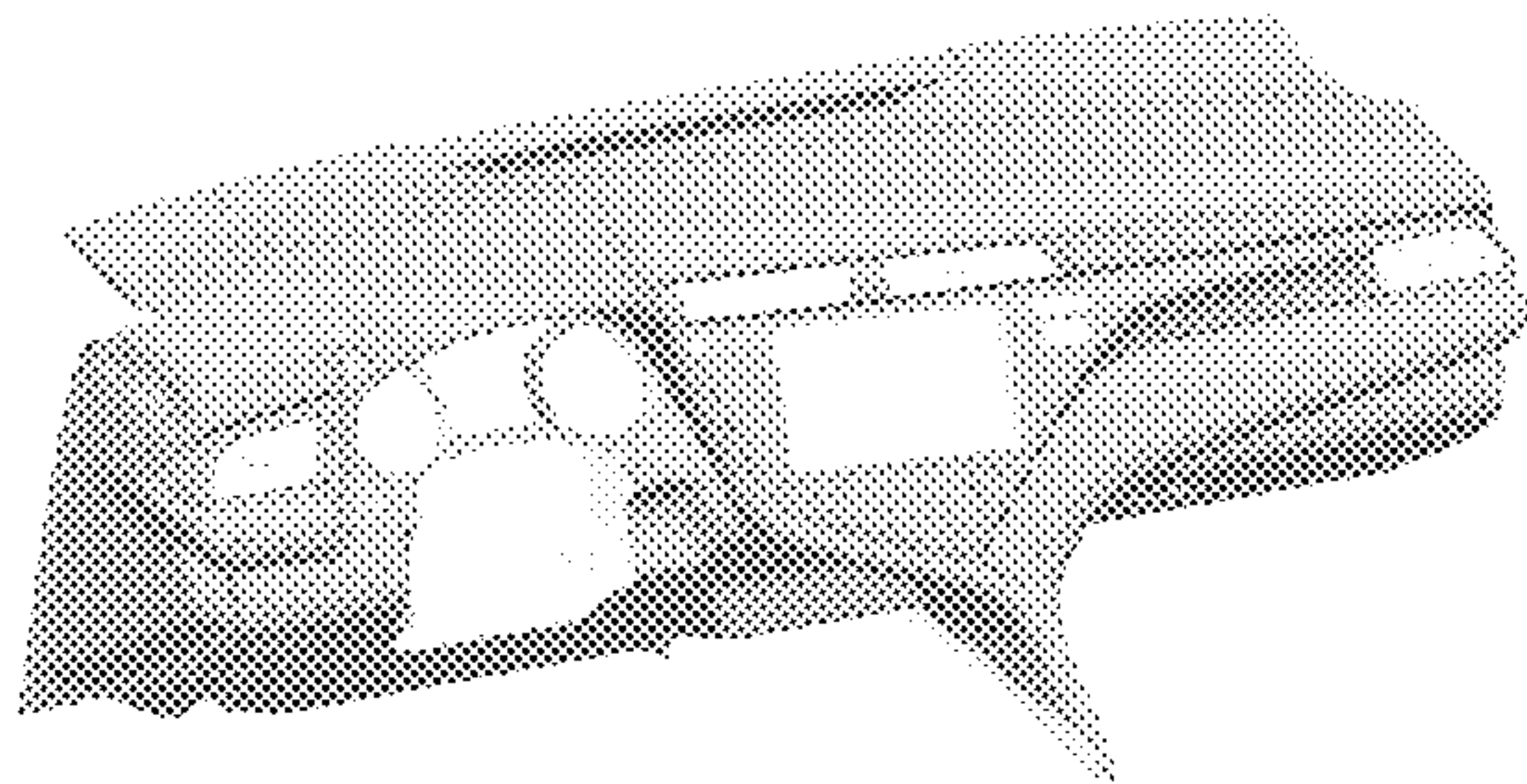
FIG. 5 is a left side view thereof;

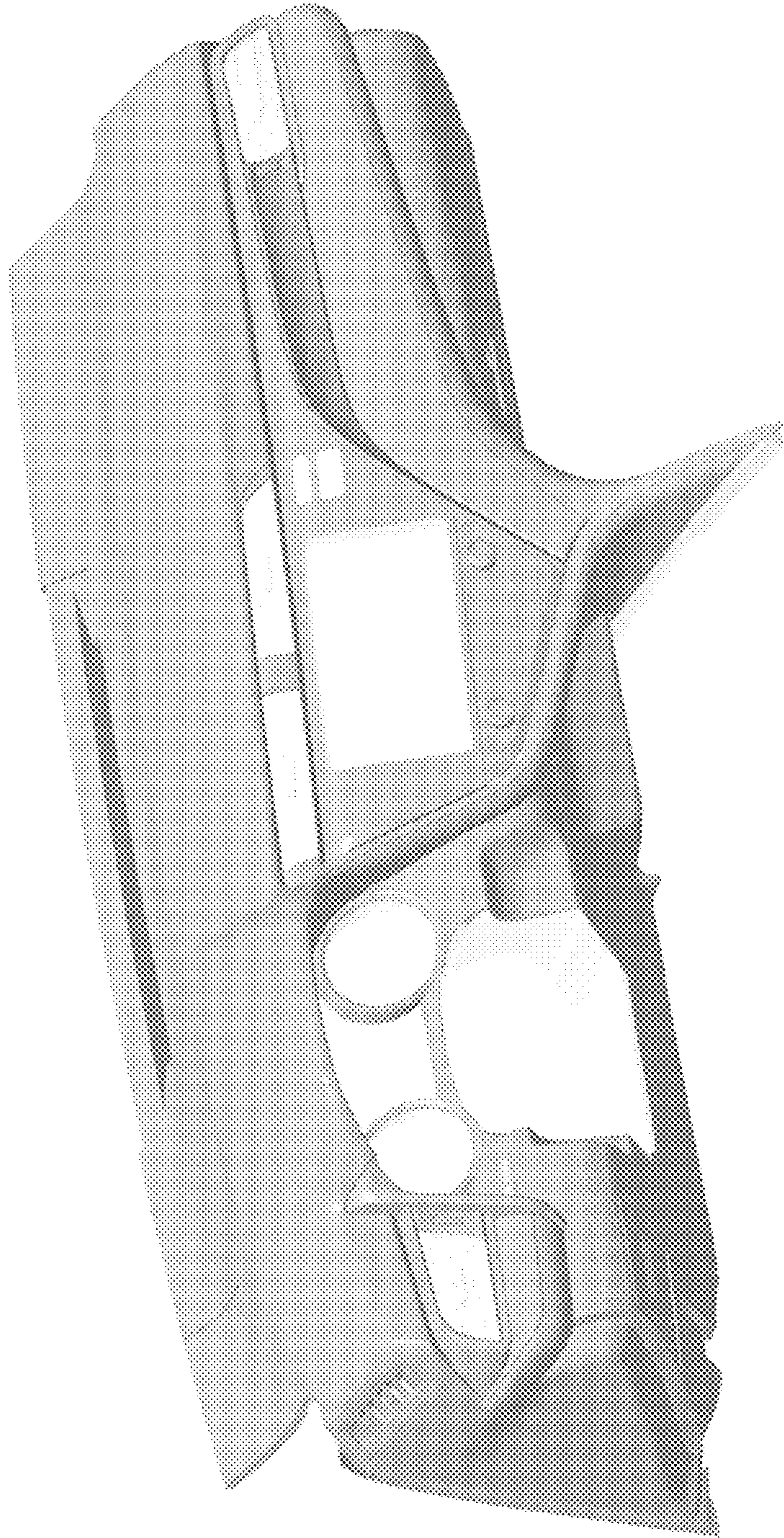

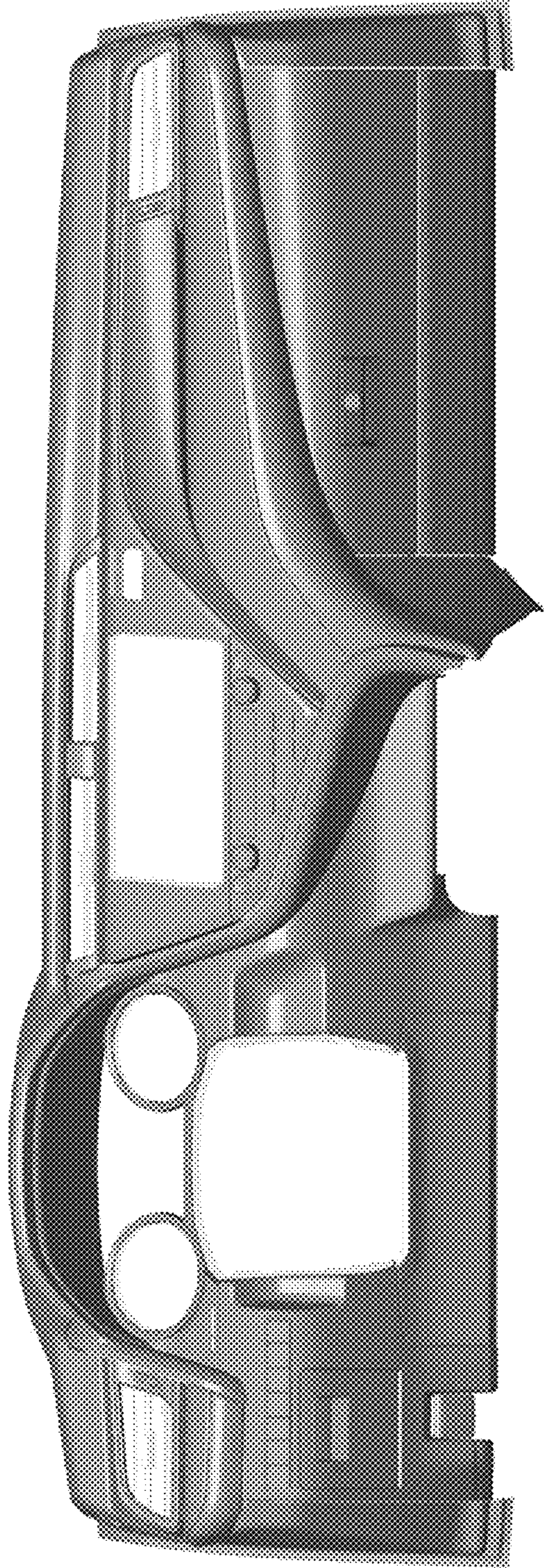

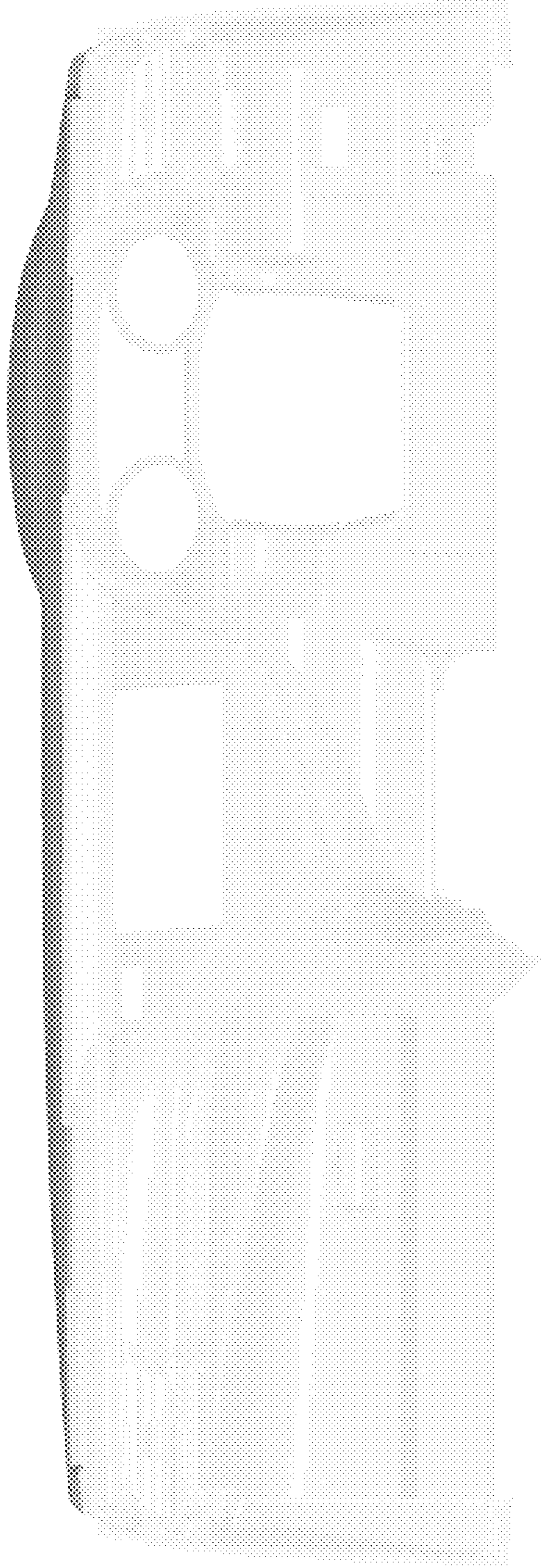

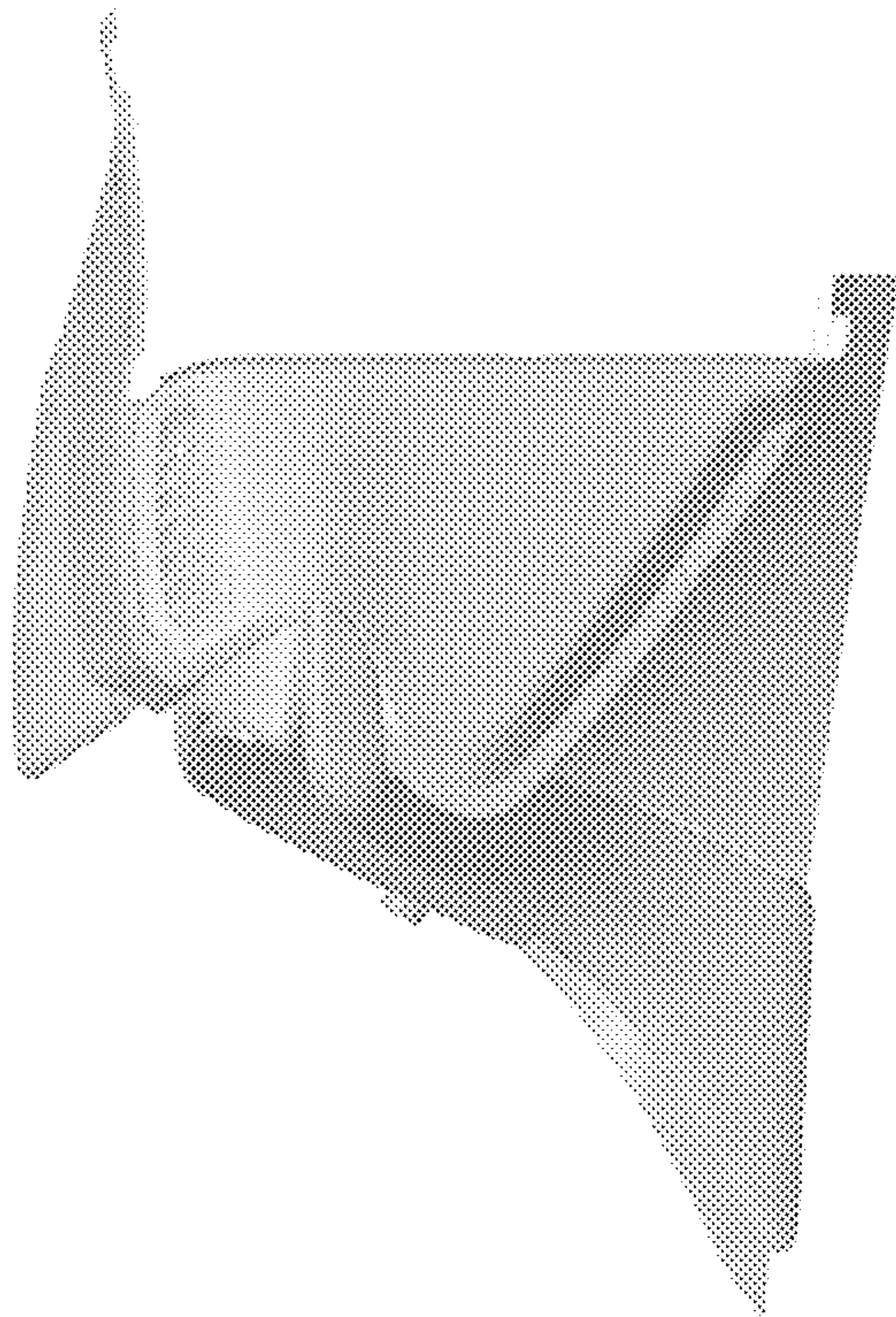

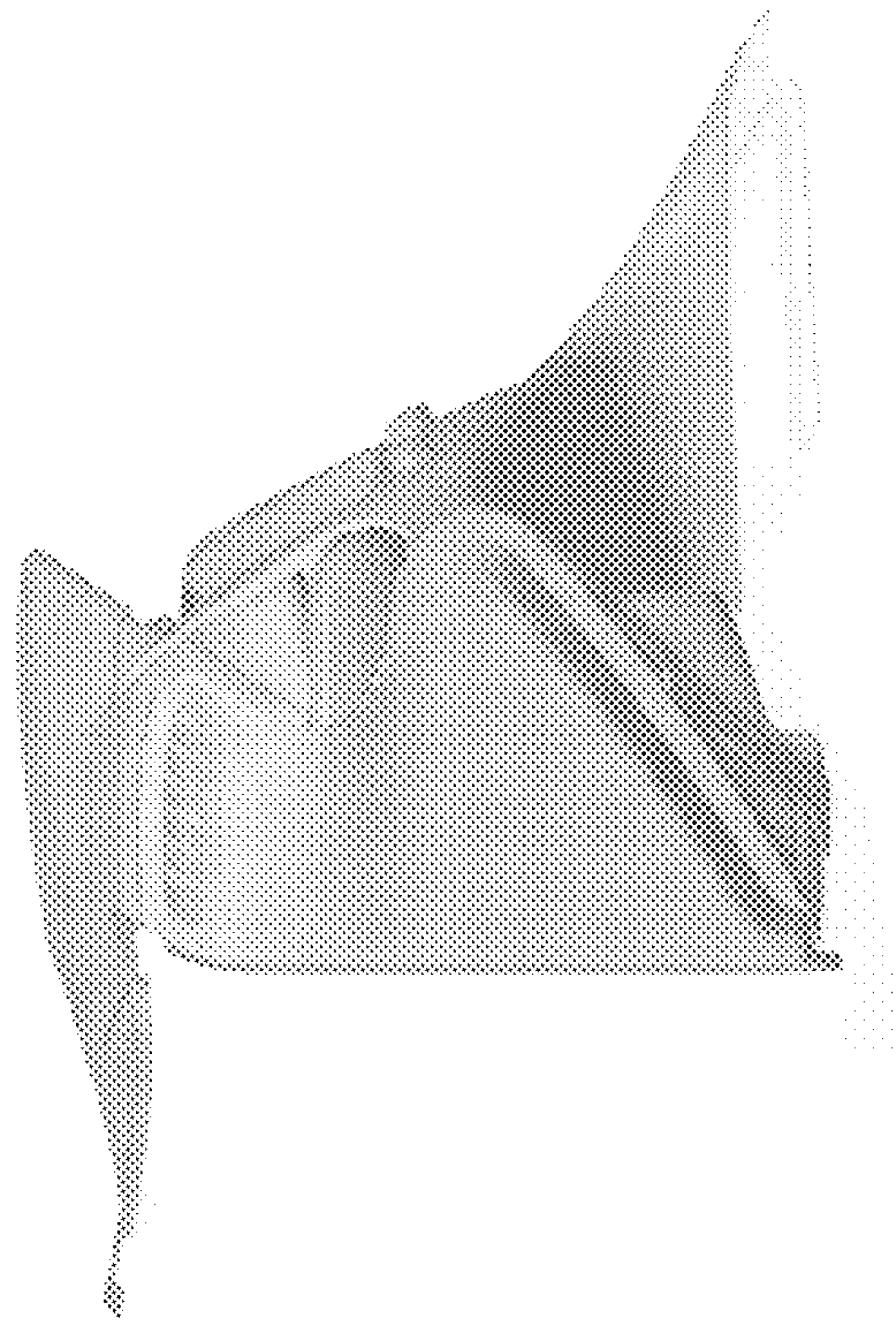

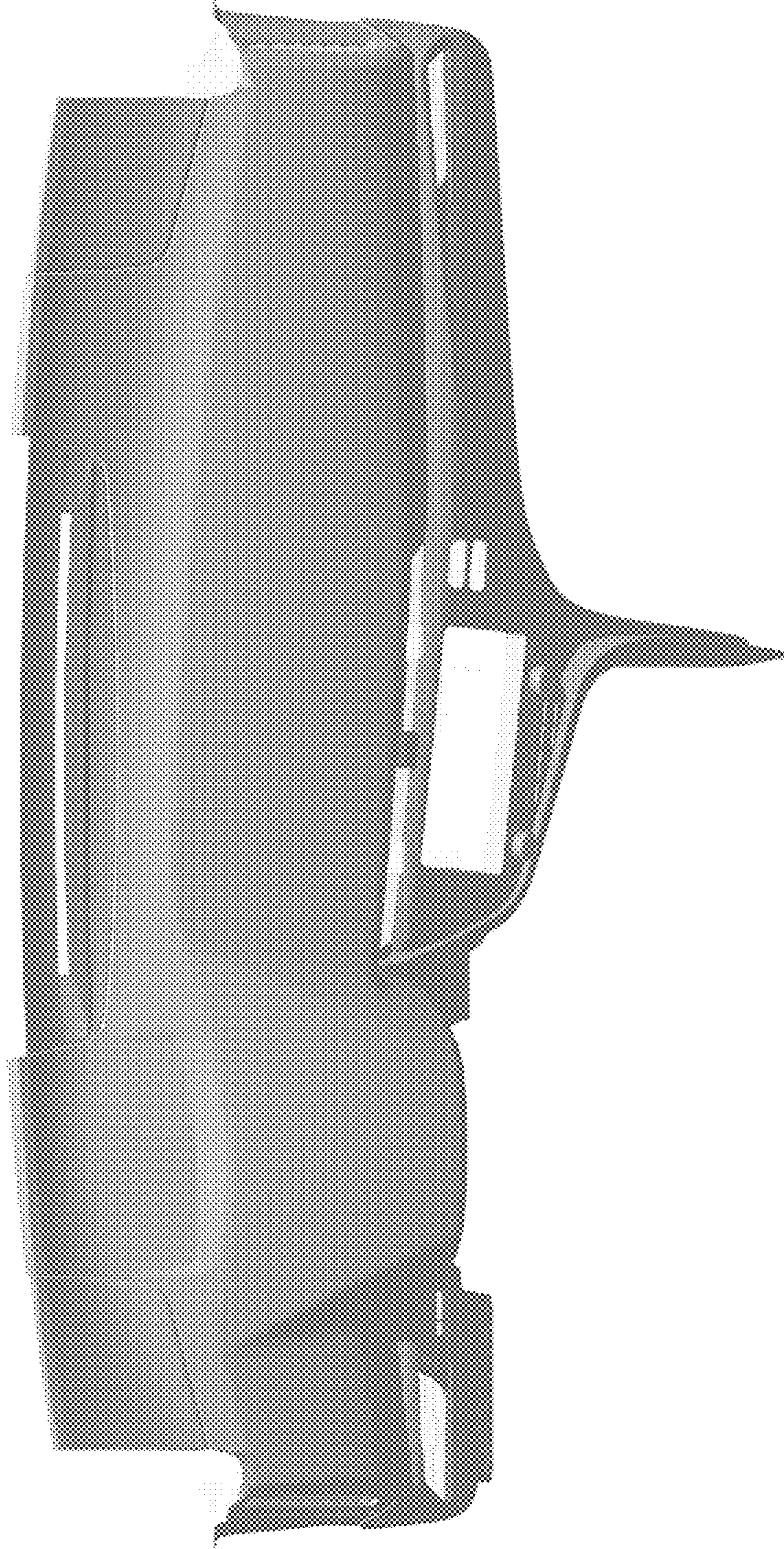

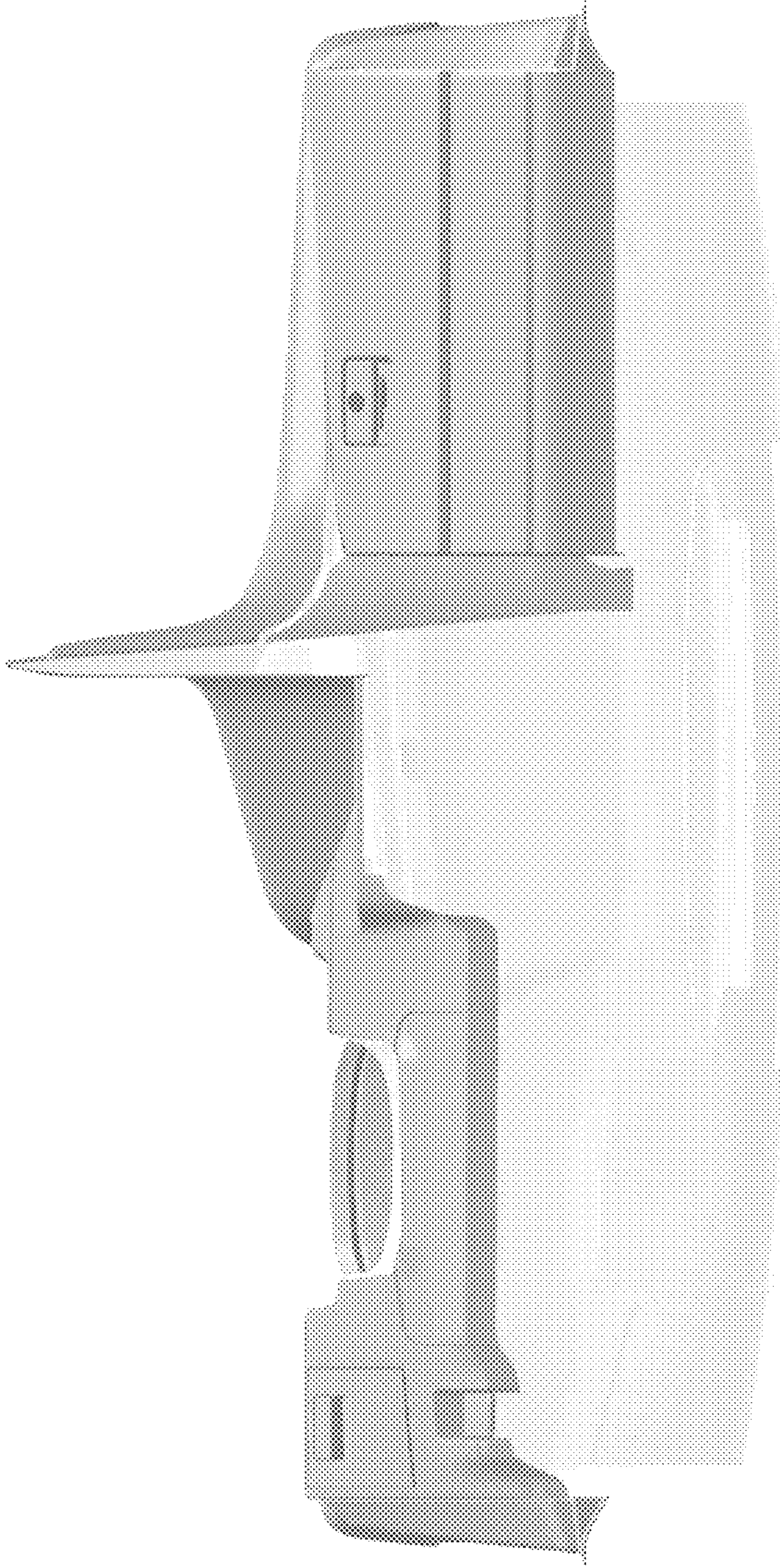
