FIG. 20 is an enlarged front perspective view of the portion encircled in FIG. 12;

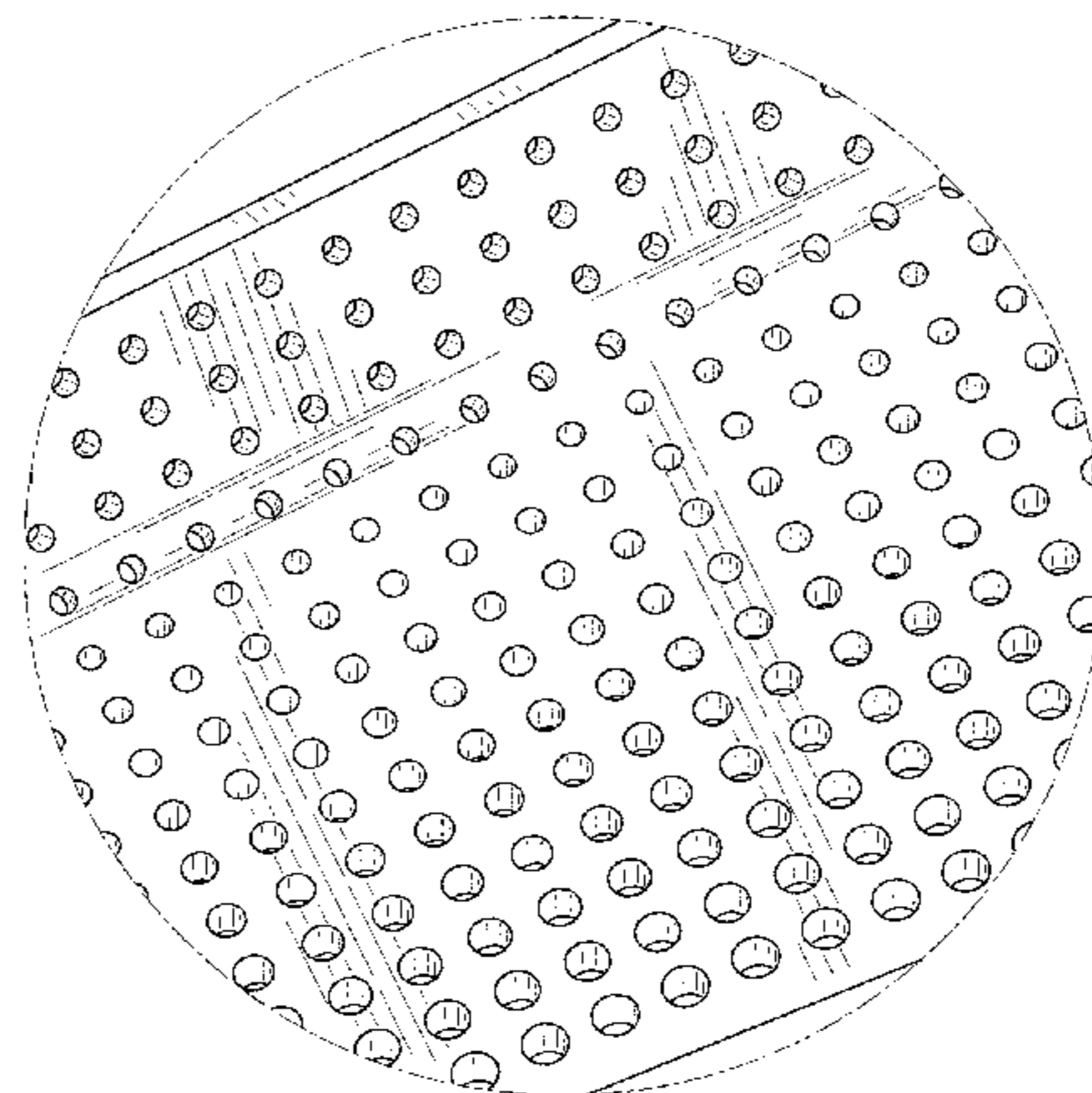
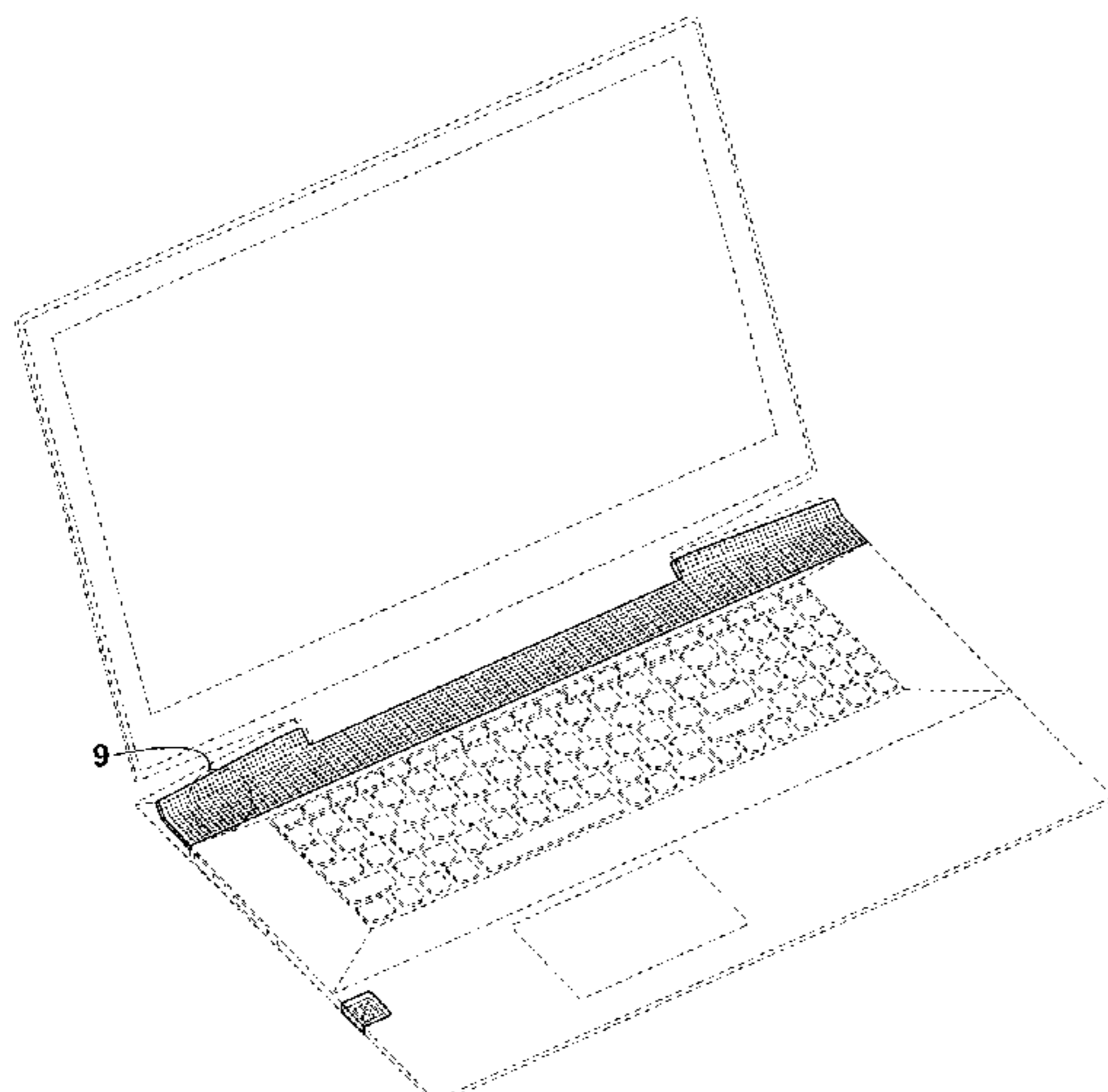
FIG. 21 is an enlarged rear perspective view of the portion encircled in FIG. 19; and,

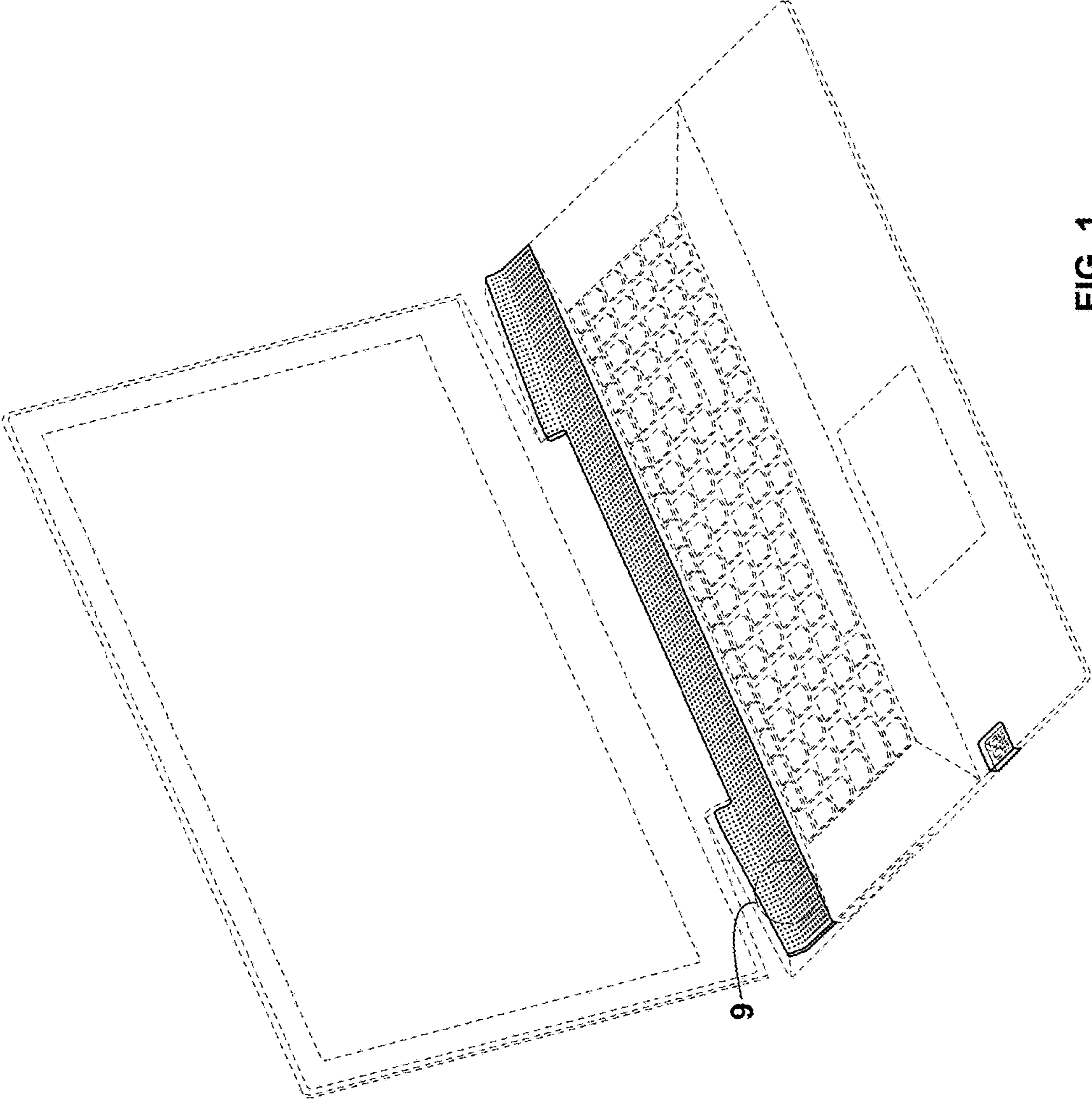

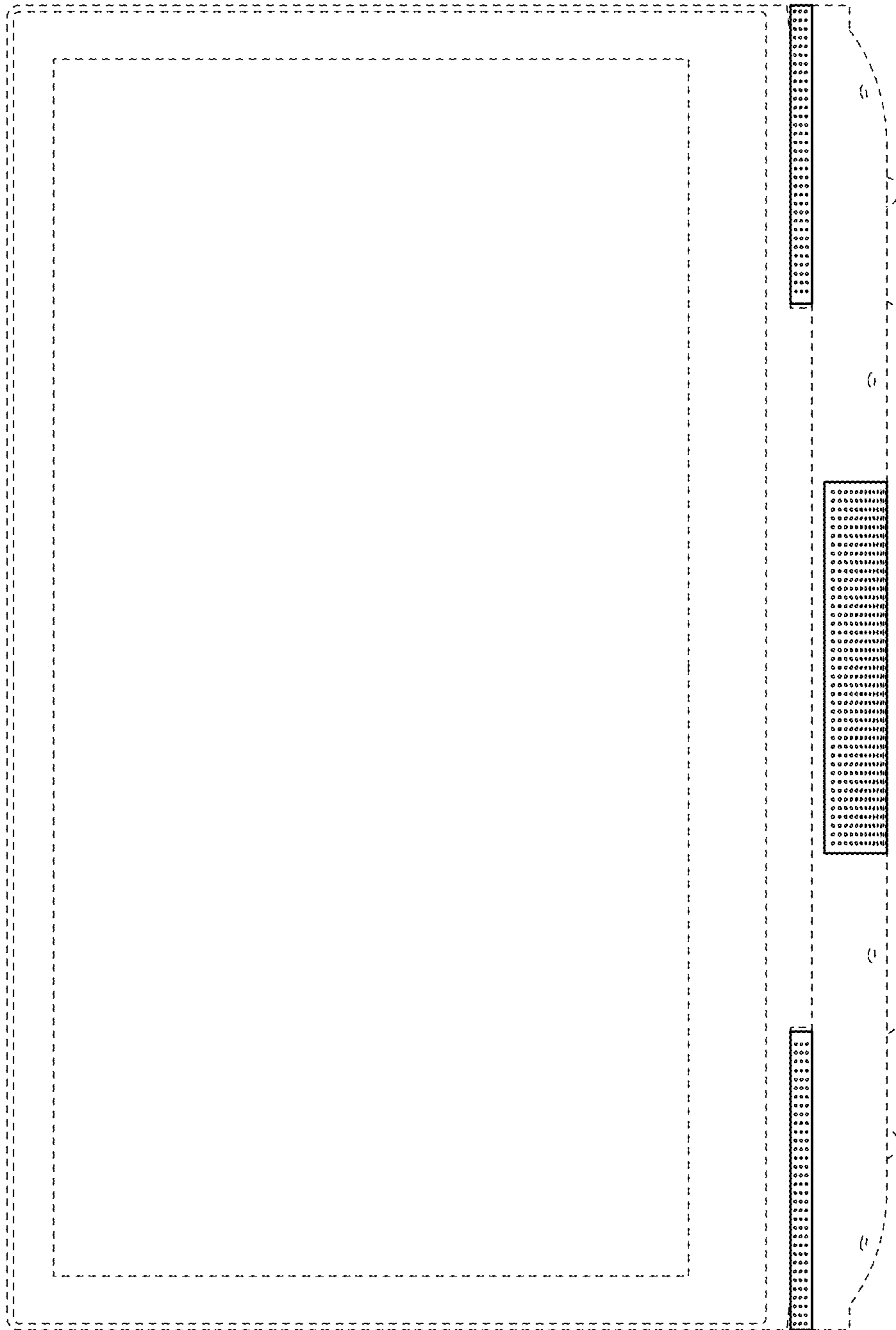

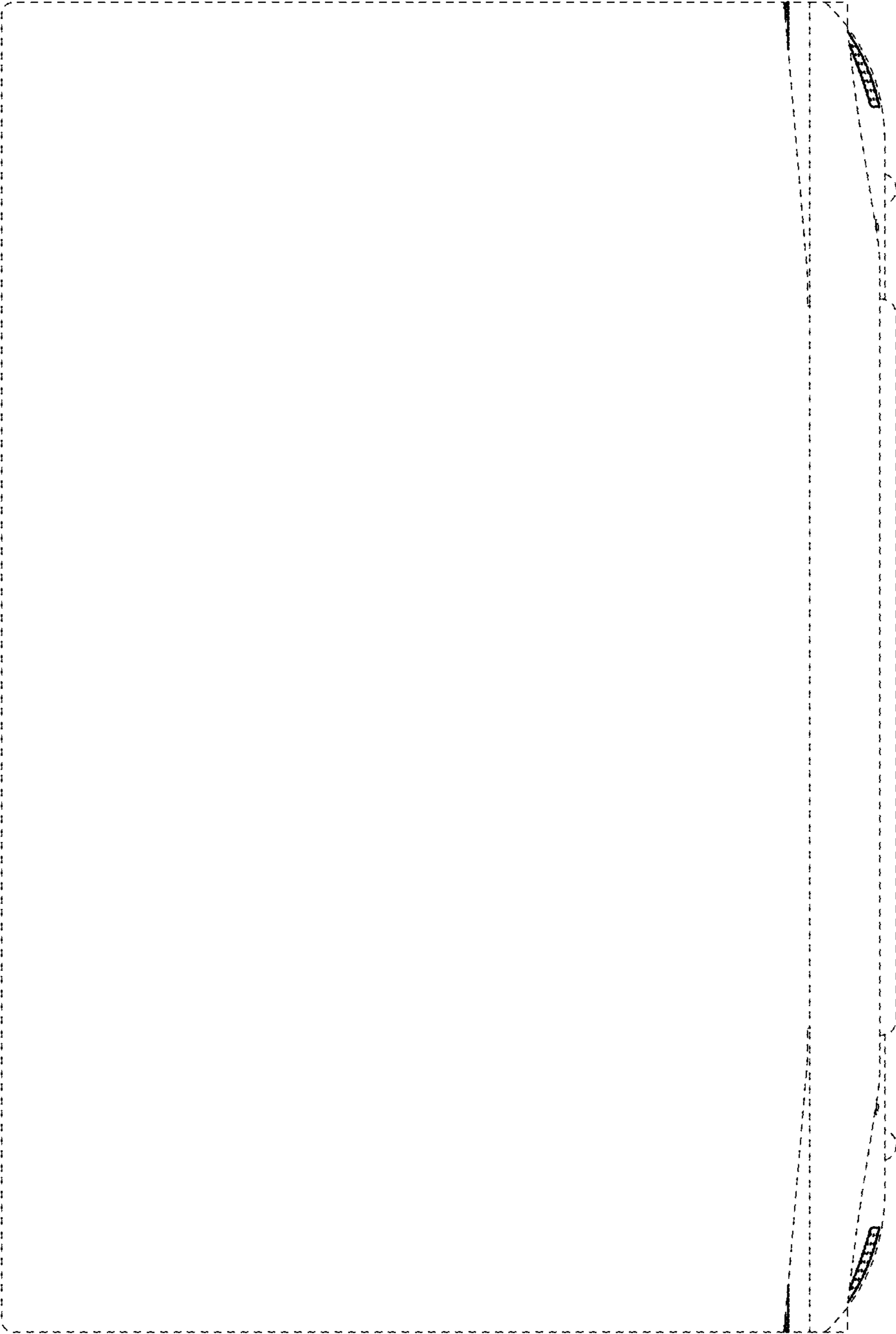

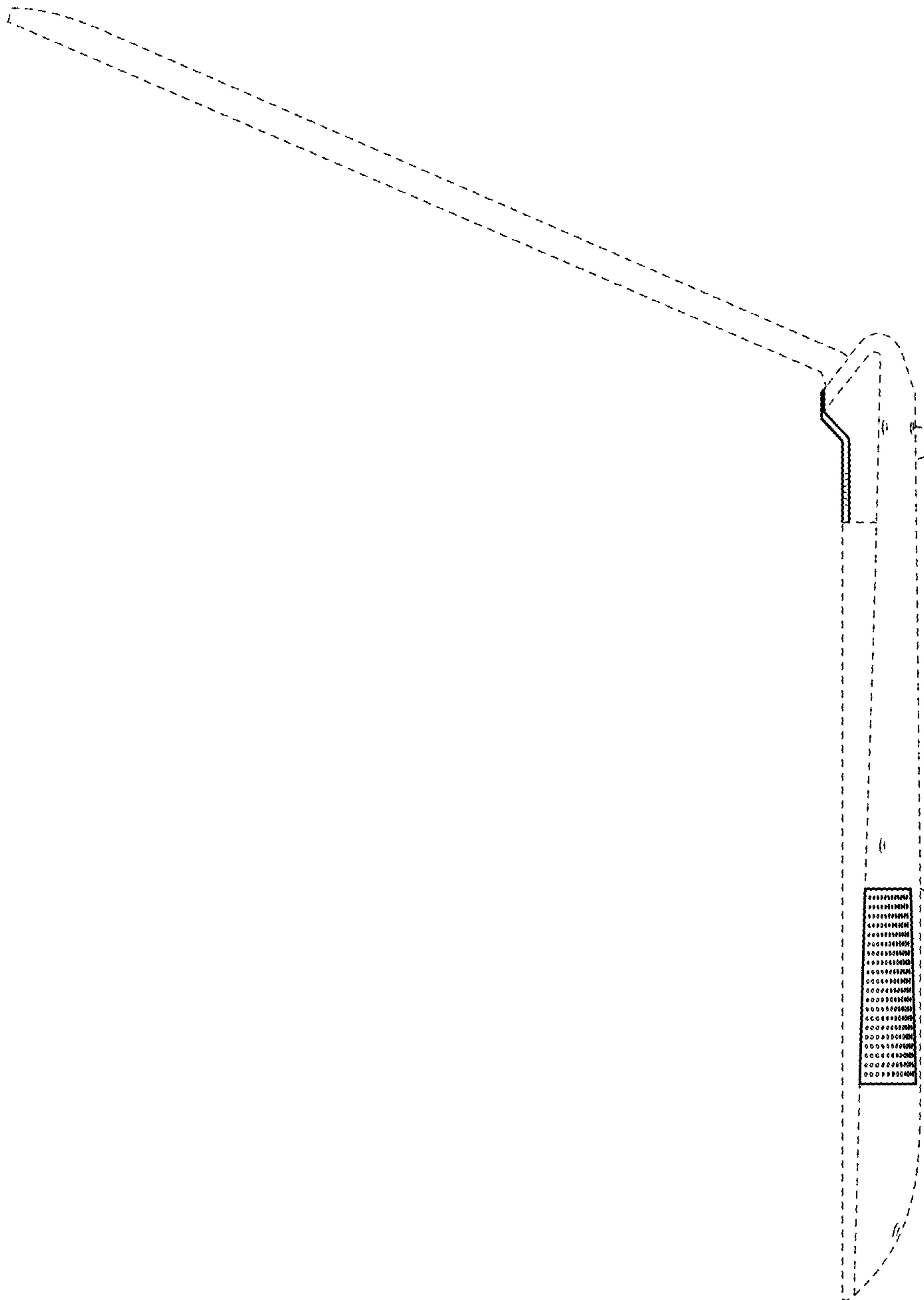

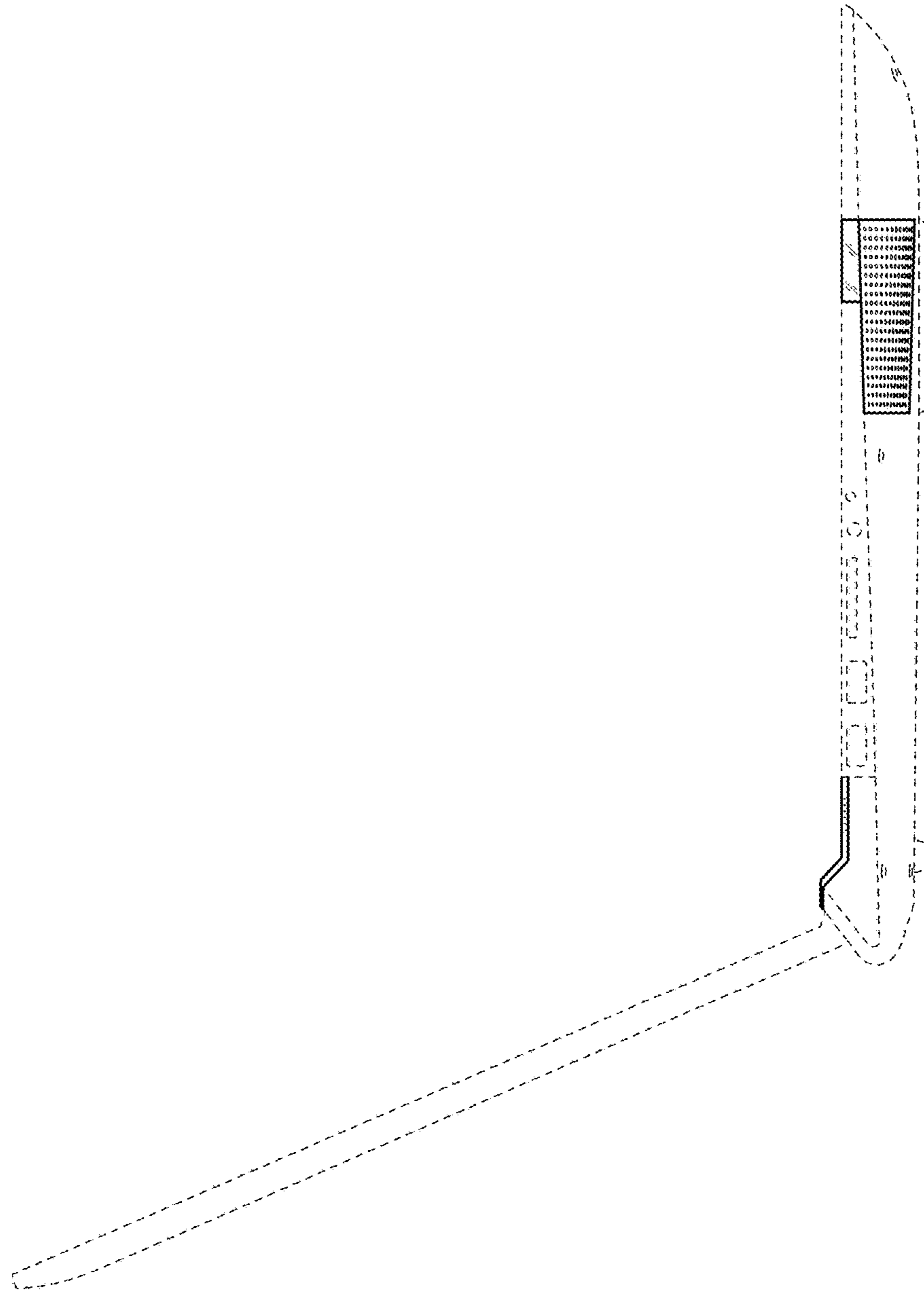

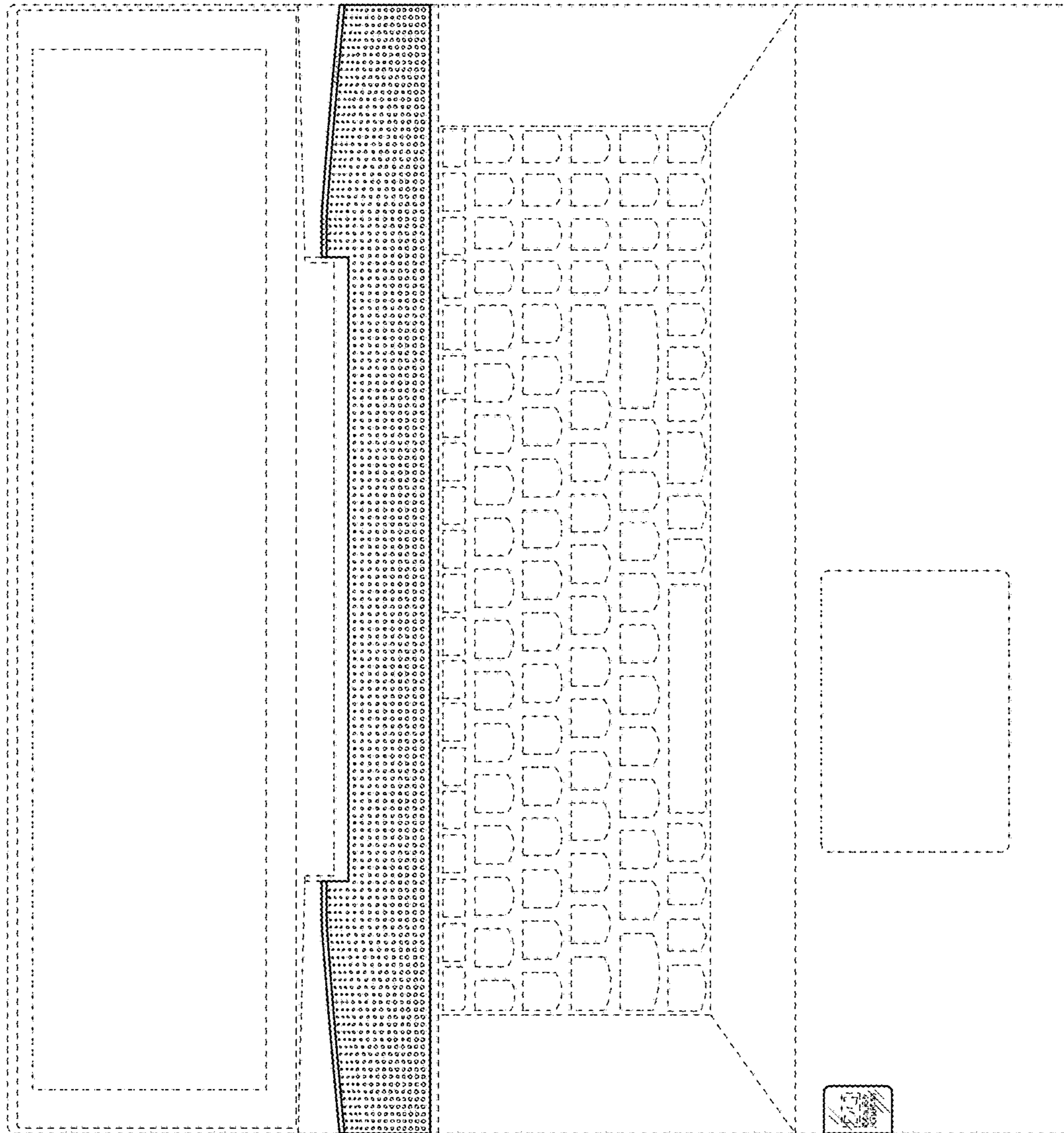

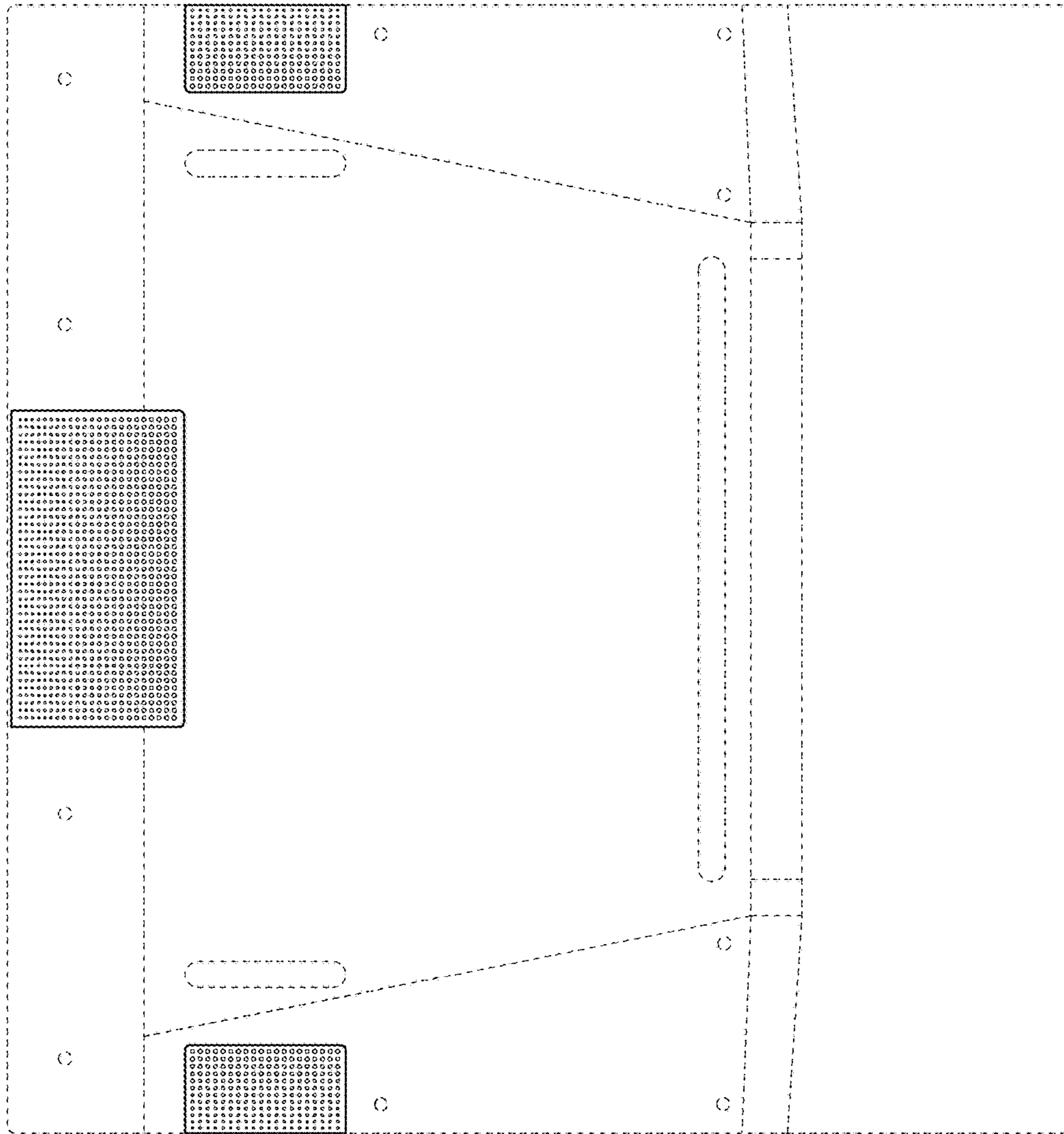

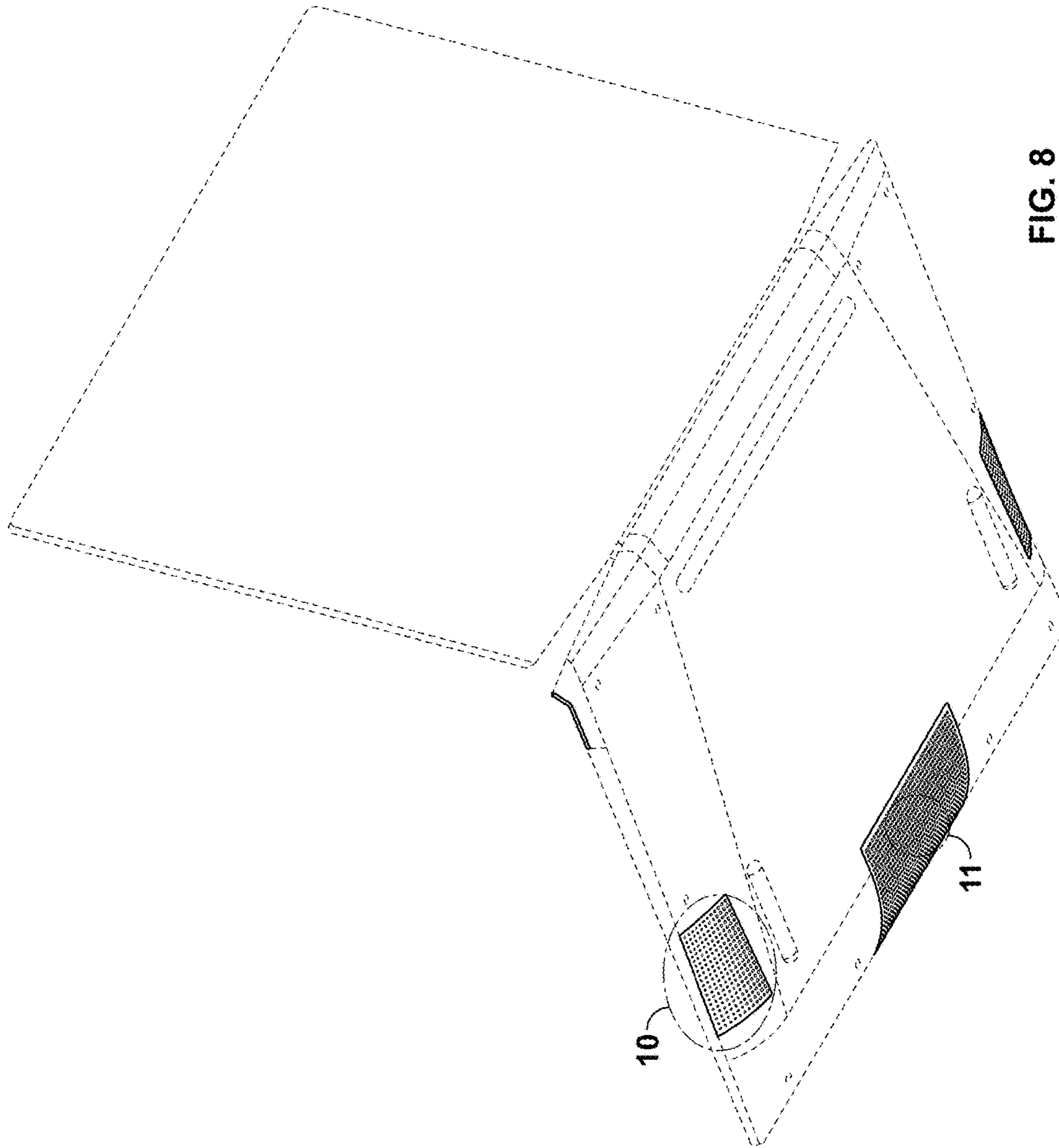

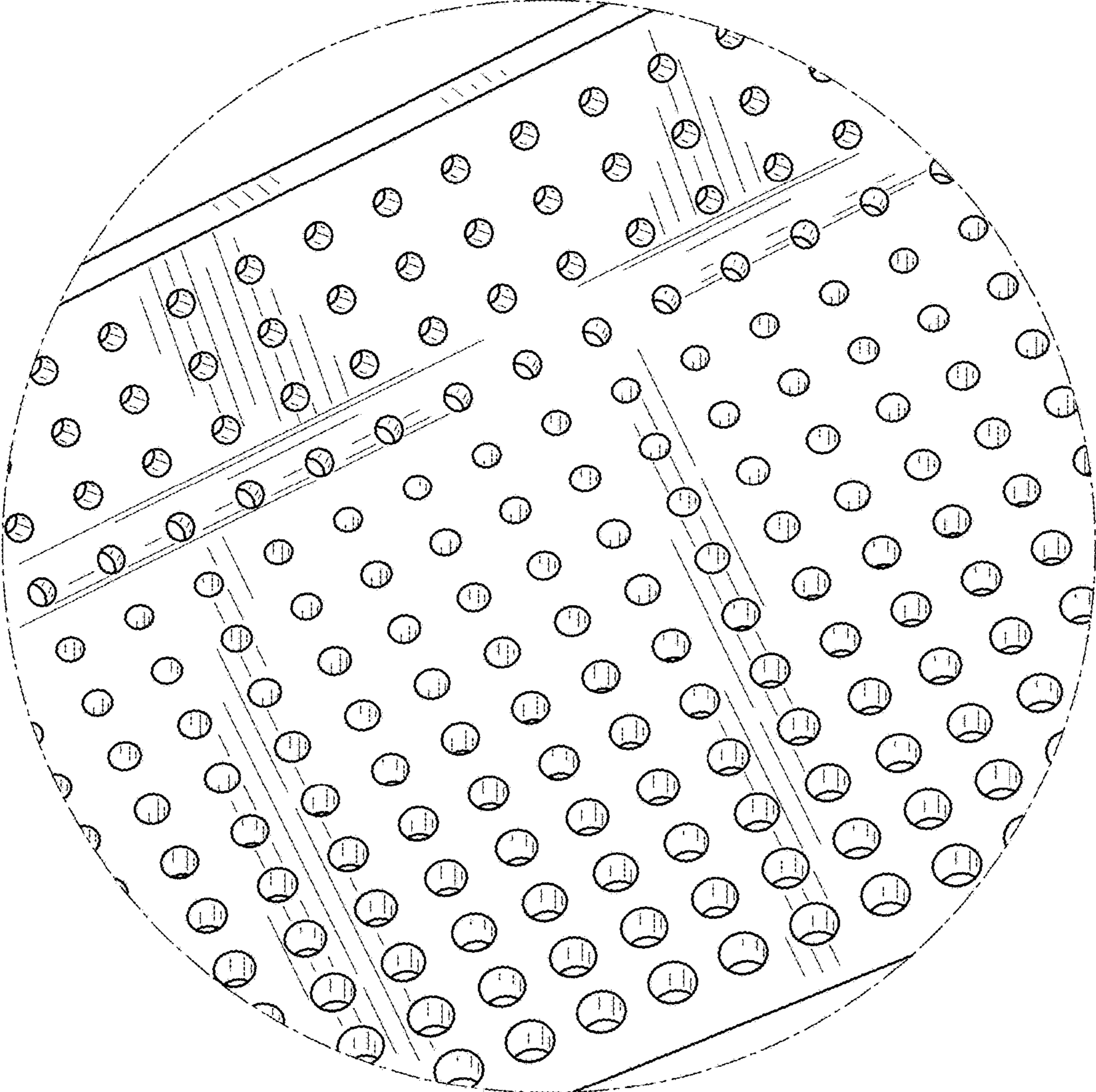

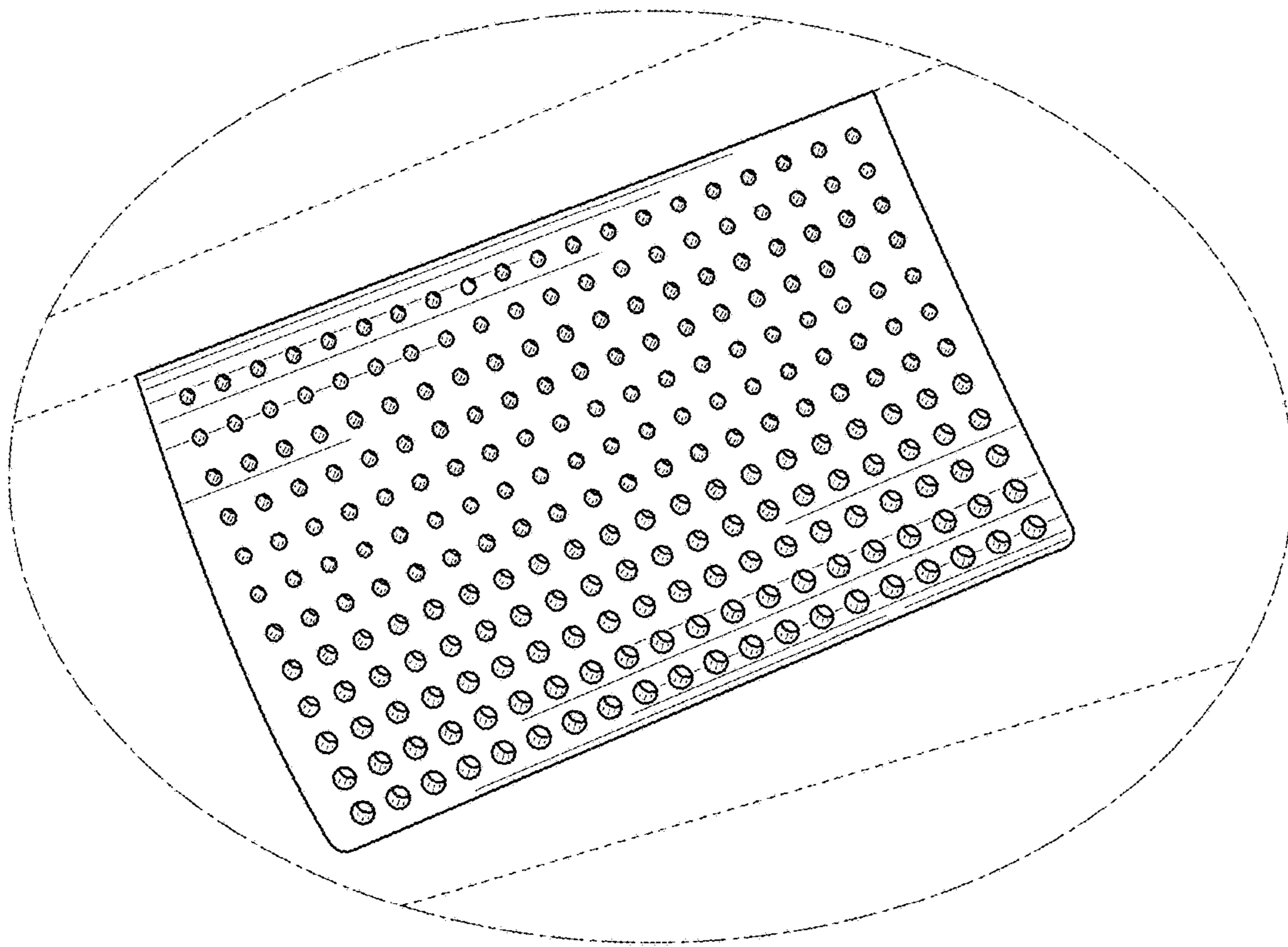

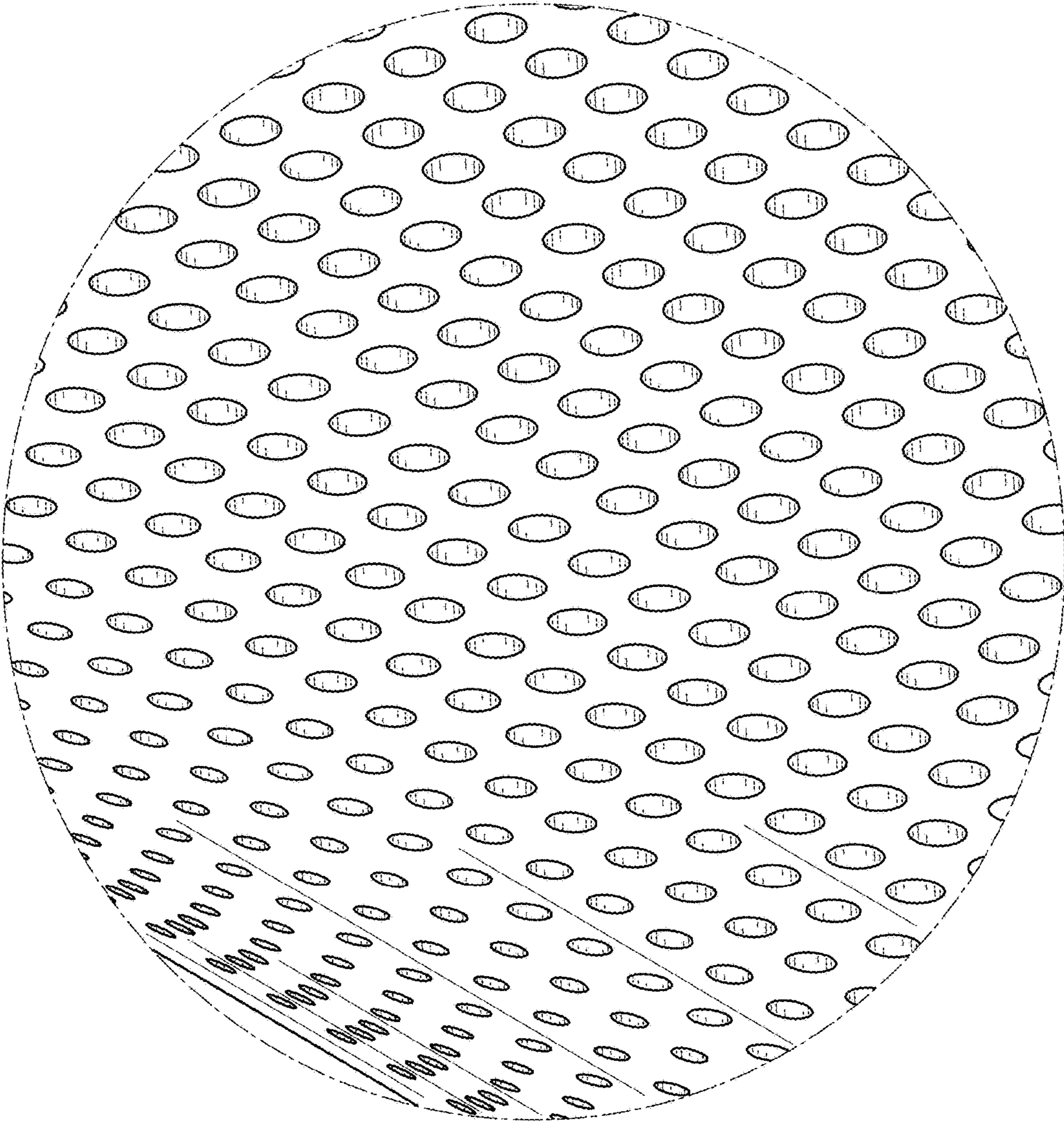

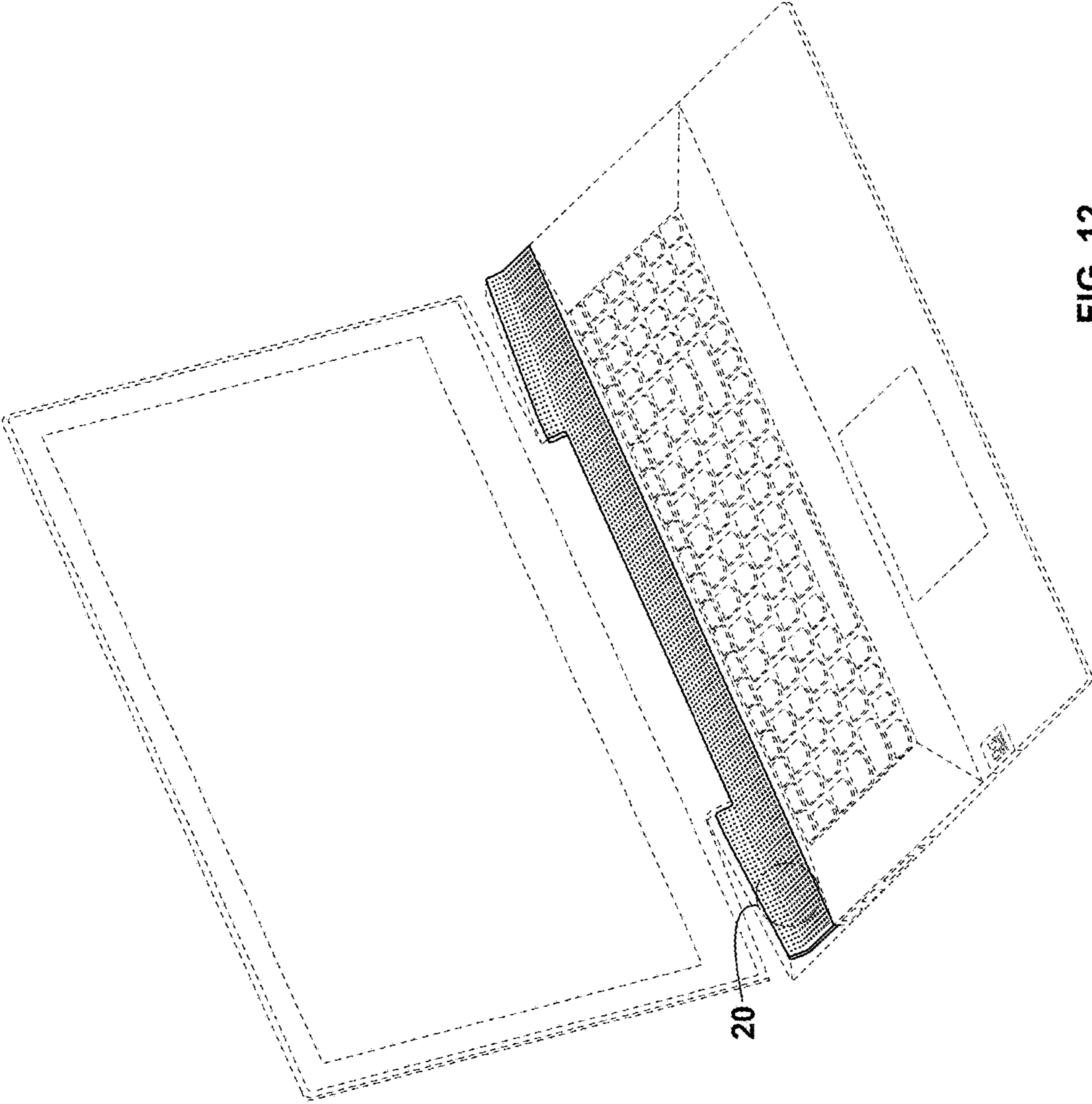

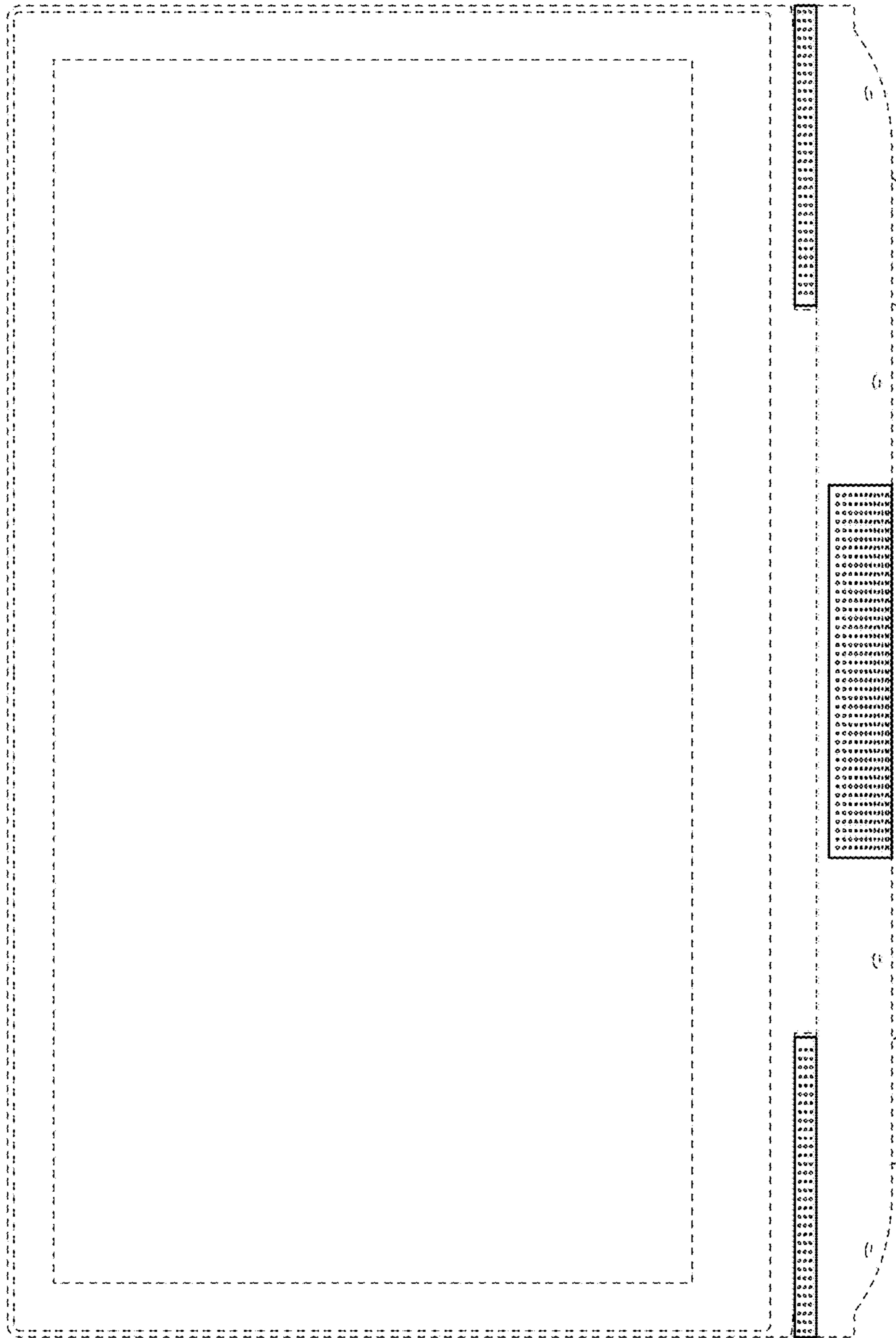

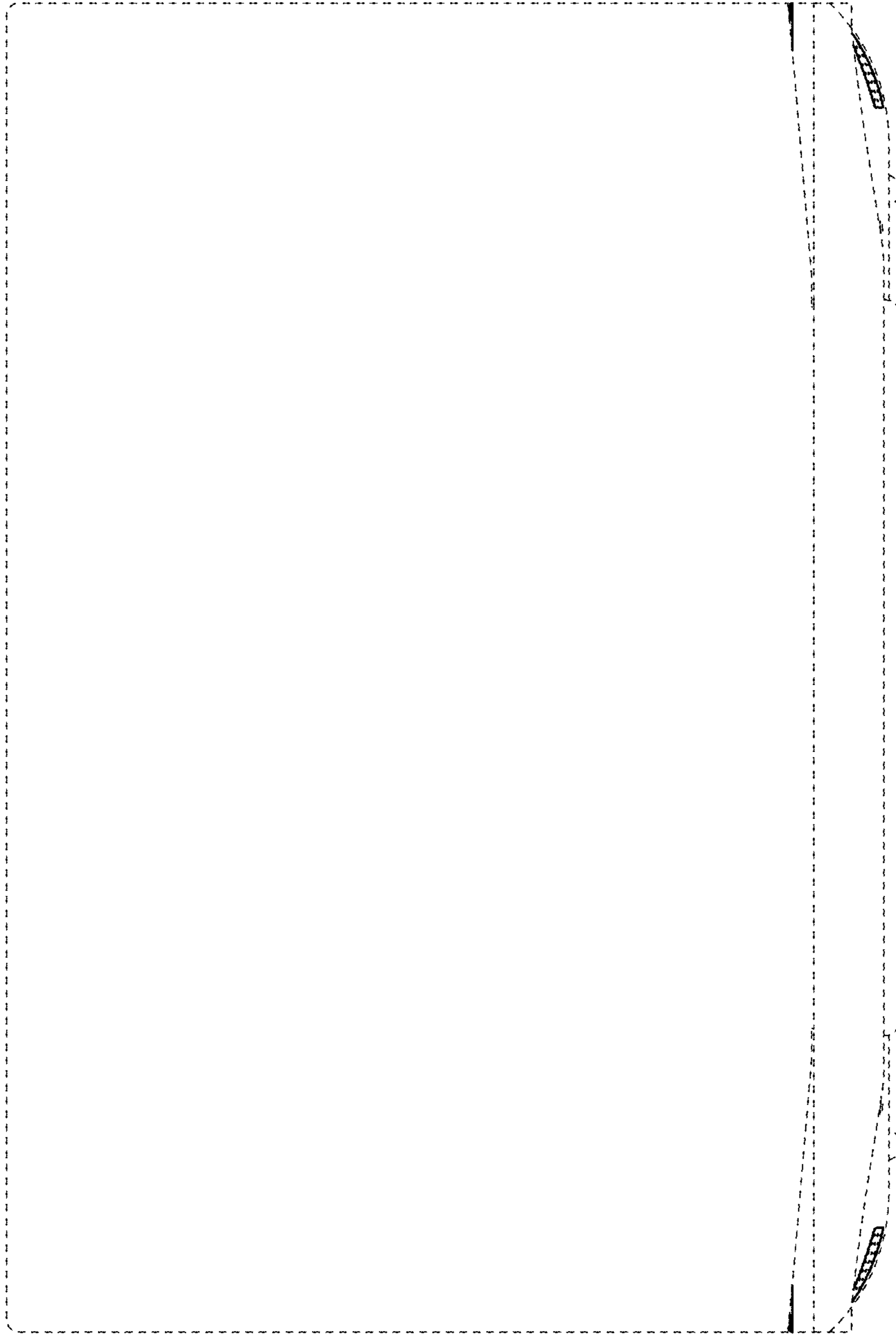

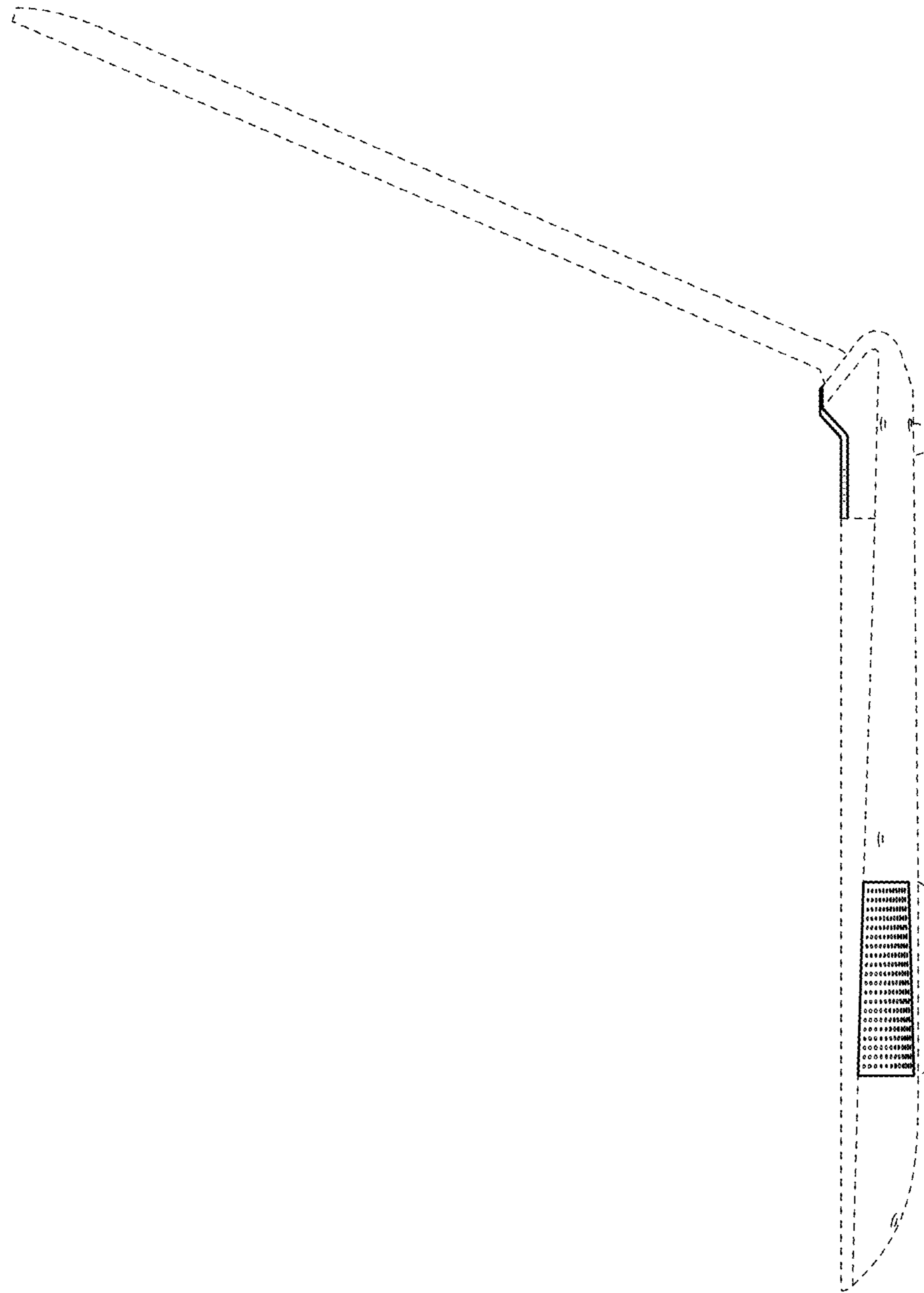

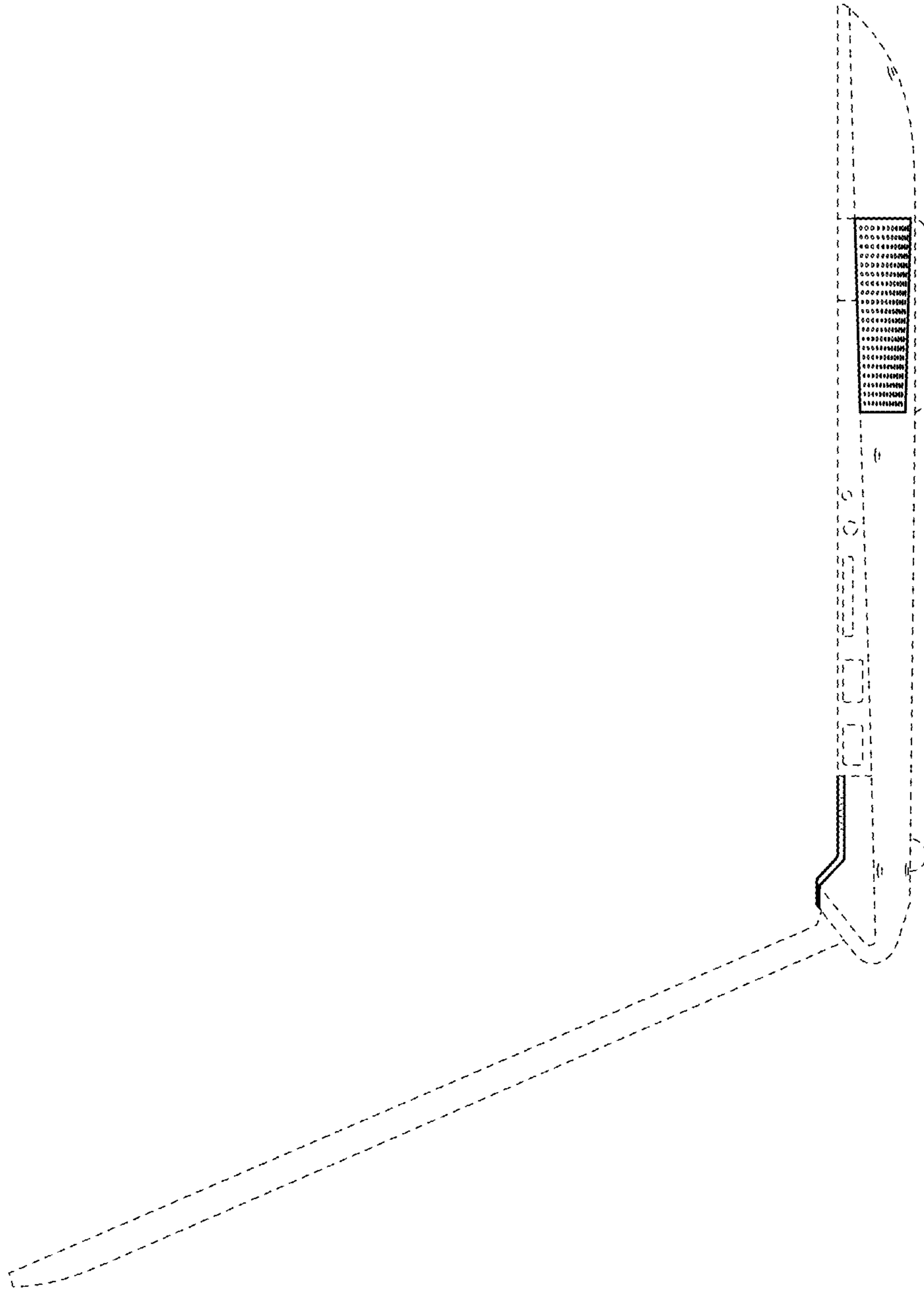

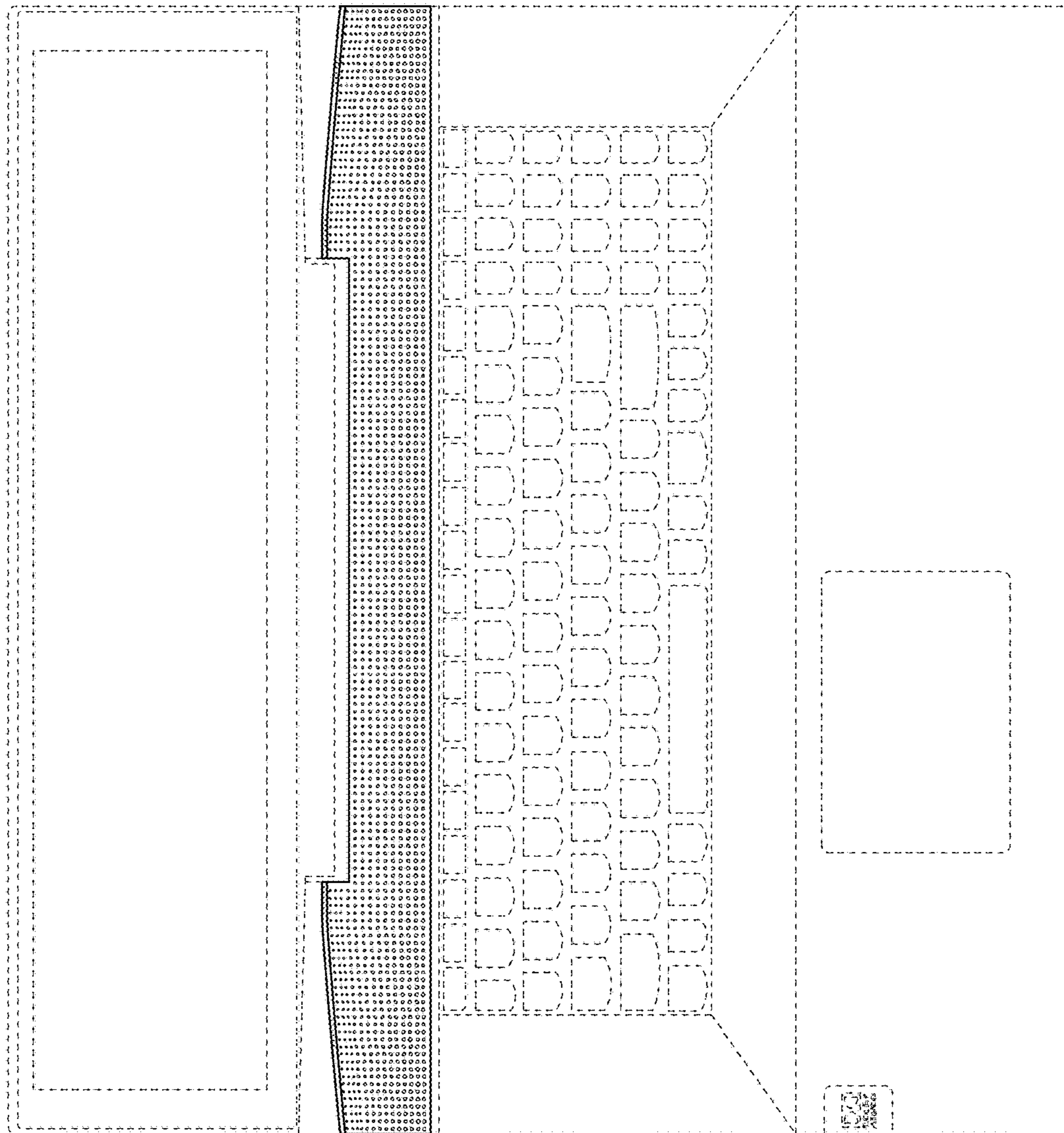

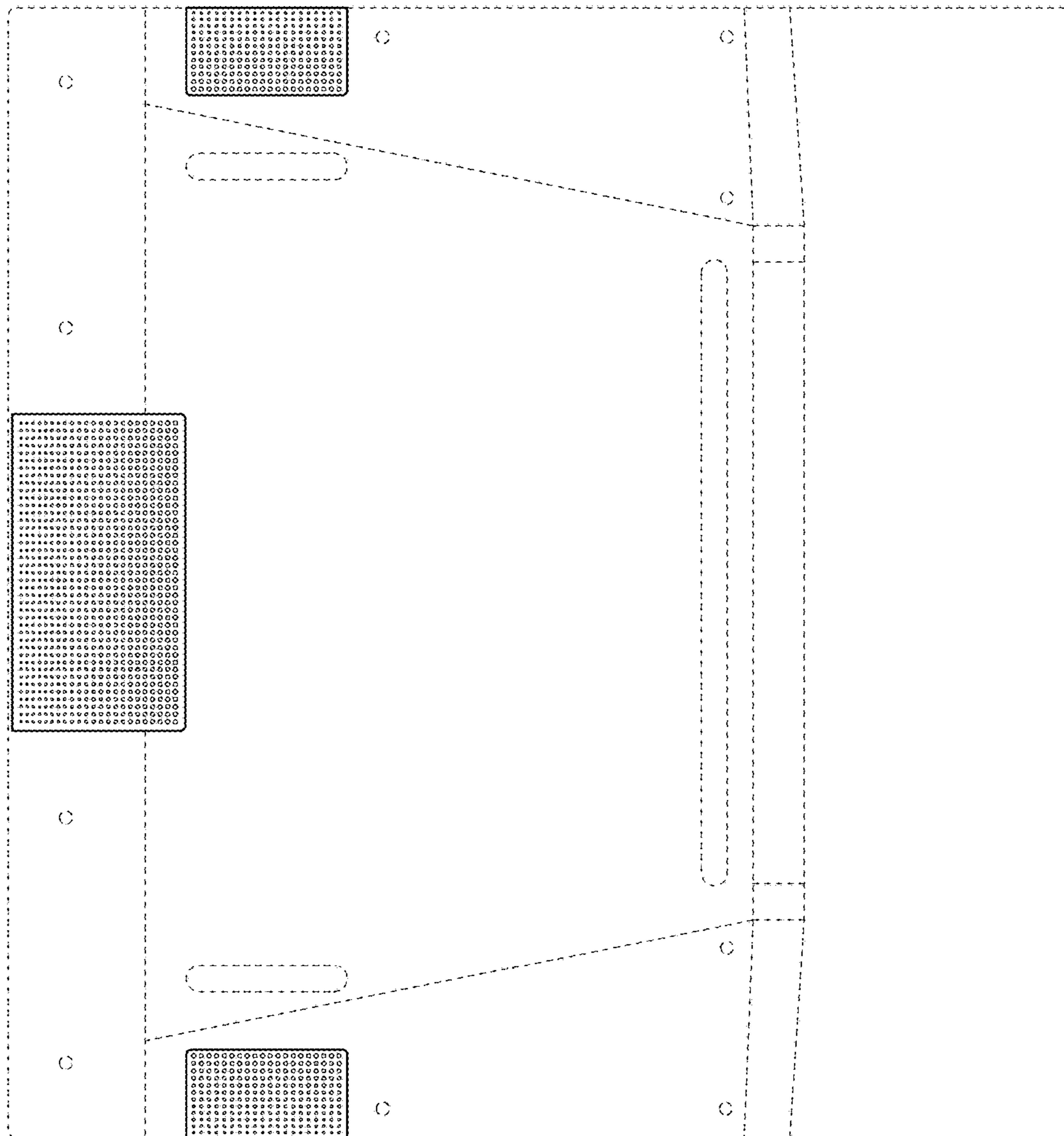

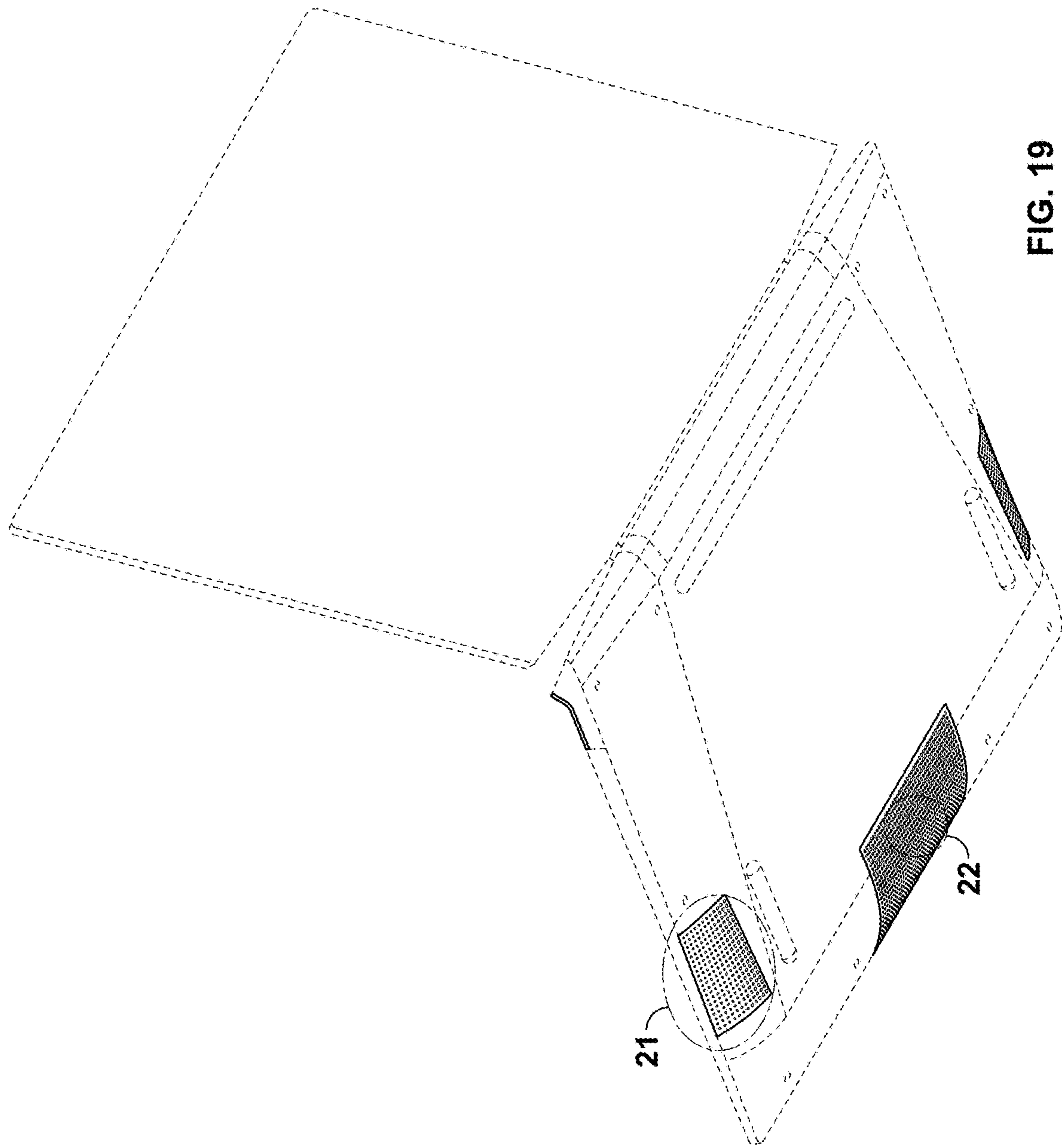

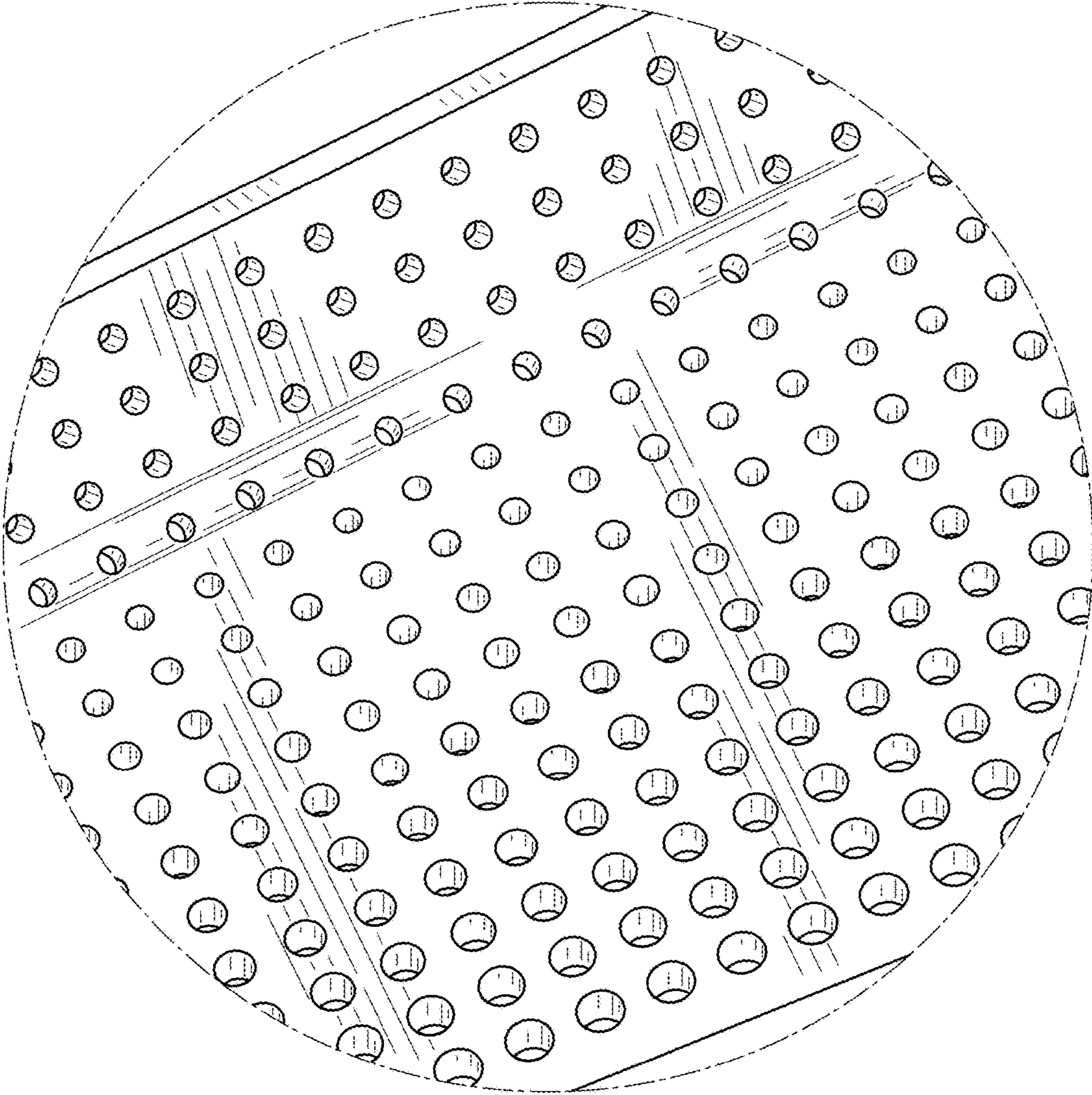

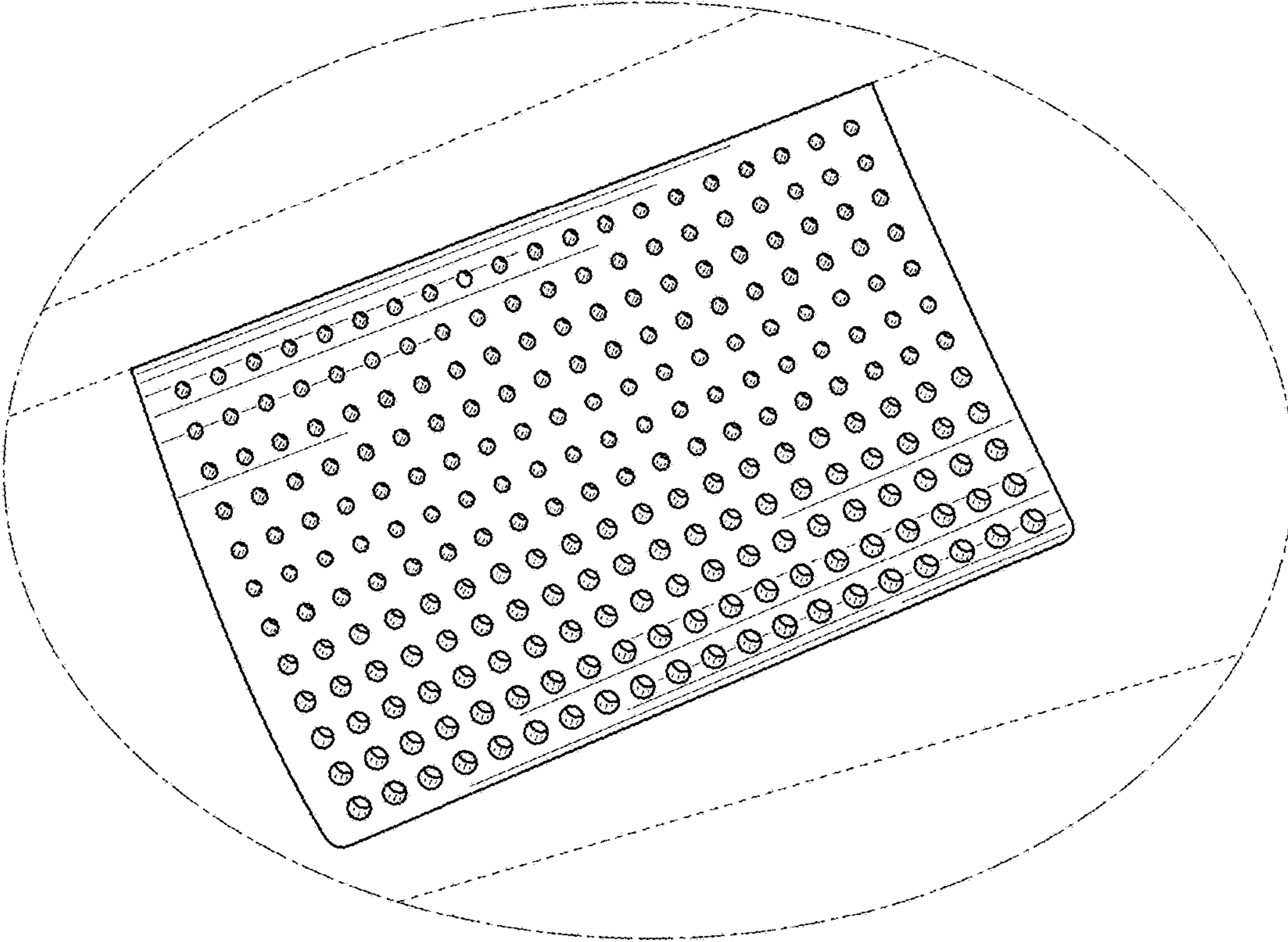

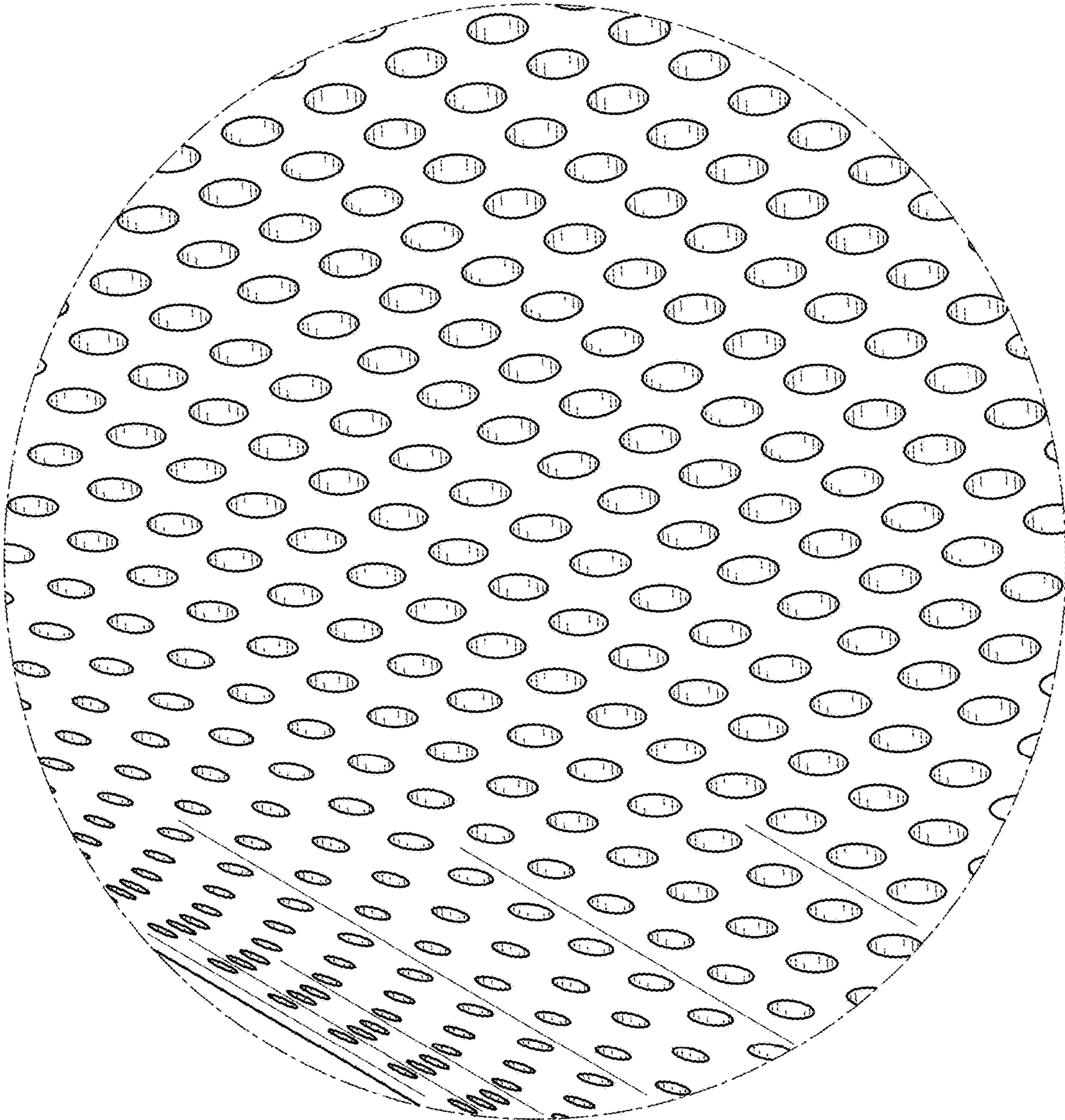
