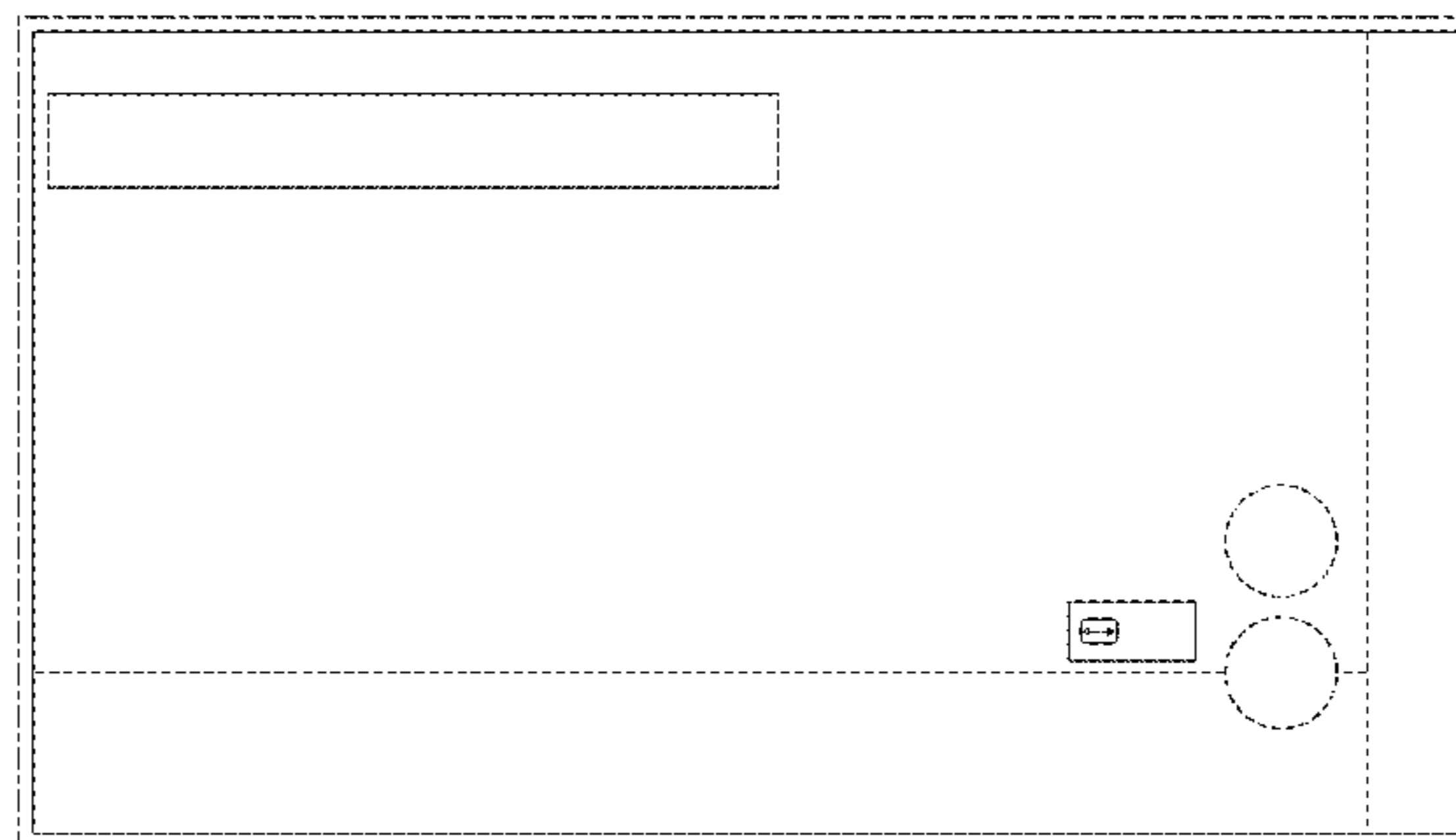
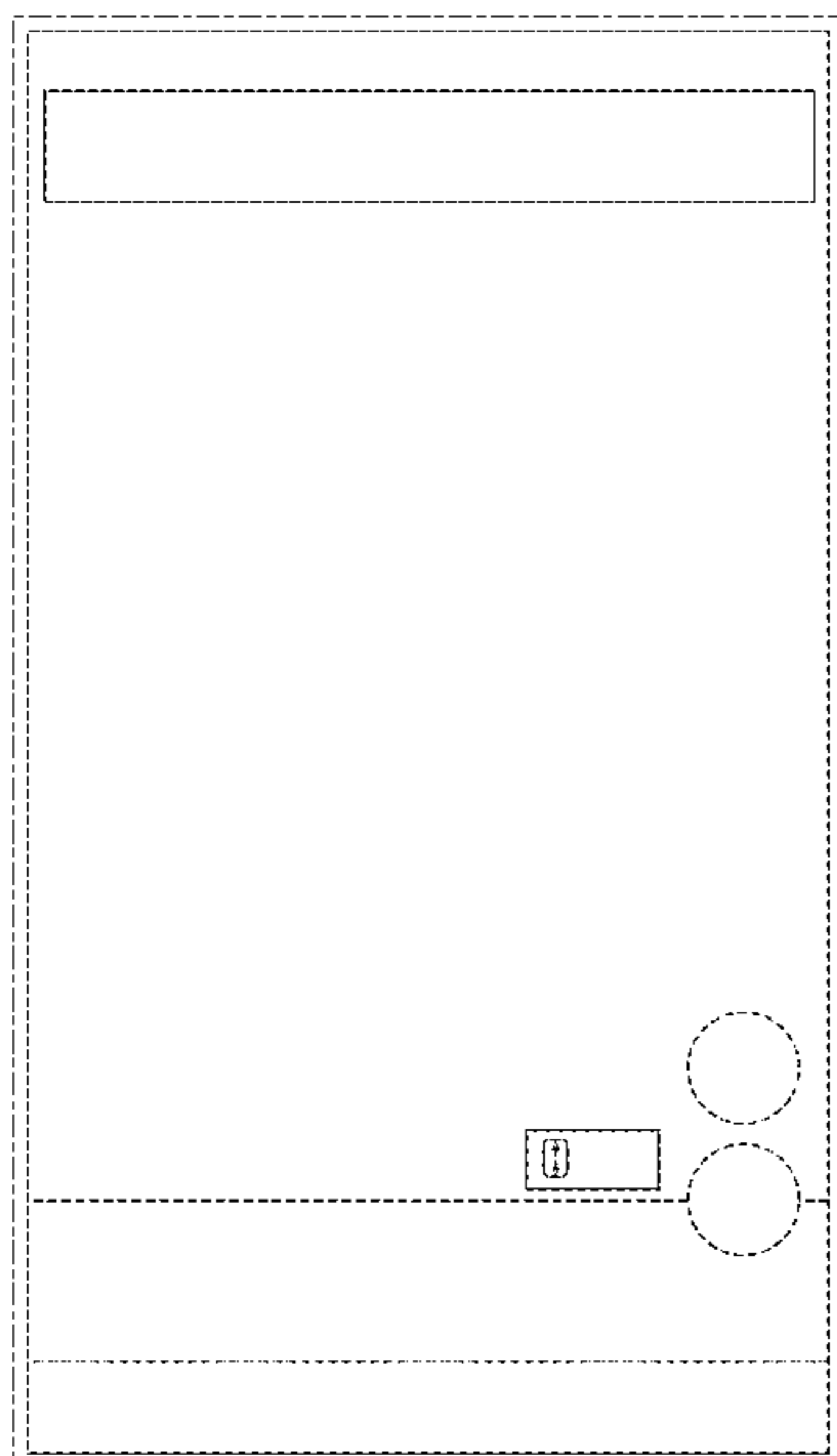
The ornamental design for display screen with graphical user interface, as shown and described.

DESCRIPTION

FIG. 1 is a front view of a display screen with graphical user interface, showing a first embodiment of our new design; FIG. 2 is a second embodiment thereof; FIG. 3 is a third embodiment thereof; and, FIG. 4 is a fourth embodiment thereof.

The broken lines of uneven length show the display screen and form no part of the claimed design. The broken lines of even length shown in the drawings illustrate portions of the display screen with graphical user interface that form no part of the claimed design.

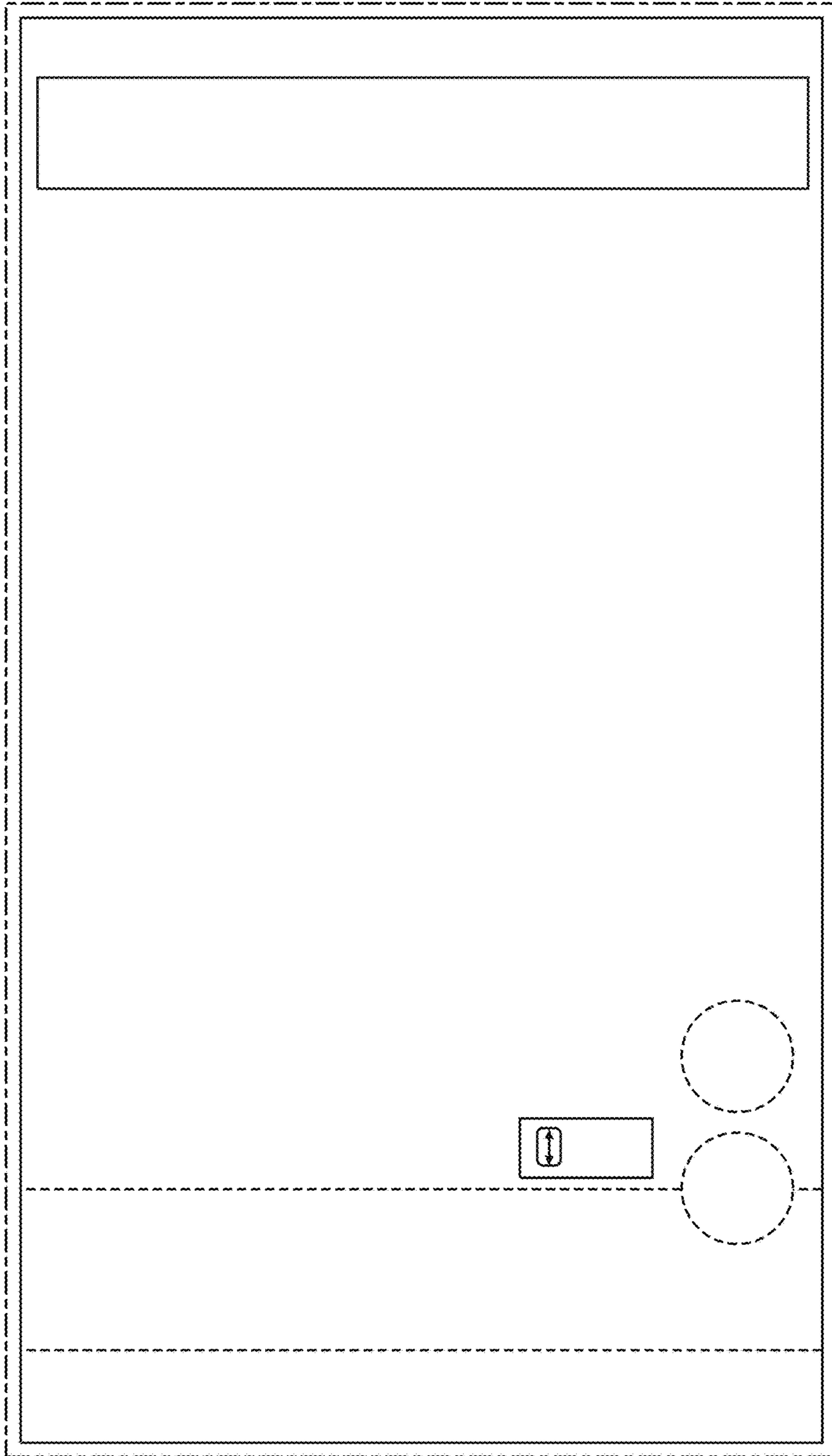

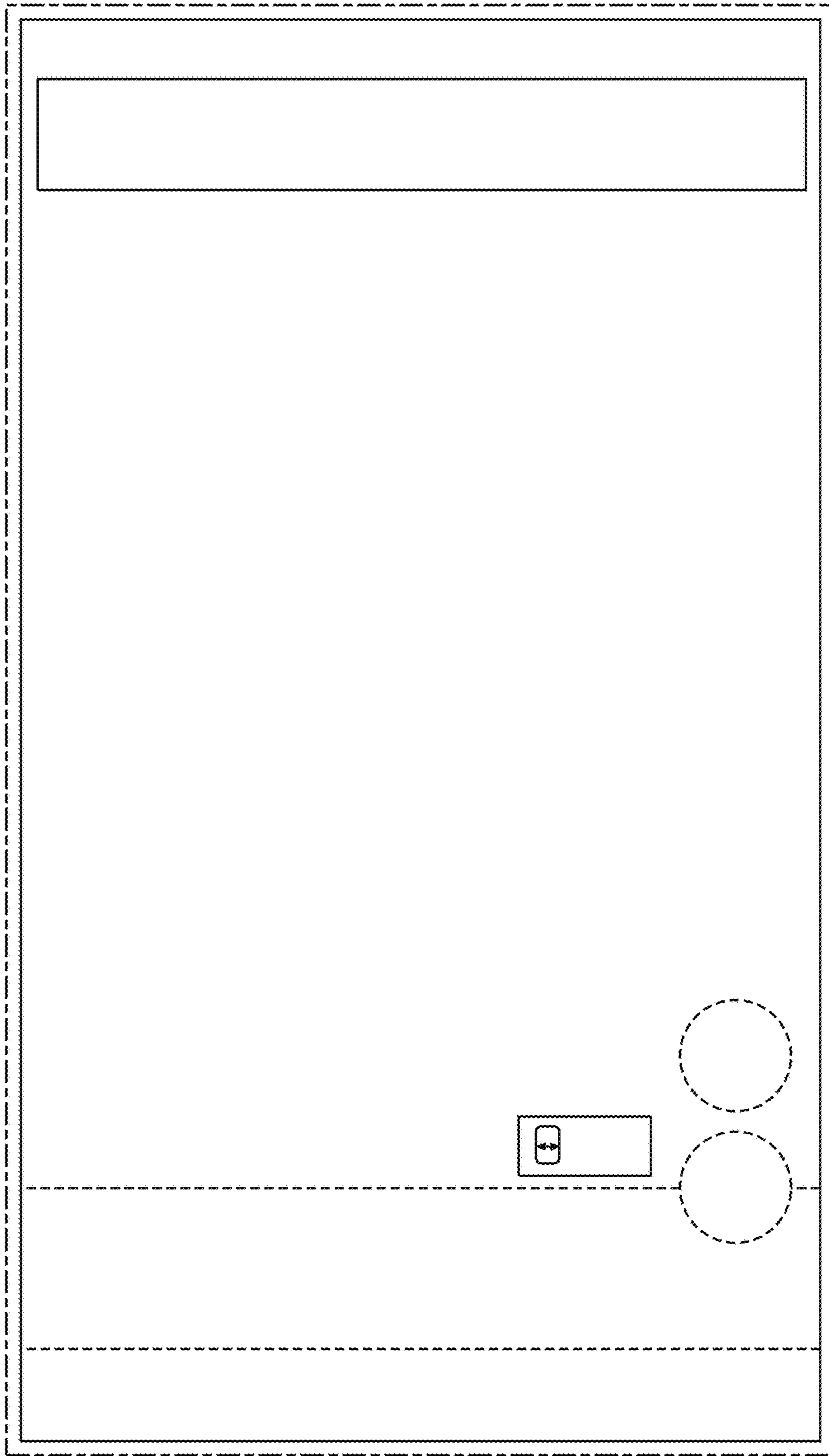

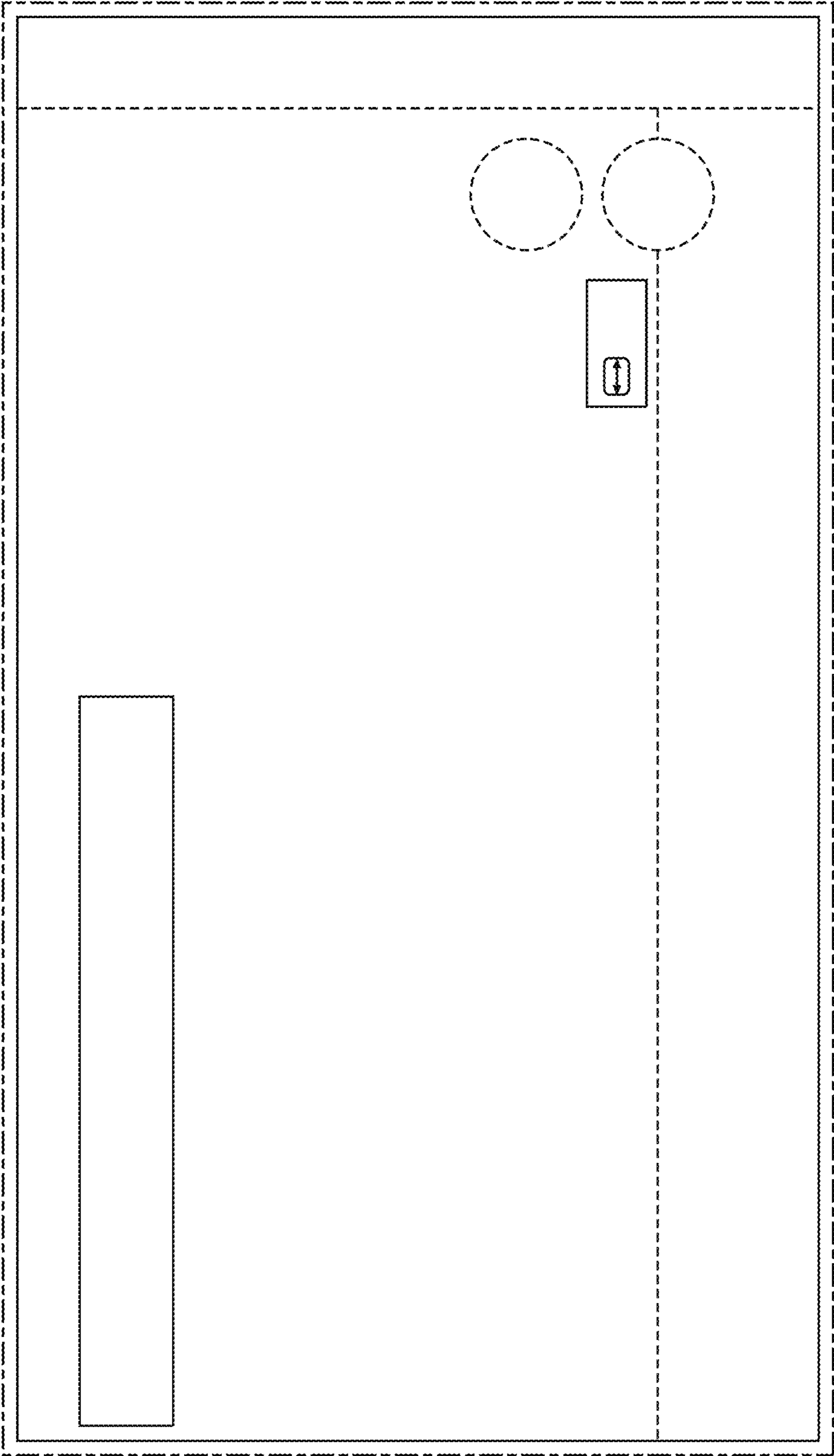

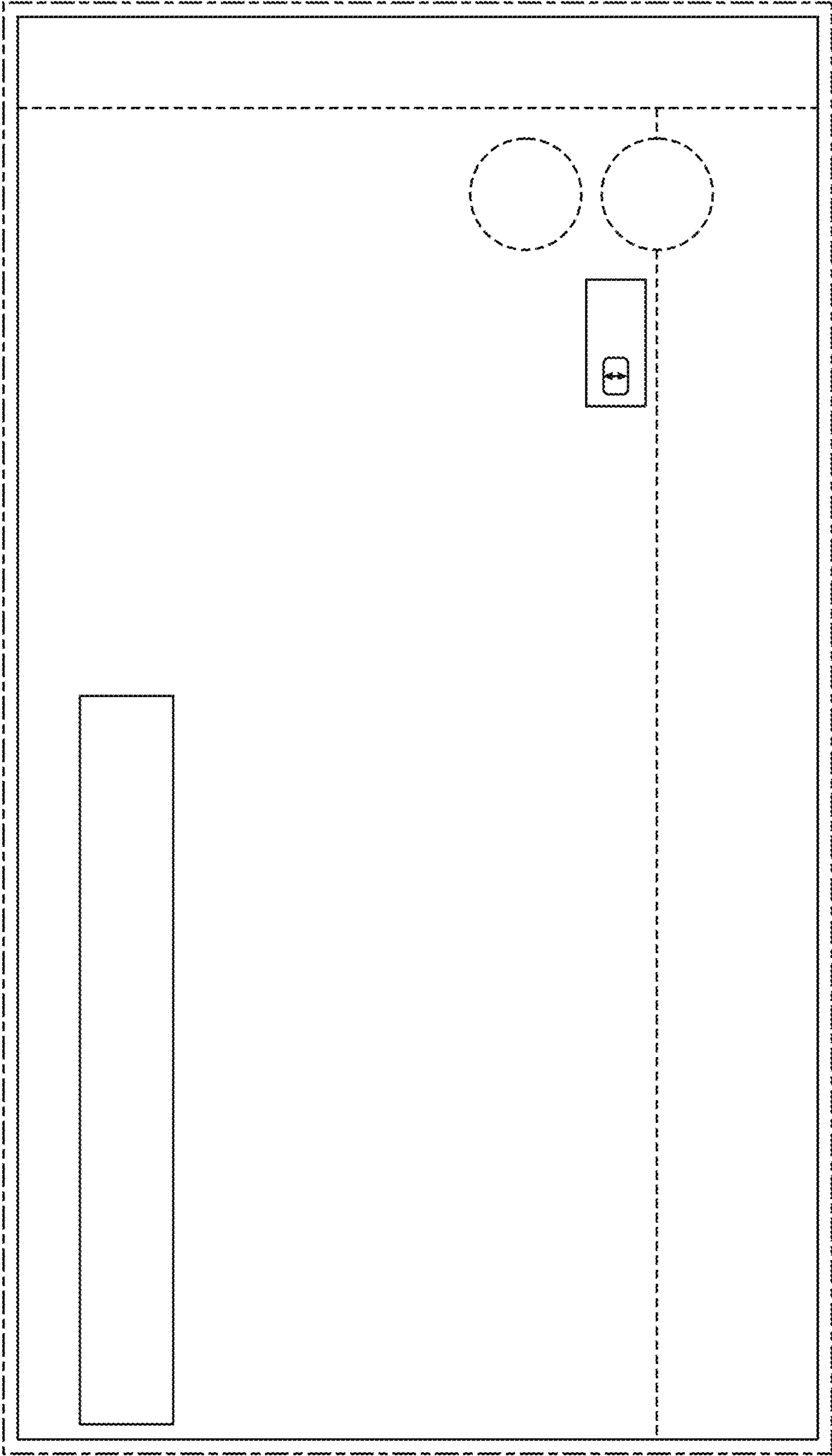
