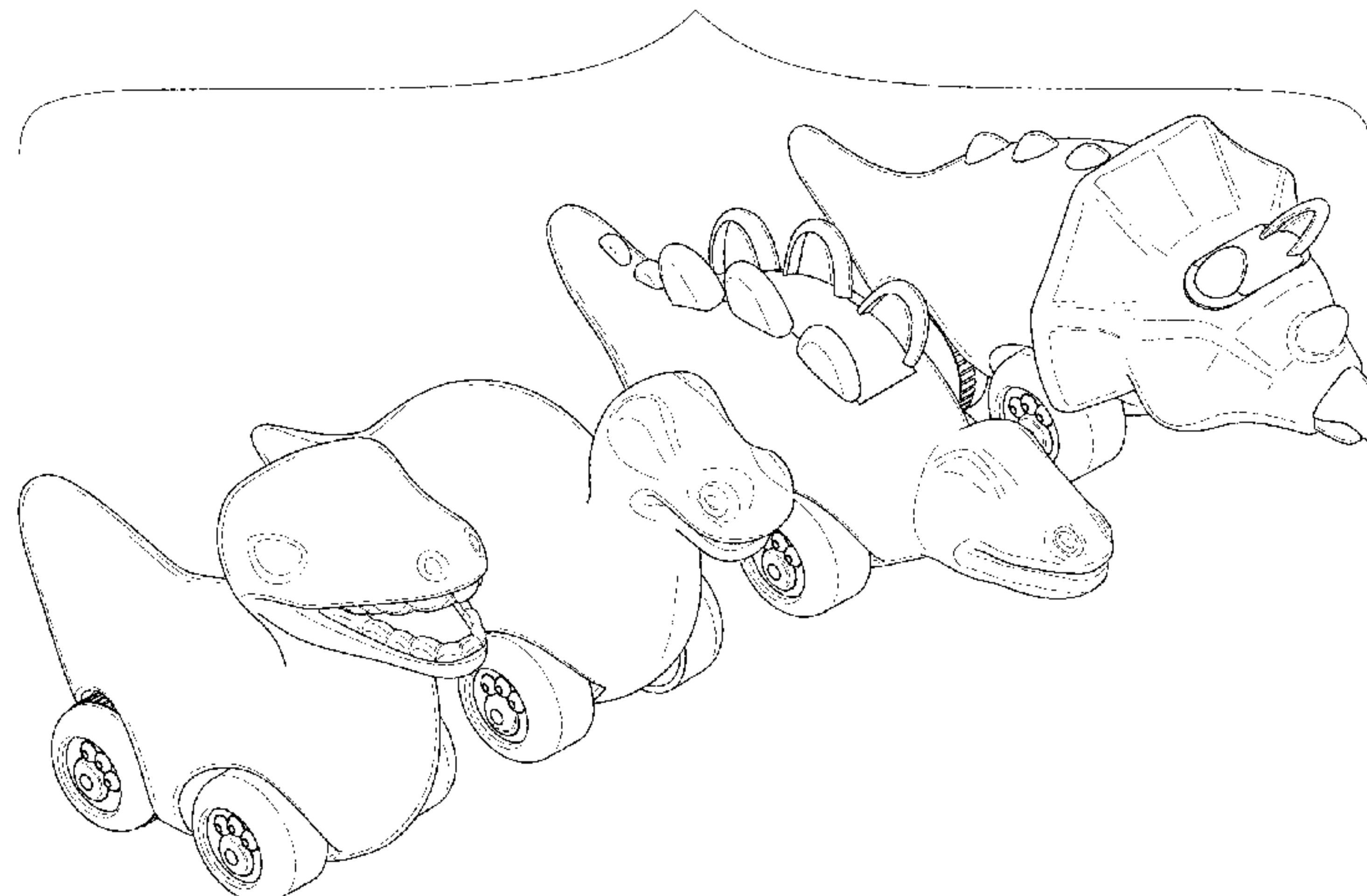
The ornamental design for the toy dinosaur set, as shown and described.

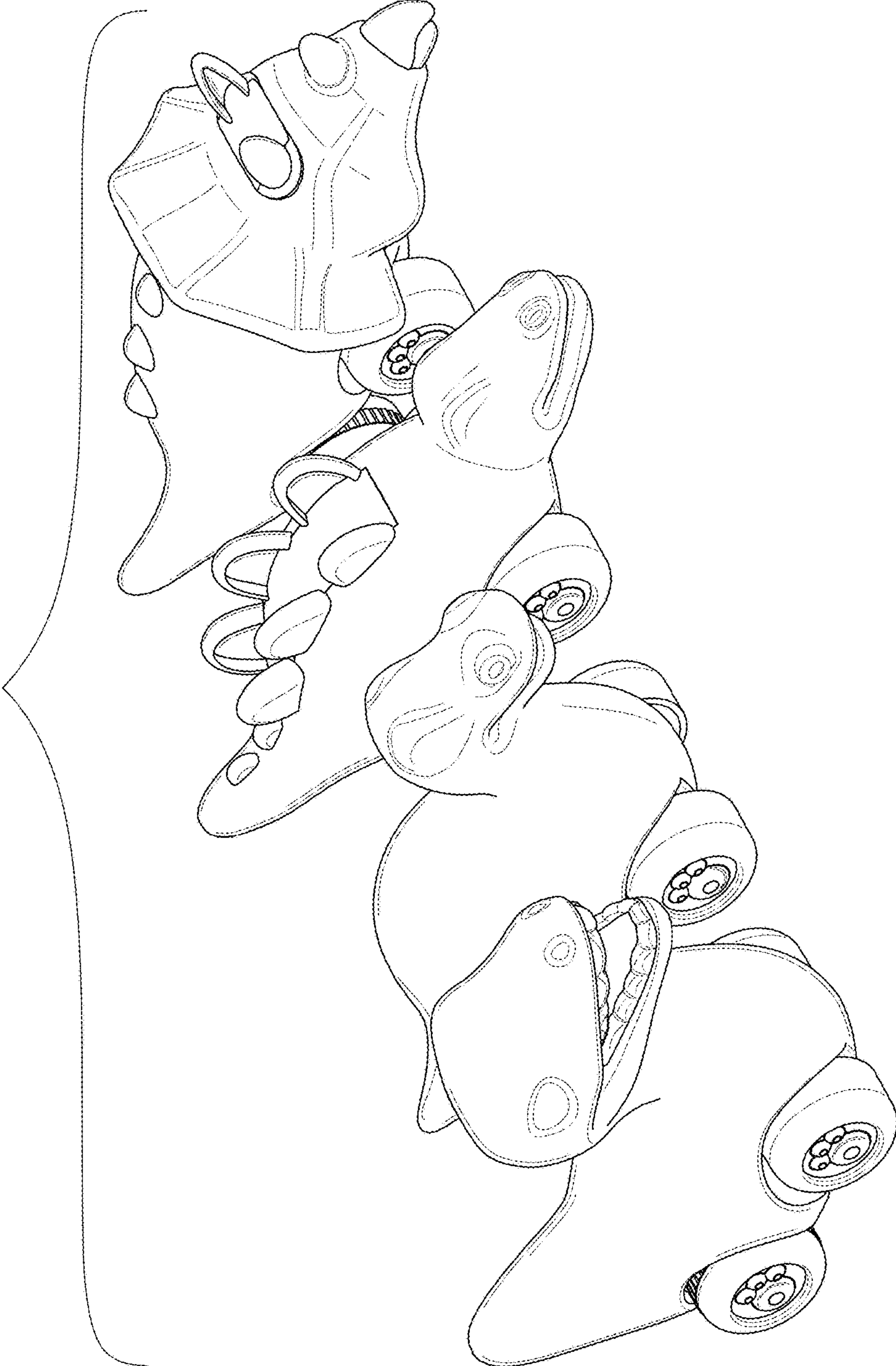

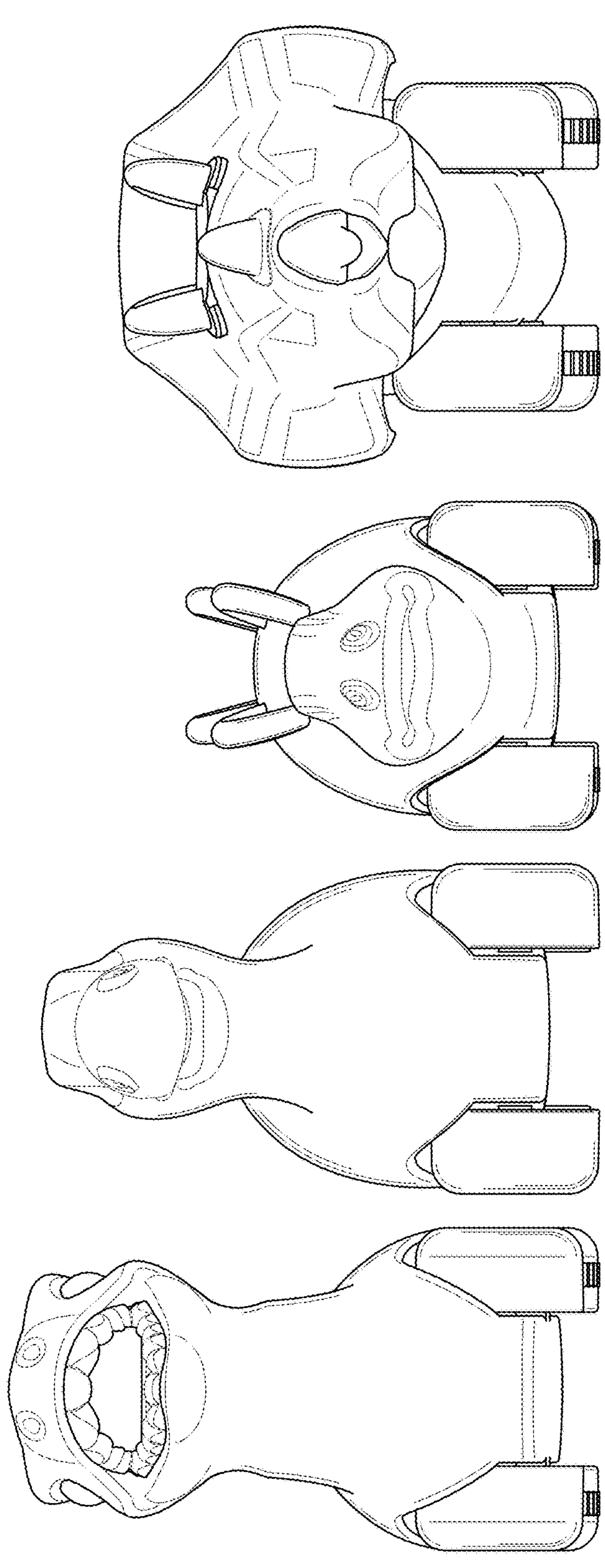

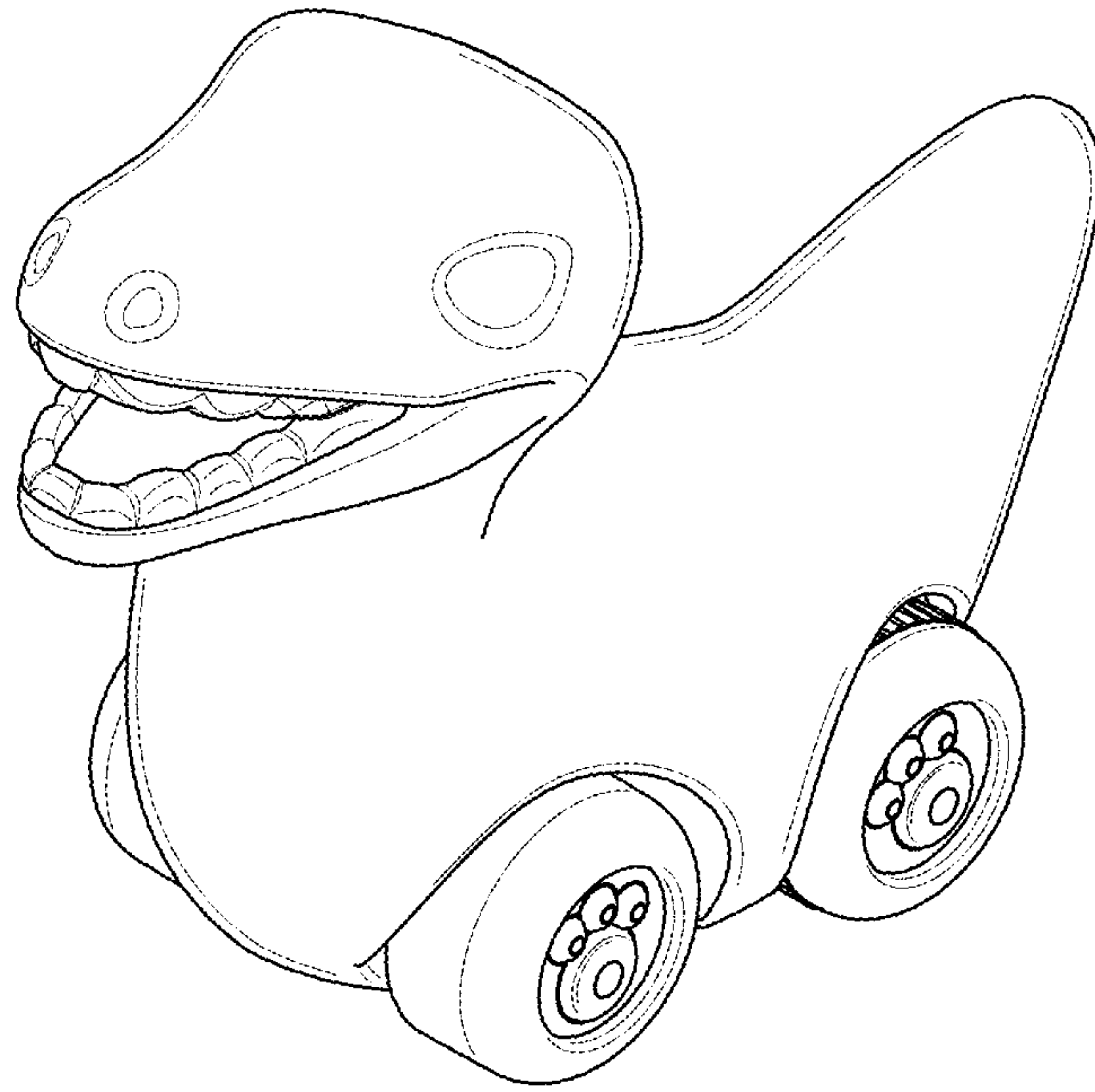

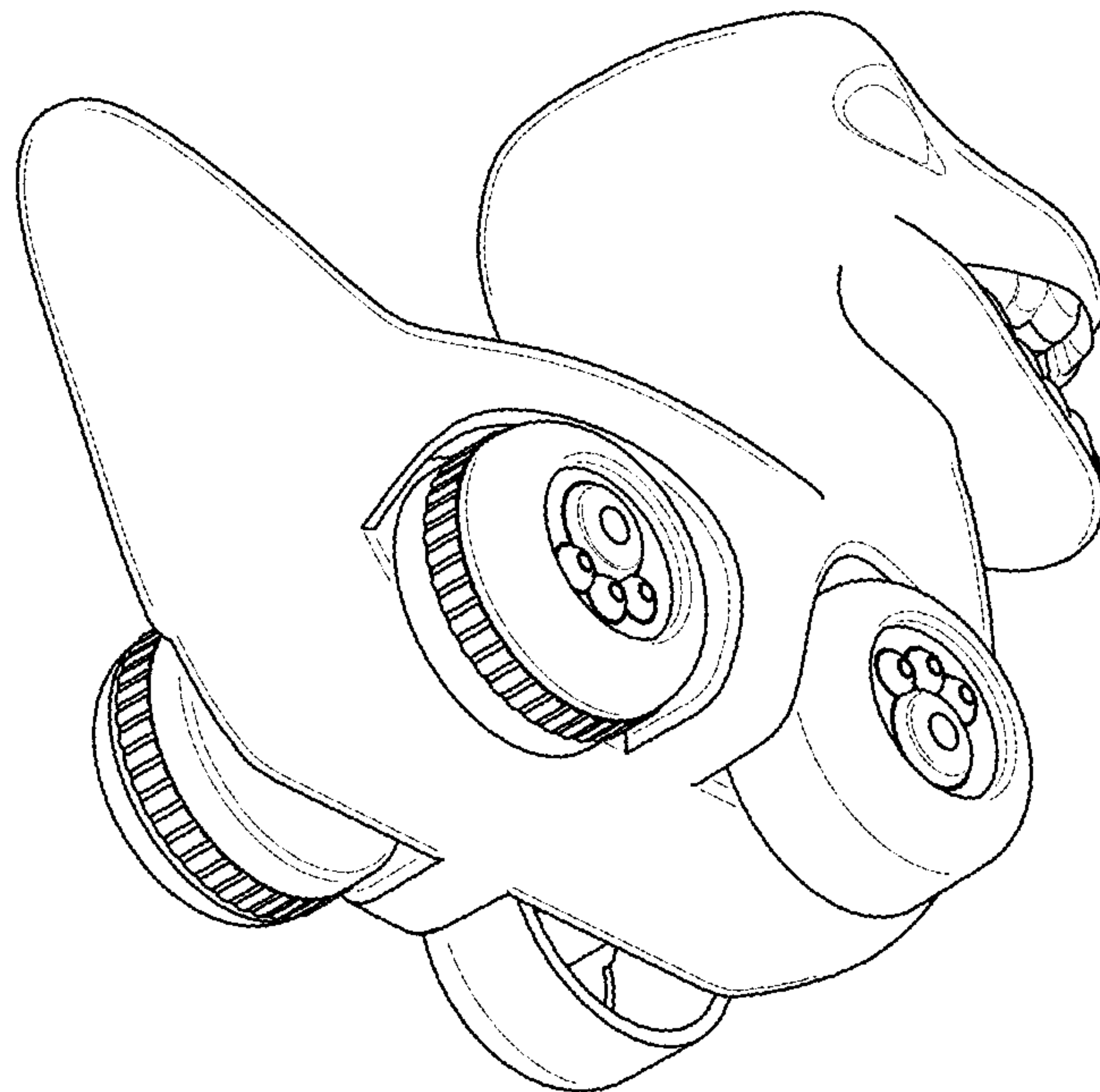

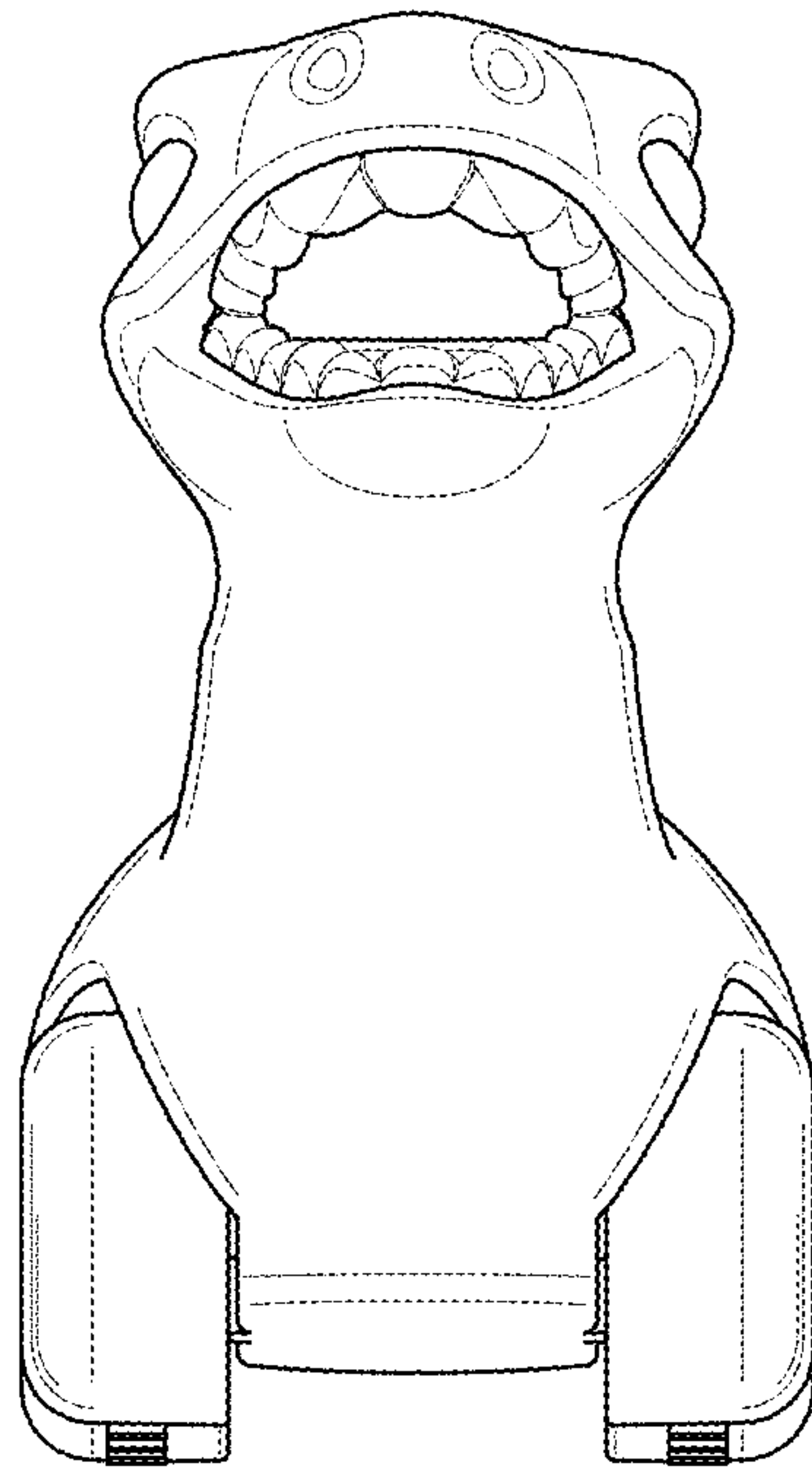

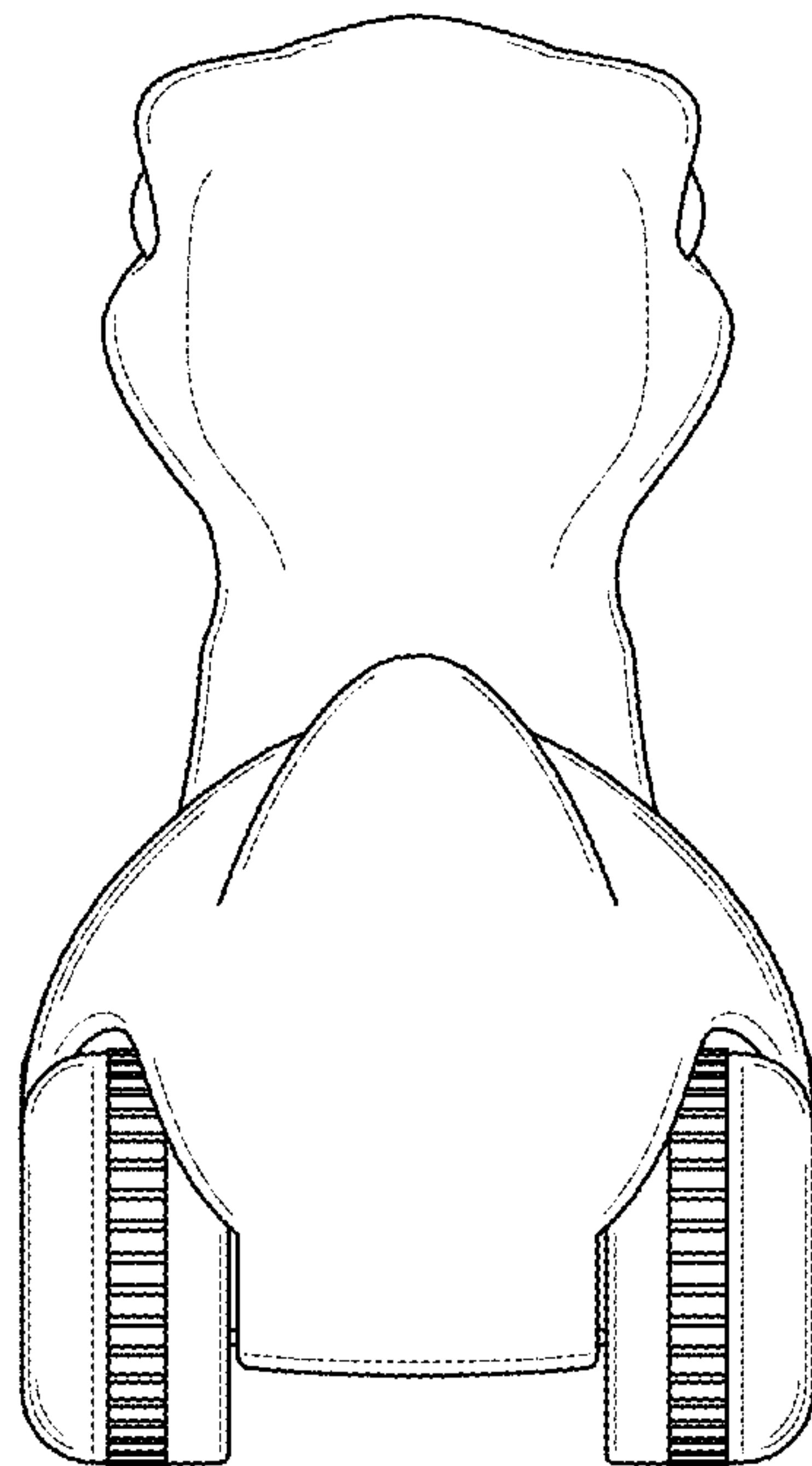

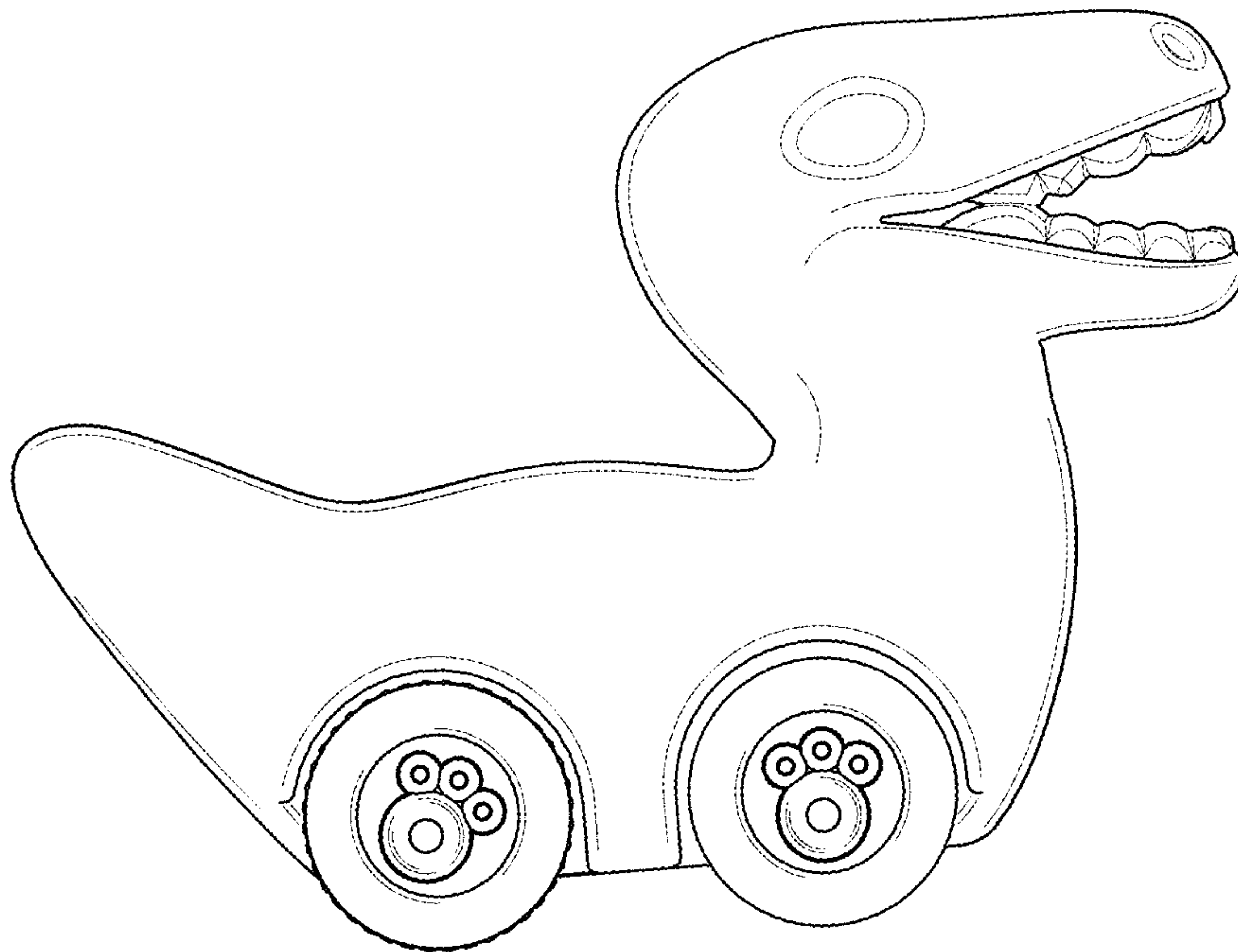

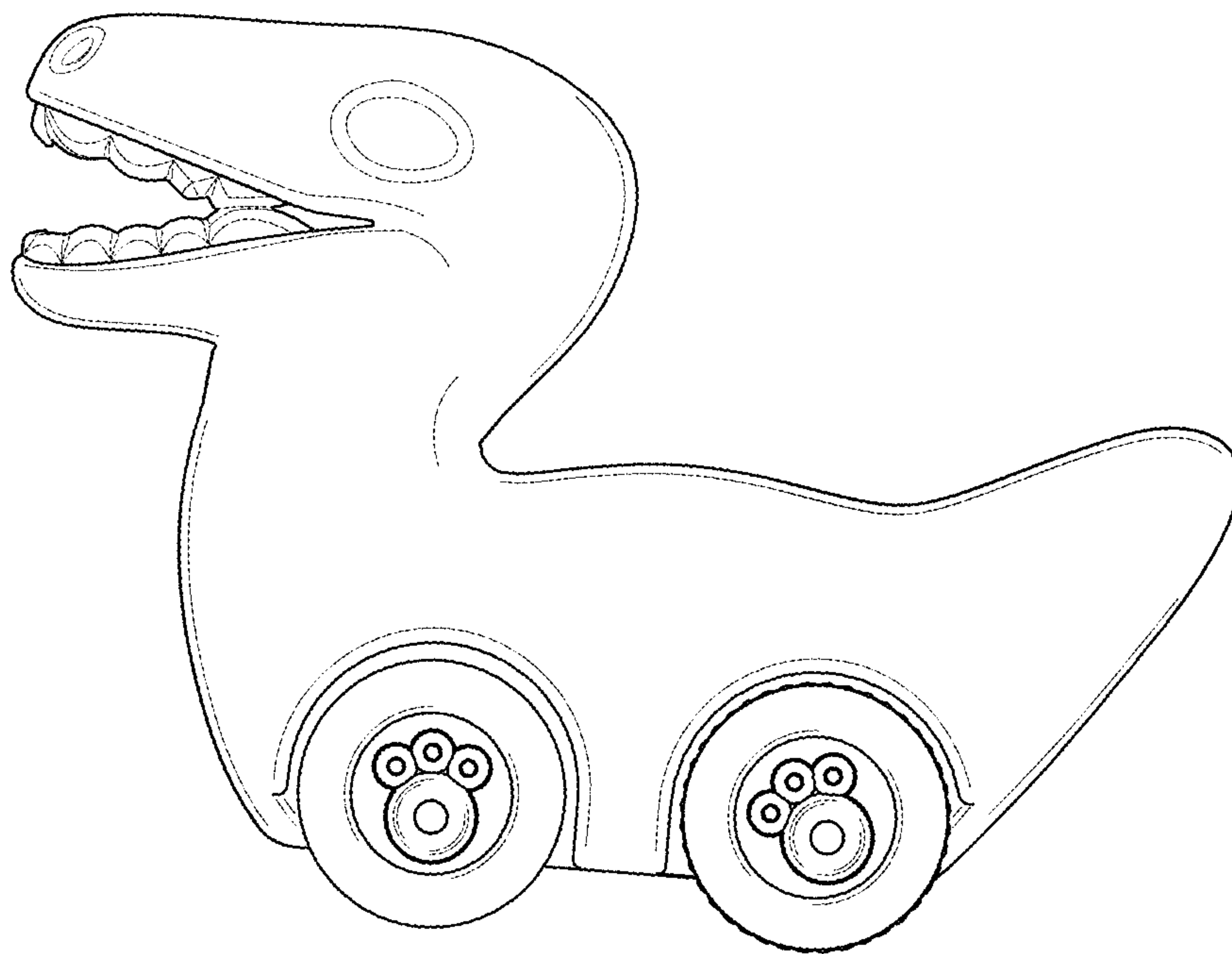

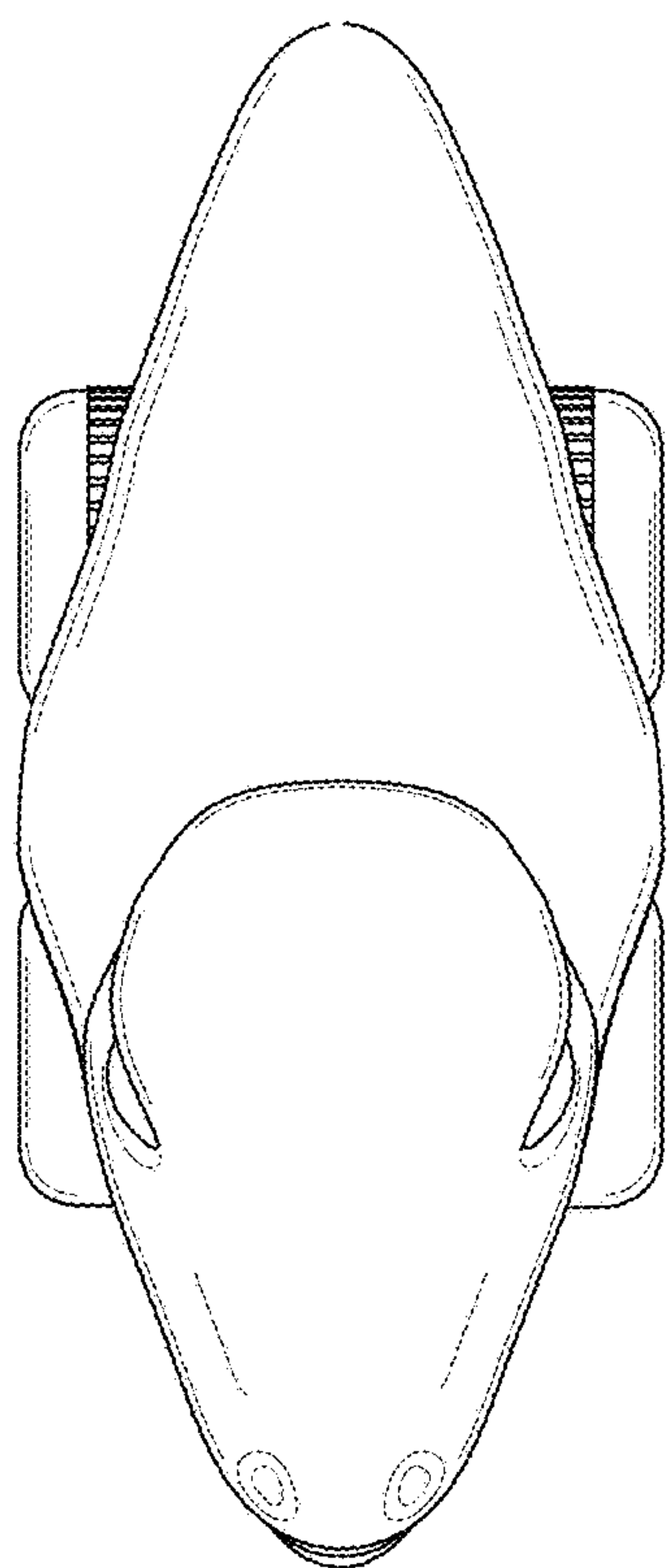

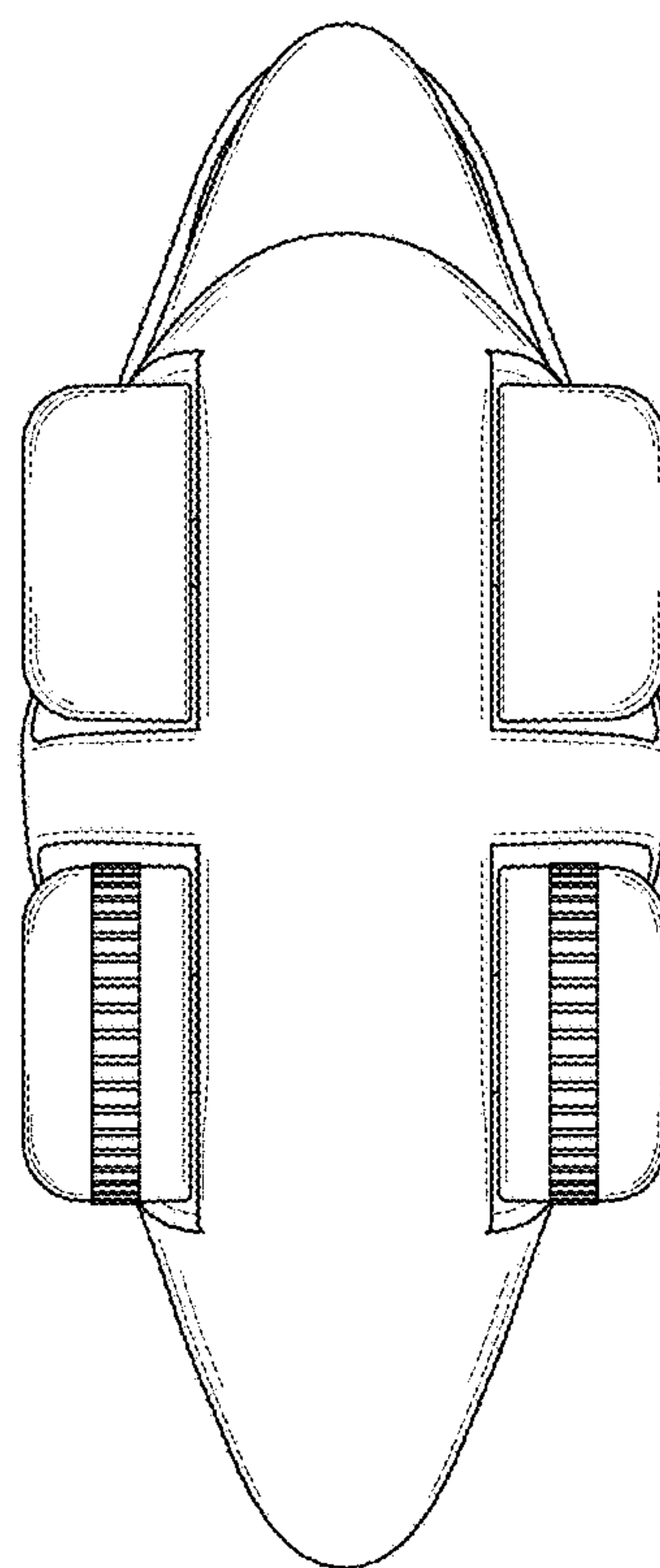

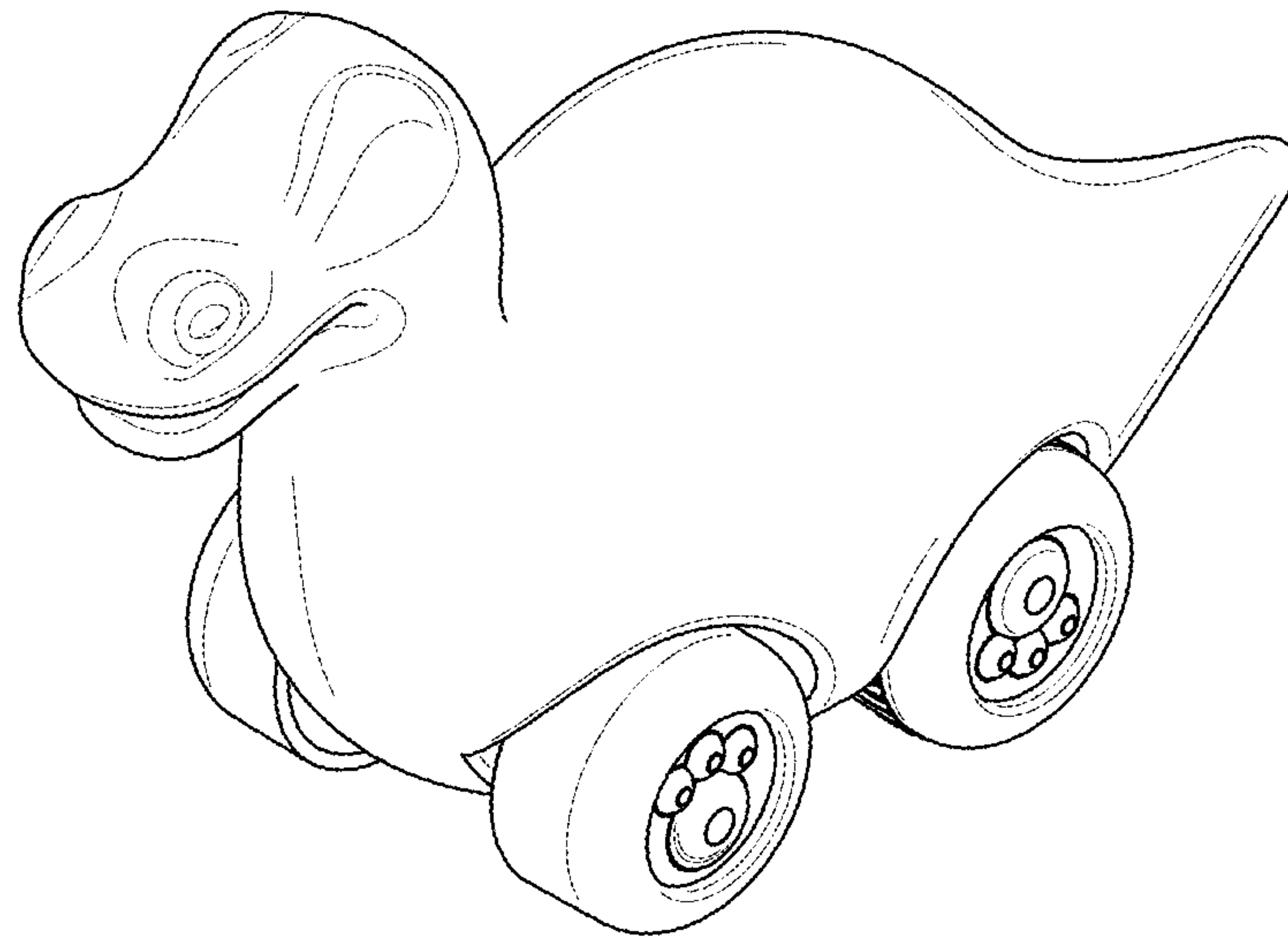

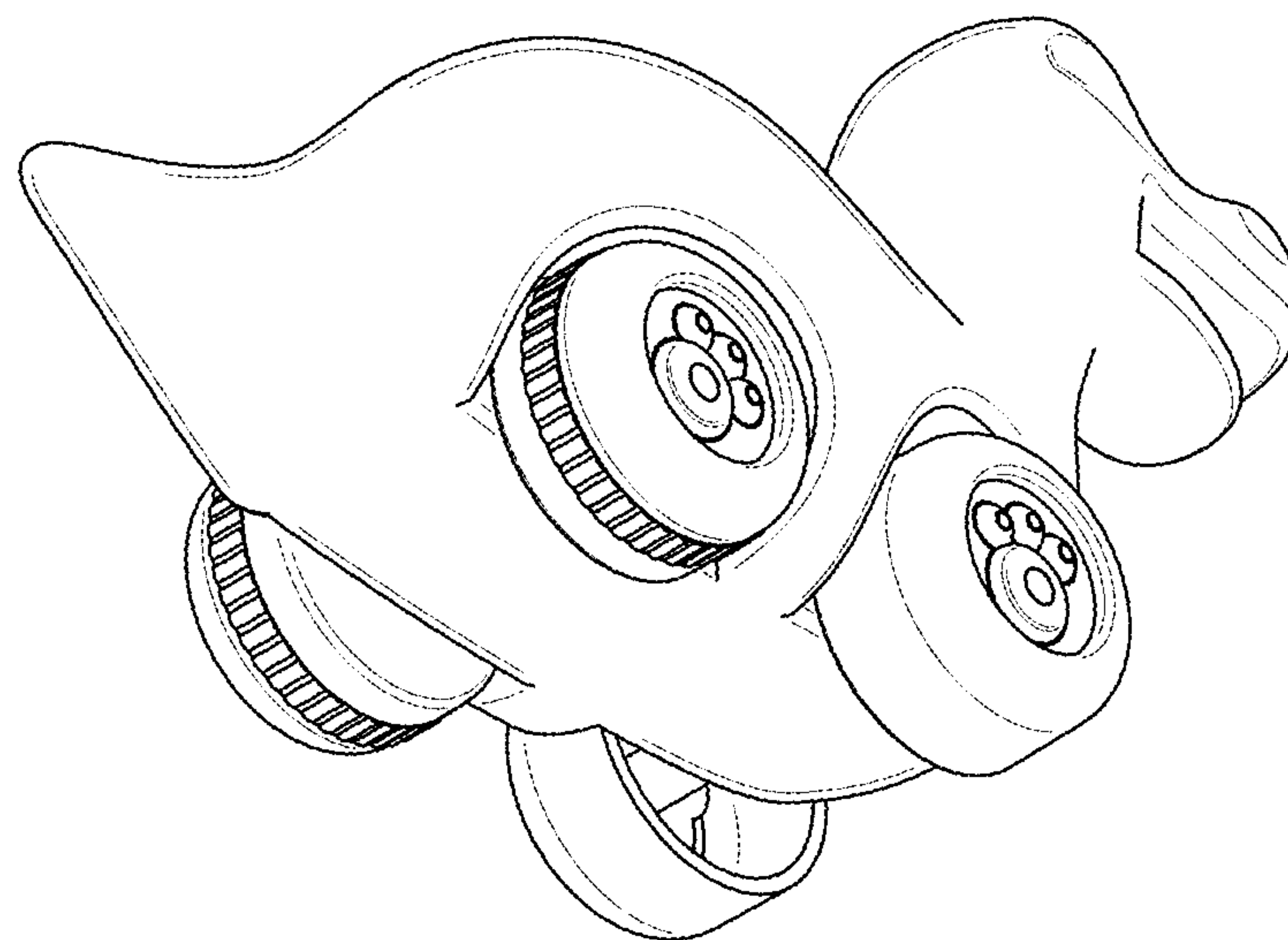

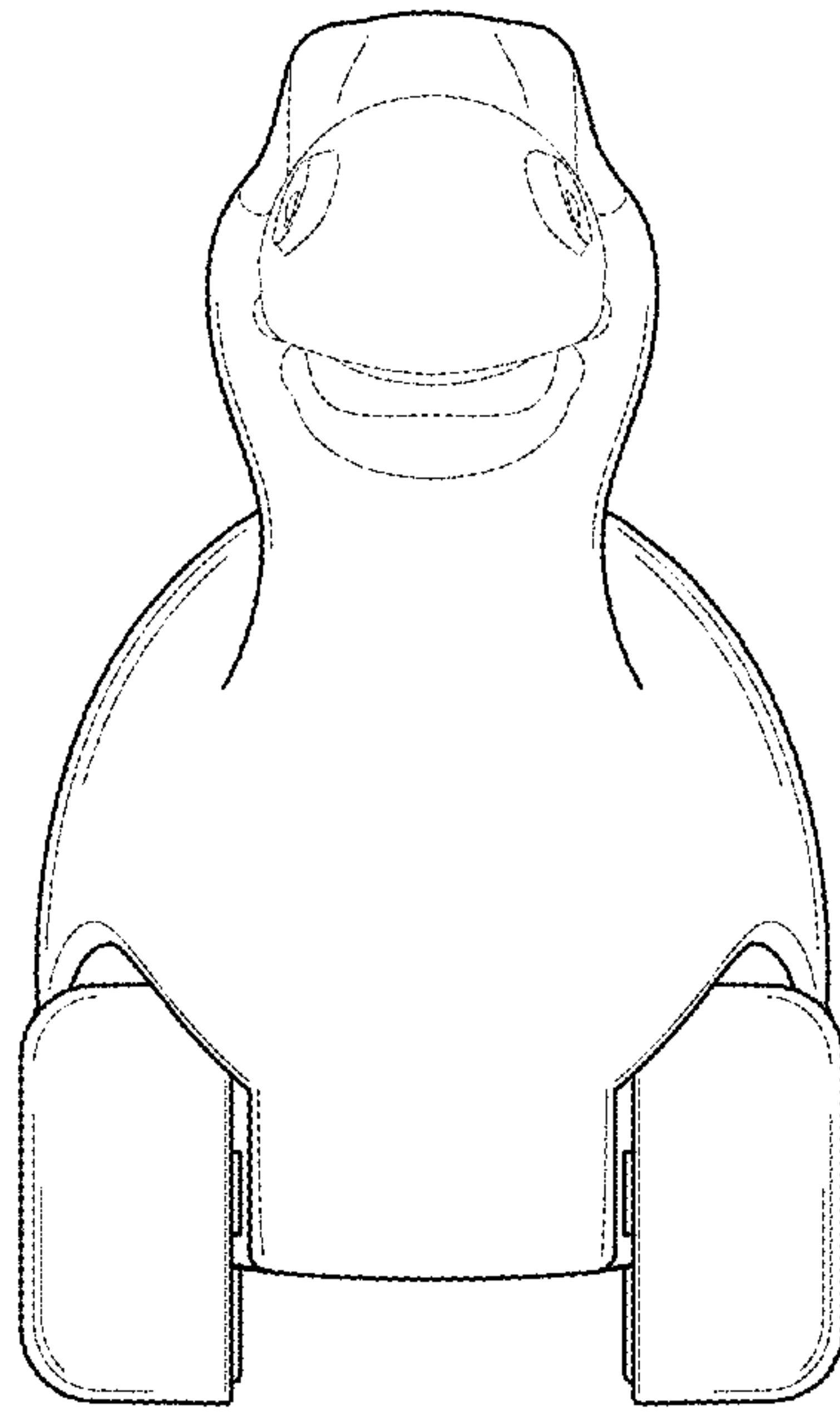

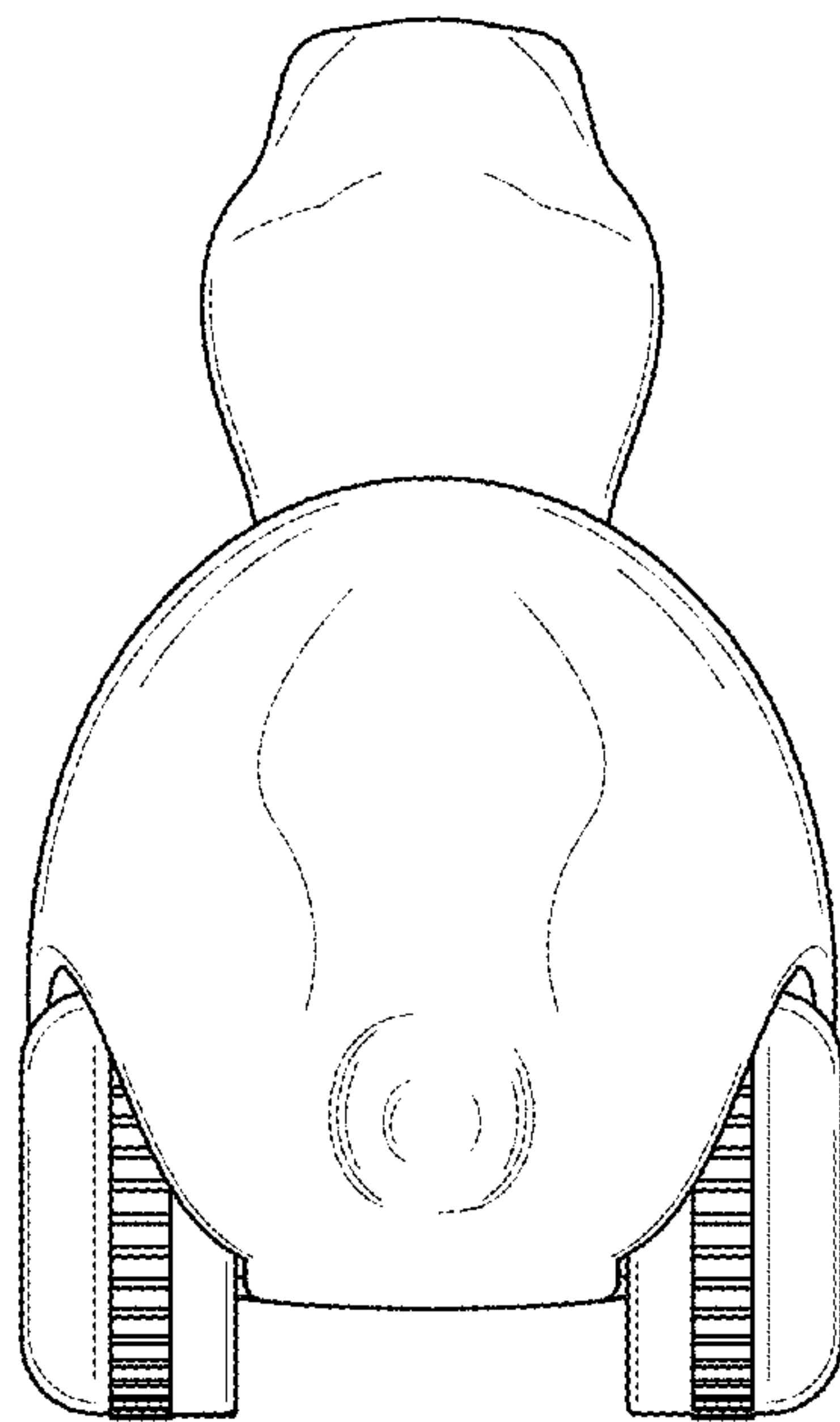

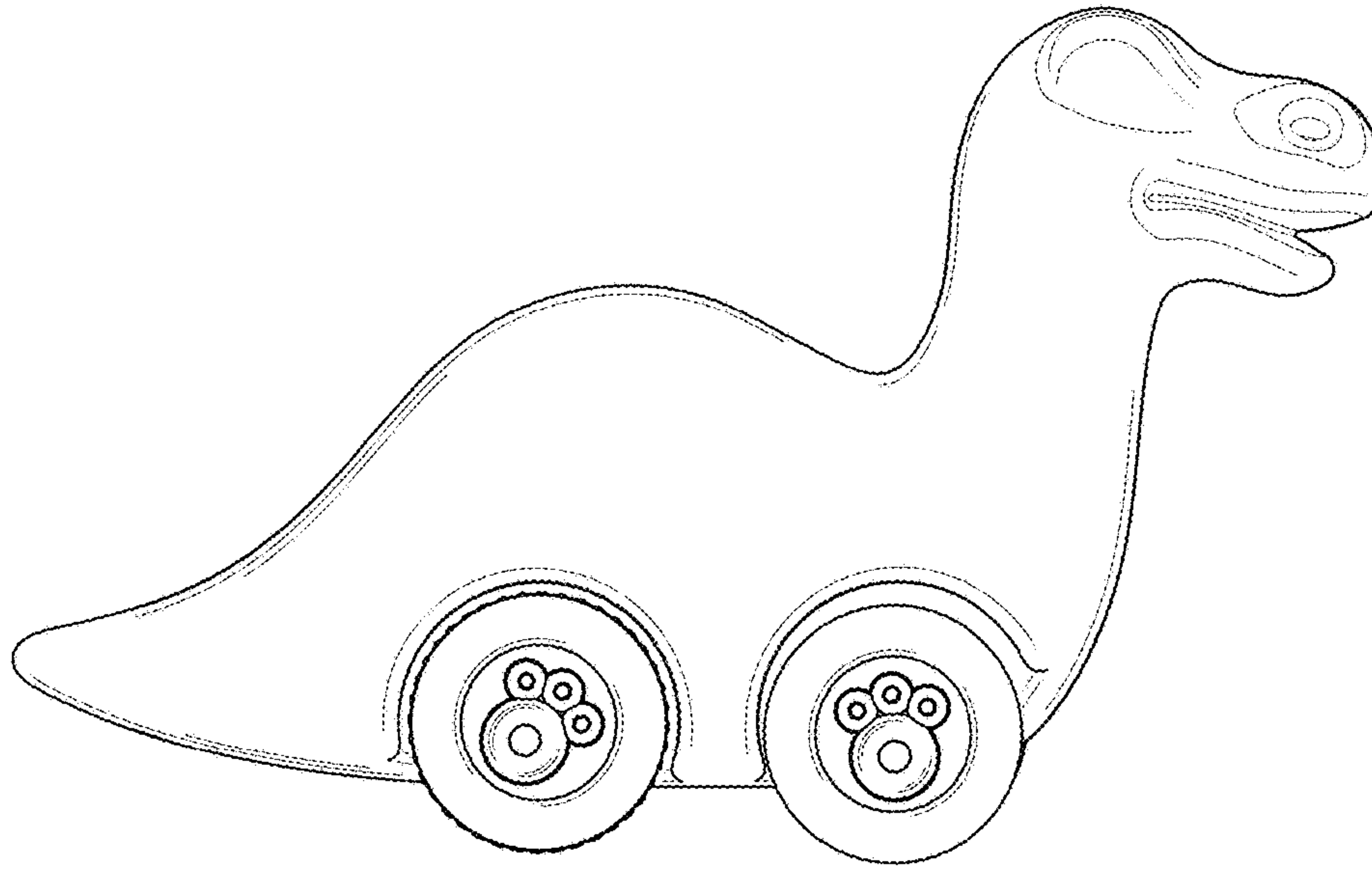

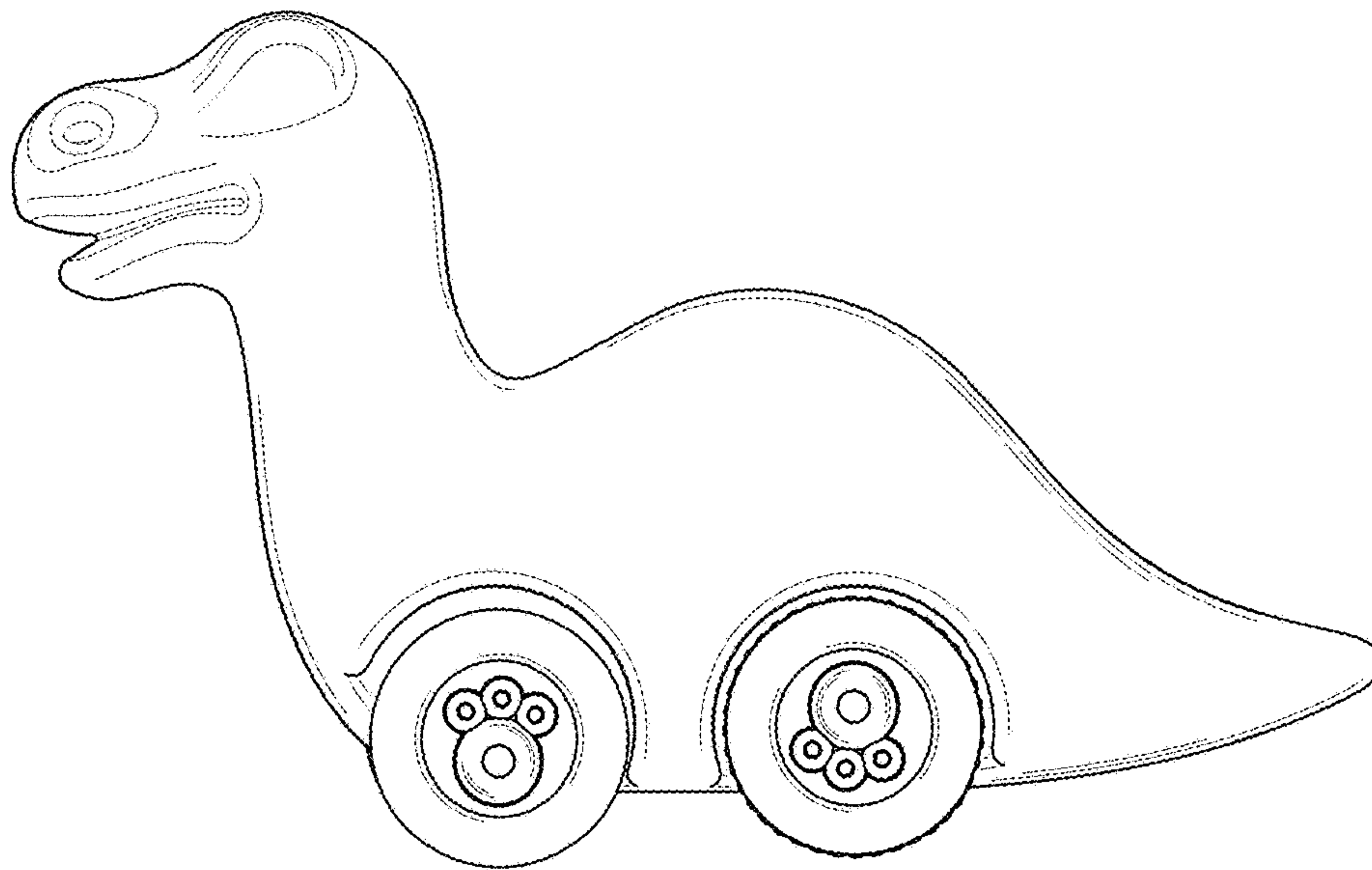

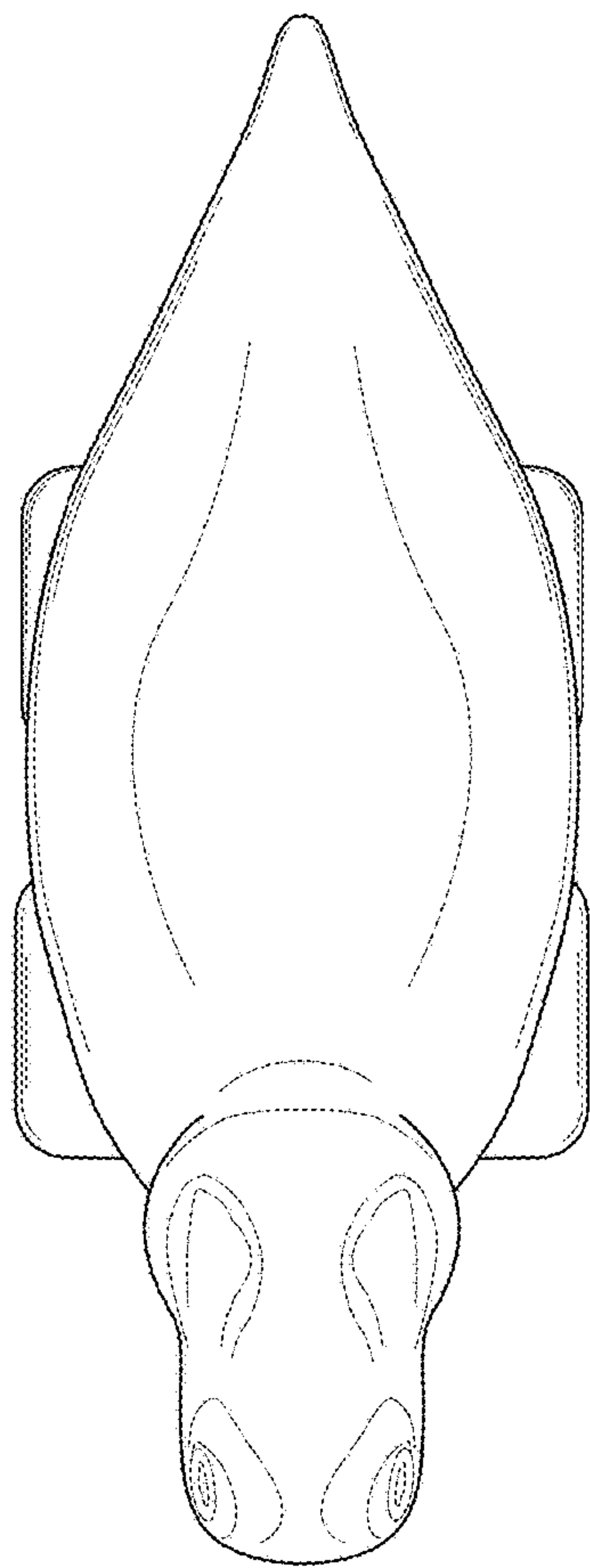

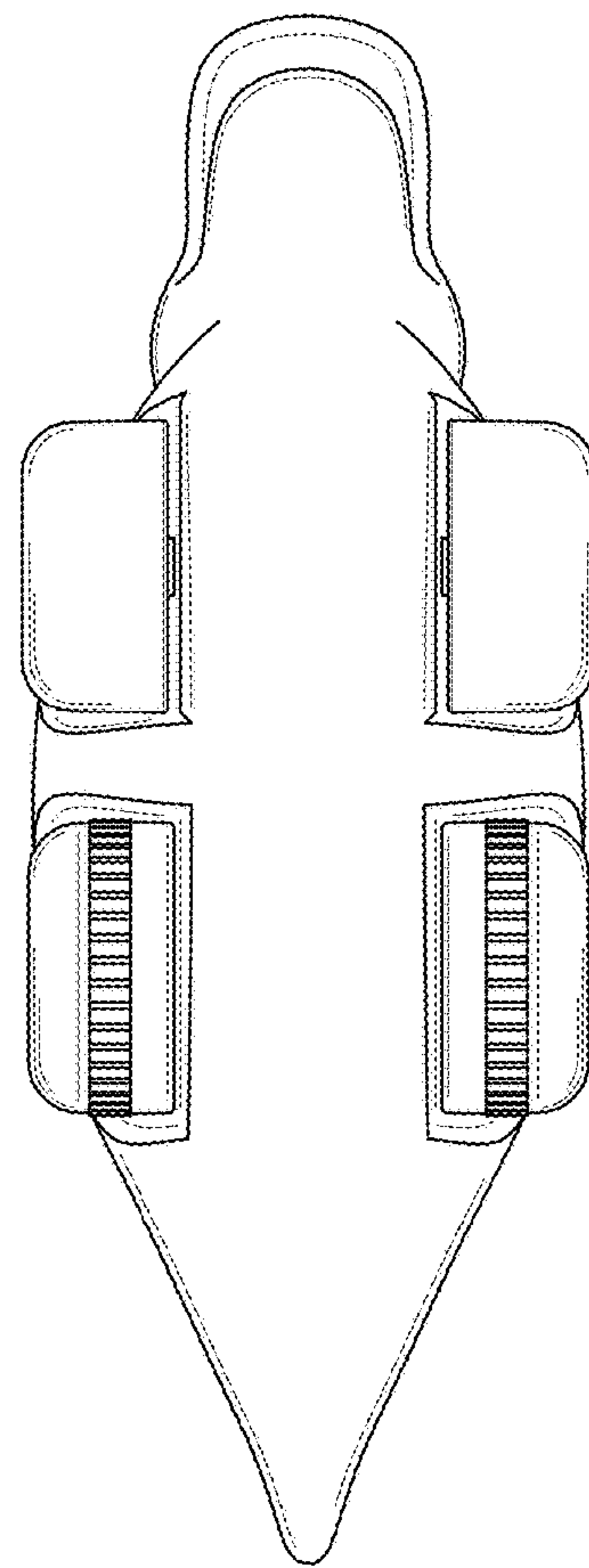

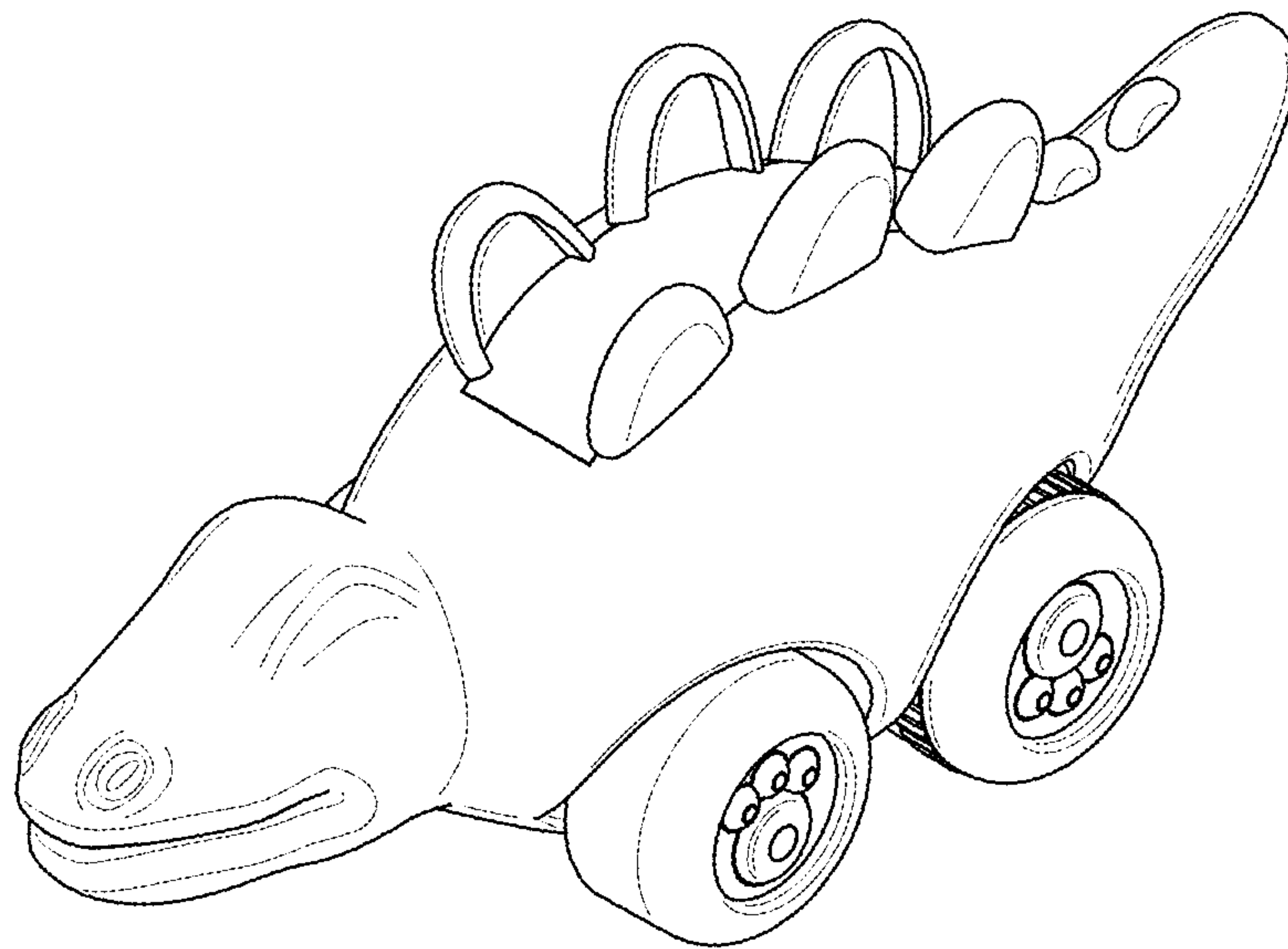

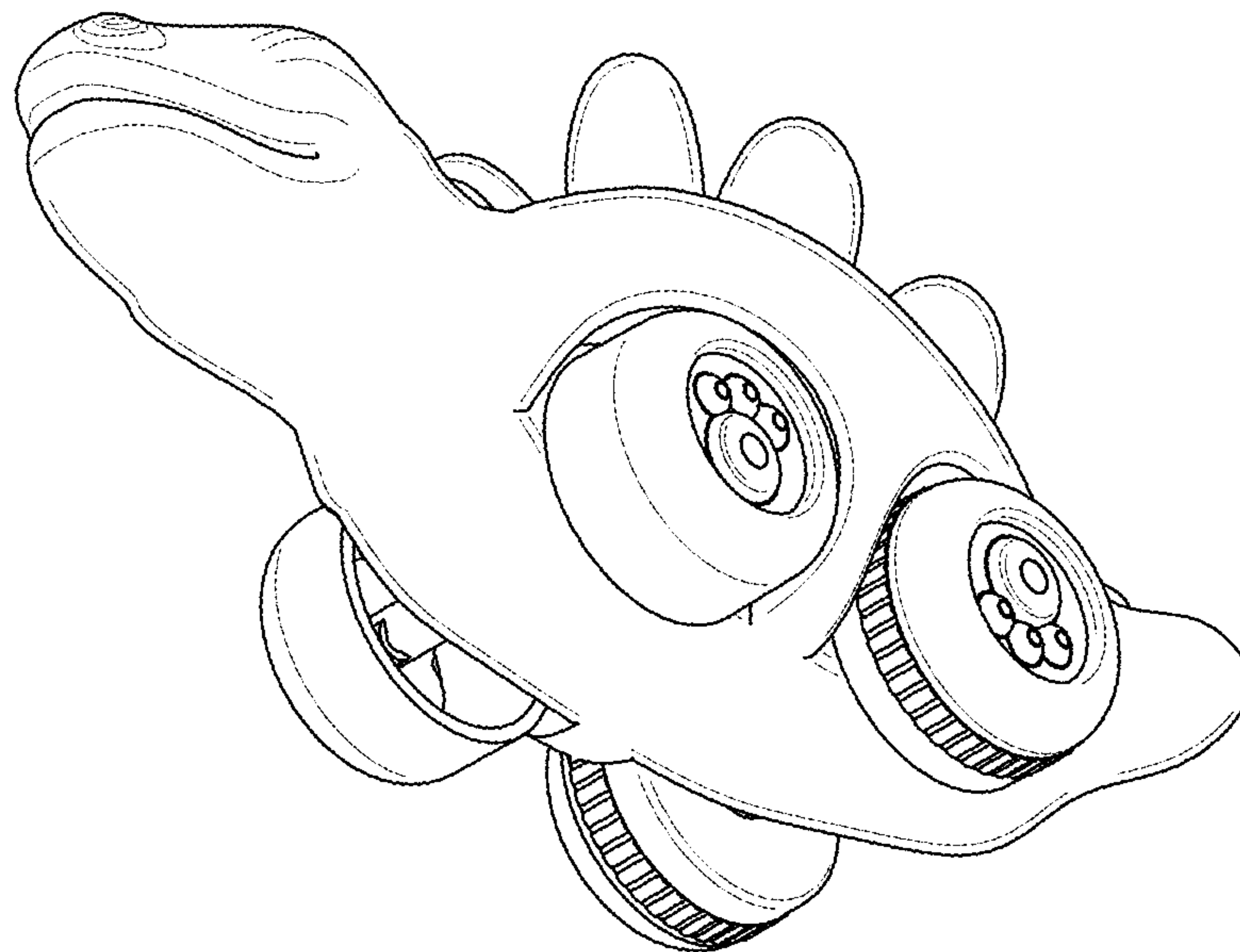

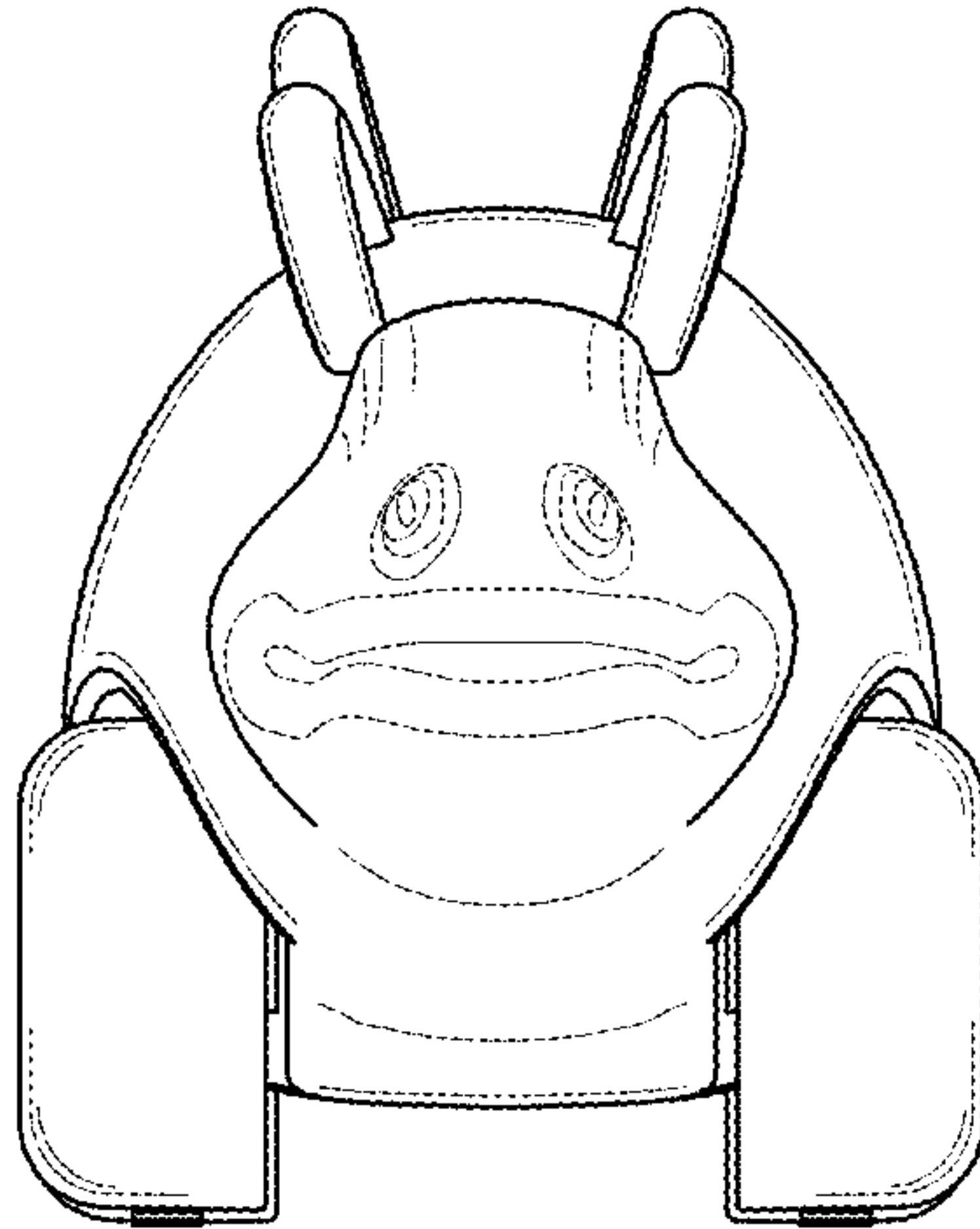

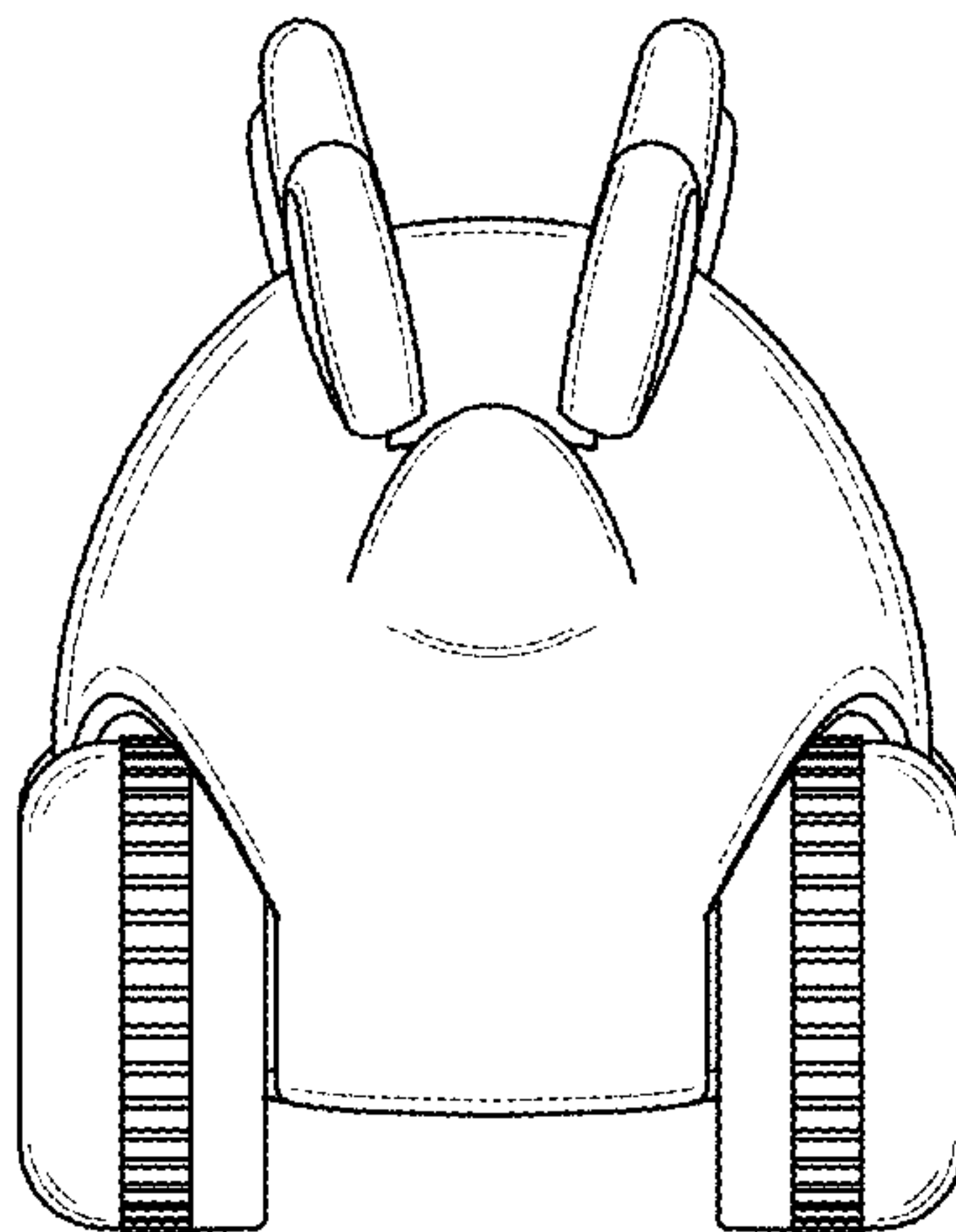

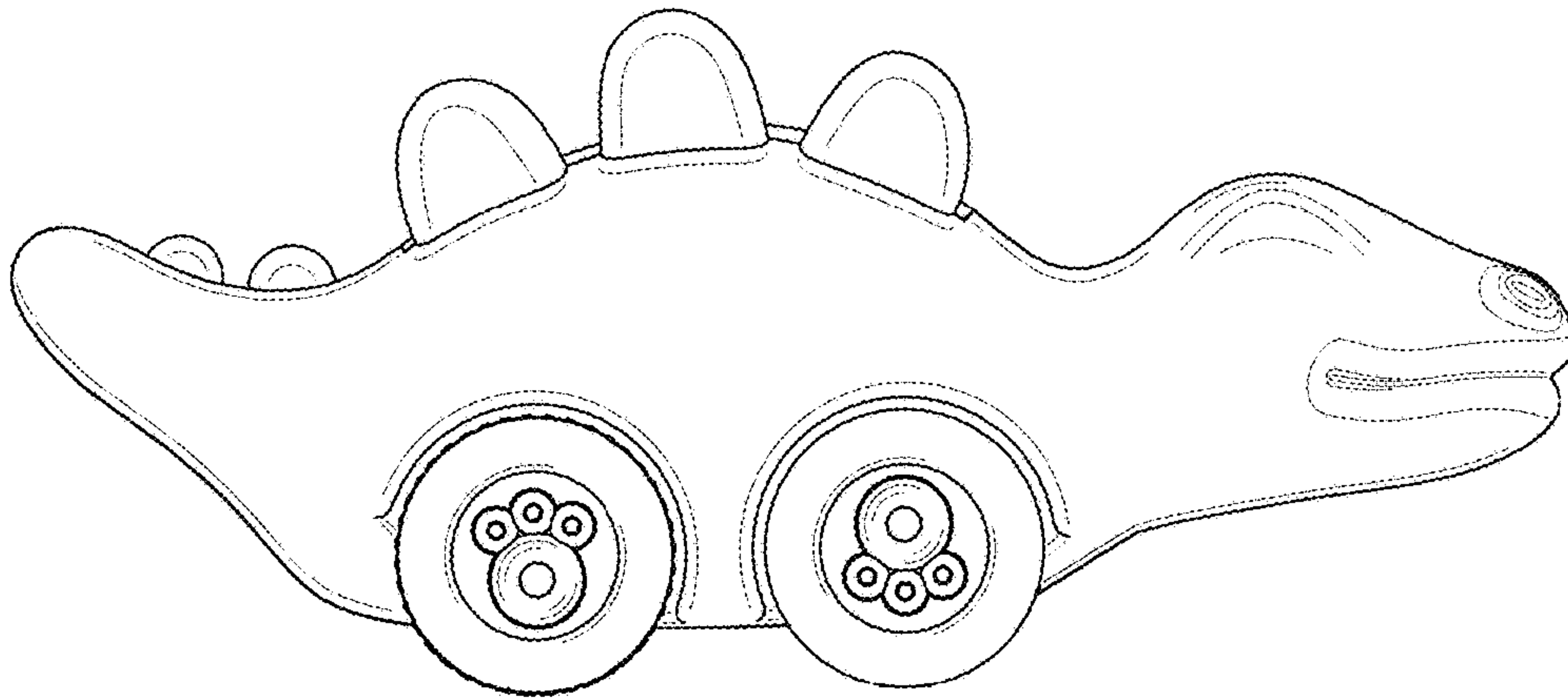

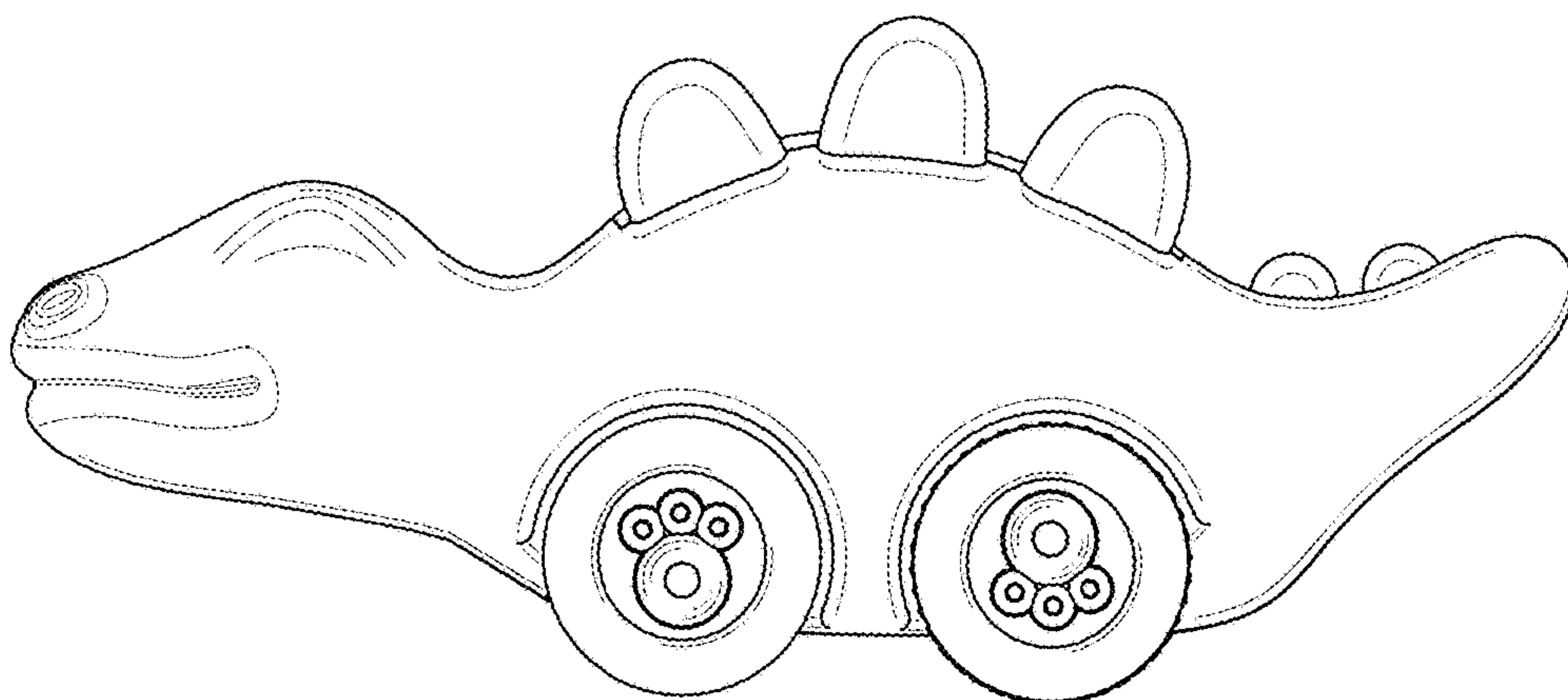

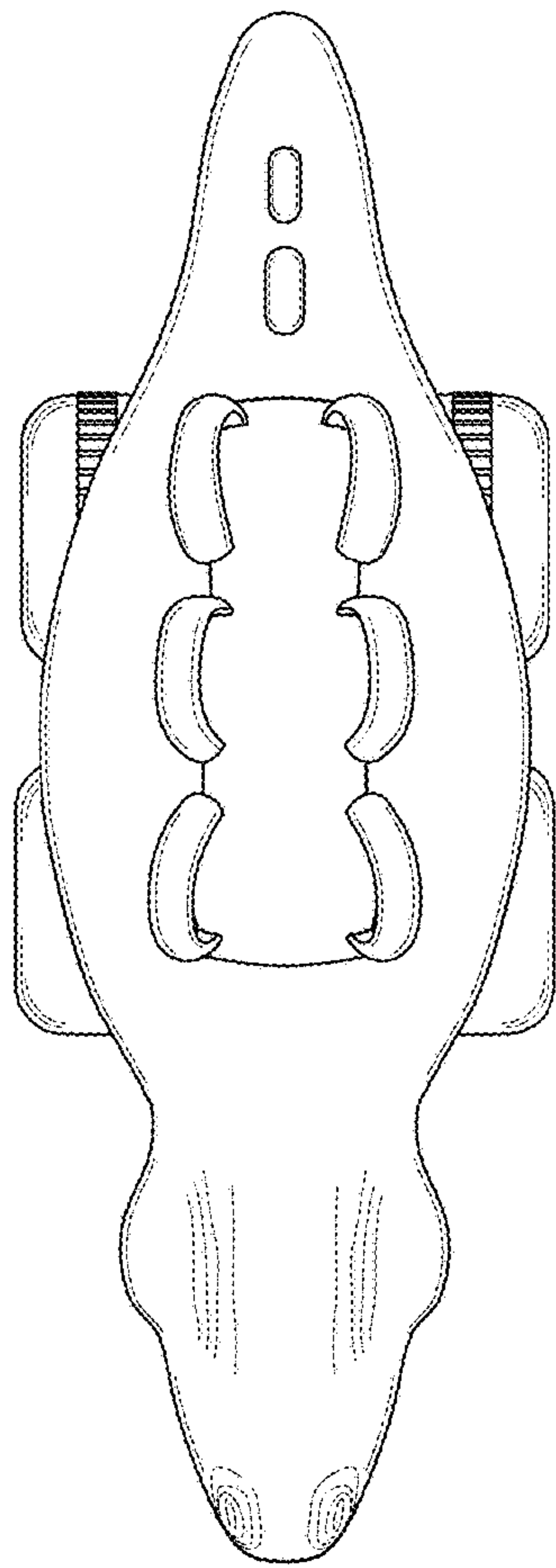

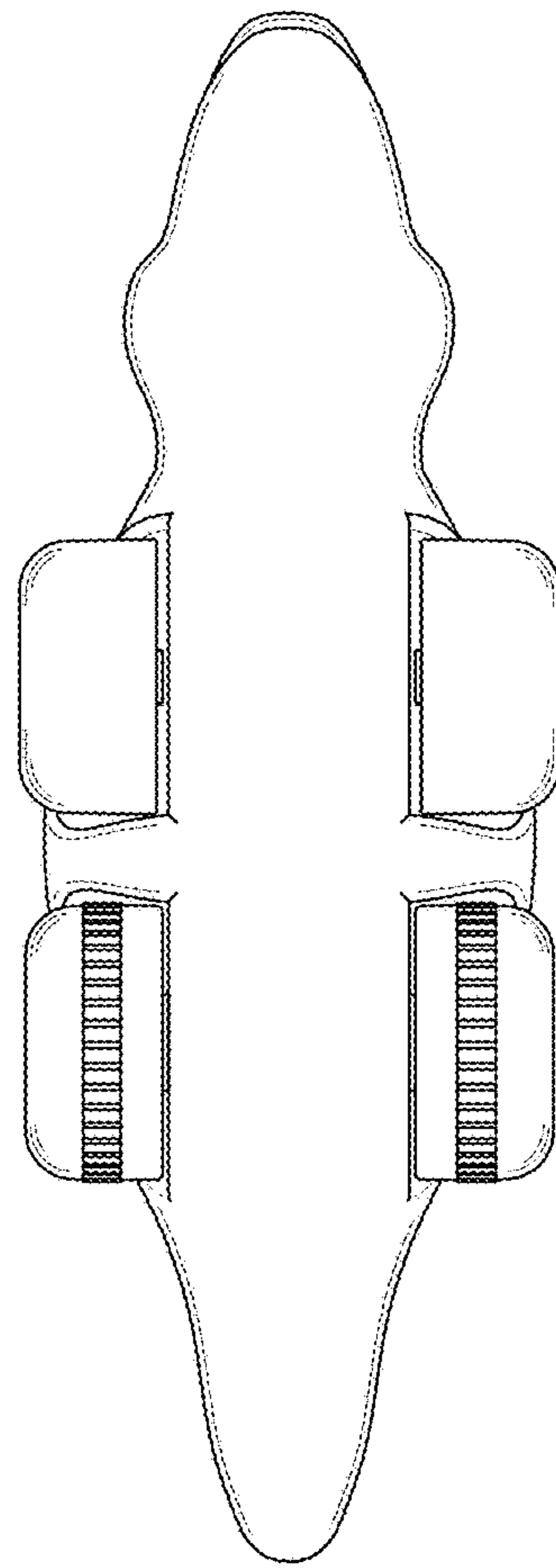

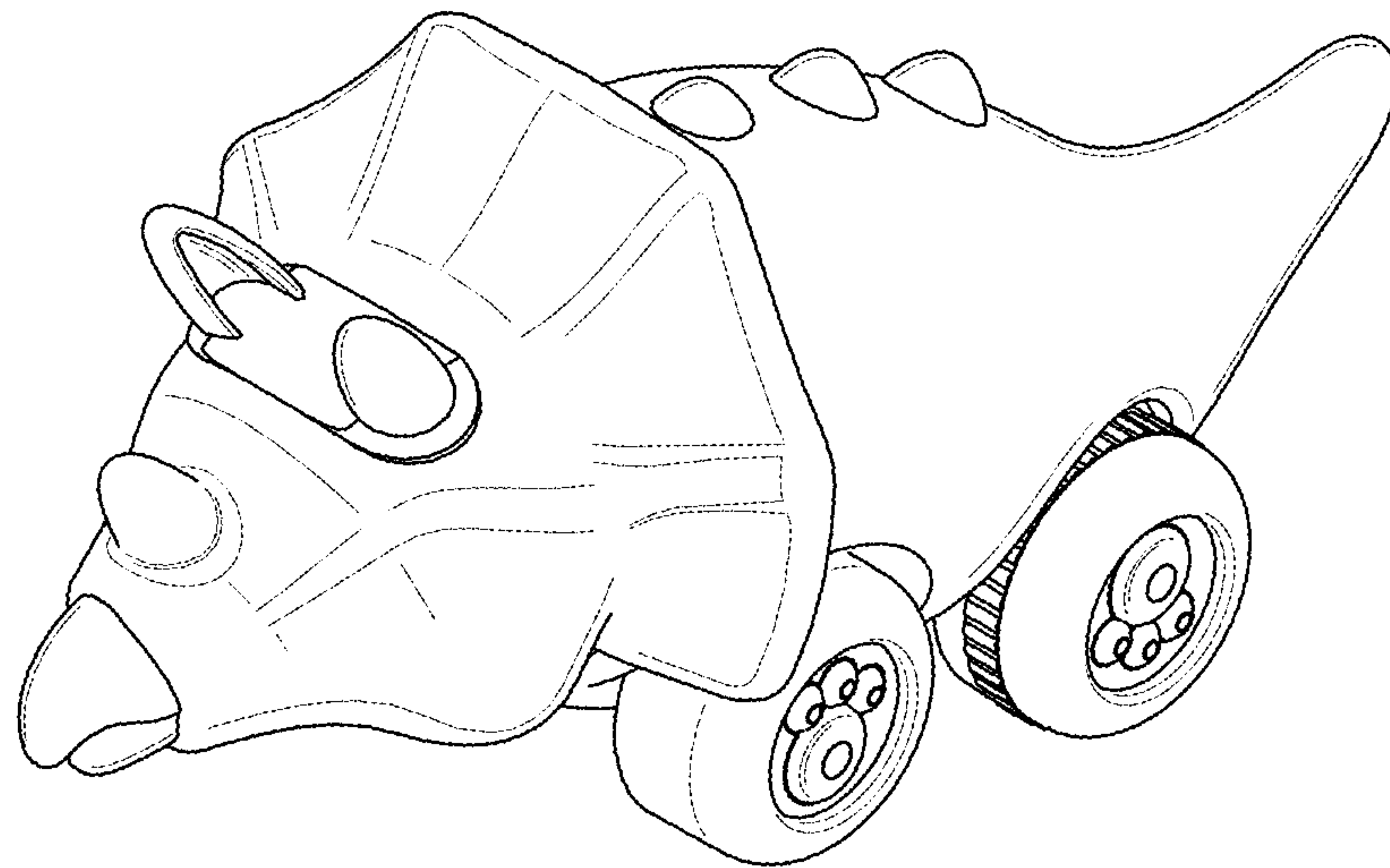

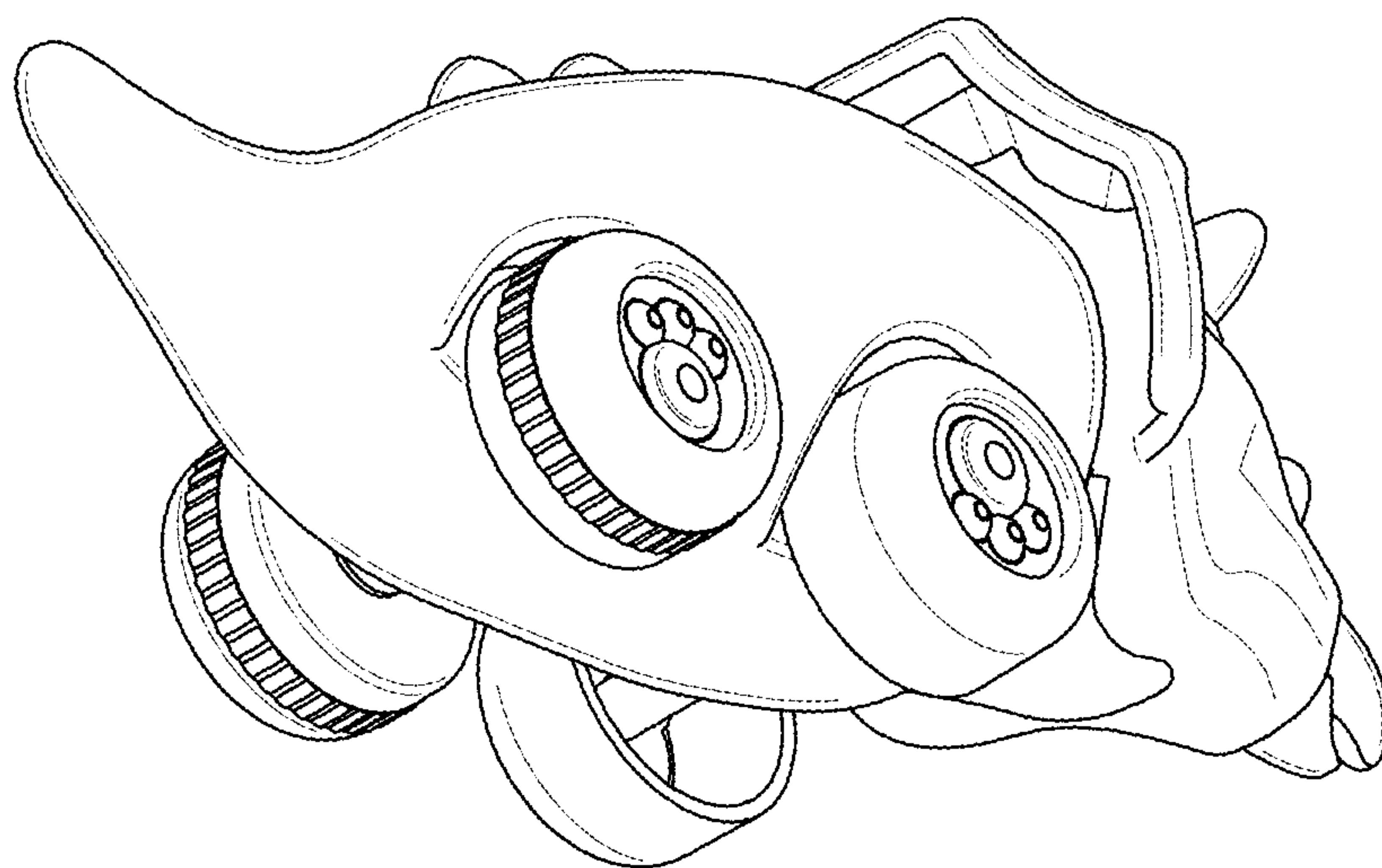

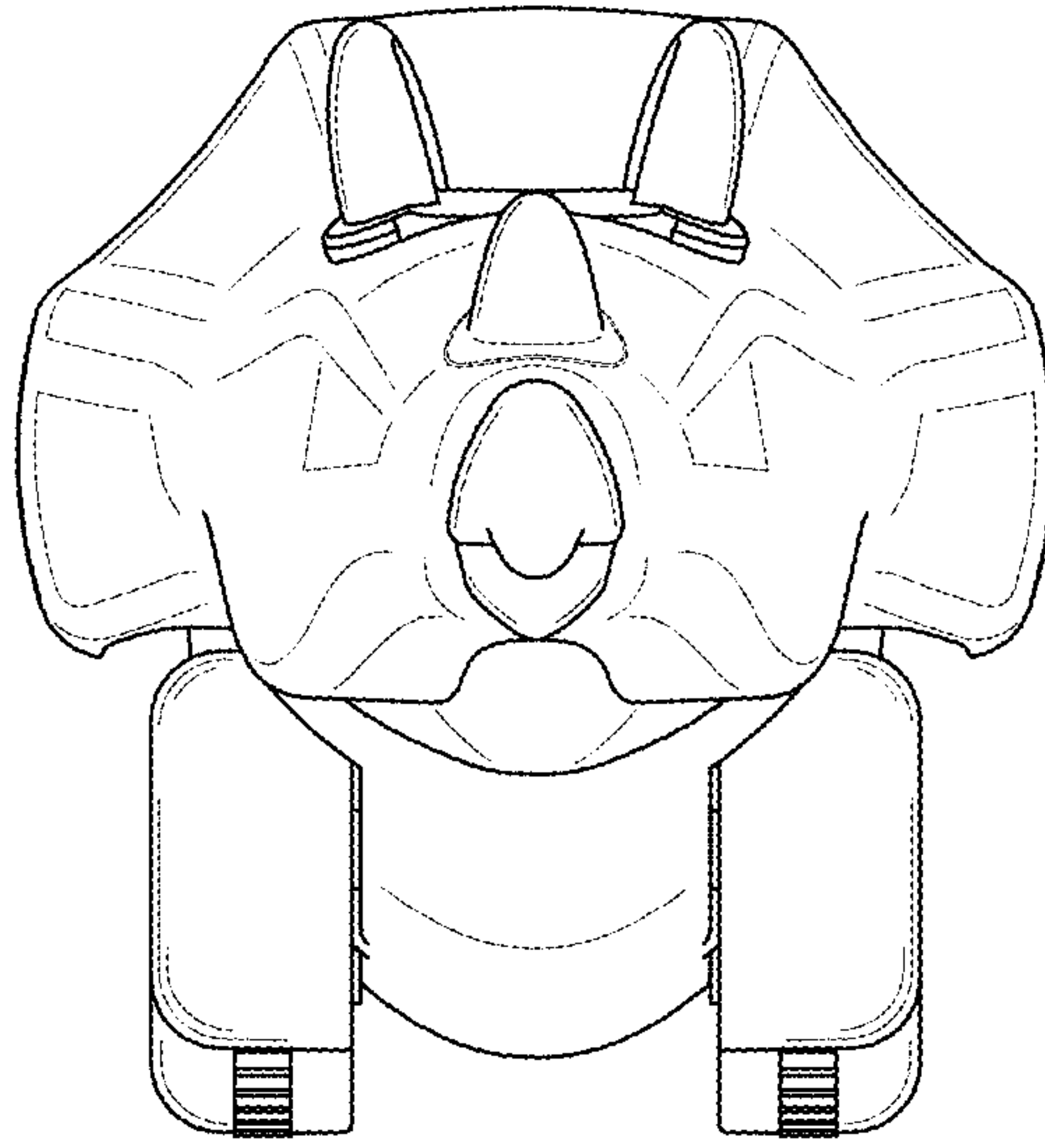

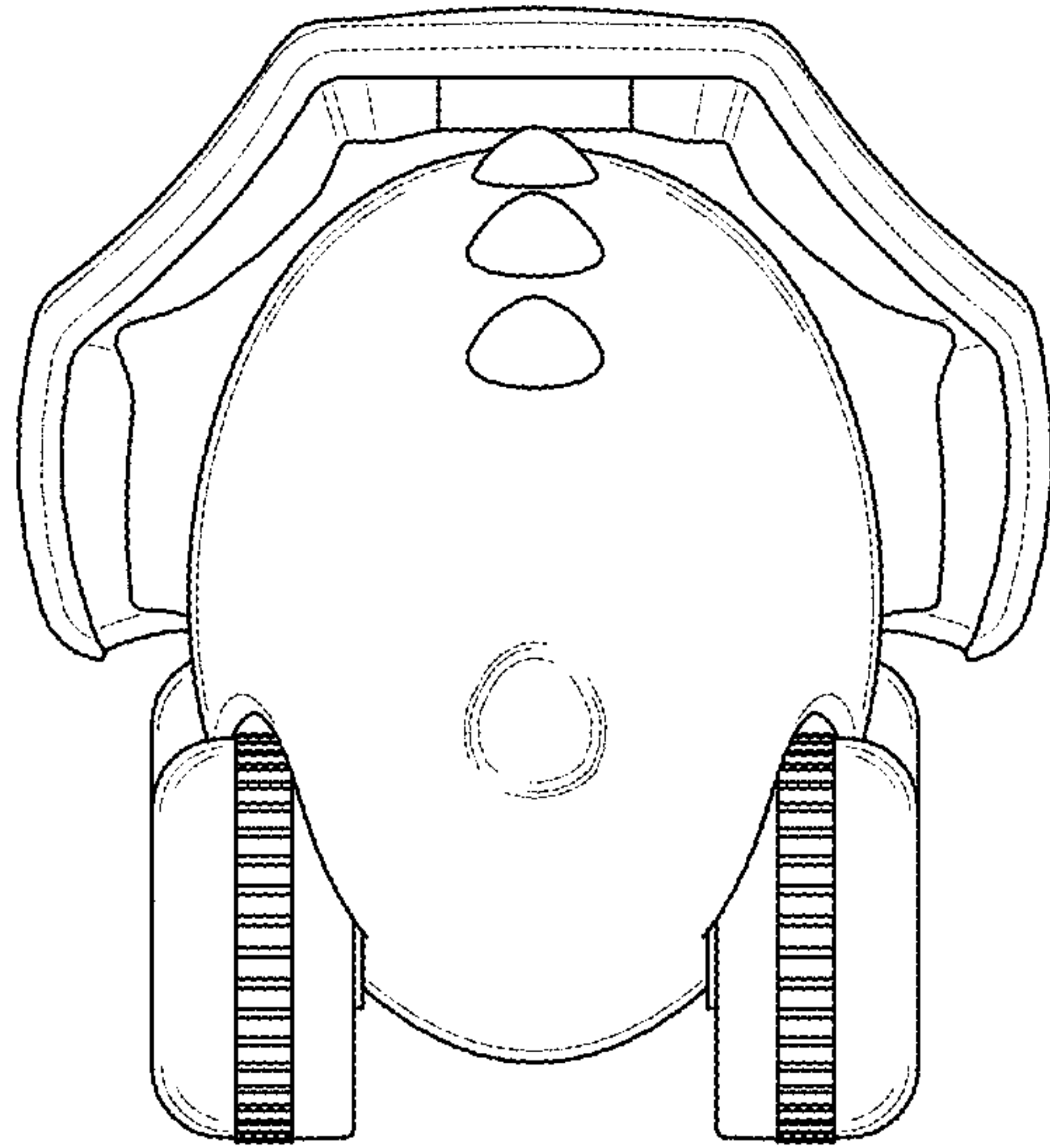

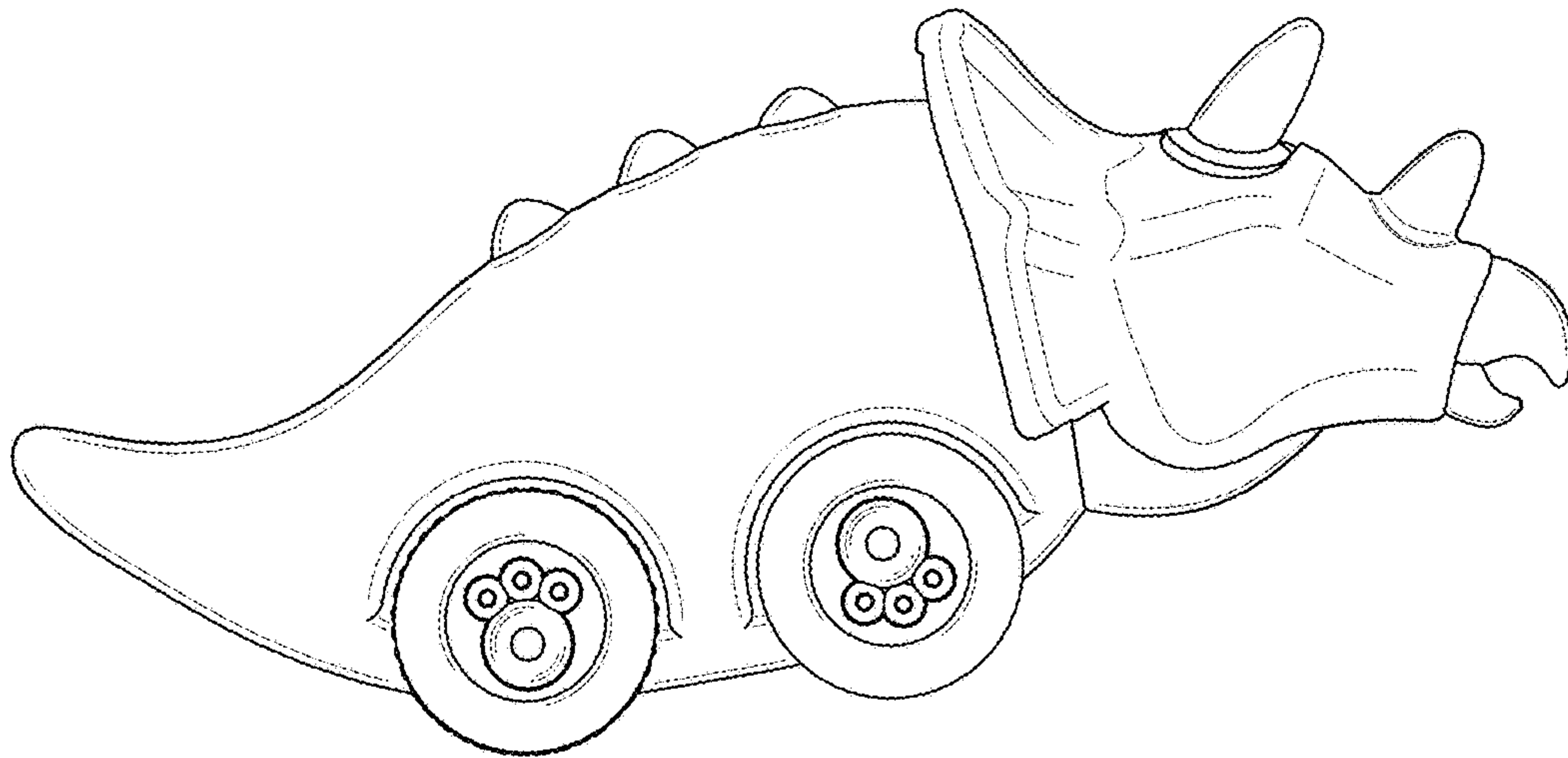

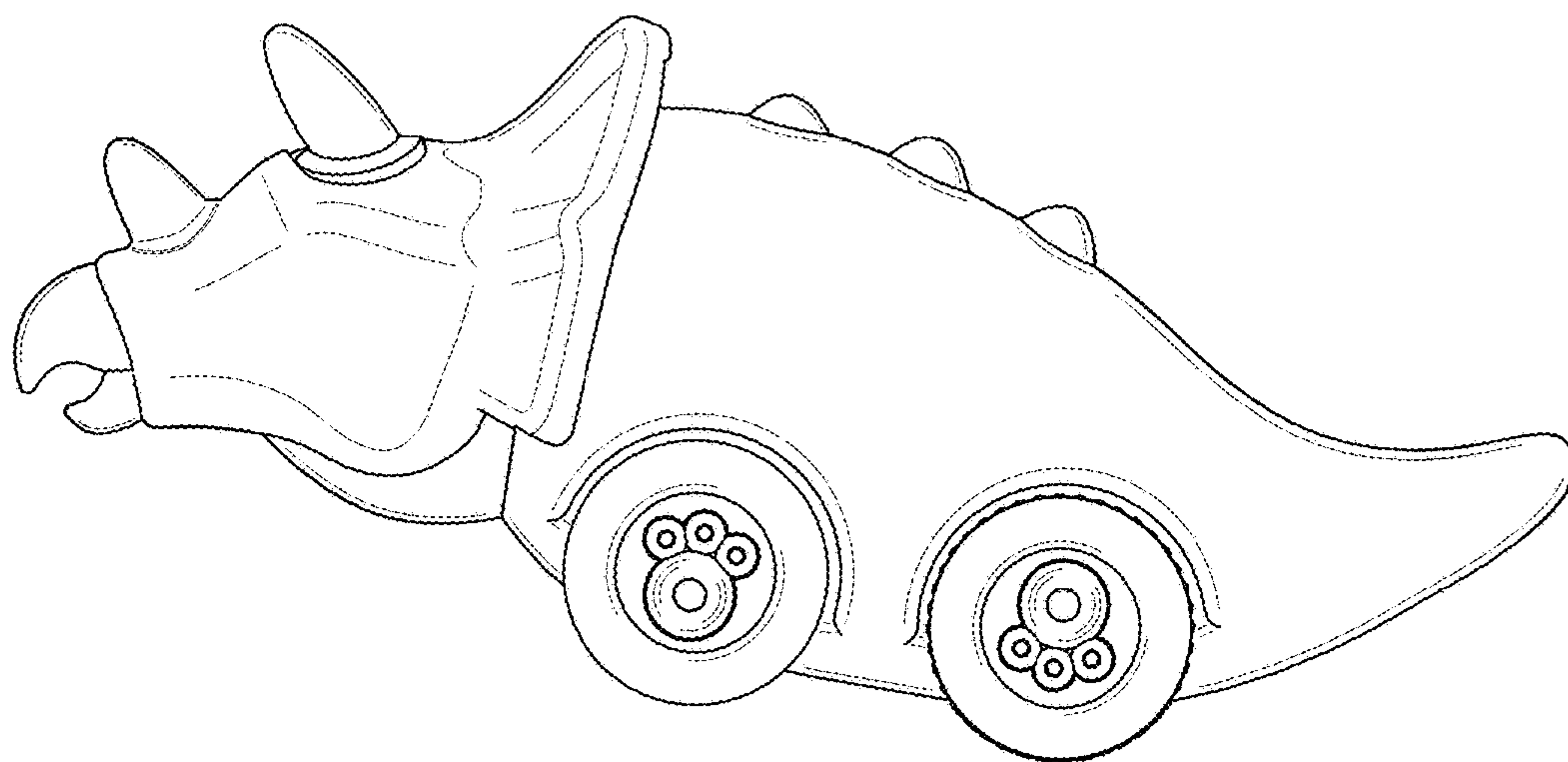

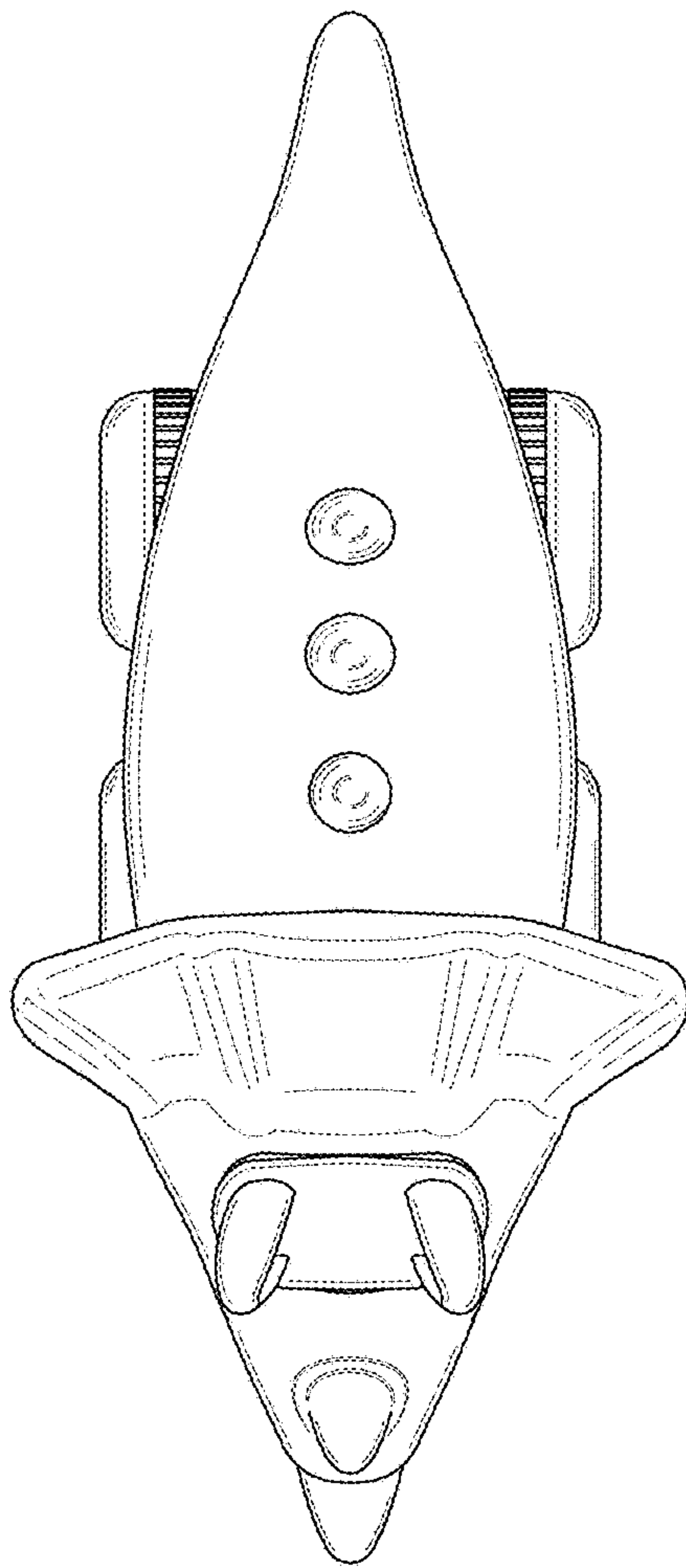

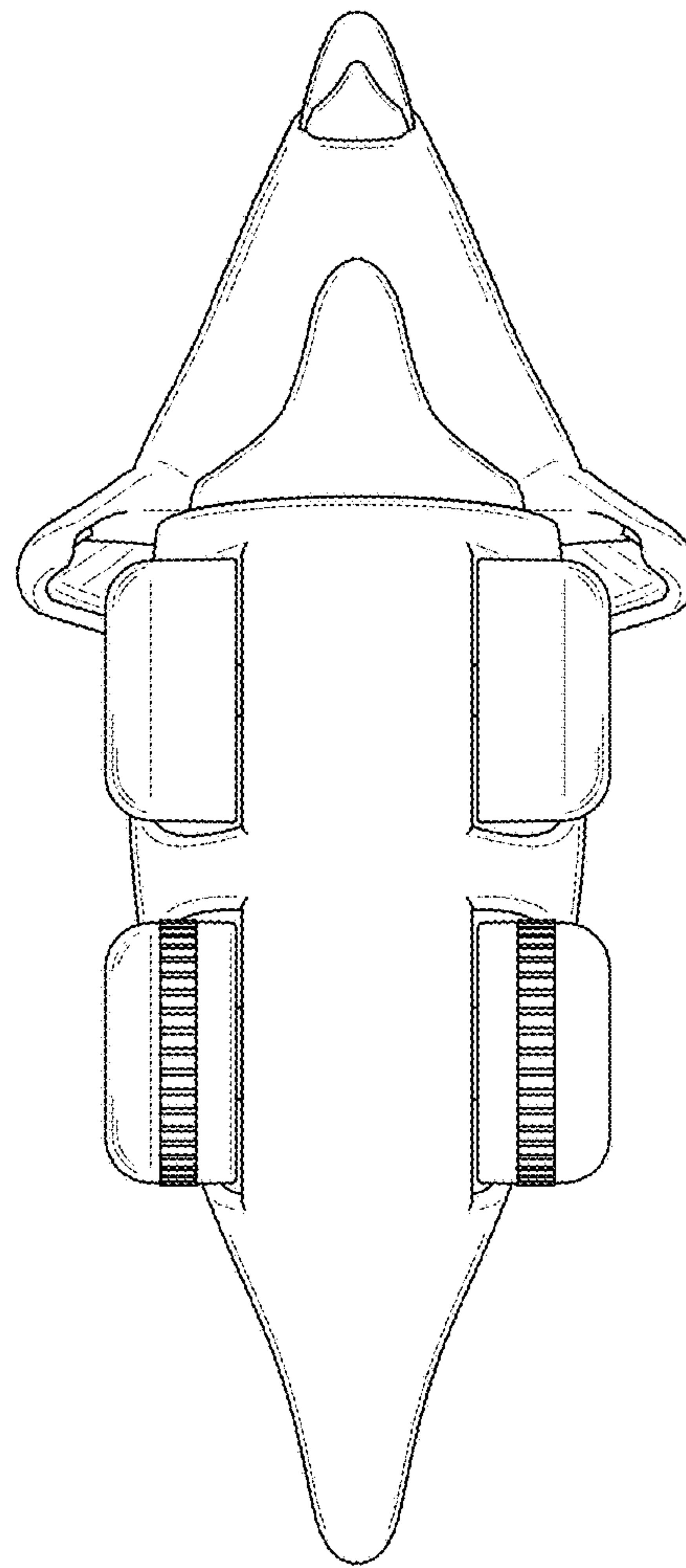
