(57) **CLAIM**

The ornamental design for a gutter cover, as shown and described.

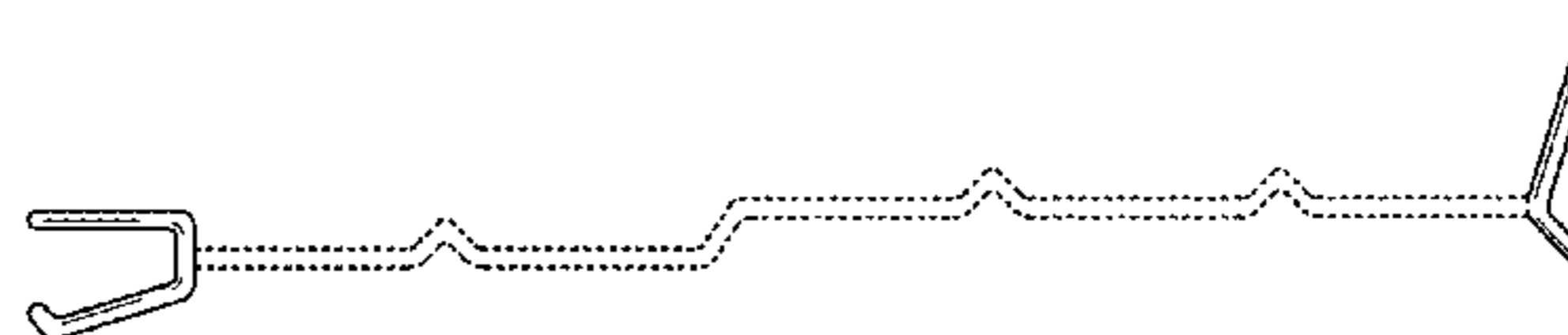
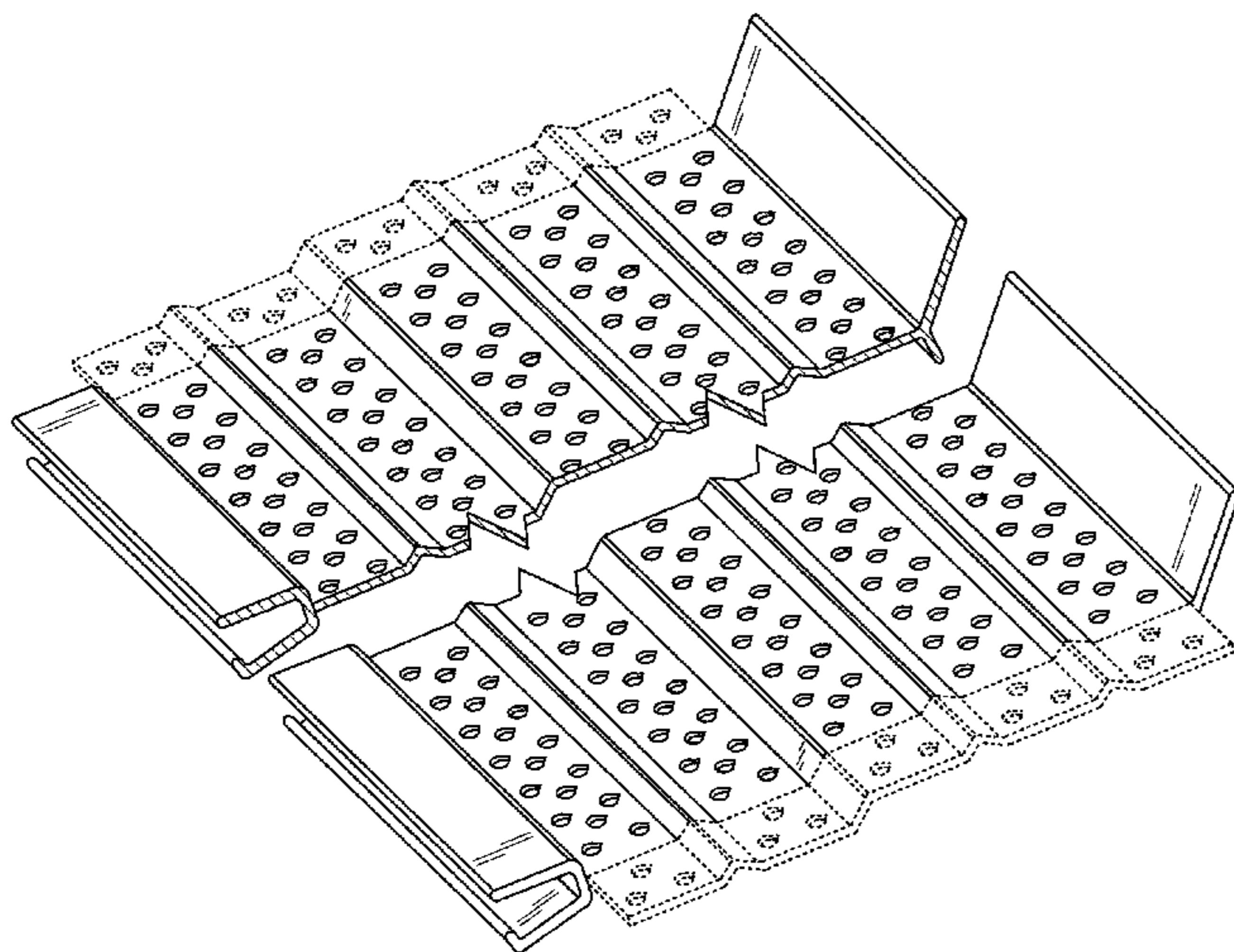
DESCRIPTION

FIG. 1 is a perspective view of a gutter cover according to the concepts of the present invention; FIG. 2 is a top view of the gutter cover shown in FIG. 1; FIG. 3 is a bottom view of the gutter cover shown in FIG. 1; FIG. 4 is a rear view of the gutter cover shown in FIG. 1; FIG. 5 is a front view of the gutter cover shown in FIG. 1; FIG. 6 is a first side view of the gutter cover shown in FIG. 1; FIG. 7 is a second side view of the gutter cover shown in FIG. 1; and, FIG. 8 is a perspective view of a gutter cover shown in FIG. 1, and shown in a position of use.

The broken lines shown along the outer edge that connect to the claimed ends shown in FIGS. 1-5 and 8 define the boundaries of the claim and form no part of the claim. The dashed lines shown in FIGS. 1-8 showing the edges of the gutter cover beyond the boundary line depict portions of the gutter cover that form no part of the claim. The additional dashed lines shown in FIG. 8 depict environment only that form no part of the claim.

FIGS. 1-5 and 8 are shown with a symbolic break in the gutter cover's length. The appearance of any portion of the gutter cover between the break lines forms no part of the claim.

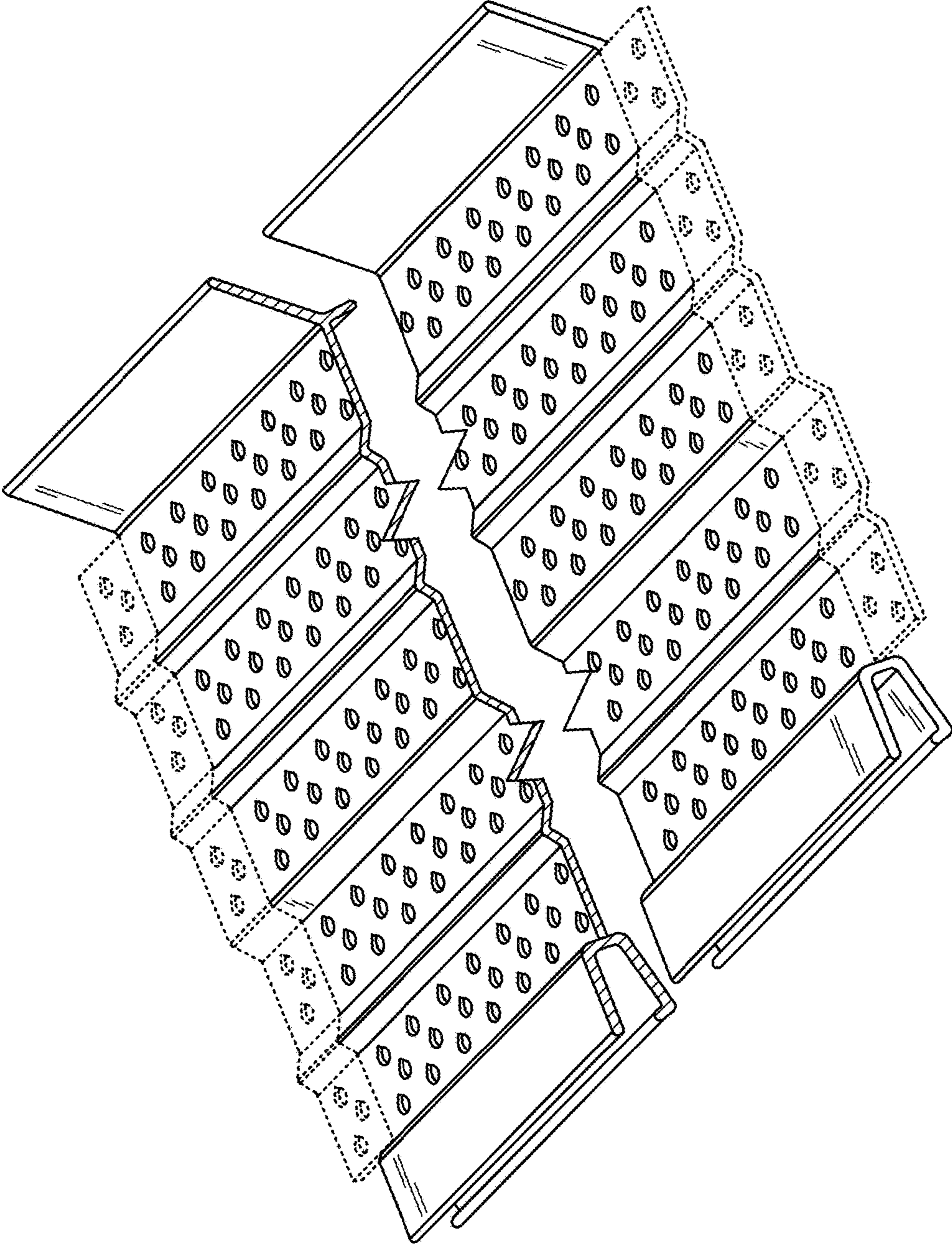

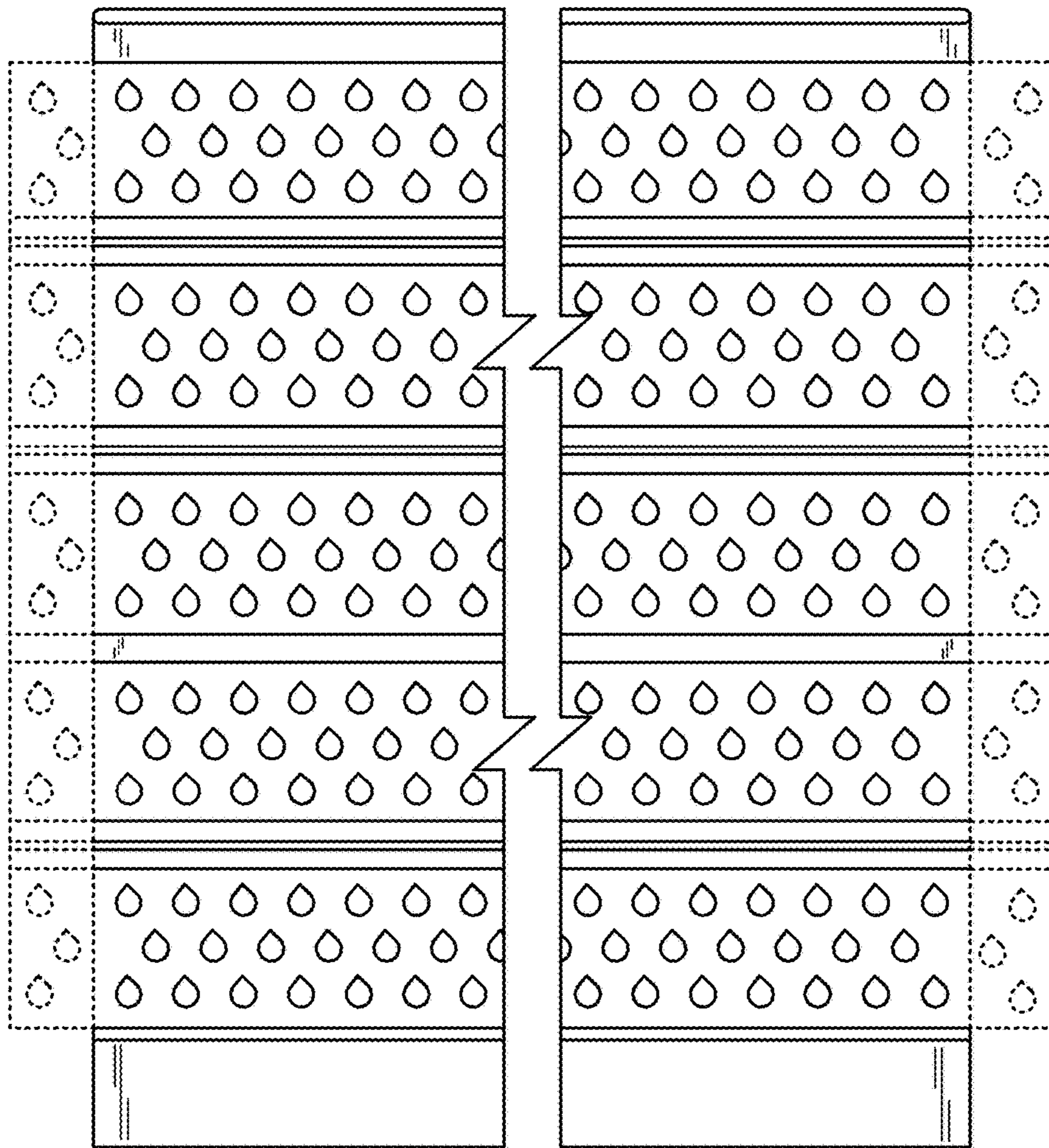

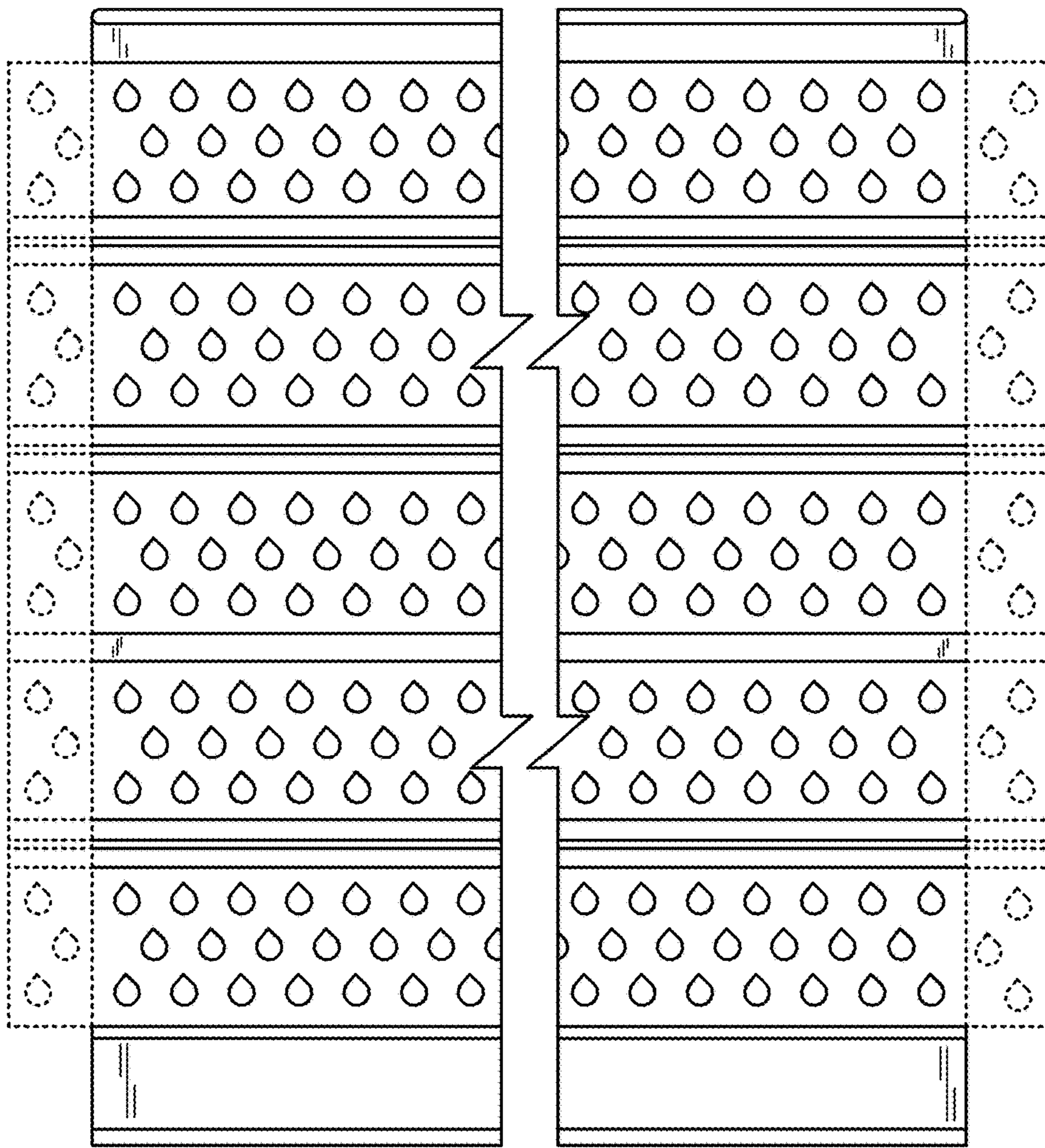

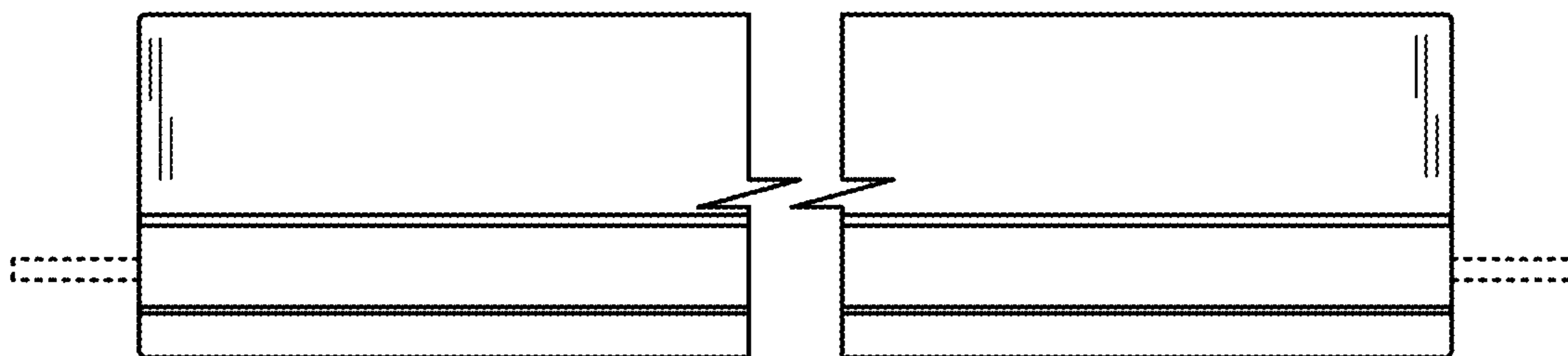

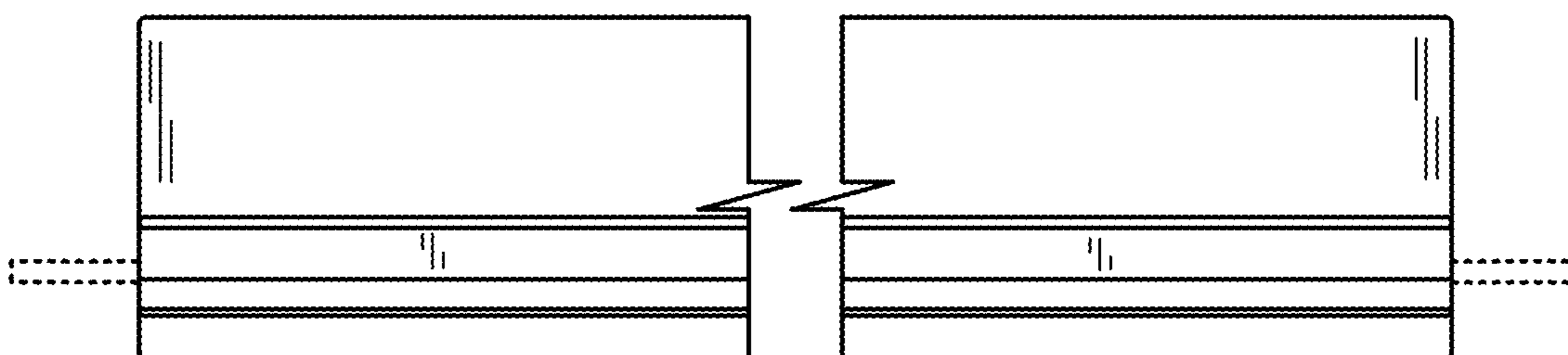

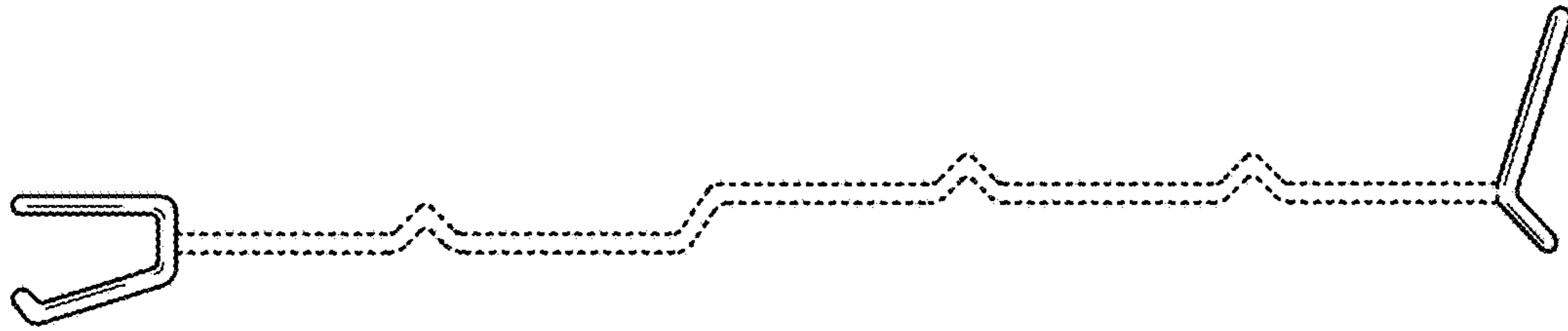

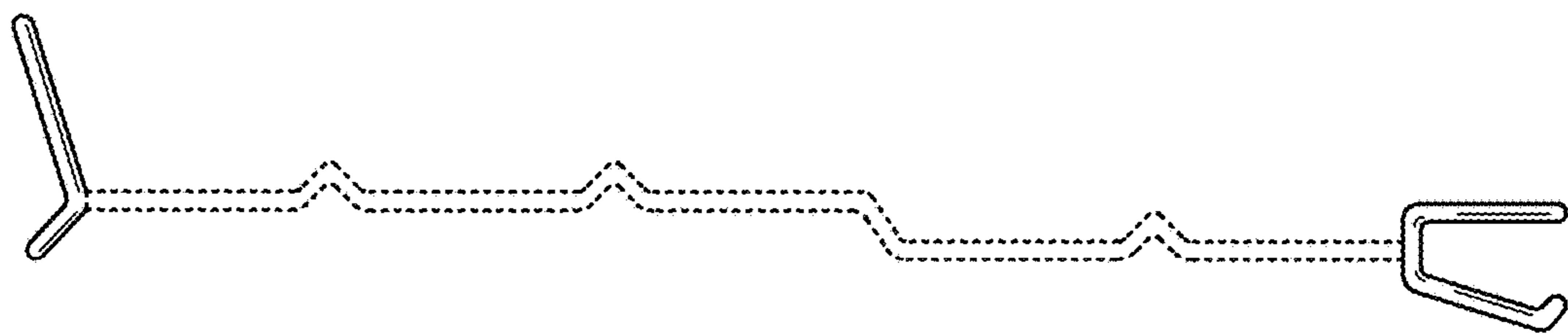

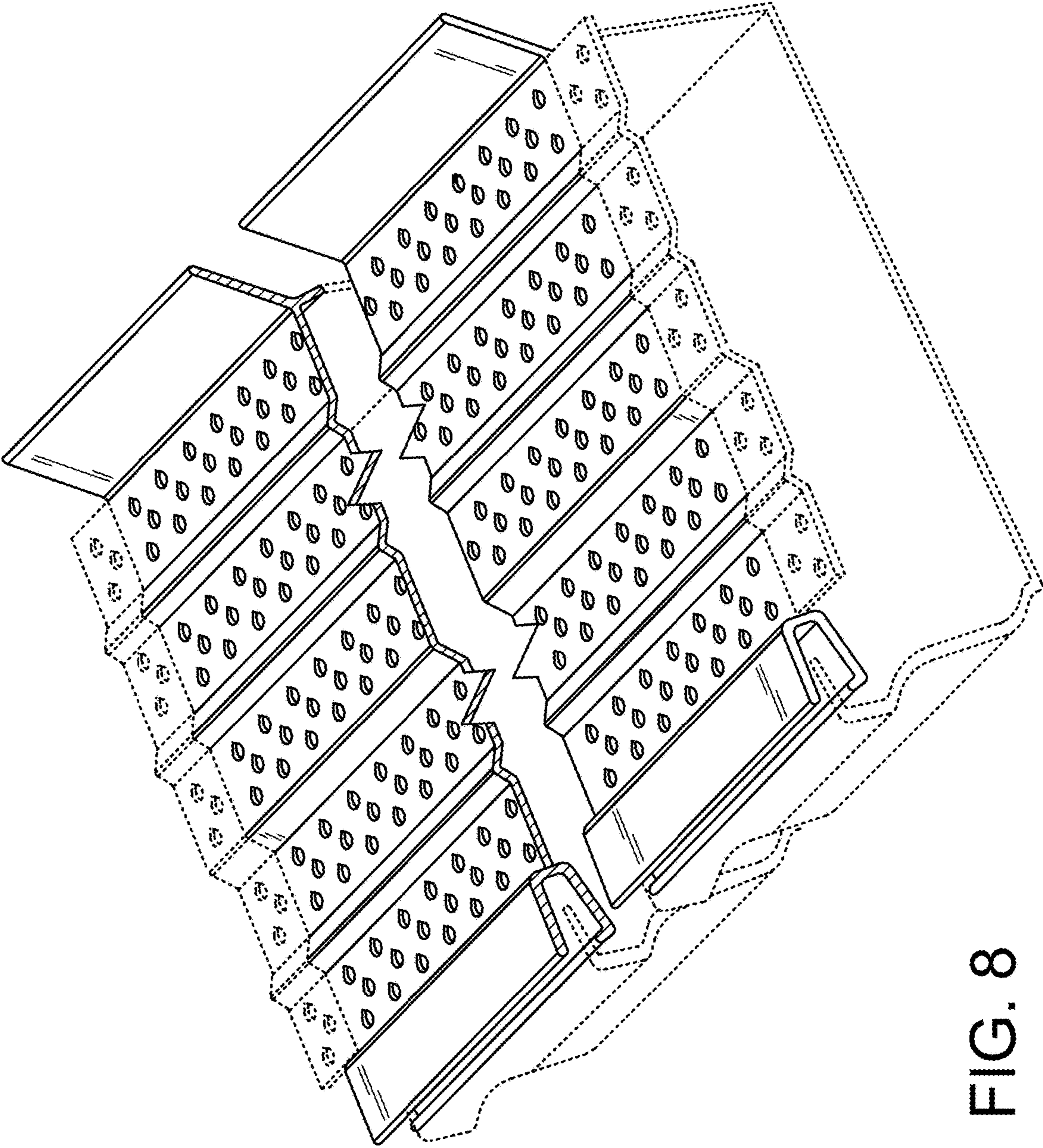
