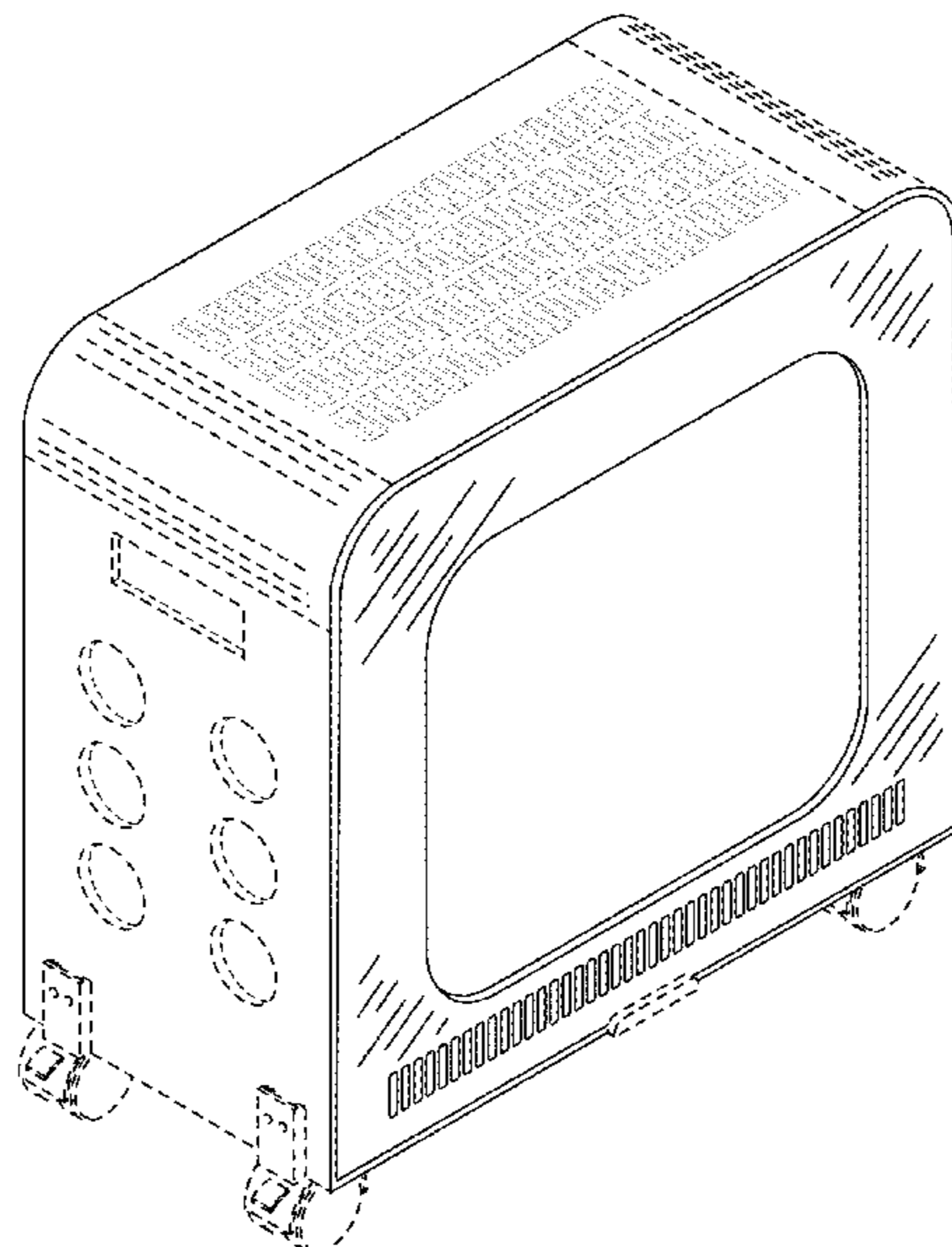
**CLAIM**

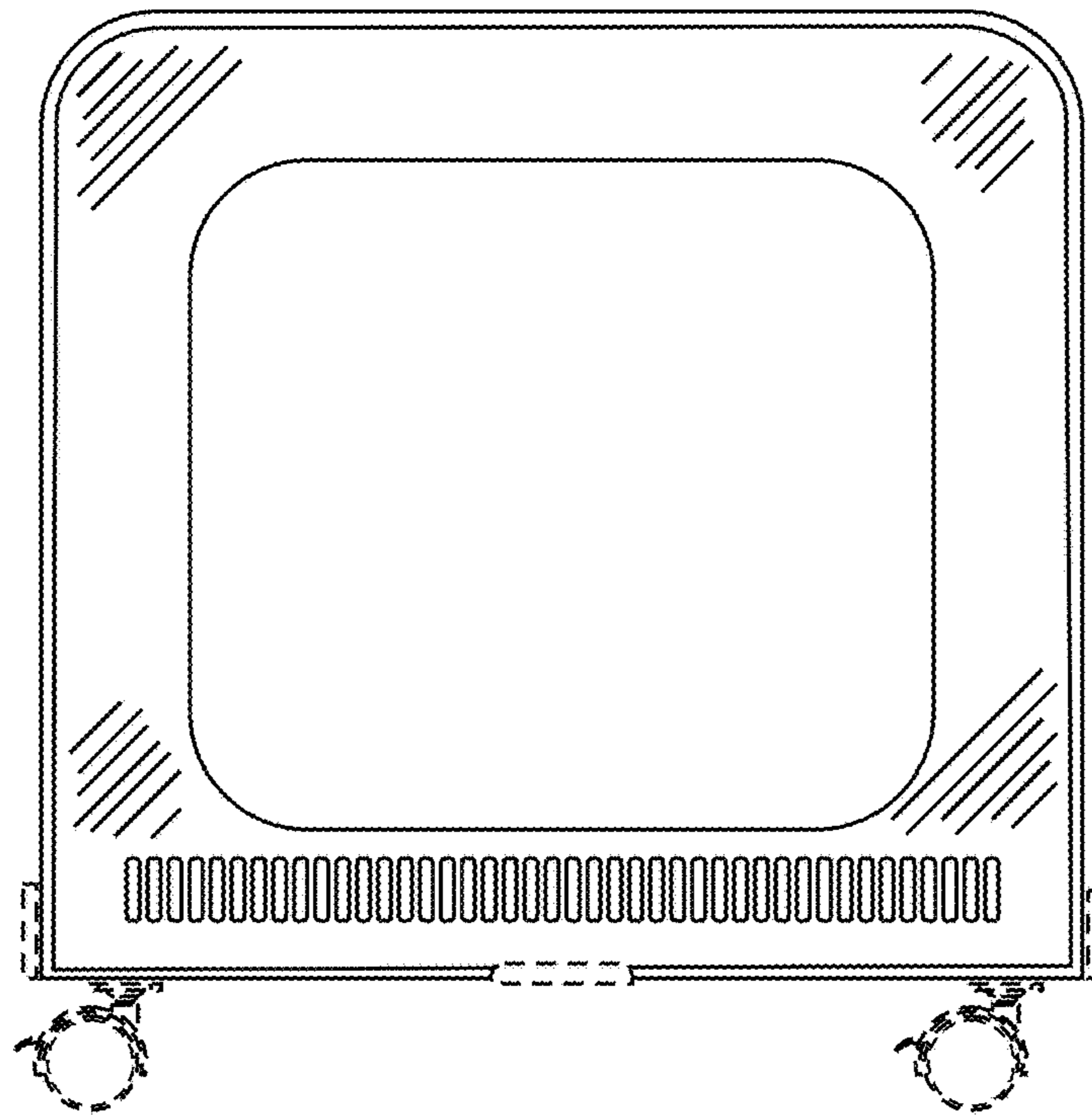
The ornamental design for an air purifier, as shown and described.

**DESCRIPTION**

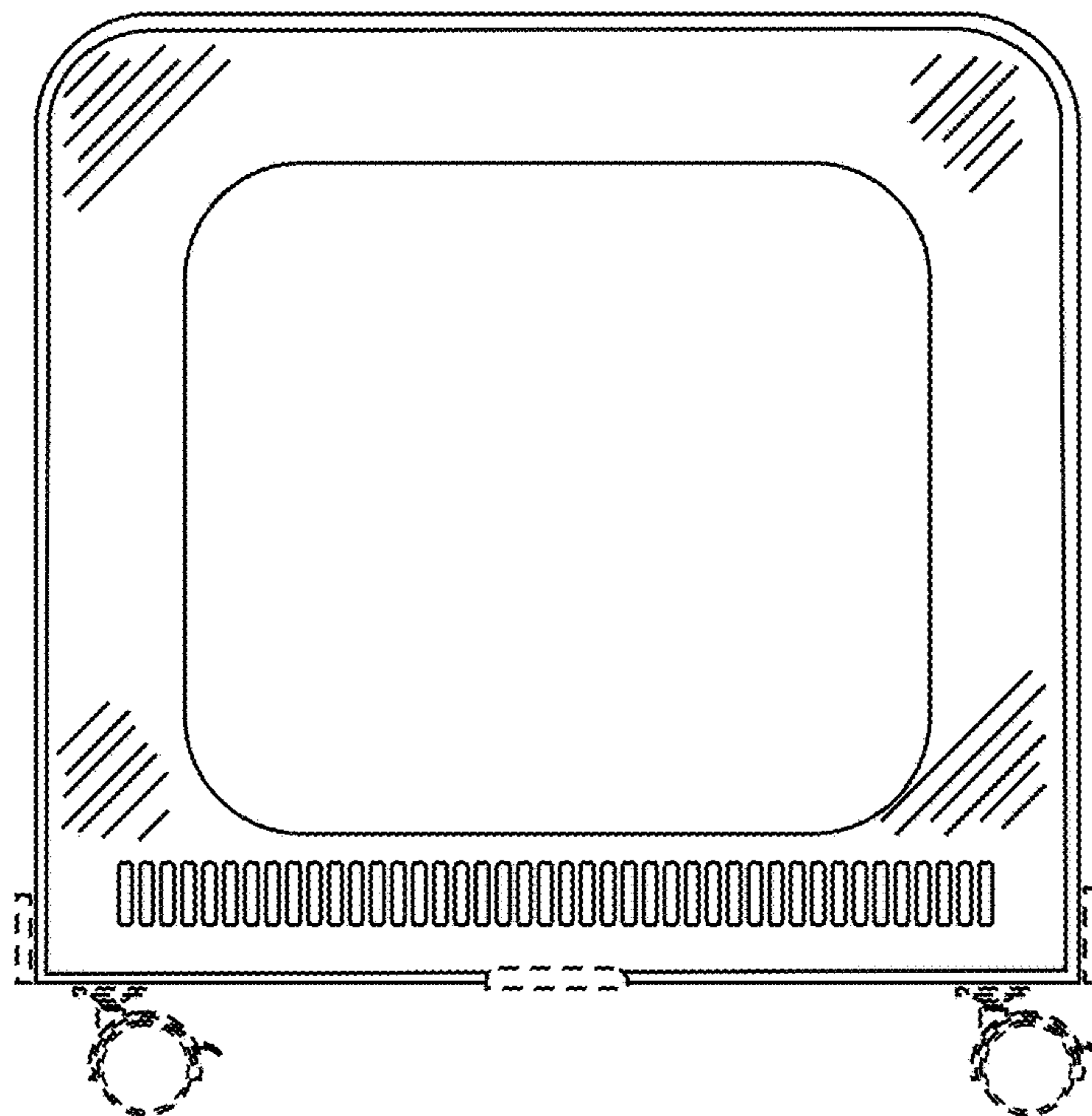

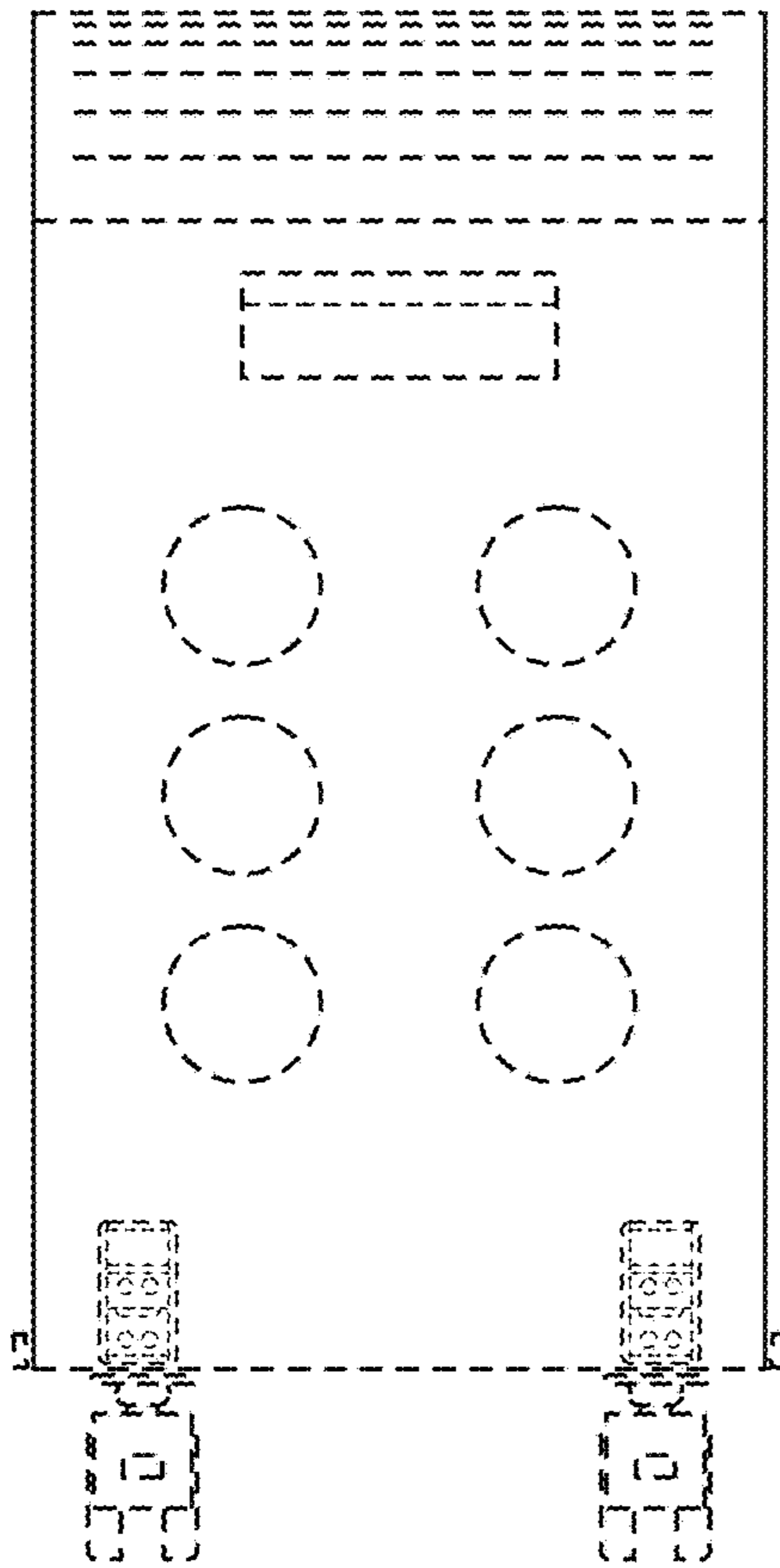




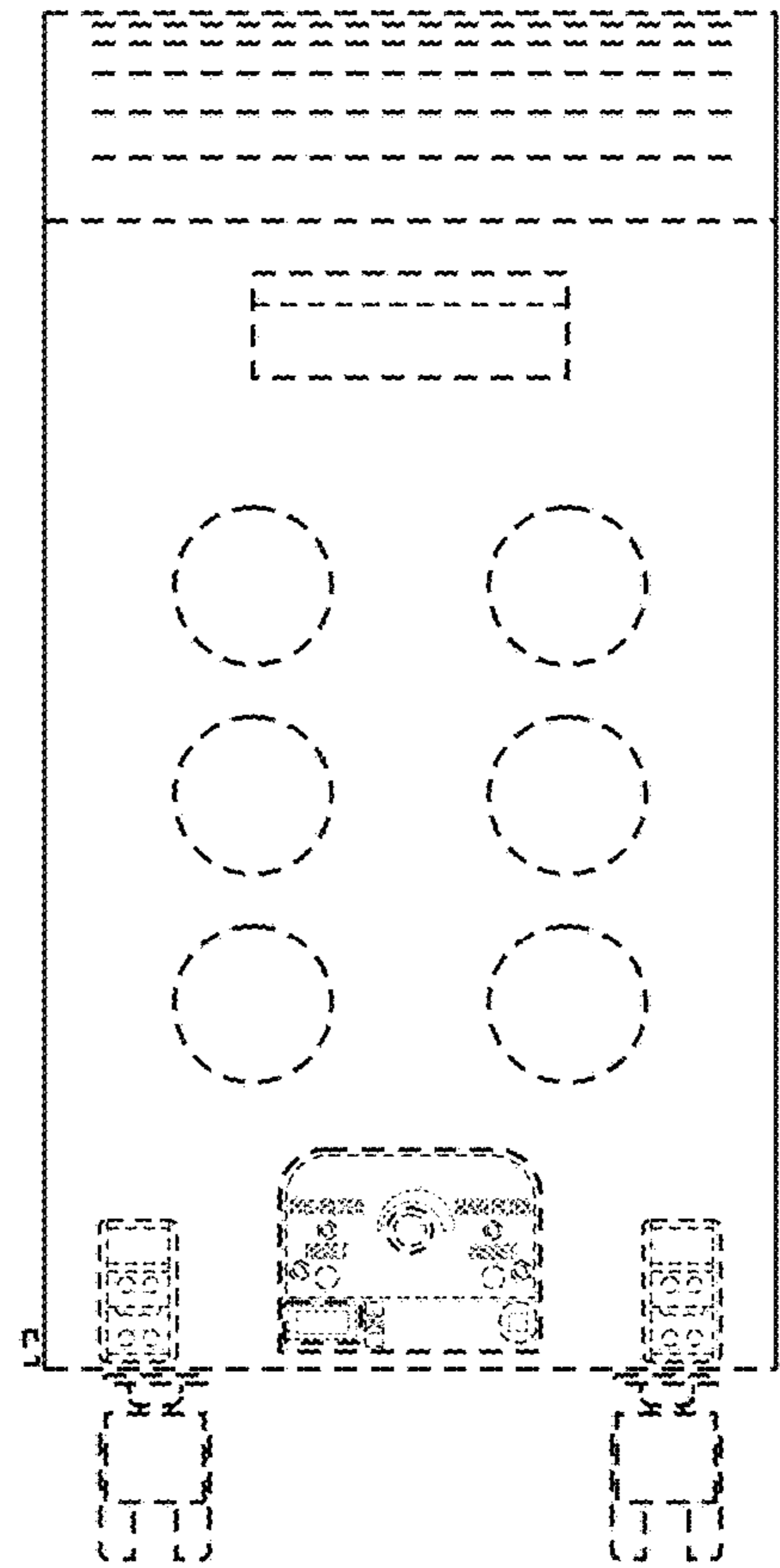

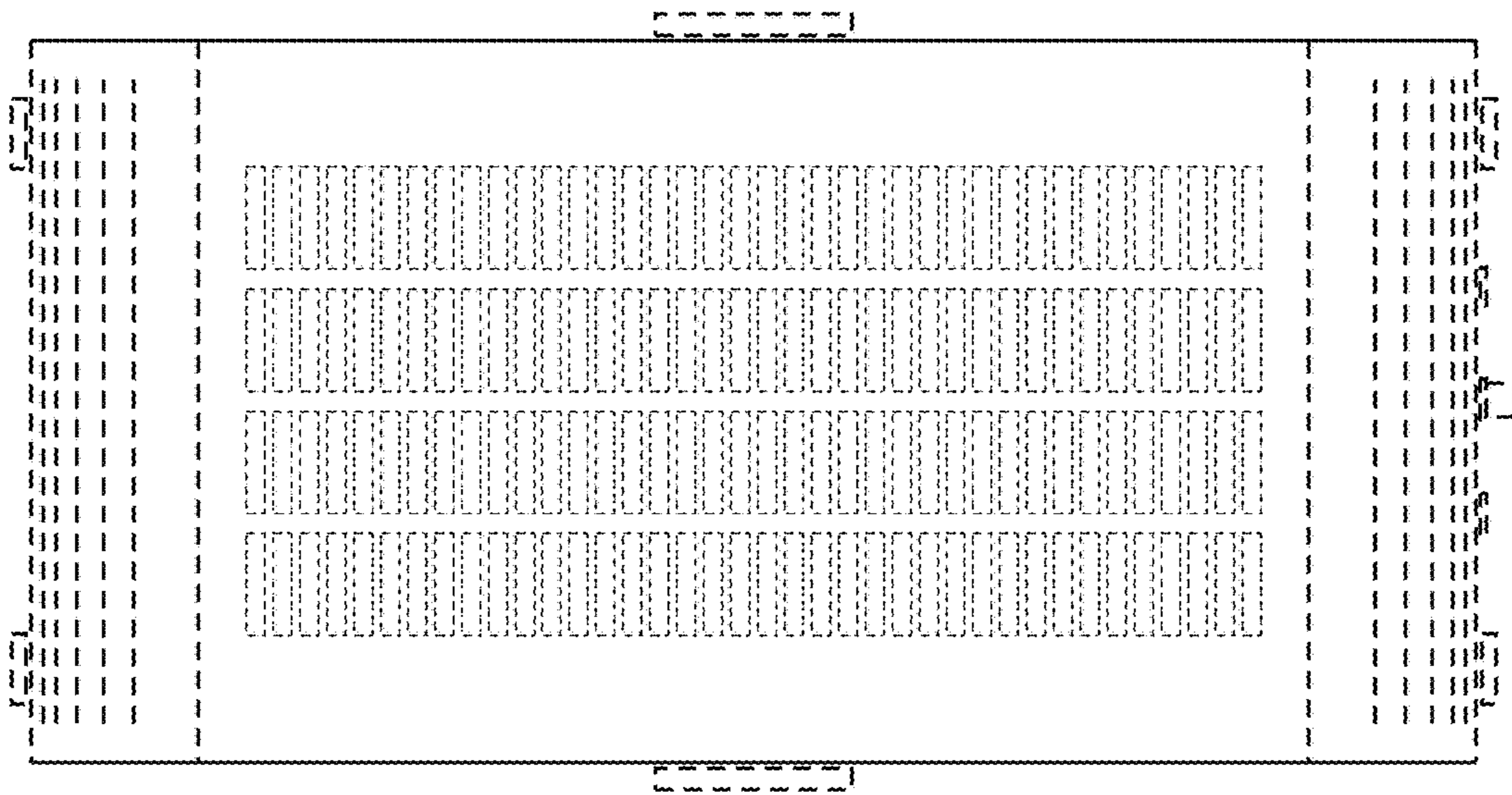

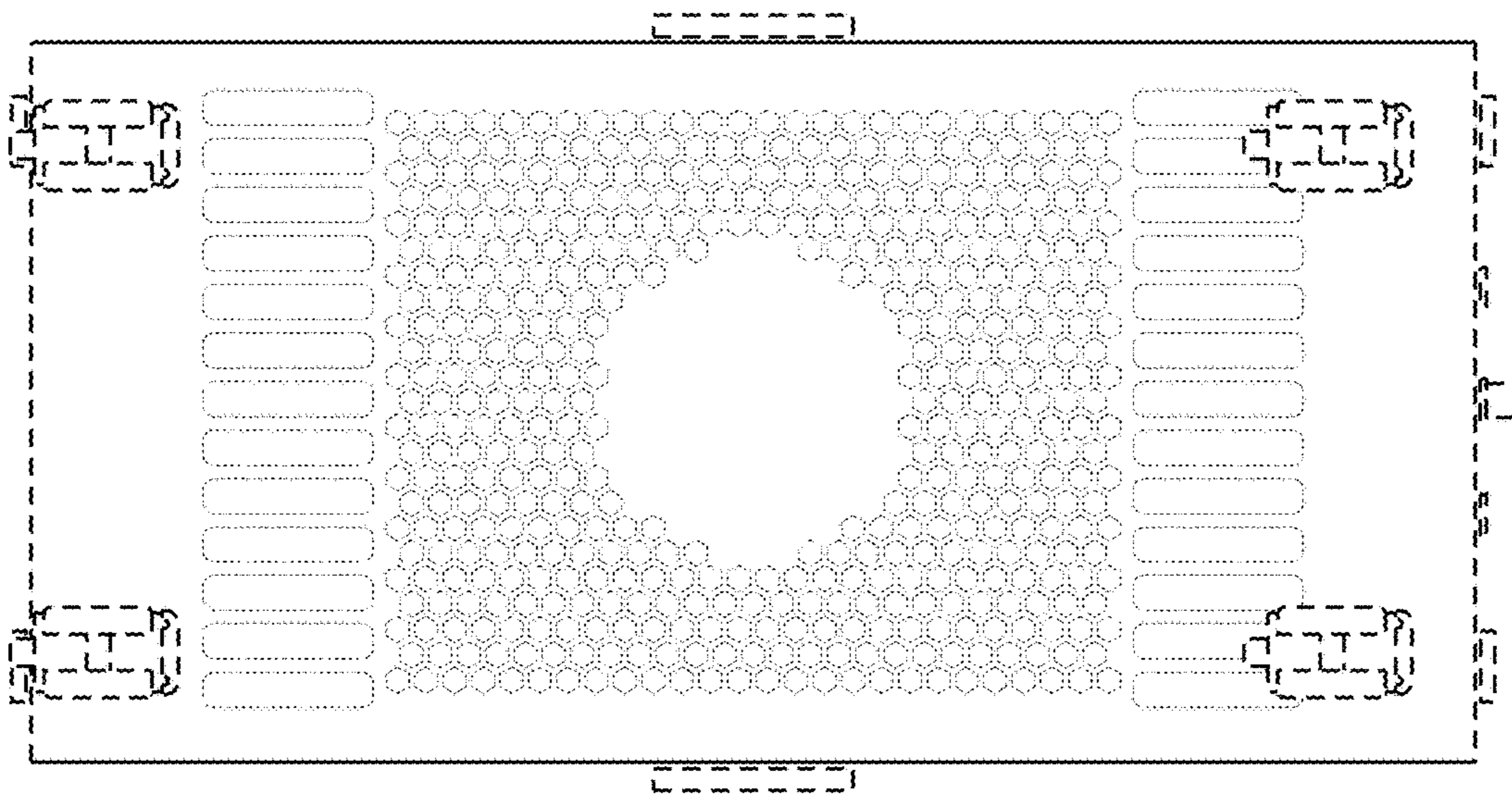

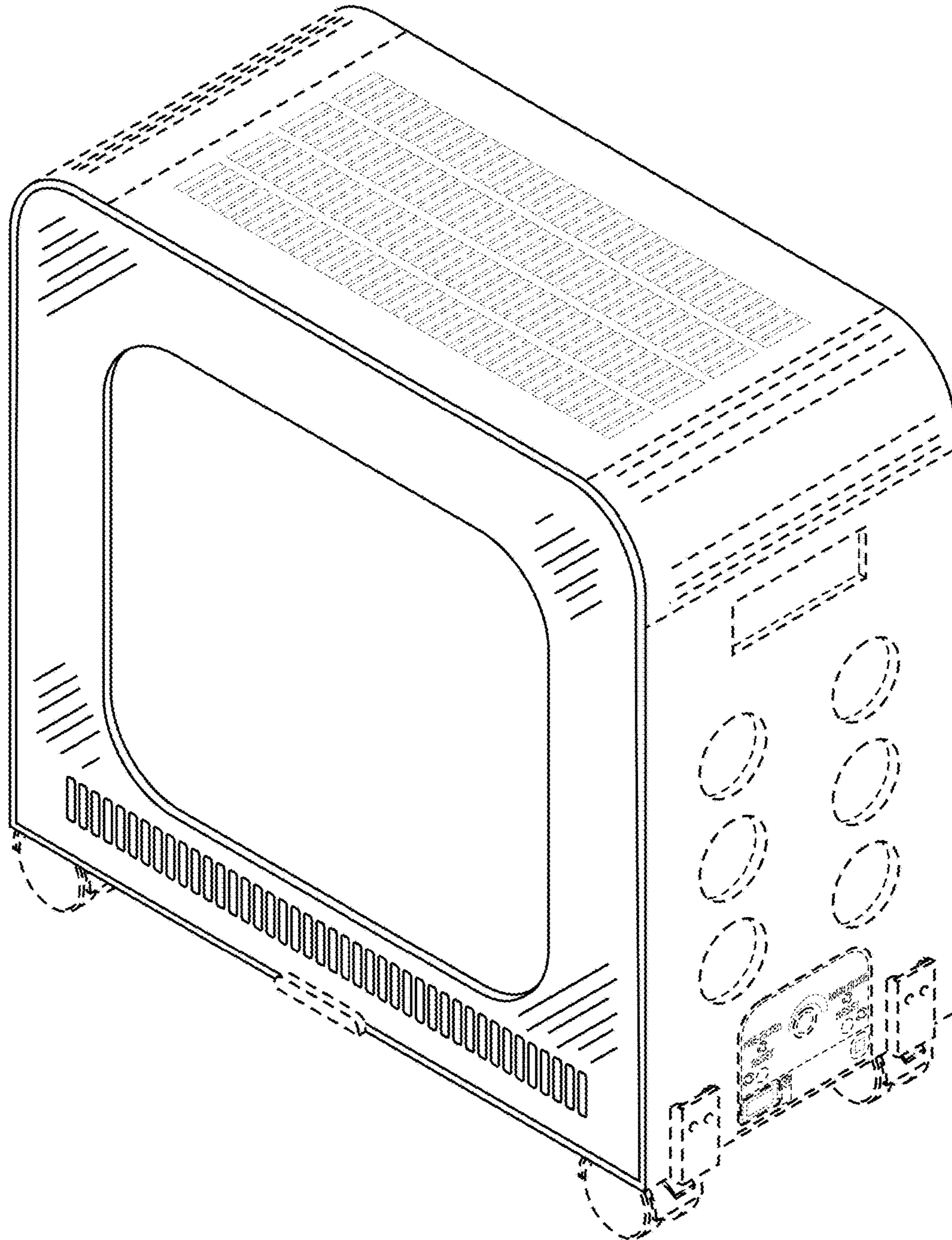




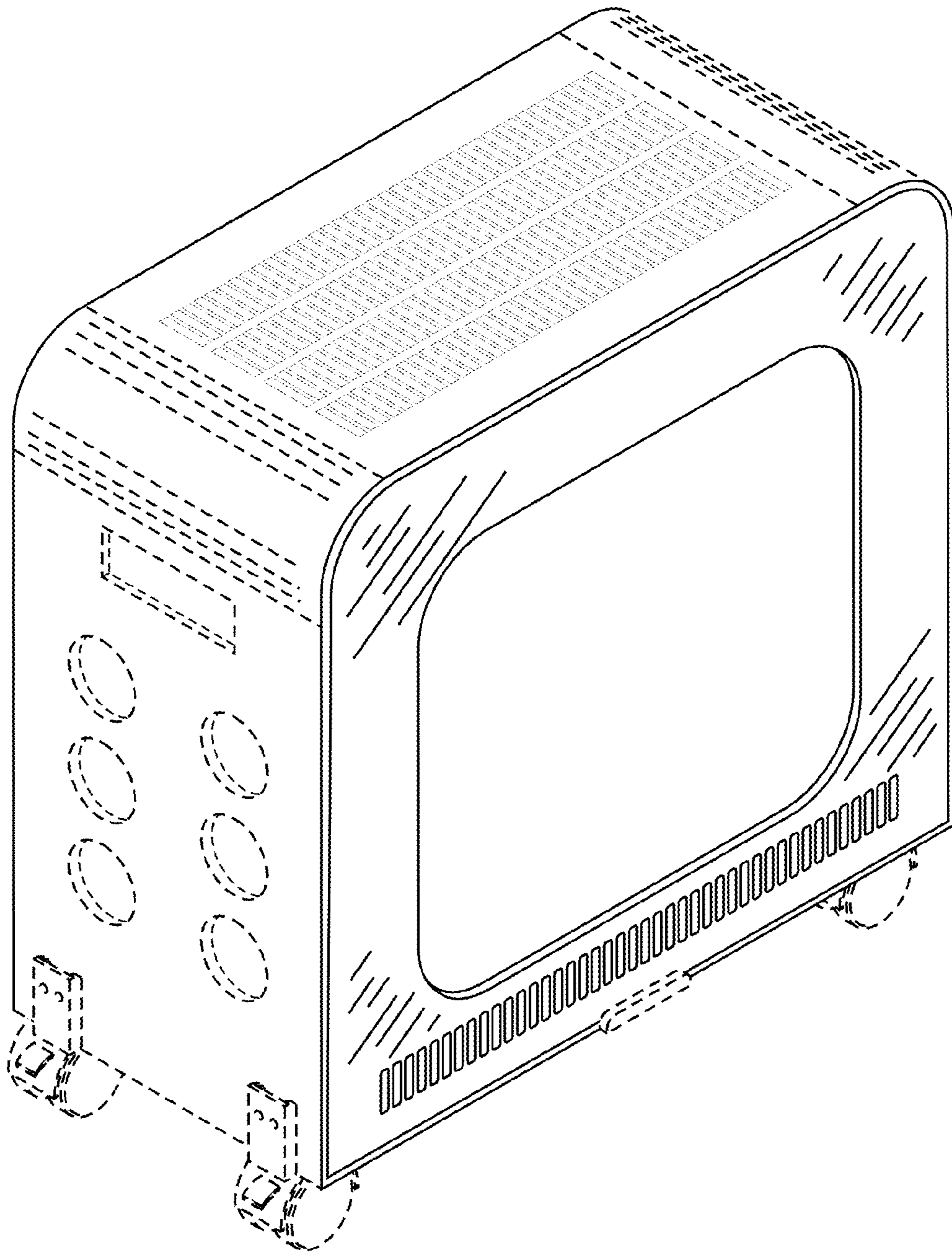
