FIG. 4 is a back side view of FIG. 2.

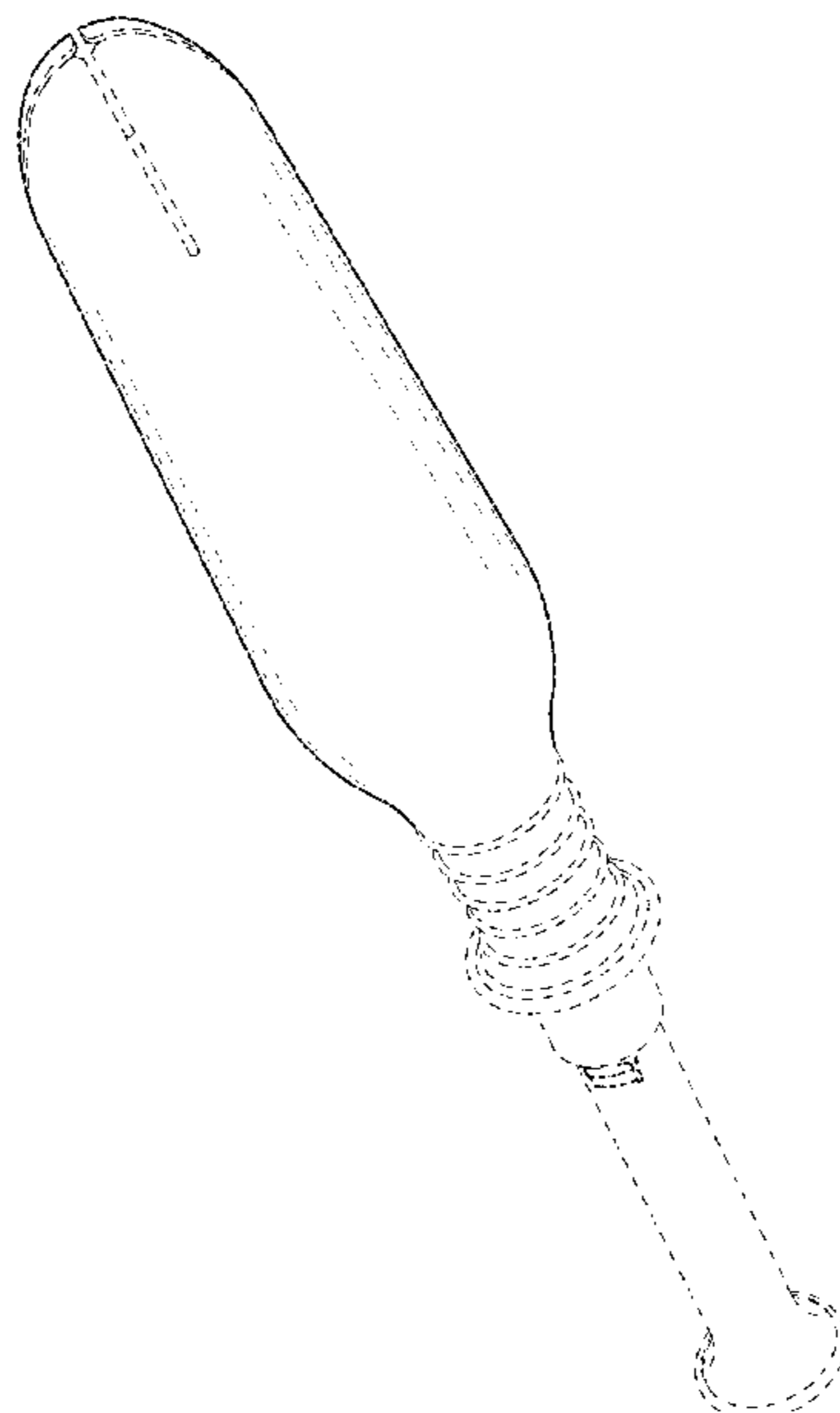
FIG. 5 is a left side view of FIG. 2.

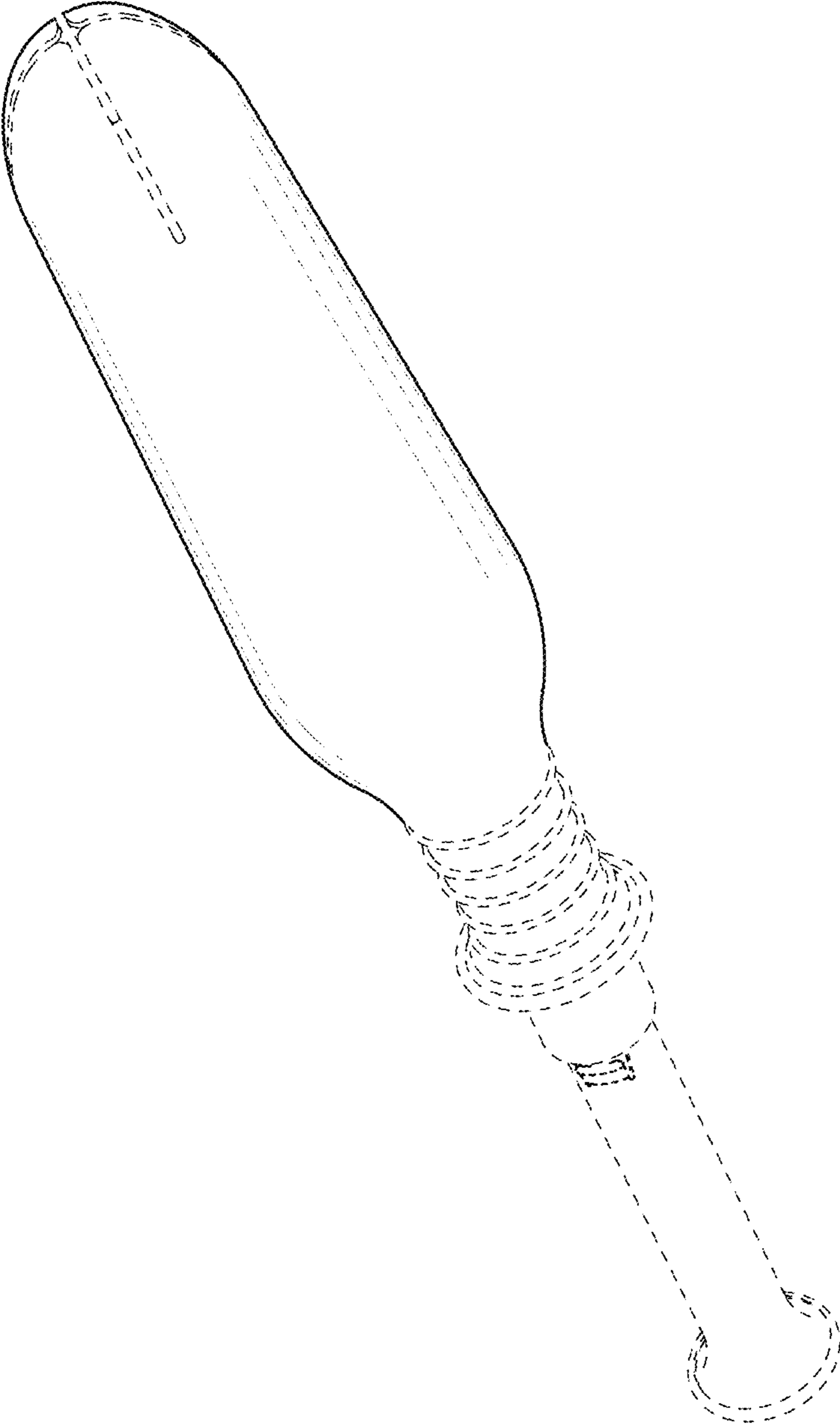

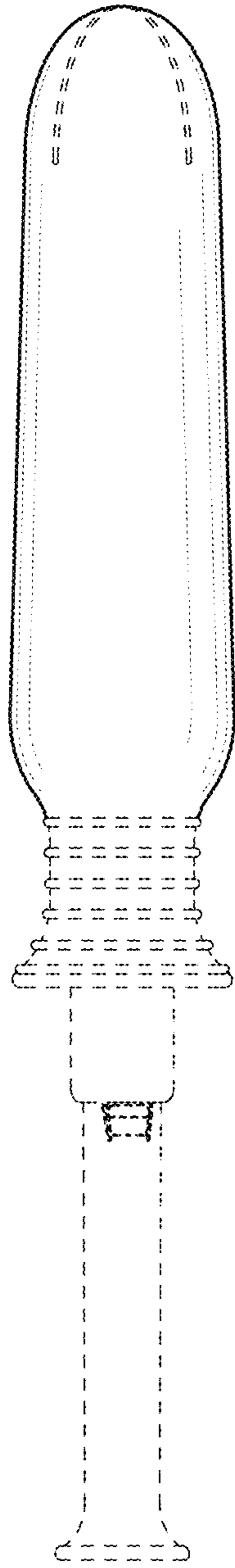

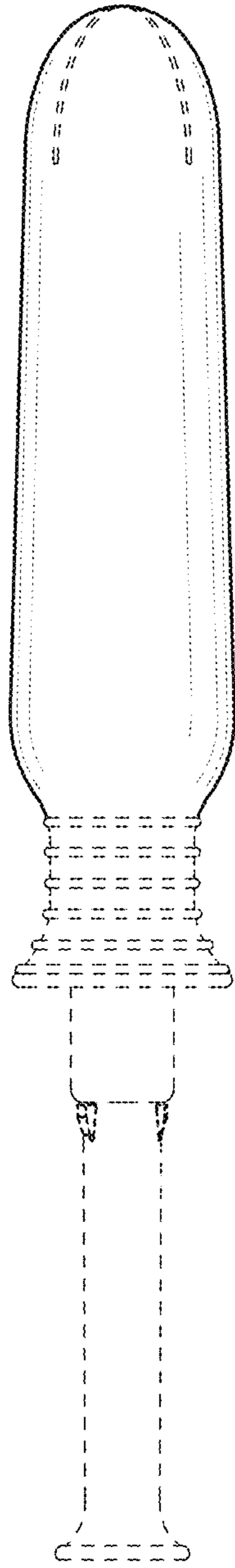

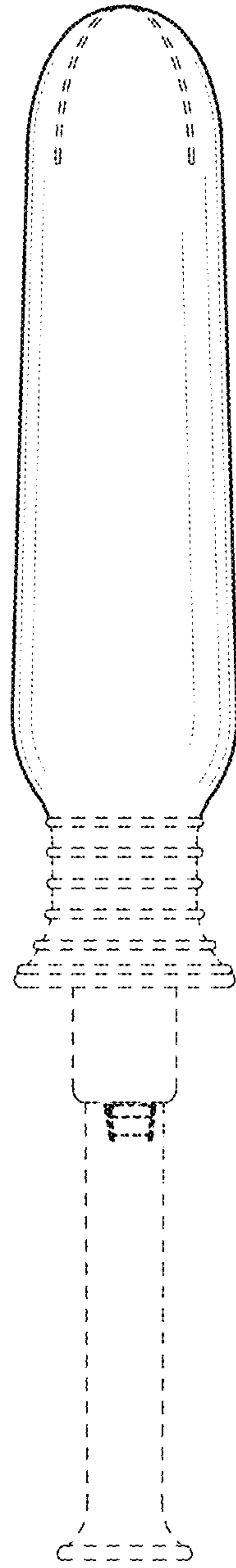

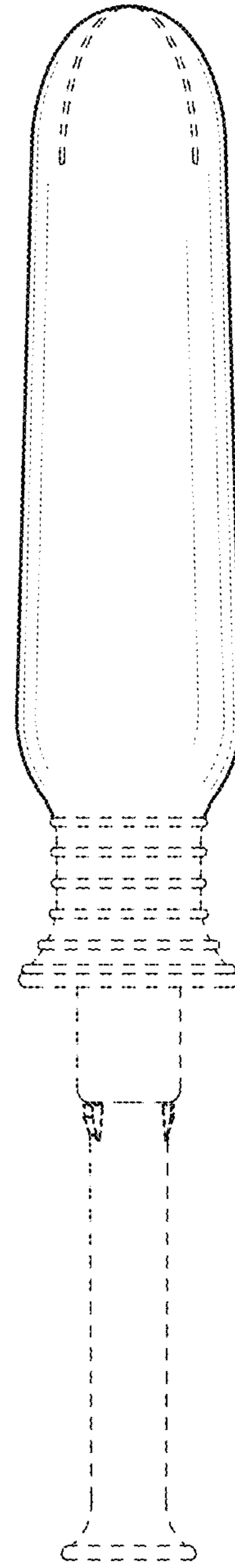

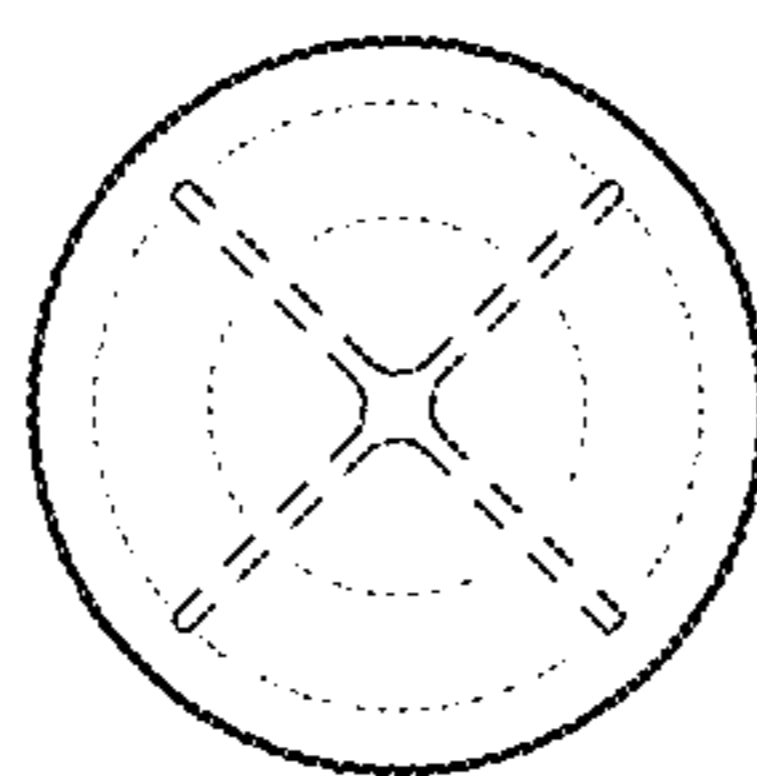

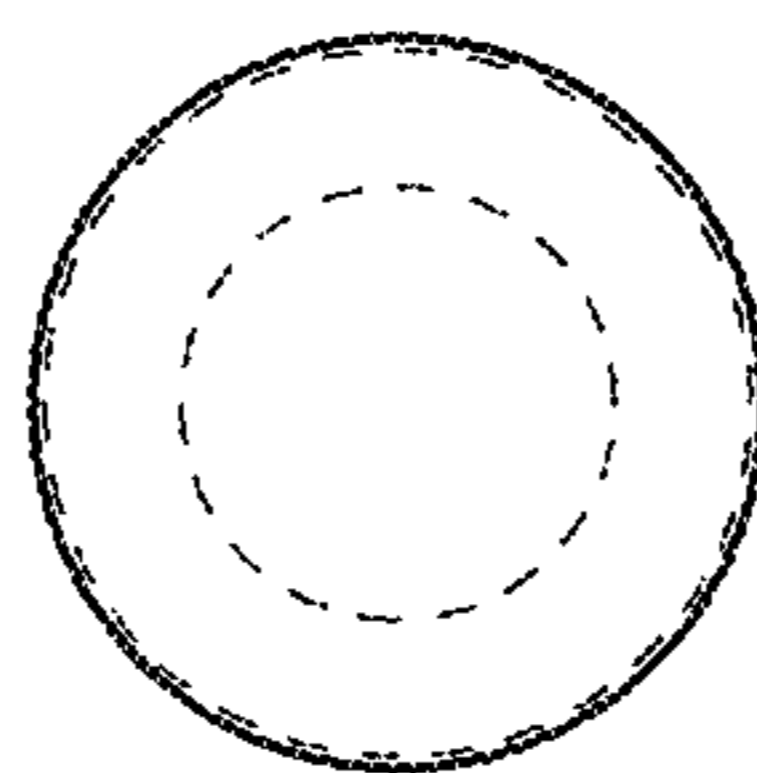
