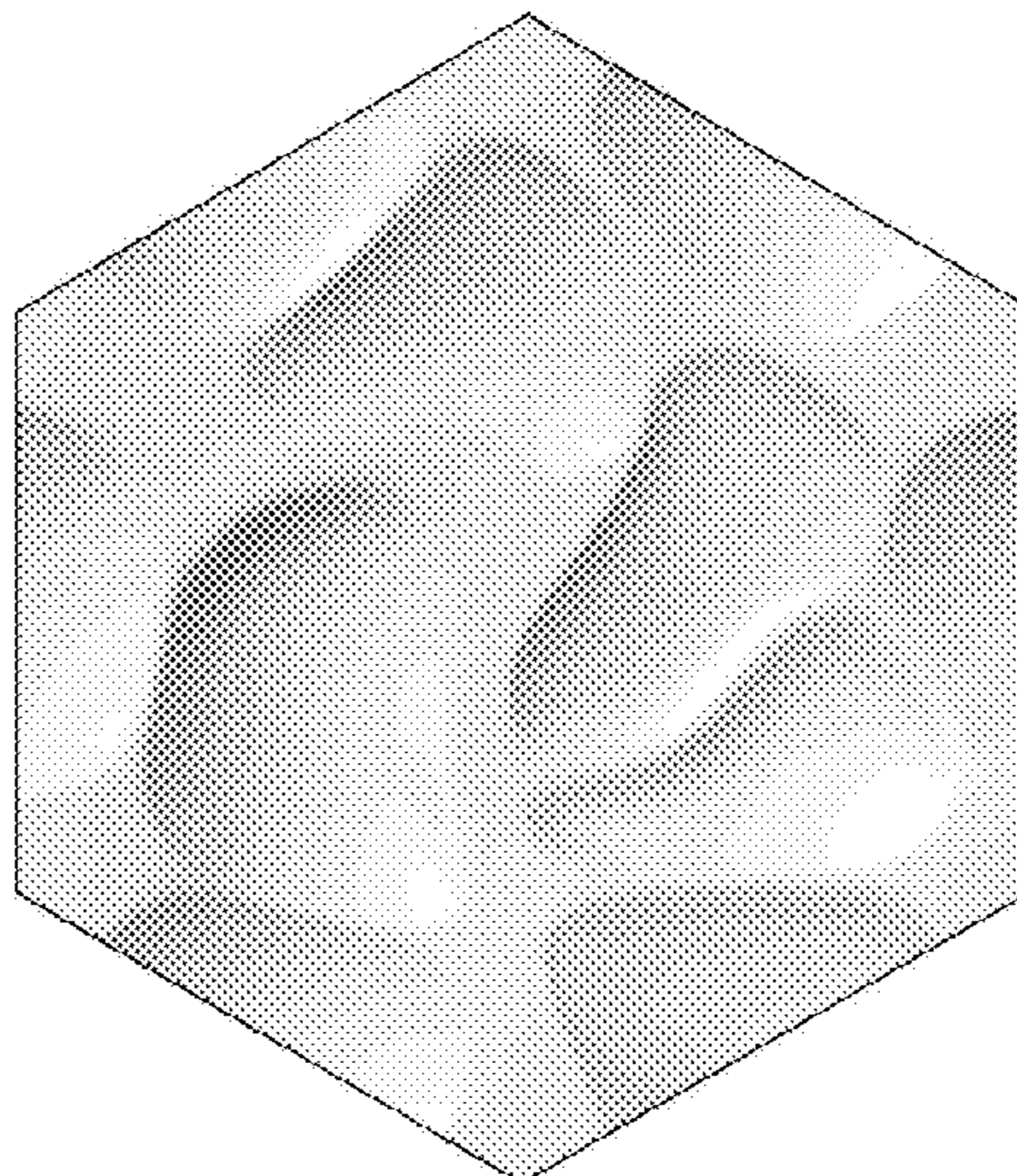
(57) **CLAIM**

I claim the ornamental design for decorative wall panels, as shown and described.

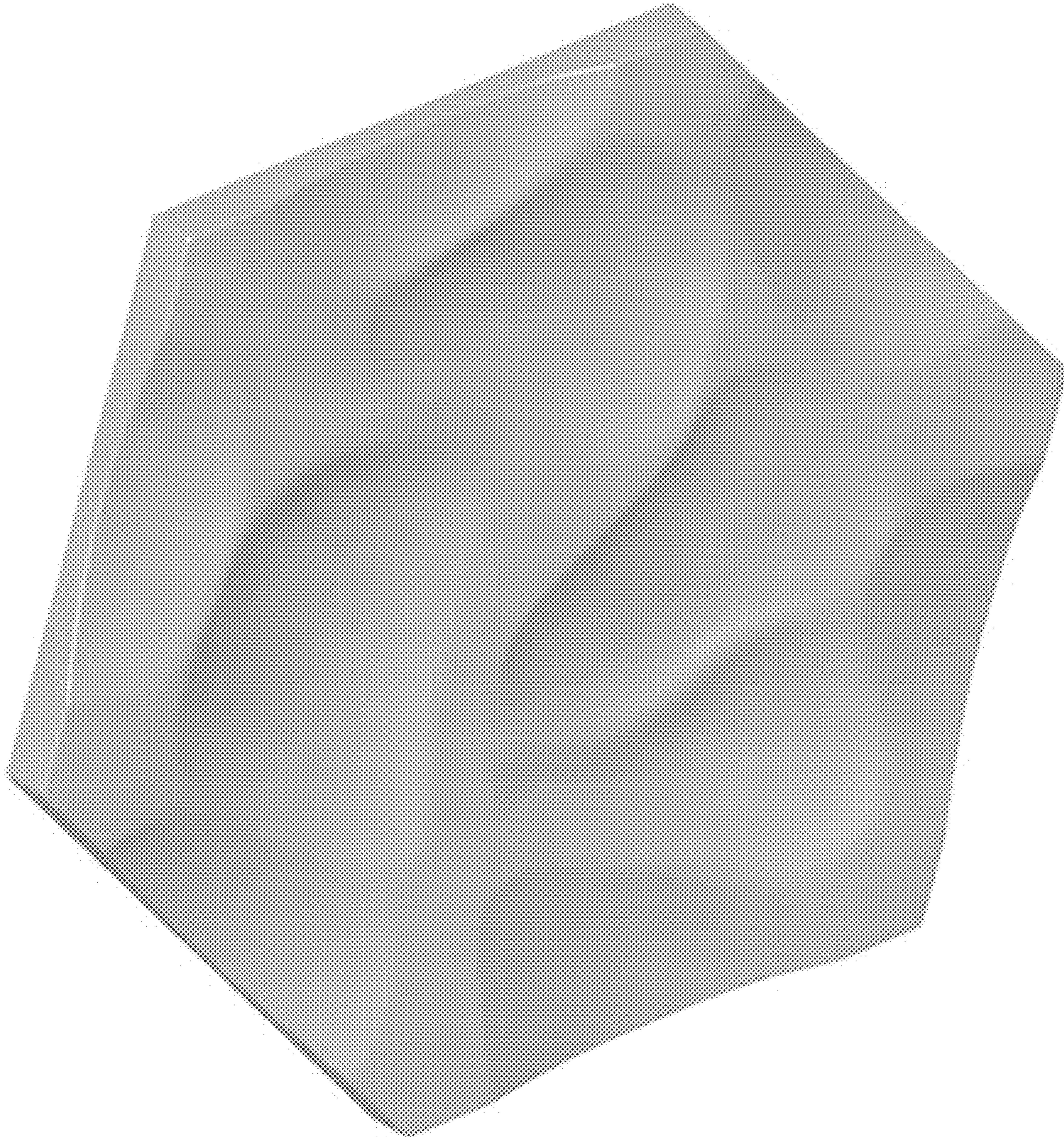
DESCRIPTION

1.3 shows a front side view of 1.1.

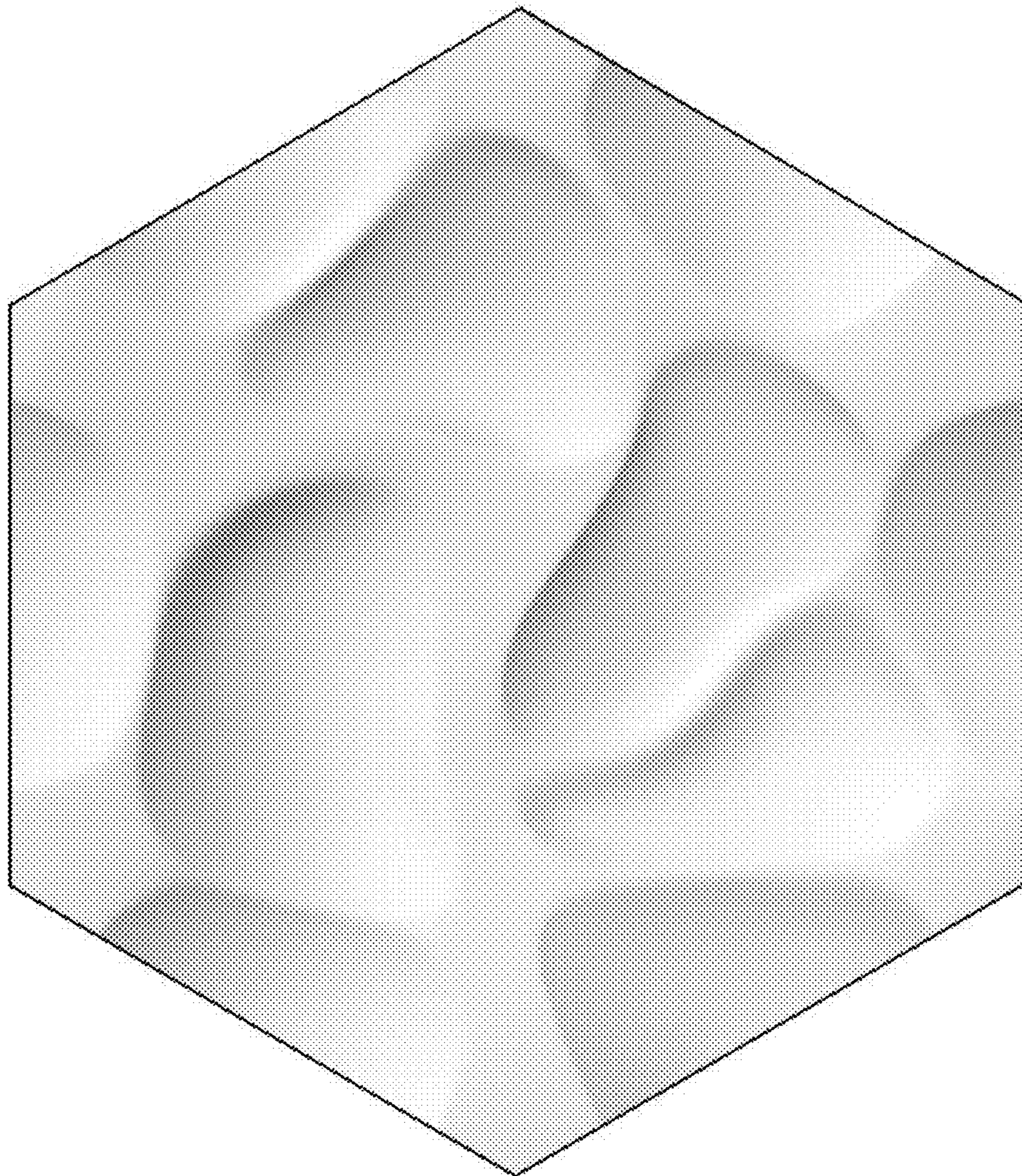

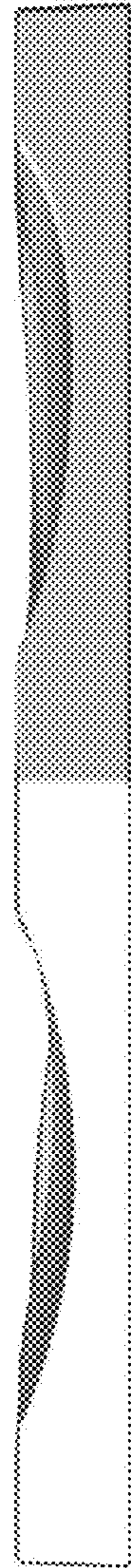
