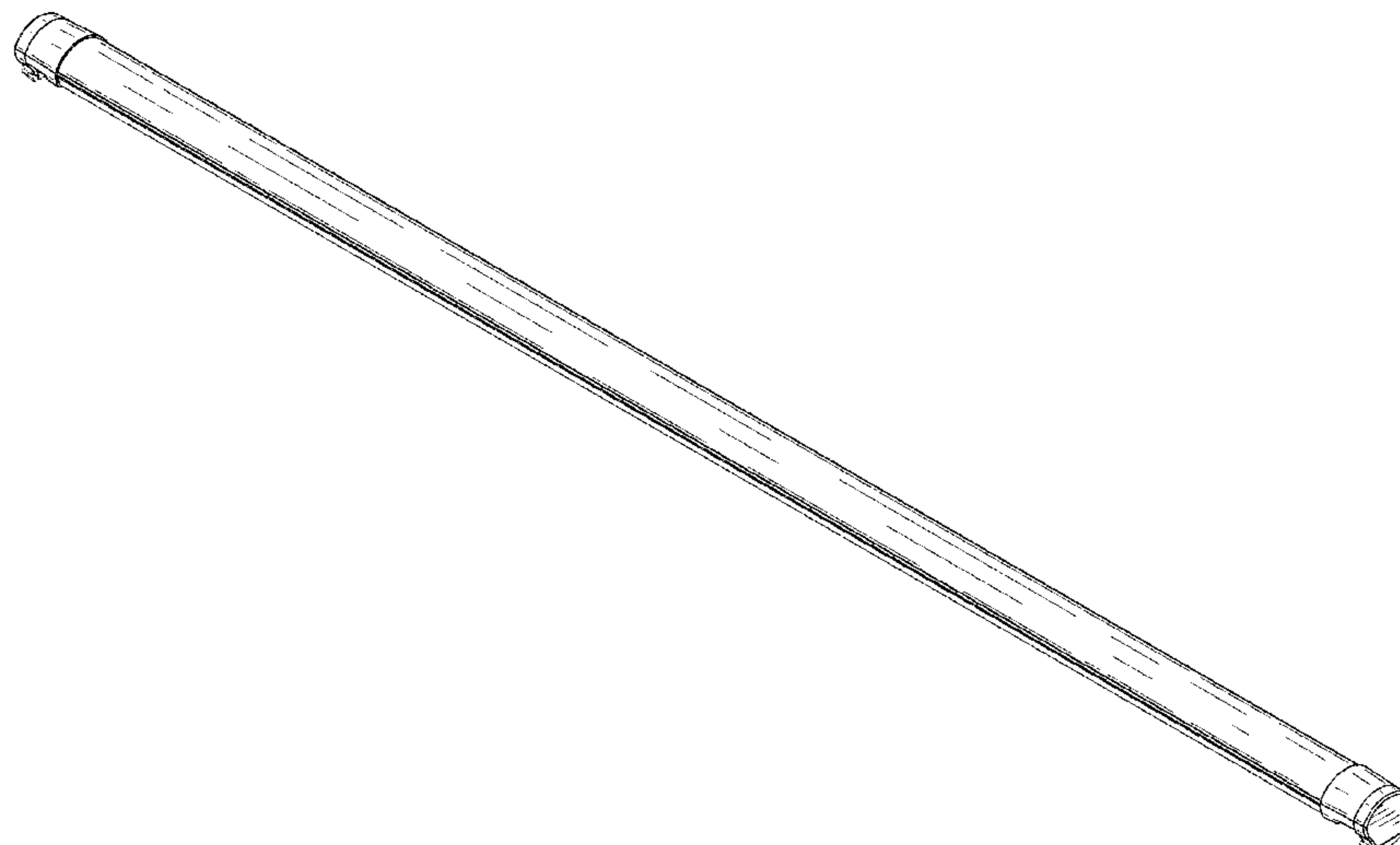
(57) **CLAIM**

The ornamental design for a LED board rail and clip, as shown and described.

DESCRIPTION

FIG. 1 is a top perspective view showing our new design; FIG. 2 is a bottom perspective view thereof; FIG. 3 is a top elevational view thereof; FIG. 4 is a bottom elevational view thereof; FIG. 5 is a right side elevational view thereof, the left side being a mirror image; FIG. 6 is a front view thereof, the rear being a mirror image; FIG. 7 is a top perspective view thereof; FIG. 8 is a bottom perspective view thereof; FIG. 9 is a top elevational view thereof; FIG. 10 is a bottom elevational view thereof; FIG. 11 is a right side elevational view thereof, the left side being a mirror image; and, FIG. 12 is a front view thereof, the rear being a mirror image. The article is shown broken away in FIGS. 7-11 for ease of disclosure only. Nothing between the break lines is part of the claimed design.

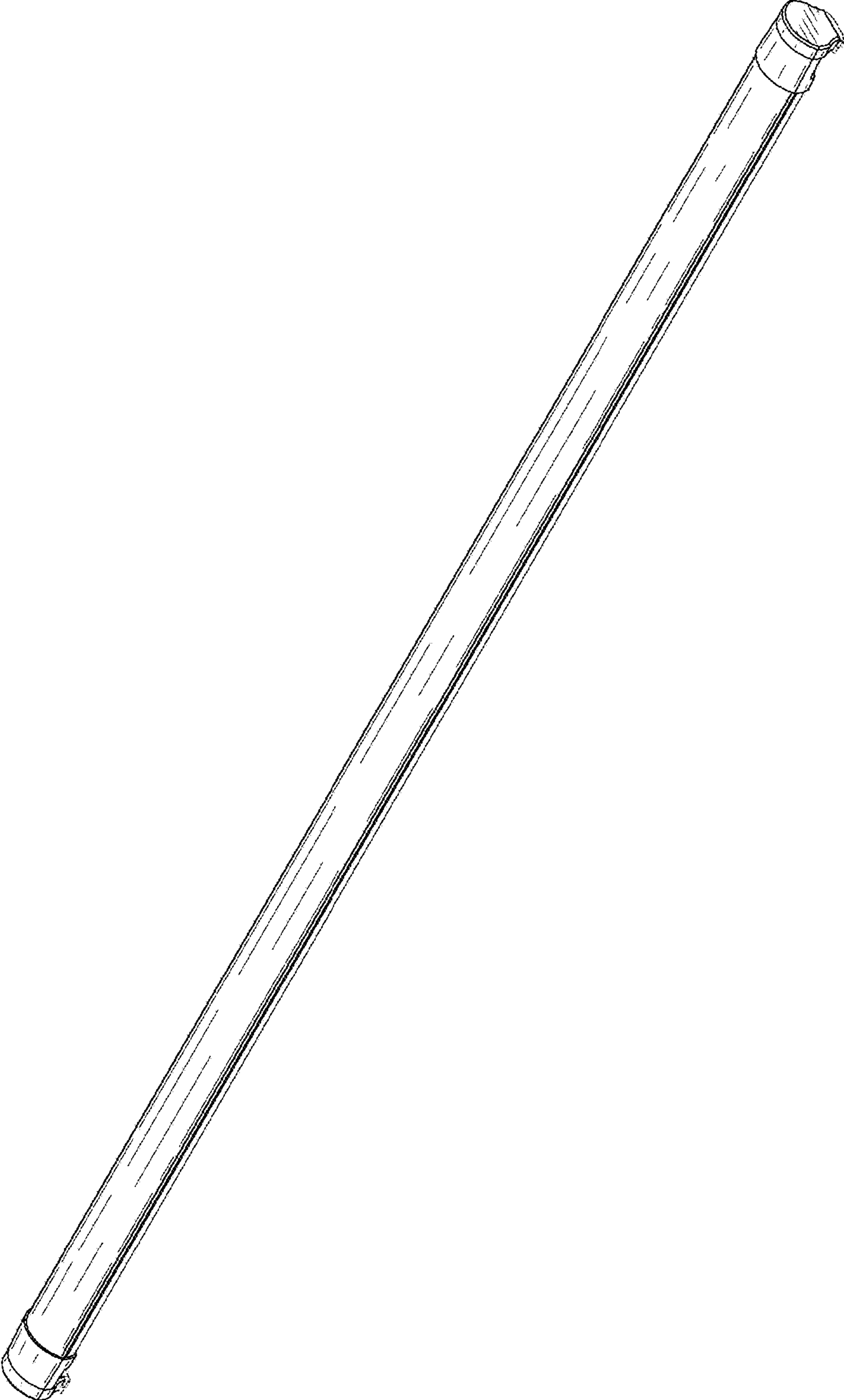

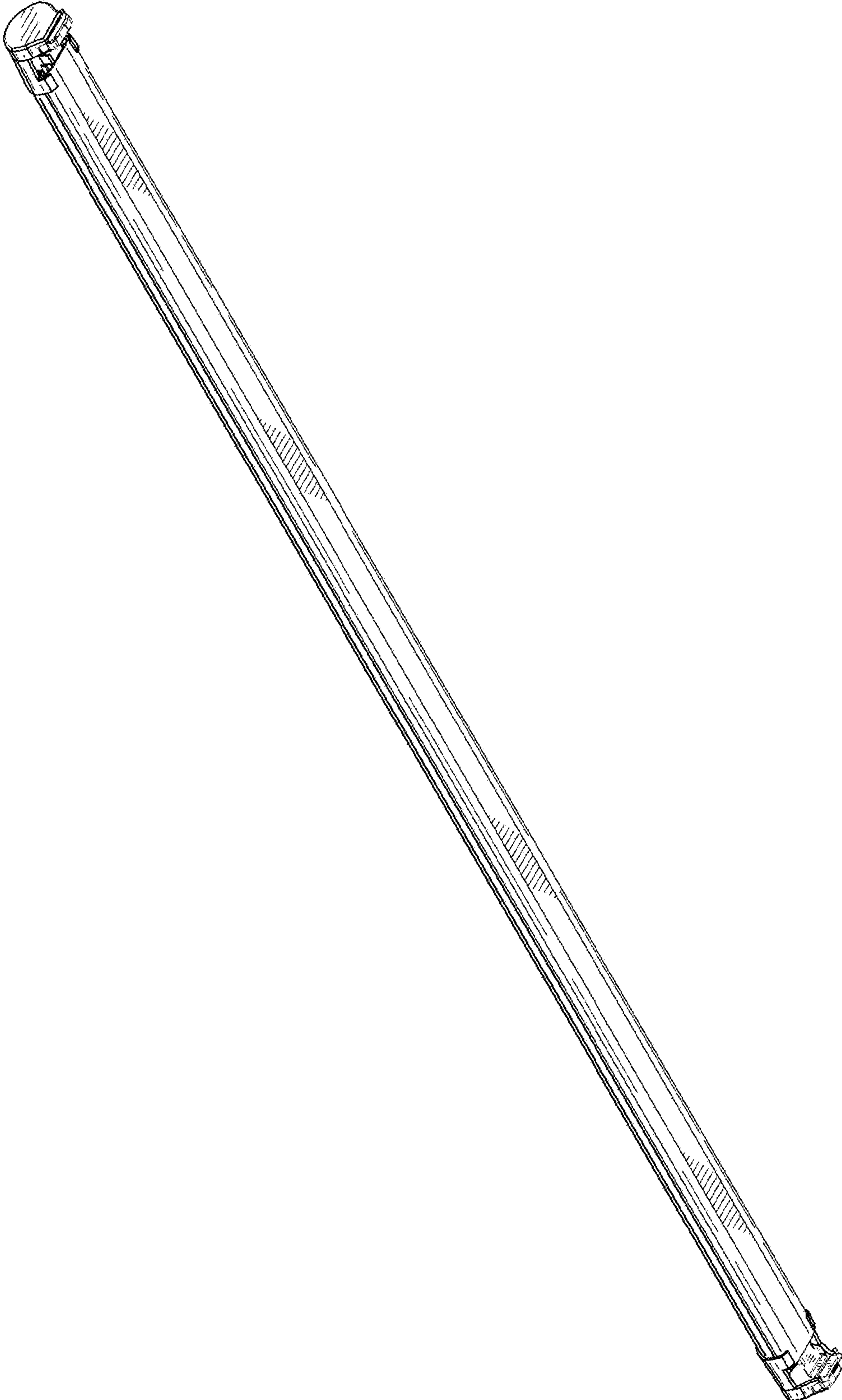

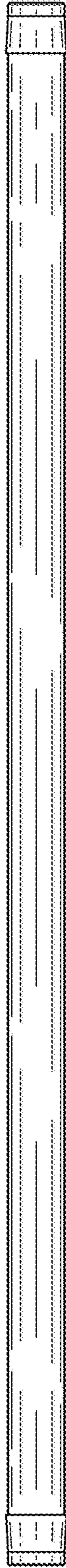

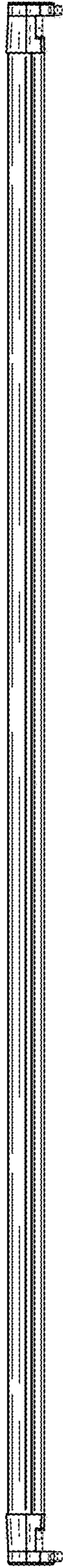

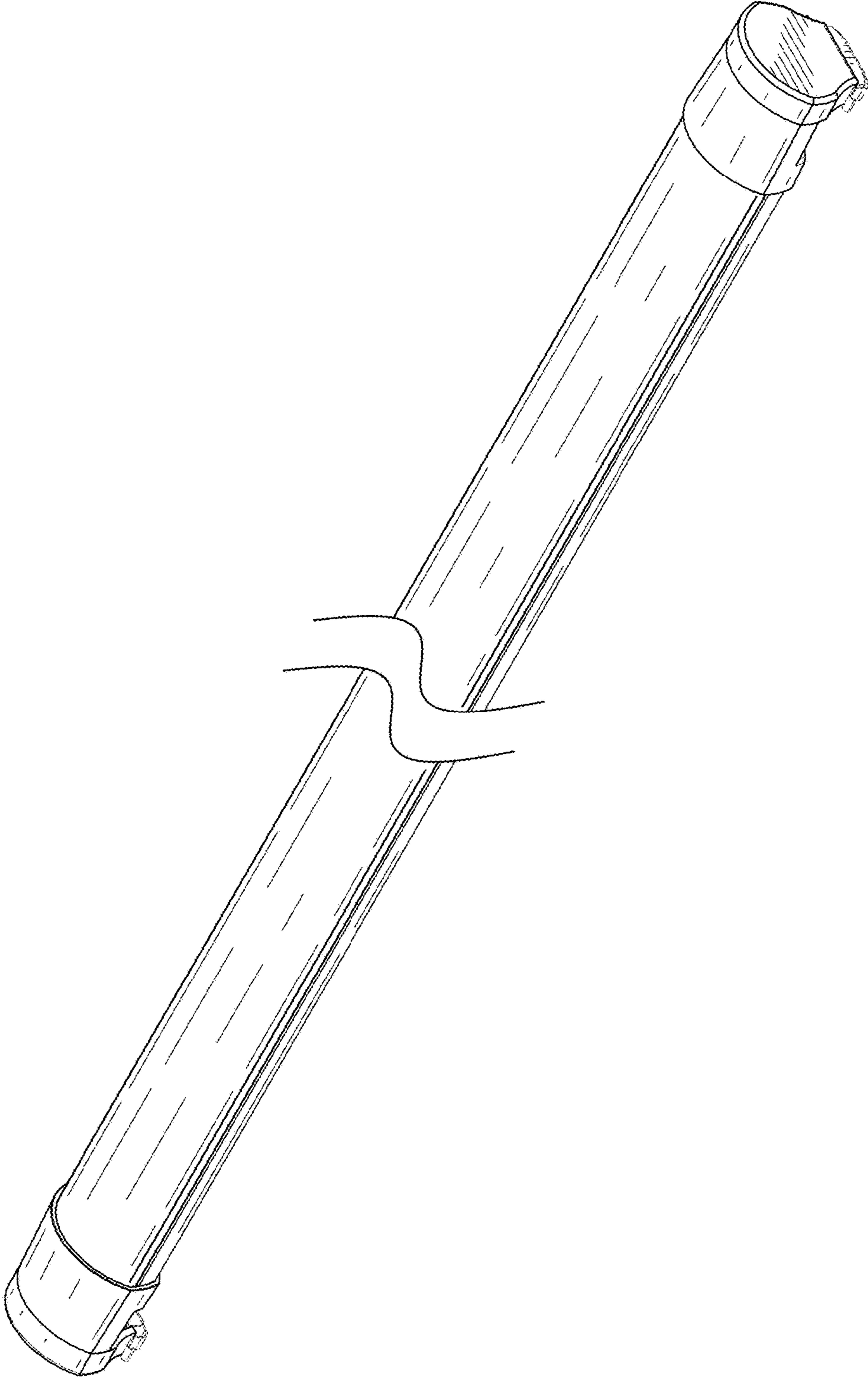

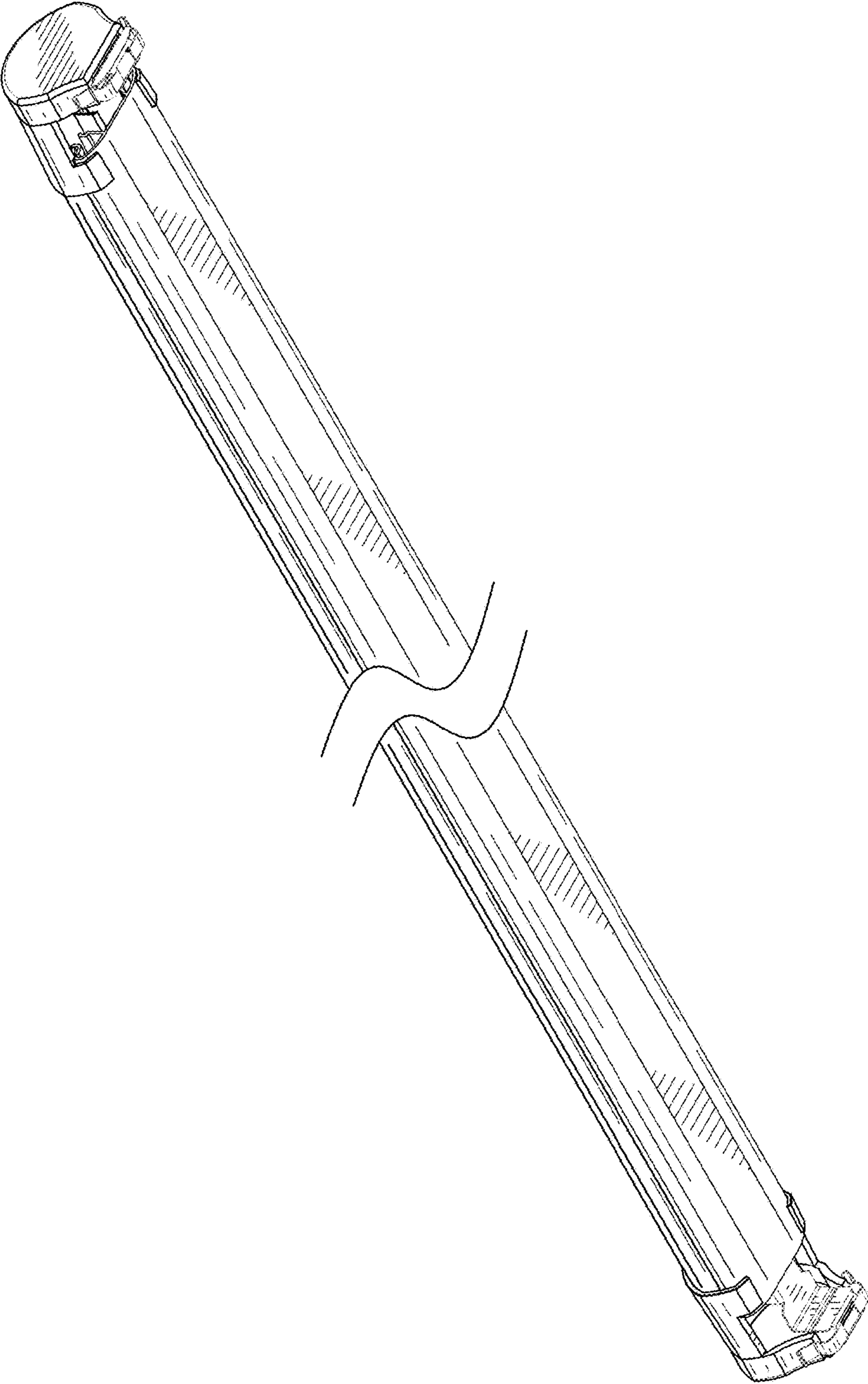

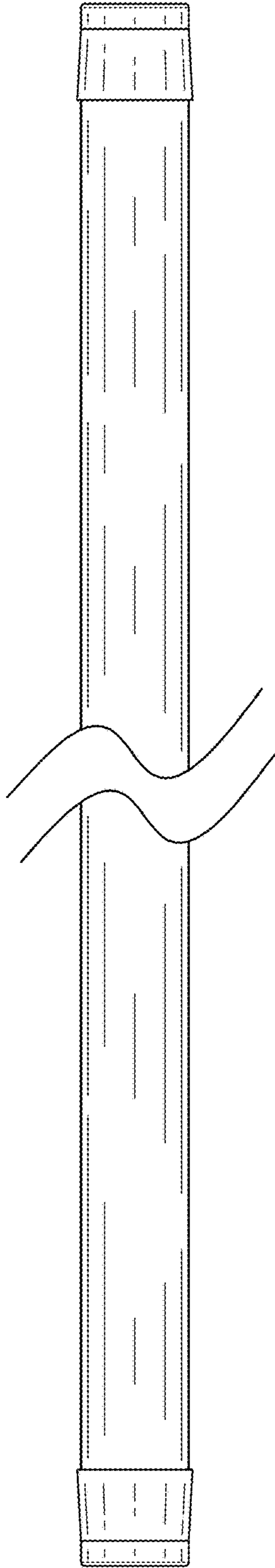

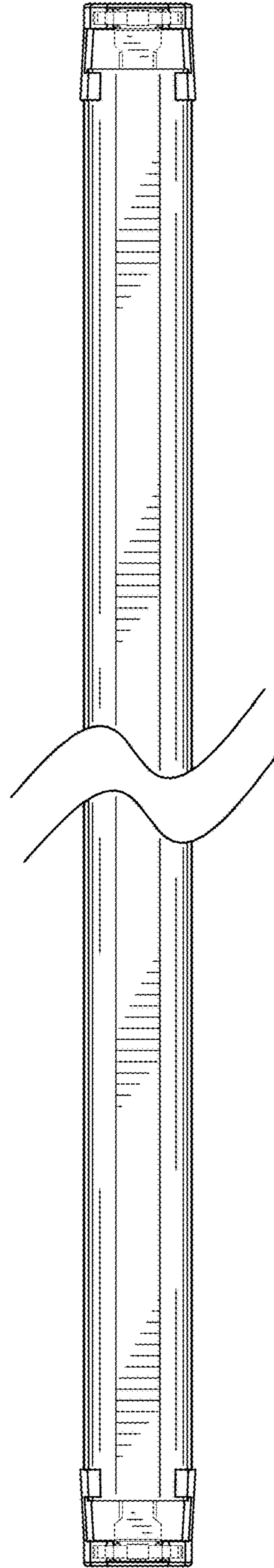

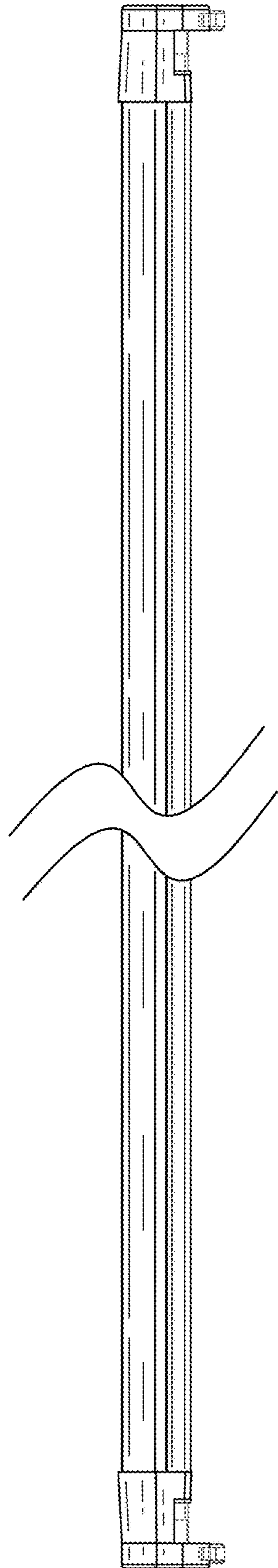

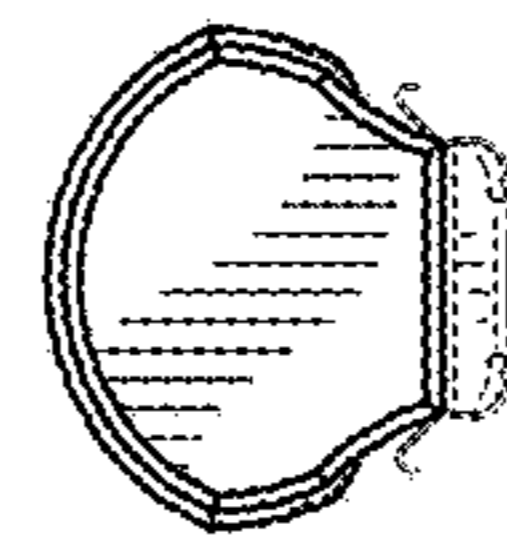
