(57) **CLAIM**

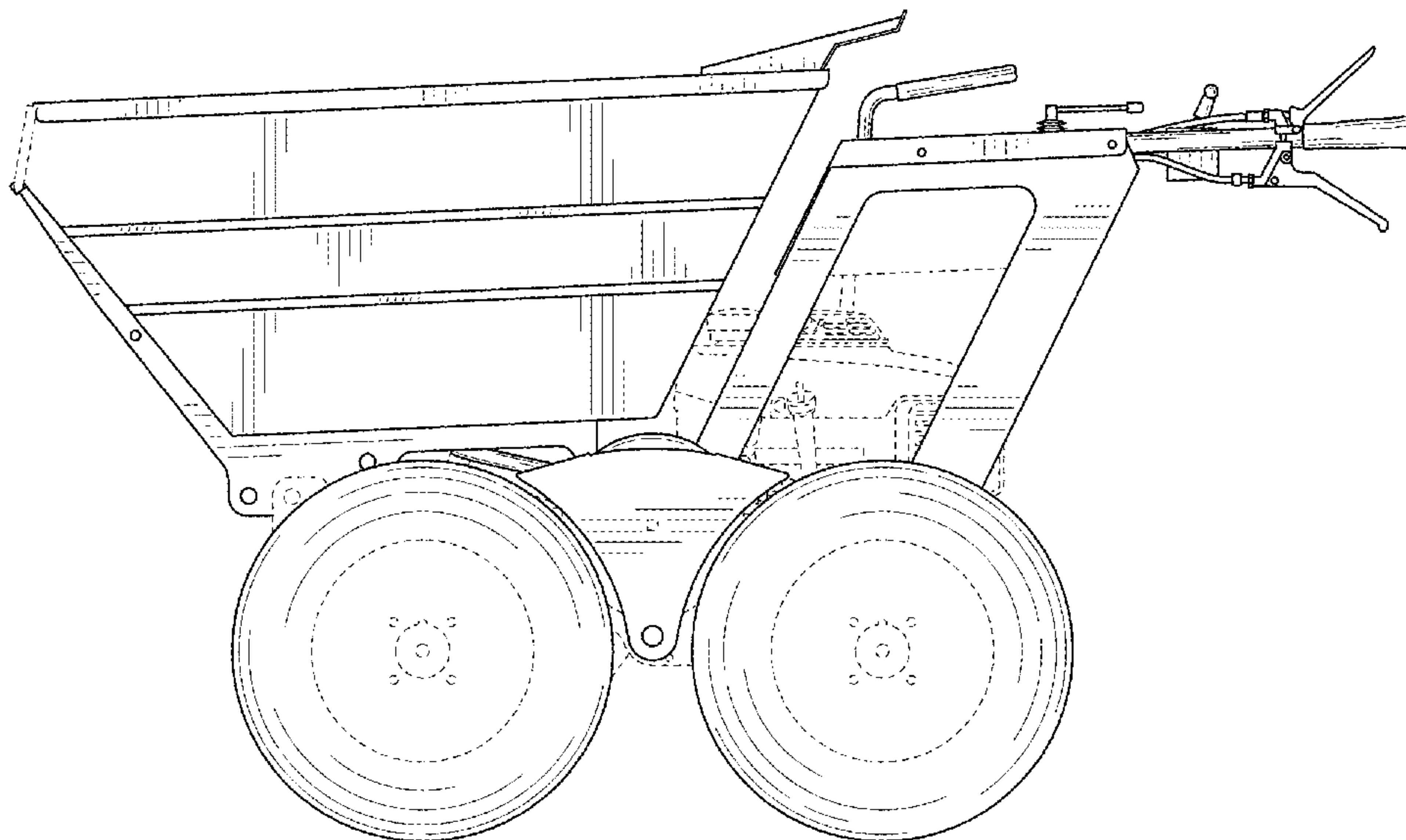
The ornamental design for a motorized wheelbarrow, as shown and described.

DESCRIPTION

FIG. 1 is a left side elevational view of a motorized wheelbarrow showing my new design; FIG. 2 is a right side elevational view thereof; FIG. 3 is a front elevational view thereof; FIG. 4 is a back elevational view thereof; FIG. 5 is a top plan view thereof; FIG. 6 is a left side elevational view thereof, with the bed shown in a raised position; and, FIG. 7 is a top plan view thereof, with the bed shown in a raised position.

The broken lines in the drawings illustrate the portions of the motorized wheelbarrow that form no part of the claimed design.

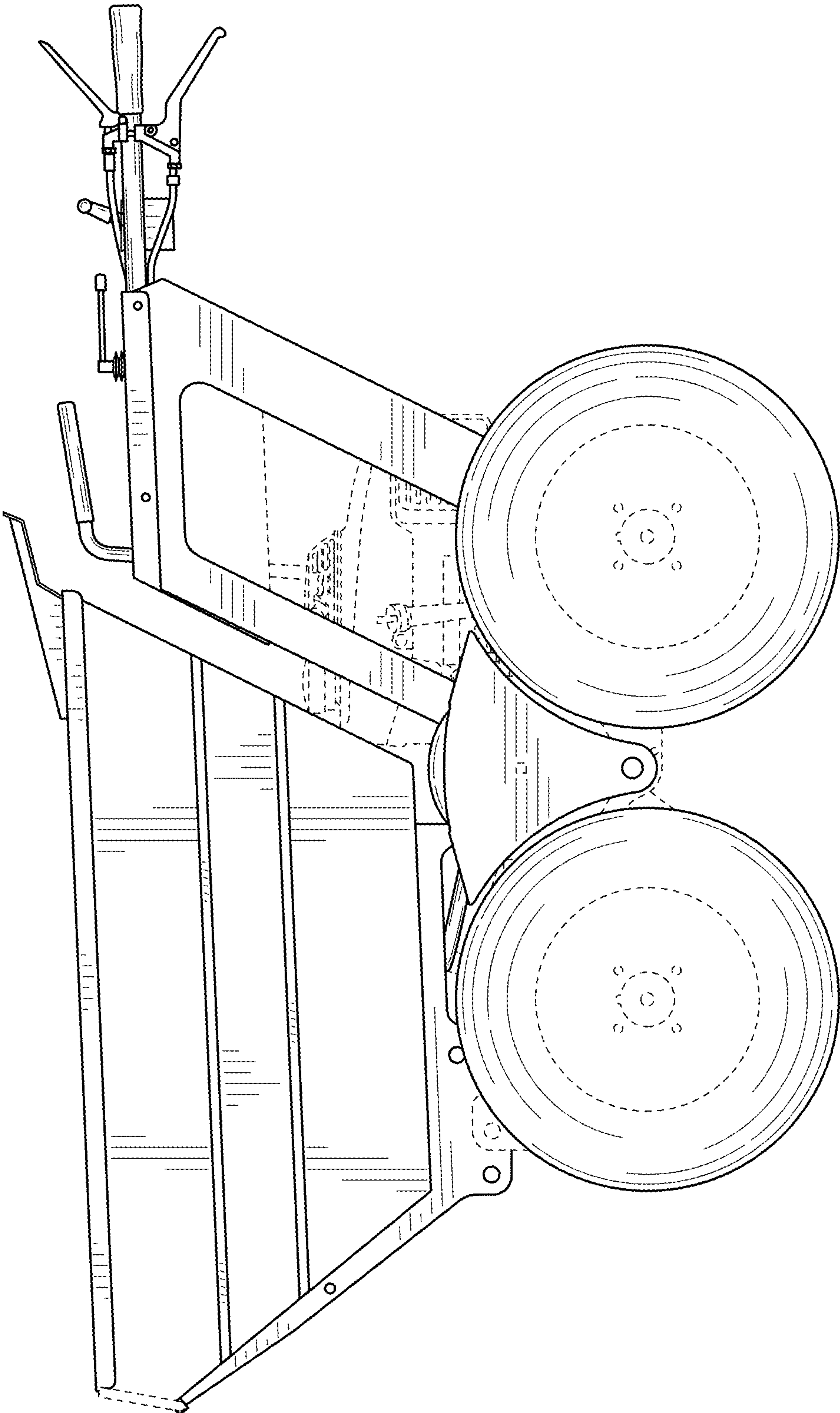

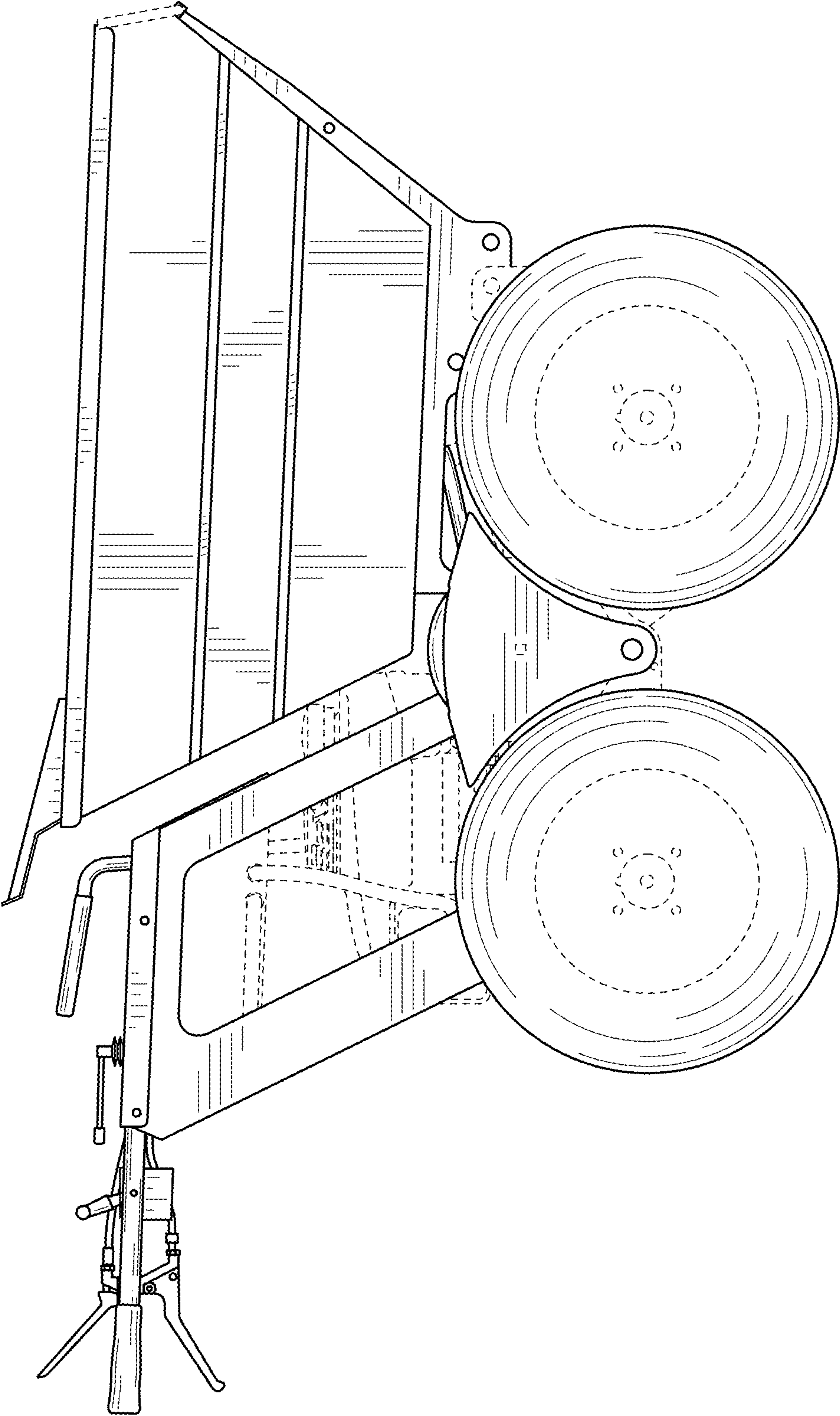

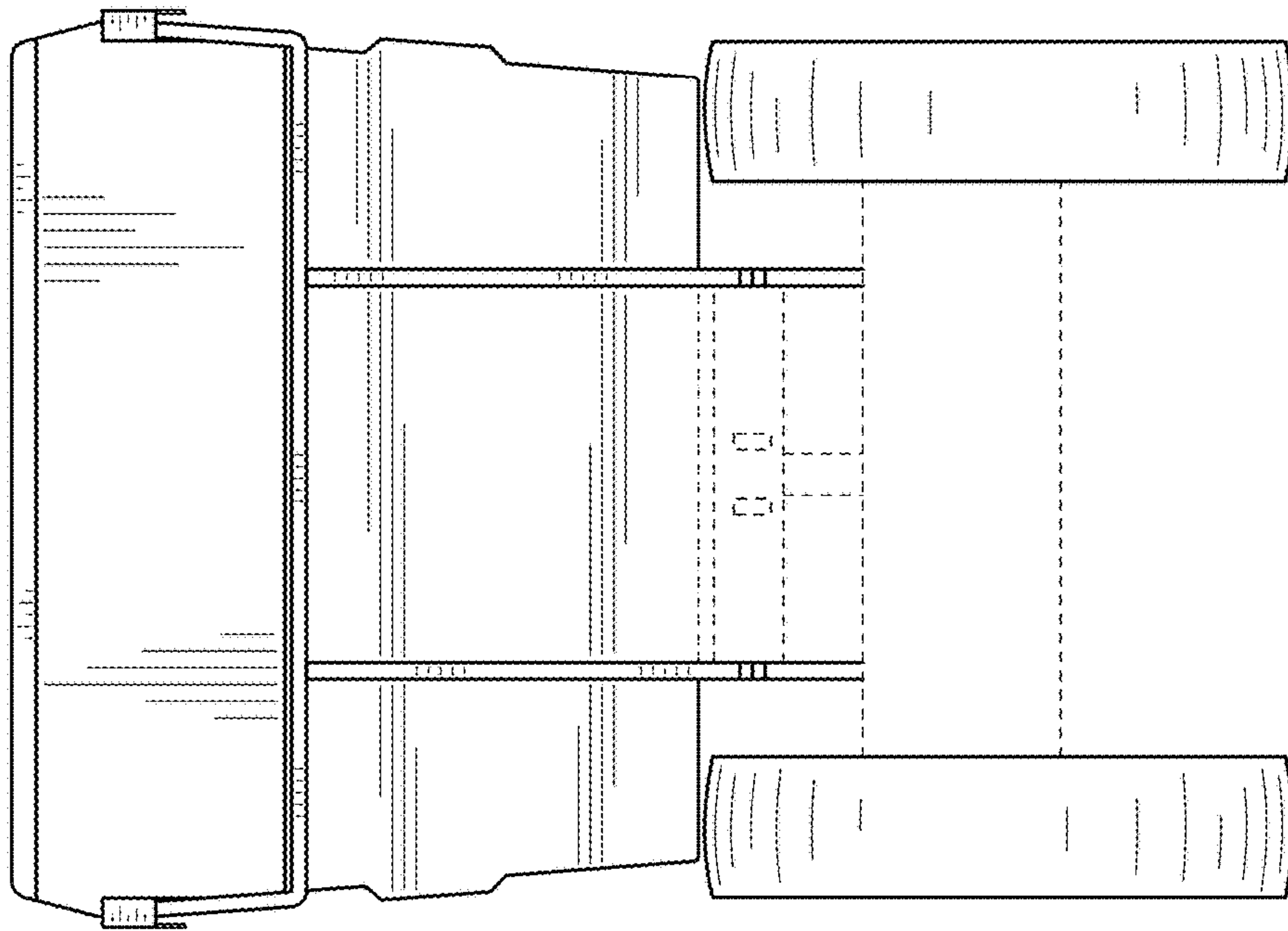

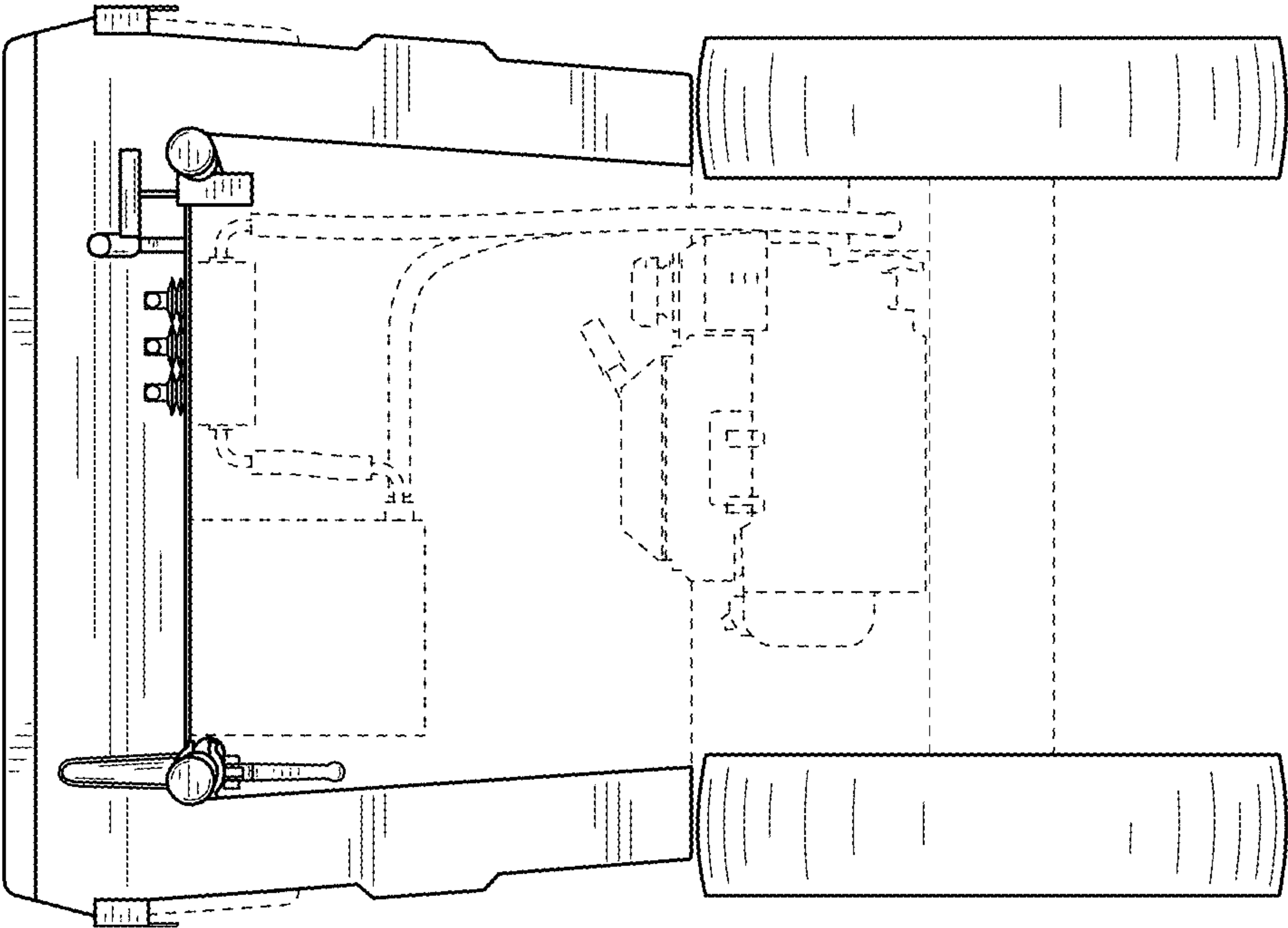

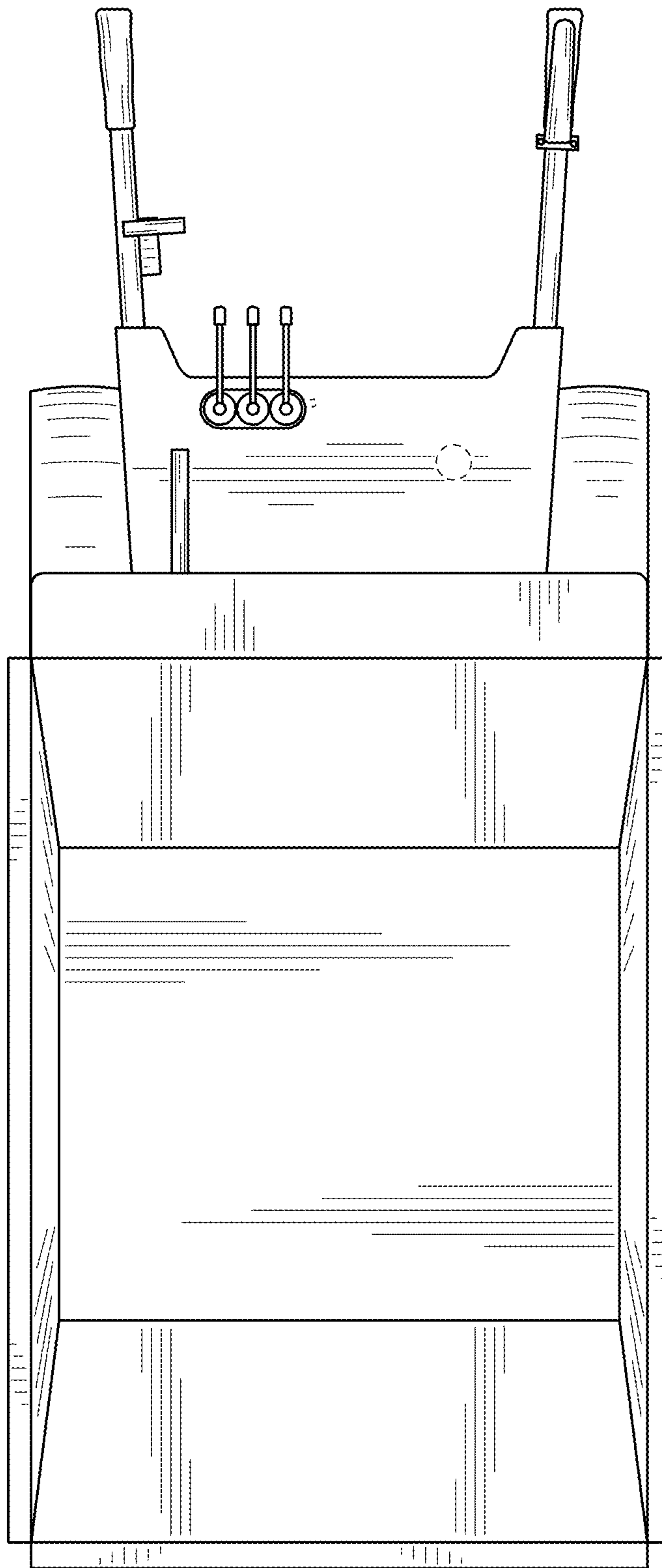

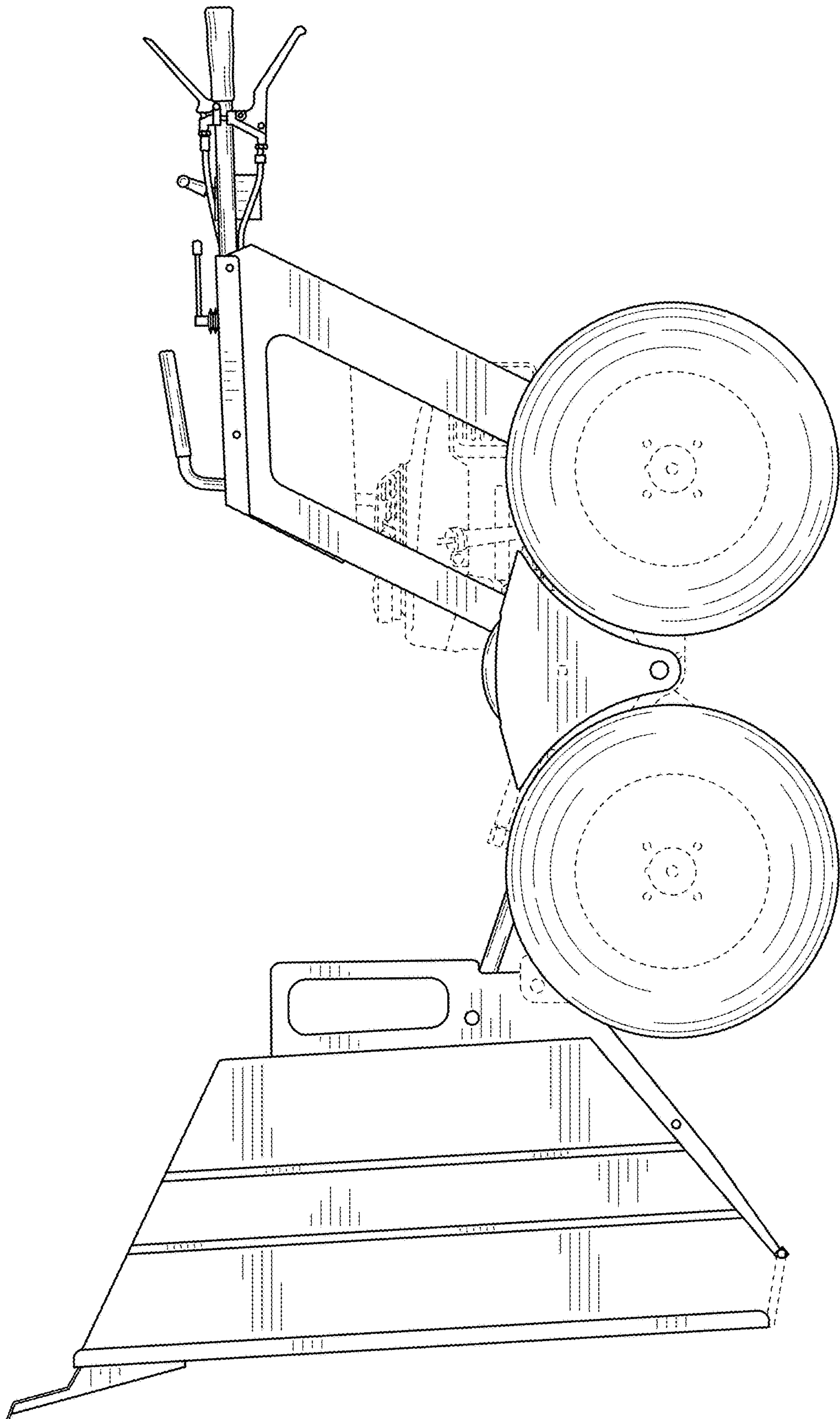

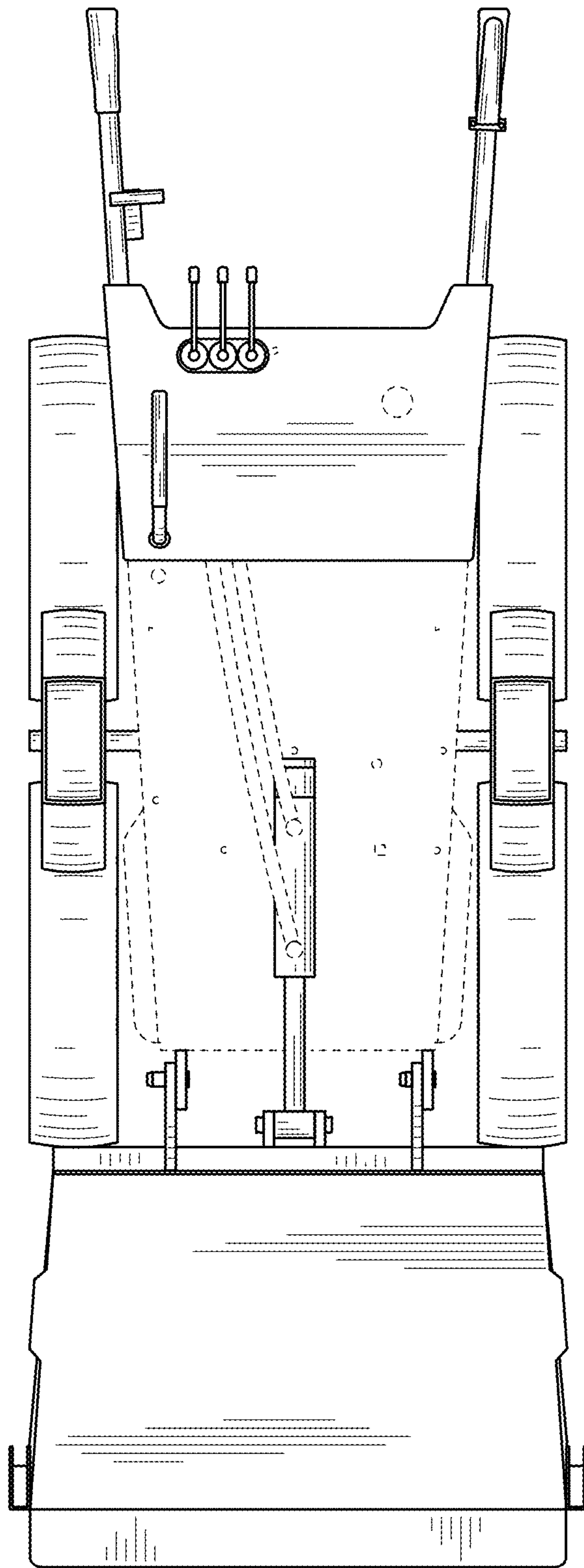
