I claim the ornamental design for an full-dip overshoe, as shown and described.

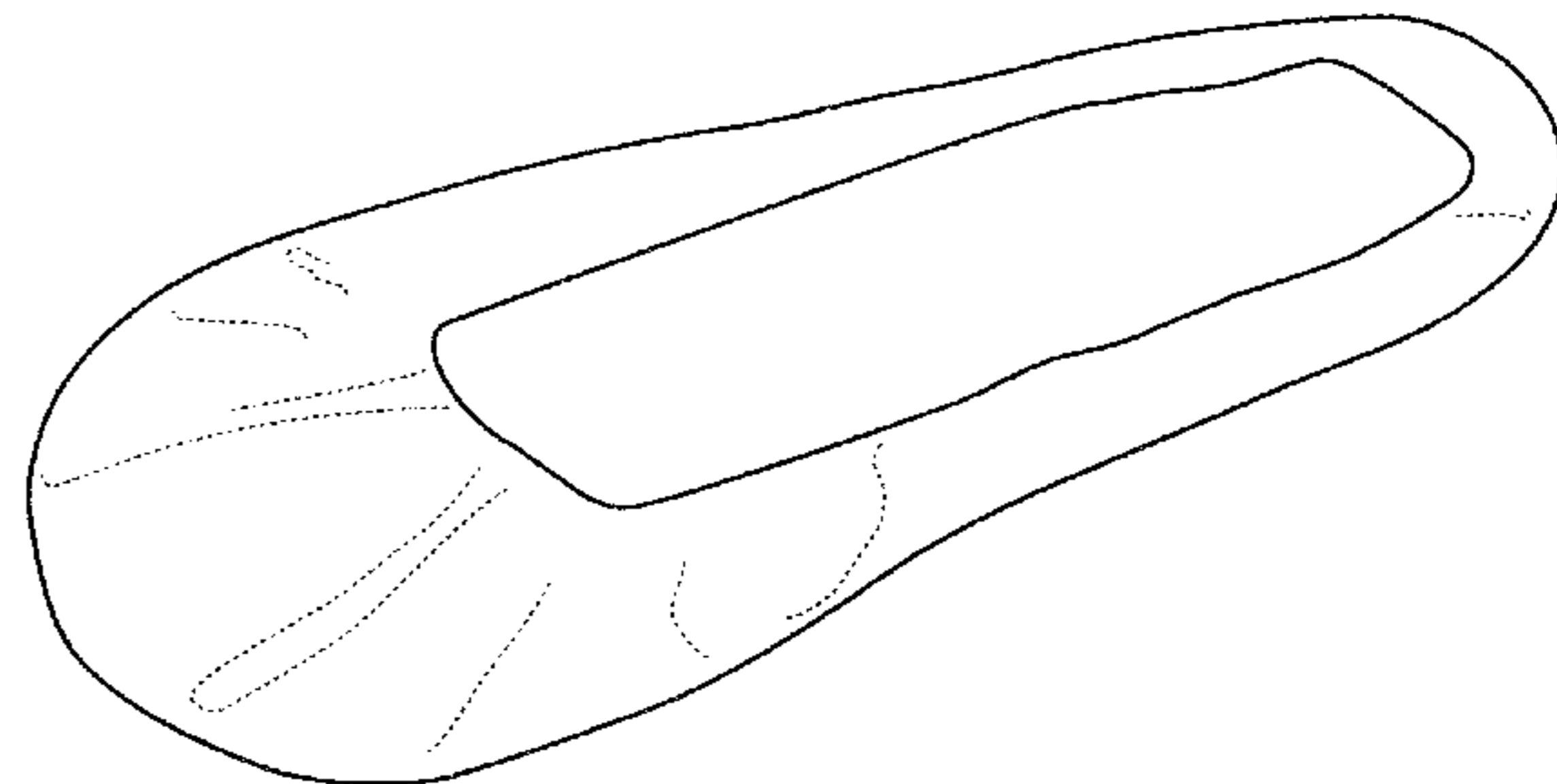
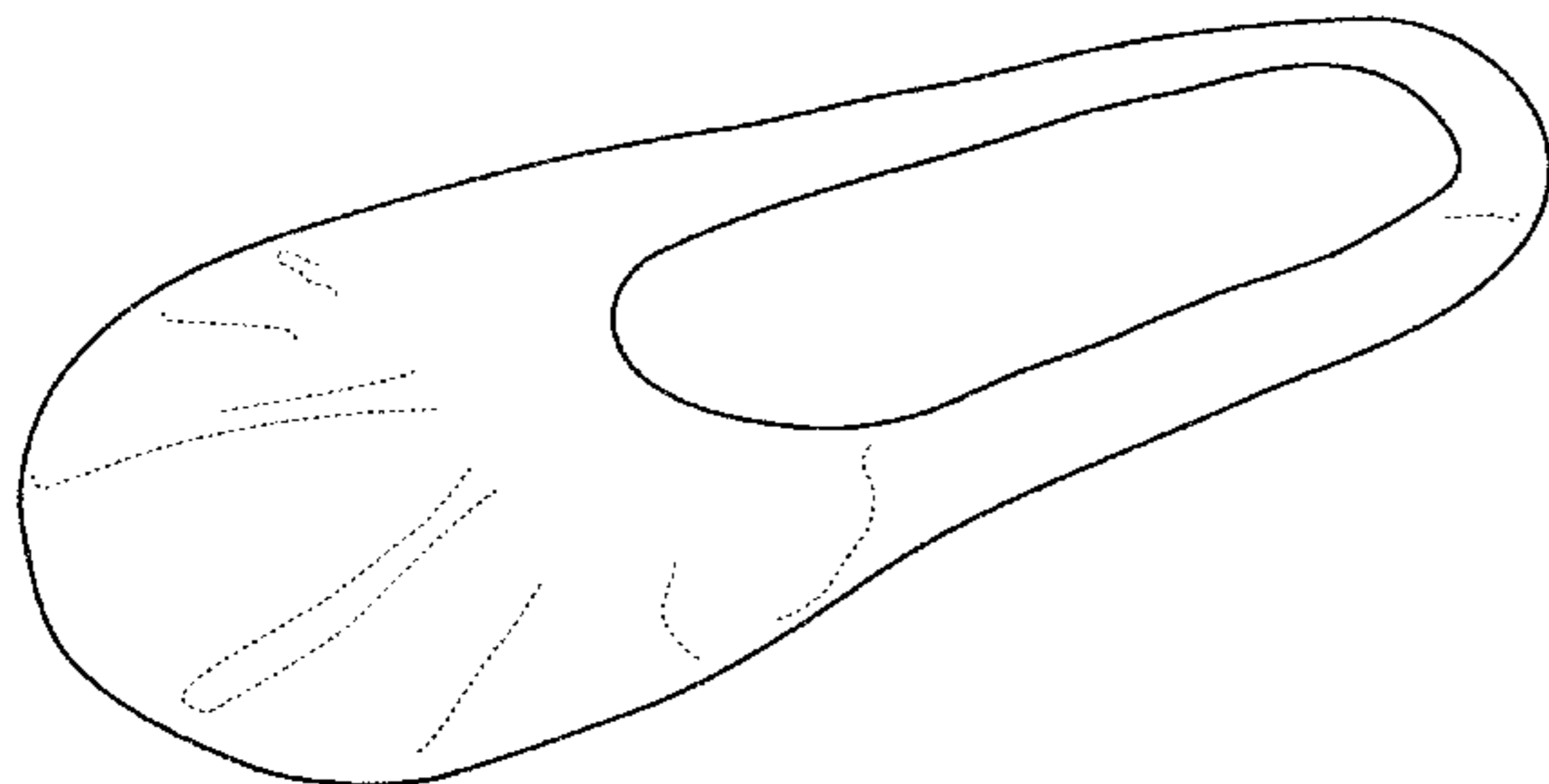


FIG. 20 is a perspective view of the full-dip overshoe shown in FIG. 17.

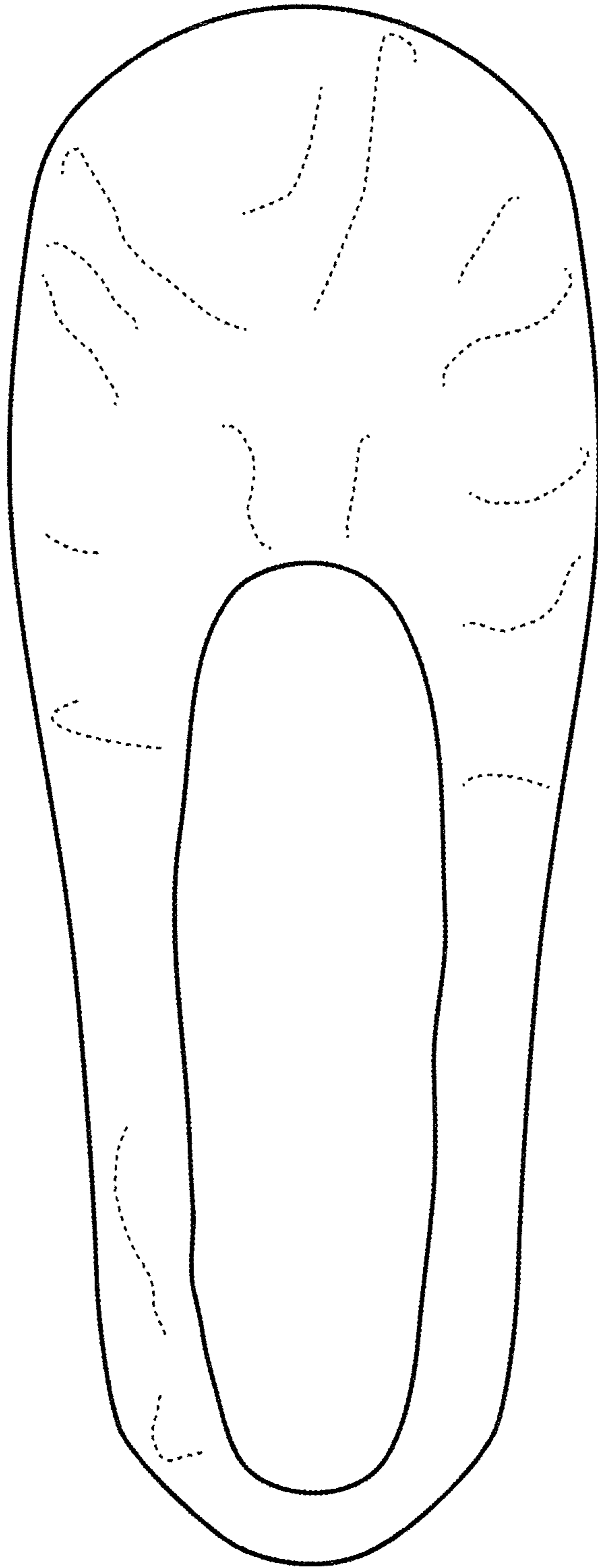

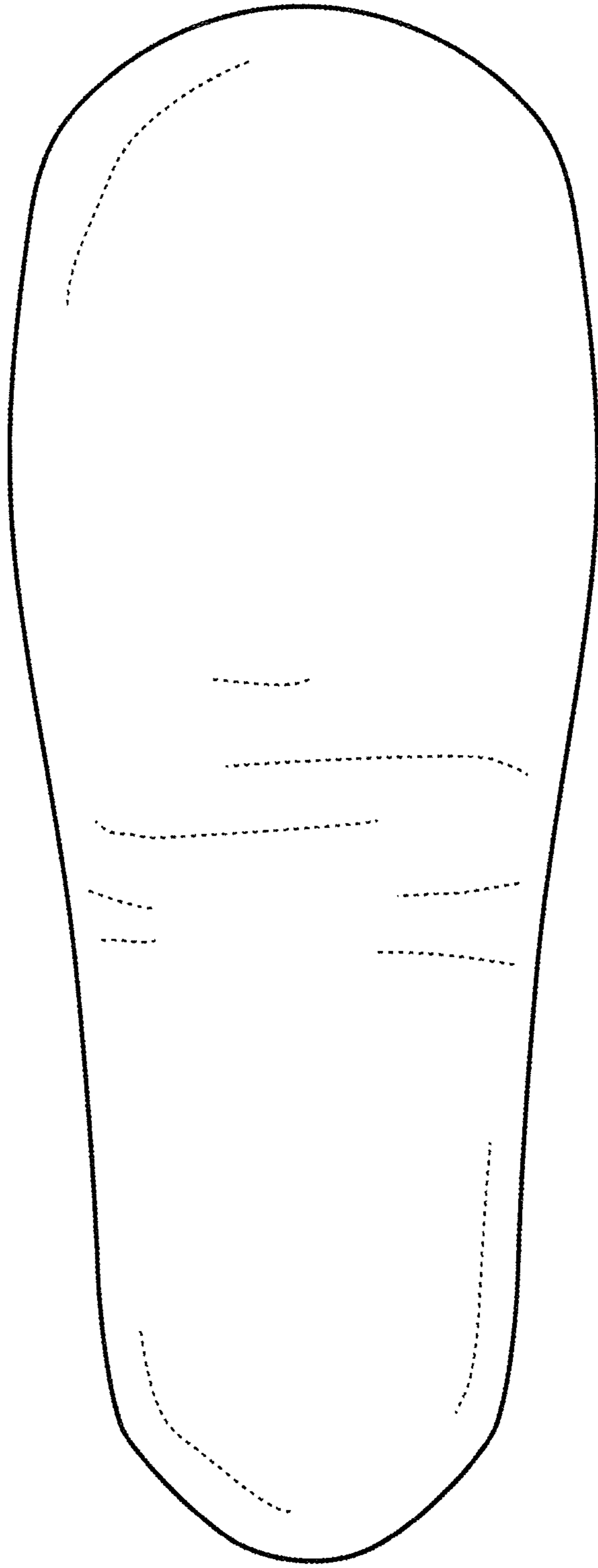

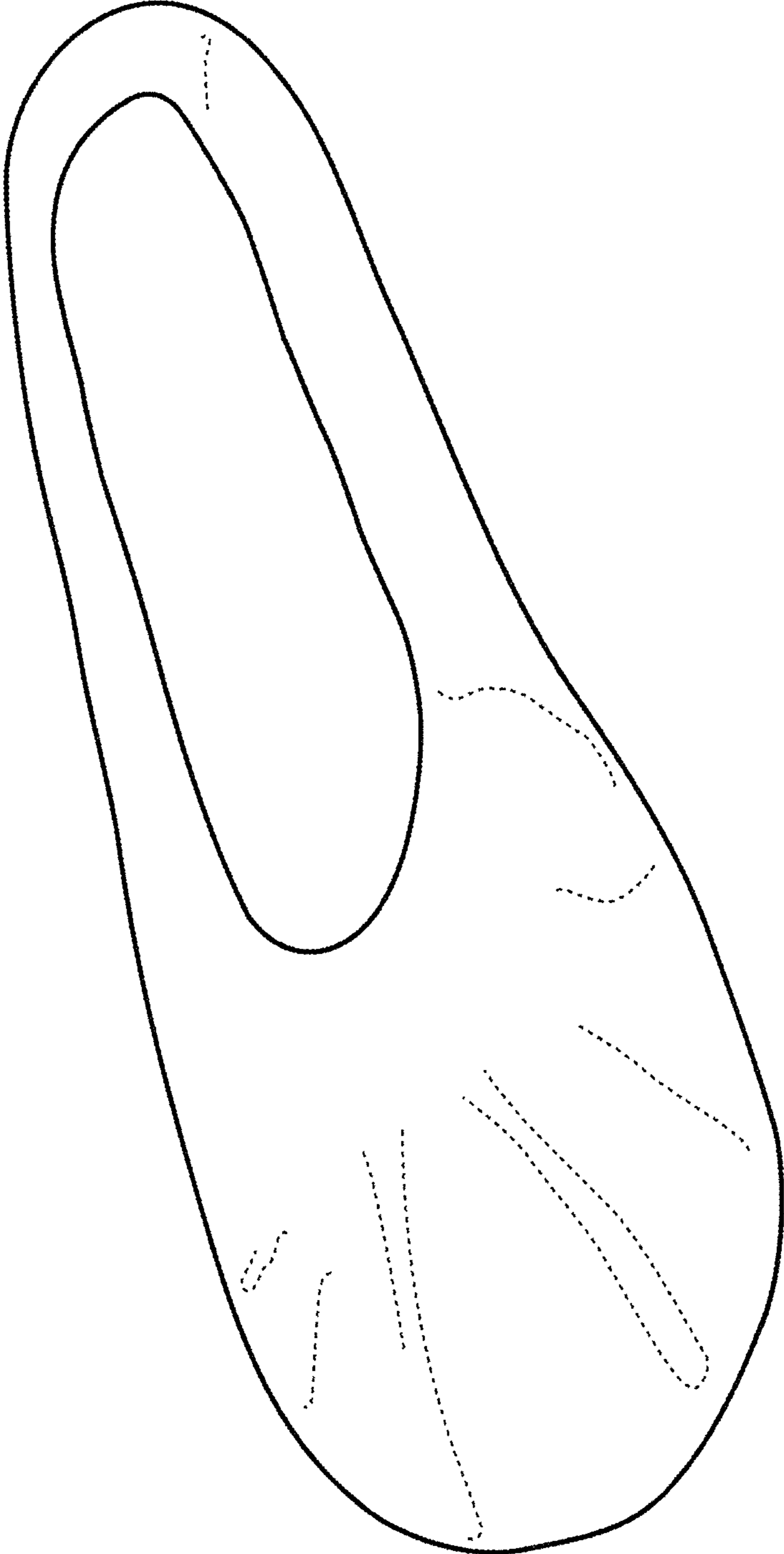

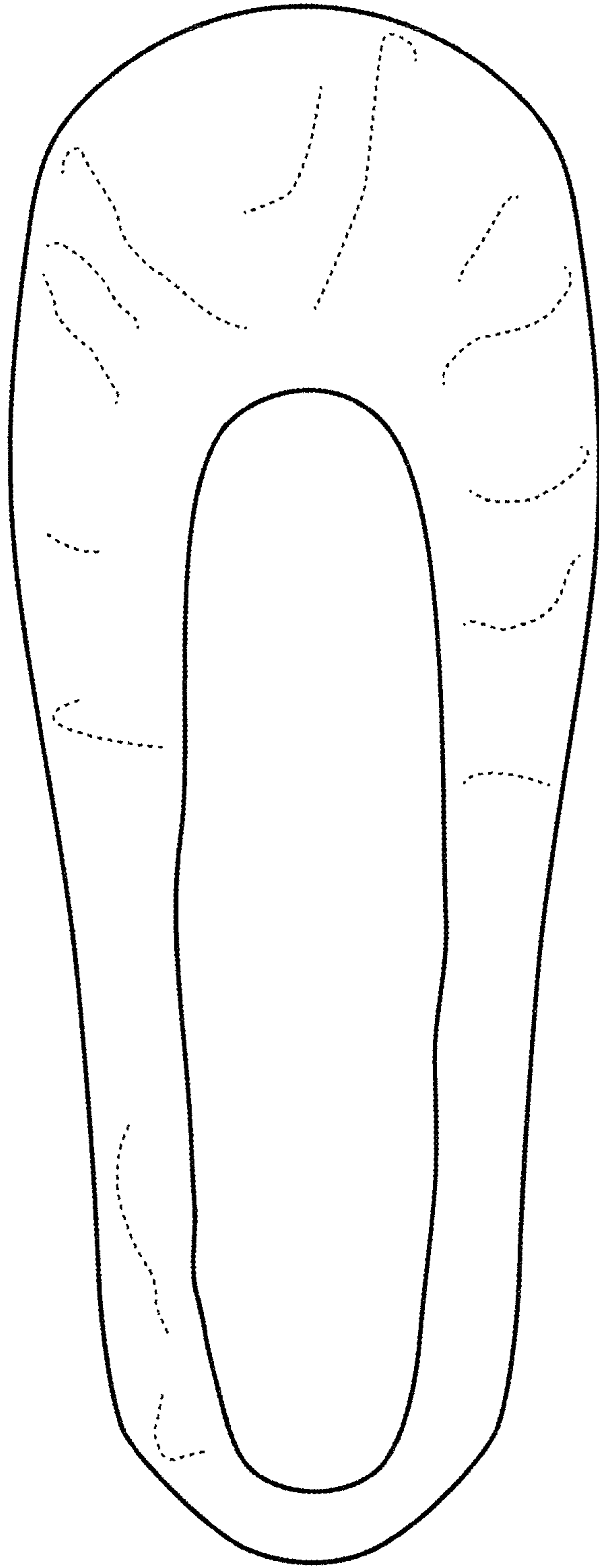

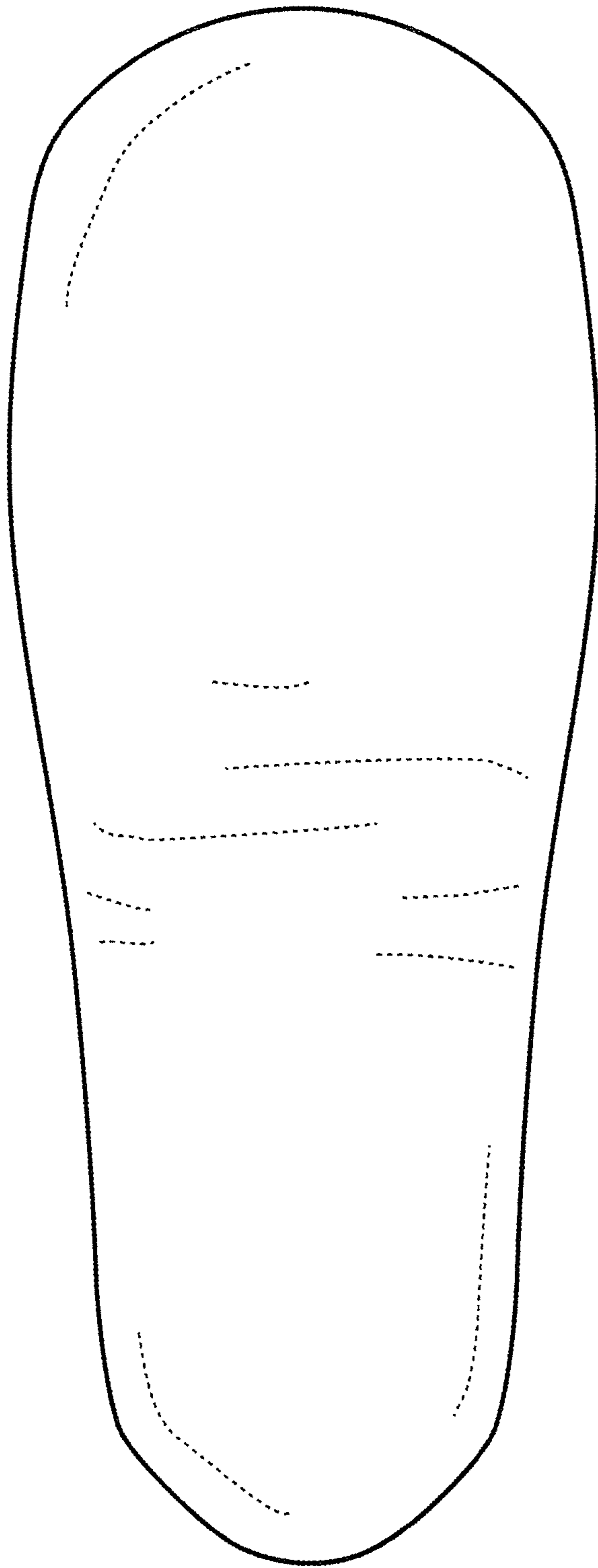

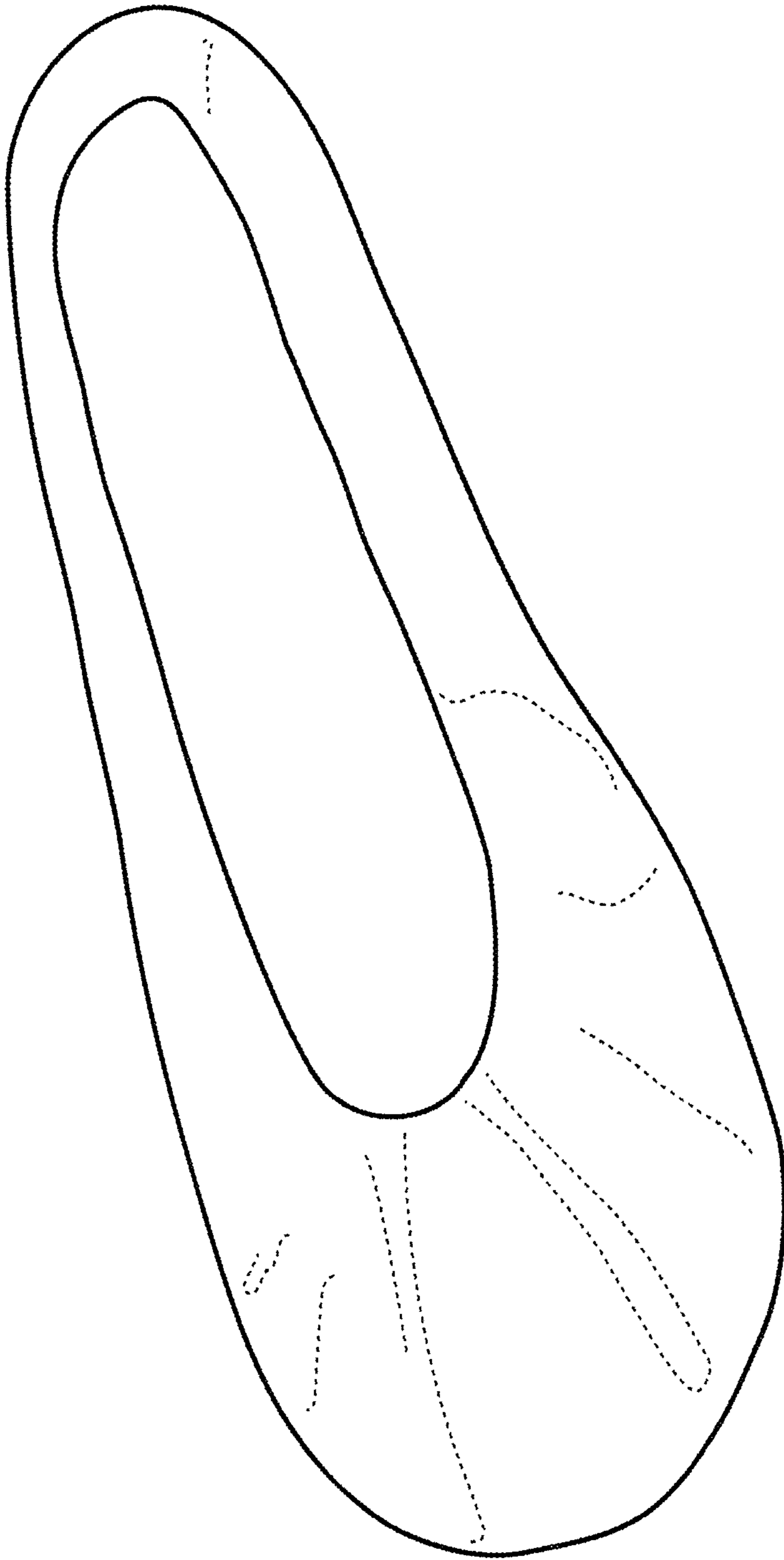

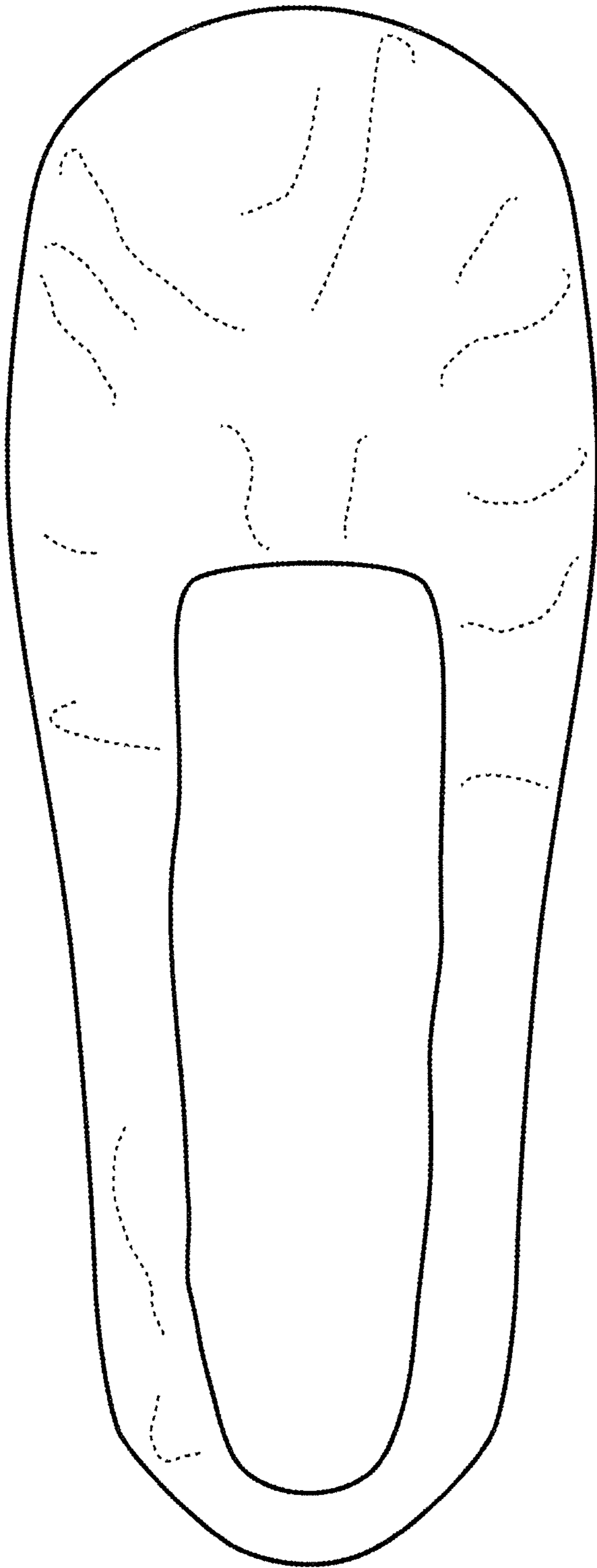

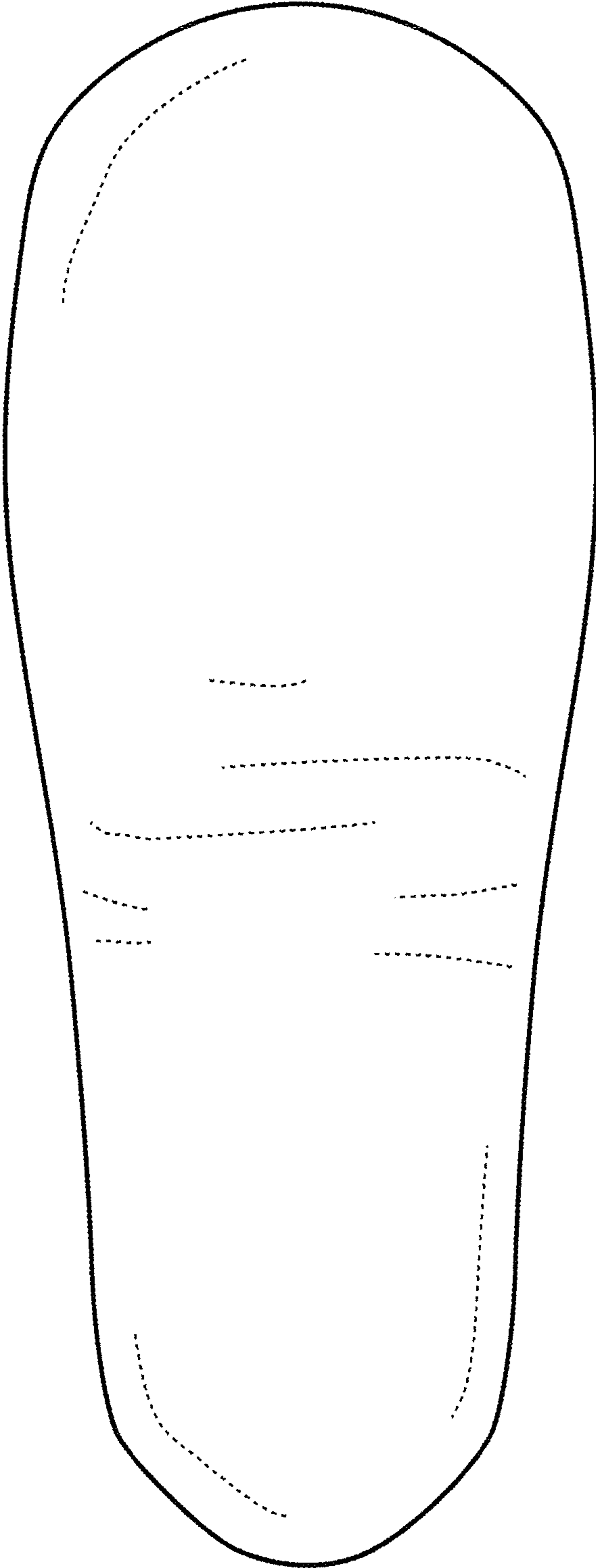

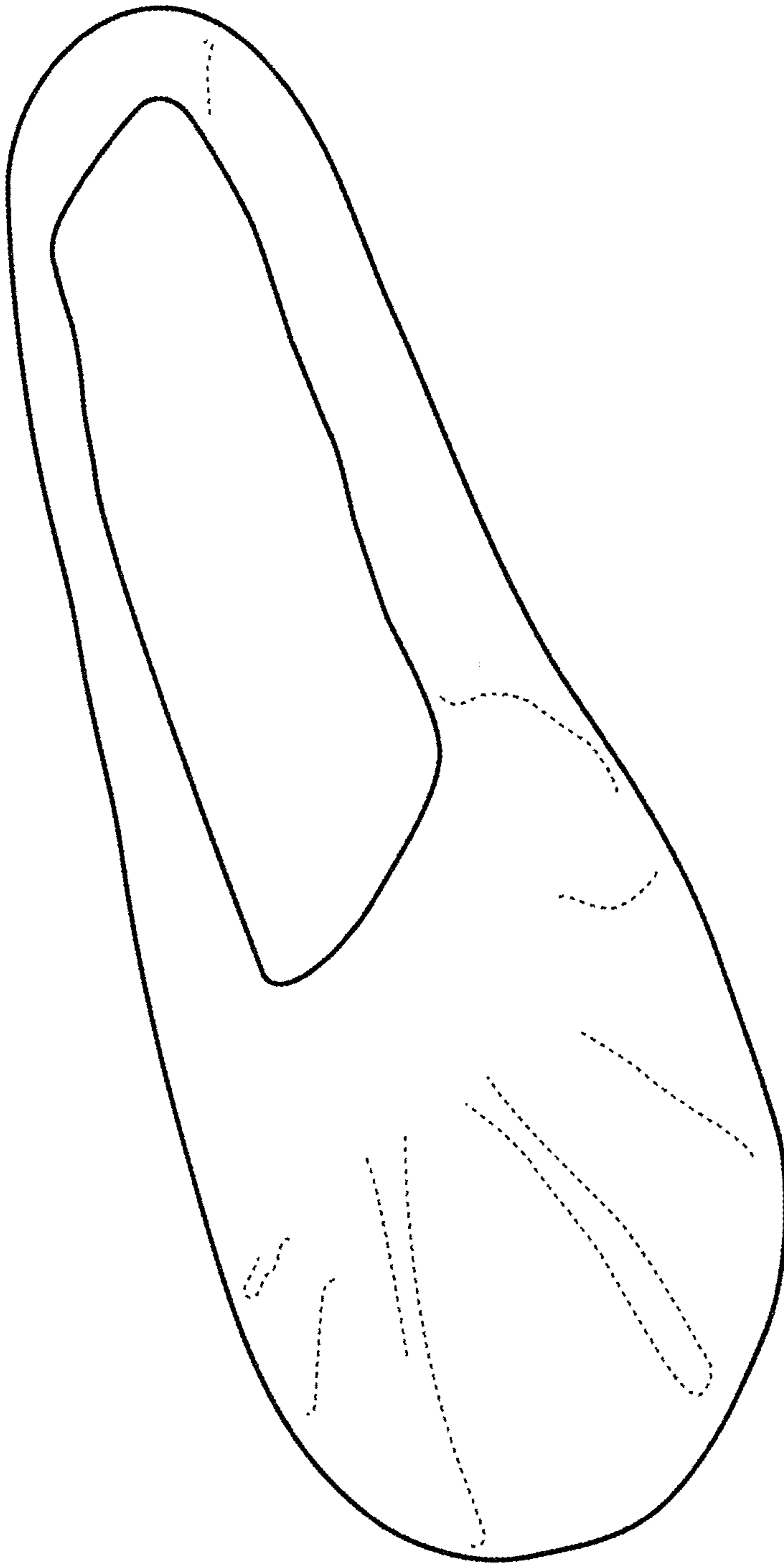

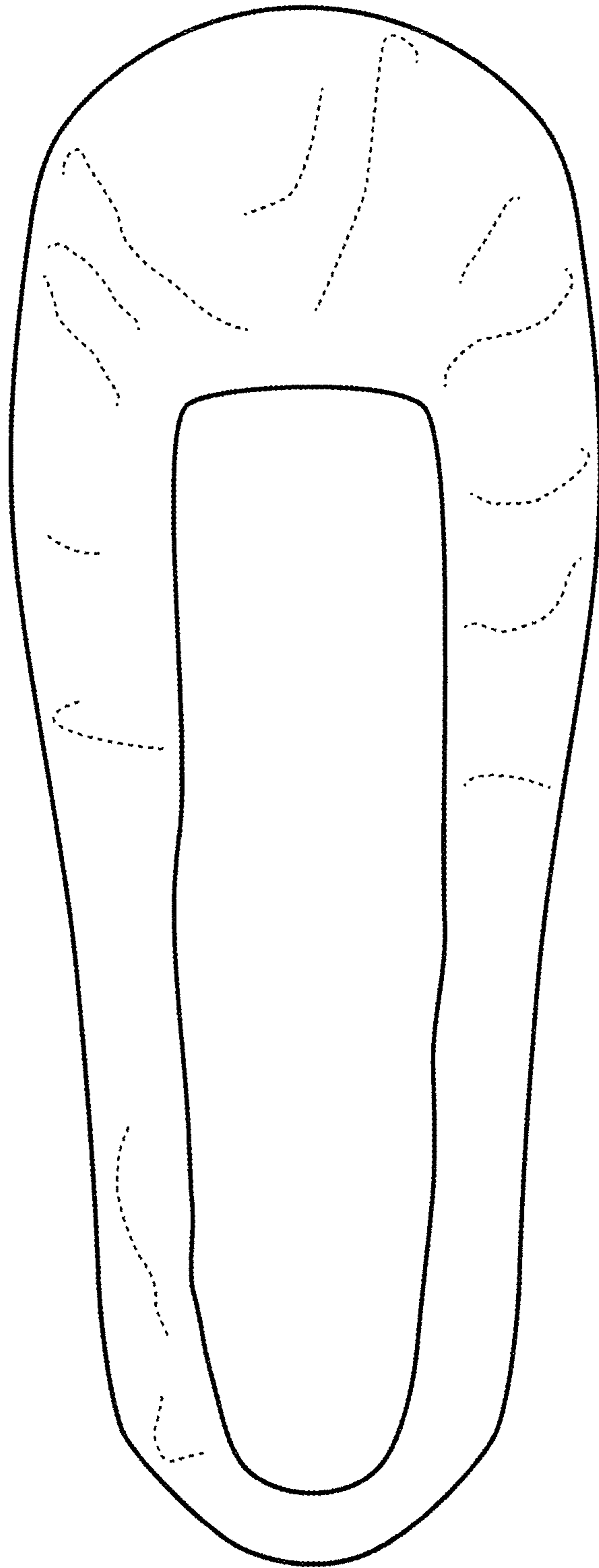

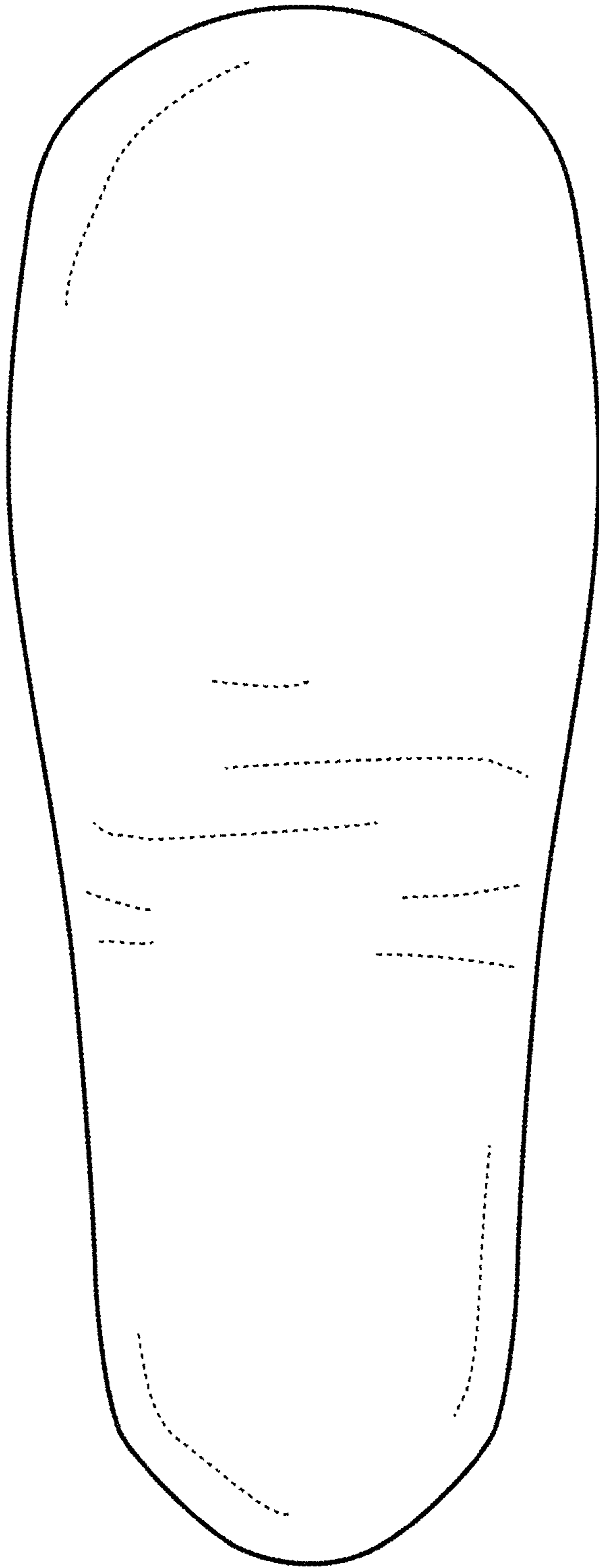

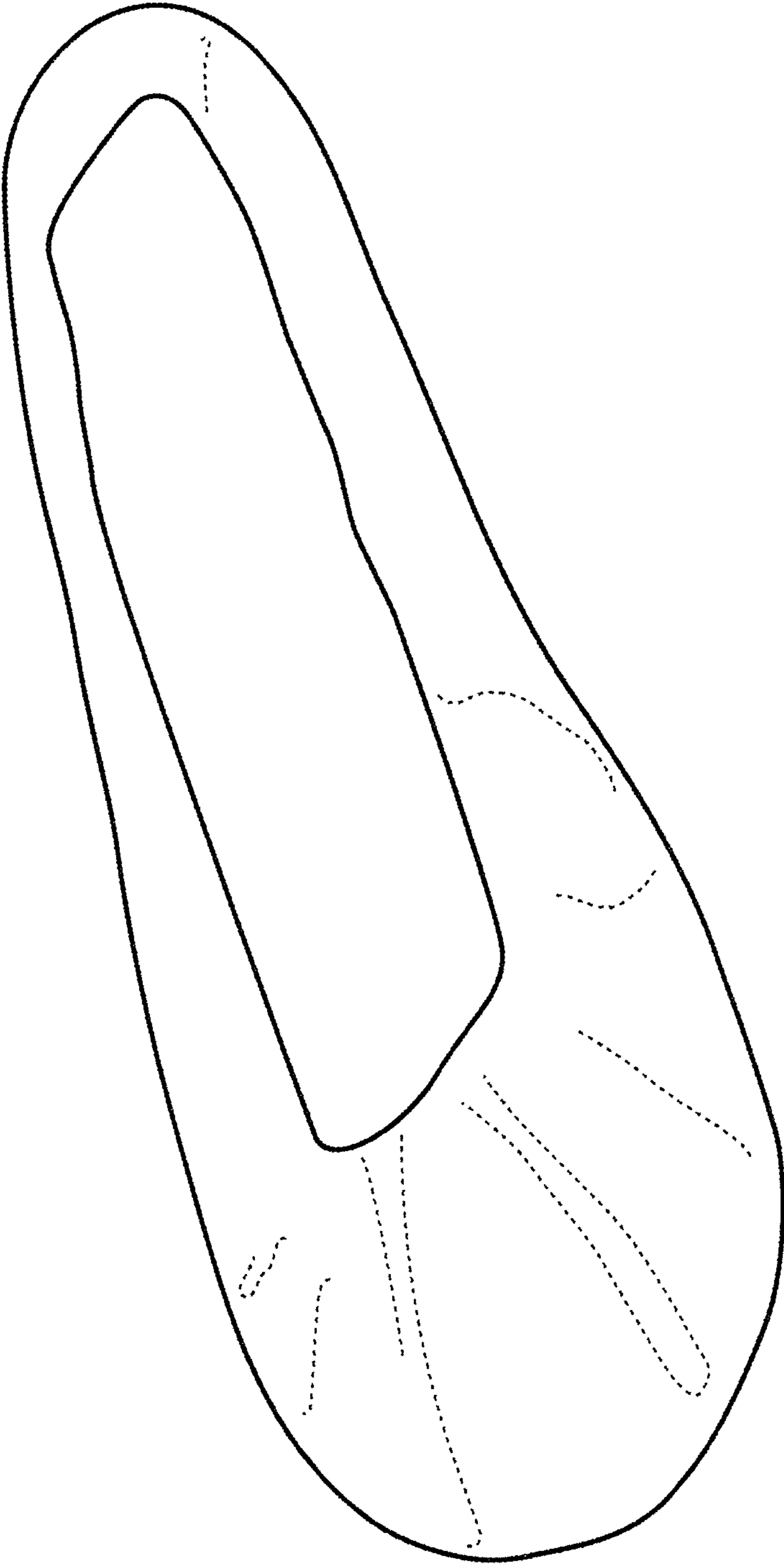

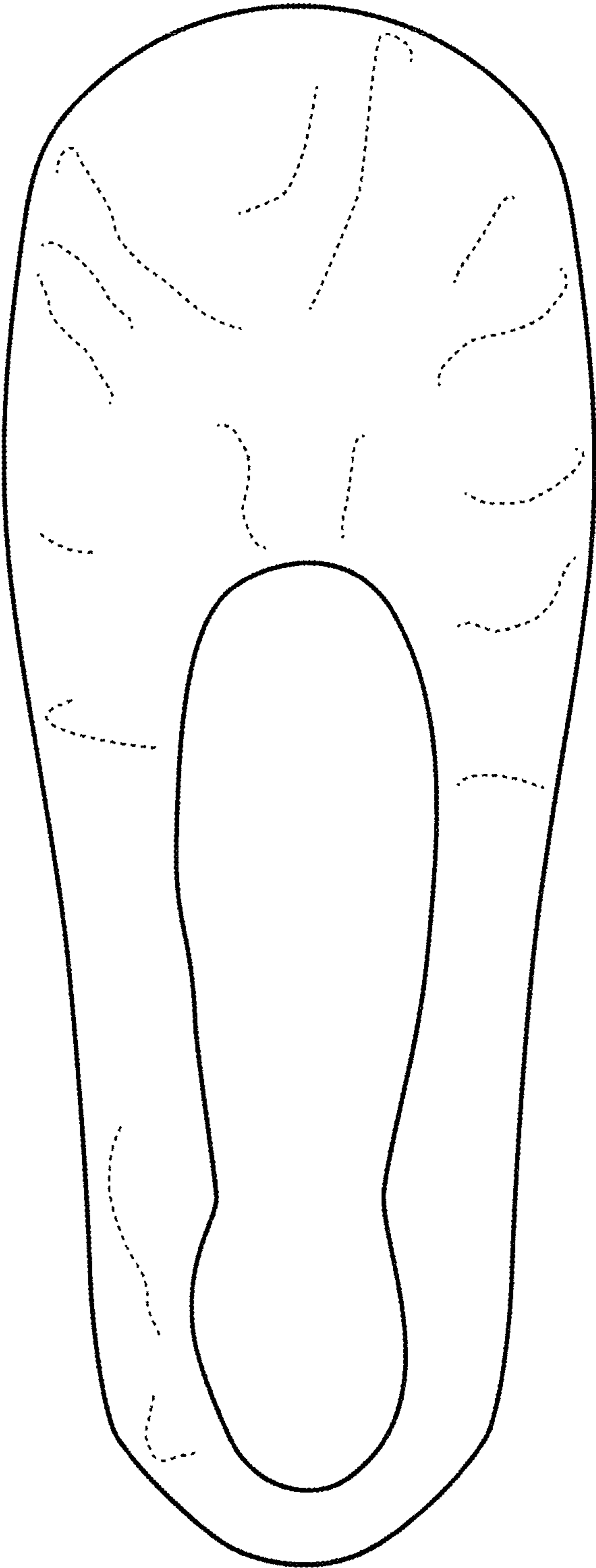

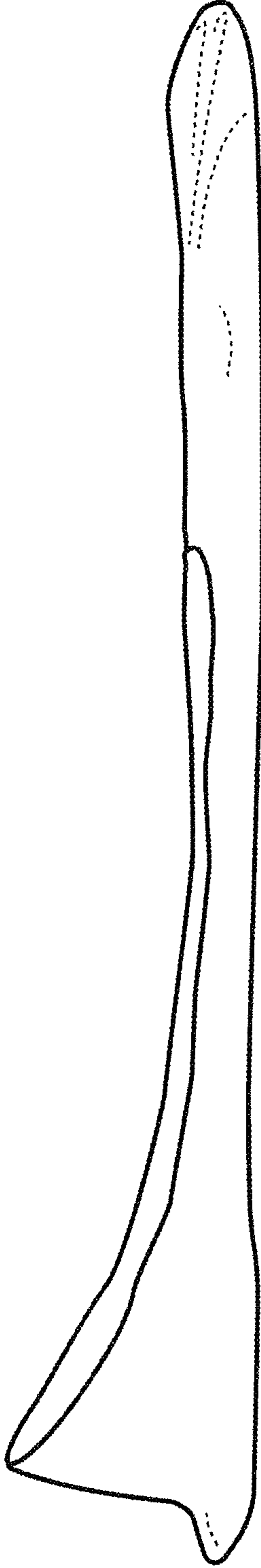

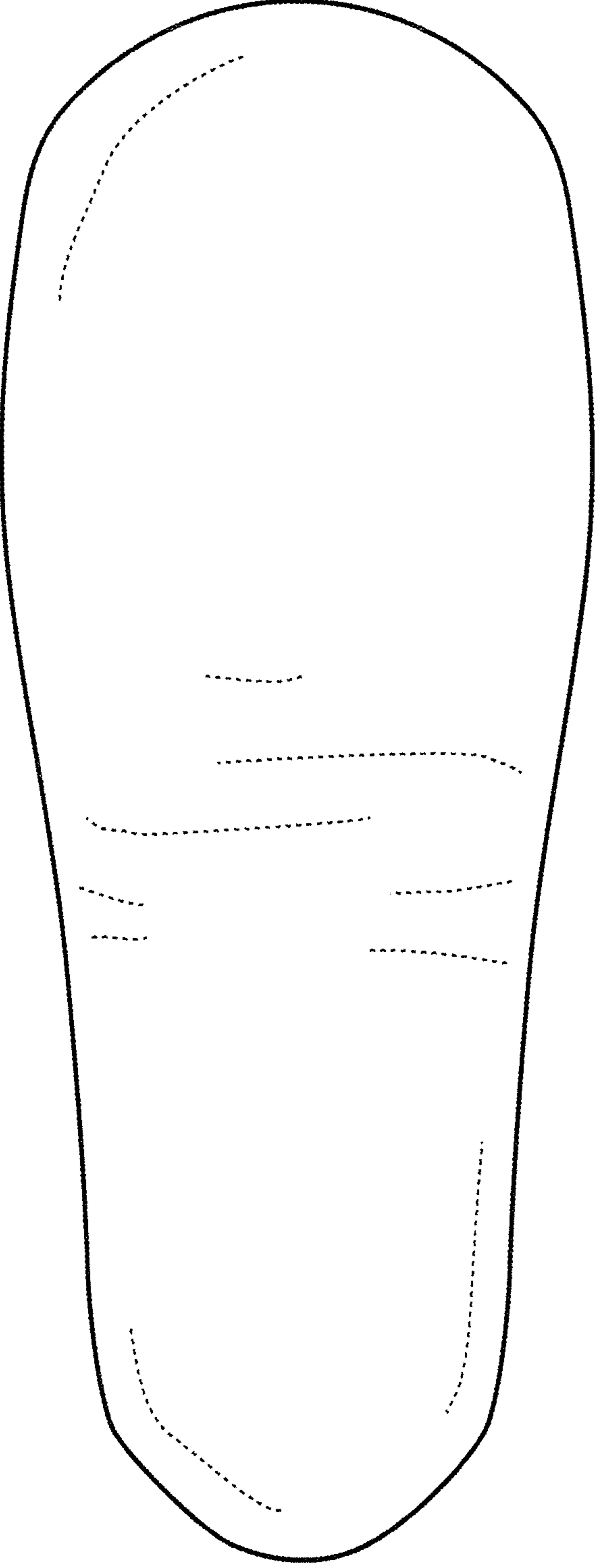

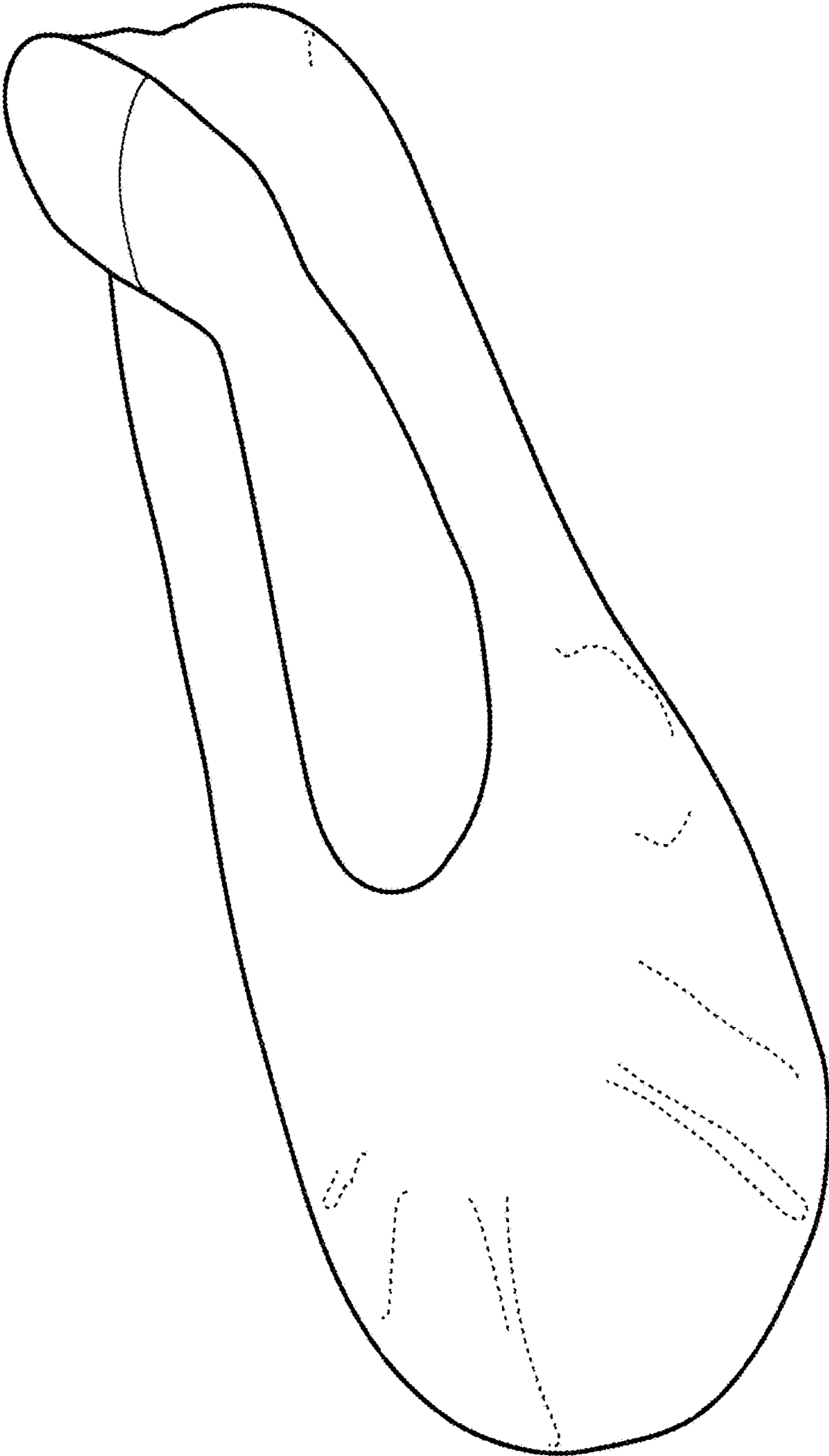

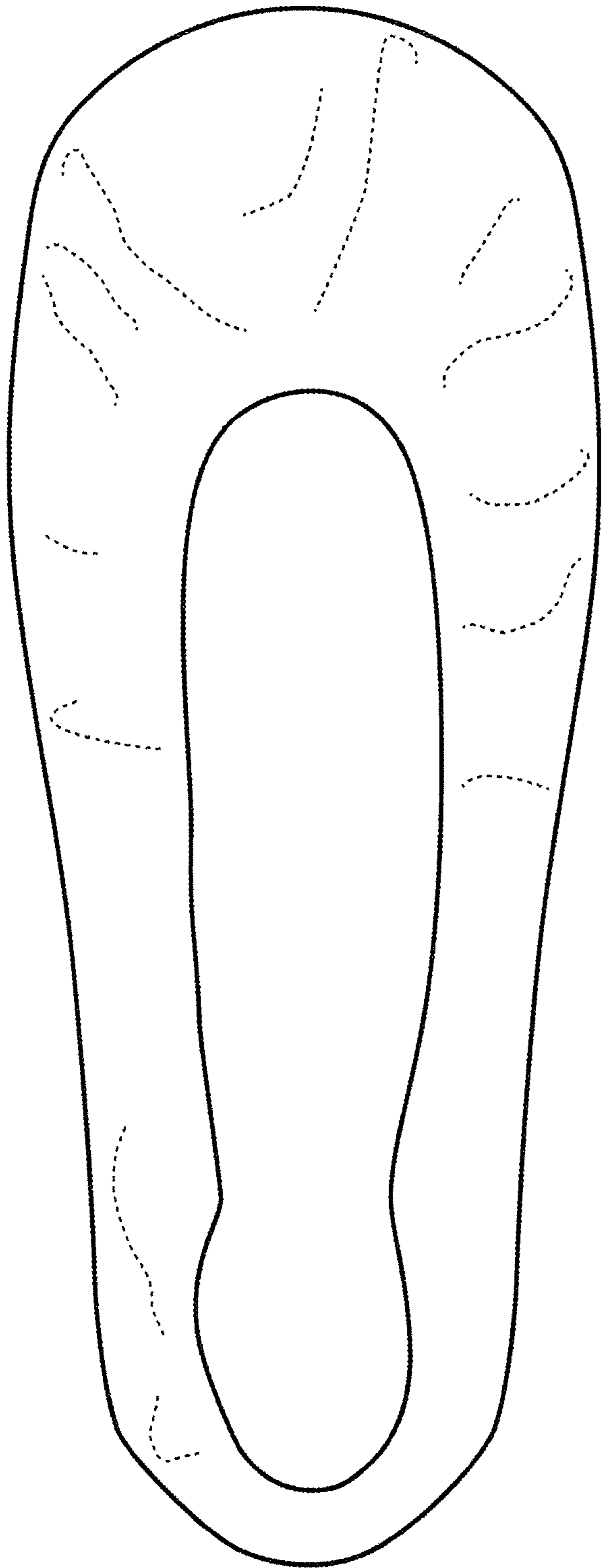

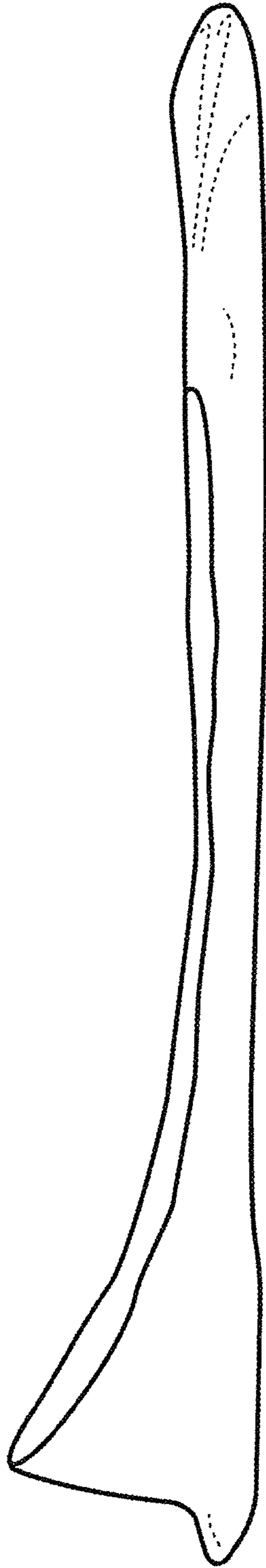

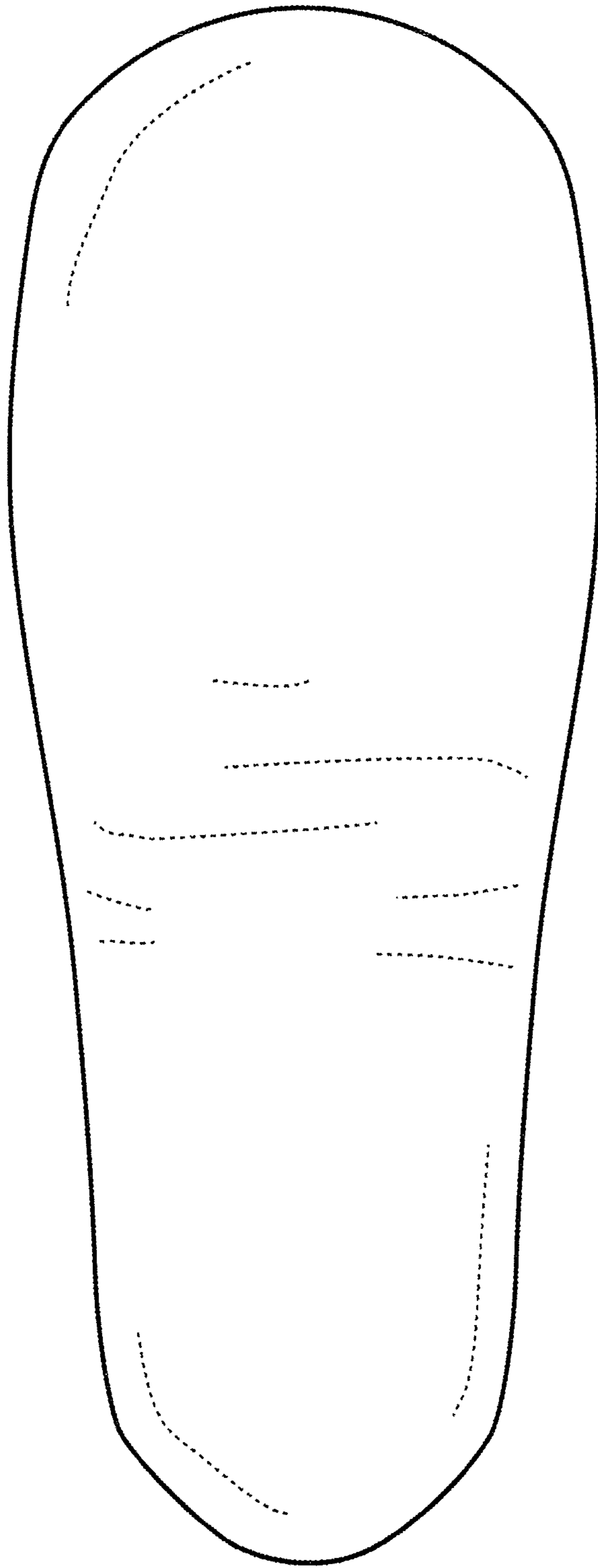

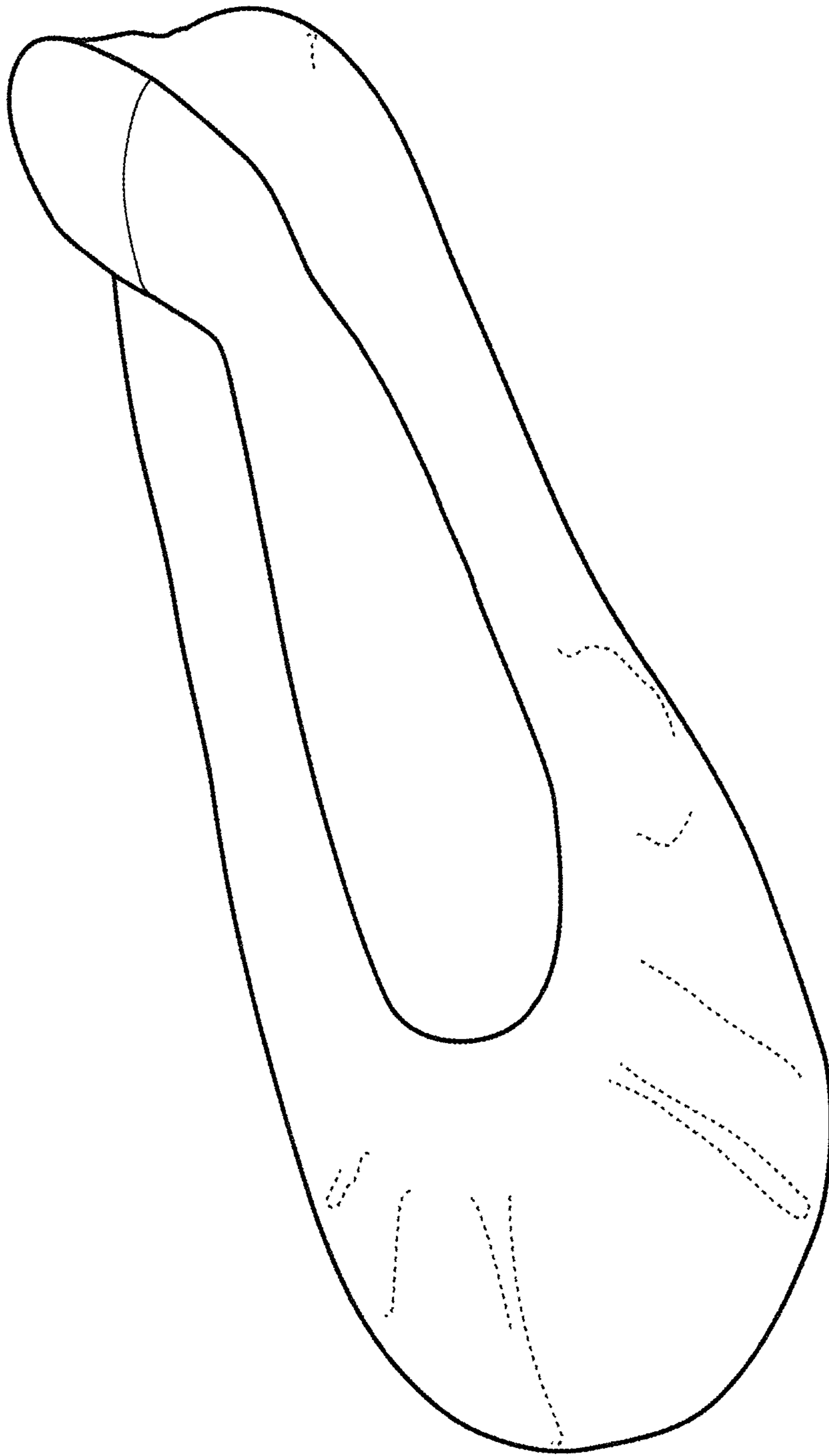

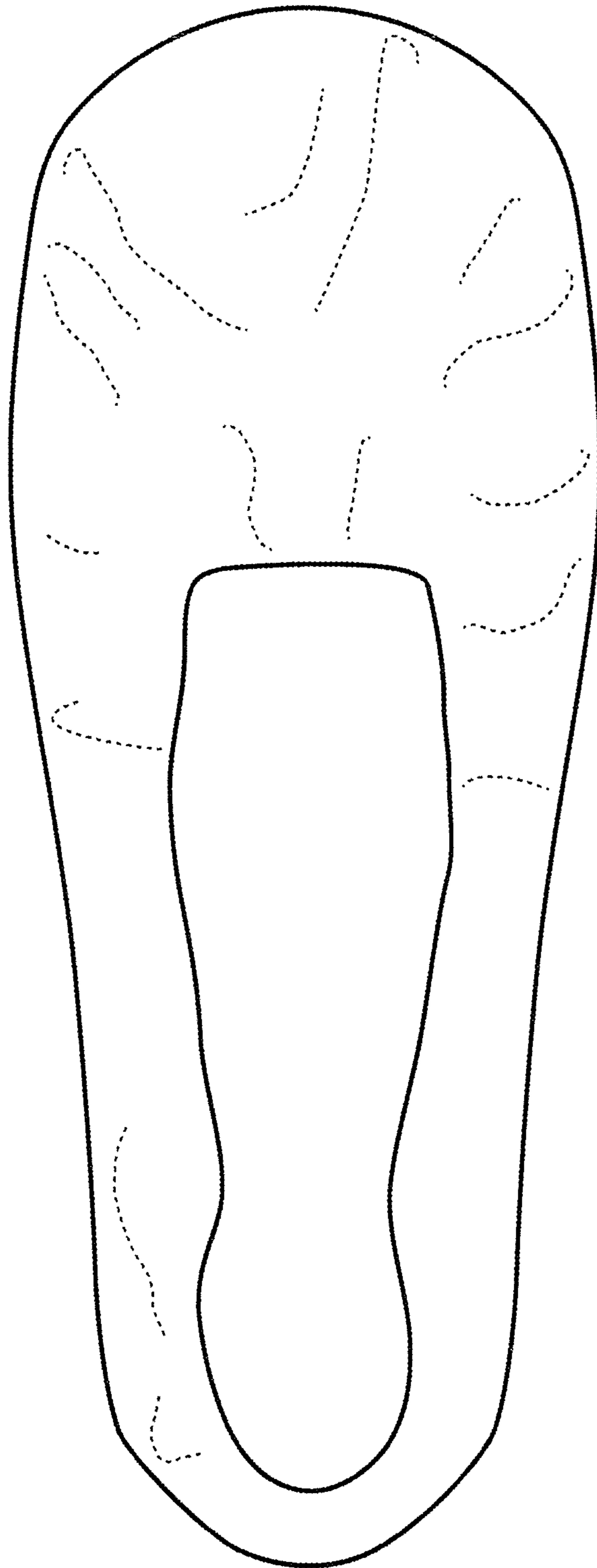

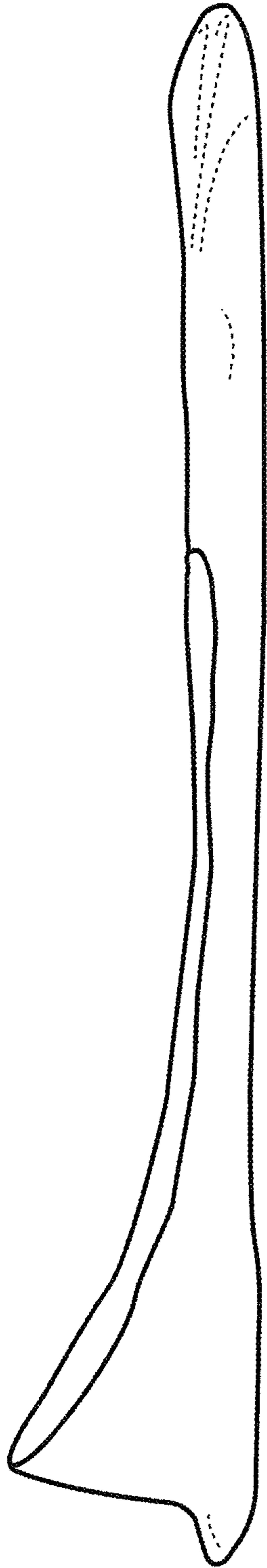

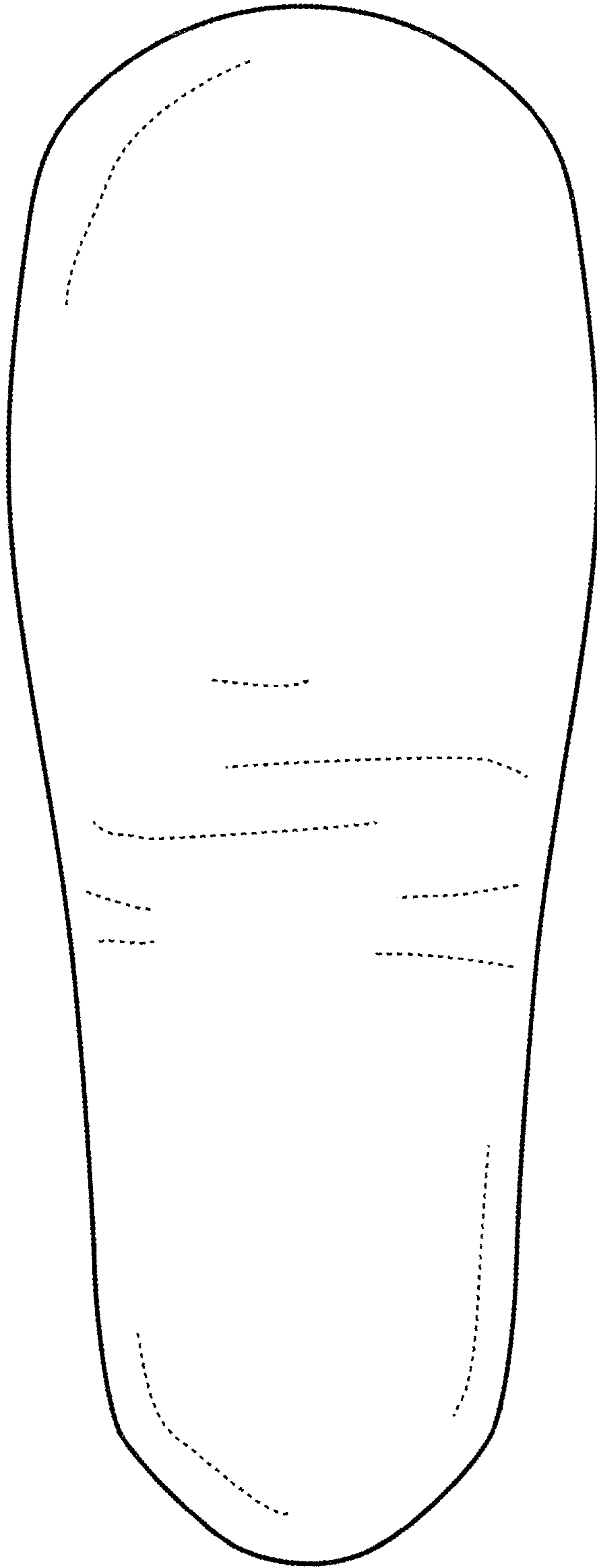

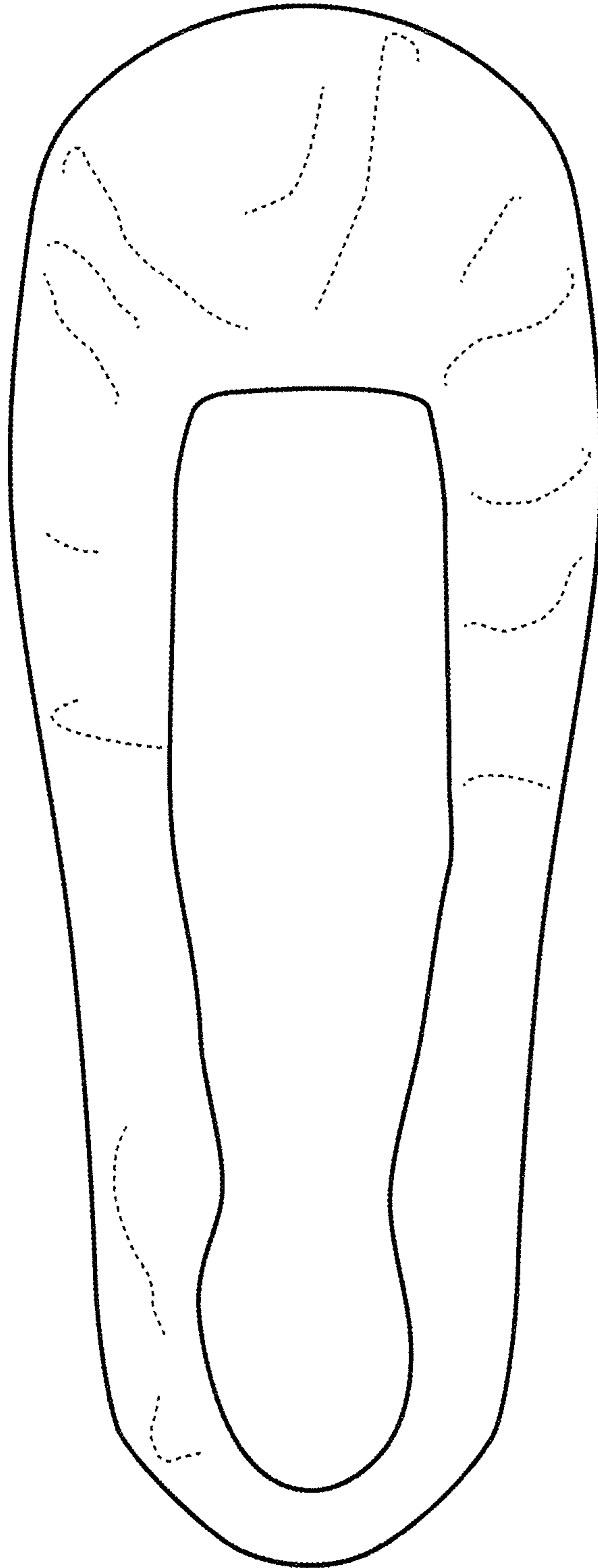

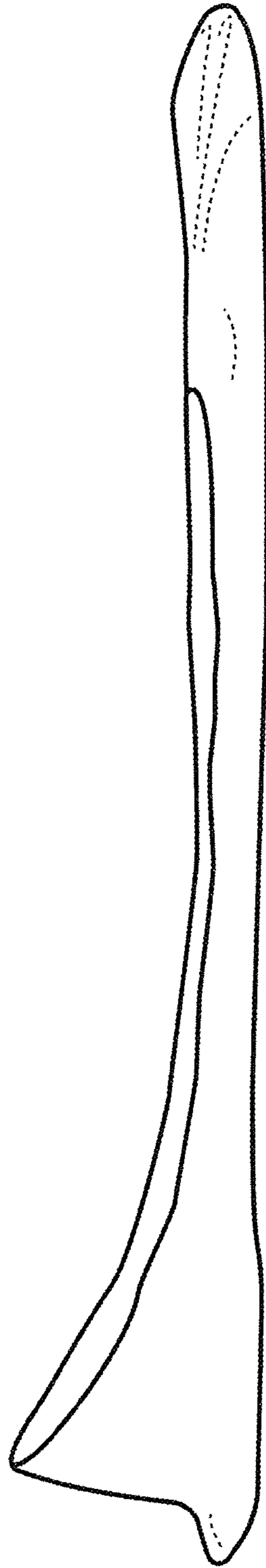

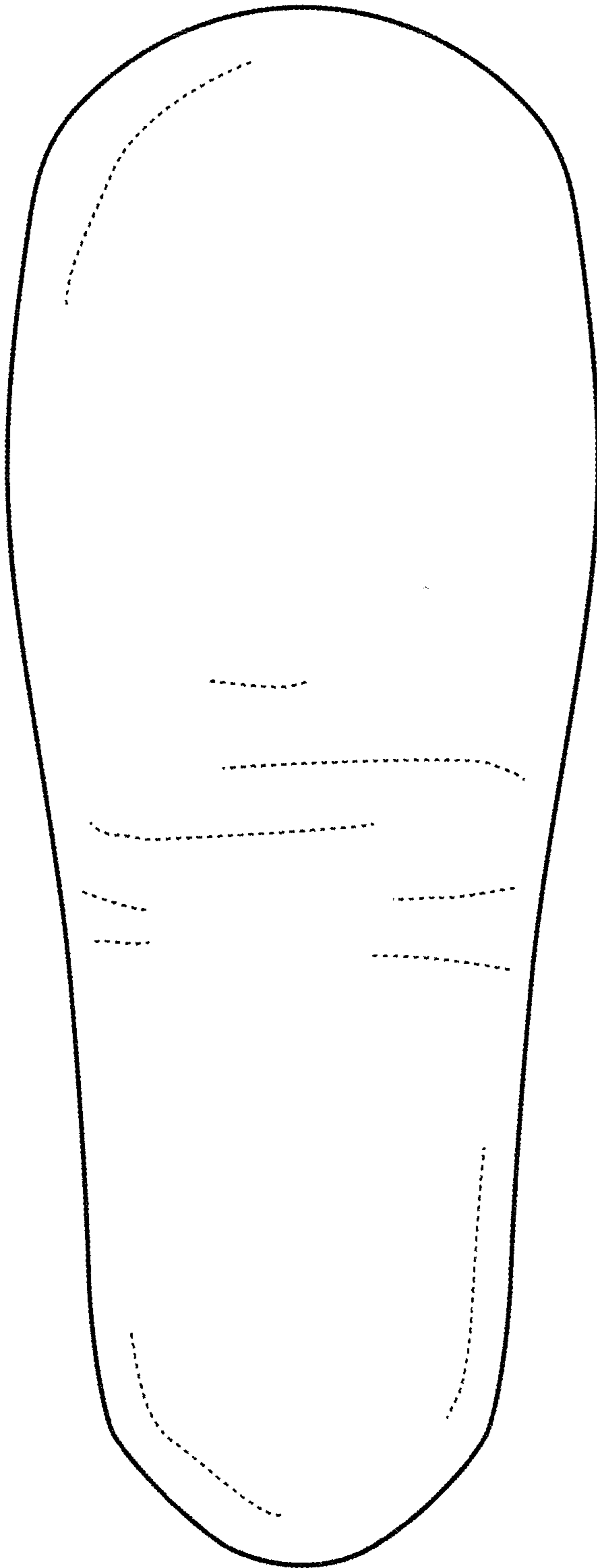

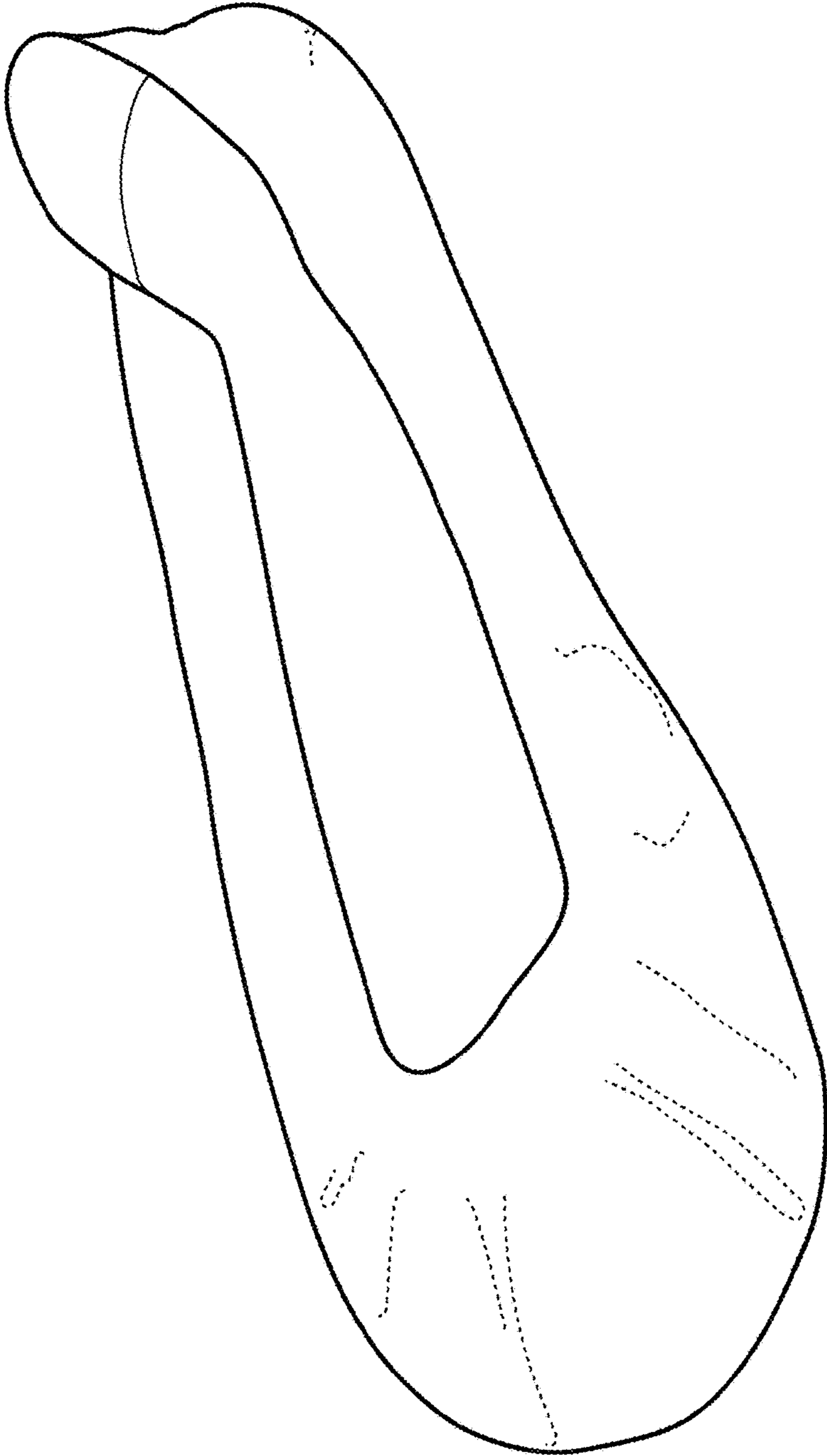
