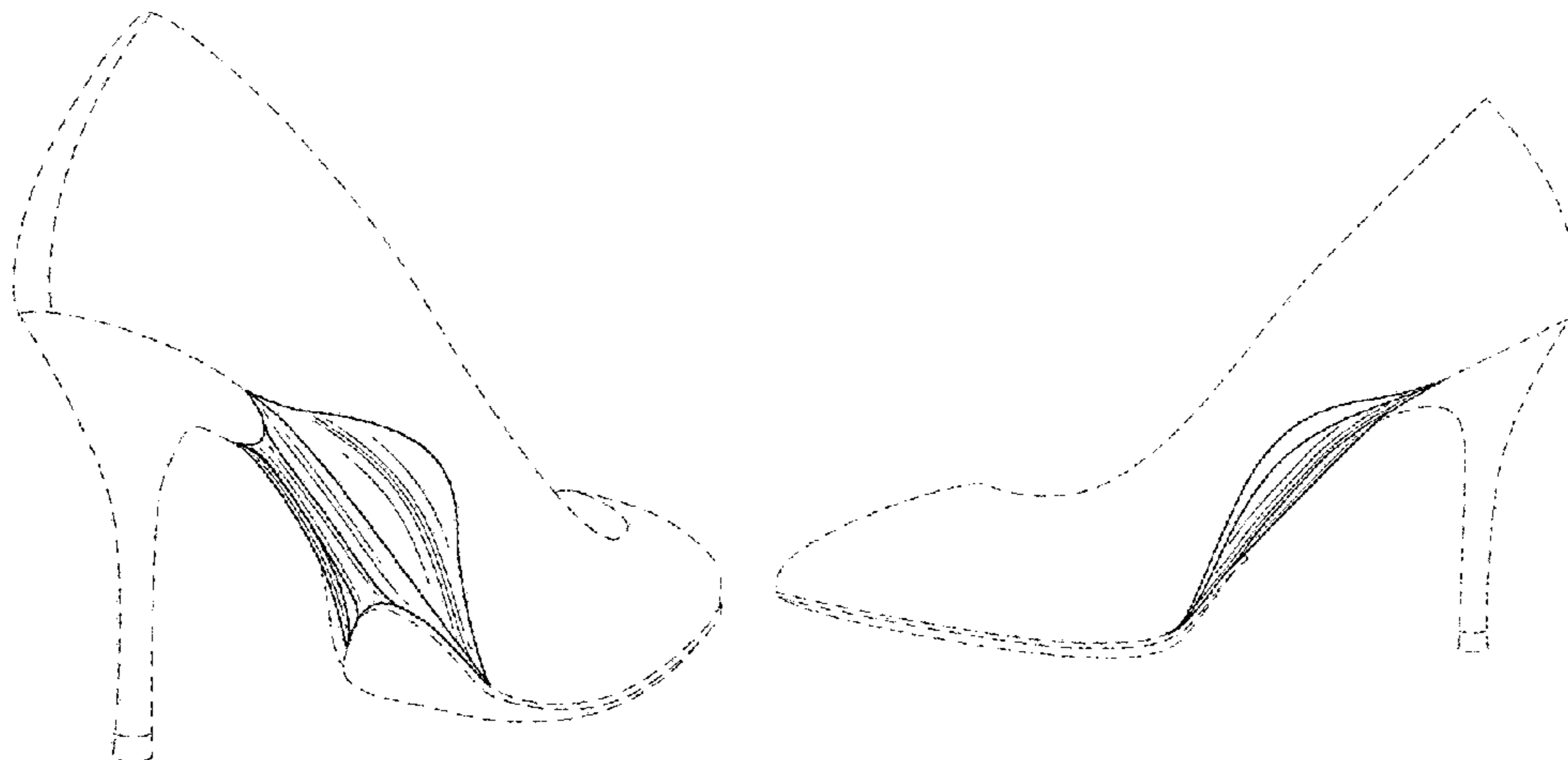
The ornamental design for shoe exterior, as shown and described.

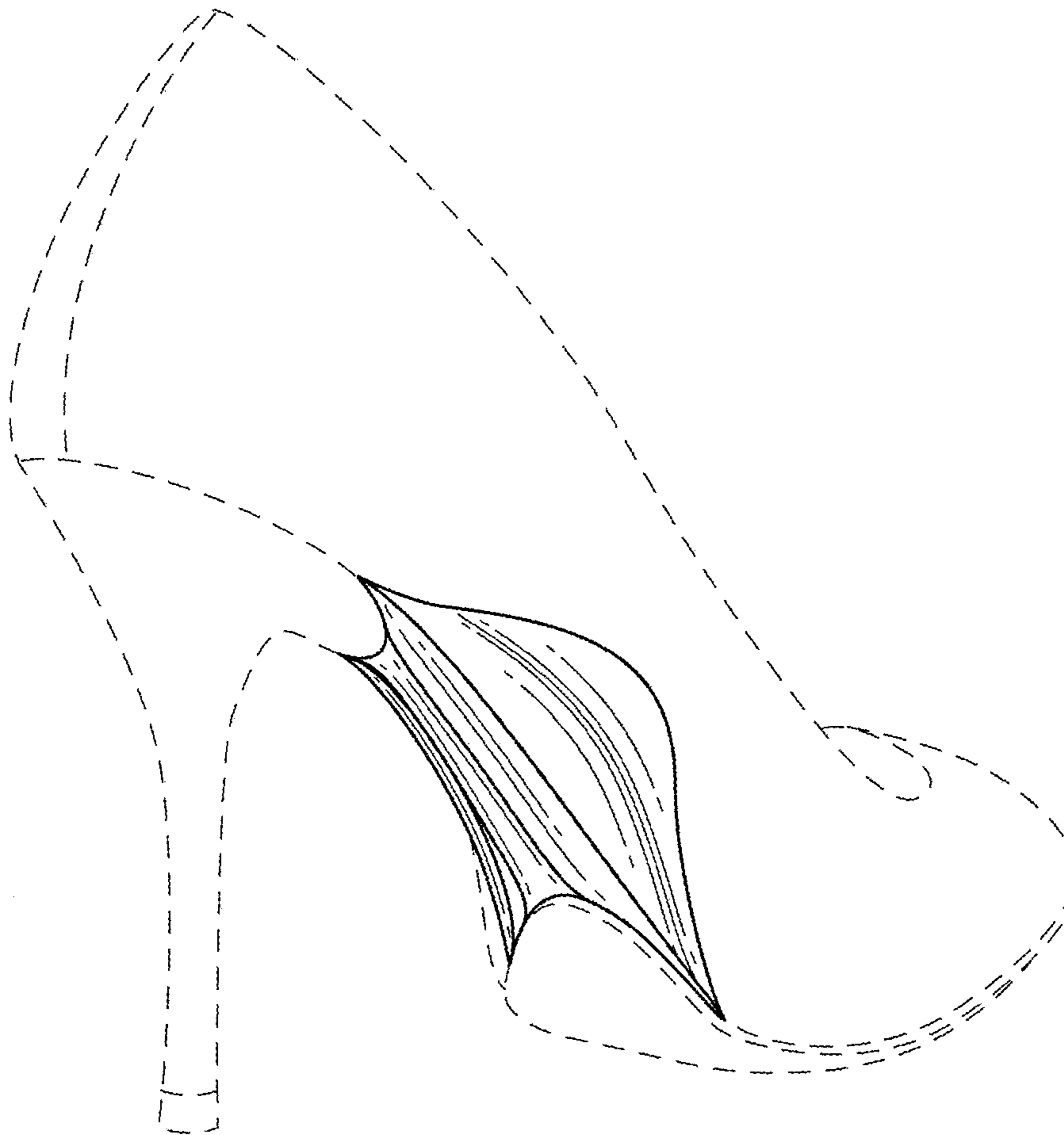

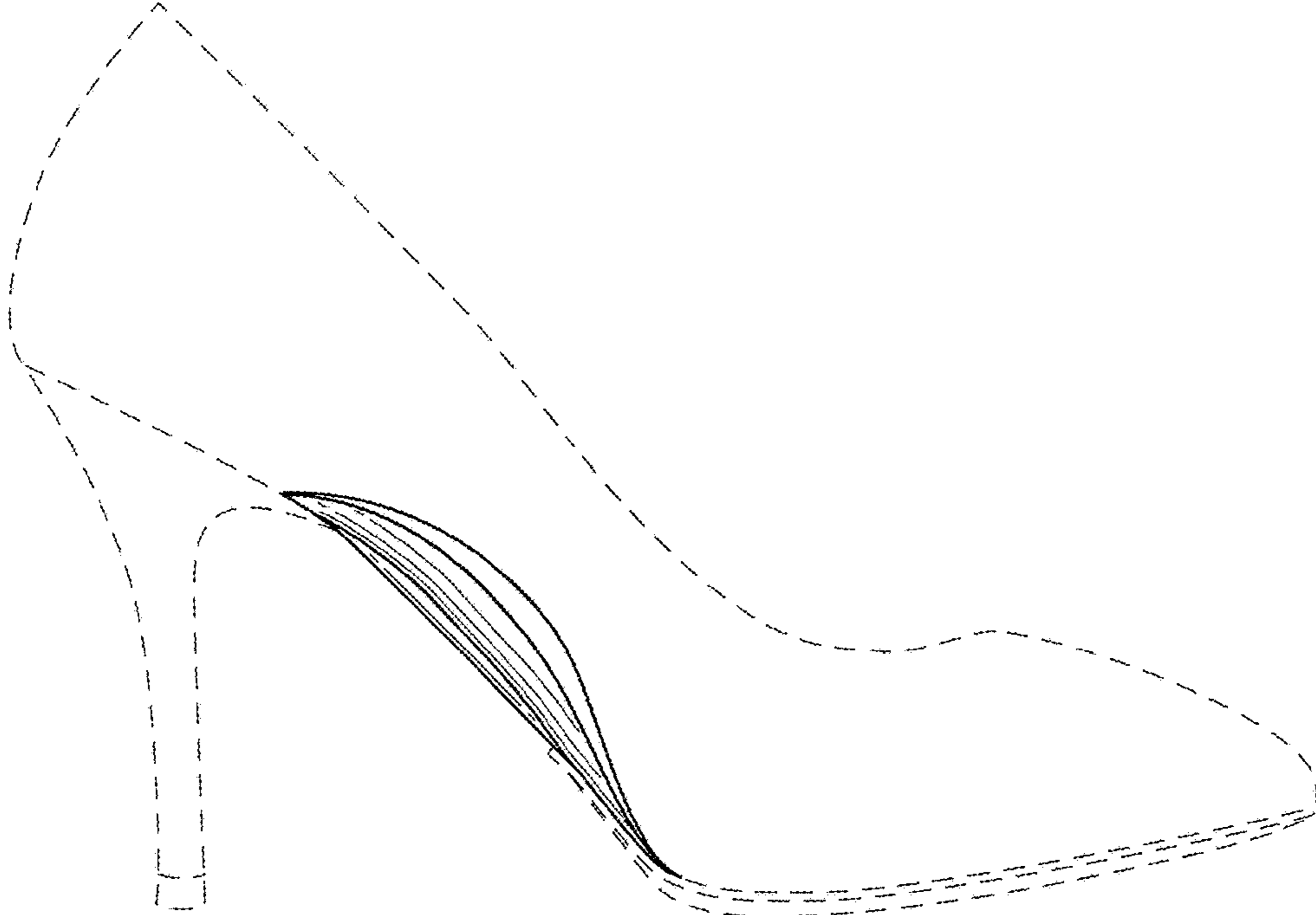

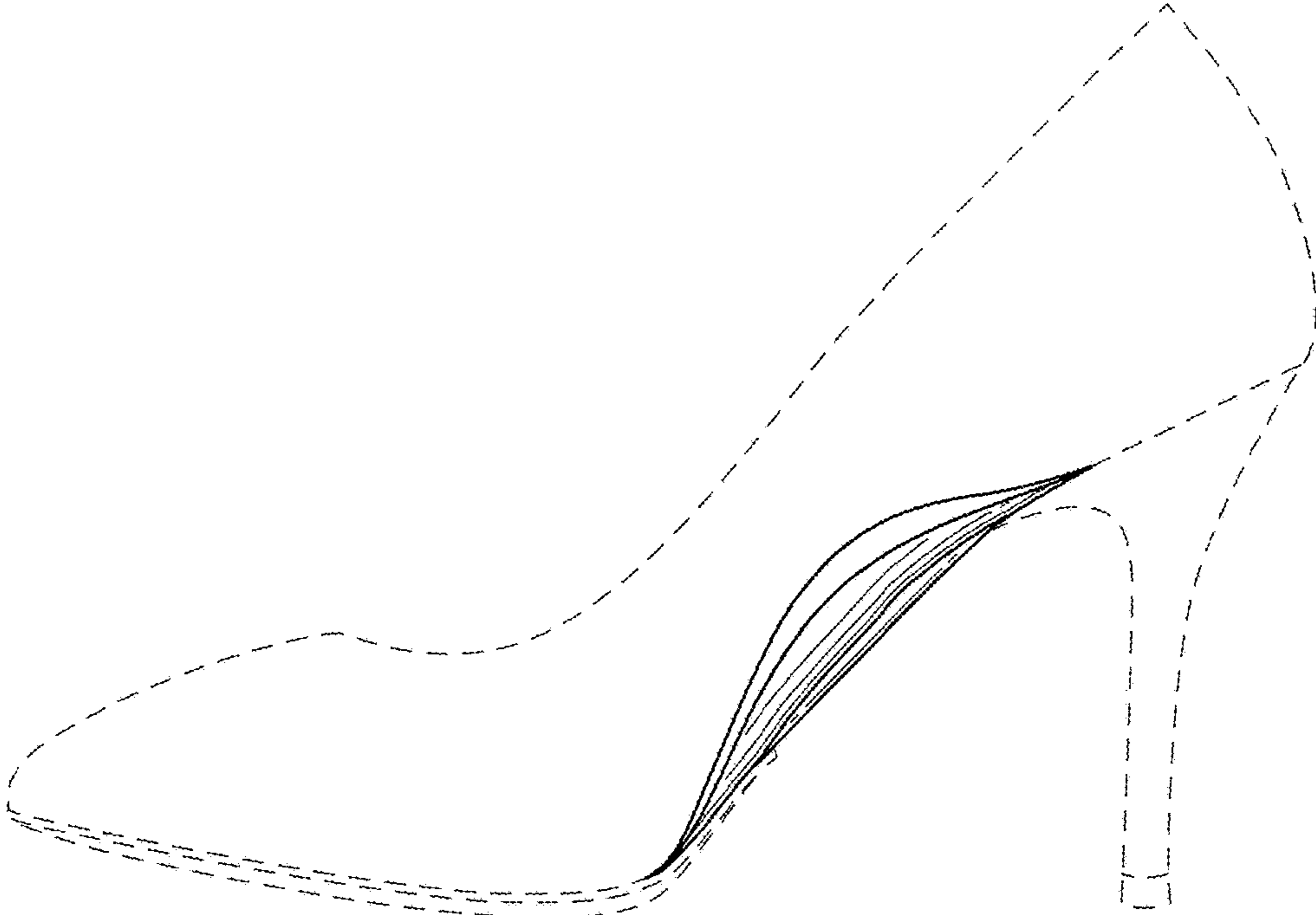

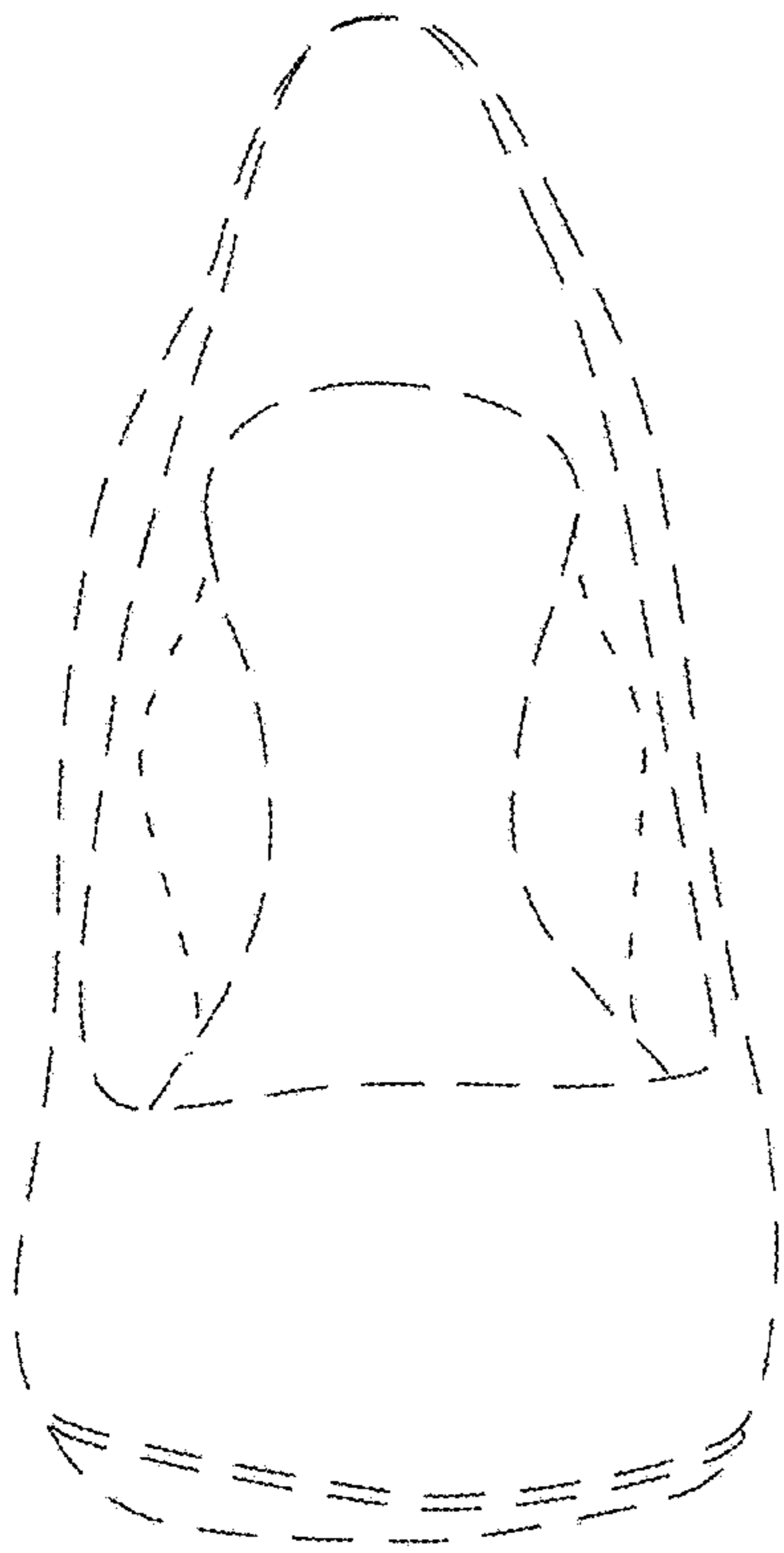

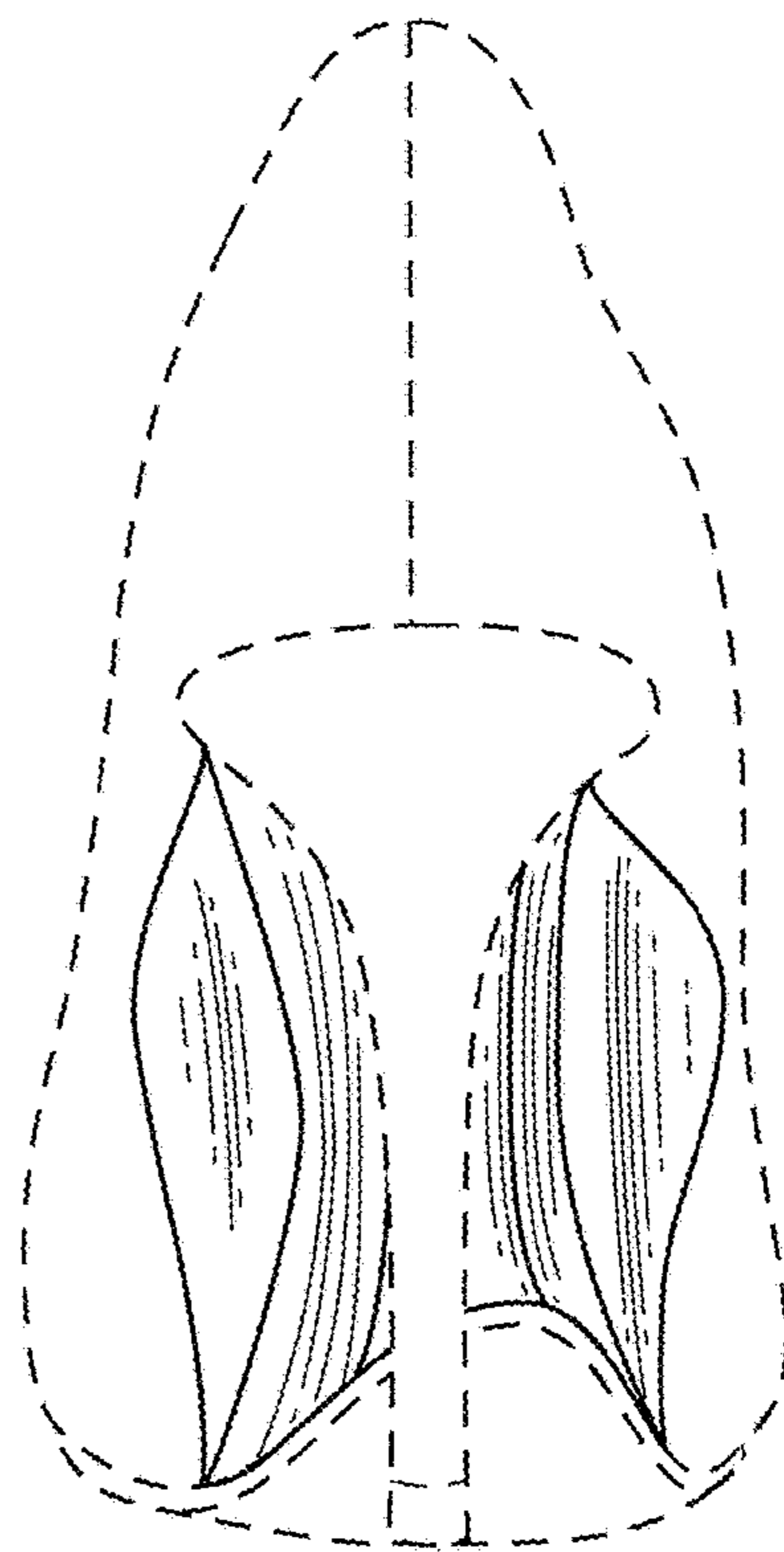

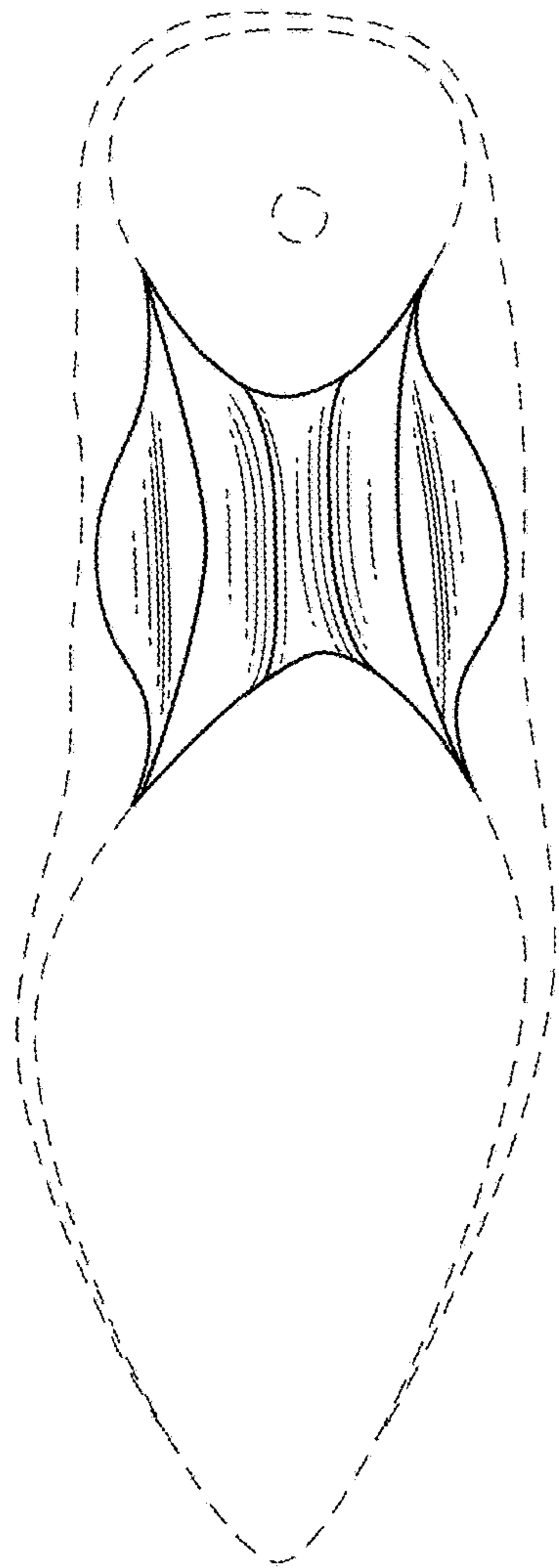

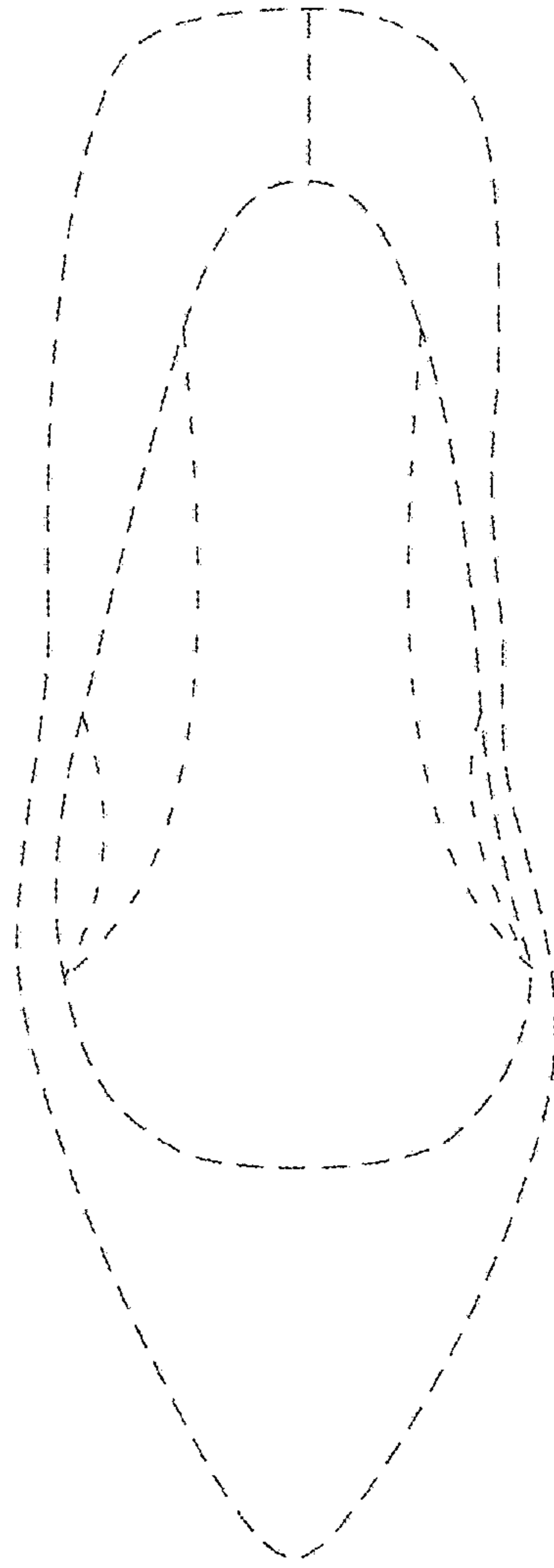
