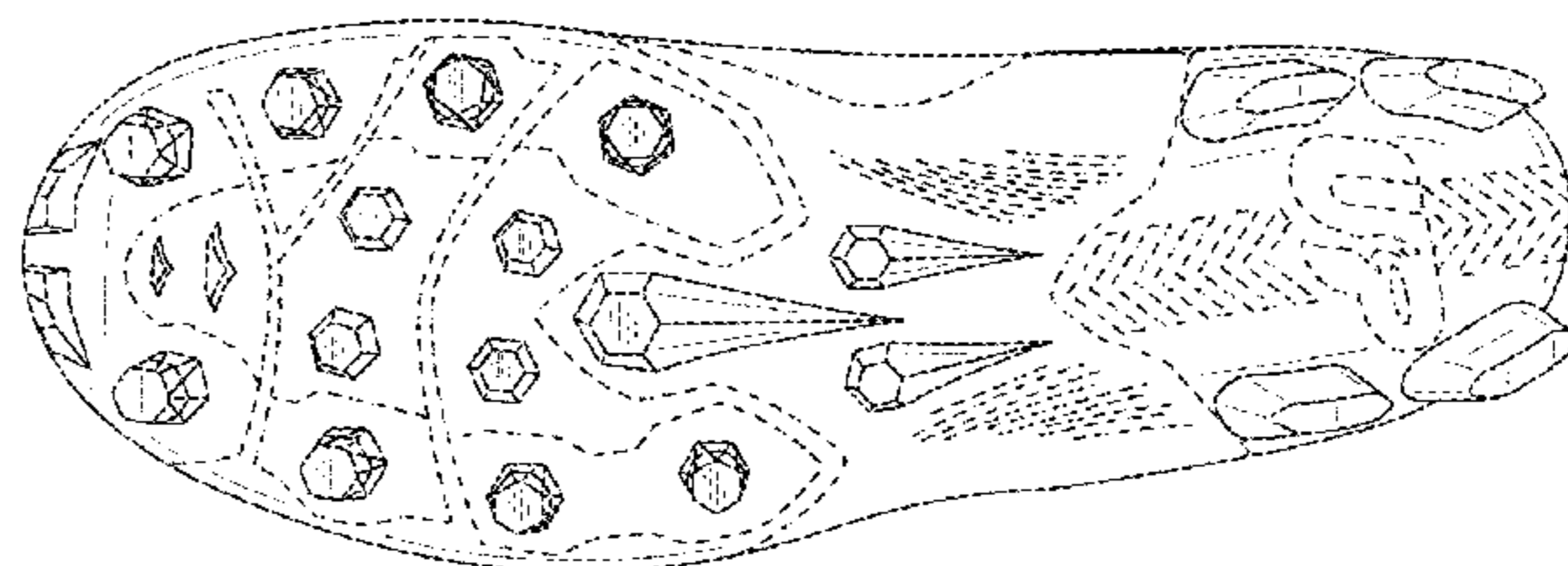
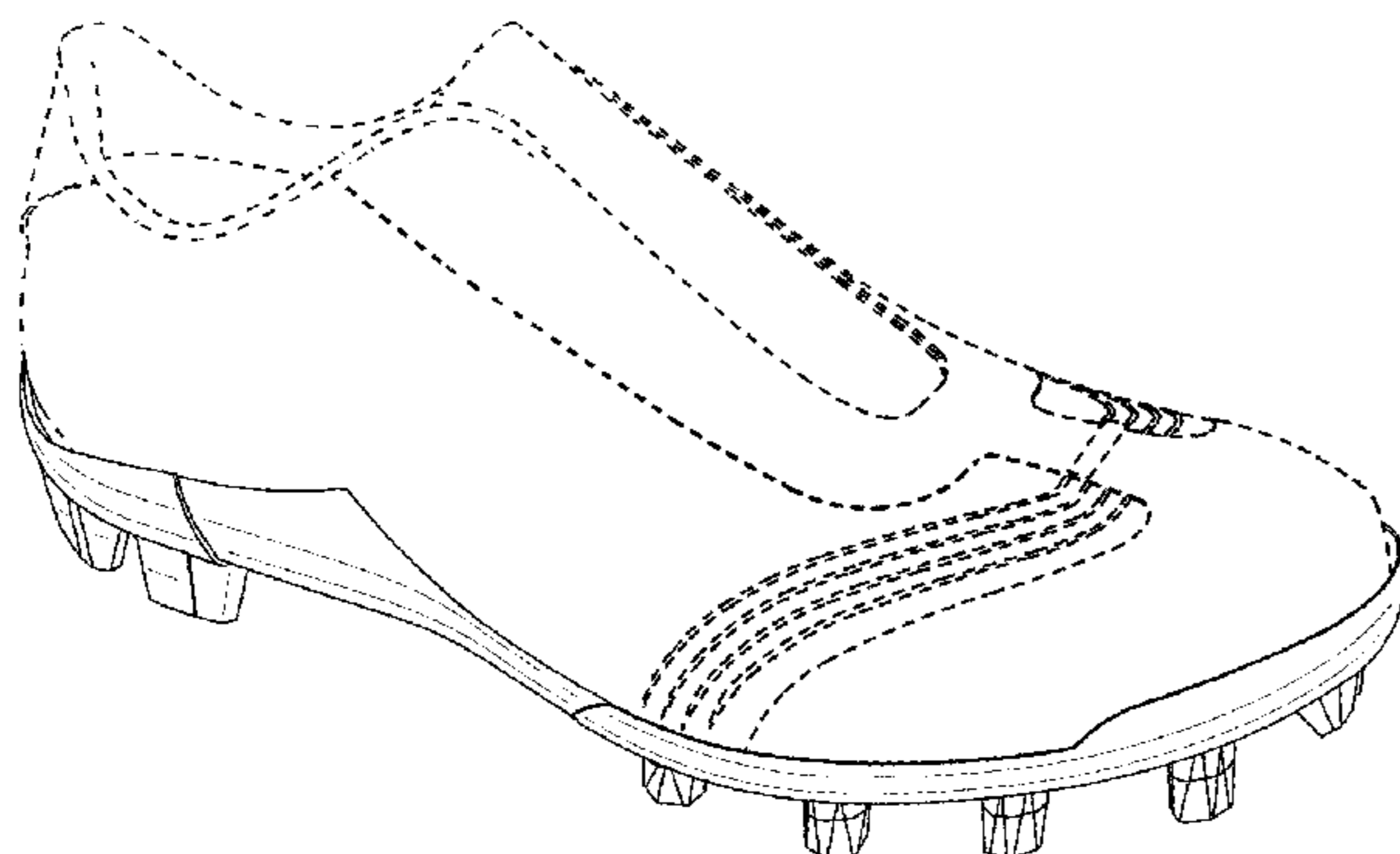
(57) **CLAIM**

**DESCRIPTION**

FIG. 1 is a right side, perspective view of a shoe sole for flying disc sports,

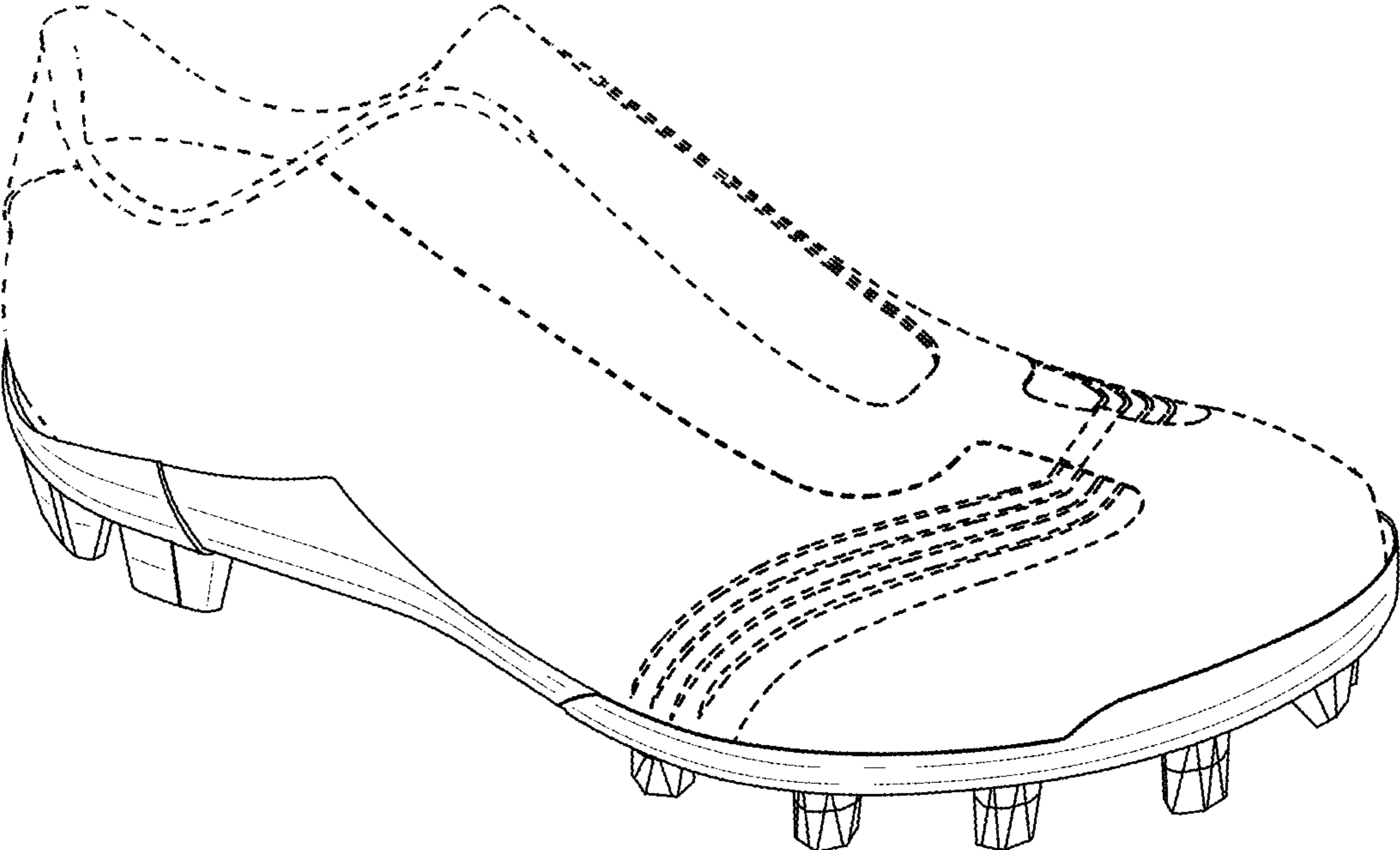

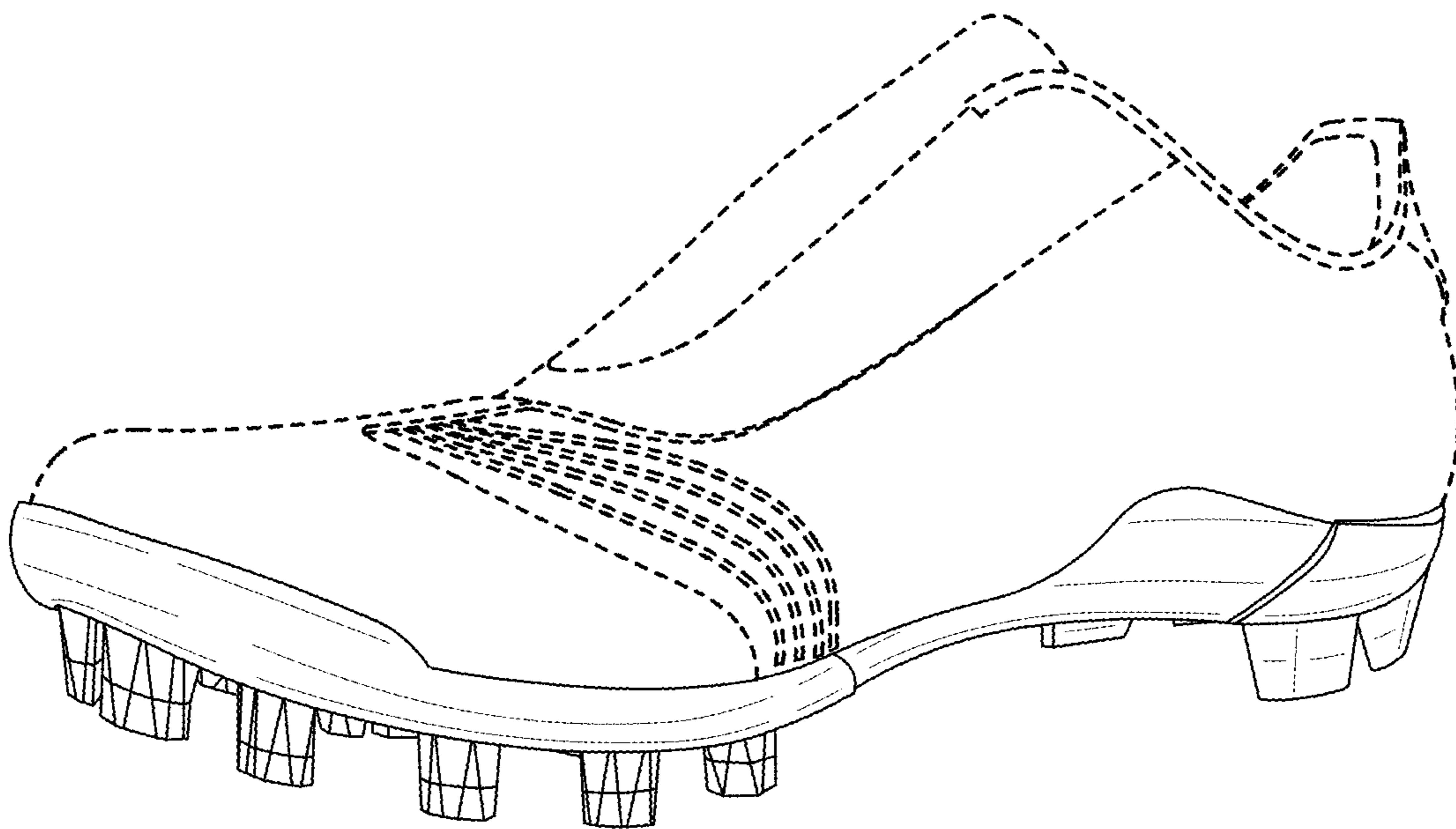

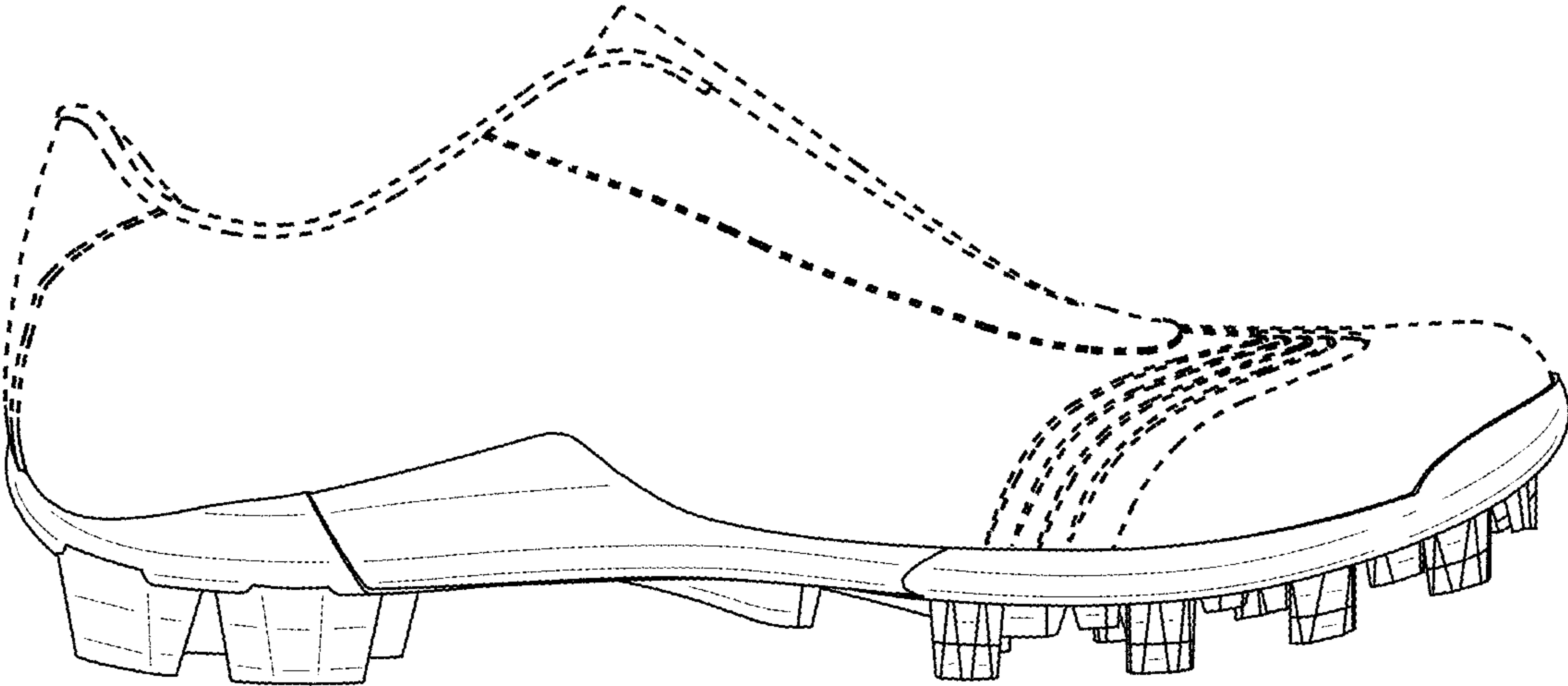

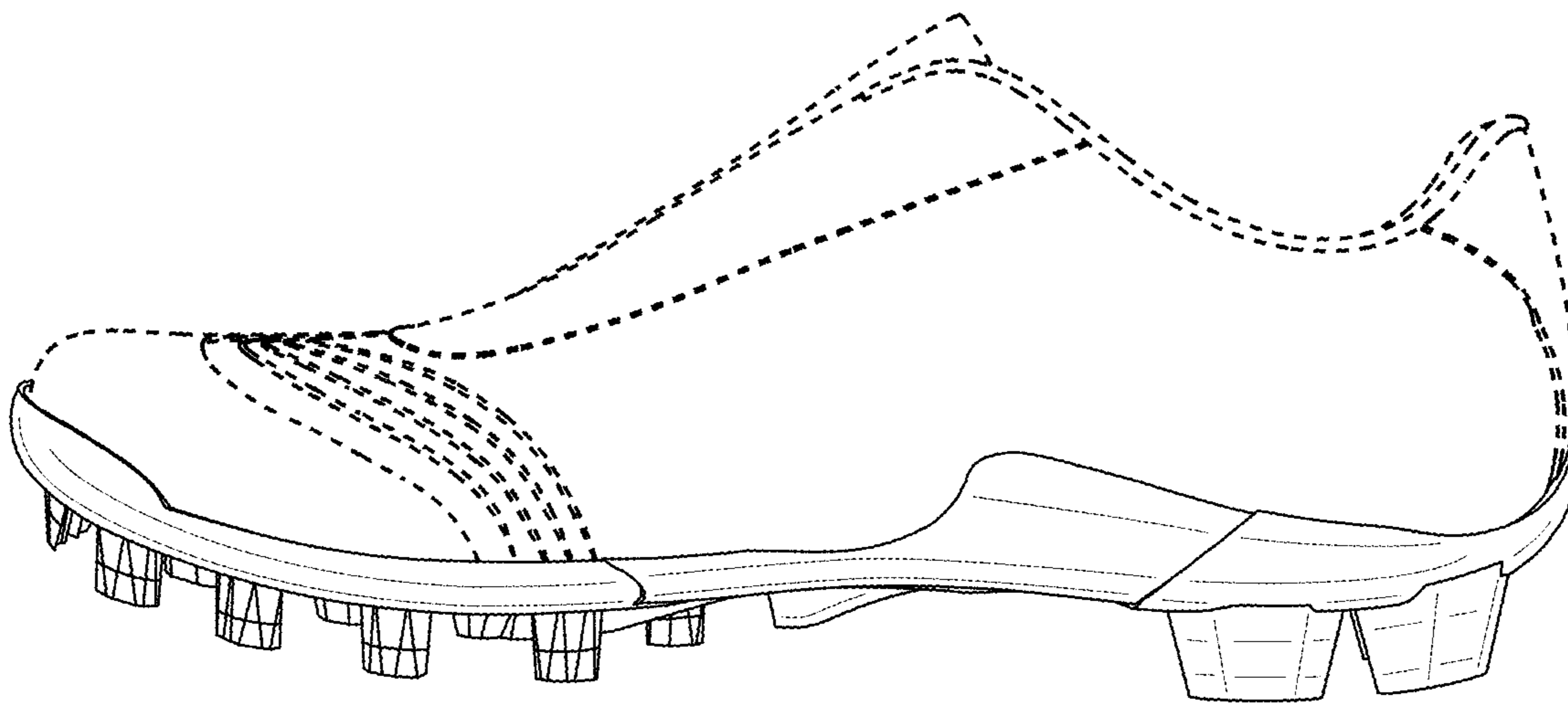

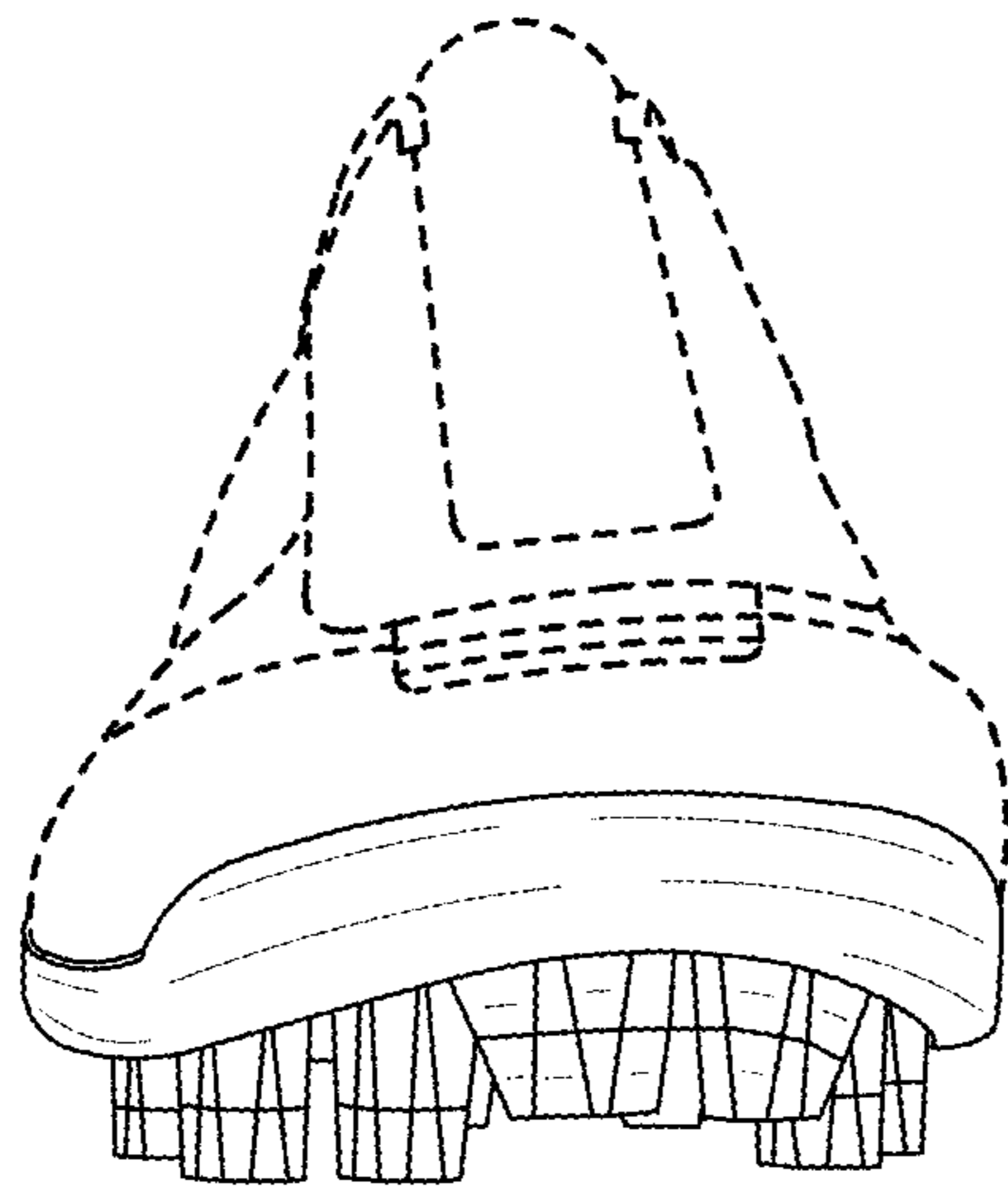

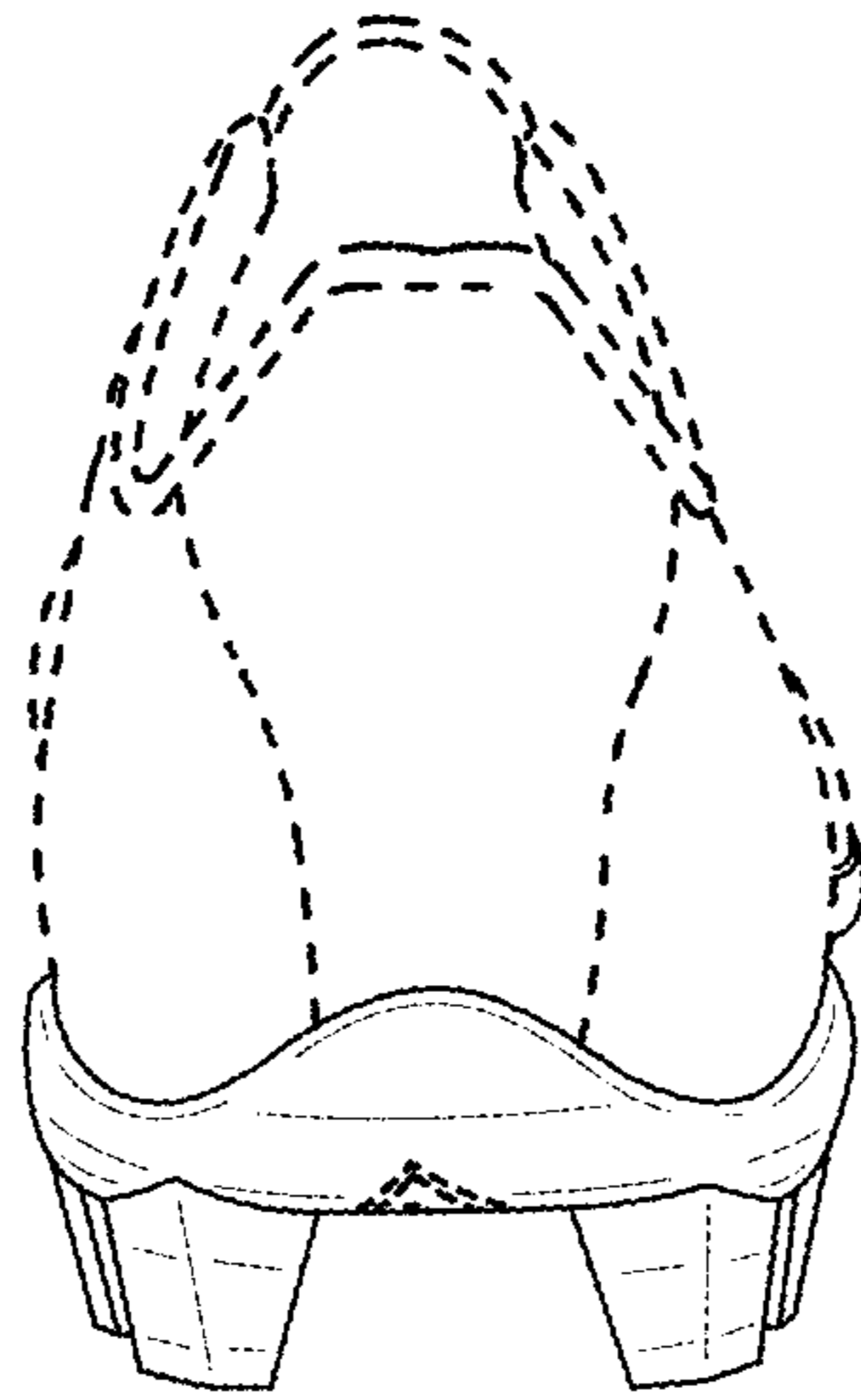

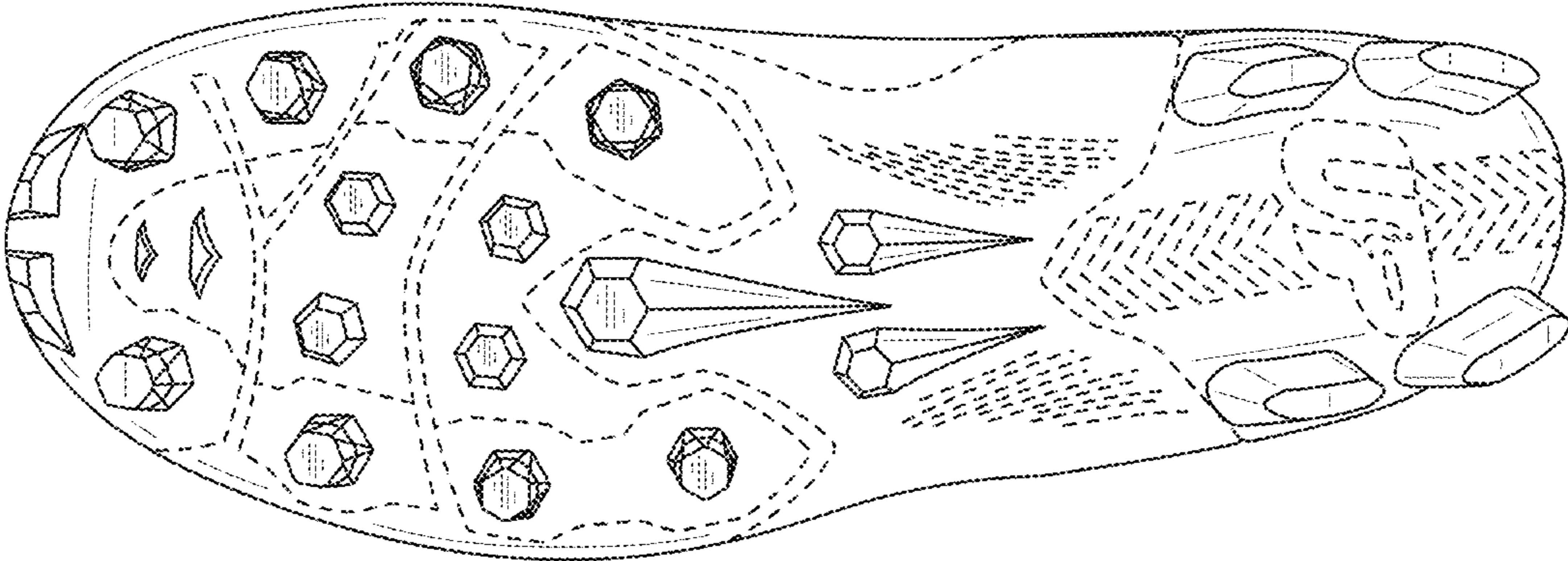
