The ornamental design for a diaper bag, as shown and described.

**DESCRIPTION**

FIG. 1 is a front side view of a diaper bag.  
FIG. 2 is a rear side view of the diaper bag of FIG. 1.  
FIG. 3 is a left side view of the diaper bag of FIG. 1.  
FIG. 4 is a right side view of the diaper bag of FIG. 1.

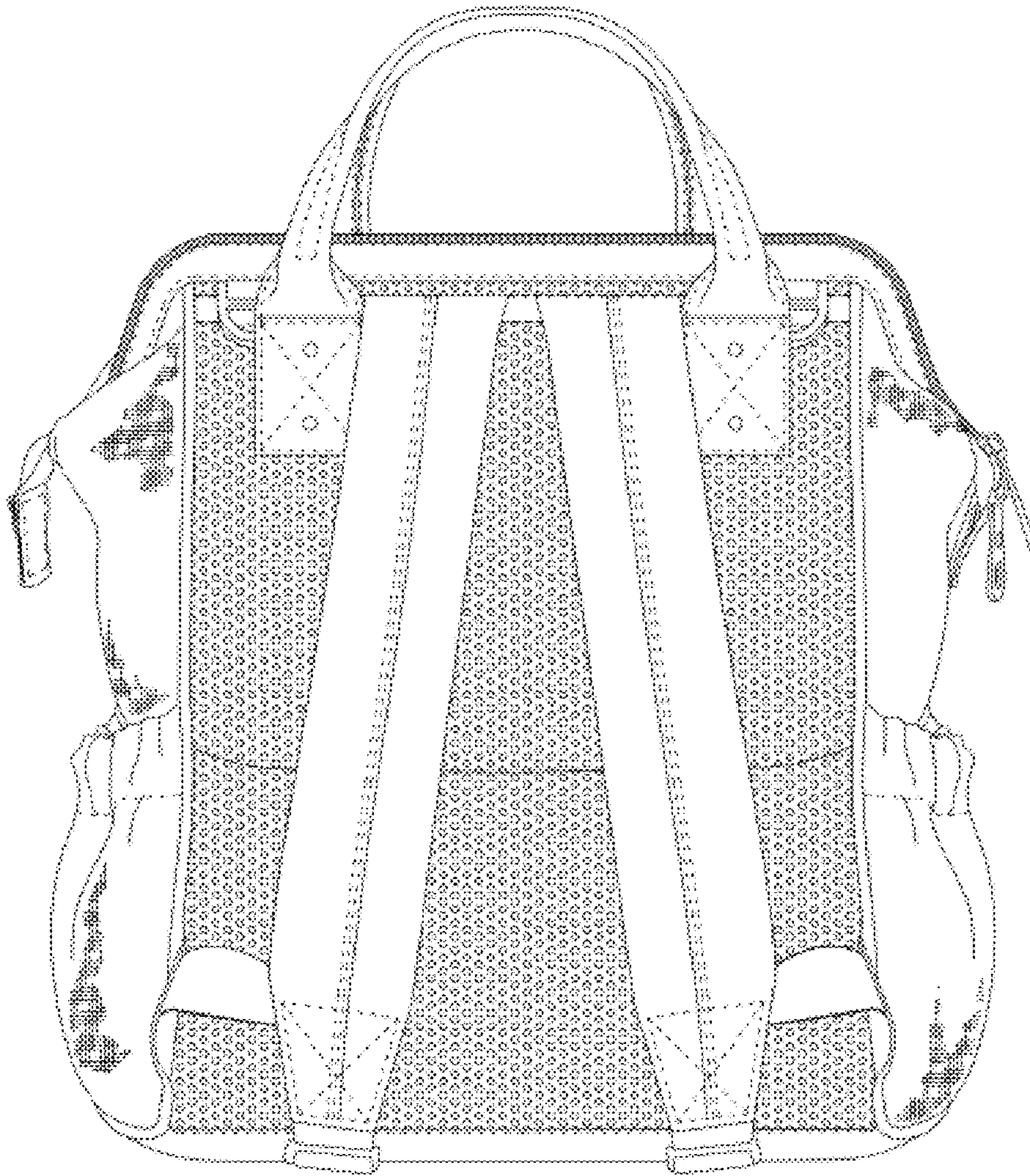

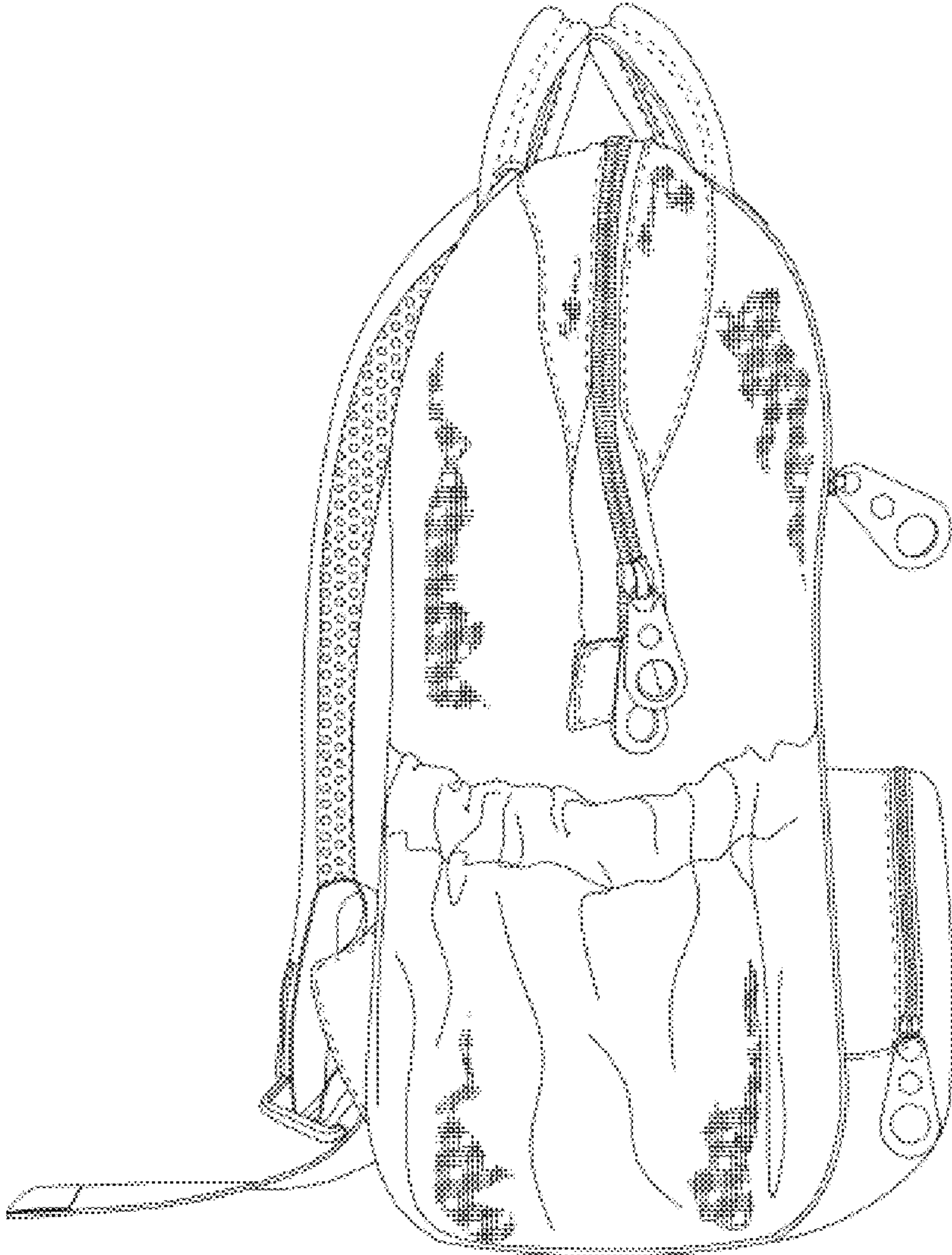

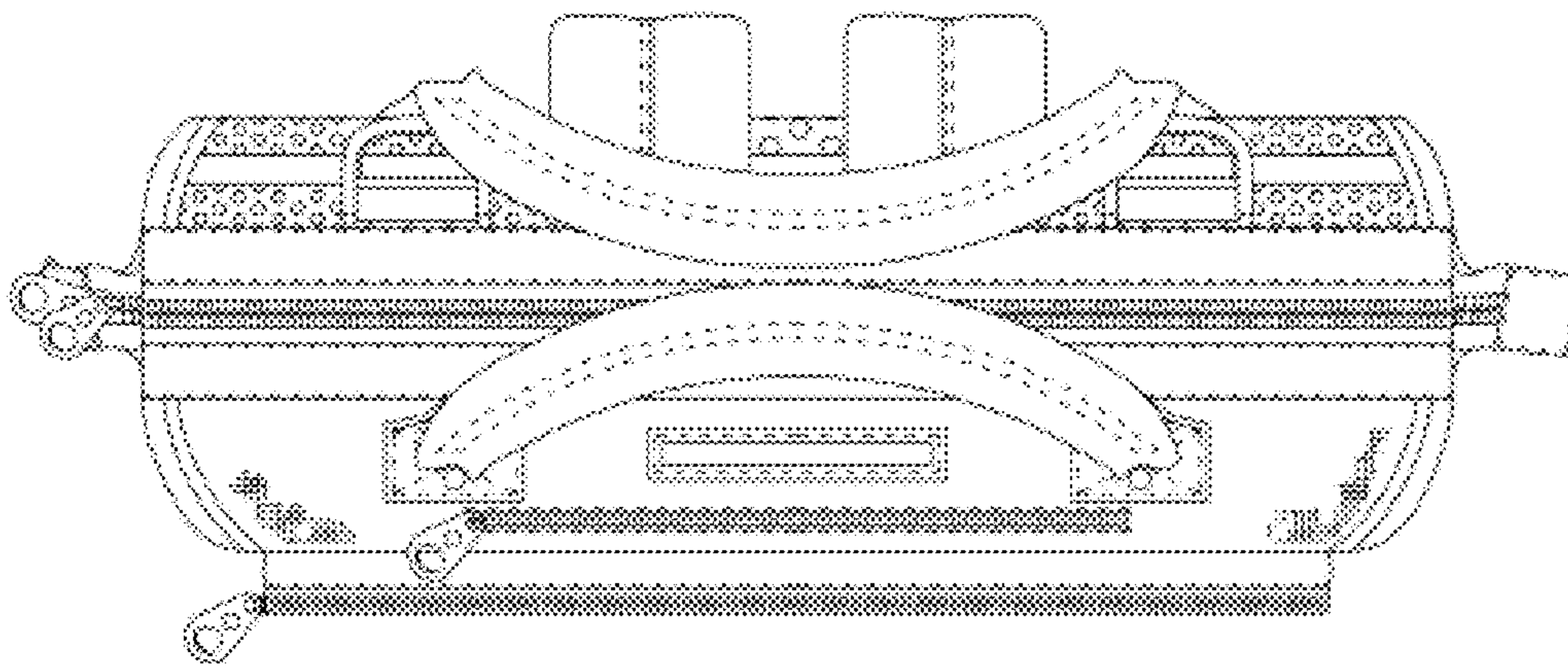

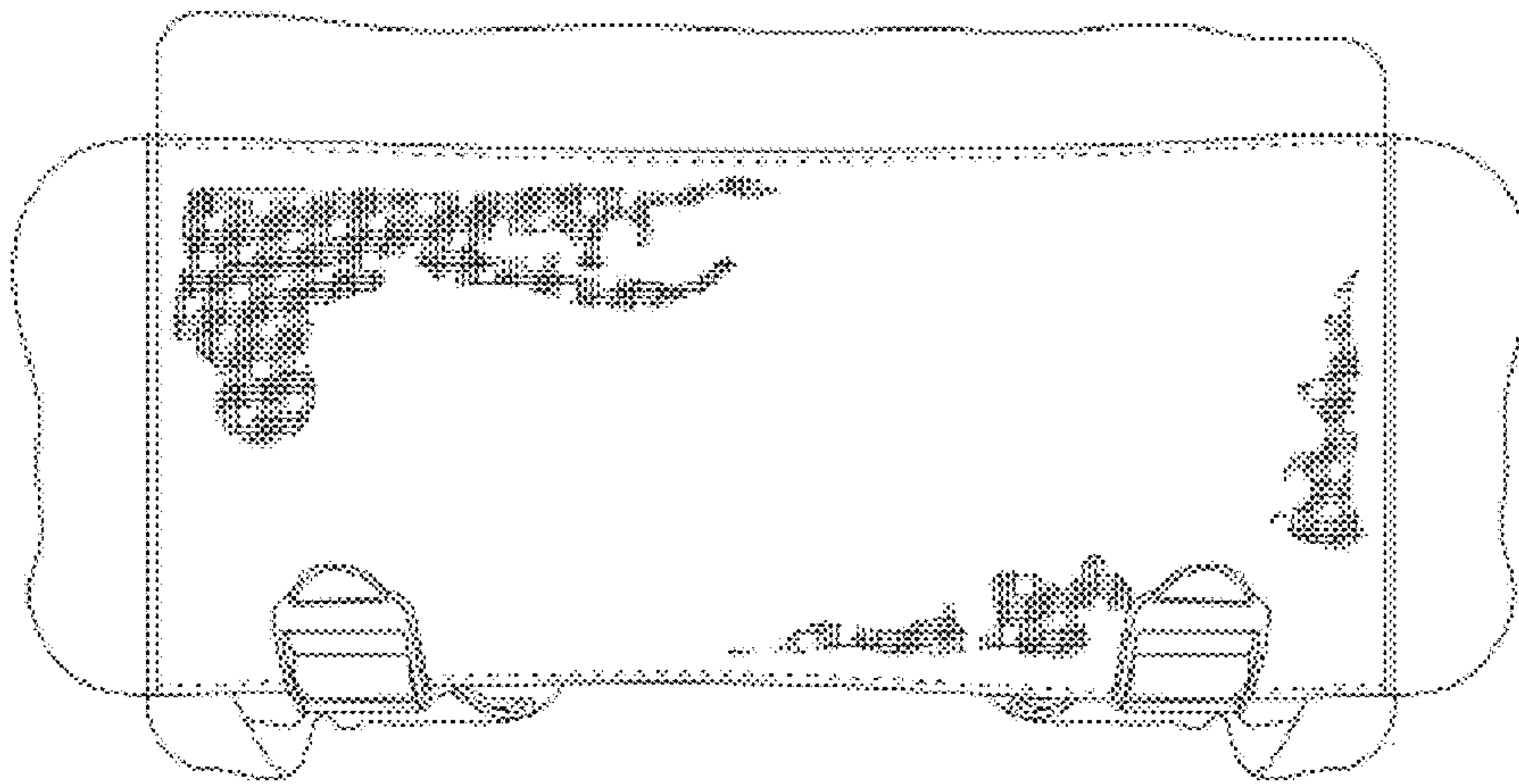
