**DESCRIPTION**

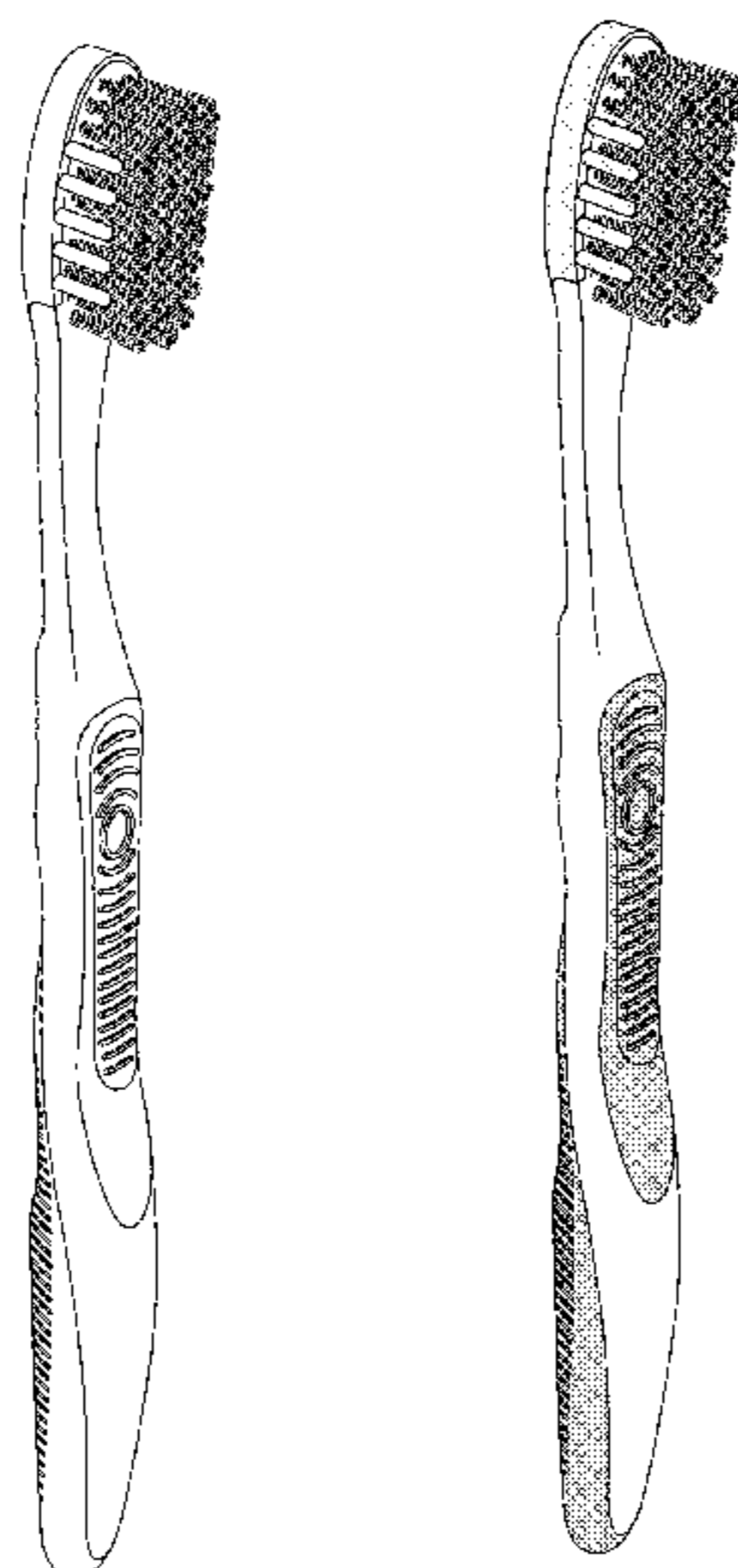
FIG. 1 is a perspective view of a toothbrush according to a first embodiment showing my new design;

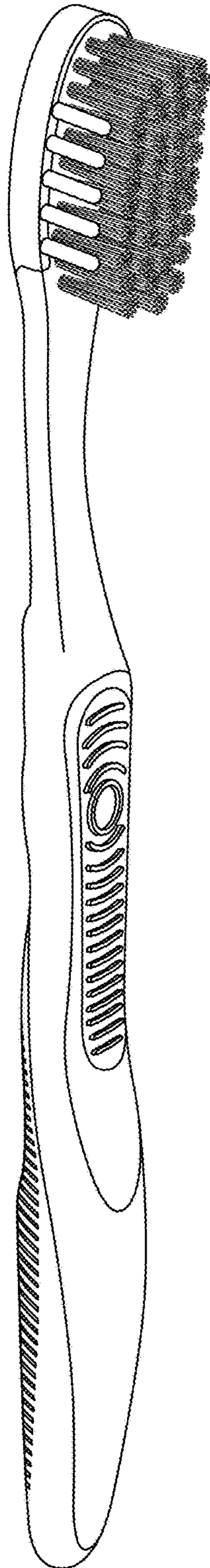

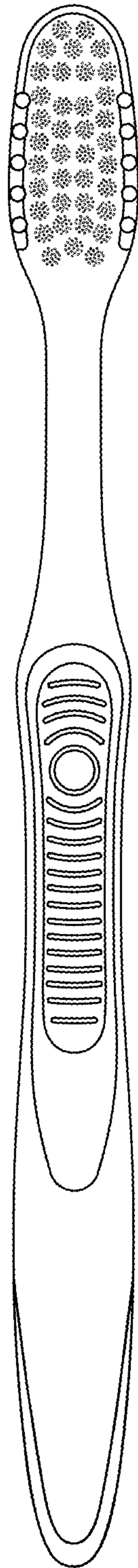

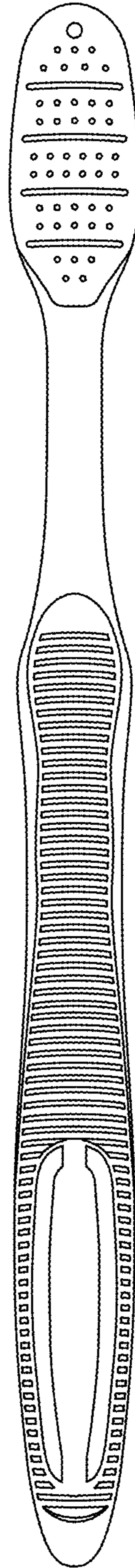

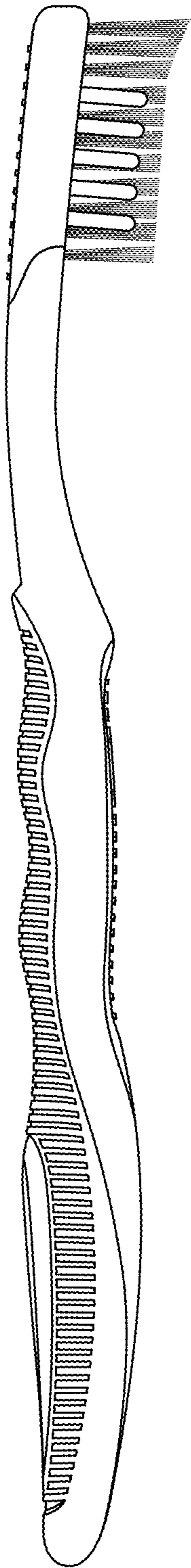

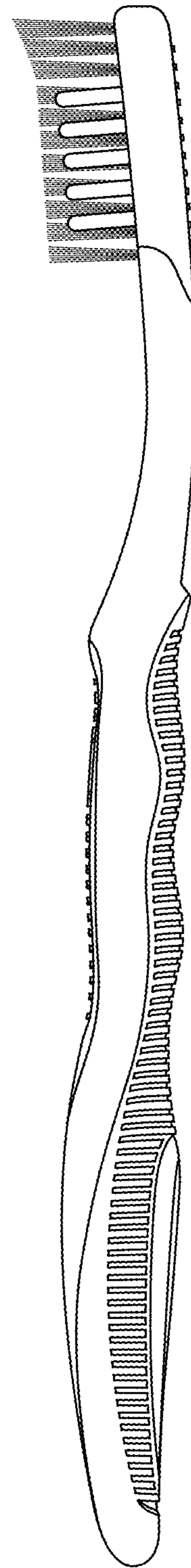

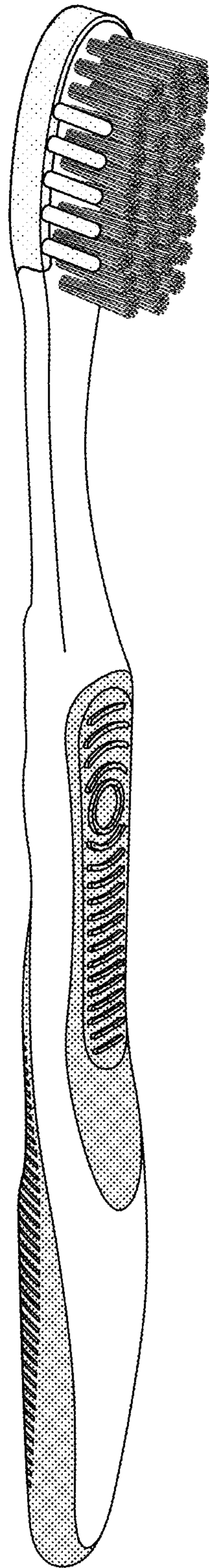

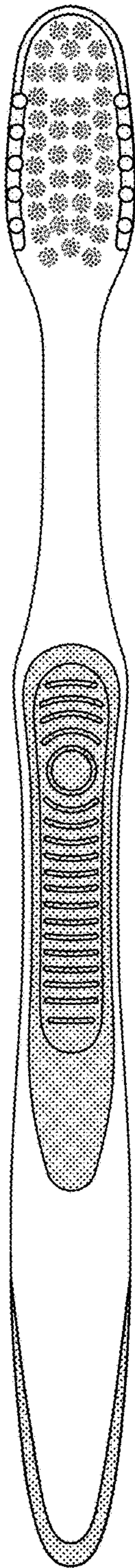

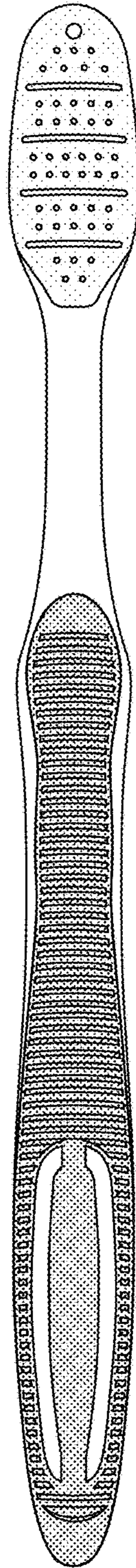

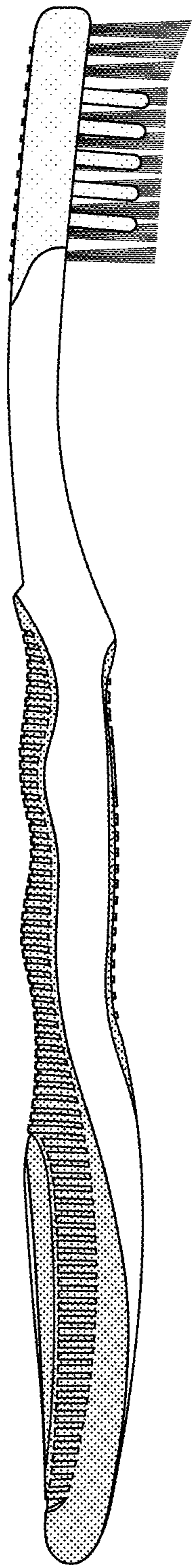

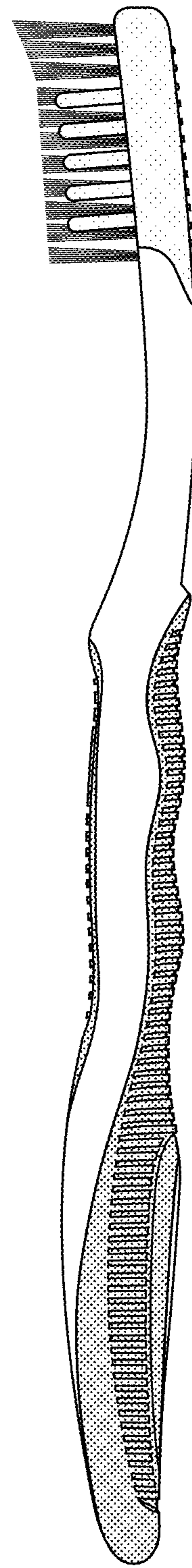
