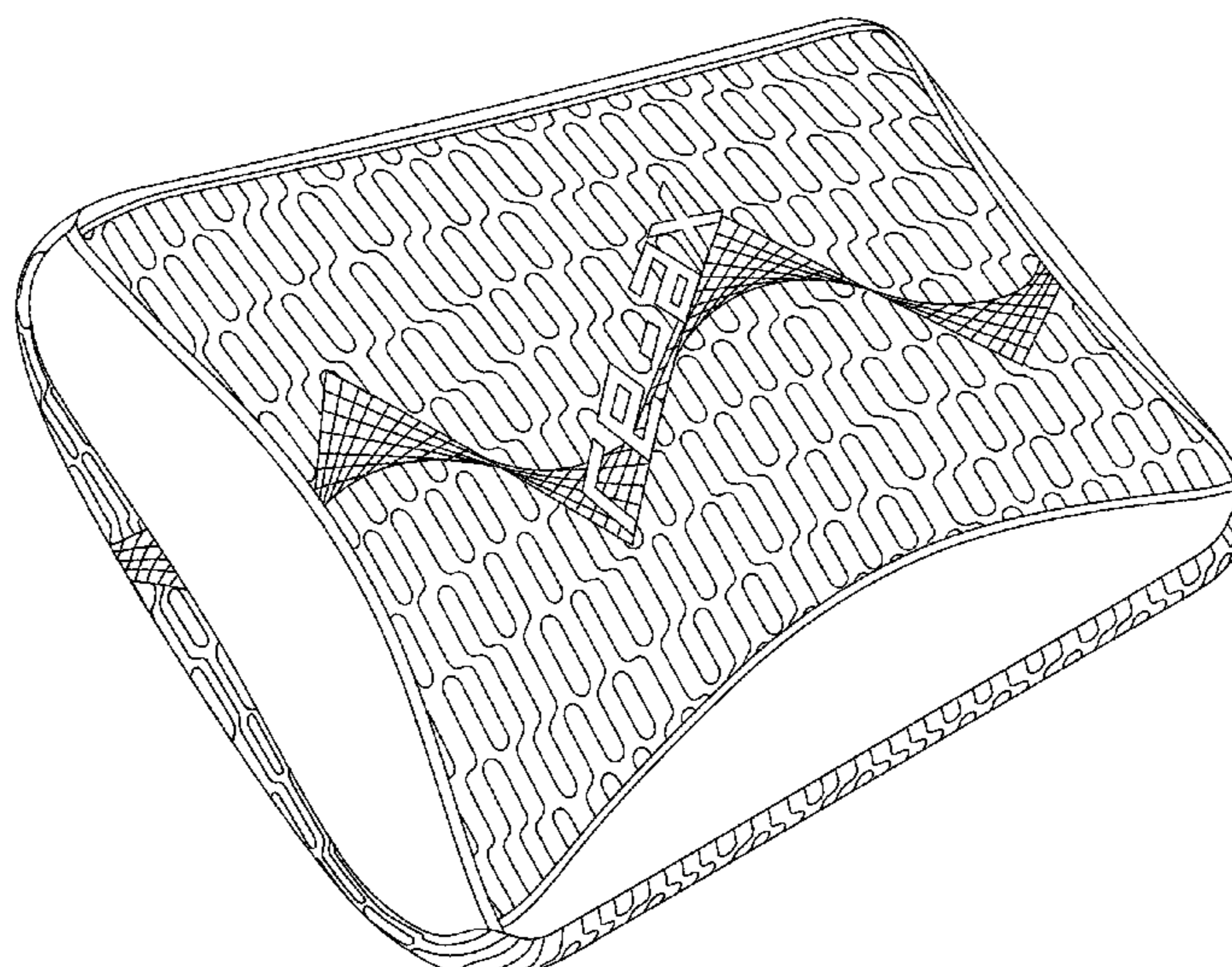
(57) **CLAIM**

The ornamental design for a pillow, as shown and described.

DESCRIPTION

FIG. 1 is a front perspective view of a pillow;
FIG. 2 is a top plan view thereof;
FIG. 3 is a front elevation view thereof;
FIG. 4 is a bottom plan view thereof;
FIG. 5 is a rear elevation view thereof;
FIG. 6 is a right side elevation view thereof;
FIG. 7 is a left side elevation view thereof; and,
FIG. 8 is a front perspective view of the pillow of FIG. 1, showing our new design according to a second embodiment. The stipple shading in FIG. 8 represents a contrast of appearance.

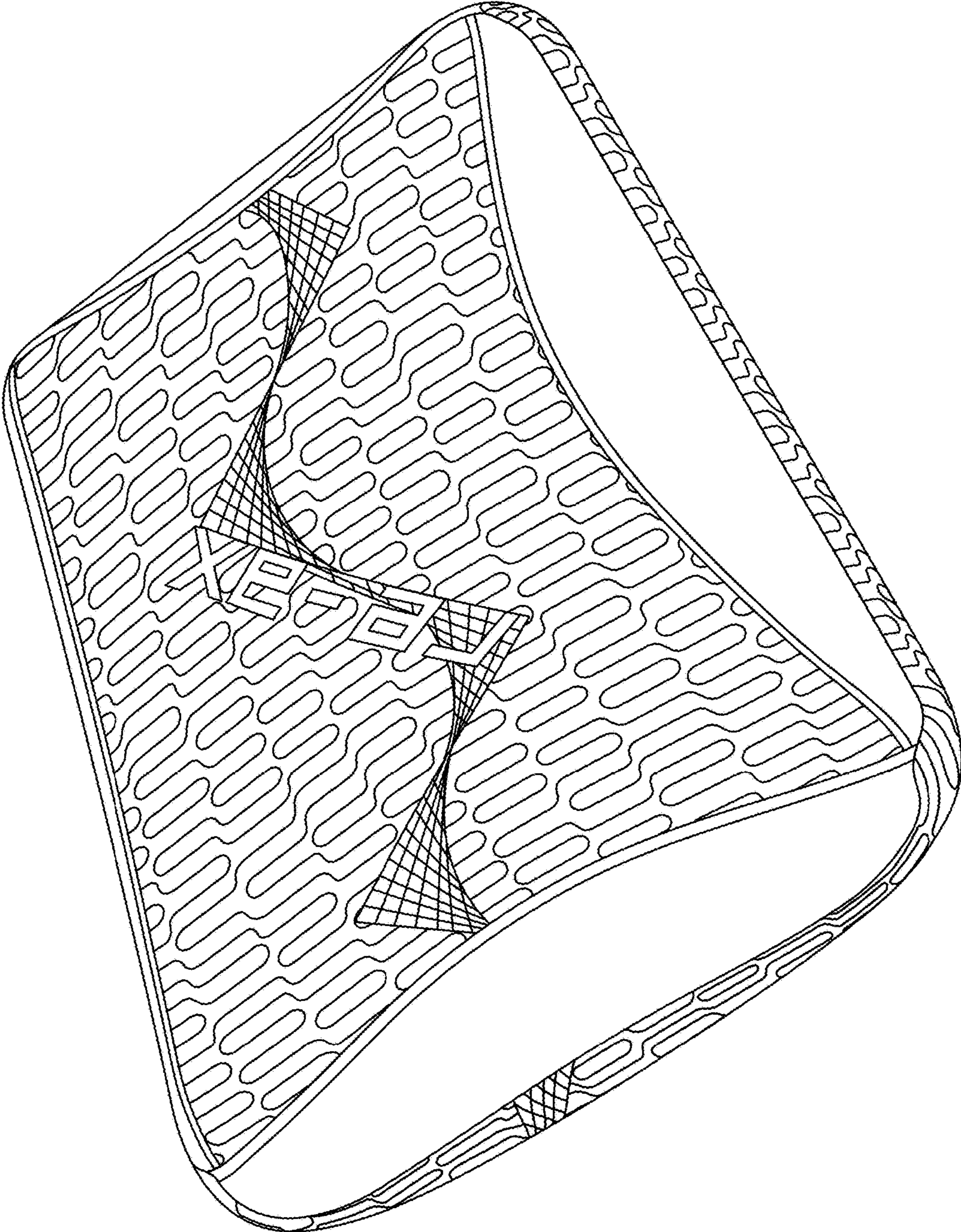

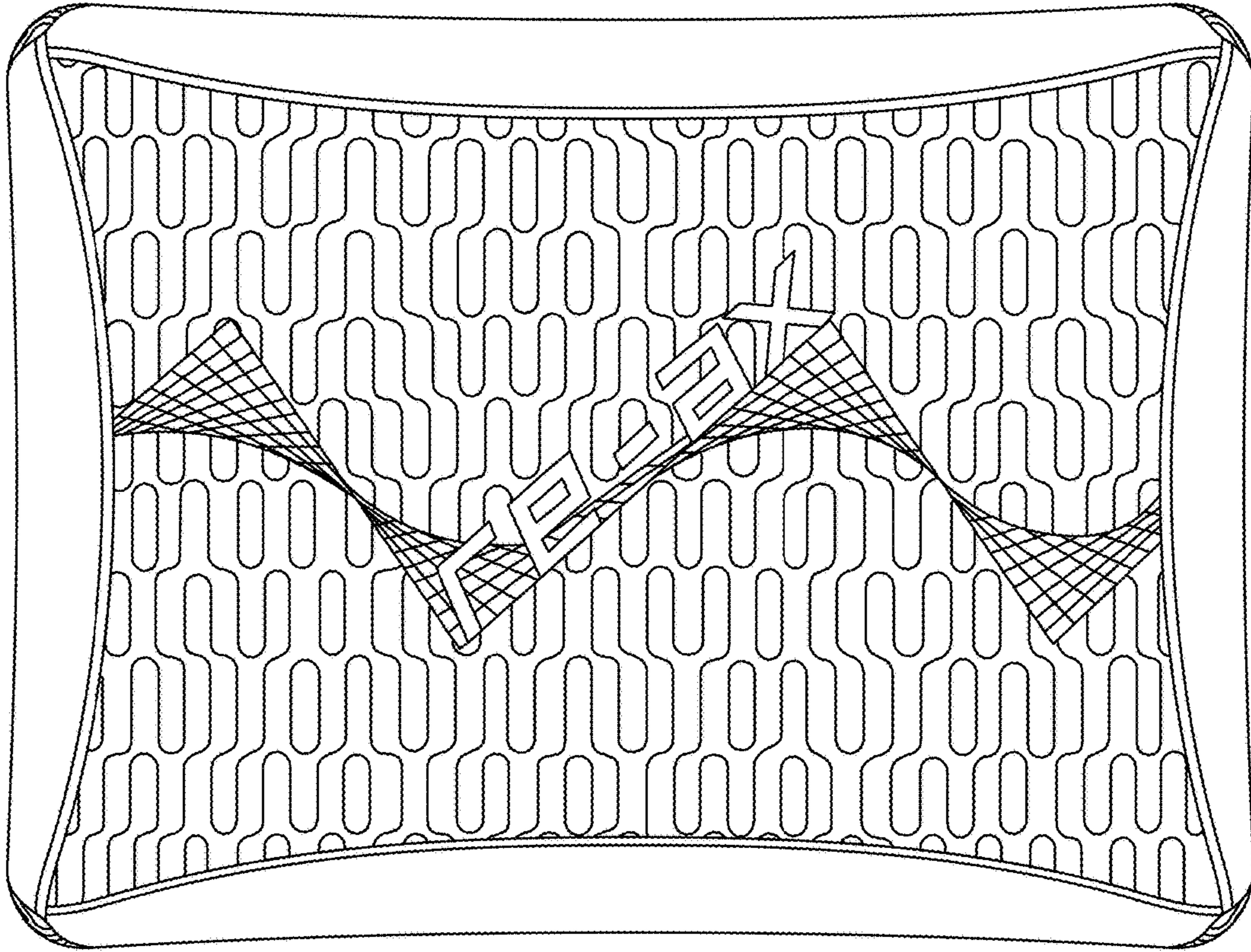

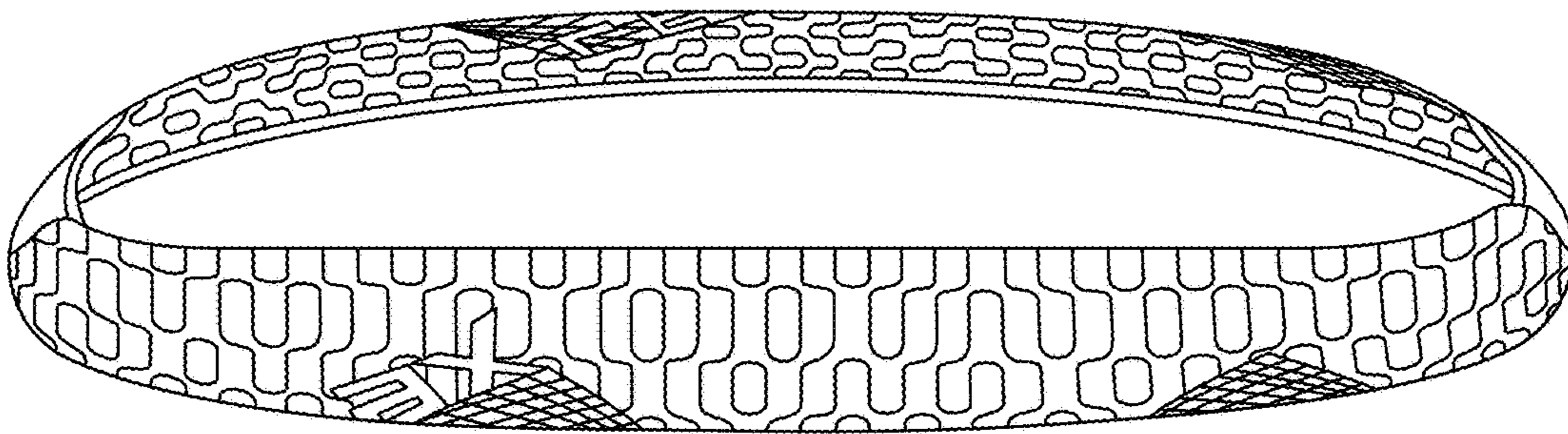

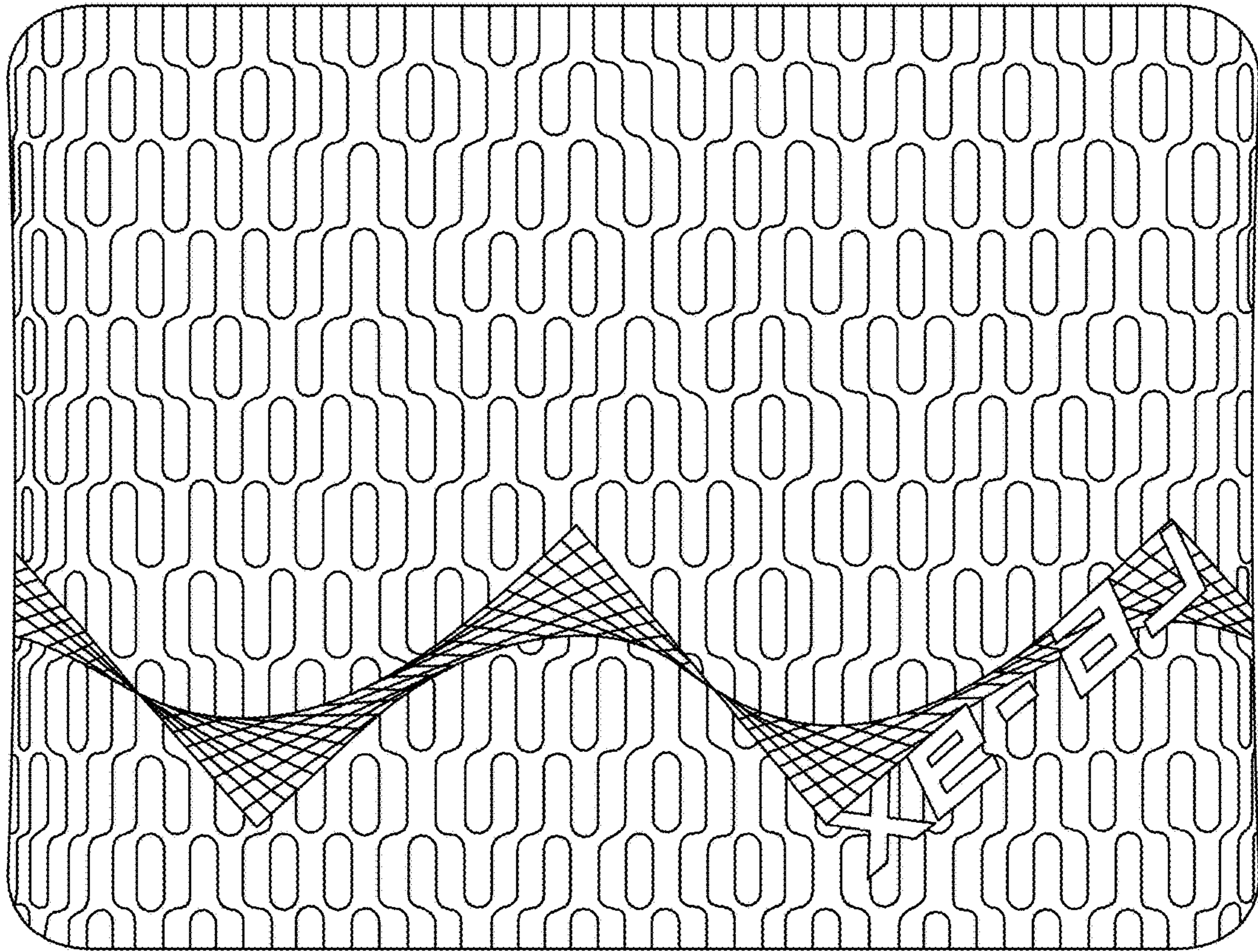

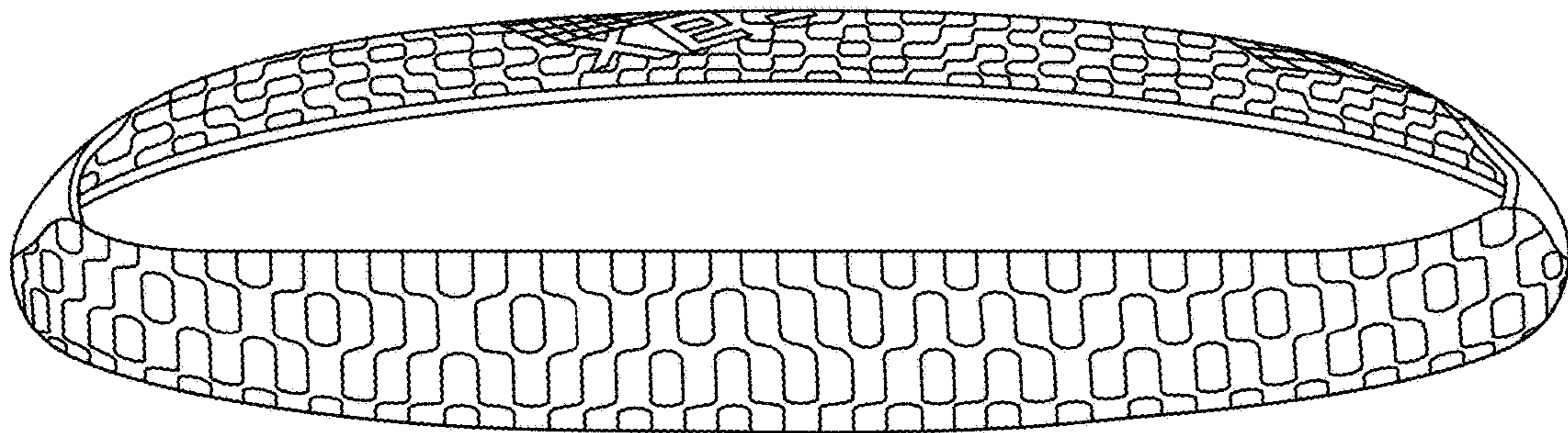

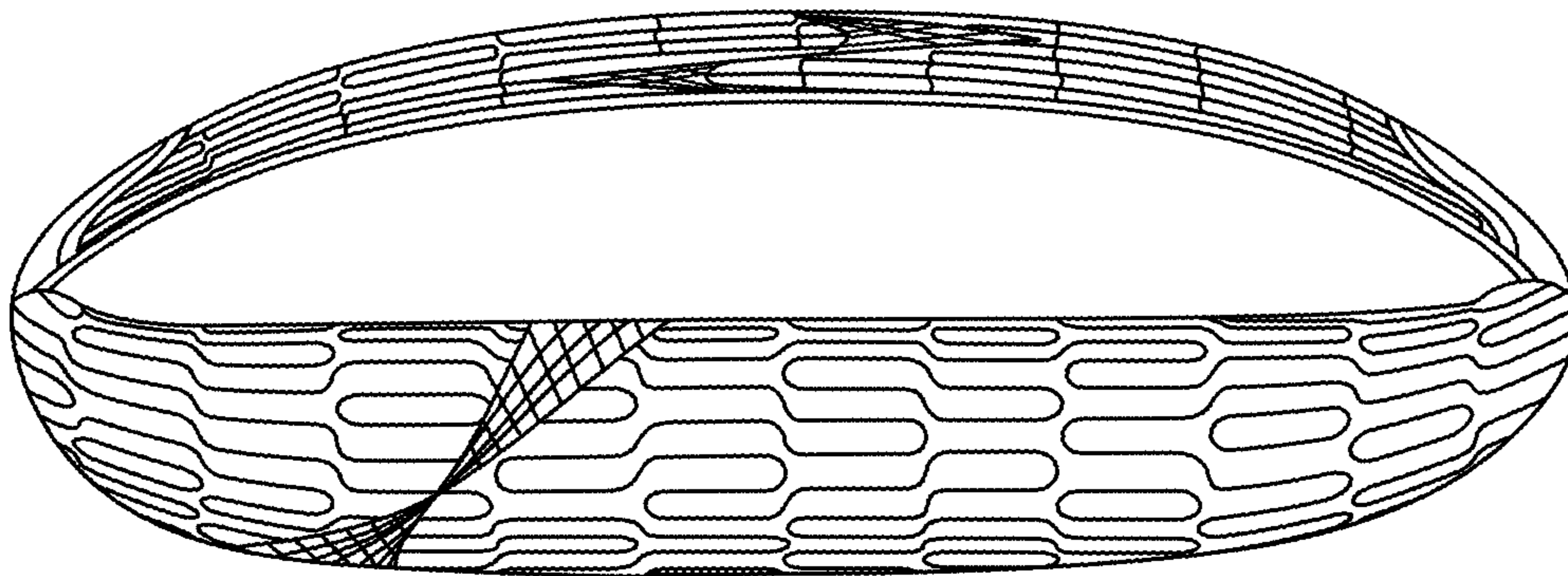

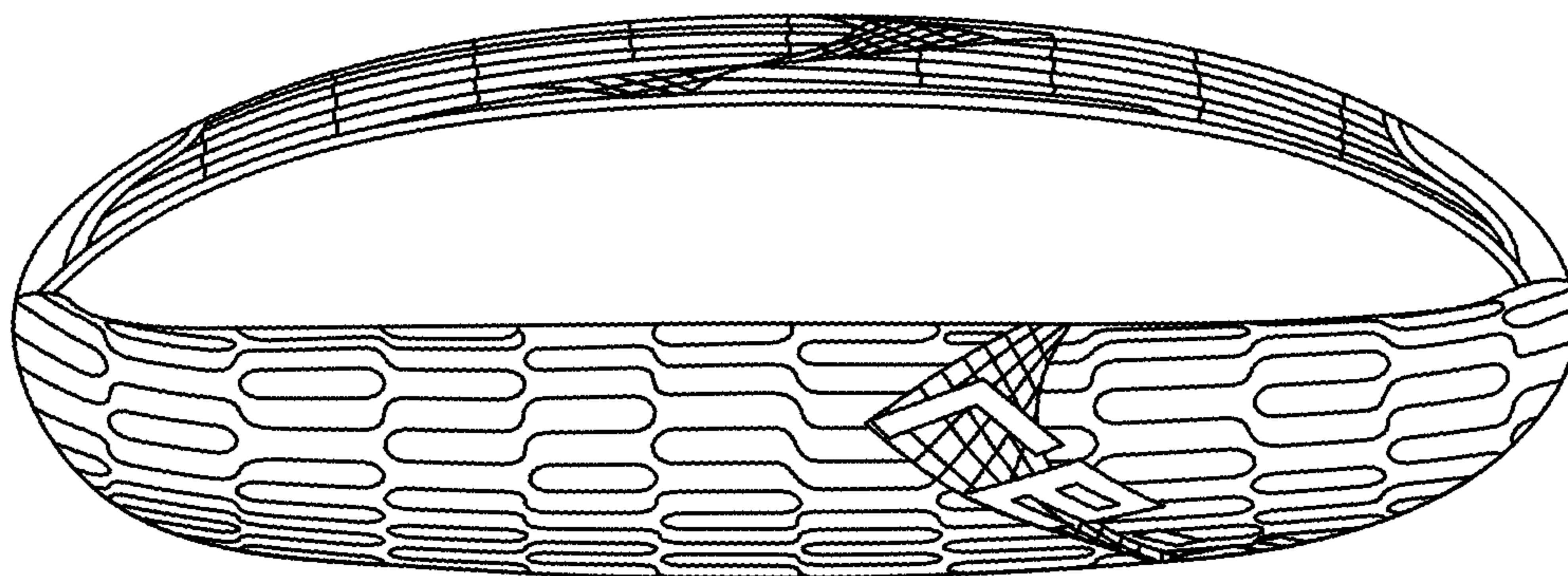

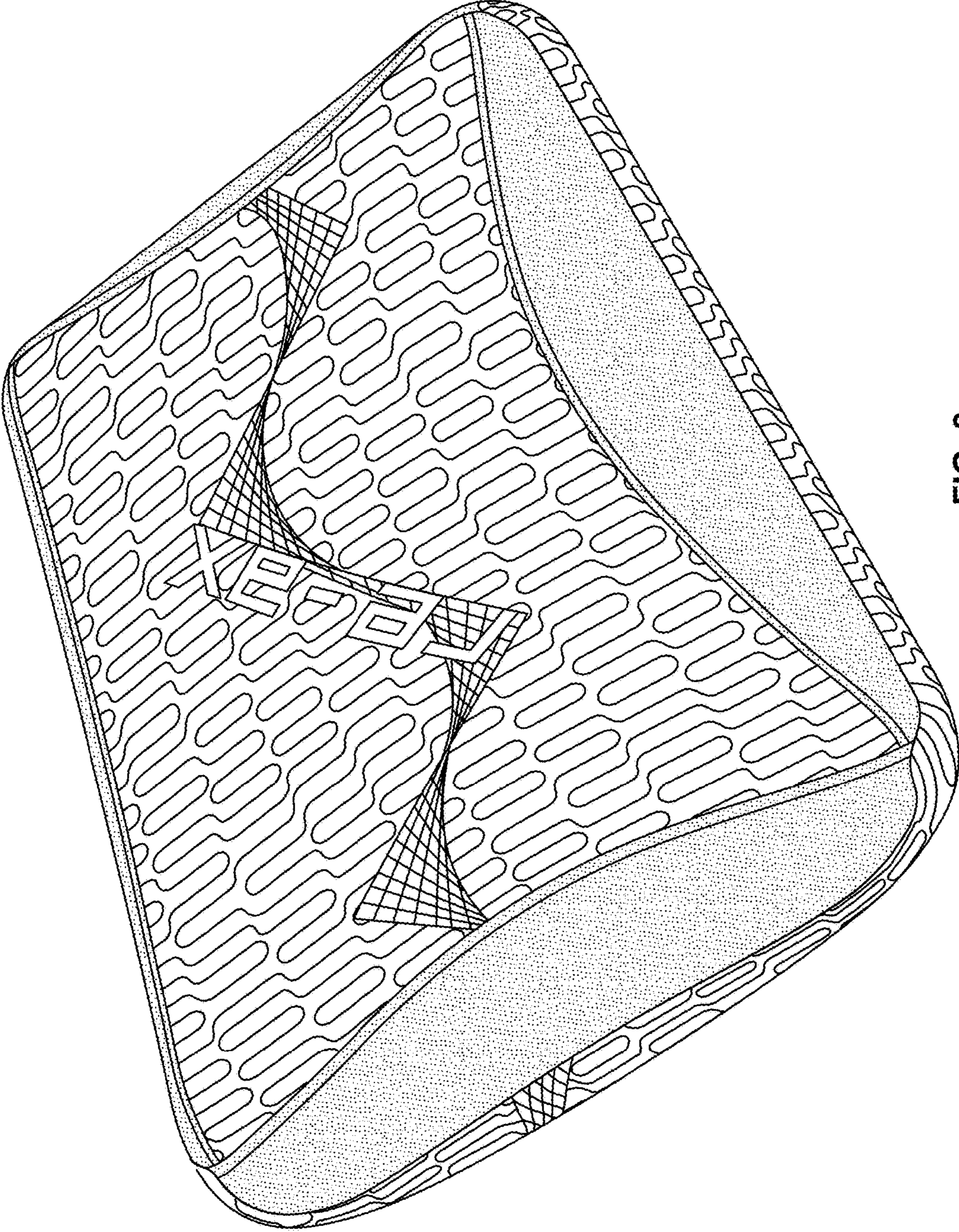
