We claim the ornamental design for a tube rack, as shown and described.

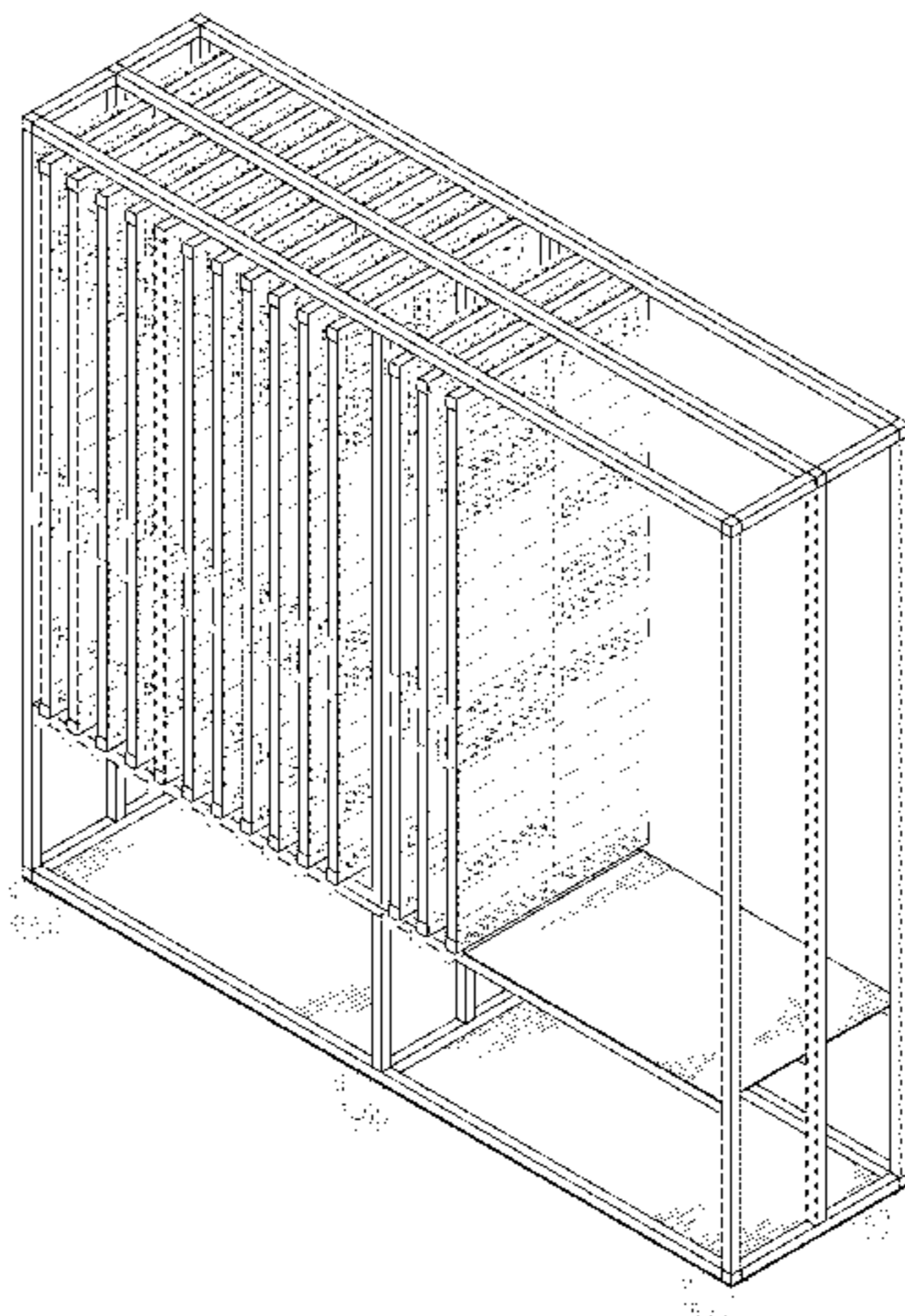
DESCRIPTION

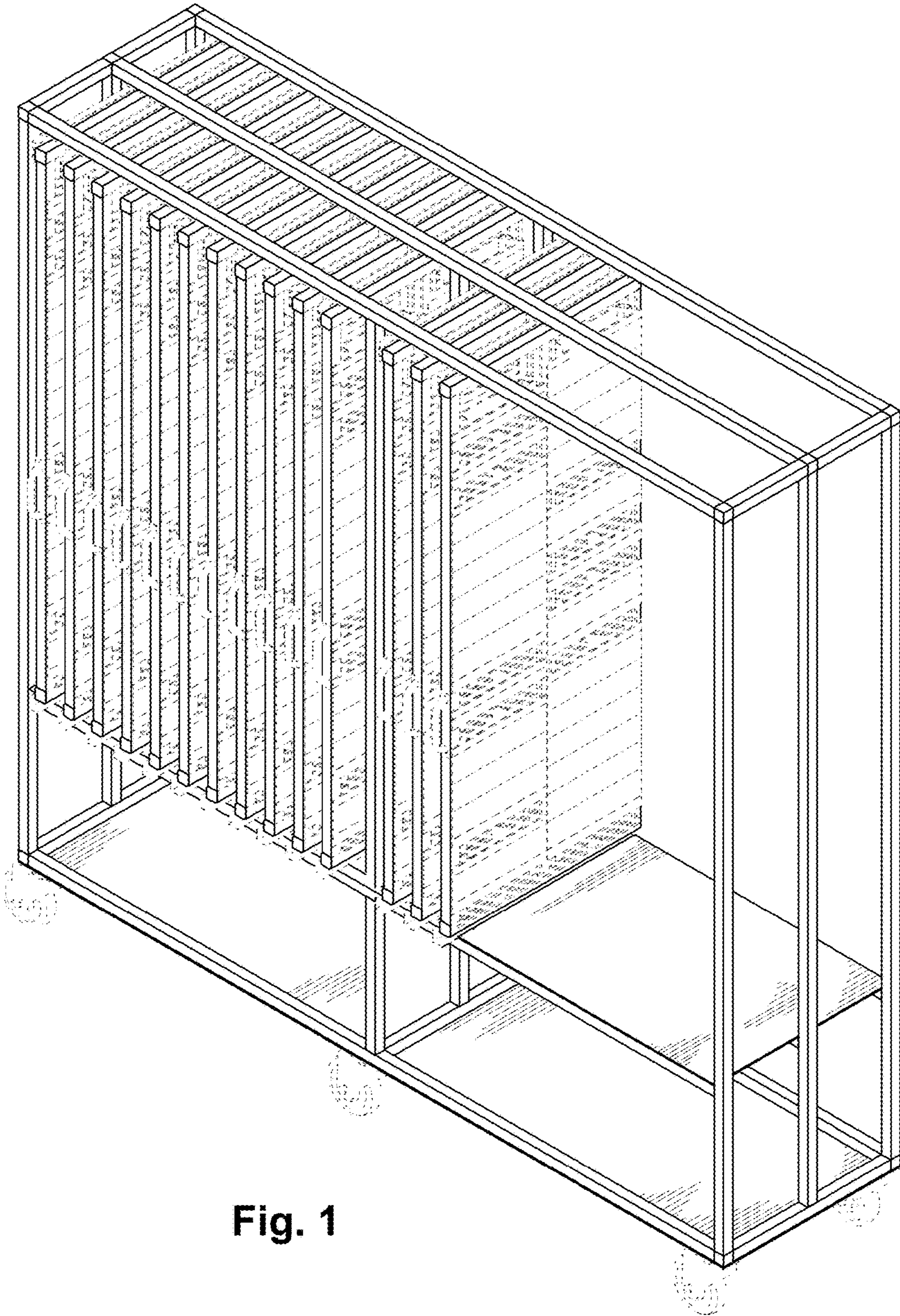

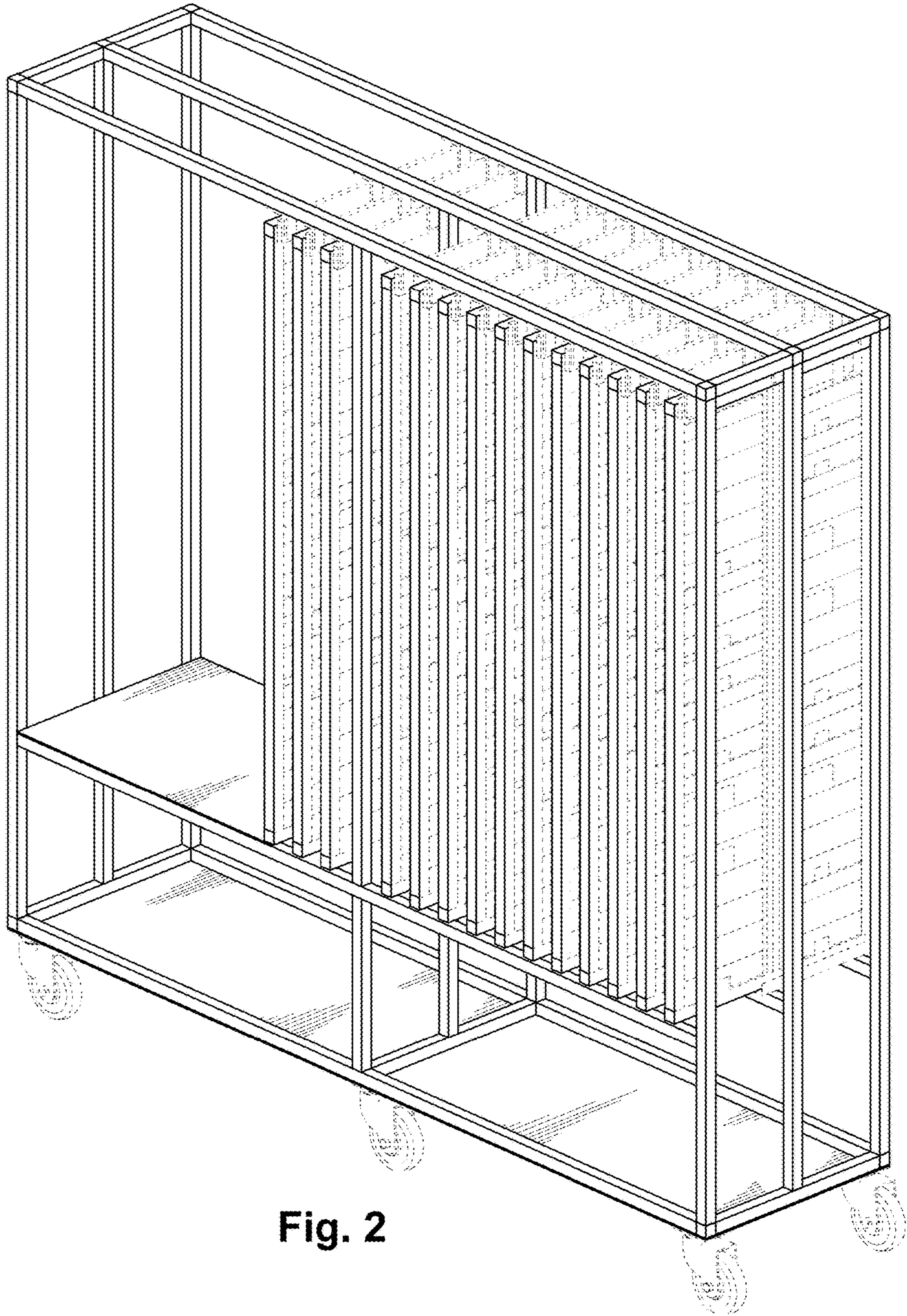

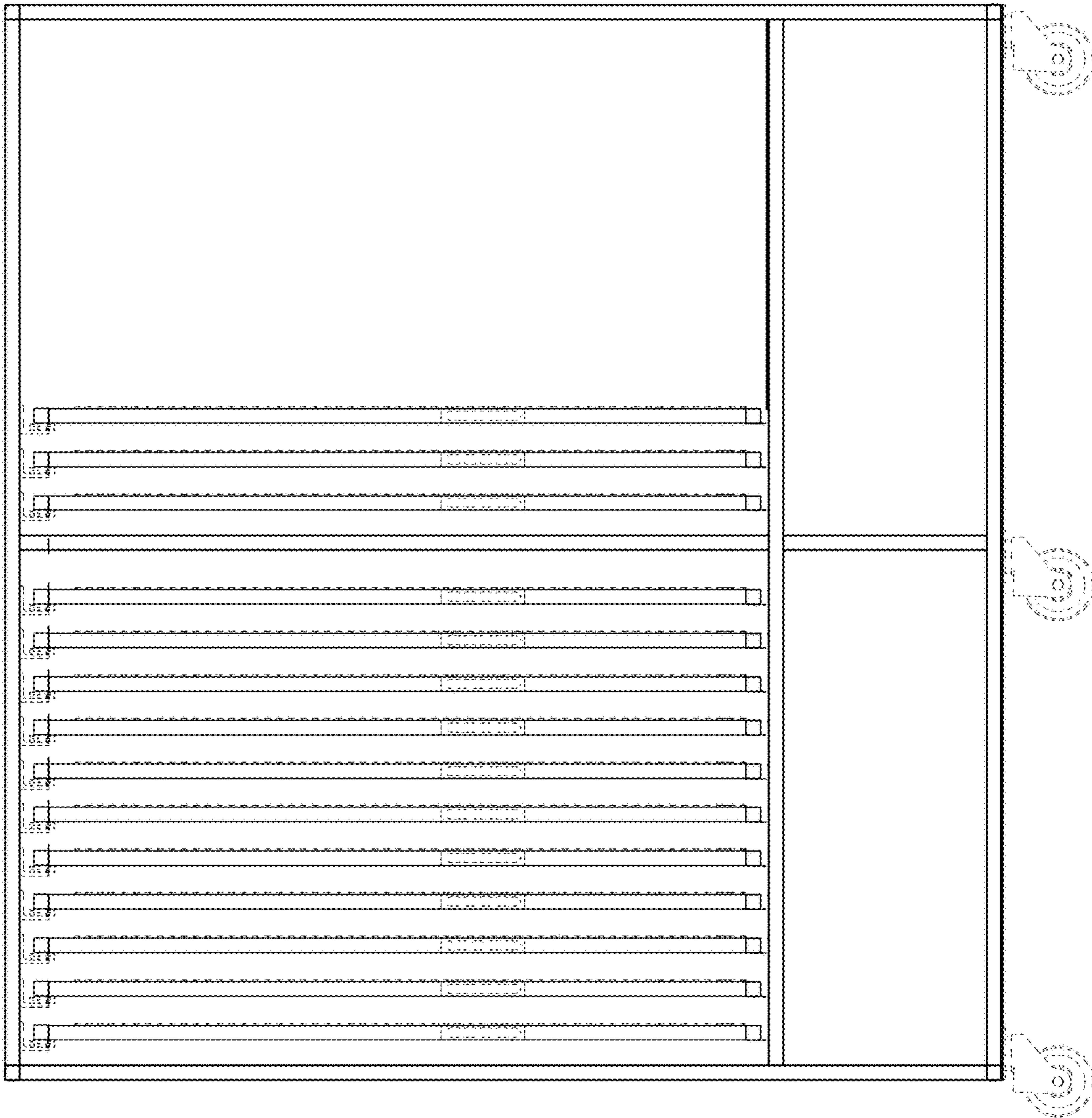

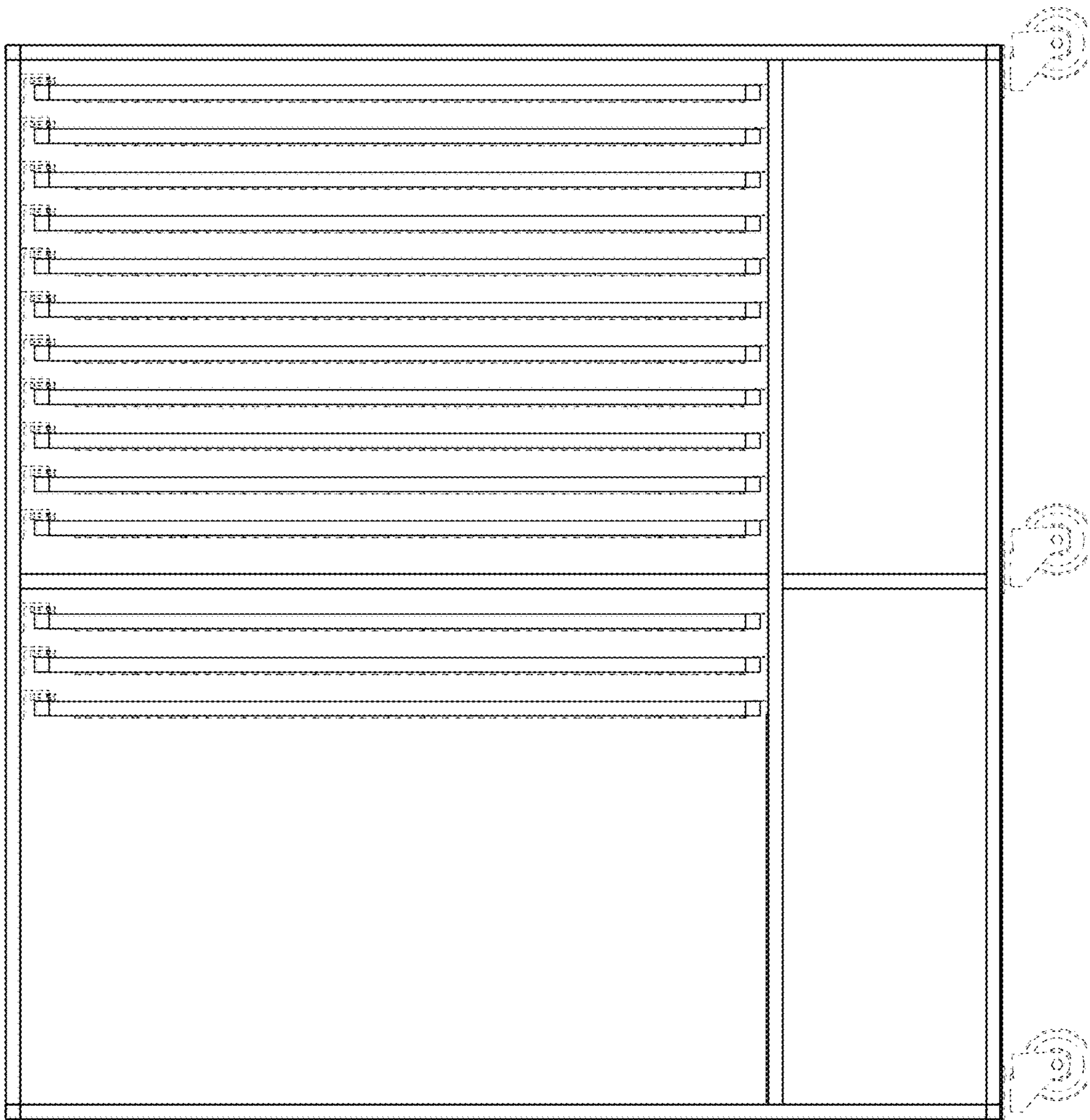

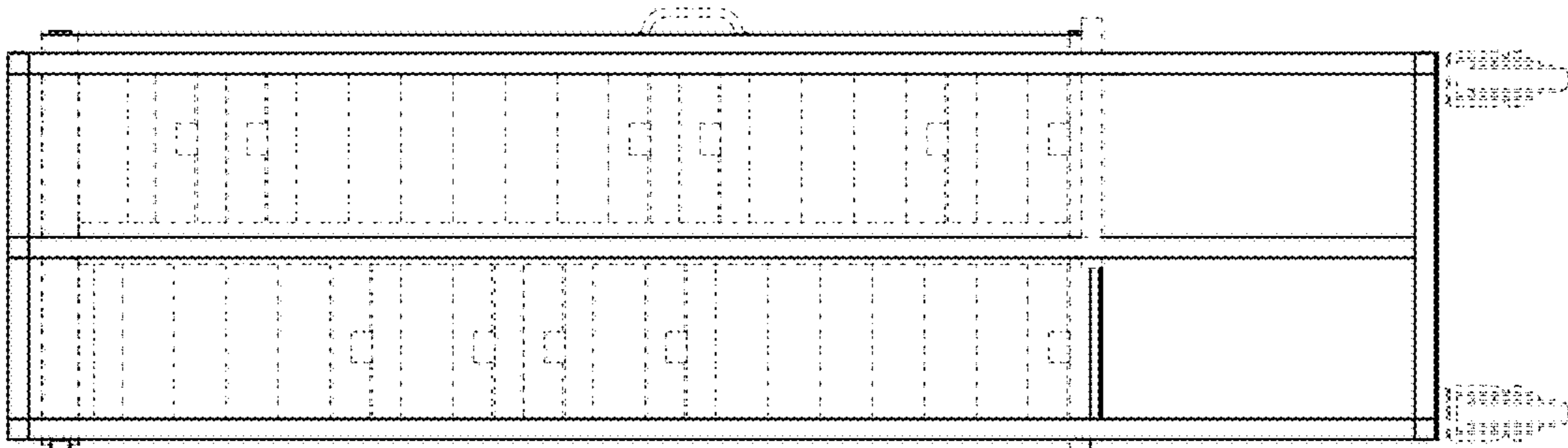

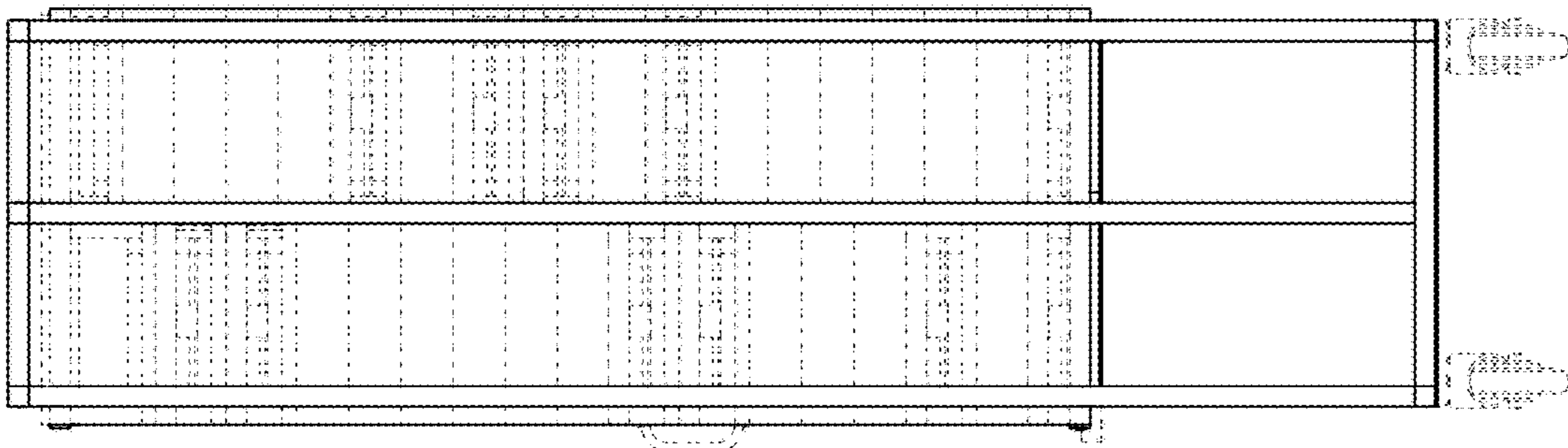

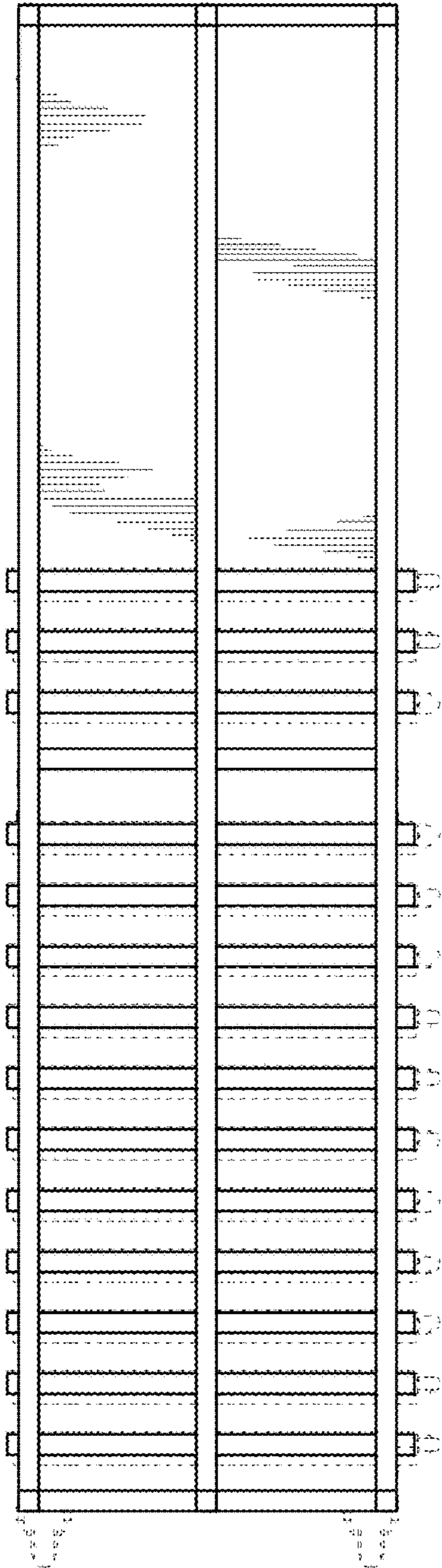

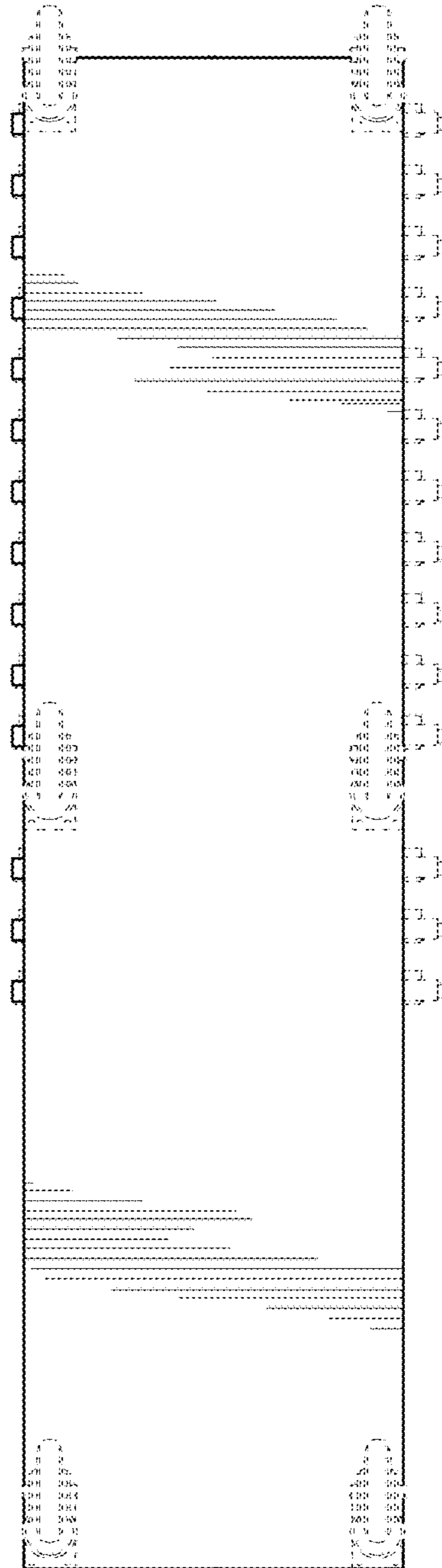

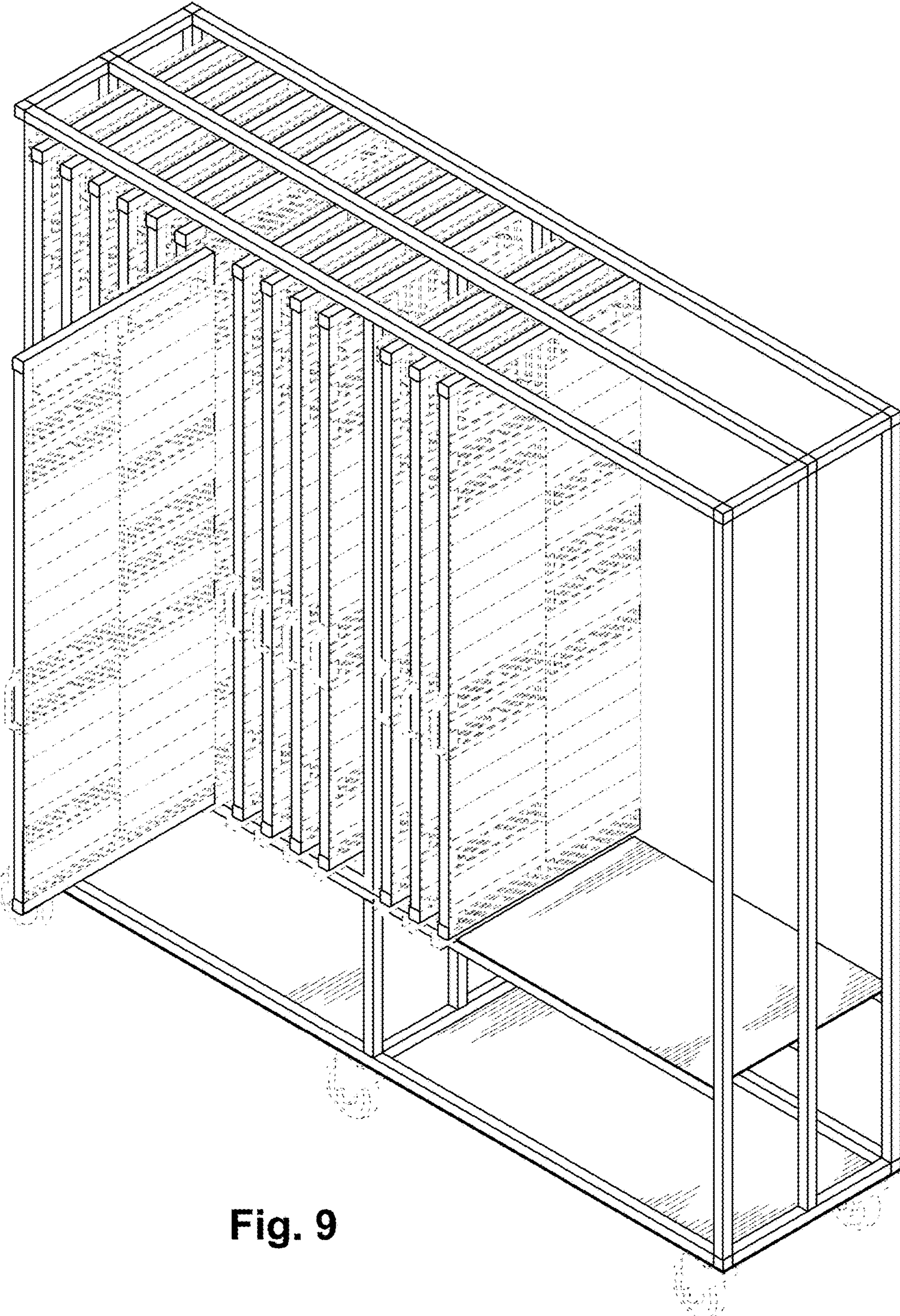

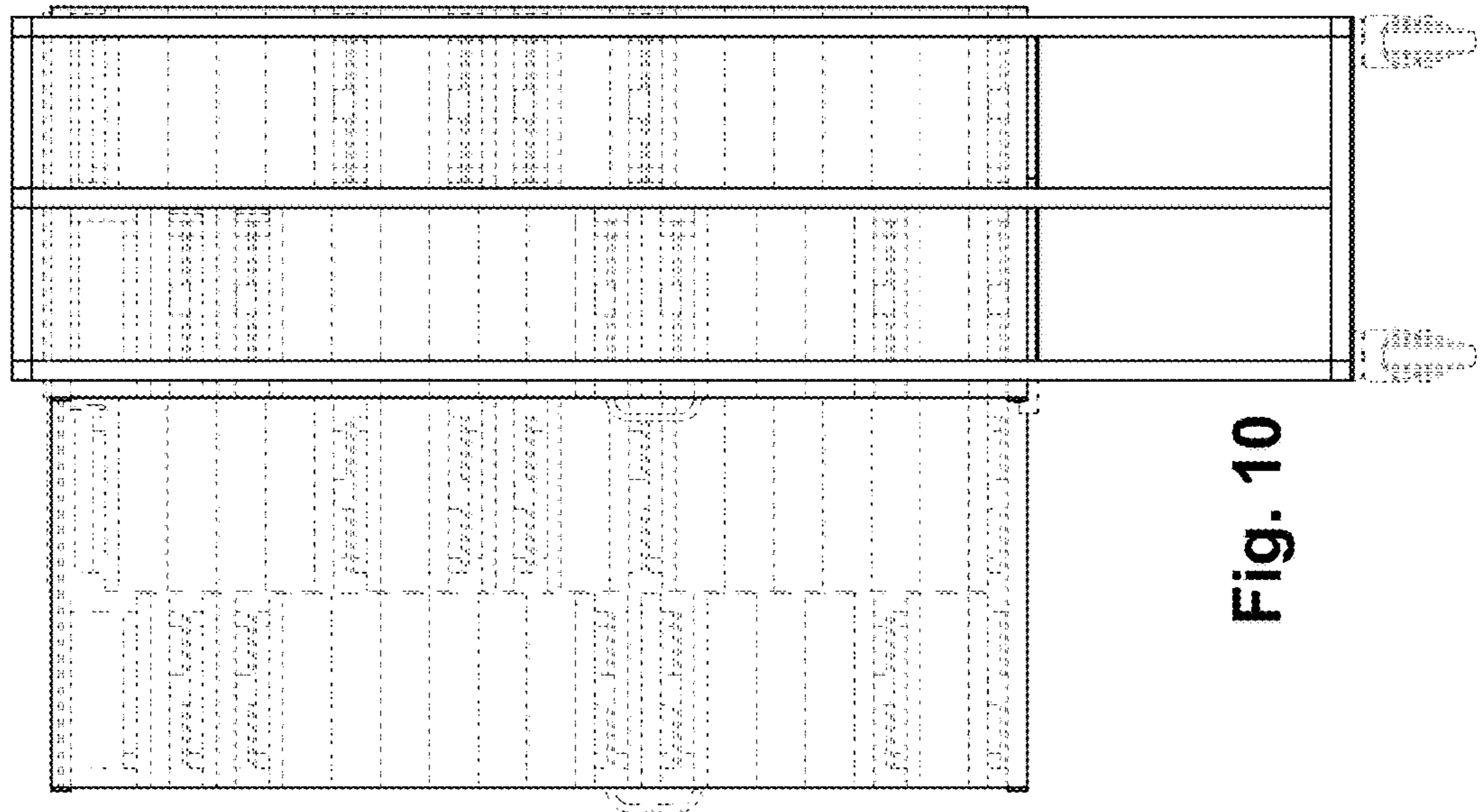

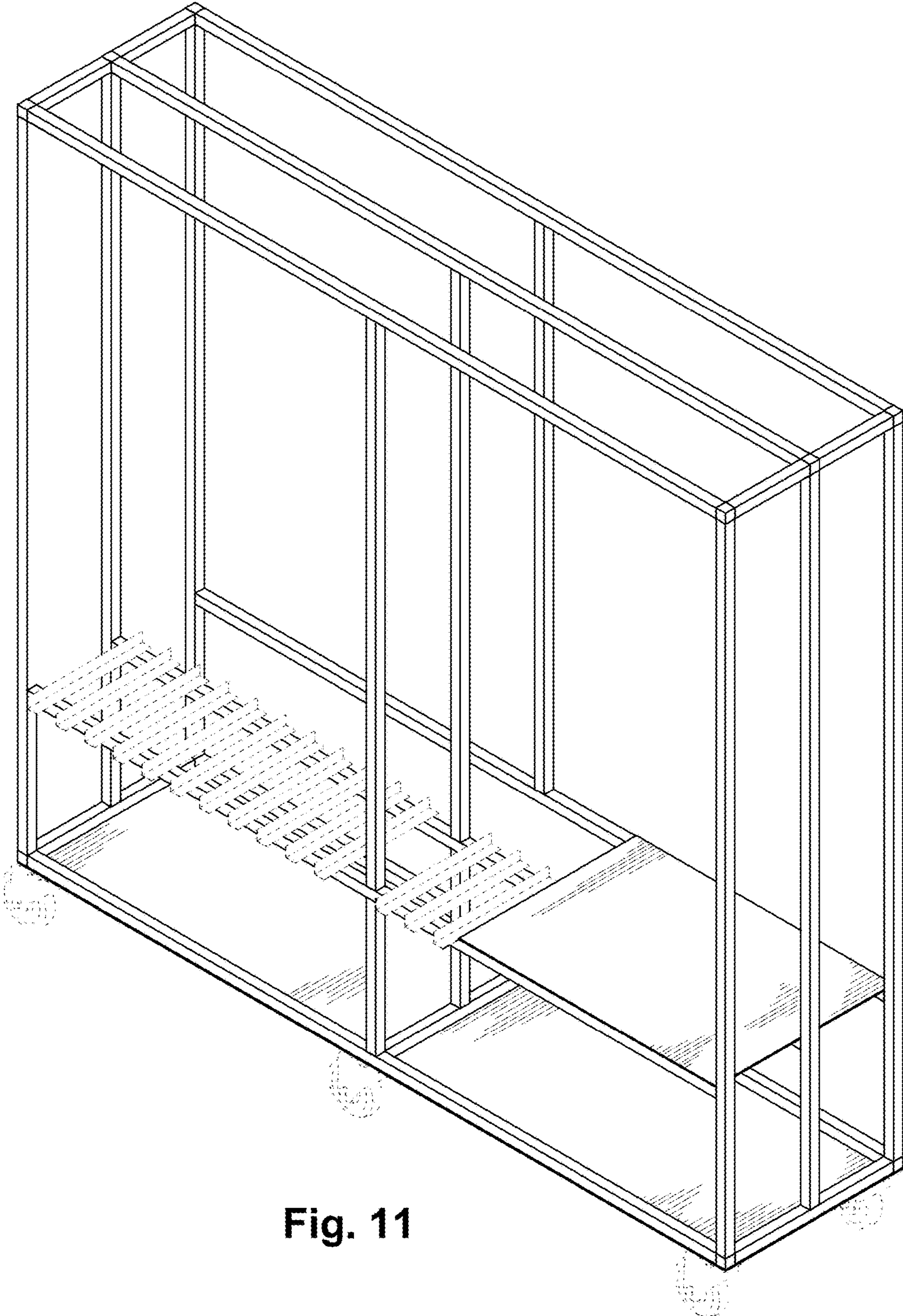

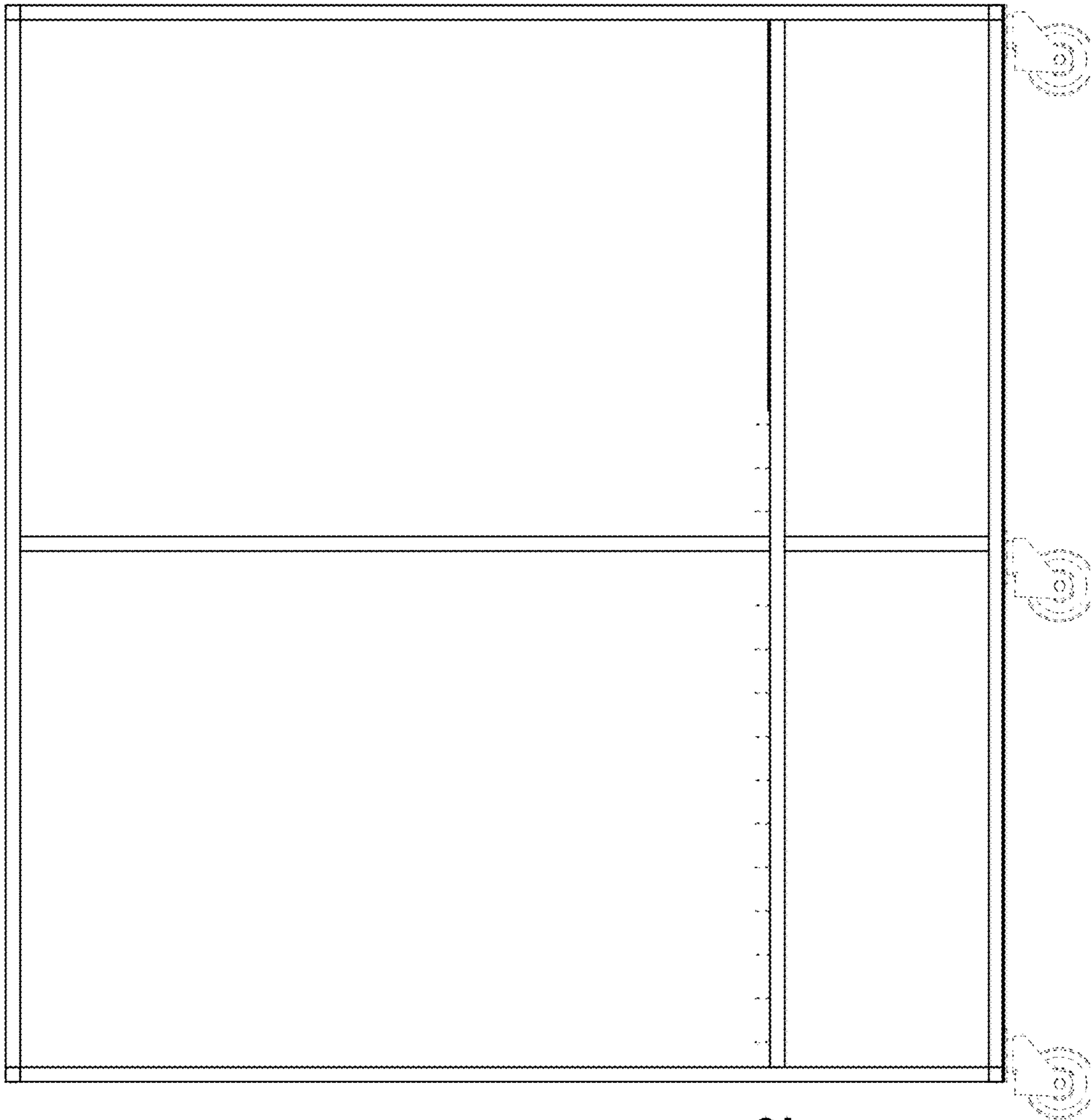

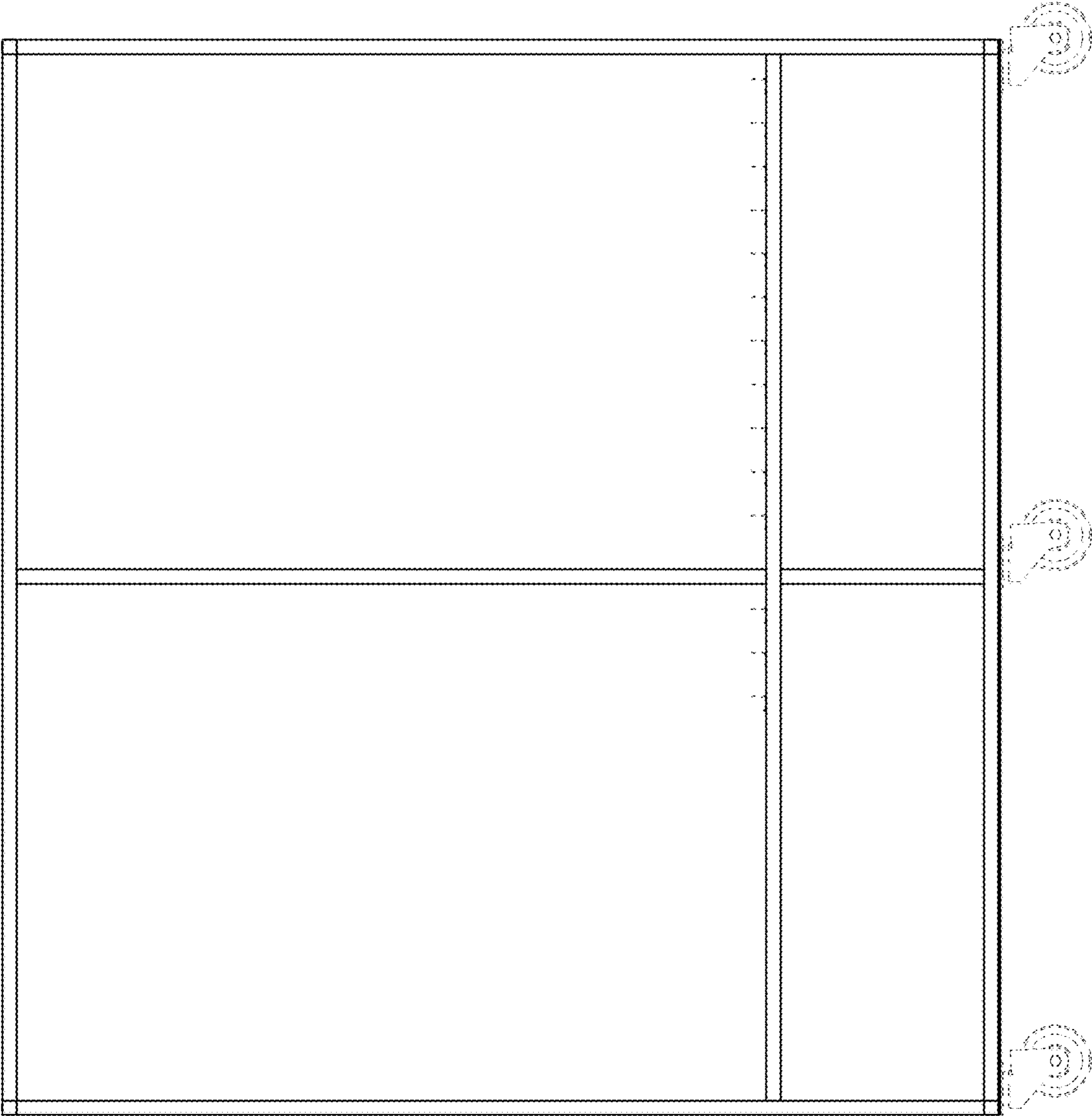

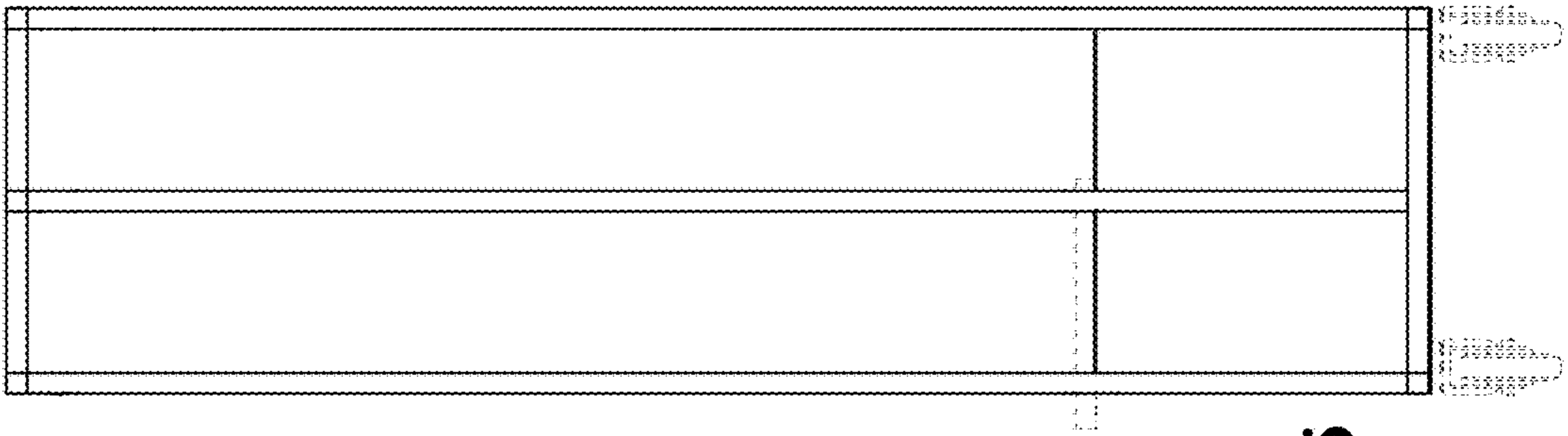

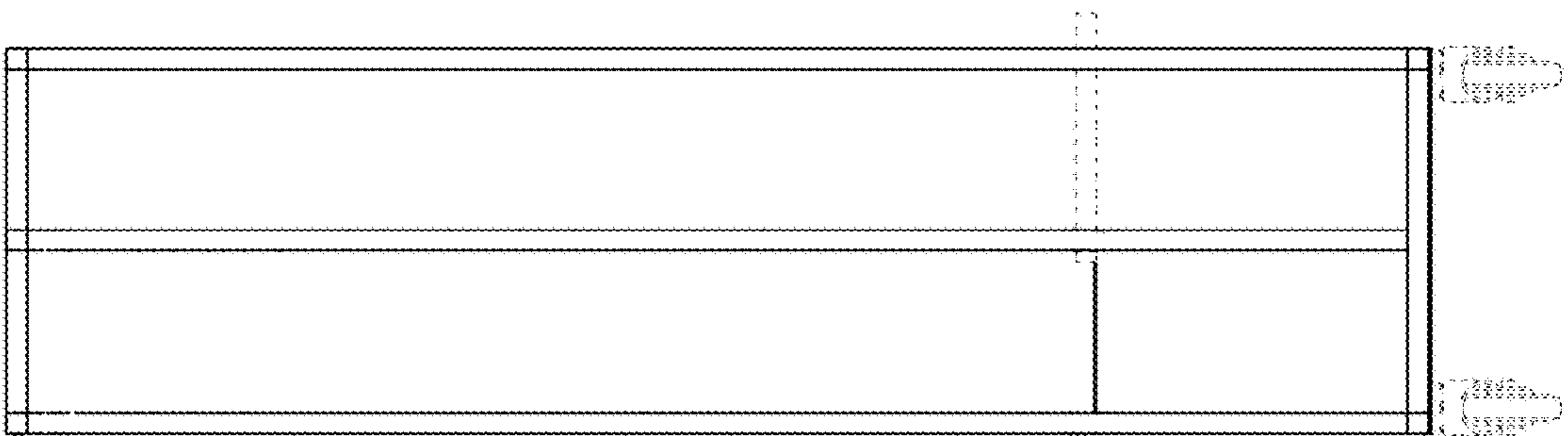

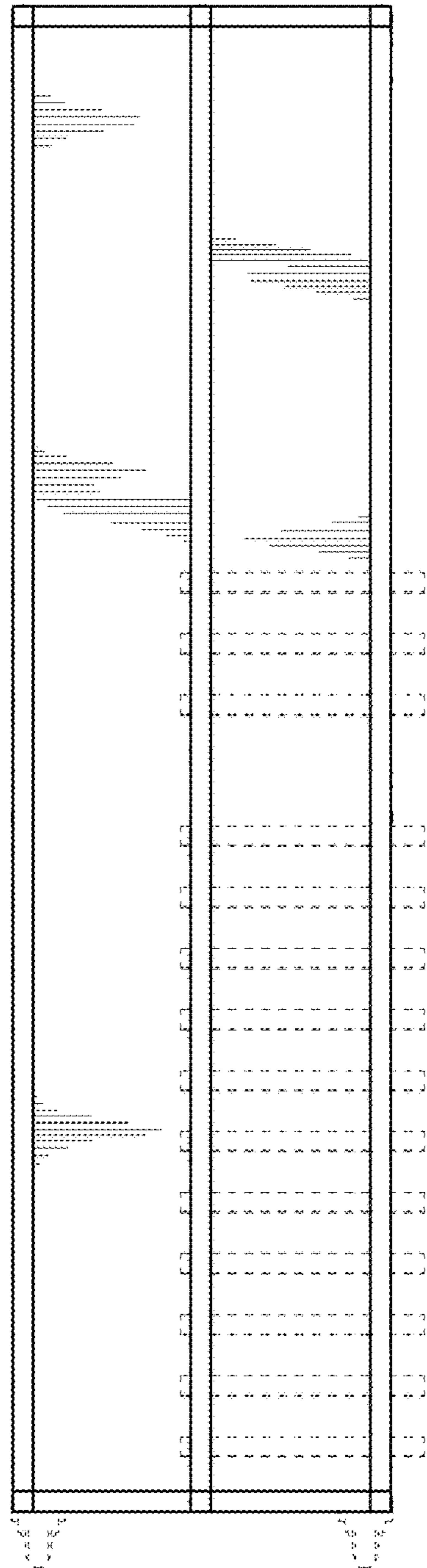

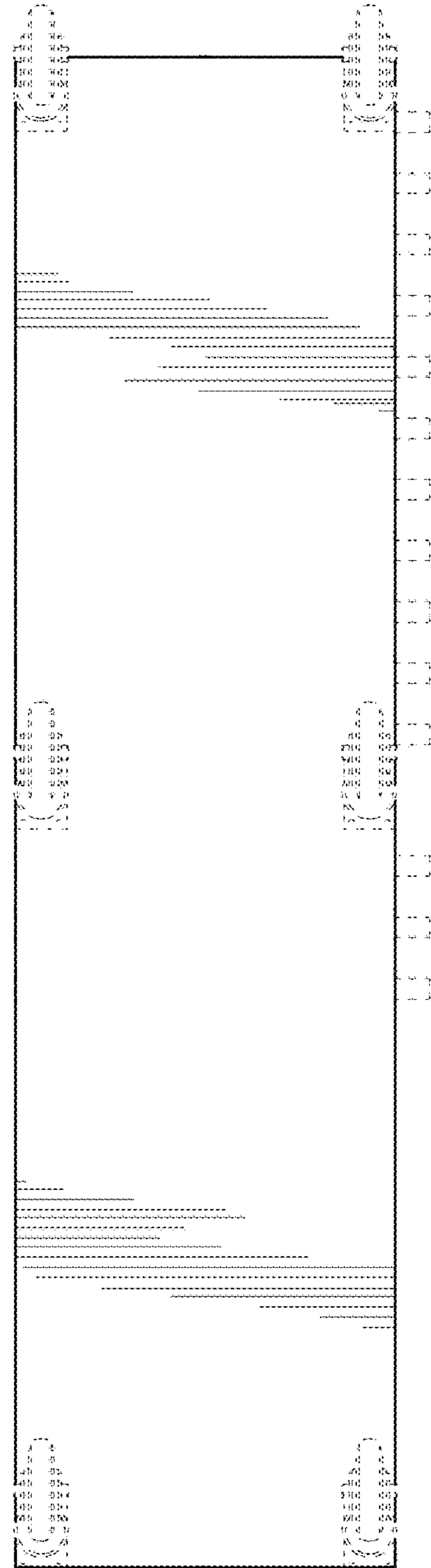

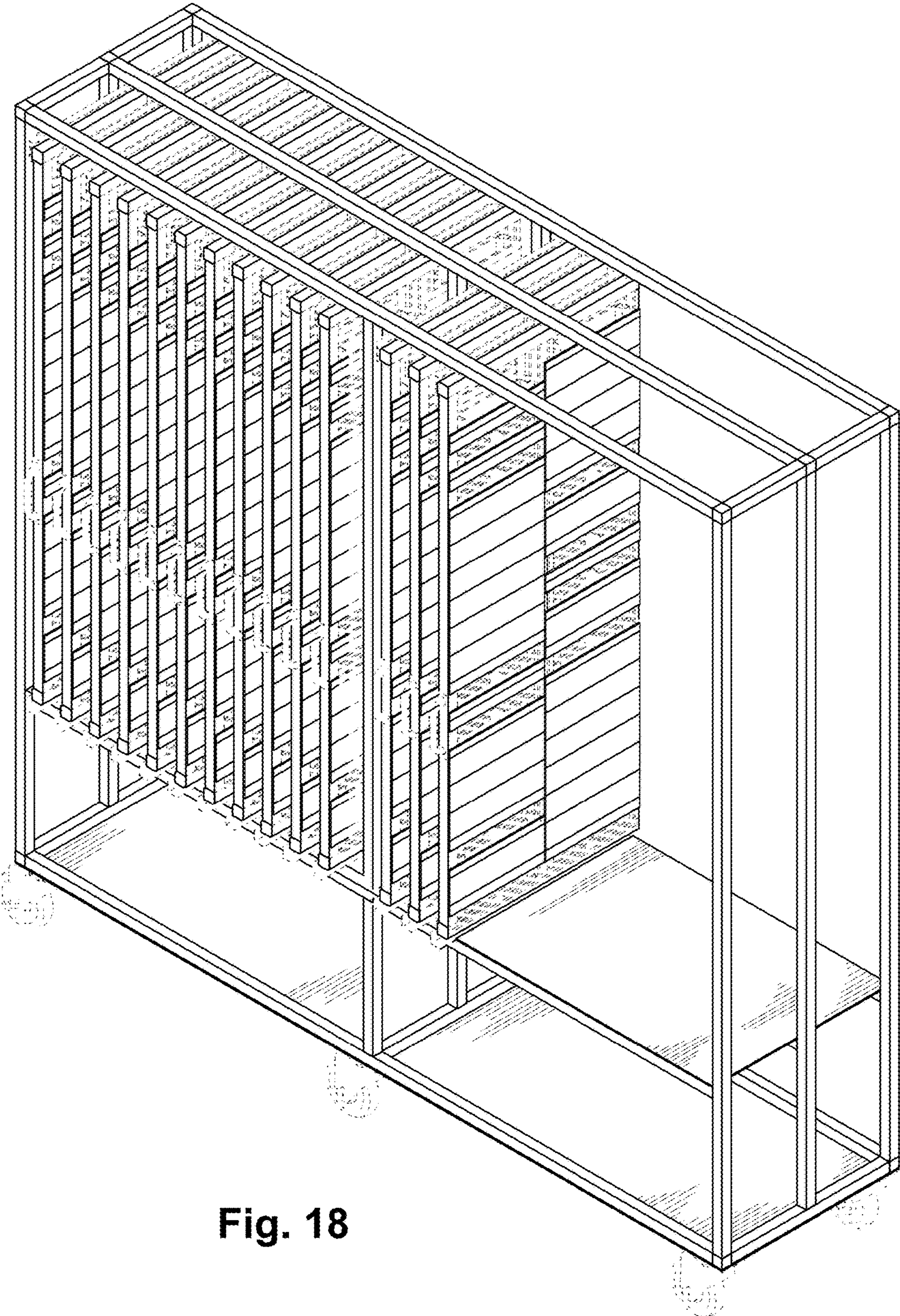

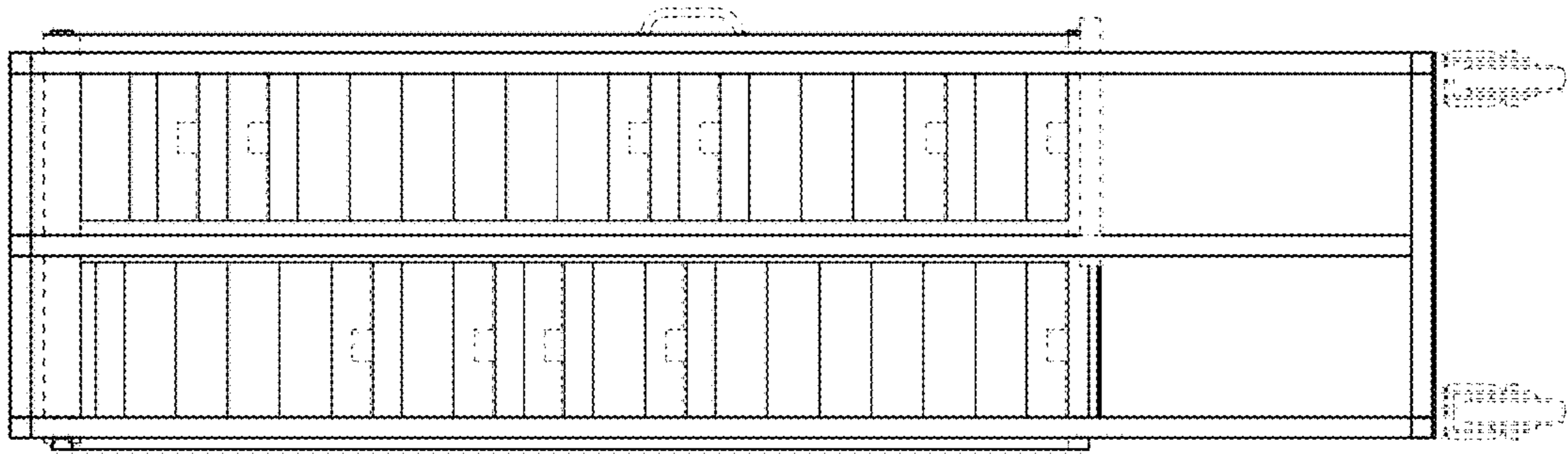

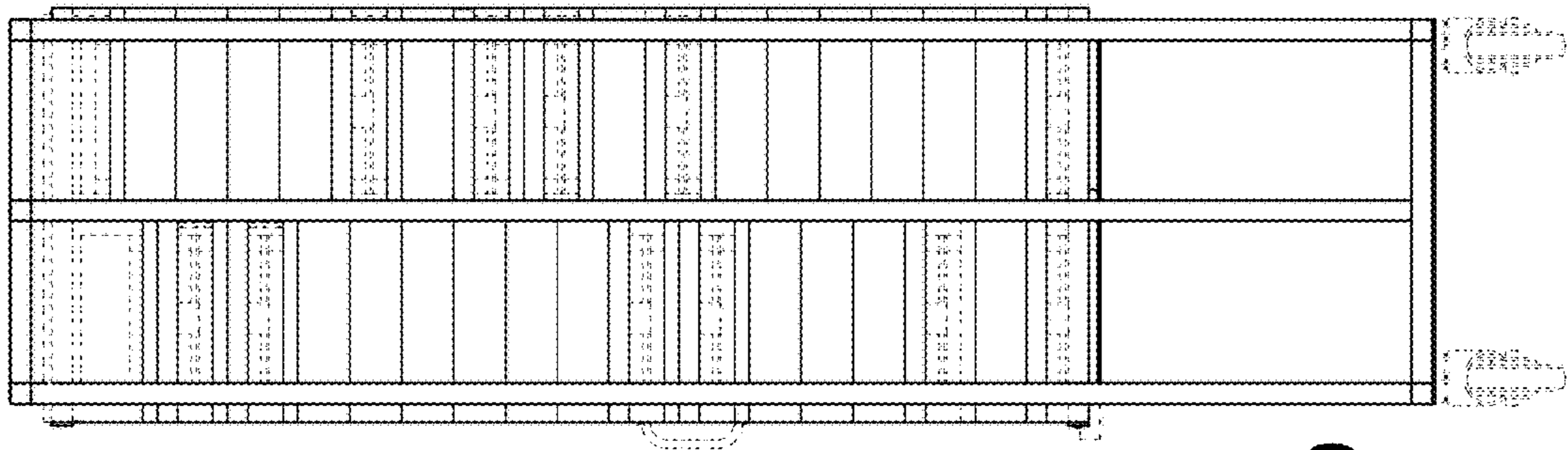

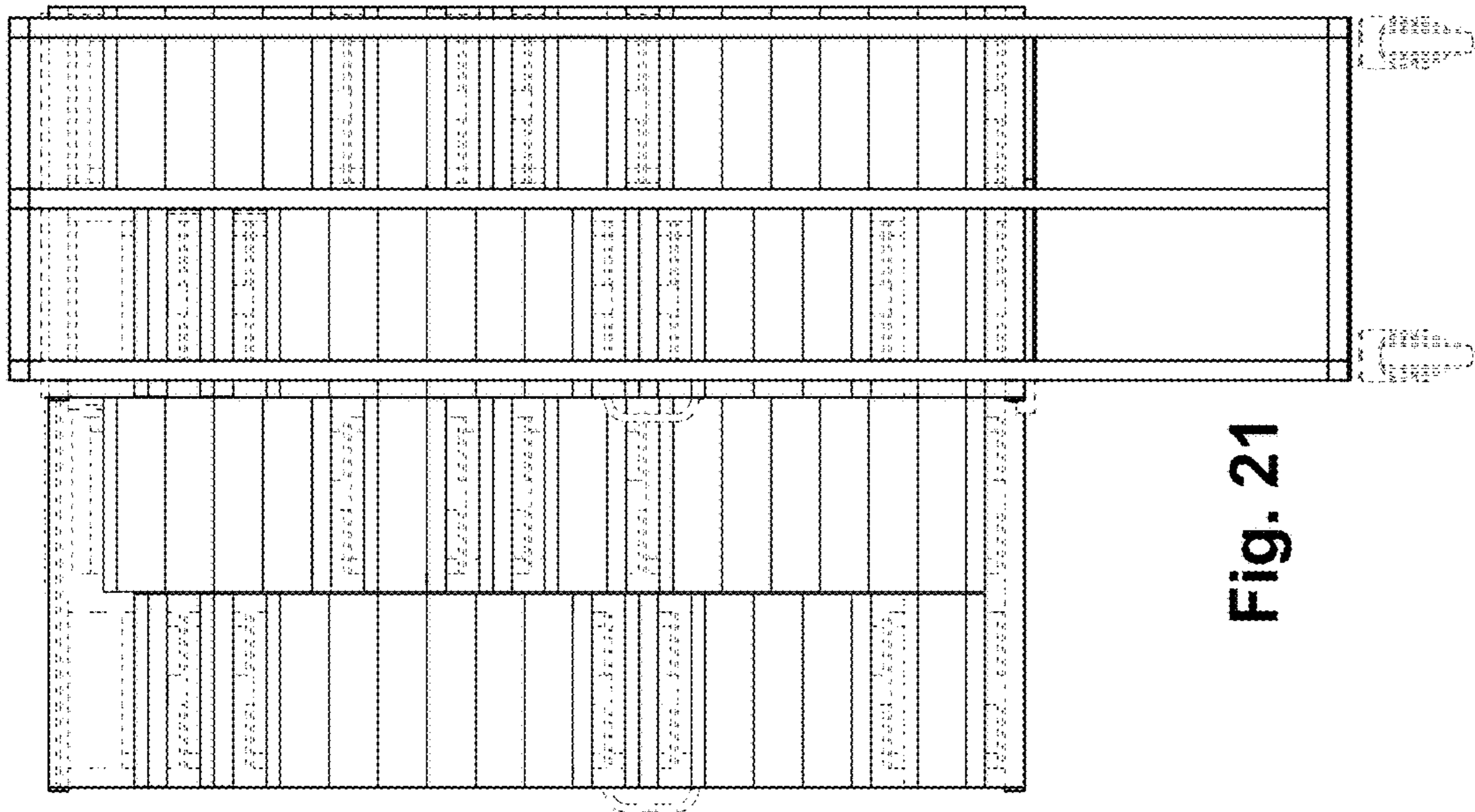

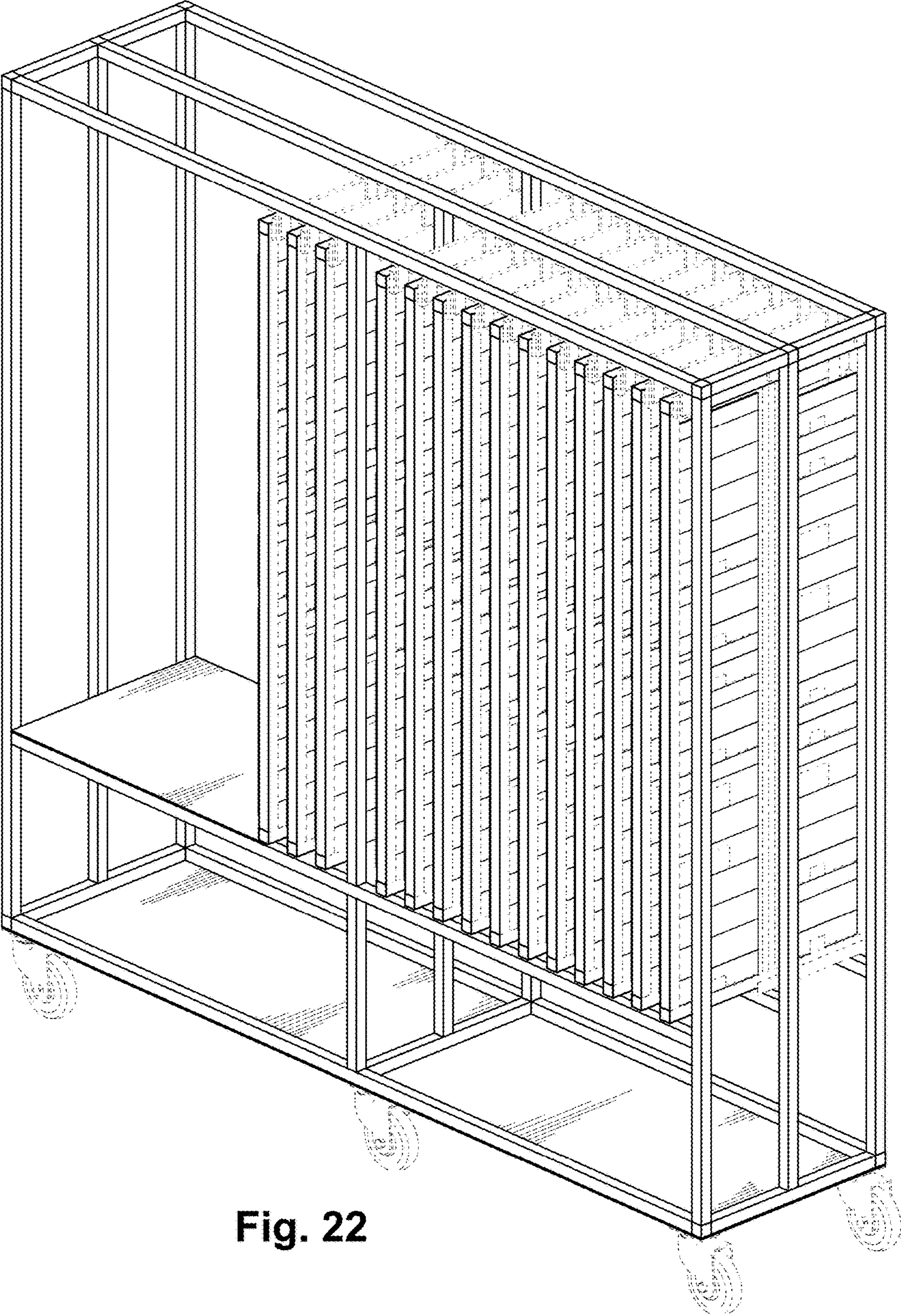
