DESCRIPTION

FIG. 1 is a front perspective view of a chair seat showing my new design;

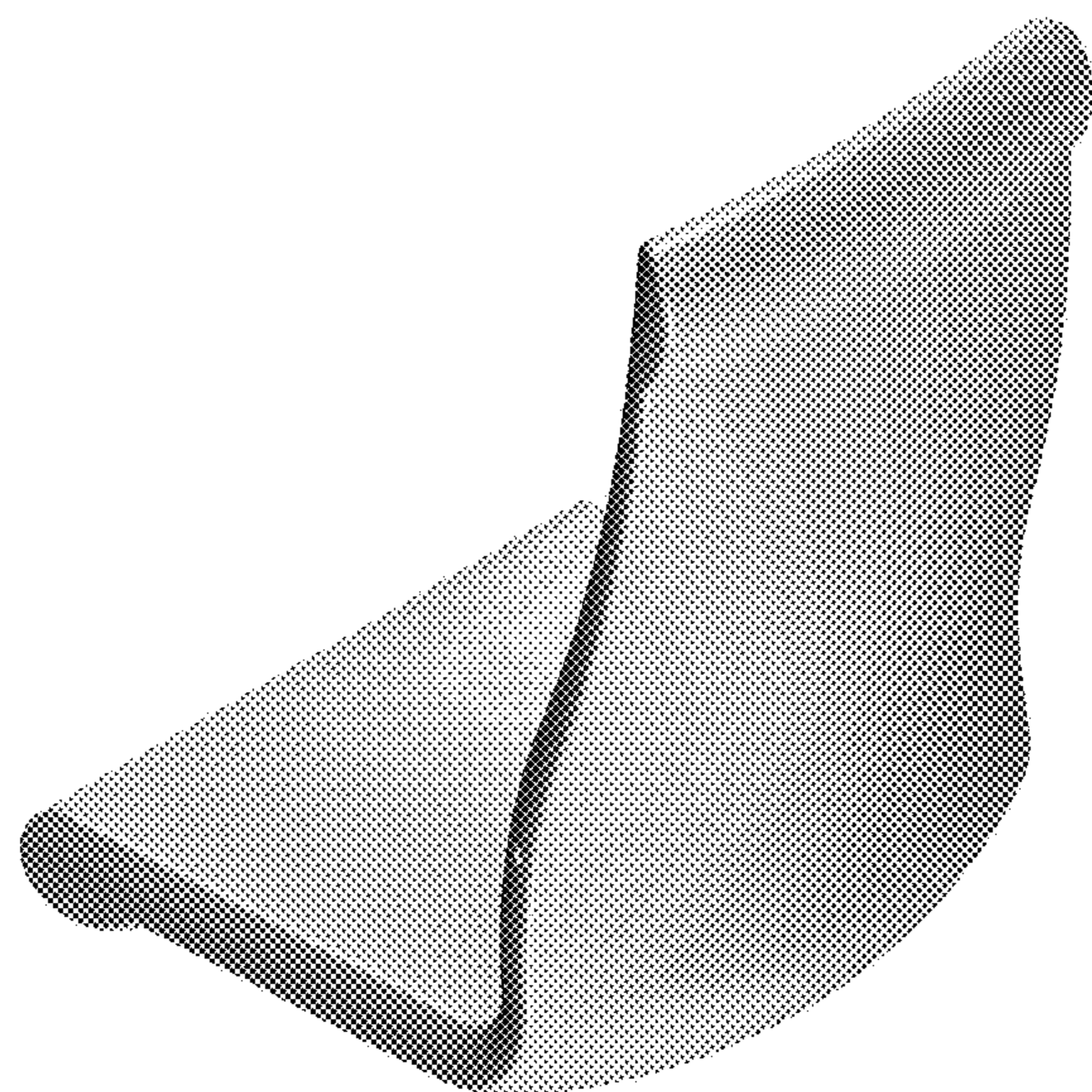
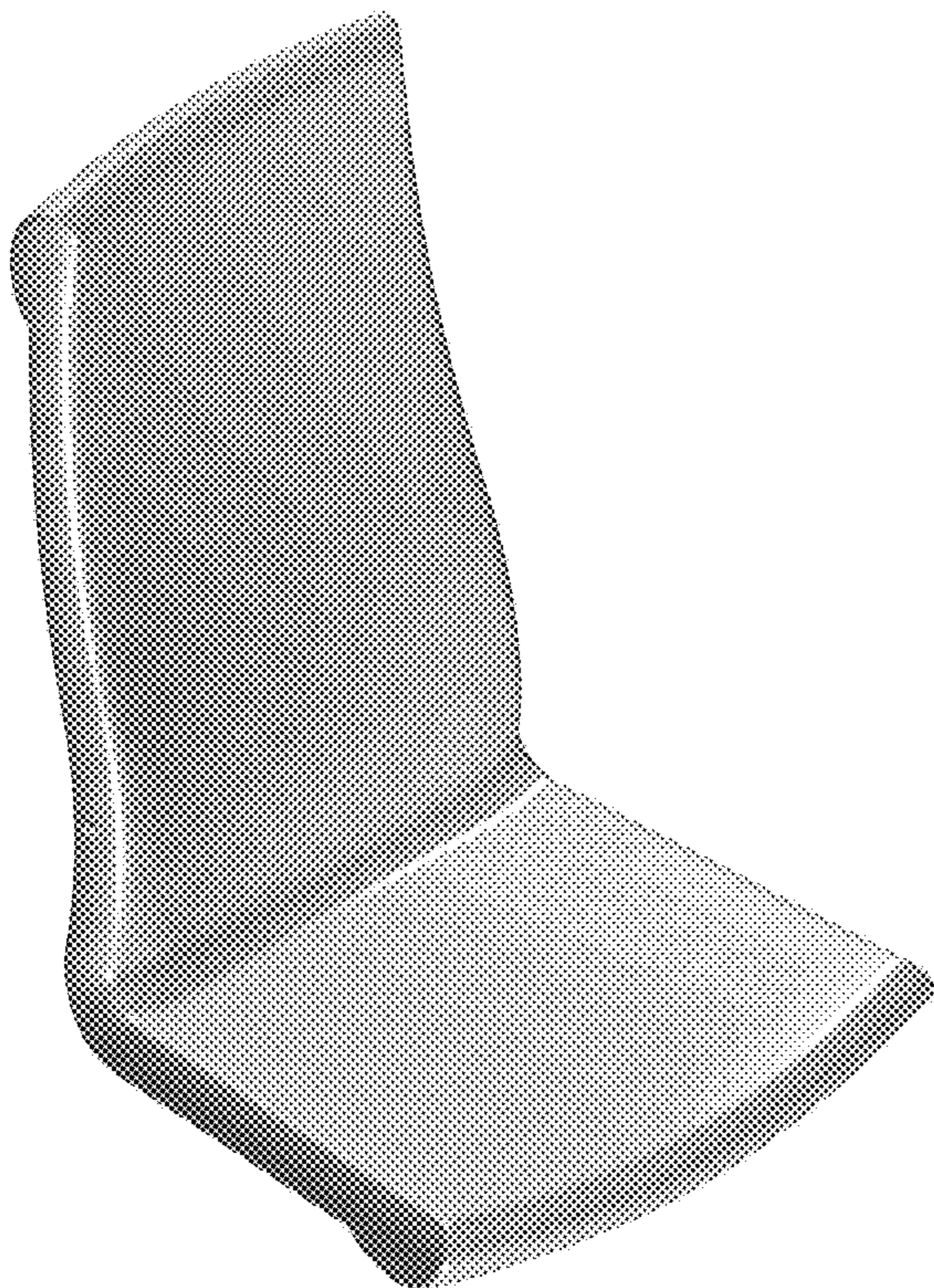

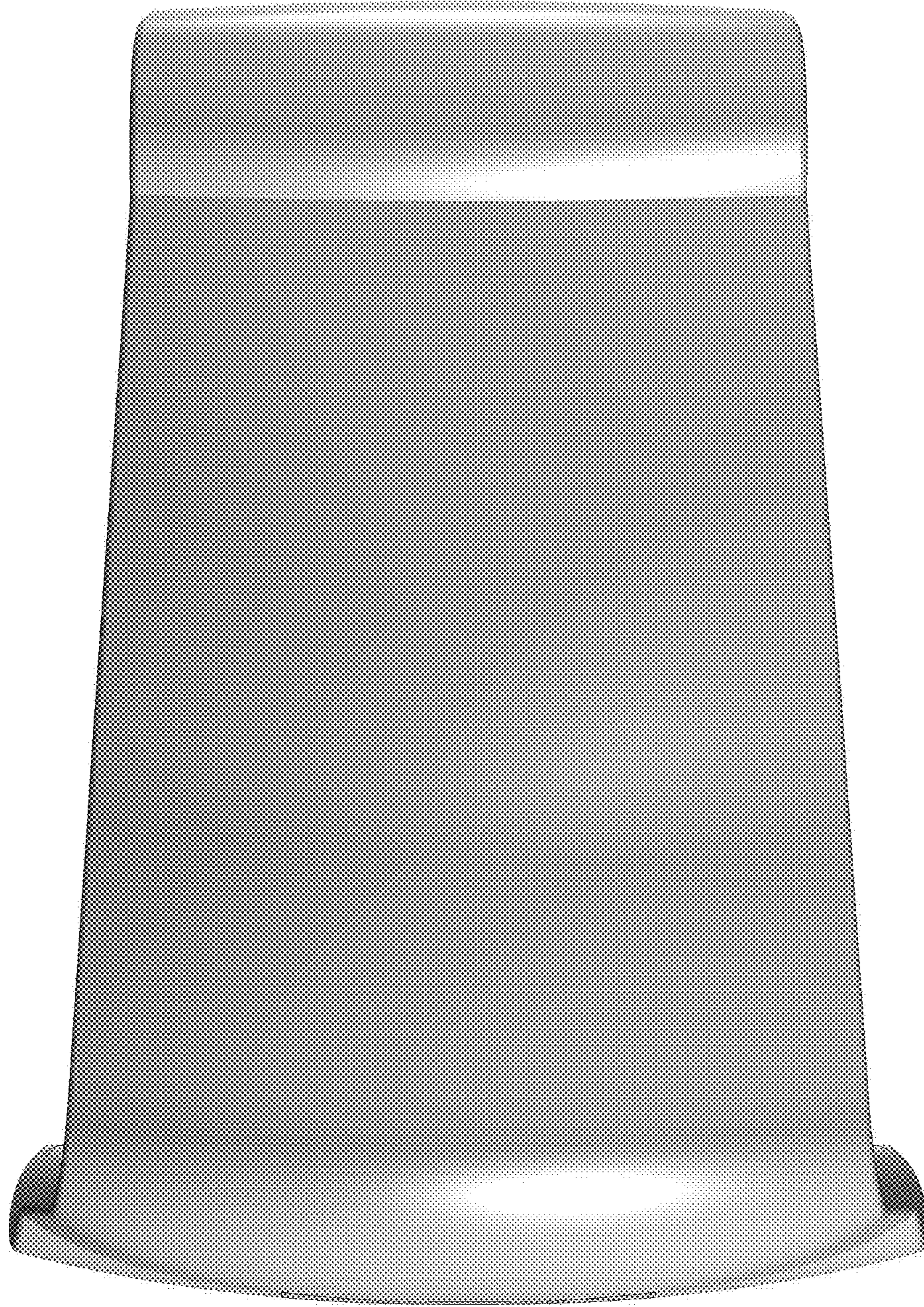

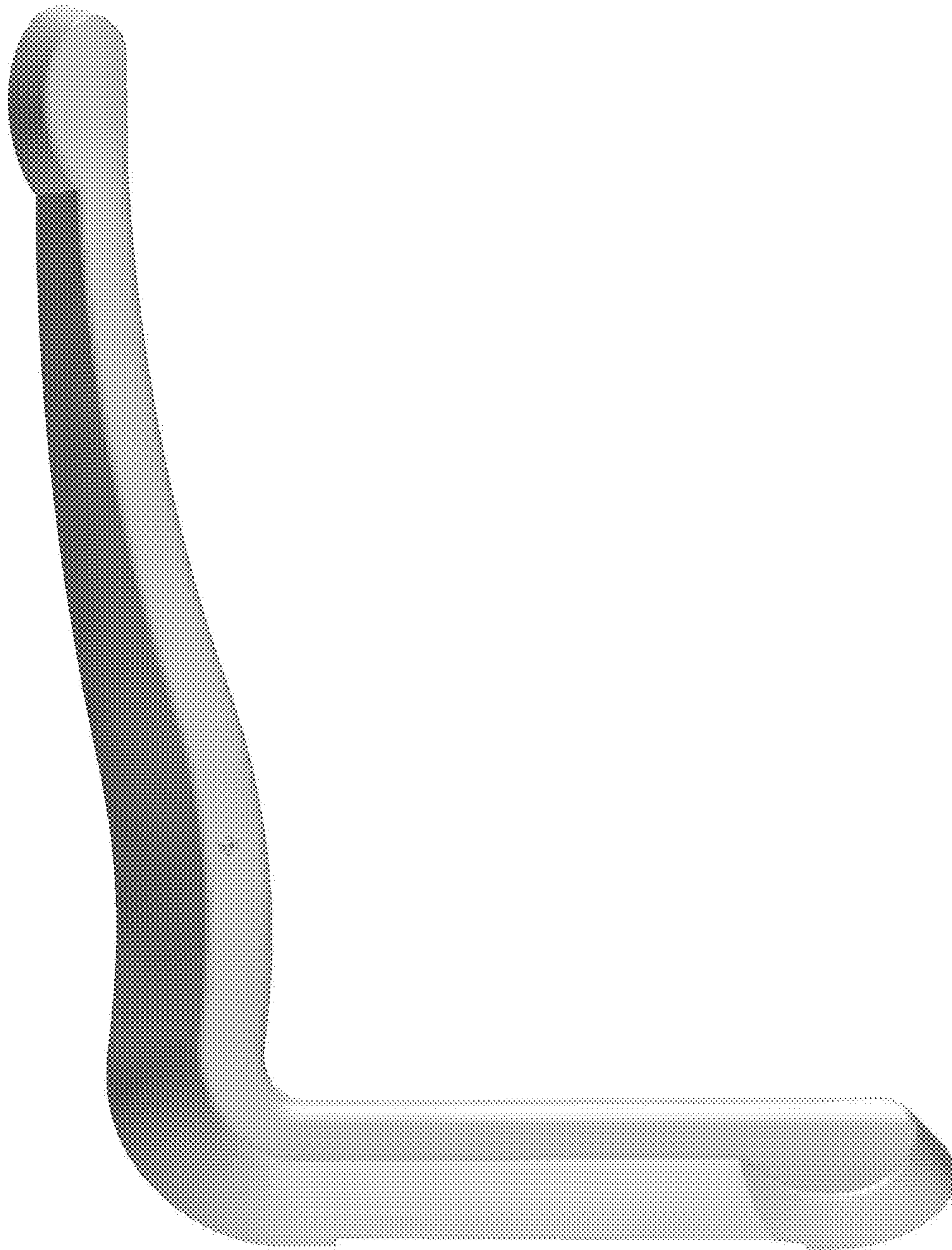
