FIG. 1 is a front perspective view of a bottle of the present invention;

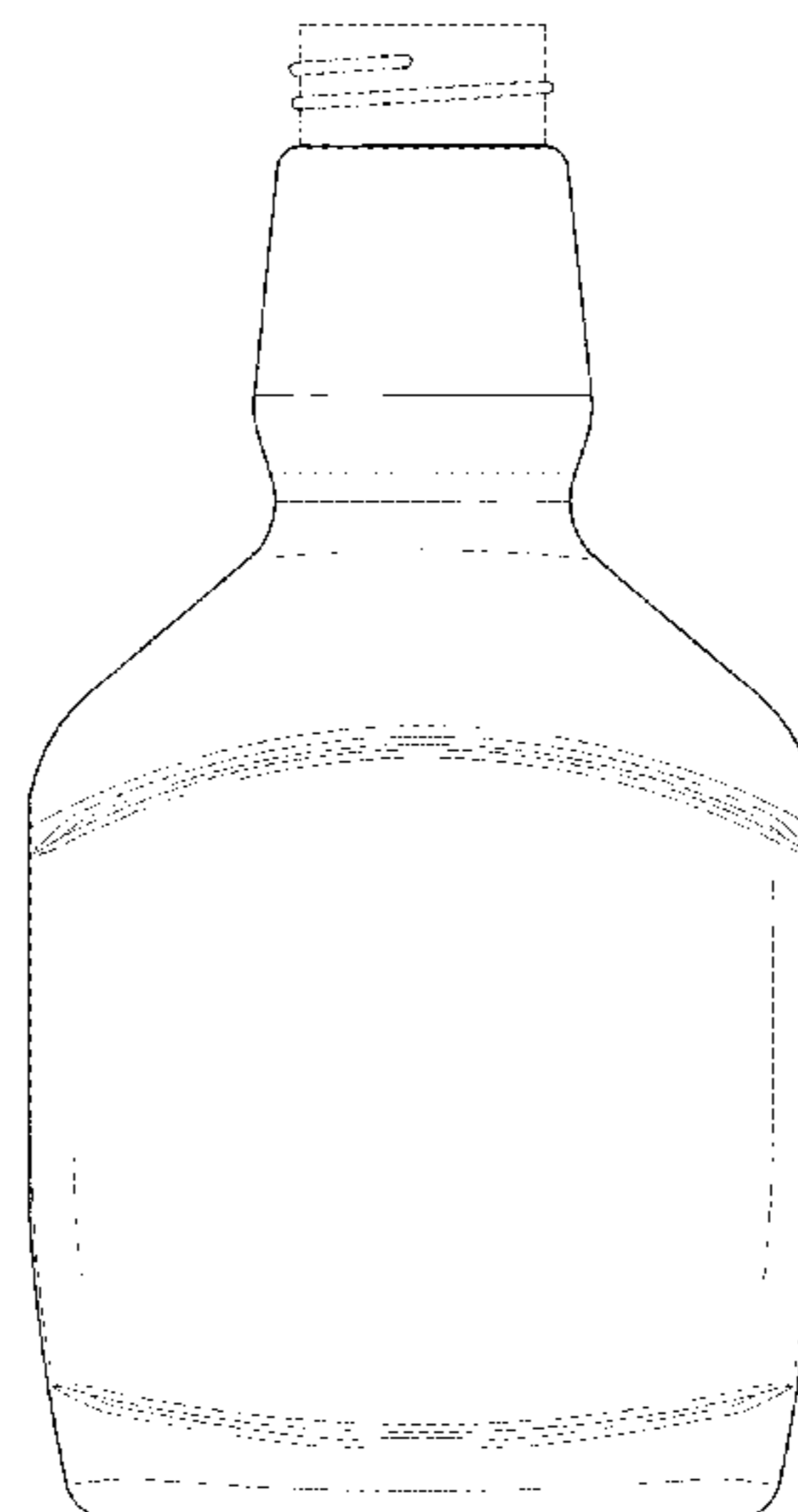
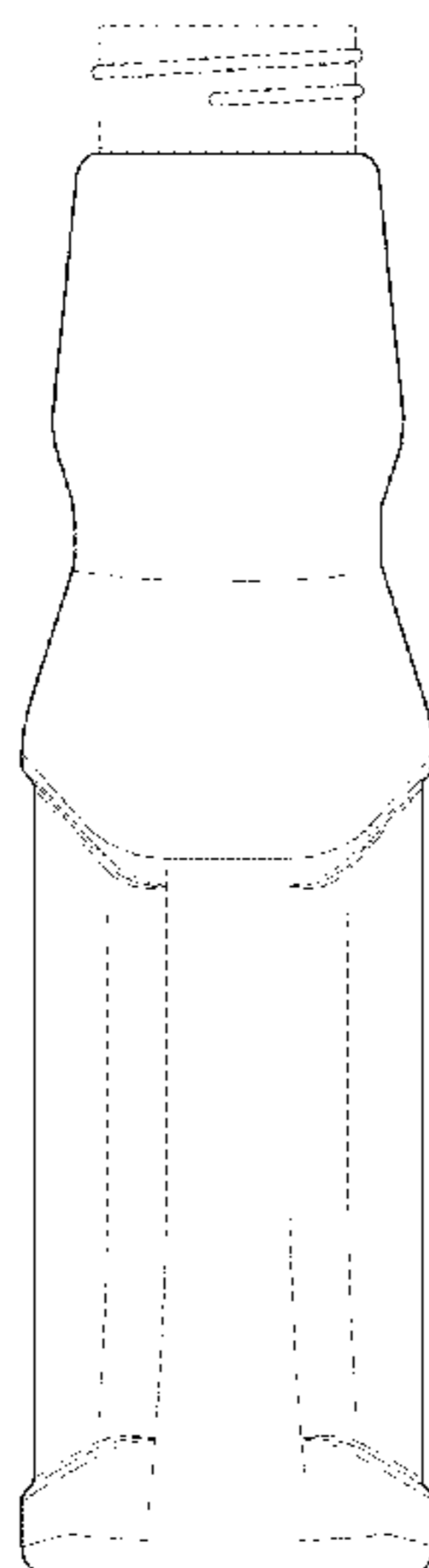
FIG. 2 is a left side view, the right side being a mirror image thereof;

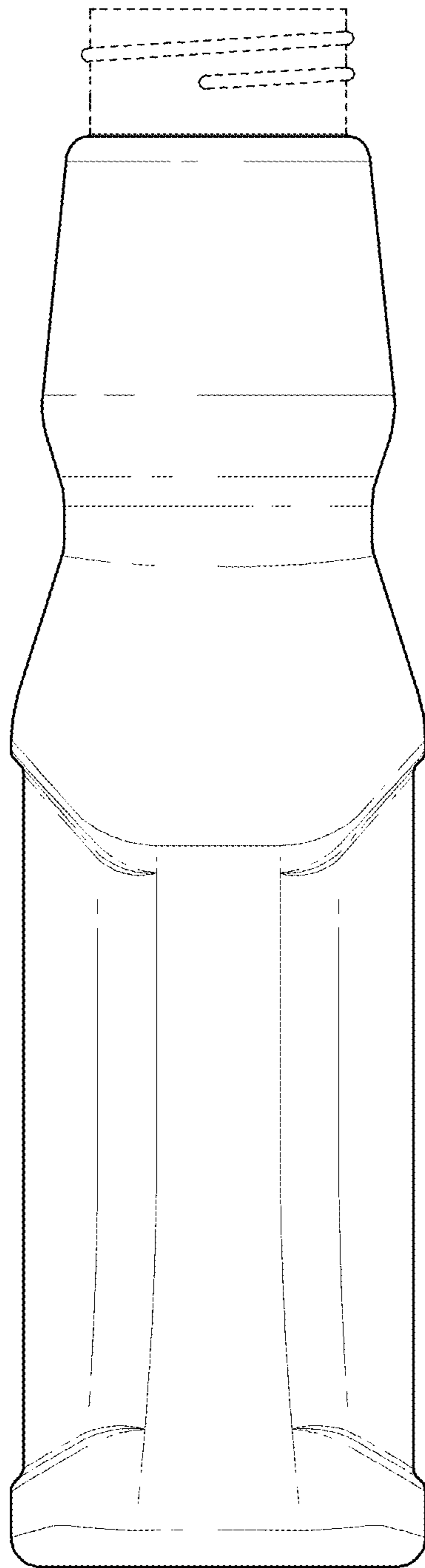

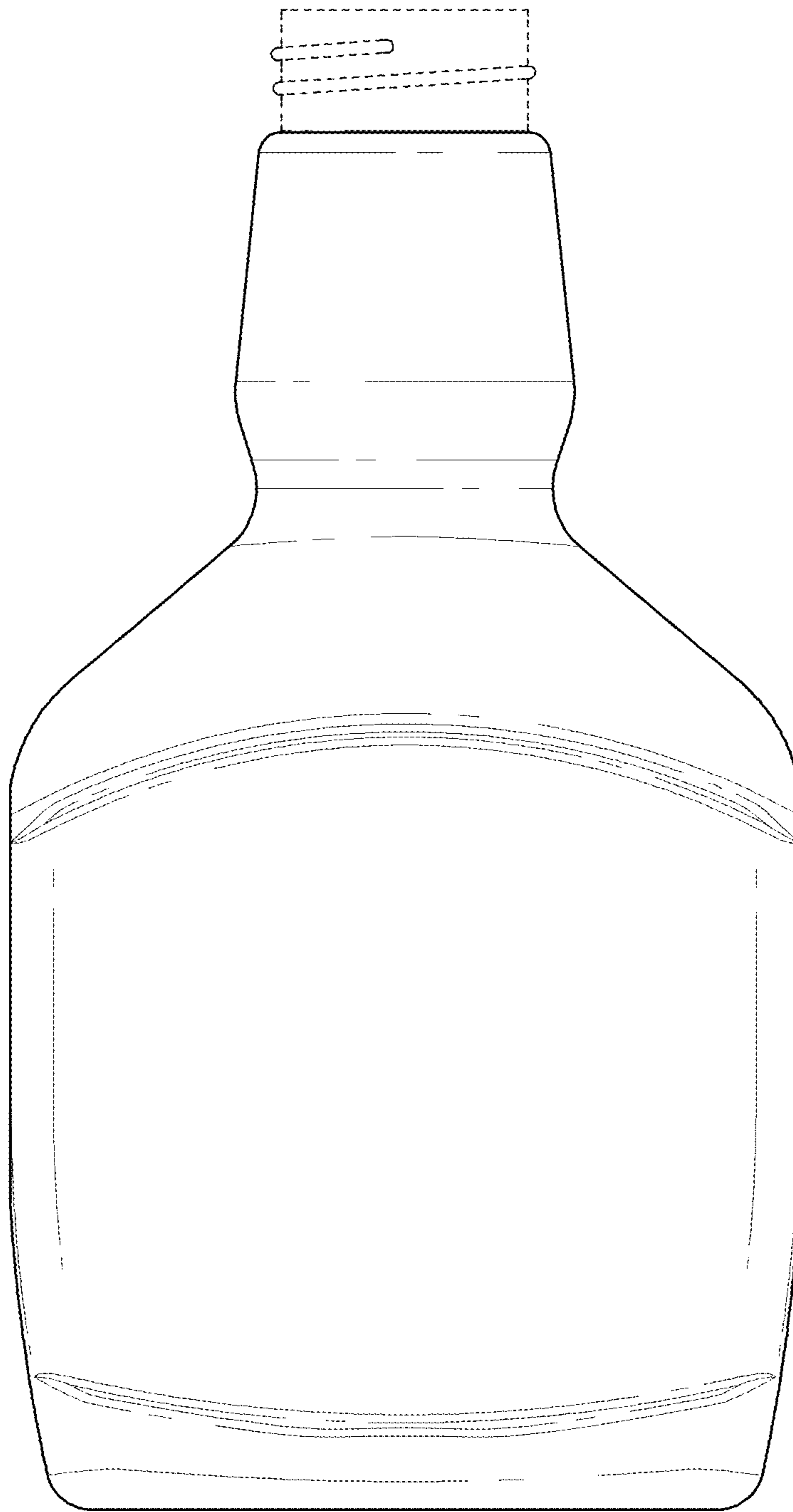

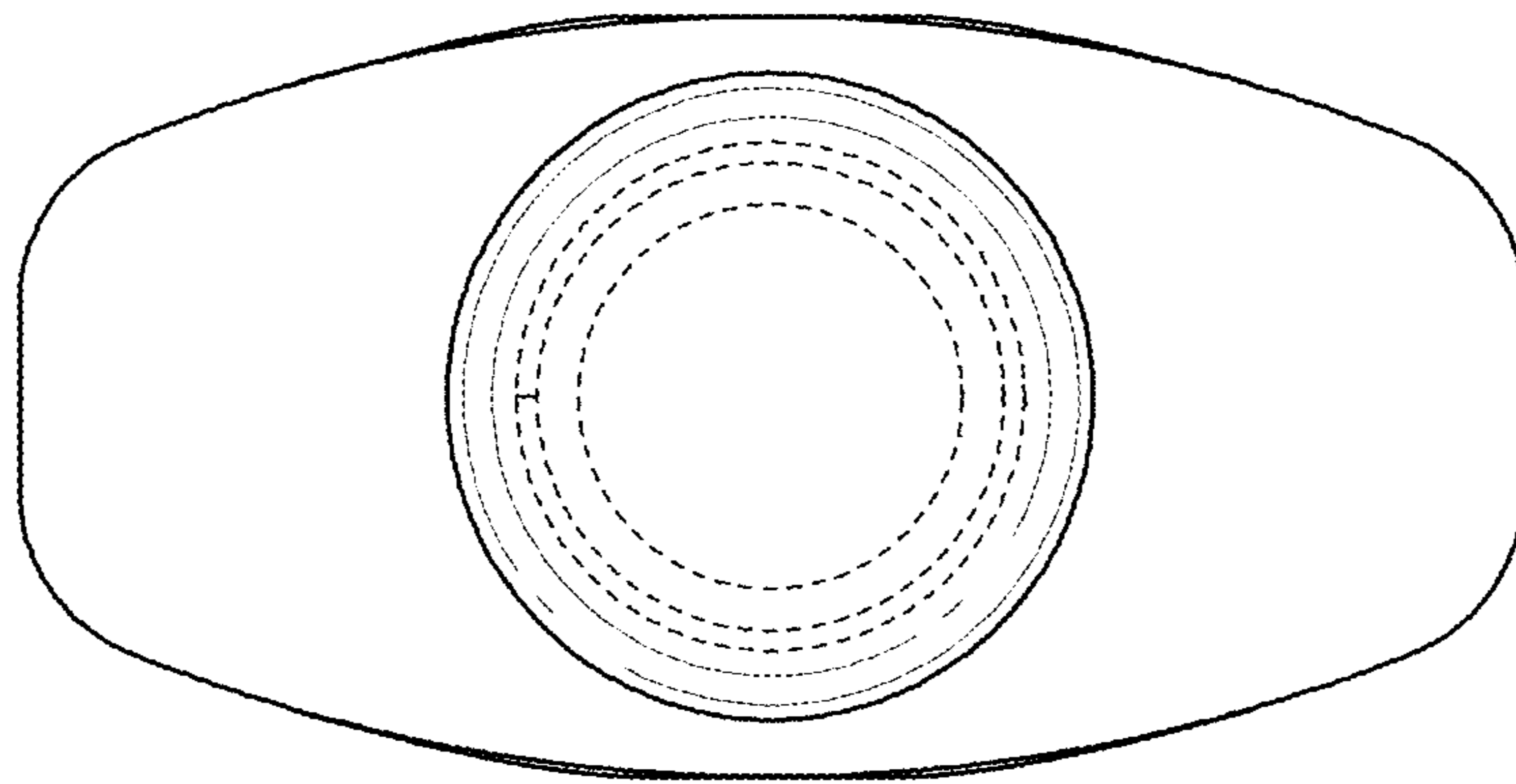
