The ornamental design for a bottle with cap, substantially as shown and described.

DESCRIPTION

FIG. 4 is a side elevation view thereof;

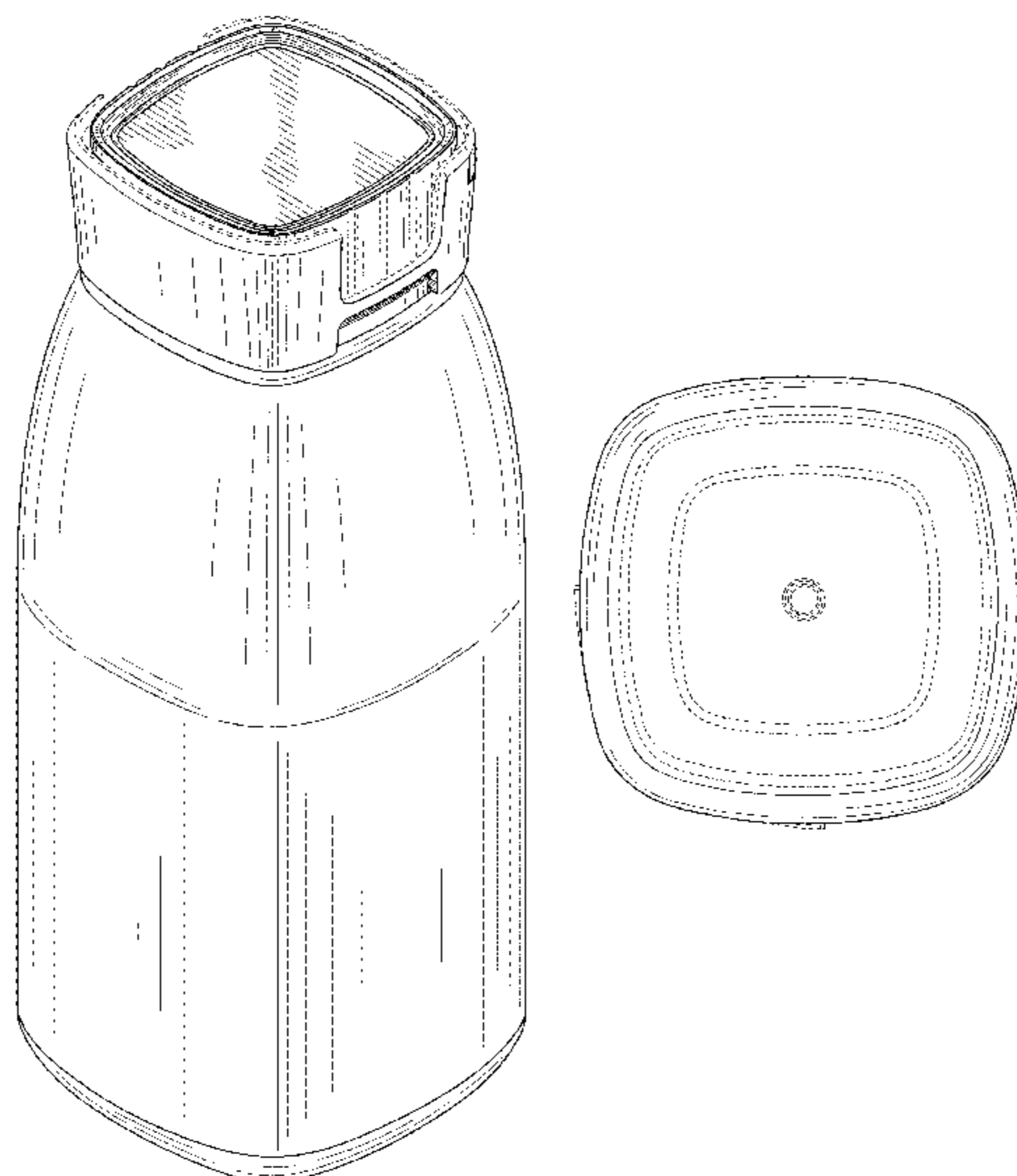
FIG. 5 is an opposing side elevation view thereof;

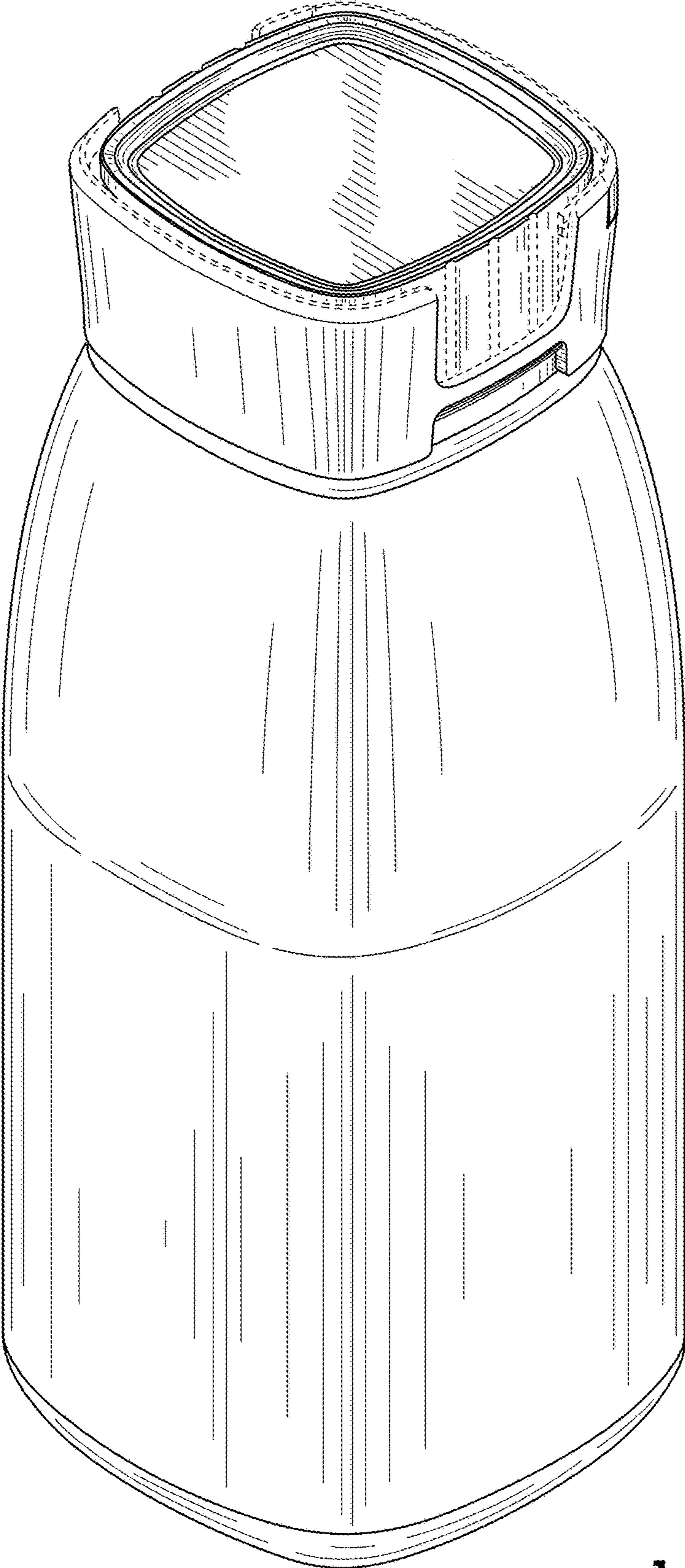

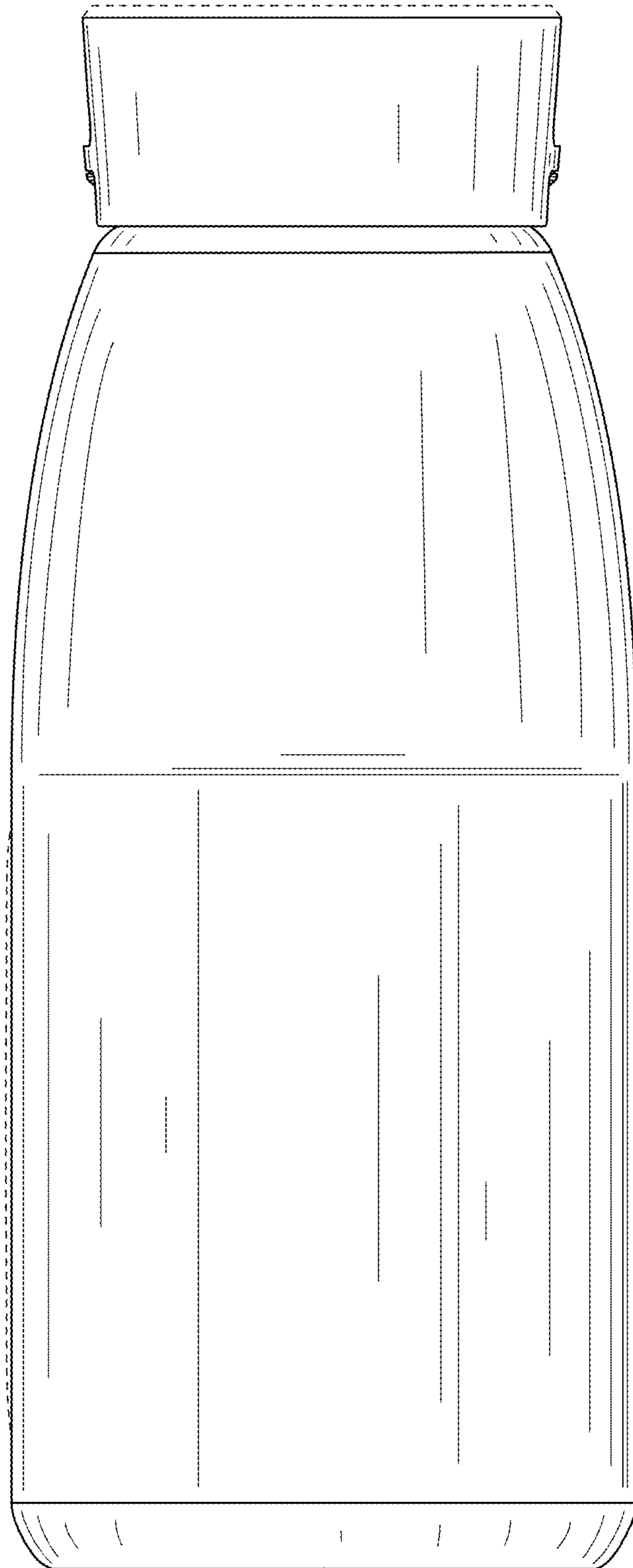

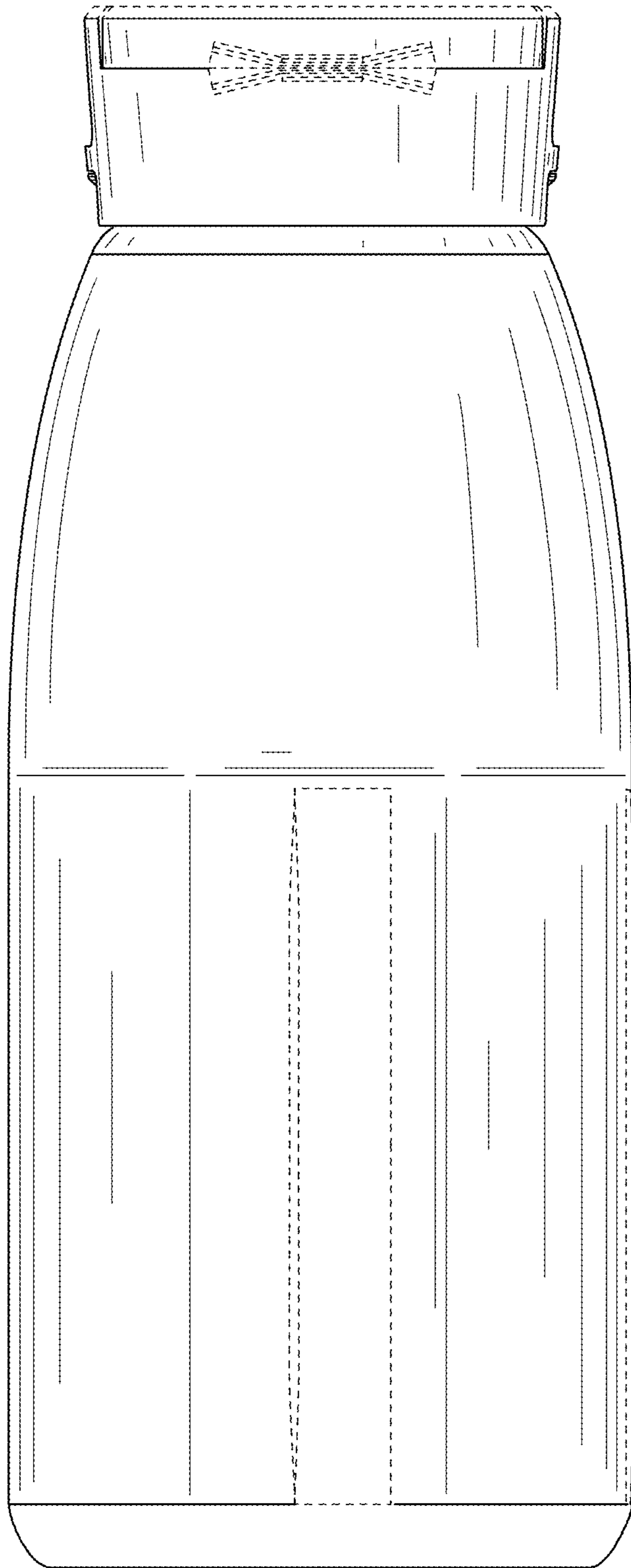

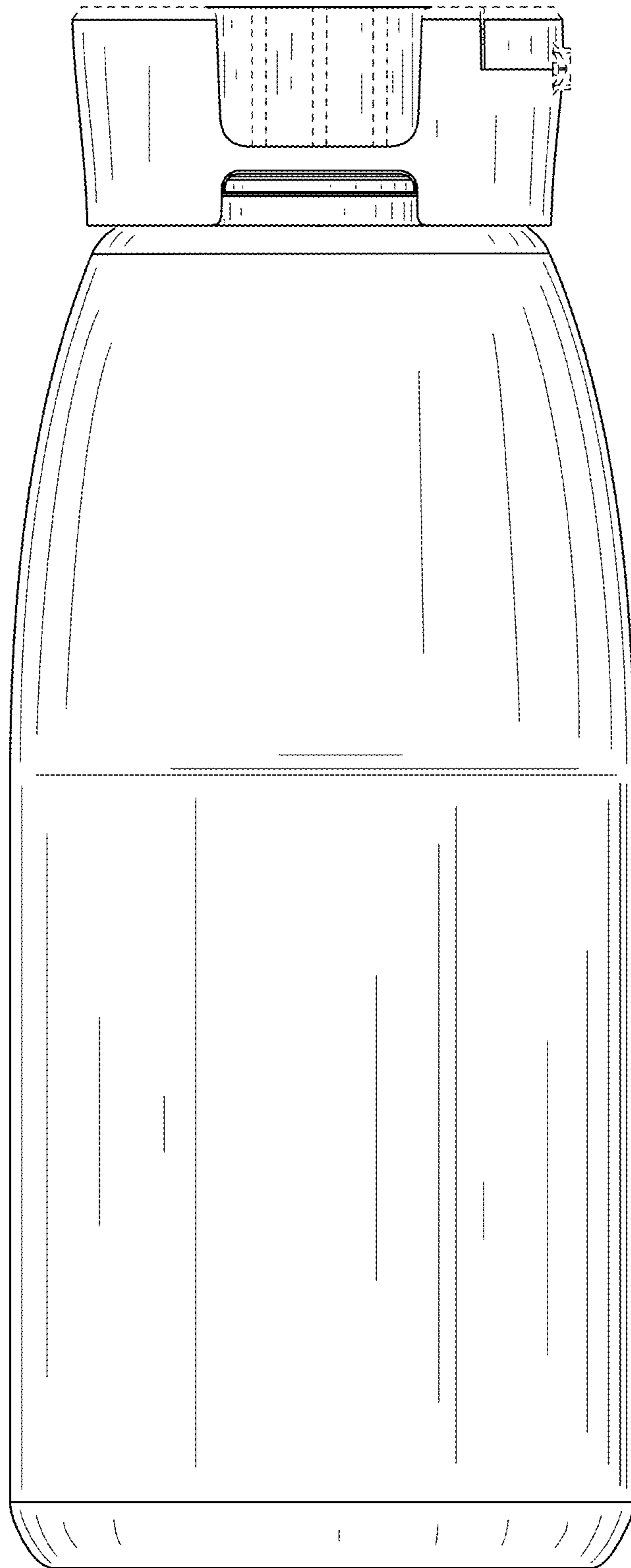

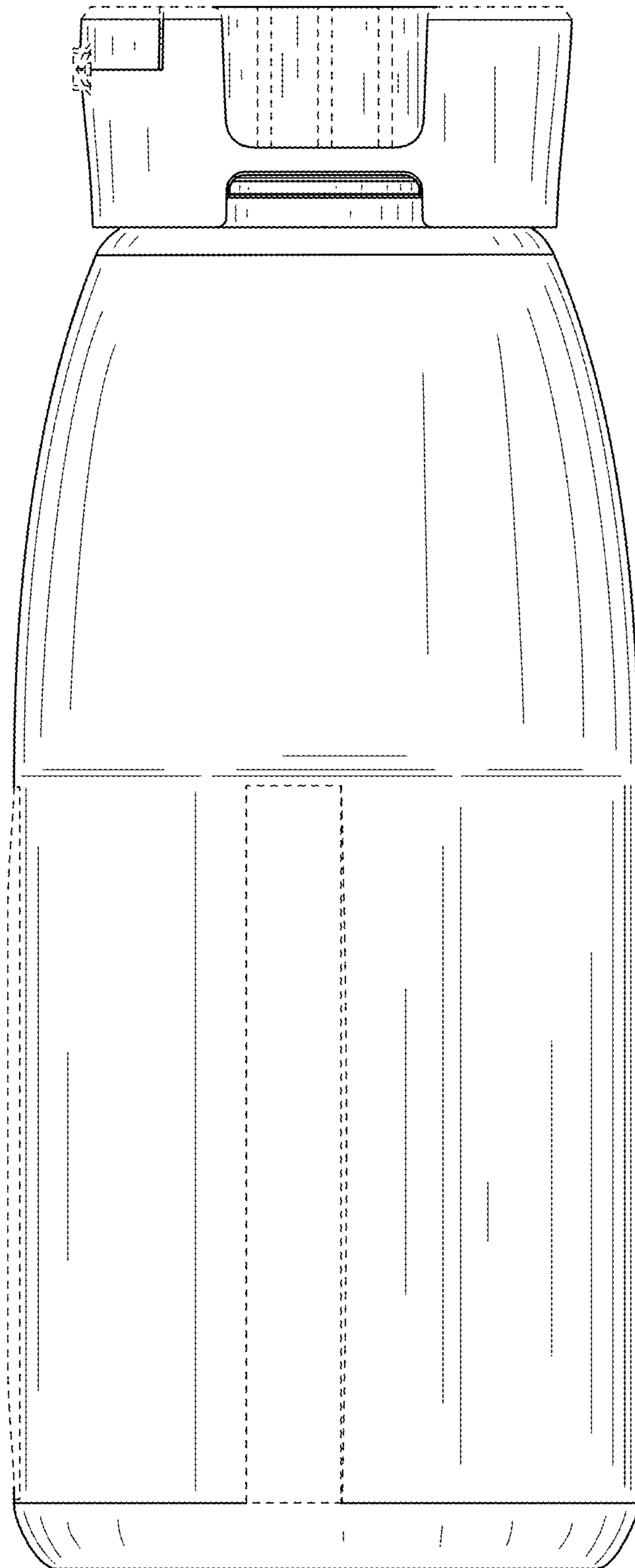

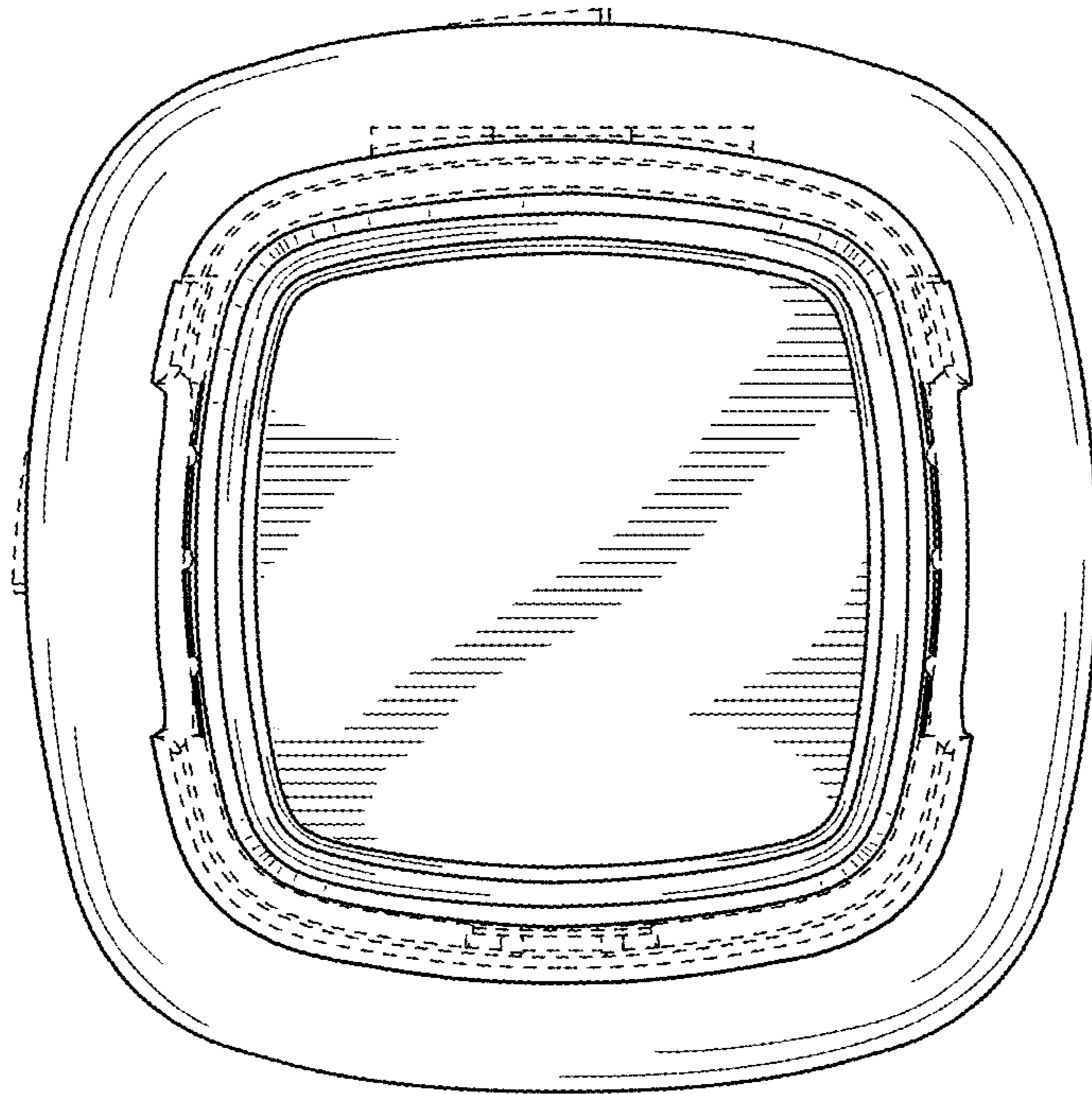

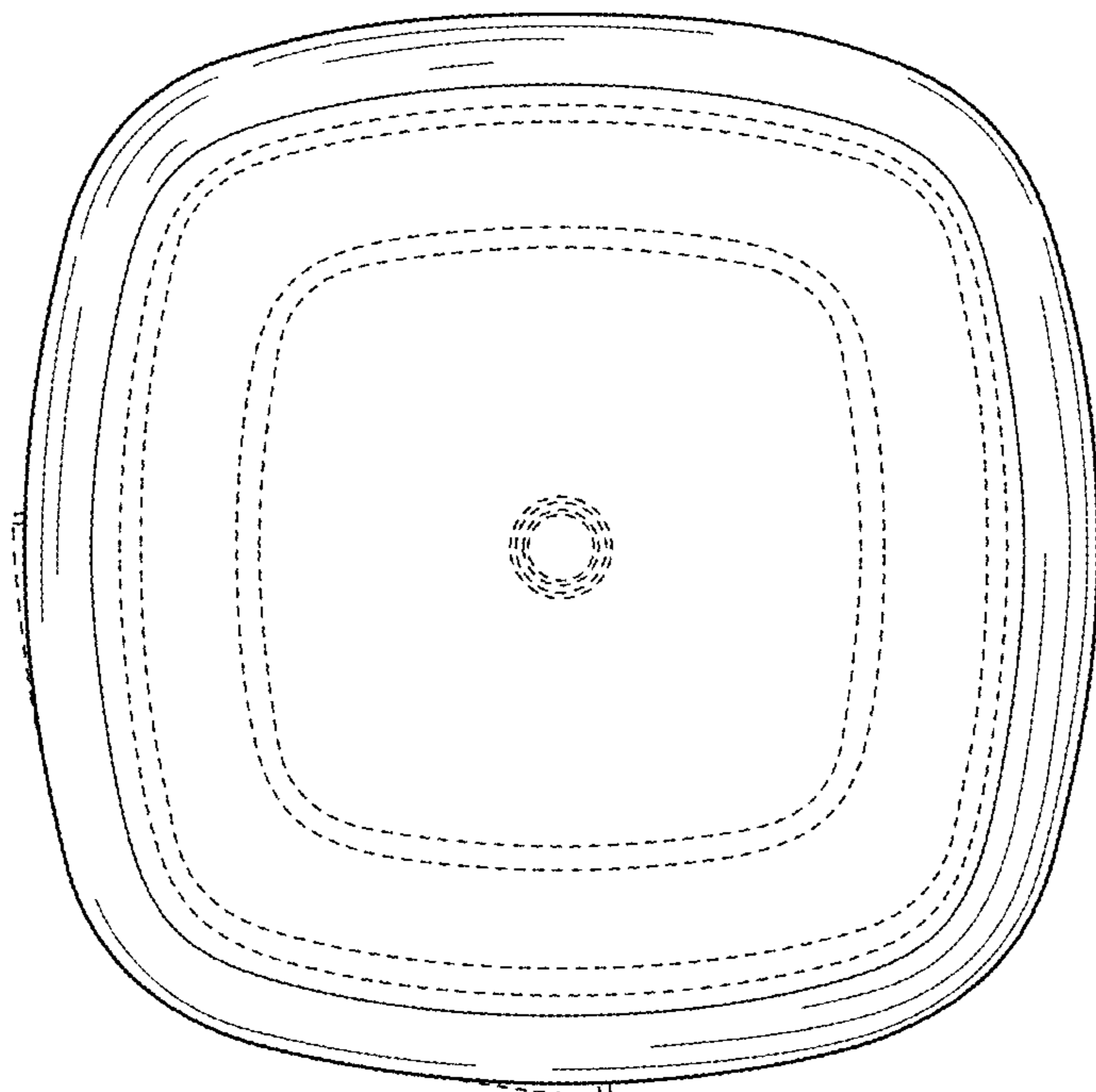
