FIG. 20 is a top view of FIG. 15; and,

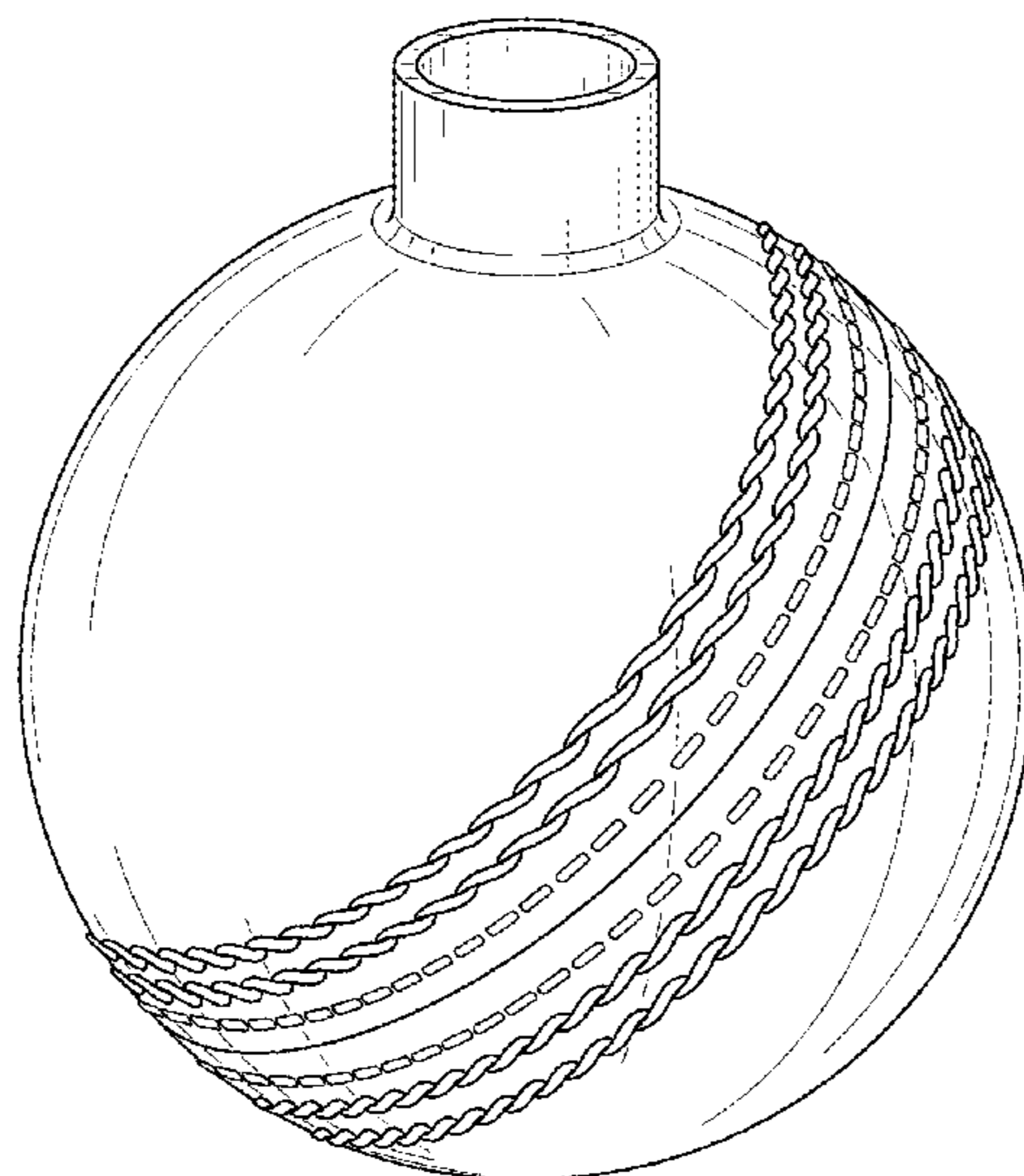

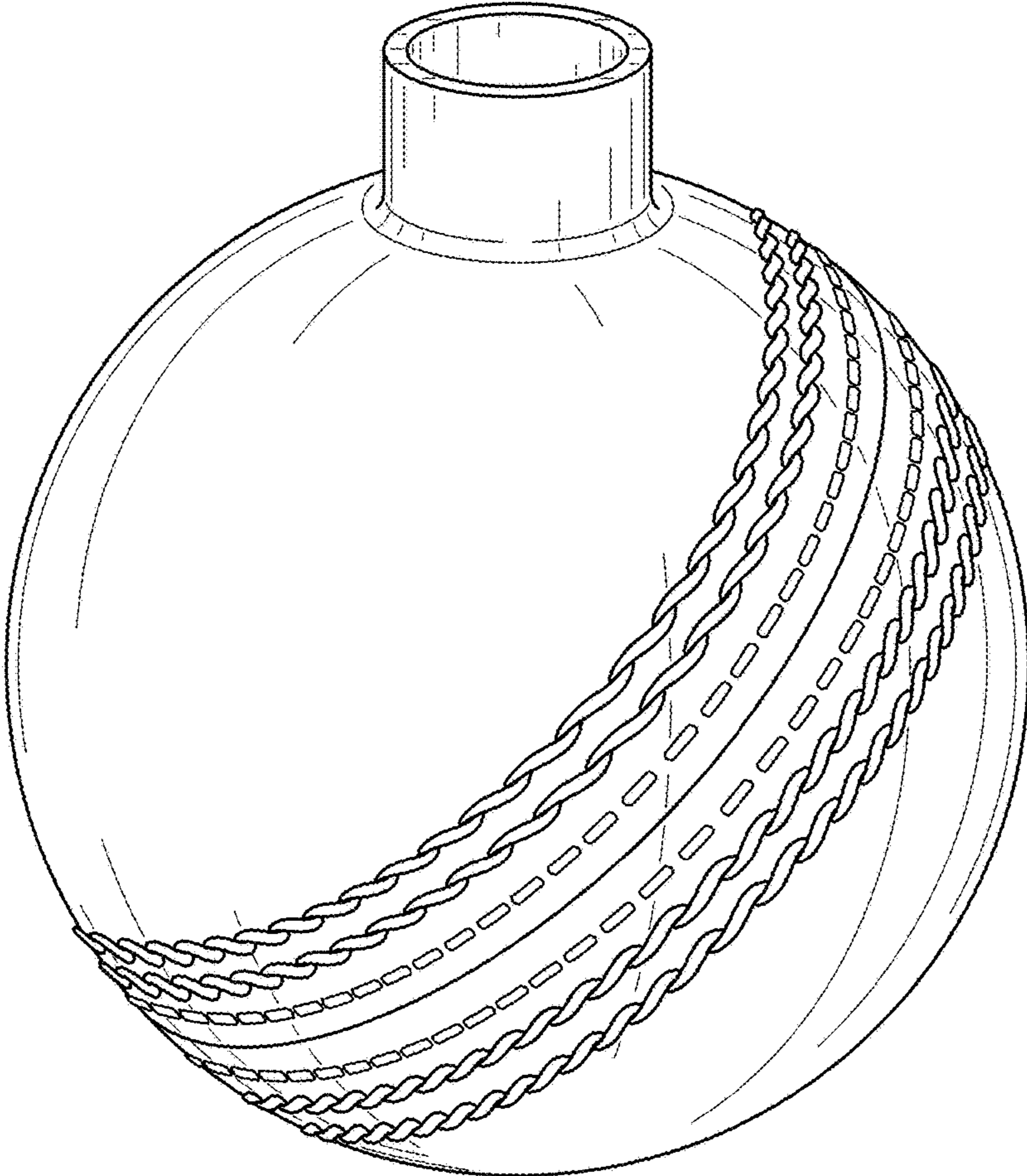

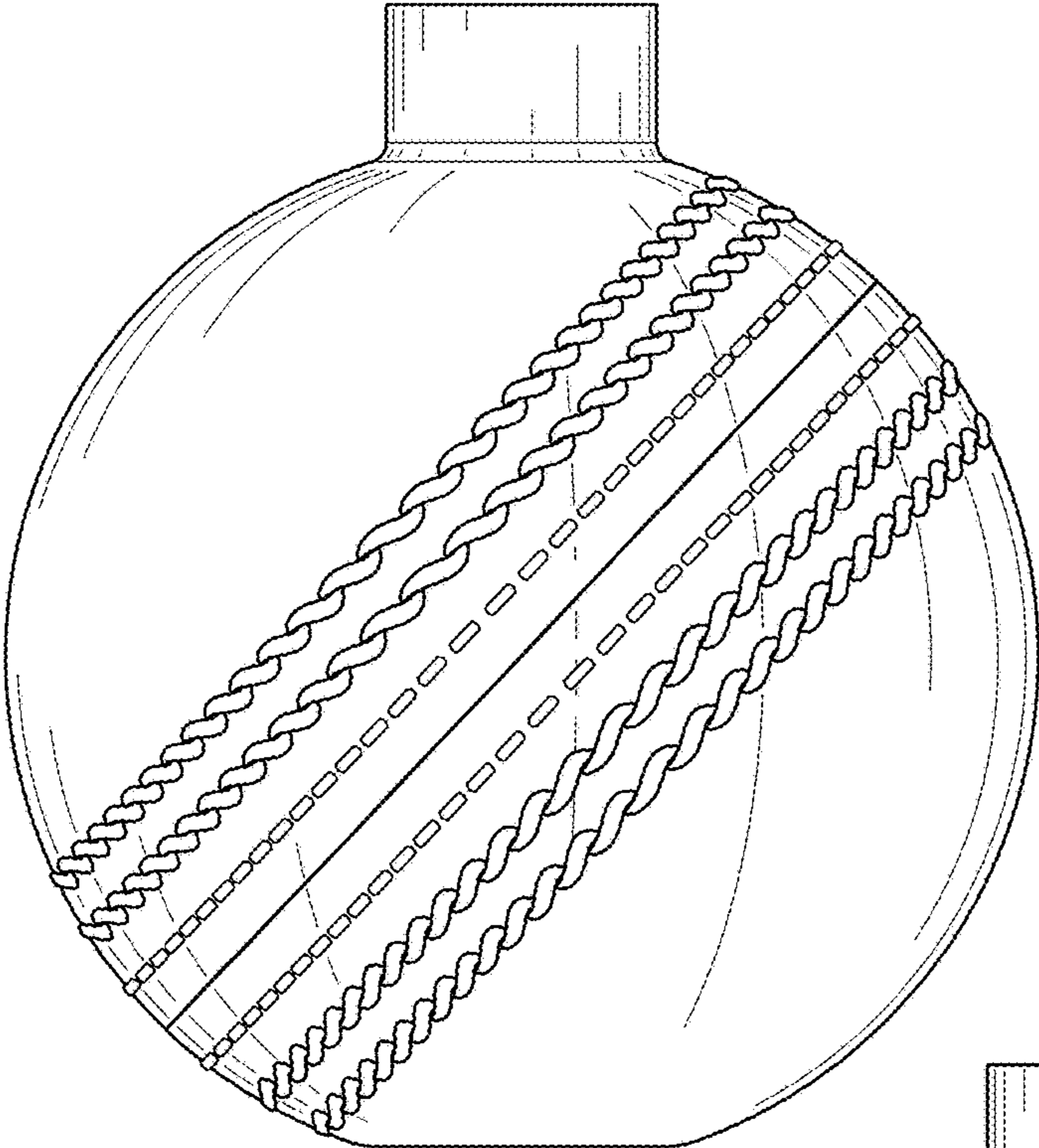

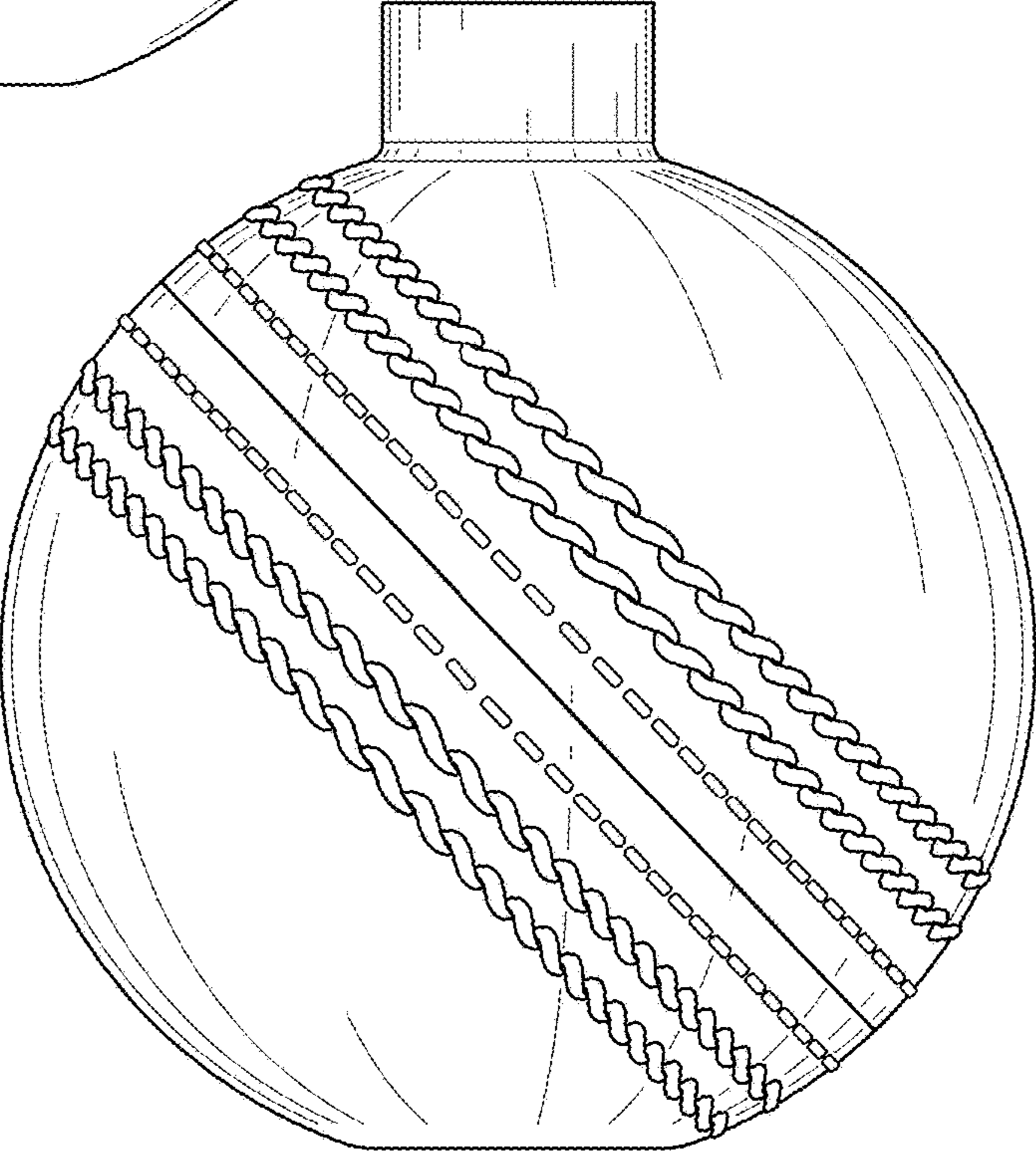

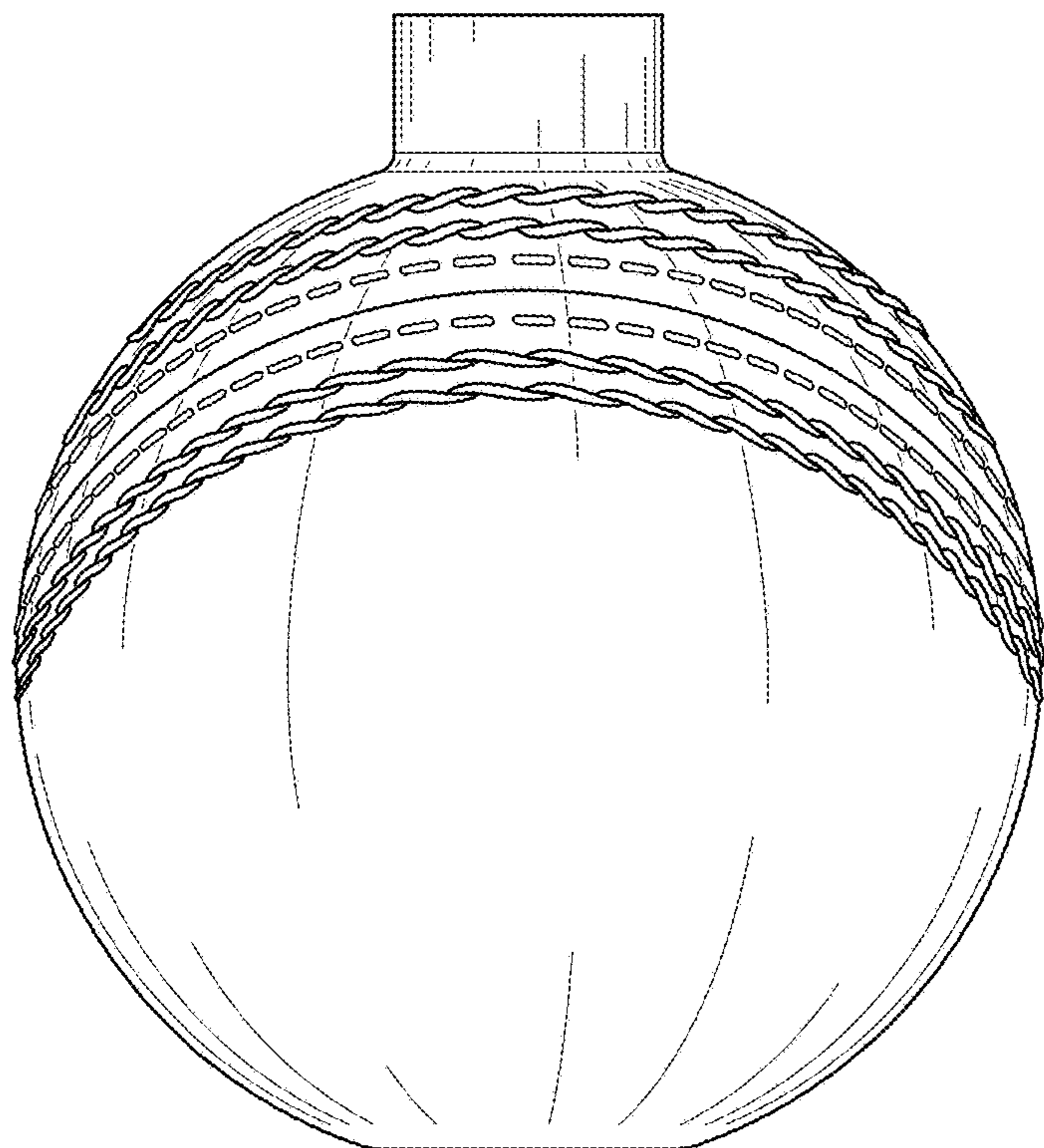

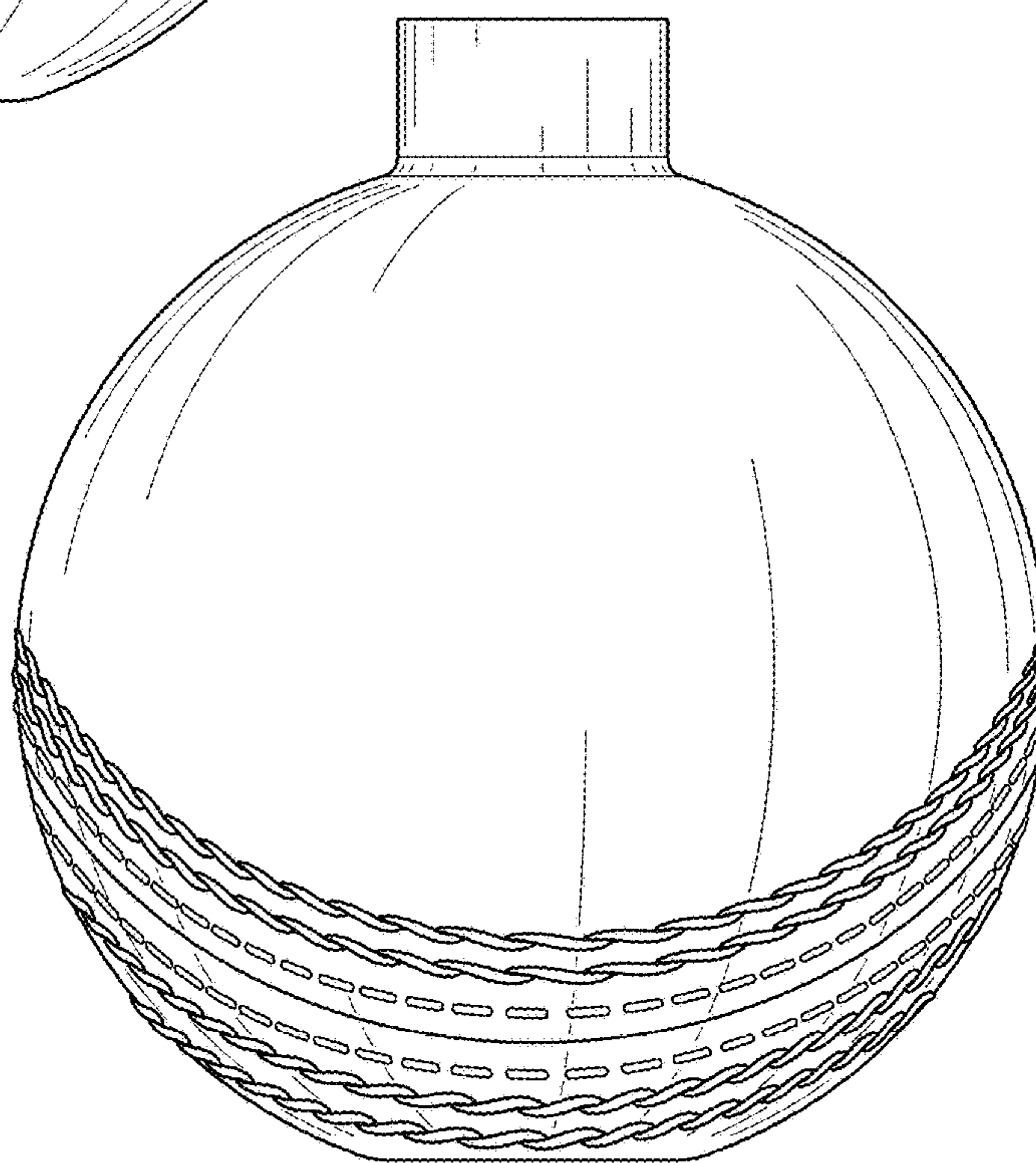

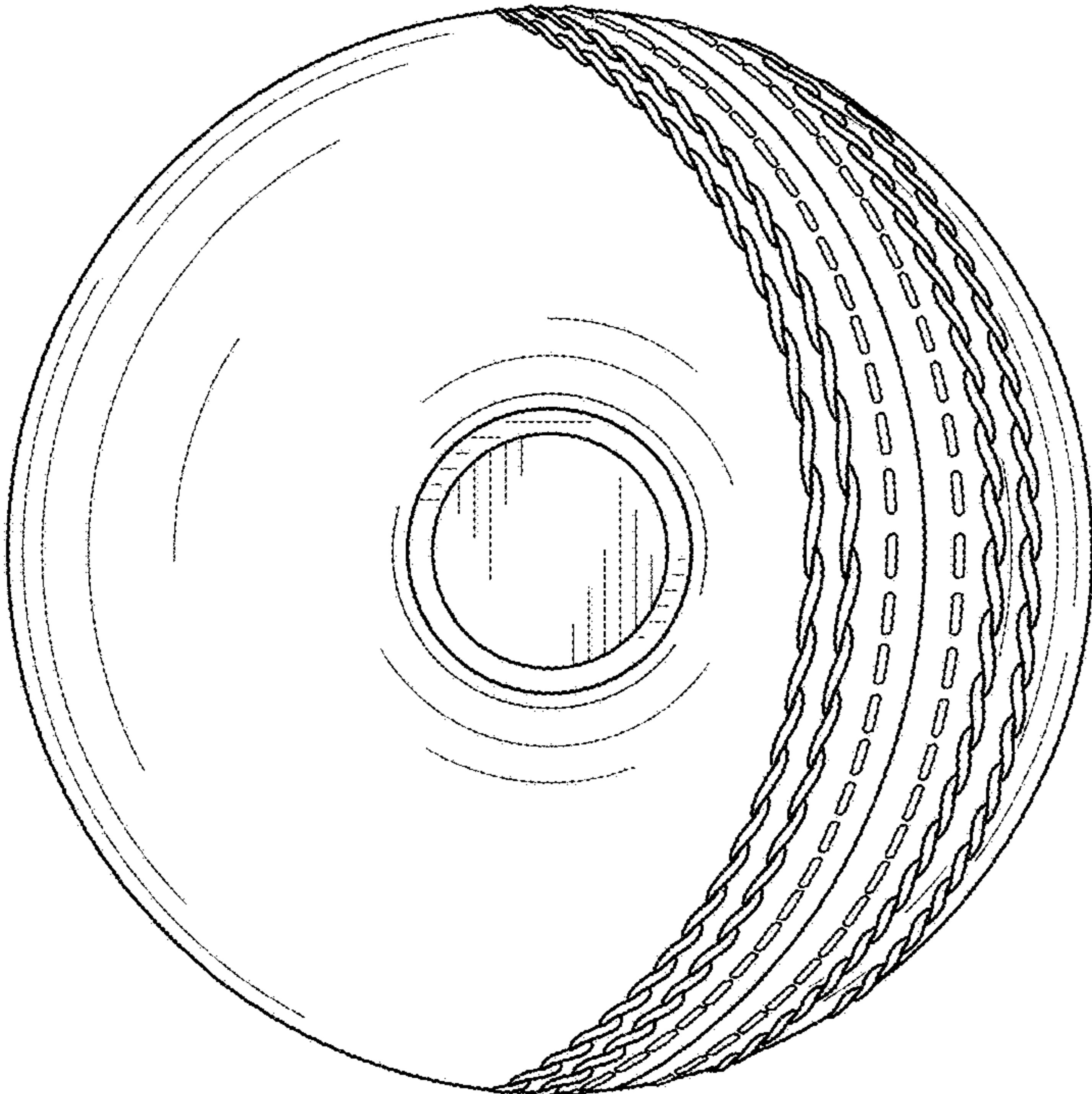

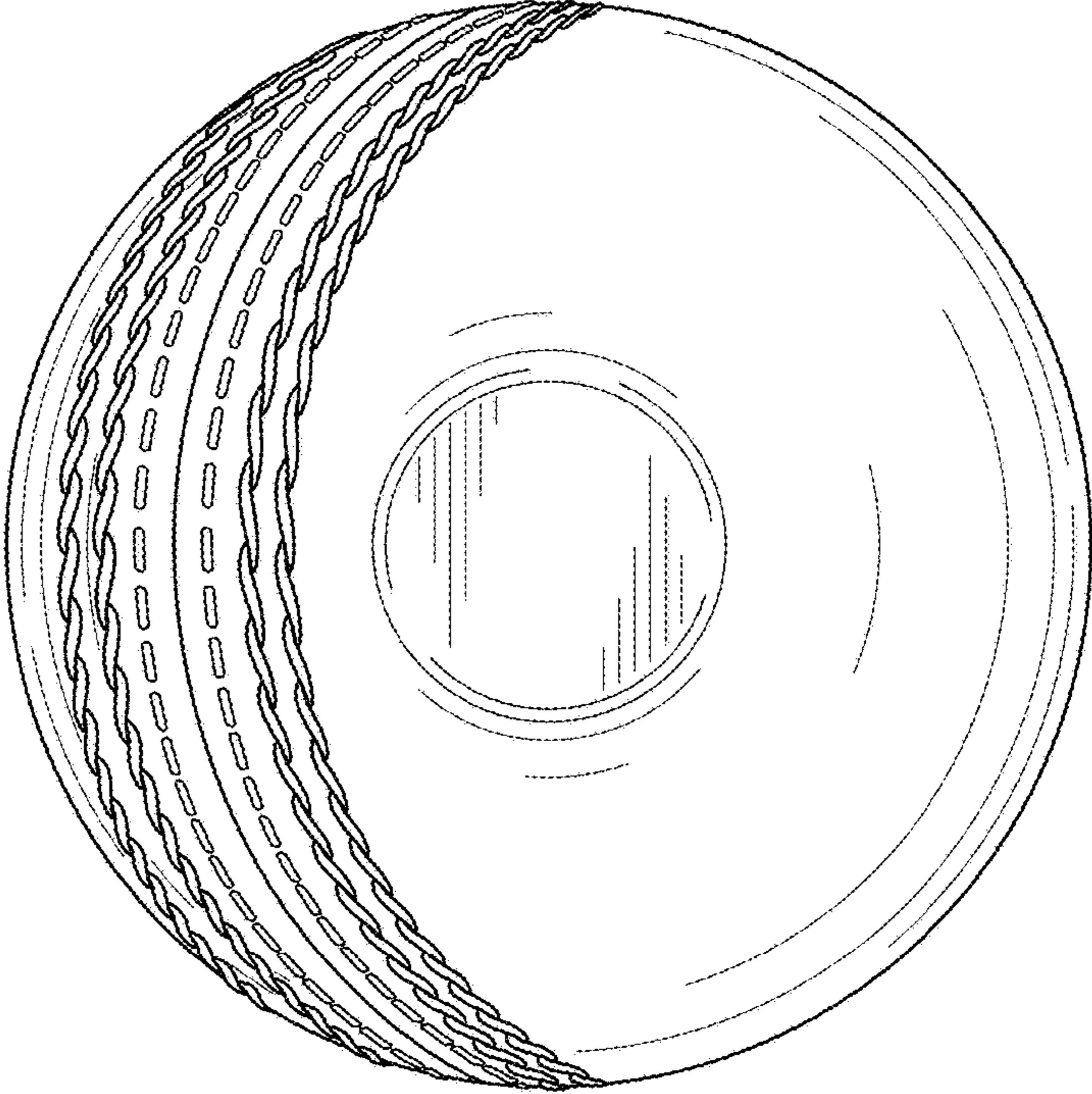

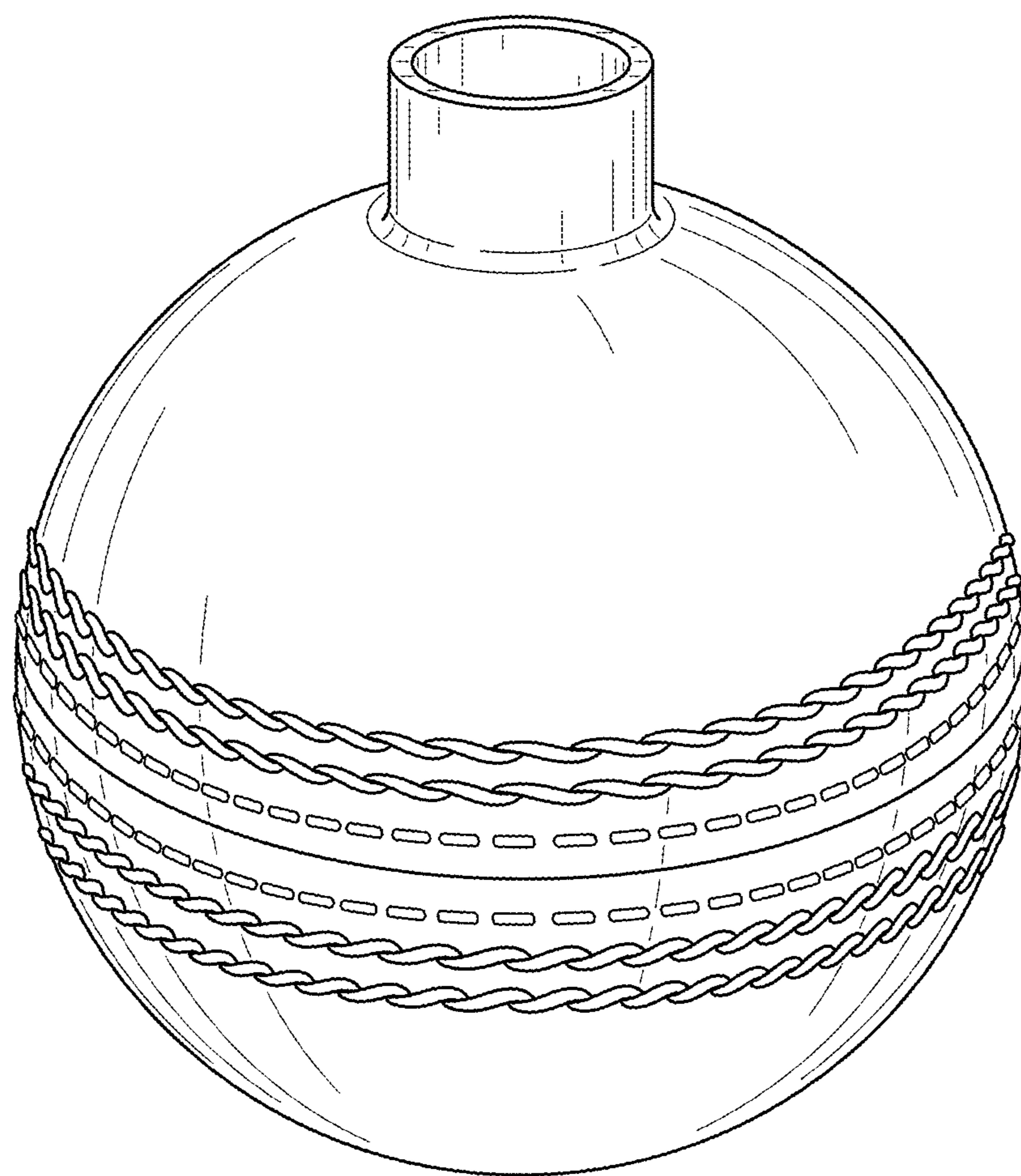

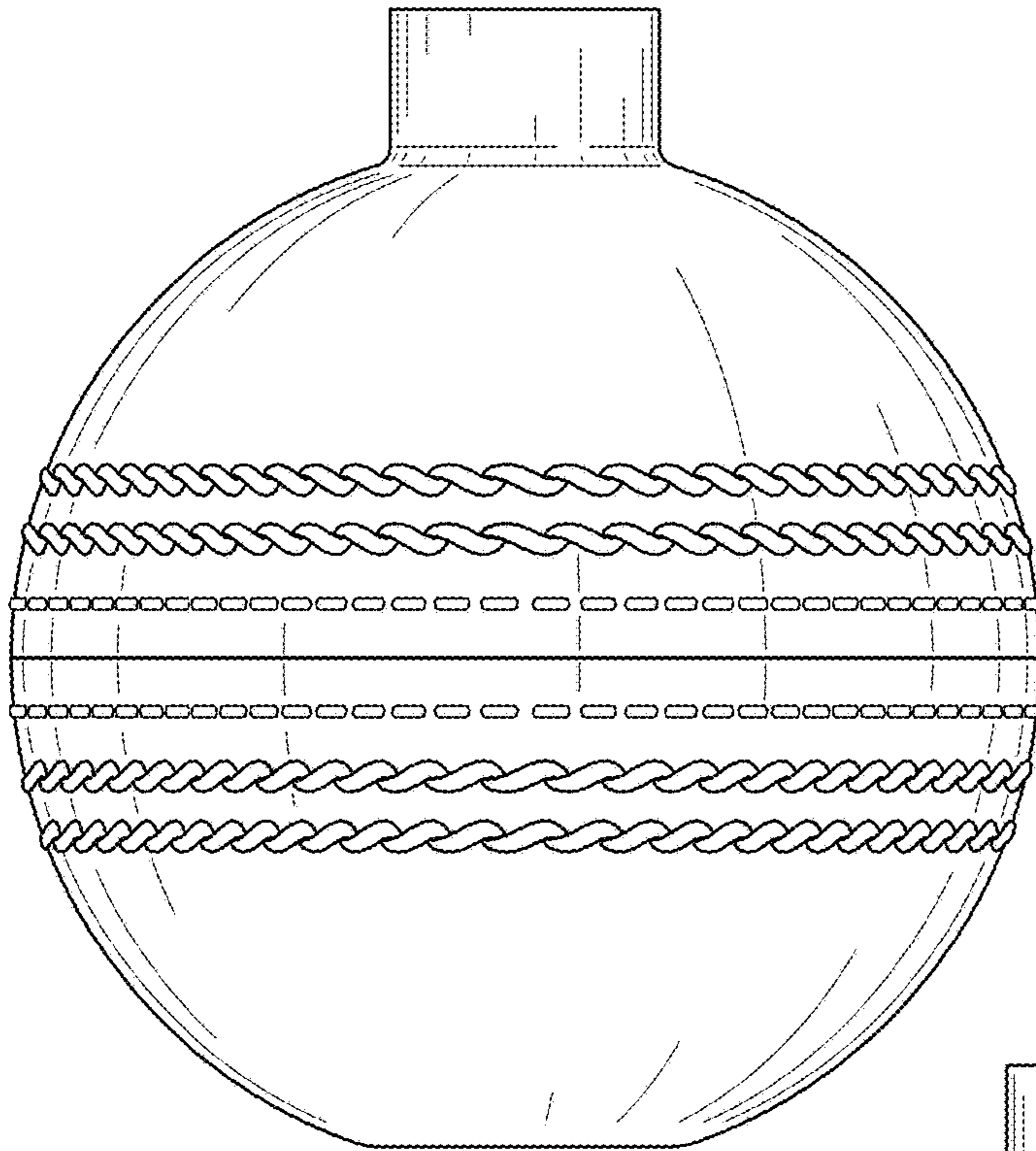

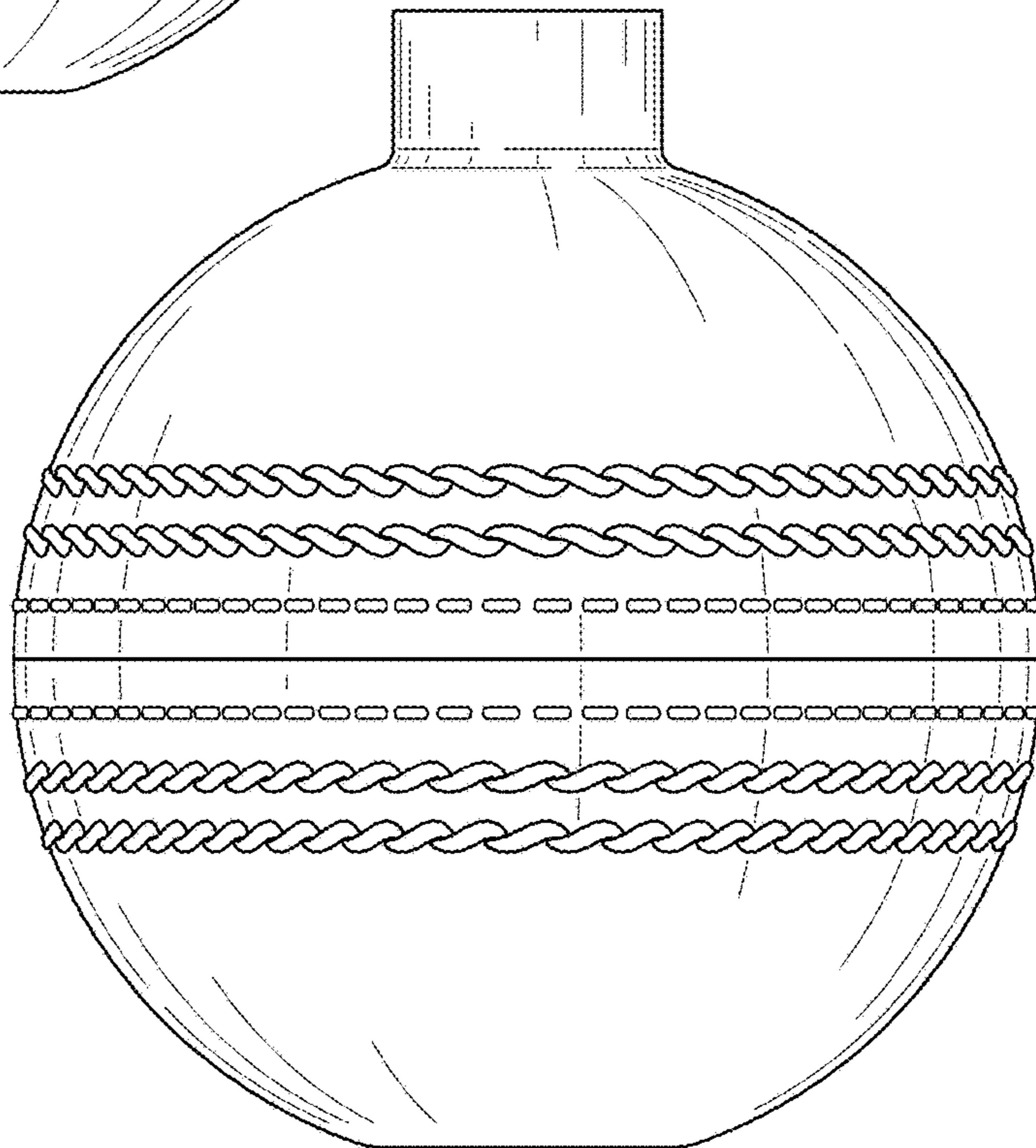

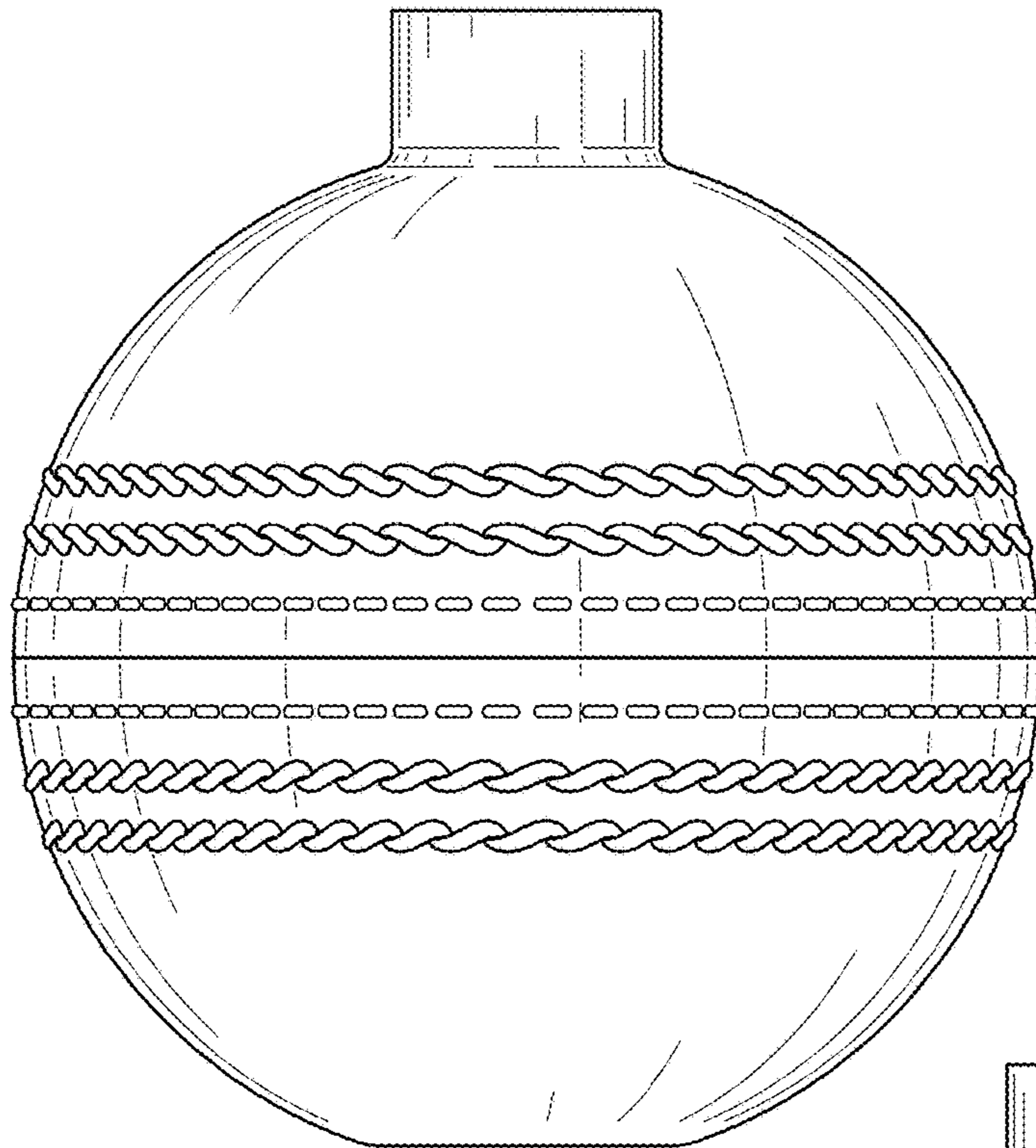

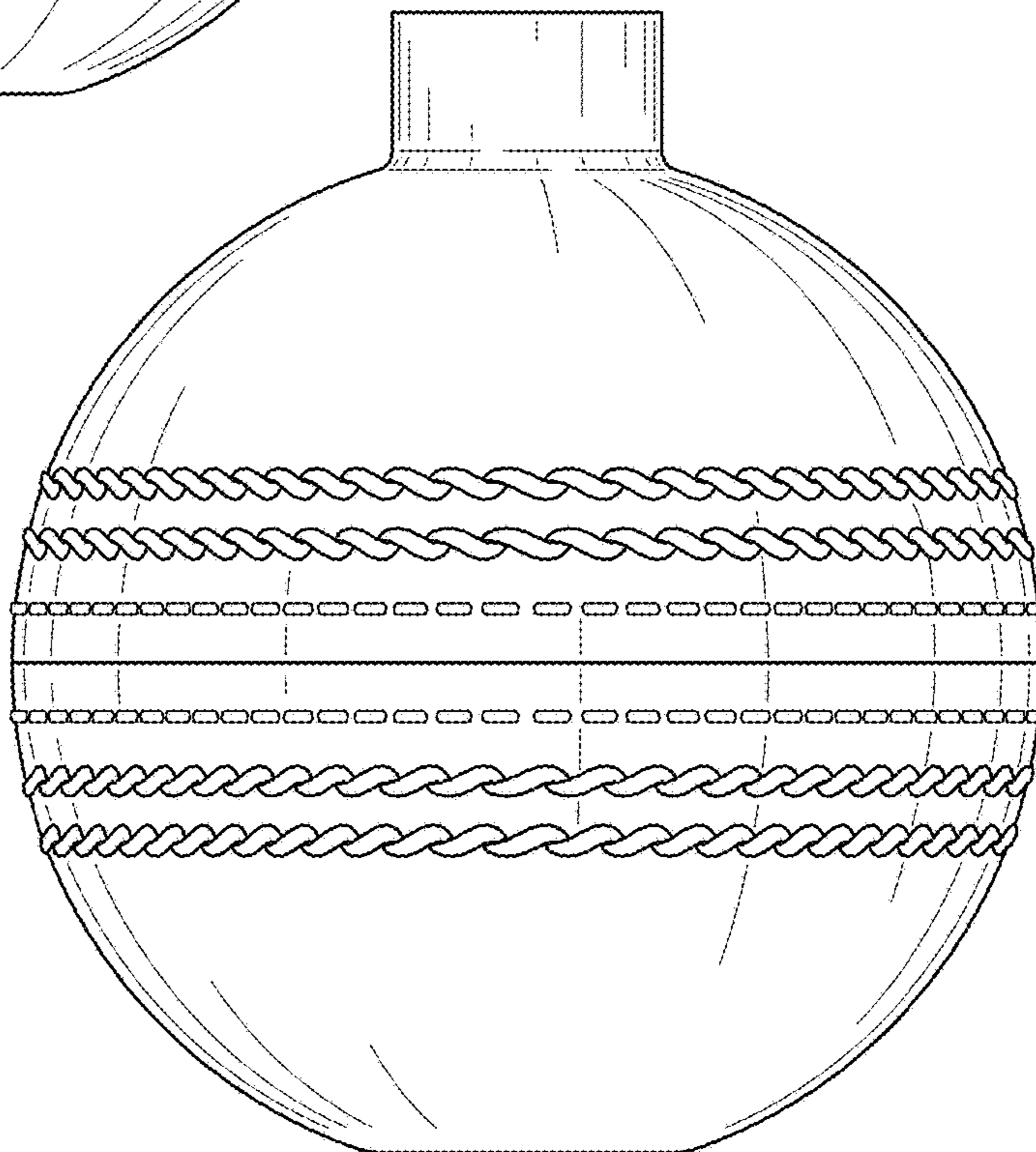

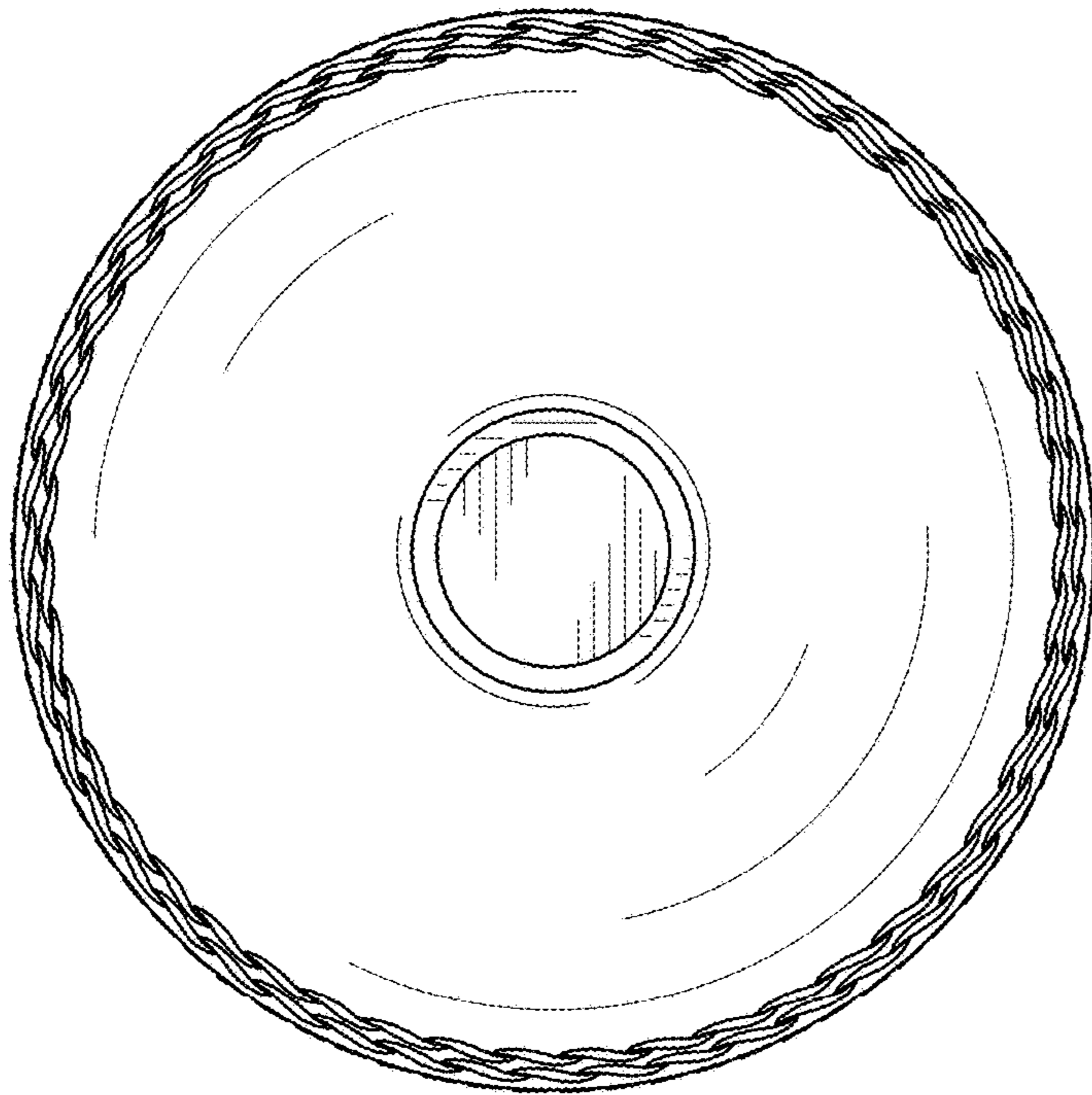

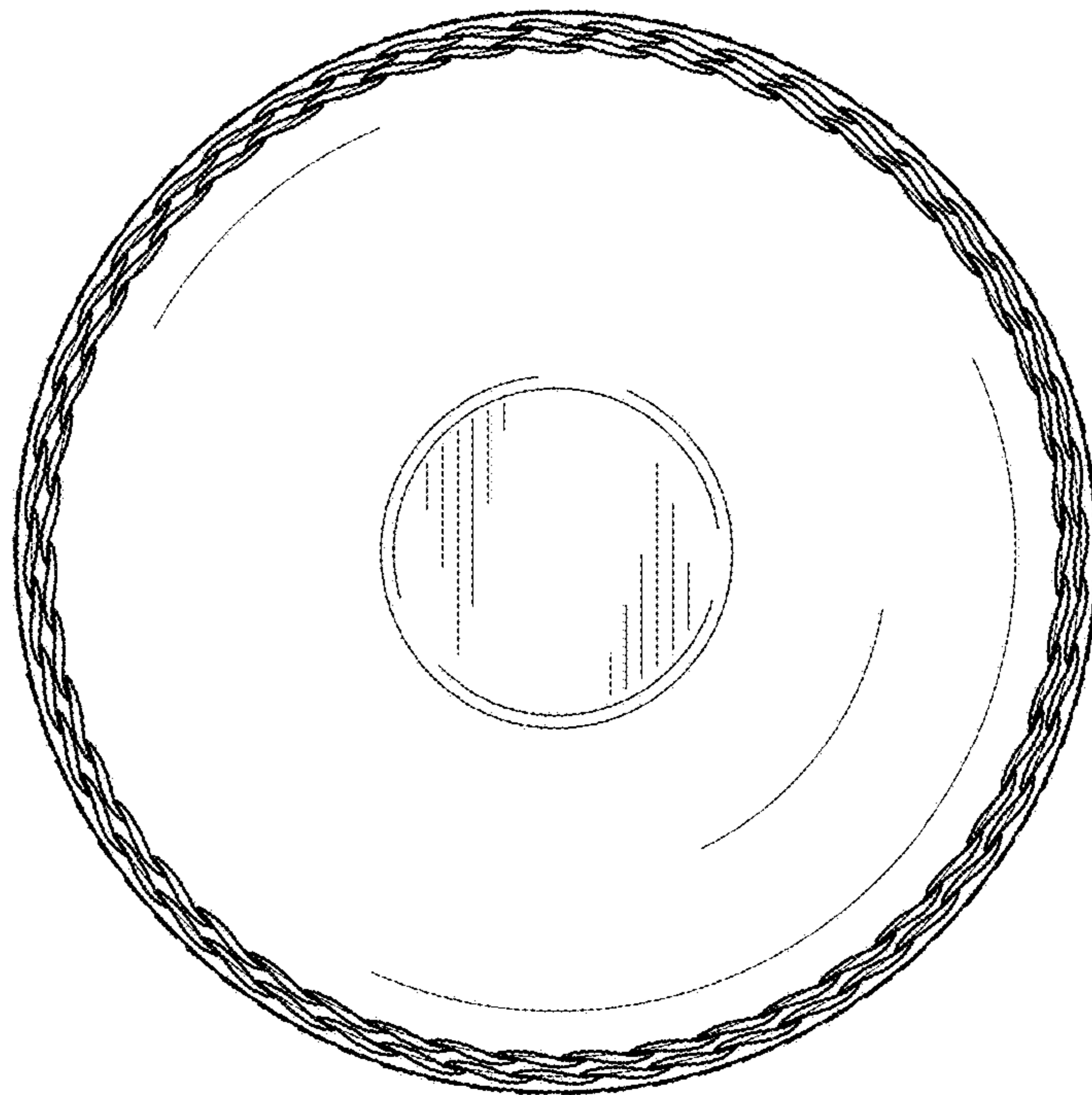

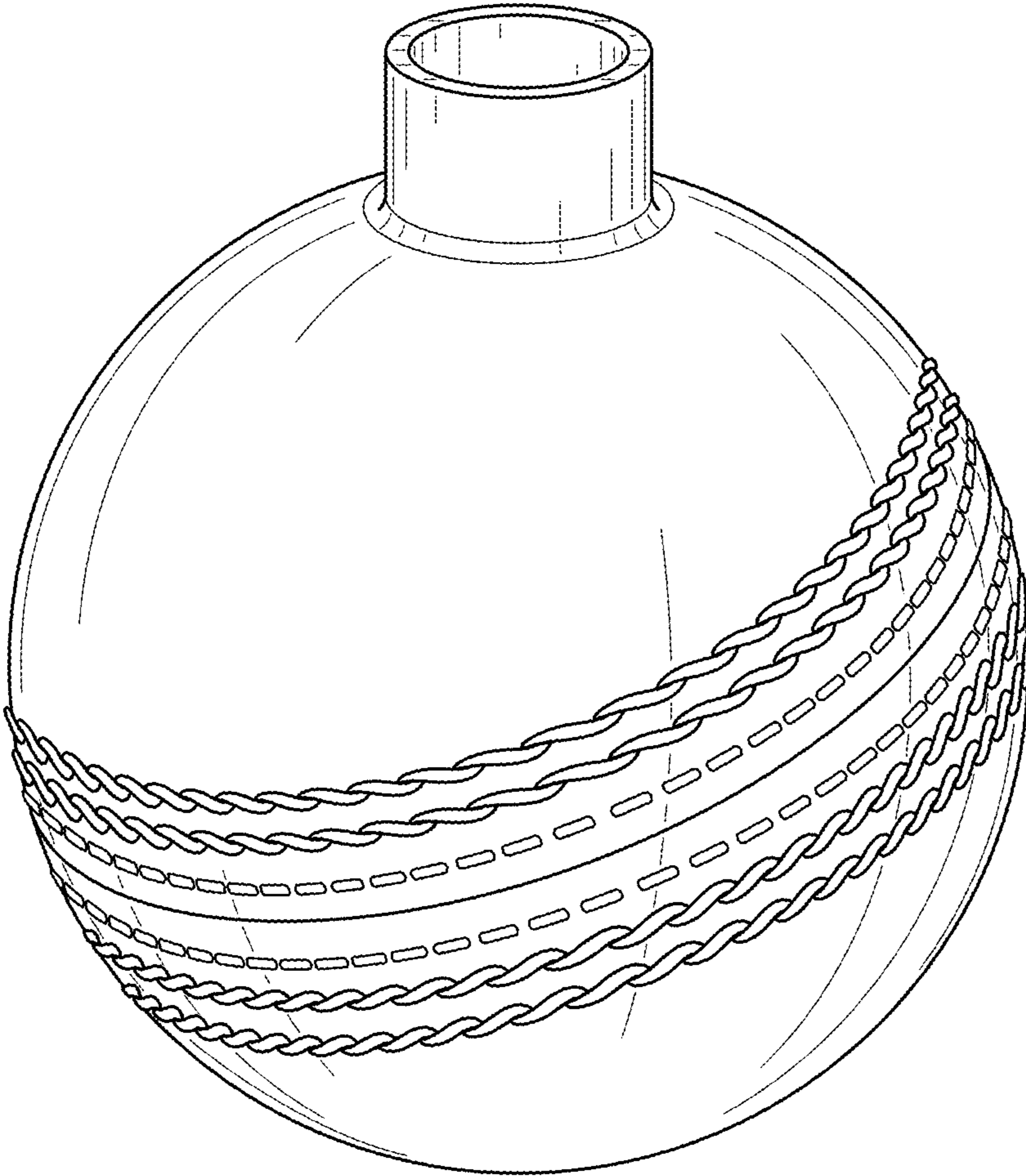

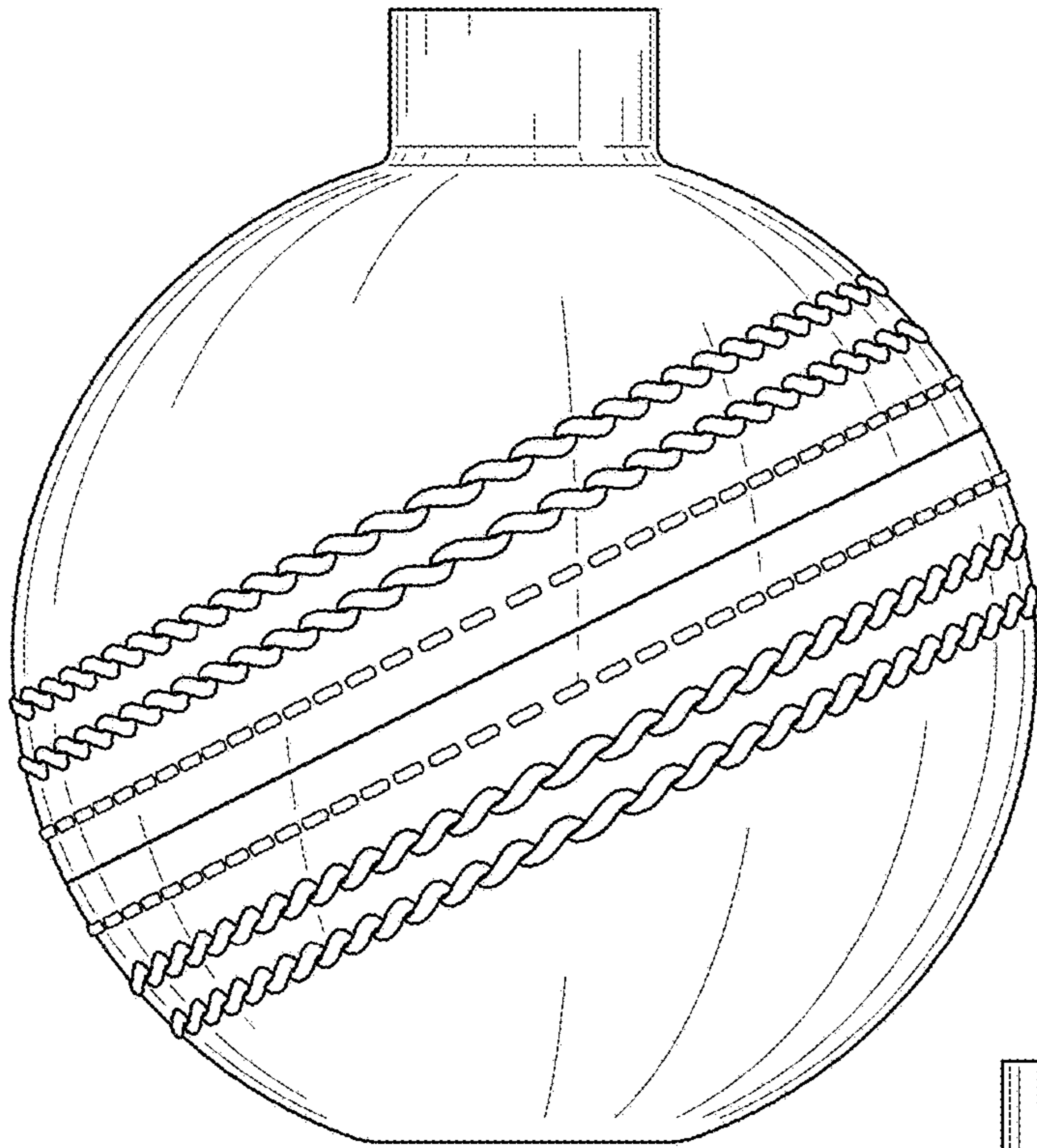

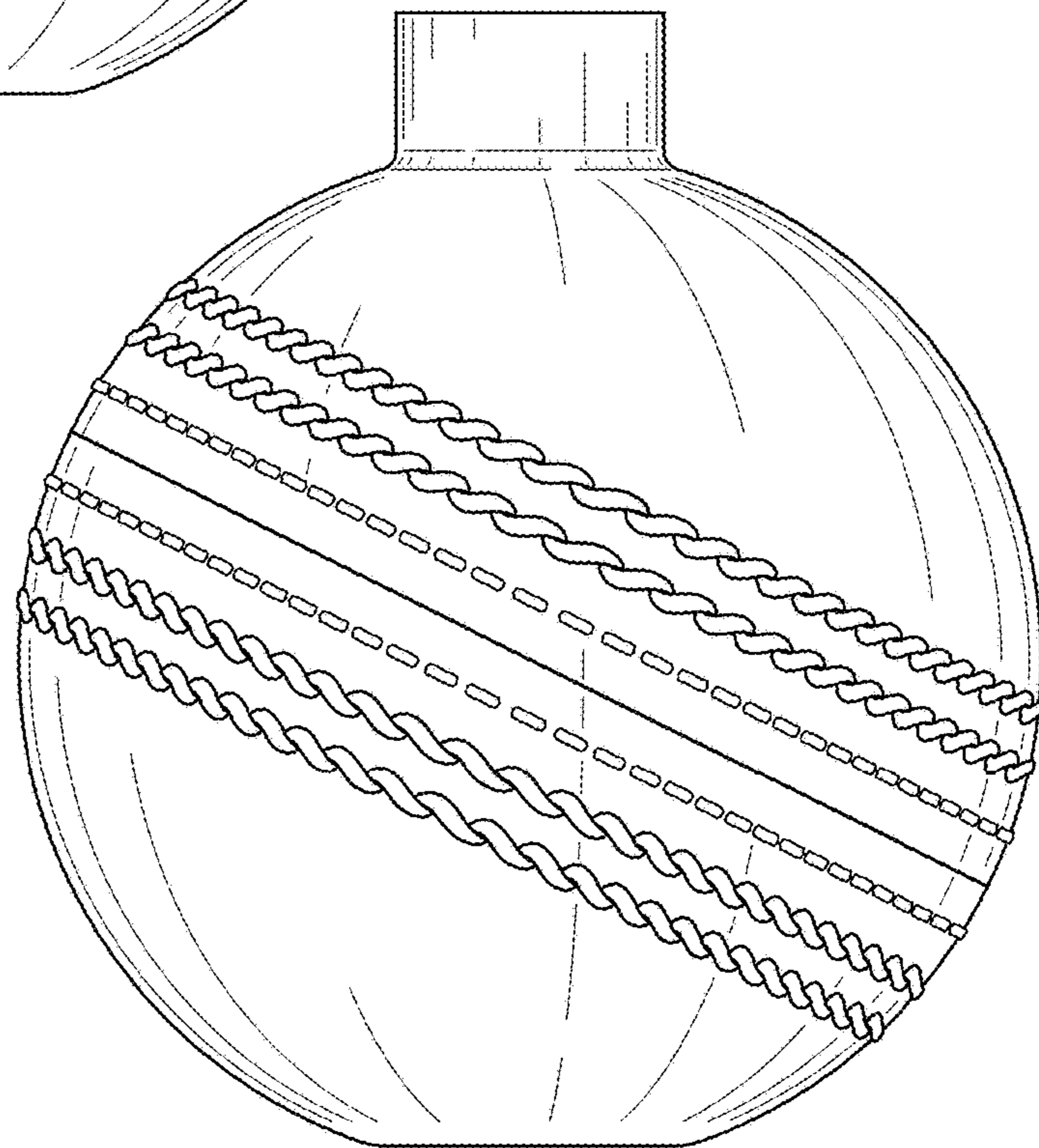

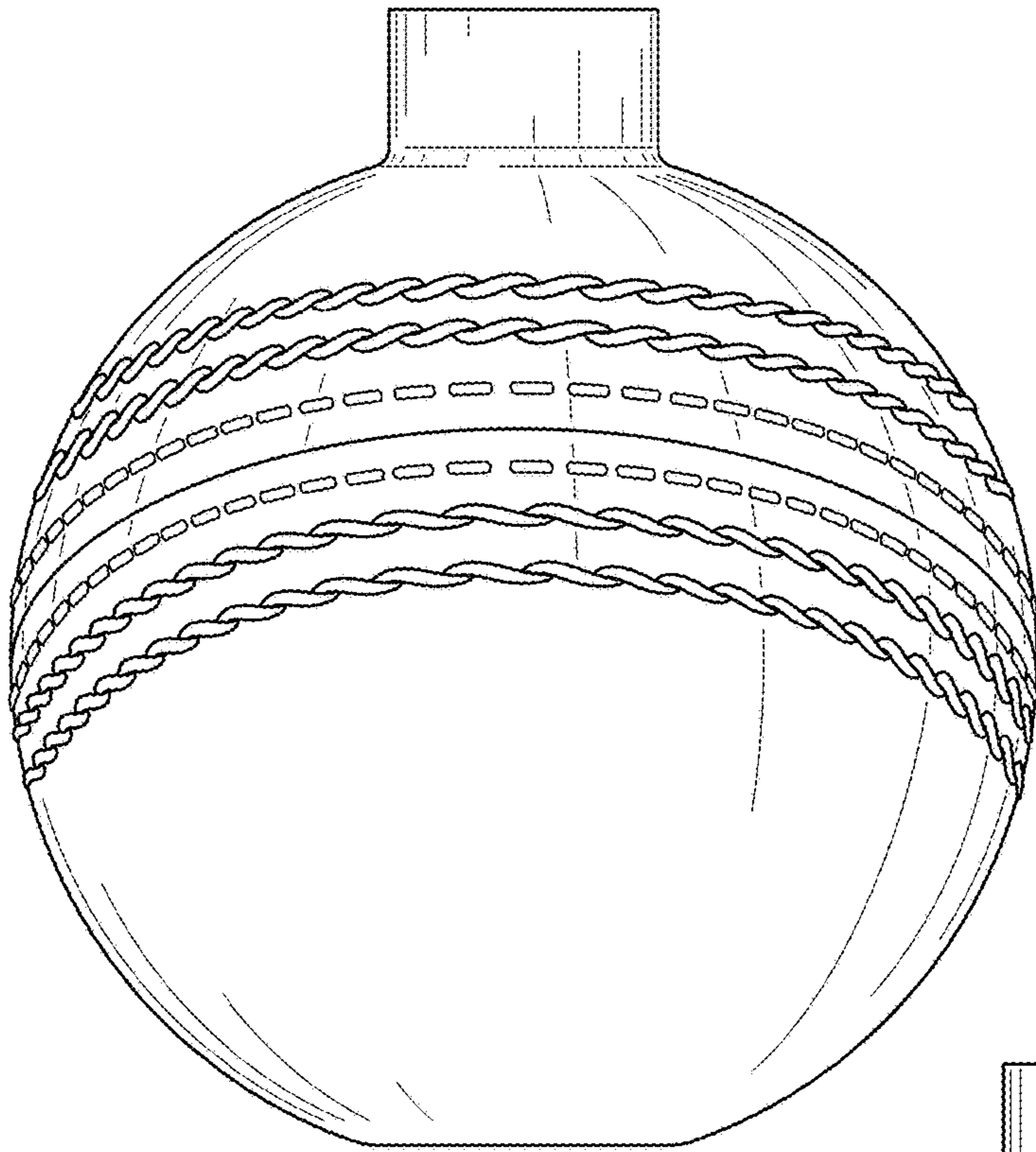

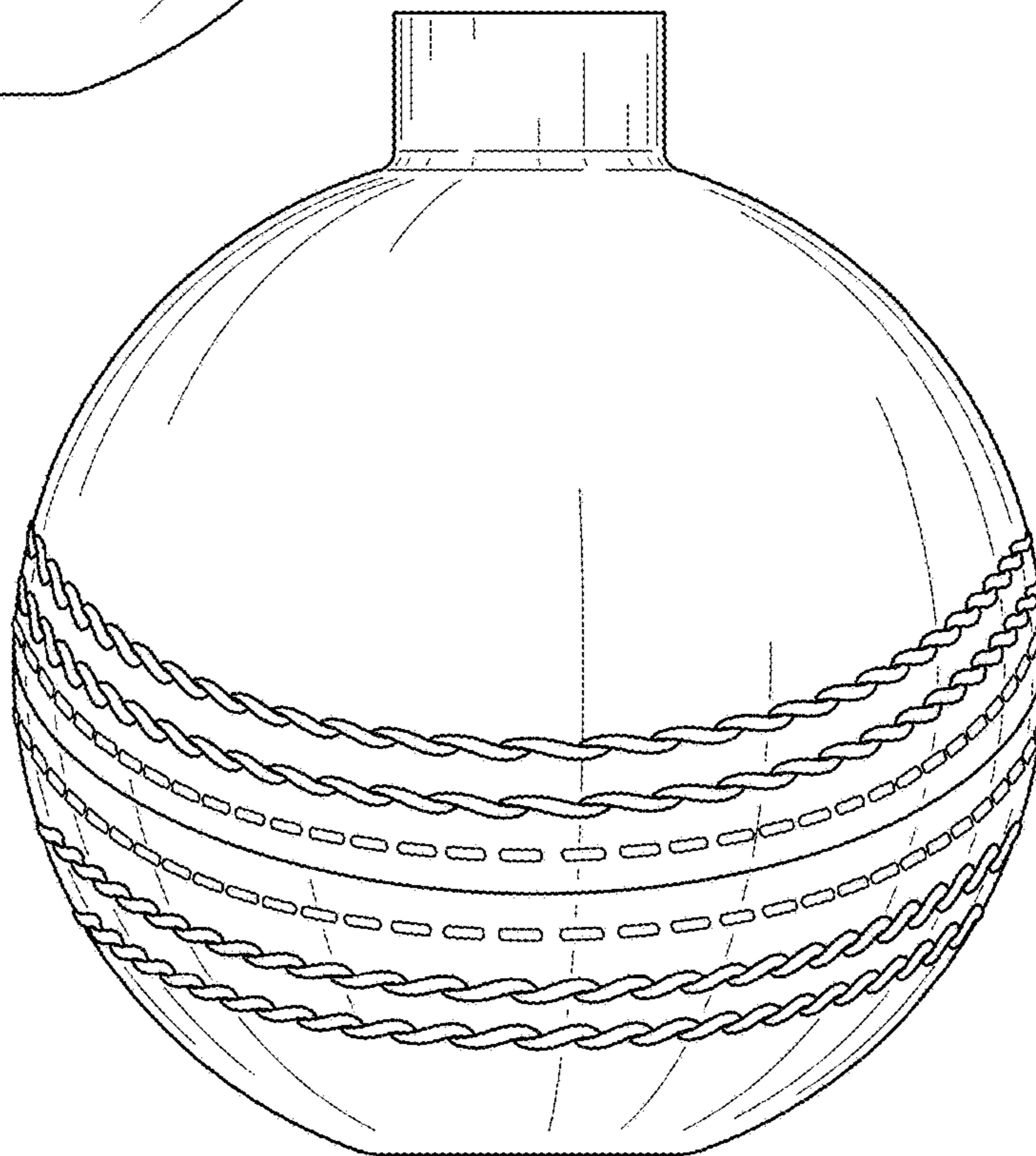

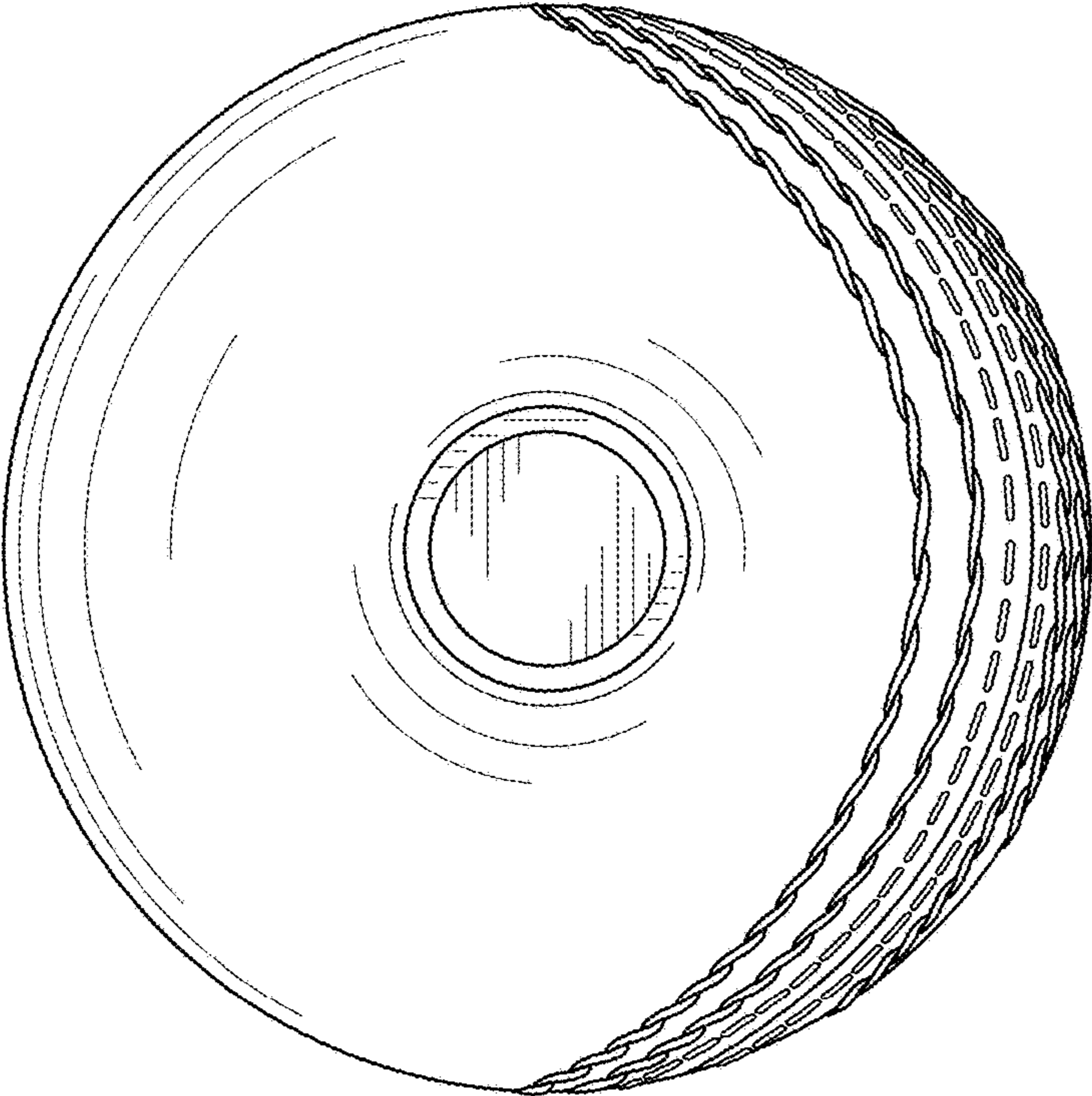

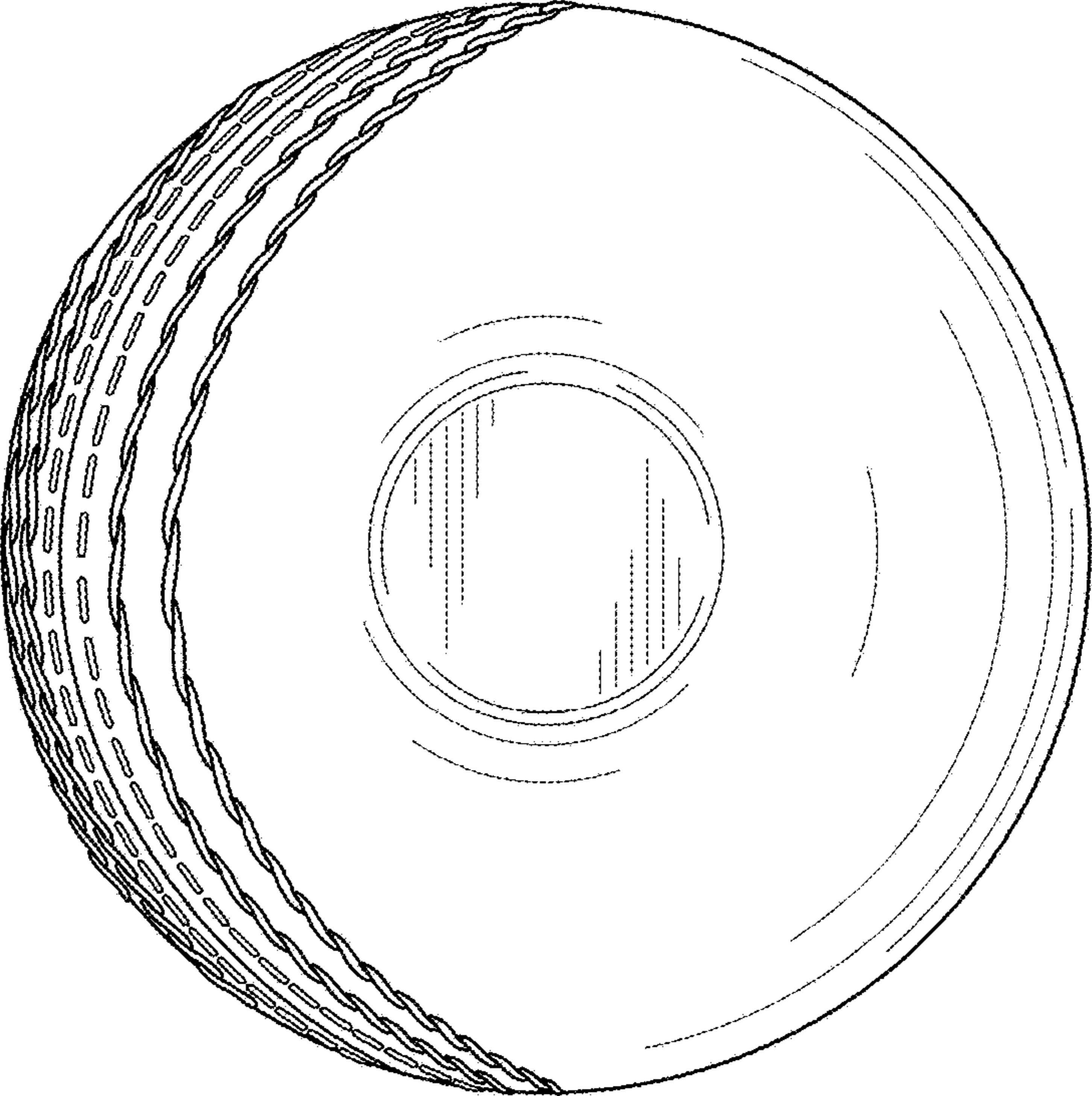
