**DESCRIPTION**

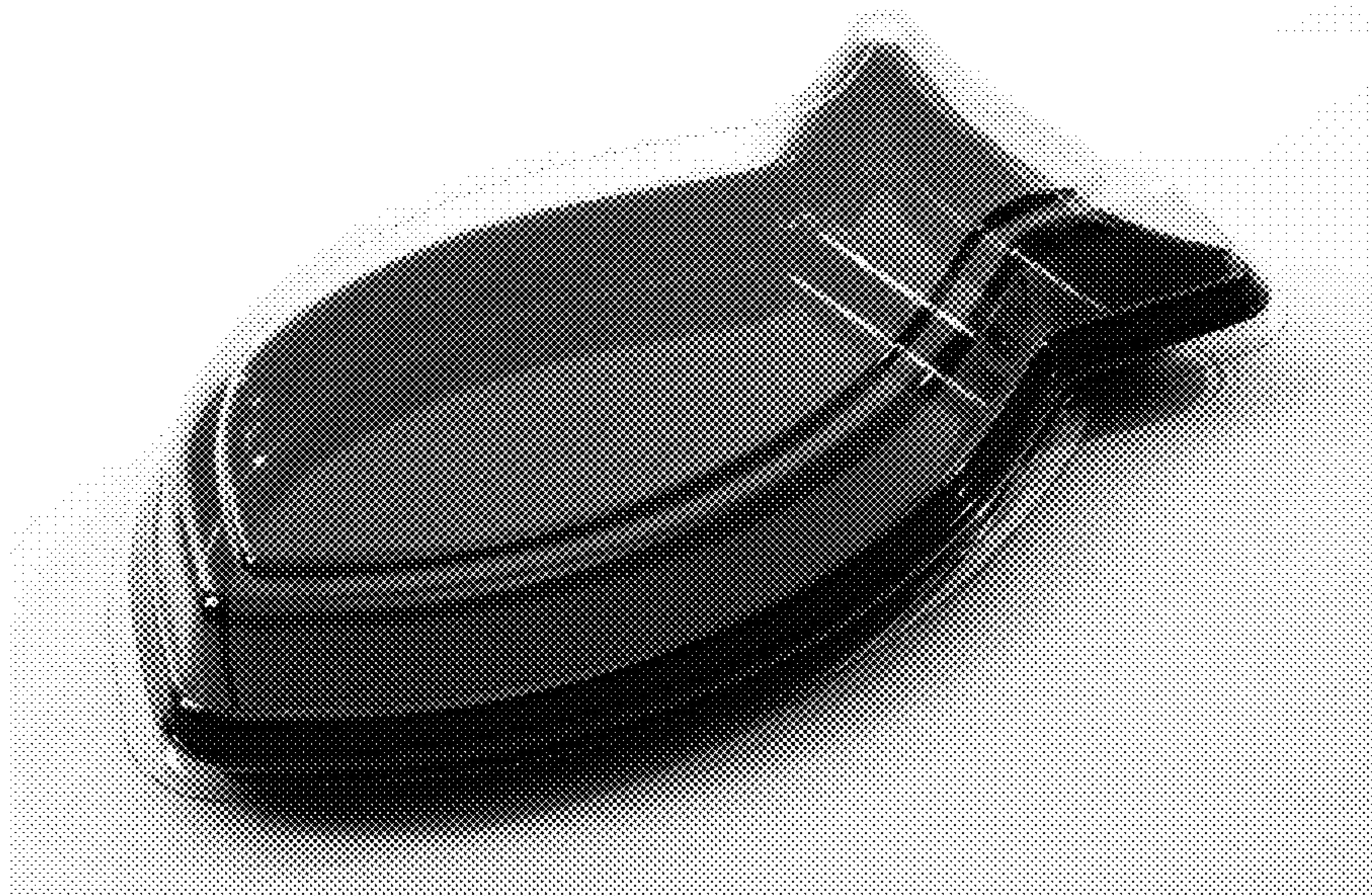
FIG. 1 is a perspective view of the covered seafood tray of the present invention;

 FIG. 7 is a left side view of the covered seafood tray of FIG. 1.

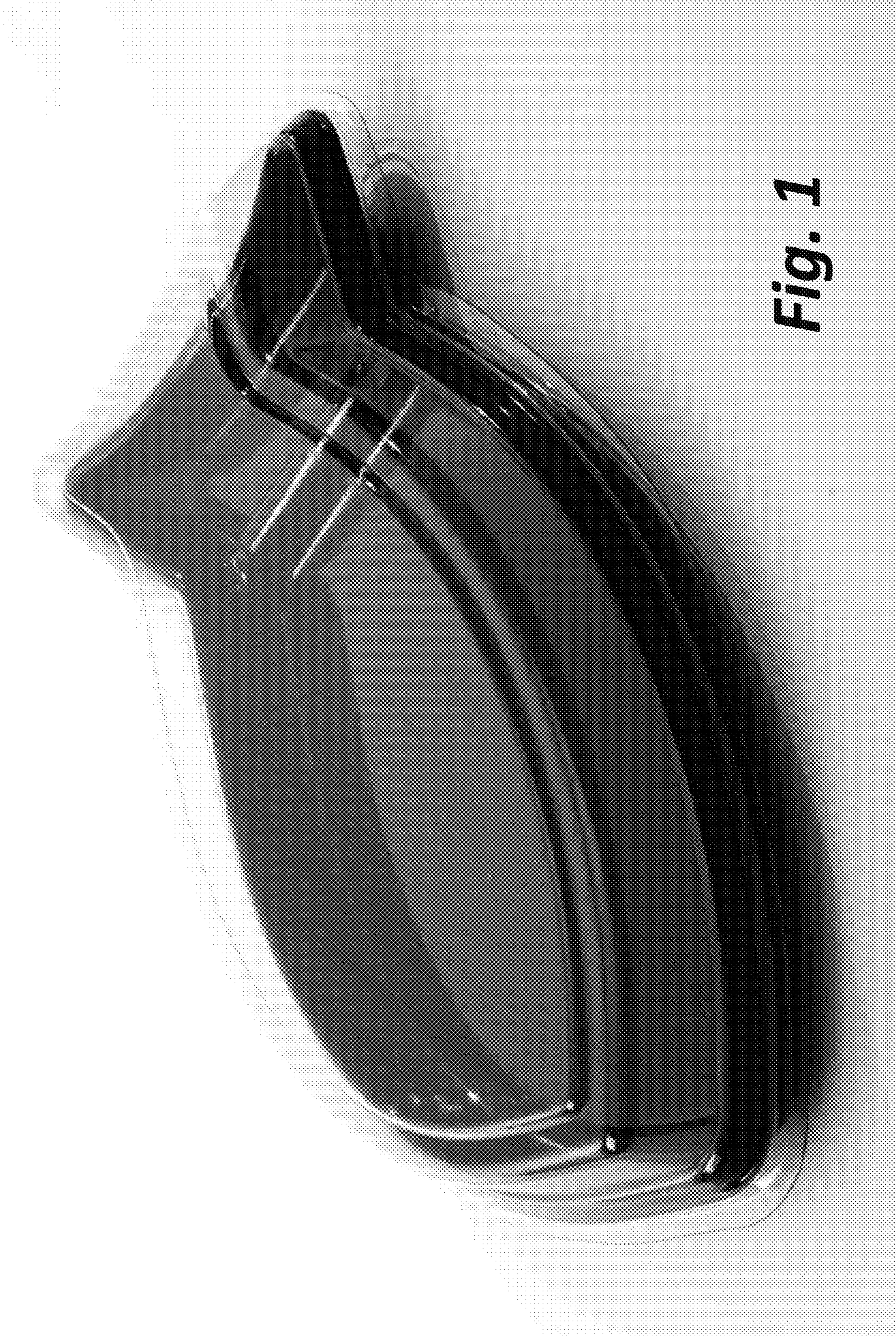
