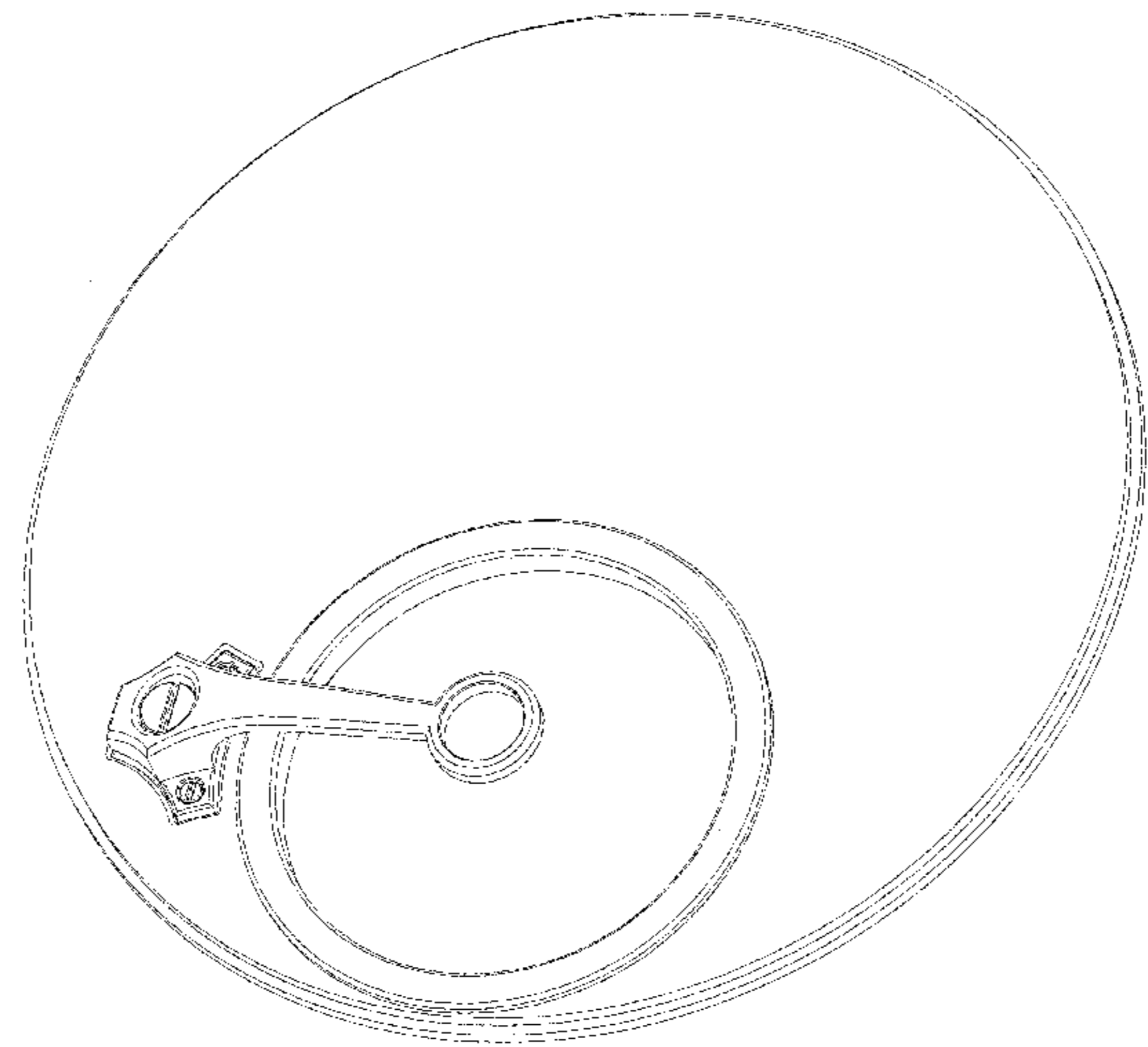

**DESCRIPTION**  
FIG. 1 is a top plan view of a watch dial showing my new design;

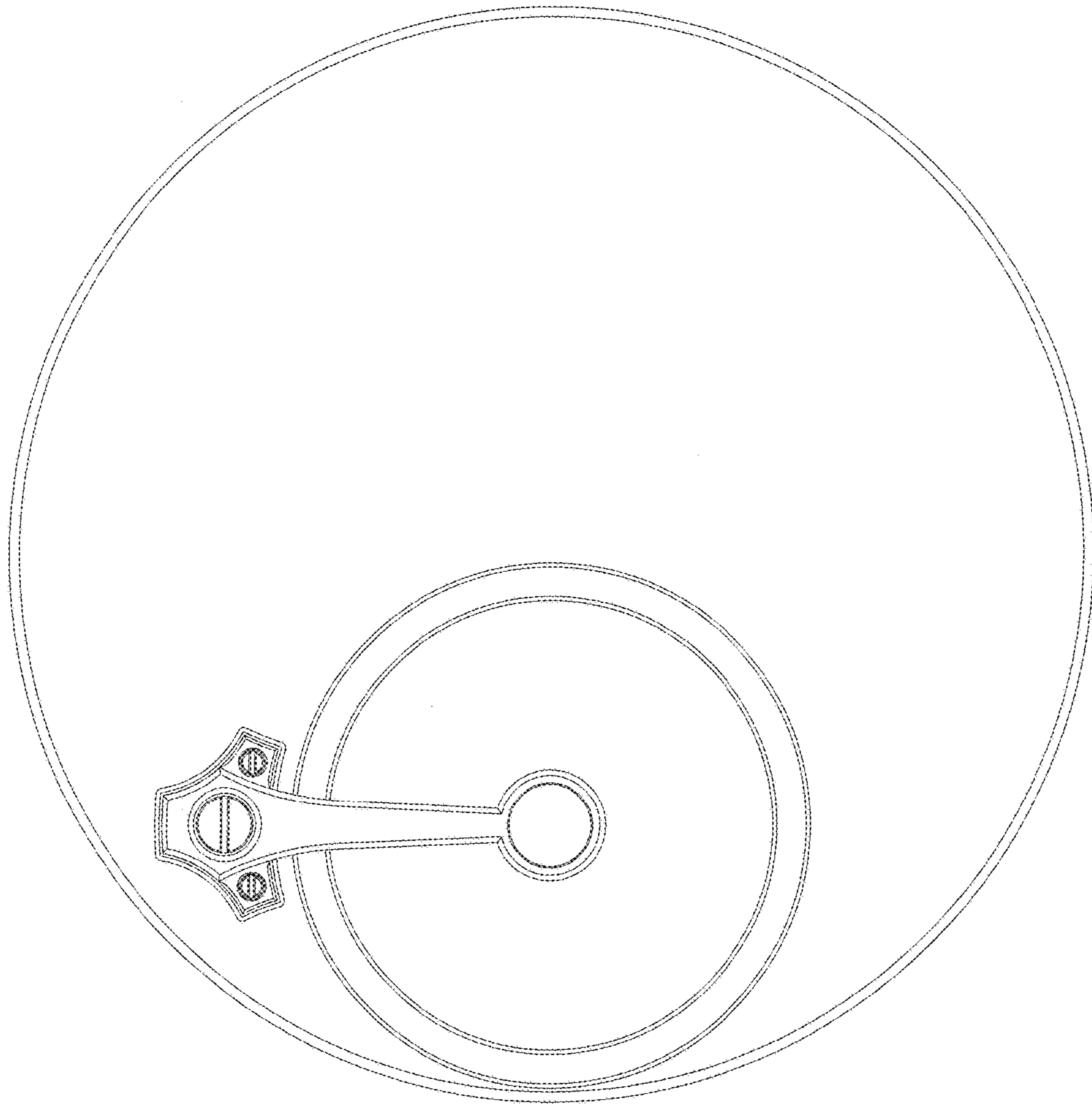

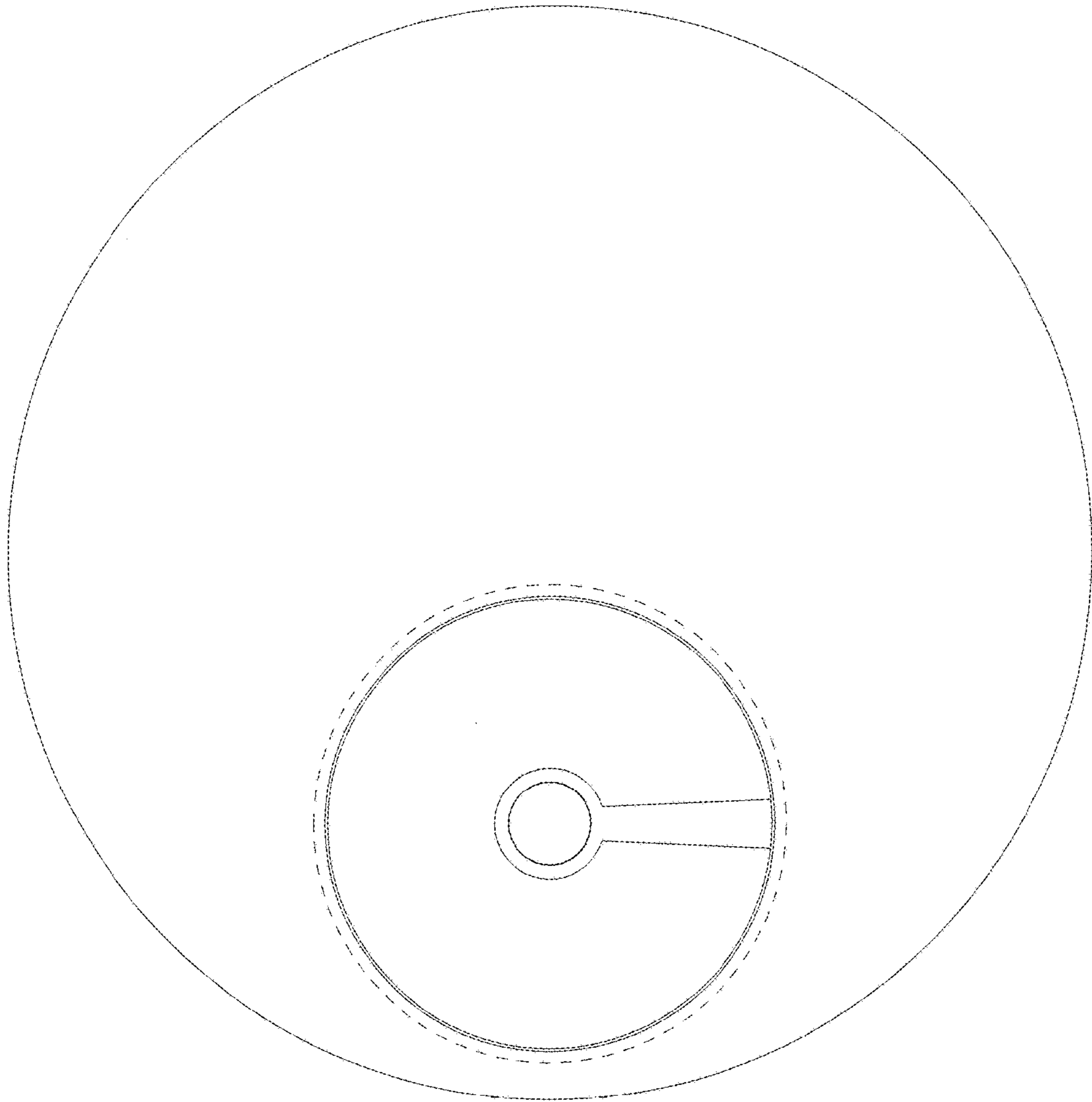

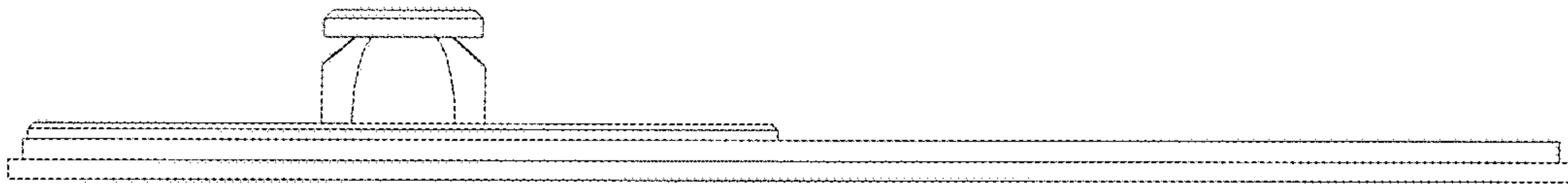

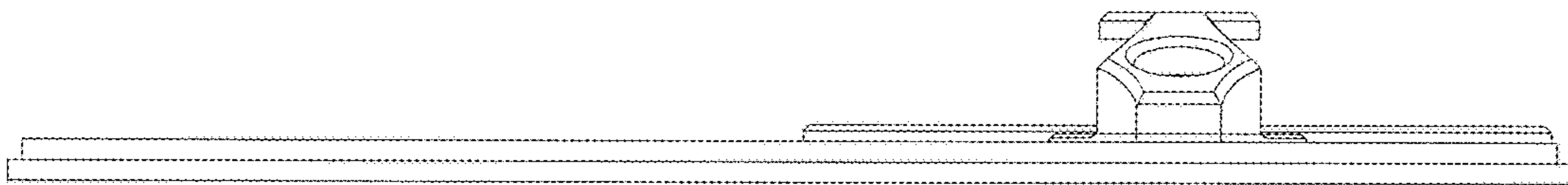

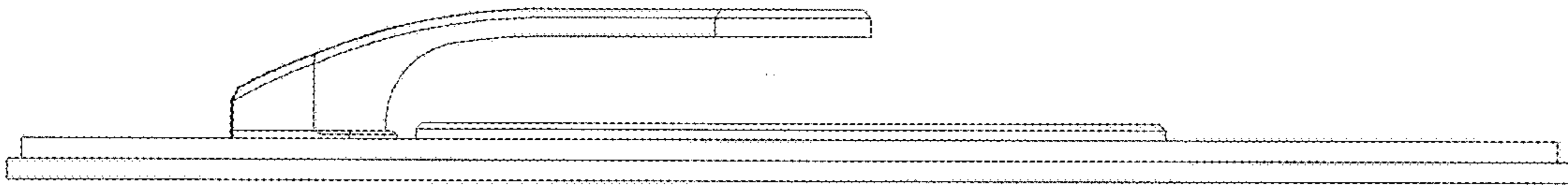

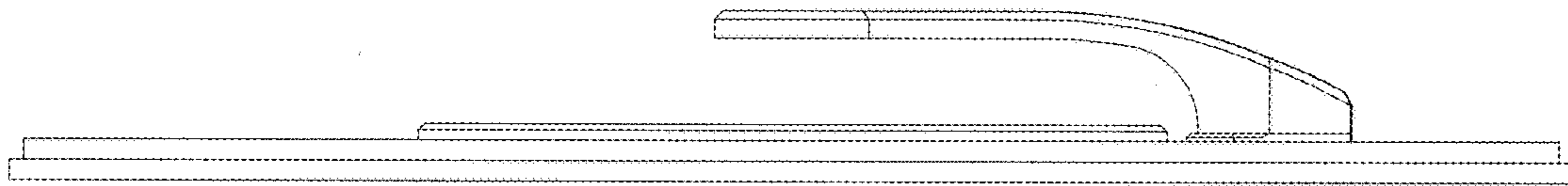

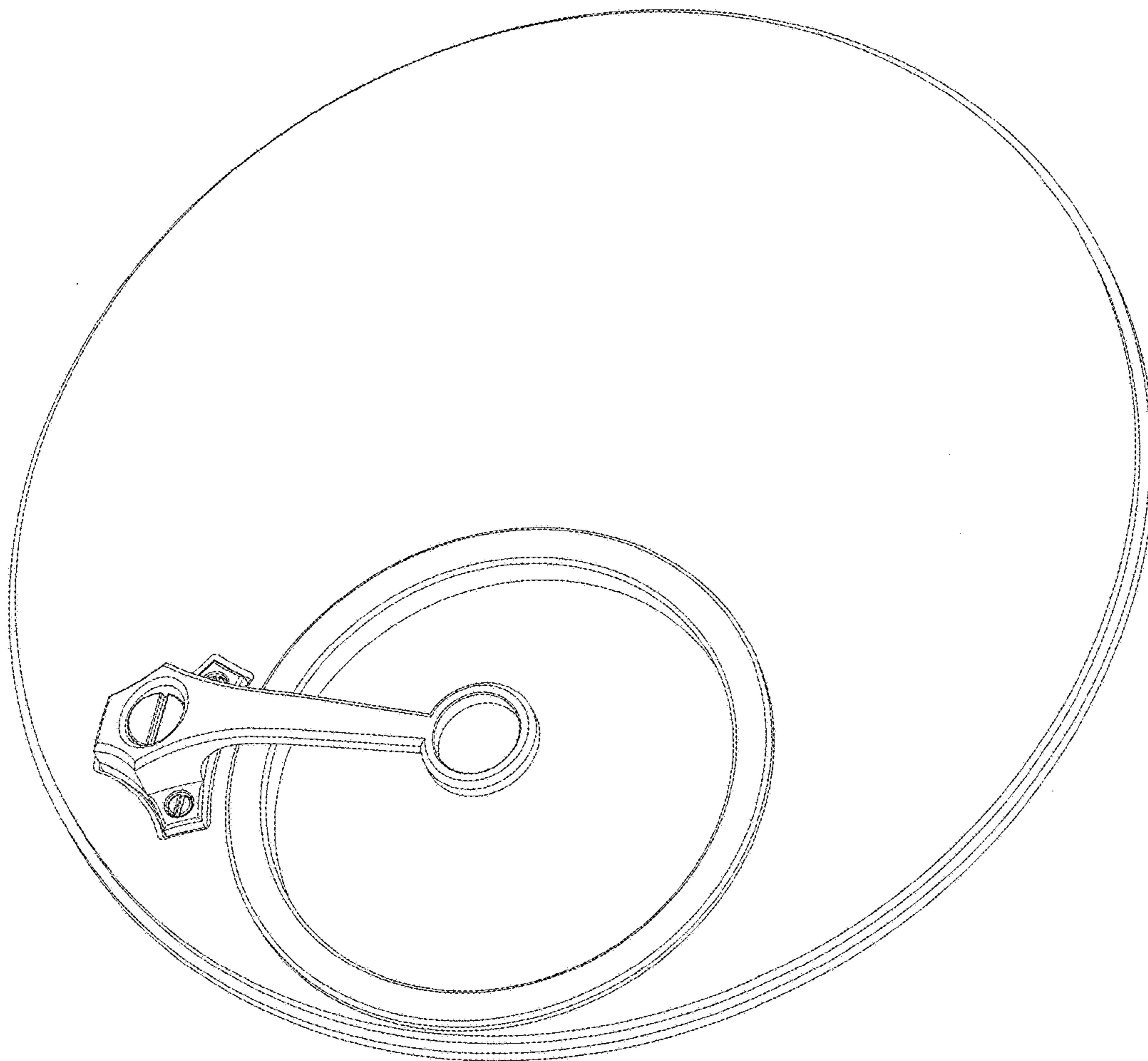
